# B lack-S choles-L ike D erivative $P$ ricing $W$ ith $T$ sallis $N$ on-exten sive Statistics

We recently showed that the $S \& P 500$ stock $m$ arket index is well described by $T$ sallis nonextensive statistics and nonlinear FokkerP lanck tim e evolution. W e argued that these results should be applicable to a broad range of $m$ arkets and exchanges where anom alous di usion and heavy' tails of the distribution are present. In the present w ork we exam ine how the B lack-Scholes derivative pricing form ula is $m$ odi ed when the underlying security obeys non-extensive statistics and FokkerP lanck tim e evolution. W e answer this by recourse to the underly ing m icroscopic Ito-Langevin stochastic di erential equation of the non-extensive process.

[^0]For certain stochastic system $s$ there is an interesting connection betw een statistics and dynam ics. A fam ily of nonlinear FokkerP landk tim e-evolution equations tums out to be solved by probability distributions which are characterized by T sallis non-extensive
 S\& P 500 stock index $\left[\begin{array}{l}{[\overline{1}]}\end{array}\right]$, show ing that prige-change distributions had both non-extensive form and Fokker-P lanck tim e evolution. W e argued that the results should be applicable to the broad range of $m$ arkets and exchanges characterized by anom alous (super)
 the B lack-Scholes derivative pricing form ula $\left.{ }_{[0,1}^{1}\right]$ is modi ed when the underlying security is described by non-extensive statistics. This is based on an analysis of the microscopic Ito-Langevin stochastic di erential equation underlying the $m$ acroscopic nonlinear FokkerP lanck equation $\bar{E}, r, 1$

## I. NONEXTENSIVESTATISTICSAND TIMEEVOLUTION

W e begin by sum marizing the probability distribution function (PDF) P (S;t) which is obtained using non-extensive statistics. D enote the value of a security at a trading tim e by prige ( ). In the follow ing we w ill take prioes and tim es relative to the prioe at som e arbitrary xed reference tim e 0 . Thus $S(t)=$ prige $(0+t) \quad$ prige $(0)$ is the (relative) security value at a (relative) trading tim et. The desired form of $P(S ; t)$ is obtained by $m$ axim izing an incom plete inform ation-theoretic m easure equivalent to the $T$ sallis entropy:

$H$ ere $q$ is a tim e-independent param eter indicating the degree of non-extensivity or equivalently the incom pleteness of the inform ation $m$ easure. $Z(t)$ is a norm alization constant, $\bar{S}(t)$ is the $m$ ean, and $(t)$ is related to the distribution's variance by

It $w$ as show $n$ rather unexpectedly that distributions of this non-extensive form tum out to solve a non-linear FokkerP lanck partial di erential equation '[

$H$ ere $F(S)=S$ is a linear driving term dependent on the $m$ arket rate of retum . Eq. (4) is solved by distributions of the $T$ sallis form Eq. (2ㄴ) if the param eters in the latter evolve in tim e according to

Here $t_{1}$ is an arbitrary tim e; e.g., it could be the shortest m easured intervalafter the reference time 0 , so that $t_{1}=1 \quad 0$ equals, say, one m inute.

In $\left[\begin{array}{l}{[17}\end{array}\right]$ we investigated price changes in the $S \& P 500$ index. W e show ed that prige-change distributions w ere well-described by distributions of the non-extensive form Eq. (2̄) evolving in tim e according to Eq. ( $\overline{4} \mathbf{4})$. The super-di usion and fat tails characterizing this $m$ arket are both a consequence of a non-extensivity param eter q greater than unity.

The nonlinear Fokker P lanck equation is a m acroscopic description of how a probability distribution evolves in tim e. It is connected to an Ito-Langevin stochastic di erential equa-
 can be w ritten in the general form

$w$ ith a the drift coe cient and b the di usion coe cient. In the stochastic term ( $t$ )dt = $d W$ ( $t$ ) is the $W$ iener process $\left.{ }_{[1]}^{9}\right]$. [ ( $(t)$ is a delta-correlated ( $\left.h(t) \quad\left(t^{0}\right) i=\left(t \quad t^{0}\right)\right)$, norm allydistributed noise $w$ th unit variance ( $h(t)^{2} i=1$ ) and zero $m$ ean ( $h(t) i=0$ ).]

Here the Fokker-P lanck equation's driving term $F(S)=S$ appears as a tim e-independent linear drift coe cient $a$. The di usion coe cient in our case is $b=\frac{q}{D P(S ; t)^{1} q}$, which
exhibits explicitly at the levelof the m icroscopic stochastic process the statisticaldependence of subsequent price changes on the macroscopic PDF P (S; t). That is, the mem ory e ect representing correlations in tim eenters here sim ply via the di usion coe cient. W eargued in $[4 \overline{4}]$ that nonlinear Fokker $P$ lanck tim e evolution can be expected in any stochastic system in which $m$ em ory e ects can be approxim ated in this sim plem anner as a probability-dependent di usion coe cient.

## II. DERIVATIVE PRIC IN G FOR NON EXTENSIVE STATISTICS

Now we tum to the question of how the B lack-Scholes derivative pricing $m$ odel is to be modi ed when the underlying security has non-extensive statistics and nonlinear Fokker$P$ lanck dynam ics.
 a derivative $G$ and long @G =@S shares of the underlying security (stock, say) S.T he change in the value of the portfolio in a tim edt is

(T he num ber of stock shares $@ G=@ S$ is of course constant during dt.) The change dG during dt is given by Ito's form ula $[\underline{9} 1]$. This results from Taylor expanding to rst order in dt and to second in order in price change $d S$, and using $d W(t)^{2}=d t$ :

U sing Eq. (9, ${ }_{(1)}$, this becom es the stochastic di erential equation obeyed by the derivative G (S; t).

W e seek a portfolio which instantaneously eams the sam e rate of retum r as a short term risk-free security (assum ing no arbitrage). T hen

$T$ his pricing equation is analogous to the $B$ lack-Scholes result $\left[\begin{array}{l}-1 \\ \hline 1\end{array}\right]$, generalized for an arbitrary di usion tem $b(s ; t)$ ! $[1] 4]$. The explicit dependence on the $m$ arket rate of retum has been replaced by the risk-firee rate $r$.

There is how ever a di culty hidden in Eq. (1]il). For our case the di usion term $b(S ; t)=$ $\mathrm{p} \overline{\mathrm{DP}^{19}}$ depends on the probability distribution function of the underlying stock. Hence Eq. (1]j̄) depends im plicitly on the $m$ arket's rate of retum. To show what di culty this entails, let us begin by review ing the C ox and Ross approach to solying Eq. (1] $\overline{1}$ ).

First de ne a two-point function $P\left(S ; t 5^{0} ; t^{0}\right)$ which obeys an equation very sim ilar to Eq. (4í),

Here we continue to use $b=$ ${ }^{q} \overline{D P(S ; t)^{1 q}}$.] The CoxRoss solution is based on the fact that Eq. ( $\left.\overline{1} \bar{\sim} \overline{4}\right)$ is a forward C hapm an $K$ olm ogorov equation, and as such also has a corresponding badkw ards form $\sqrt{\underline{9}}$,通 1 ?

A s an exam ple, let us seek a solution of Eq. (1ָ- $\overline{1})$ for a European-style calloption $G(S ; t)$ on a non-dividend-paying stock S. Follow ing C ox and Ross, we try the form

$w$ here $S_{T}$ is the term inalstock price and $X$ the exercise prioe. (At $m$ aturity the value of the call option is worthless if the term inal stock price is less than the exercise prioe; otherw ise the value is the prioe di erence.) Substituting Eq. ${ }^{\prime}(\overline{1} \overline{\bar{\beta}})$ into Eq. $(\overline{1} \overline{1} \bar{\beta})$, one nds thater $m$ ust solve

In all the cases considered by C ox and Ross，the di usion term $B$ w as independent of the underlying stock＇s rate of retum ．Then $\mathrm{P}^{\Upsilon}$ was the probability distribution for a risk neutral world，and could readily be found．

H ere how ever the di usion term ${ }^{1}$ depends im plicitly on the underlying stock＇s rate of retum ，and consequently Eq．（10）cannot be solved by assum ing a risk neutral world． A ssum ing risk neutrality am ounts to replacing by the risk－free rate $r$ everyw here．Then Eq．（1］ī）would be identical to Eq．（1－15）w ith replaced by r everywhere．This could be solved by a T sallis form ．Unfortunately this replacem ent is not justi ed，and we have to tum to an altemative approach．

In fact，we have found two variations on the C ox－R oss approach which perm it straight－ forw ard solutions of the valuation equation for securities $w$ th non－extensive statistics．W e will present both．
 Then using Ito＇s form ula as in Eq．（ $(\underline{1} \overline{1})$ ，we have

O ptionsw ritten on $S$ can be evaluated for any 5 which is independent ofthe originalsecurity＇s $m$ arket rate of retum ．Let us consider the sim plest case，where $\bar{\sigma}=\bar{\delta}(t)$ is a function of $t$ only．Then the second of Eqs．（2ַ̄̄）can be solved for $S$ ：

Now we consider an option $G(S ; t)$ and a portfol $\quad=G+\frac{@ G}{@ S} S$ ．An analysis exactly like that leading to Eq．（1̄⿱龴⿱乛亅㇒⿴囗⿱一一心．）show s that follow s the risk－free rate of retum $r$ if

This by construction has no dependence on ，and hence describes a risk－free universe as in C ox and R oss［1］ī $]$ ．In practical applications，$S$ can be view ed as a derivative of the original non－extensive security $S$ ，and $G(S ; t)$ is then an option involving $S$ ．

A very di erent route to valuing options for non-extensive securities com es from converting the $m$ arket's Ito-Langevin equation into a coupled process $w$ ith a constant di usion coe cient. This uses an idea developed for tim e nonhom ogeneous system s $\underset{-1}{\dagger-1}]$. C onsider the coupled process

where is a constant. N otice that $\hat{S}$ has no di usion term; this will perm it us to solve a two-variable B lack-Scholes-like equation (below). First, however, we need to relate the coupled process to the original security $S$.

Eq. (2-4íl) is form ally solved by

C onsequently as ! 1 Eq. (2-3̄1) becom es identical to our market Ito-Langevin equation Eq. ( nite and take ! 1 at the end.
Consider an option $G(\hat{S} ; y ; t)$. For nite , Eq. ( $12 \bar{\gamma}$ ) has no di usion term. C onsequently to nd dG we expand to rst order in $t$ and $\hat{S}$, and second order in $y$. The result is

$W$ e see that again the $m$ arket rate of retum has dropped out. Thus we have obtained a tw o-variable form of the usual B lack-Scholes equation. Solutions can be nd exactly as in Cox and Ross [1] $\overline{1}]$ :

P ractical application of this $m$ ethod of valuation would require solving with a nite value of , but a value large enough so that $y(t)$ is su ciently close to ( $t$ ) for tim e scales considered. W e can $m$ ake som e connection betw een the tw o approaches described above by integrating out y. O ne can de ne

Eq. ( $\left.\bar{\beta}_{\overline{1} \overline{1}}^{1}\right)$ is form ally equivalent to the solution of Eq. ( $(\overline{2} \overline{2})$ in the CoxR oss form Eq. $(\underline{1} \overline{1} \overline{-1})$, in the lim it ! 1 .

W e have followed the lines of B lack-Scholes and C ox-R oss to develop an options pricing formula for securities obeying non-extensive statistics and nonlinear FokkerP lanck time evolution. W e showed in [ī $[1]$ that the S\& P 500 index is well described using this approach, and argued there that a description in term s ofnon-extensive statistics can be usefull for any $m$ arket in which the stylized facts of fat tails and anom alous di usion are pronounced. The pricing form ula obtained here would then be useful for options based on any such $m$ arket. A s an exam ple we obtained pricing $m$ odels for a E uropean style calloption on an underlying asset that pays out no dividends.
