## M etastable quasi-one-dim ensional ensembles of nitrogen clusters N<sub>8</sub>

By means of ab initio and tight-binding calculations it is shown that metastable nitrogen clusters  $N_8$  (boats) can form quasi-one-dimensional ensembles in which the nearest clusters  $N_8$  are bound to each other by covalent bonds. Those ensembles are characterized by rather high energy barriers ( 0:3 eV) that prevent the ssion of the ensembles into isolated  $N_8$  clusters and/or  $N_2$  m olecules.

A nitrogen molecule N<sub>2</sub> is known to be them ost stable form of nitrogen at standard conditions. Contrary to the overwhelm ing majority of other chemical elements, the cohesive energy per atom,  $E_{coh}(n) = E_{tot}(n) = E_1$  (where  $E_{tot}(n)$  is the total energy of an n-atom cluster N<sub>n</sub>,  $E_1$  is the energy of an isolated nitrogen atom) decreases with n, so it is energetically favorable for clusters N<sub>n</sub> with n > 2 to decompose into separated N<sub>2</sub> molecules and thus to lower their energy. However, recently it was shown theoretically [1, 2, 3] that several nitrogen clusters, e.g., N<sub>4</sub> and N<sub>8</sub>, can exist in metastable states which correspond to the local minim a of the potential energy as a function of atom ic coordinates. A lithough metastable clusters N<sub>n</sub> with n 4 have not been synthesized yet, they attract much theoretical attention as potential high energy density materials (HEDM). The energy  $E_{acc}(n) = E_{coh}(2) = E_{coh}(n)$  accumulated in the N<sub>n</sub> (n 4) system s approaches the value of  $E_{acc}$  3 eV/atom

[1, 2, 3].

In order to make use of  $N_n$  (n 4) clusters as new e cient and environmentally safe energy sources, one should be able to create bulk metastable nitrogen structures composed of  $N_n$  (n 4) clusters. On the one hand, in order such structures could exist, the nitrogen clusters should be connected with each other by covalent bonds. On the other hand, those bonds should not be "too strong" in order the clusters preserved their individuality and the energy accumulated in such structures was not substantially lower than the energy accumulated in an isolated cluster, i.e., the clusters should form ensembles. Besides, there should be a su ciently high energy barrier preventing the ssion of ensembles into isolated nitrogen clusters and/or nitrogen molecules.

An extensive theoretical study of M ailhiot et al. [4] suggests that nitrogen can form bulk polymeric metastable structures at high pressures. However, the polymeric structures cannot be considered as composed of nitrogen clusters, i.e., as ensembles of clusters. In this paper, we present the preliminary results of numerical simulations of bonding between nitrogen clusters and show that boats N<sub>8</sub> can form metastable quasi-one-dimensional ensembles in which the nearest clusters N<sub>8</sub> are bound to each other by covalent bonds.

The version of the self-consistent- eld theory with 3-21G, 6-31G, and 6-311G basis sets in HyperChem was used in the present work. First, we studied the geometry and energetics of isolated clusters  $N_4$  (tetrahedron) and  $N_8$  (cubane and boat). Those clusters are shown in Figs. 1-3. The accumulated energies are  $E_{acc}(4) = (1.98 \ 2.21) \text{ eV}/\text{atom}$  for the cluster  $N_4$ ,  $E_{acc}(8) = (2.44 \ 2.59) \text{ eV}/\text{atom}$  for the cubane  $N_8$ , and  $E_{acc}(8) = (1.53 \ 1.66) \text{ eV}/\text{atom}$  for the boat  $N_8$ , depending on the basis set used. Our results agree with previous works [1, 2, 3].

We have carefully analyzed a lot of di erent mutual arrangements of nitrogen clusters. In both cases of N<sub>4</sub> and cubane N<sub>8</sub> clusters, we have found no metastable con gurations. However, in the case of boats N<sub>8</sub>, we have revealed that two boats can form a "cluster molecule" (N<sub>8</sub>)<sub>2</sub>. It is shown in Fig. 4. The energy accumulated in thism olecule,  $E_{acc}$  (16) = 1:79 eV /atom (3-21G basis set), exceeds slightly the energy accumulated in an isolated boat N<sub>8</sub>. We have demonstrated by direct calculations that the molecule (N<sub>8</sub>)<sub>2</sub> is mechanically stable, i.e., all its oscillation frequencies are real, giving evidence that the con guration shown in Fig. 4 corresponds to a local minimum in the total-energy surface as a function of atom ic coordinates.

In order to study the form ation of large ensembles of boats  $N_8$ , we employed a version of TBM D (tight binding m olecular dynam ics) m ethod with transferable interatom ic potential [5, 6] used by us earlier for carbon clusters [7, 8, 9, 10, 11] and m odi ed for calculations on nitrogen system s. A lthough the TBM D m ethod is not as rigorous as ab initio approaches, it allows one to study relatively large system s as well as to calculate directly the lifetim e of the m etastable state and the height of the energy barrier. For  $N_4$  and  $N_8$  clusters and  $(N_8)_2$  "boat dim ers", the results of TBM D simulations agree qualitatively with ab initio calculations. We have also shown that rather long quasi-one-dim ensional ensembles of boats can be form ed through attaching of new boats  $N_8$  to the  $(N_8)_2$  "m olecule". The ensembles  $(N_8)_m$ with m up to 6 have been shown to be m etastable with accumulated energy about 90 percents of the energy  $E_{acc}(8)$  accumulated in an isolated boat. The heights of the energy barriers preventing the ssion of m etastable con gurations exceed 0.3 eV.

F inally, we note a recent success in recovering the non-m olecular phase of nitrogen at am bient pressure at tem peratures below 100 K [12]. Structure and physical properties of a new phase are not understood yet. Its characterization remains an important issue. P resum ably, it is polymeric. This can be considered as a rst step towards synthesis of bulk metastable nitrogen structures, including "cluster phases" studied in this paper.
