Low frequency R am an studies of multi-wall carbon nanotubes: experim ents and theory

In this paper, we investigate the low frequency R am an spectra of multiwall carbon nanotubes (M W N T) prepared by the electric arc method. Low frequency R am an modes are unambiguously identied on puried samples thanks to the small internal diameter of the M W N T. We propose a model to describe these modes. They originate from the radial breathing vibrations of the individual walls coupled through the V and er W aals interaction between adjacent concentric walls. The intensity of the modes is described in the frame work of bond polarization theory. U sing this model and the structural characteristics of the nanotubes obtained from transmission electron microscopy allows to simulate the experimental low frequency R am an spectra with an excellent agreement. It suggests that R am an spectroscopy can be as useful regarding the characterization of M W N T as it is in the case of single-wall nanotubes.

Since their discovery, carbon nanotubes attract a huge interest in the scienti c community due to their potential use in future devices, exploiting either their mechanical or electrical properties. Much attention is paid to single-wall nanotubes (SW NT) which exhibit electronic properties which depend on their type and/or chirality. Am ong the techniques extensively used to characterize these materials, Raman scattering plays a fundam ental role as reviewed by D resselhaus and Eklund in ref.1.0 n one hand, the radial-breathing mode (RBM) in the low frequency region shows a straightforward dependence on the diam eter of the SW NT to a determ ination of the distribution of tube diam eters². On the other hand, strong resonance e ects lead to di erent pro les of the tangentialm odes (G band), in particular in the red excitation range for which m etallic tubes contribute signi cantly to the Raman response³. Multi-wall nanotubes (MWNT) are now adays also studied extensively and characterized by R am an scattering. Low frequency R am an m odes have also been observed as well and resonance e ects have been detected^{4,5}. However, up to now, the results have been rather dispersed and no clear interpretation of the experim ental results has been o ered.

In this paper, we present a detailed low frequency Ram an study of arc discharge multi-wall carbon nanotubes which are characterized by transm ission electron m icroscopy (TEM). We clearly identify low frequency m odes in puri ed samples. We present a model to interpret these m odes based on the coupling of the RBM of each individual wall of the M W NT. Intensity calculations are proposed as well. The low frequency spectrum of the M W NT is shown to be very sensitive to the internal diam eter of M W NT. For the st time, a com prehensive simulation of low frequency Ram an spectrum of M W NT is given. P relim inary results have already been presented elsew here⁶.

The MWNT samples are synthesized by sublimation of pure graphite rods using electric arc discharge at Trinity College, Dublin using standard conditions. A typi-

calm icrograph of the material extracted from the cathode of the arc set-up and obtained by scanning electron microscopy (SEM) is given in the right part of Fig.1. Carbon brils which constitute the MWNT as well as a rather large num ber of polyhedric particles are found. From SEM observations, the purity of the sample does not exceed 50 % . In order to improve the quality of the samples, we follow the oxidation puri cation procedure described in ref.7. As shown in Fig.1, the sample quality is drastically improved even if some parts remains of poorer quality. High resolution TEM (Hitachi H 9000 NAR) of the puri ed material con m s the SEM observations. It show salso that the MWNT are very well graphitized as shown in inset of Fig 2. Indeed degradations and tube opening som et in es occur. Fig 2 show shistogram sof the diameter distributions obtained from TEM observations. The inner diam eter distribution is peaked around

1.2 nm whereas the outer diam eter one has a maximum close to 14 nm. On average, these M W NT have 18 walls.

Room tem perature Ram an spectra of our sam ples were obtained using a multichannel Jobin-Y von T 64000 spectrom eter. A system atic observation of the investigated area is performed before any measurement using the CCD cam era of the R am an m icroscope in order to probe the quality of the area. Typical Ram an spectra using the = 676.4 nm excitation line are shown in Fig.1. The two spectra correspond to the puri ed and the non puried SEM micrographs shown in the upper part of the gure. Looking to other areas with similar morphology gives sim ilar results. The three di erent regions of interest are: the G band region close to 1600 cm $^{-1}$, the D band one close to 1330 cm $^{-1}$, and the low frequency range below 200 cm 1 on which we focus on this paper. A snoticed above, low frequency Ram an modes have already been observed in MWNT^{4,5} although a large dispersion of results is observed. Fig.1 gives clues to understand this behavior. The low frequency modes are clearly observed in the high quality sample while they are not in the raw sample. This di erence in sample quality is also re ected in the two other Ram an contributions: in the puri ed sample, the D band is weaker and the G band narrower.A directm easurem entof the D band to G band intensity ratio gives $I_D = I_G = 0.048$ after purication to be compared to $I_D = I_G = 0.27$ before. Another quantity of interest is the full width at half maximum (FW HM) of the G band. Its value is 17 cm⁻¹ for the puri ed sam ple and 27 cm 1 for the non puri ed one to be compared to 13 cm¹ for HOPG graphite⁸. In pre-graphitic carbons, both quantities, $I_{\text{D}}=I_{\text{G}}$ and FW HM , are known to depend on the size of the graphitic crystallites^{9,10}: the sm aller these param eters, the highest the degree of crystallinity. Here indeed, the reduction by one order of magnitude of $I_D = I_G$ and by alm ost a factor of 2 of the width of the G band in the puri ed sample has to be related with the destruction of most of the polyhedric particles as




FIG.3: (a) Experimental R am an spectra of MWNT using = 676 nm and = 514 nm laser excitations on the same sam – ple area. (b) Results of the simulation discussed in the text. We used a FWHM of 4 cm⁻¹ and 6 cm⁻¹ for the = 676 nm and = 514 nm spectra respectively. (c) Individual contributions of the 20 walls nanotubes involved in the simulation shown in (b). The inner diameter of the 20 walls tubes are given on the right. The star markers indicate laser lines. We do not substract any baseline on the experimental spectra.

observed by SEM and presum ably of a part of the am orphous carbon. Conversely, this work suggests that low frequency m odes are not observed in the R am an spectra of m ost of the as-grown M W N T sam ples because they are hidden by the prom inent contribution of other carbonaceous com pounds.

De nitive assignment of the low frequency Raman modes to MWNT is con med by using a thin lm of 30 % puri ed MWNT mixed with polymethylmetacrylate. Observations with the Raman CCD camera and with SEM as well clearly show MWNT emerging from the fracture zones of the lm while polyhedric particles are not observed in the same conditions. Raman studies at di erent excitation wavelengths can thus be performed on the same eparticle free area by focusing the laser beam on such a zone. Two low frequency spectra obtained using = 676 nm and and = 514 nm are presented in Fig.3(a). Several low frequency modes are clearly visible from 115 to 220 cm⁻¹. The position of the peaks depends on the laser excitation suggesting resonance effects as pointed out in ref.5.

In SW NT, the low frequency part of the R am an spectrum is due to the radial breathing modes (RBM) with A_{1g} symmetry. In this paper, we suggest that the low frequency modes observed in MW NT have the same origin, i.e. they also originate from the breathing vibrations

of the individual walls of the M W NT. However, because the individual walls are concentric, the situation is much m ore complex than in SW NT. Three ultimate assum ptions can be made. i- The di erent walls can "breathe" independently. It is very unlikely. As discussed below, despite its weakness, the Van der W aals interaction is su cient to allow the coupling of the individual vibrations. Furtherm ore, we should expect to observe m any m ore peaks than those observed in Fig.3. ii- Only the m ost outer wall is able to breathe. If so, we should not expect to observe m odes in the 200 cm⁻¹ region but instead below 50 cm⁻¹. iii- The di erent walls can breathe how ever the breathing vibrations are a ected by the interactions between concentric walls. Here we propose a m odel to describe these interactions.

The problem of interacting RBM has already been considered theoretically to describe the "bundle e ect" in SW NT¹¹. In our group, we have addressed the "bundle e ect" problem for an hexagonal lattice of SW NT⁶. A Lennard-Jones potential is used to describe the carboncarbon long range interaction. The tube-tube interaction is obtained from the mutual integration of the potential over adjacent SW NT. The second derivatives of the interaction give the tube-tube force constants. The adjacent tube-tube force constant C is given by: $C = 0.3C_{g}$ $(d_{V dW} = d)^{1=2}$ in which d is the SW NT diam eter, $d_{V \ dW}$ is the distance between adjacent SW NT and $C_{q} = 2.3 \text{ N/m}$ corresponds to the force constant between two graphene sheets extracted from the B_{1q} mode of graphite. In this simpli ed model, we consider a bundle of N identical tubes. The N individual RBM are coupled through the tube-tube interactions, resulting in N new modes. The frequency of these modes is obtained by diagonalizing the dynam icalm atrix. Thism odel gives an upshift of the RBM mode of (10,10) SW NT in bundle in the range 11-16 cm 1 , in agreement with other authors¹¹.

Here we adapt this approach to the case of the low frequency R am an modes of a M W NT. A multiwall nanouble is described by its inner diameter d₁ and its outer diameter d₁ and it can be characterized individually by its radial breathing mode $!_{0\,i}$ (cm 1)=223.7/d_i (nm)¹². In the following, the wall-wall distance is xed at 0.34 nm . We estimate the concentric wall-wall interactions in the same way as before. We limit these interactions to

rst neighboring walls since extending the interactions to all the walls does not change signi cantly the nal result. The rst neighbor wall-wall interactions turn out to be independent of the wall diam eters with force constants close to C_g when the wall-wall distance is 0.34 nm. Introducing these interactions couples the N individual modes, resulting in N new modes. Again, the frequencies $!_i$ of the N new modes are obtained after diagonalization of the dynam ical matrix. As expected, all the new modes are upshifted by comparison with the bare modes. The upshift $_i = !_i$ $!_{0i}$ is the strongest for interm ediate modes. For example, considering a N = 20 MW NT




FIG.4: Simulated low frequency R am an spectra of M W NT. The FW HM of each peak is arbitrary xed to 4 cm¹. Left pannel: e ect of the inner diam eter d₁ on a 20-walls tube. Right pannel: e ect of the num ber of walls on a d₁=12 nm M W NT whose num ber of walls varies between 5 to 50.

with inner diam eter $d_1 = 1.2 \text{ nm}$, the m ost inner or outer m odes are only shifted by $_1 = +12 \text{ cm}^{-1}$ and $_N = +3 \text{ cm}^{-1}$, respectively, while a shift of $_i = +70 \text{ cm}^{-1}$ is obtained for m odes with i close to 10. Still, this m odel is not su cient to explain the experimental data, and m ore precisely the fact that we observe wellde ned and intense m odes in the 200 cm⁻¹ region. A ctually, the dynam ical m atrix diagonalization shows that in-phase vibration is achieved for the m ode num berN , i.e. for the m ode at the low est frequency. It suggests that the R am an intensity of the m odes should be sm all at the highest frequencies.

In order to address this problem carefully, we propose also an intensity calculations. We do not take into account any possible resonance e ect. The polarisability tensor of each individual wall is obtained using the nonresonant bond polarization theory¹³. It turns out that the derivative polarisability tensor $d()/d(d_i)$ of an isolated wall with diam eter d_i scales with $d_i^{1=2}$, then giving rise to a $!_{0i}$ RBM of intensity proportional to $1/d_i$. In the whole MWNT, the derivative polarisability tensor is equal to the sum of the tensors of the individual wall multiplied by the amplitude of the vibration of the considered mode. The results of this calculation show that the most intense modes are those which originate from the vibration of the most internal and external walls, respectively. In fact, this is due to two competitive effects. i-The smallest walls contribute to the intensity as 1/di. ii- The sm allest frequency mode (originating from the biggest wall) is associated with an in-phase vibration, inducing there a cumulative e ect in term of intensity. Such calculations reveal that two param eters are of primary importance, the internal tube diameter on one hand, and the number of walls in the MWNT on the other hand. Such data can be statistically extracted from TEM observations.

The combine results of both the frequency and intensity calculations are shown in Fig.4 where we arbitrary use a FW HM = 4 cm¹. As shown in the left panel of the gure, the modes at highest frequencies originate from the smallest wall. However, their intensities become vanishingly small as soon as the inner diam eter exceeds 2 nm. It suggests that low frequency modes of MW NT with large inner diam eter cannot be observed even if present. It may explain partly the disparity of the results published in the literature. In the right panel of the gure, we simulate the spectrum of a MW NT with inner diam -

In the right panel of the gure, we simulate the spectrum of a MWNT with inner diam – eter $d_1 = 1.2$ nm and N walls. The intensity evolution described before is clearly visible. More interestingly, we can divide the spectra in two parts. The three modes at highest frequencies are only weakly a ected by the num – ber of walls. However, when looking to lower frequencies (! i 130 cm⁻¹), the situation is dram atically di erent when N increases from 5 to 50. This is due to two facts. First, the num ber of modes in the 0-130 cm⁻¹ is increasing with N, giving rise to the oscillatory behavior. Then, the upshift i of the interm ediate modes is also increasing with N pushing all the modes closer to each other.

This model can be used to simulate the experimental spectra of Fig.3. We recall that our calculations do not take into account any possible resonance e ects. From the TEM results, we consider MWNT with inner diam eters between 1 and 2 nm and with N = 20. Let us start with the spectrum at = 647 nm. Four well resolved peaks are observed at 217, 199, 180 and 162 cm 1 respectively. Two doublets are observed close to 141 and 115 cm¹ respectively. We need four MWNT with inner diam eter 1.08, 1.20, 1.36 and 1.54 nm respectively to yield the four modes at highest frequencies. The calculated spectra of this four MWNT are given in part (c) of the qure with the same intensity unit. The resulting simulated spectrum is shown as spectrum (b) in the gure and using the relative weights 16%, 55%, 10% and 19 % for the MWNT with $d_1 = 1.08, 1.20, 1.36$ and 1.54 nm respectively (the relative weights take into account the intensity considerations discussed before). Indeed, the simulated spectrum describes very well the highest frequency modes. Much more interestingly, the simulated spectrum exhibits two doublets, one close to 145

are comparable to the two experimental doublets. The origin of these doublets is easily found in the individual spectra shown in part (c). The rst one com es from the second modes of the $d_1 = 1.08$ and $d_1 = 1.20$ nm MWNT and the second one from the third modes. Indeed, this simulation strongly supports our model. Still, a small discrepancy in the position of the doublets remains, this discrepancy being bigger when the third modes are involved. Since the experim ental doublets are at low er frequencies, it may indicate that the involved MWNT have less than 20 walls. The second experimental spectrum was obtained on the same sample area with = 514 nm. Two peaks are found at 190 and 160 cm⁻¹ and unresolved features appear close to 149 and 130 cm $^{-1}$. The simulated spectrum shown in (b) is obtained by considering M W NT with $d_1 = 1.25$, 1.54 and 1.70 nm and relative weights 22 %, 45 % and 33 % respectively. In this case, the simulated spectrum is able to describe the experim ental unresolved feature at 149 cm 1 and the second one at 130 cm 1 , due to the second m ode contributions. There is less discrepancy in frequency positions than in the previous case. This is what is expected if the num ber of walls is less than the one we used.

In sum m ary, low frequency R am an m odes in M W N T have been unam biguously identi ed provided the M W N T are of high quality and their internal diam eter is sm all (less than 2 nm). These m odes which originate from the radial breathing m odes of the individual walls are strongly coupled through the concentric tube-tube V an der W aals interaction. Frequency and intensity calculations perform ed in the fram ework of the dynam ical m atrix diagonalization and non resonant bond polarization theory allow to sim ulate experimental R am an spectra with a rather good agreem ent. Still, resonance e ects are observed which are not taken into account in our m odel. They deserve further experimental and theoretical work.
