# Current and vortex statistics in m icrowave billiards

U sing the one-to-one correspondence between the Poynting vector in a microw ave billiard and the probability current density in the corresponding quantum system probability densities and currents were studied in a microw ave billiard with a ferrite insert as well as in an open billiard. D istribution functions were obtained for probability densities, currents and vorticities. In addition the vortex pair correlation function could be extracted. For all studied quantities a complete agreement with the predictions from the random -superposition-ofplane-waves approach was obtained.

## I. IN TRODUCTION

A particularly successful approach to describe the statistical properties of the eigenfunctions of chaotic billiards, dating back to Berry [1], assumes that at any point not too close to the boundary the wave function can be described by a random superposition of plane waves,

$$(\mathbf{r}) = \sum_{n}^{X} a_{n} e^{(k_{n} \mathbf{r})}; \qquad (1)$$

where the modulus  $k = j_{k_n} j$  of the incoming waves is xed, but directions  $k_n = k$  and amplitudes  $a_n$  are considered as random. In billiards with time-reversal symmetry there is in addition the restriction that the wave function has to be real. This ansatz cannot be strictly true. It completely ignores the boundary conditions at the billiard walls, but this is of no importance as long as the wave length is small compared to the billiard size.

As a consequence one expects a Gaussian distribution for the wave function amplitudes , or, equivalently, a Porter-Thom as distribution for their squares  $j \ \hat{f}$ . For the spatial auto-correlation function c(r) =h  $(r + r) (r)i_r$  a Bessel function is found. These predictions were rst veri ed by M cD onald and K aufm an in their dissem inating papers on stadium wave functions [2, 3]. It is impossible to mention all works which have been published hitherto on this subject. A sanother consequence of ansatz (1) the gradient of the wave function is G aussian distributed, too, and uncorrelated to the wave function. This has been used to calculate the distribution of eigenvalue velocities and the velocity auto-correlation function for the case of a local parameter variation [4].

The approach is not restricted to quantum -m echanical systems, or systems where there is a one-to-one correspondence to quantum m echanics such as quasi-twodim ensional m icrowave billiards. Porter-Thom as distributions are found as well in the squared am plitudes of vibrating plates [5]. In an experiment on a threedimensional Sinai m icrowave billiard, having no quantum mechanical equivalent, the electrom agnetic eld distributions as well as their spatial correlations could be explained assum ing a random superposition of plane electrom agnetic elds [6, 7]. In a very recent experiment on light propagation through distorted wave guides, nally, the observed transversal eld patterns could be described again by ansatz (1) [8]. All these examples show that the random -superposition-of-plane-waves approach is not of a quantum -m echanical origin, but holds for all types of waves.

If the billiard is opened, or if tim e-reversal sym m etry is broken, the wave function acquires an im aginary part,

with the consequence that in dependence of the relative fractions of real and im aginary parts the distribution of j f changes from Porter-Thom as to single exponential behavior. An explicit form ula describing the distribution in the transition regime has been given by di erent authors [9, 10, 11, 12]. The sam e function has been derived by Seba et al. for the distribution of scattering m atrix elem ents in a partially opened m icrow ave billiard [13]. W u et al. studied amplitude distributions and spatial autocorrelation functions in a microwave billiard with one ferrite-coated wall to break tim e-reversal sym m etry, and found quantitative agreem ent with the results expected from the random -superposition-of-plane-waves approach [14]. In a recent paper by Ishio et al. also deviations of this form ula due to scars and in regular systems are studied [15].

M ore recently the interest focussed on the current statistics in open systems. Saichev et al. calculated the distribution of currents [12]. The properties of current vortices have been studied by Berry and Dennis, who gave analytic expressions for dierent types of vortex spatial auto-correlation functions [16]. Independently, such auto-correlation functions as well as the distribution of nearest distances between nodalpoints have been studied in R ef. [17].

Experimental results on current statistics and the distribution of nodal points have not been available as yet. The method of choice to study such questions are microwave techniques. In a previous work of our group we




FIG.1: M ap of  $j j^2$  (top) and of the current (bottom) in the ferrite billiard at 5.19 G H z (a) and 6.41 G H z (b), and for the open billiard at 5.77 G H z (c). The intensity has been converted into a gray scale with the intensity increasing from white to black. The lengths of the arrows in the current m ap correspond to the magnitude of the Poynting vector. For the eld distribution in panel (a) there is a strong ow into the probing antenna at points of high intensity. In the two other examples the ow into the probing antenna is negligible.

could dem onstrate that currents can be easily obtained in an open m icrowave billiard [18]. In the present paper we show results on current distributions in two types of billiards, verifying a number of predictions given in the above m entioned papers for the rst time also in experim ent.

# II. EXPERIMENT

The basic principles of the experiment are described in detail in Ref. [19]. Therefore we concentrate on the aspects being of relevance to the present study. Two different billiards have been used, both resonators have a size of about 25 cm and a height of 8 mm. One of them is an open system of a rectangular shape with rounded corners and two openings on opposite sides containing entrance and exit antenna (see Fig. 1c). A third movable antenna was used to map the eld distribution in the resonator on a square grid of period 5 mm. The same system was used for a quantum-dot analog study previously [20]. The two xed antennas have a metallic core of diameter 1 mm, and a te on coating for stronger coupling; the movable antenna was a thin wire of diameter 0.2 mm. The lengths of all antennas were about 6 mm. The quantity directly accessible in the experiment is the scattering matrix [21]. From a rejection measurement as a function of the antenna position a mapping of the modulus of the wave function can be obtained; to get the sign as well, the transmission between two antennas is needed. By the presence of the antennas the resonances are somewhat broadened and shifted, but in chaotic systems this does not change the universal distributions. (For details see R ef. [19].)

The second system studied is a Robnik, or lim a con billiard [22, 23]. It can be obtained by a complex mapping of the unit circle in the complex plain by means of the function  $w = z + z^2$ . The deformation parameter used in the experiment was = 0.4. For this parameter the billiard is believed to be completely chaotic. (There are recent theoretical results indicating that this cannot be taken for sure [24]. But if there are still stable islands in the phase space, their corresponding volume will be very small.) A ferrite ring is introduced to break tim ereversal symmetry (shape and position are included in Figs. 1a and b). Ferrites have been used already repeatedly for this purpose [14, 25, 26, 27]. A detailed description of the function principle of the ferrites will be given in a forthcoming publication [28]. During relection at the ferrite the microwaves experience a phase shift with

the consequence that there will be currents through the billiard though it is completely closed. These currents are a complete analogue to the persistent currents observed in mesoscopic structures [29], for a recent review see R ef. [30]. They will be the subject of a separate publication [31]. In addition there will be currents due to the fact that the ferrite introduces considerable absorption into the system. In the present context it is not of relevance whether the currents are due to a break of tim e reversal symmetry or due to absorption.

It was demonstrated in Ref. [18] that in quasi-twodimensional billiards the Poynting vector  $S = \frac{c}{4} \vec{E}$  if can be written as

$$S = \frac{C}{8 k} \operatorname{Im} [E (r)r E (r)];$$

showing that there is a one-to-one correspondence with the current density

$$\tilde{j} = \frac{h}{m} \text{Im} [(r)r (r)]$$

in the corresponding quantum -m echanical system . A m easurem ent of the electric eld in the resonator including the phase thus im m ediately yields the Poynting vector and by m eans of the m entioned analogy the current density.

There is one problem with the experim ental determ ination of eld and current distributions. The probe antenna moving through the billiard unavoidably gives rise to a leakage current spoiling the statistical properties of the current distribution [18]. The in uence of the probe antenna is smallas long as there is a strong ow through the system . In this case the unavoidable leakage current into the probe antenna is negligible. There are situations, how ever, where there is no or only little ow, e.g. for the open dot, if the total transmission is close to zero, or for the ferrite billiard, if there are strong standing waves present, as in Fig. 1a. In such cases the leakage current is no longer negligible, and may even become dom inating. There is only one way to avoid this problem : the frequencies have to be chosen such that the overall am plitudes are moderate. A san example Fig. 1a show sam apping of j f and of the current distribution in the ferrite billiard at a frequency where there is a strong ow into the measuring antenna at points of high intensity. In Fig. 1b, on the other hand, the frequency has been chosen such that there is no noticeable current into the probe antenna.

#### III. IN TENSITY DISTRIBUTIONS

In a chaotic billiard real and imaginary part of the wave function are uncorrelated within the random -superposition-ofplane-waves approach,  $h_{\rm R}$  \_i = 0, where the average is taken over the billiard area. In a microwave m easurement, there may be an additional rotation of the phase, caused by antennas, cables etc., i.e. the wave




FIG.2: Distributions of  $= j \hat{f}$  for the ferrite billiard at 5.19 GHz (a), 6.41 GHz (b), and for the open billiard at 5.77 GHz (c), corresponding to Fig.1. The dashed lines have been calculated from Eq. (2).

function registered by the apparatus is

This has the consequence that real and in aginary part become correlated,  $h_{R}^{\sim} i \in 0$ . To begin with we have to remove this phase rotation. The procedure is described, e.g., in Refs. [12, 15].

The distribution of intensities = j j can be calculated with help of the Berry ansatz described above. If




FIG. 3: D istributions of  $j_x$  (a),  $j_y$  (b), and j, the latter one both on a linear (c) and a logarithm ic scale (d), for the ferrite billiard at 6.41 GHz, corresponding to Fig. 1b. The dashed lines are the theoretical expectations from Eqs. (3) and (4), respectively, where =  $h_{j_xyy}^2$ , see Eq. (5).

there is a complex m ixing of independent G aussian elds  $_{\rm R}$  and  $_{\rm I}$ , we have in the transition regime [12, 15]

In the lim it ! 0, Eq. (2) describes the Porter-Thom as distribution found for system s where the wavefunction is real. For ! 1, a single exponential behavior is observed which holds for system s where real and im aginary part are of the same strength.

Figures 2a and b show the corresponding intensity distributions for the ferrite billiard. The dashed lines are calculated from Eq. (2). The parameter has not been tted but has been taken directly from the experiment by averaging  $\frac{2}{R}$  and  $\frac{2}{T}$  over all pixels at a given frequency.

O ne observes a quantitative agreem ent with theory for the case that the leakage current is negligible (Fig. 2b). For the scarred wavefunction of Fig. 2a, on the other hand, the experimentally found distribution of  $j \neq j$  is com pletely at odds with theory. Such discrepancies are not new. A lready in the dissem inating paper by M cD onald and K aufm an [3] G aussian distributions for were observed for chaotic wave functions exclusively. It is obvious that the random -superposition-of-plane-waves approach cannot work for bouncing-ball and scarred wave functions such as the one shown in Fig. 1a. It is an easy m atter to show that sharp drops in the j f distribution as the one in Fig. 2a are generic, e.g., for all wave functions of the rectangle [15].

Figure 2c shows a corresponding example for the open billiard at a frequency where there is no leakage current. Again one nds a complete correspondence with theory.

## IV. CURRENT DISTRIBUTIONS

For the currents shown in the bottom panel of Fig.1 the distribution function of

has to be calculated. A similar problem occurred in our work on global and local level dynamics where the distributions function of r was needed [4]. With the




FIG. 4: Sam e as Fig. 3, but for the open billiard at 5.77 GHz, corresponding to Fig. 1c.

random -superposition-of-plane-waves approach the calculation of the averages is straightforward and yields [12]

for the distribution of the current components  $\boldsymbol{j}_x$  and  $\boldsymbol{j}_y$  , and

for the distribution of the modulus  $j = \frac{q}{j_x^2 + j_y^2}$  where the parameter

can again be taken directly from the experiment.




FIG.5: D istribution of j on a logarithm ic scale as in Fig.3d, but for the scanned wave function at 5.19 GHz, shown in Fig.1a.

Figures 3 and 4 show the distributions for  $j_x$ ,  $j_y$ , and j for the same patterns depicted in Figs. 1b and c, respectively. Once more theory is in complete accordance with the experiment if there are no leakage currents, but is not able to describe the experiment otherwise. For comparison, Fig. 5 shows the current distribution for the scarred wave function in Fig.1a. Not unexpectedly there

are again signi cant deviations from the universal behavior. The excess at large current values in particular is a consequence of the strong leakage currents observed at positions of high j f values (see Fig. 1a).

In particular we observe identical distributions for  $j_x$ and  $j_y$  in the ferrite billiard. This is no longer the case for the open billiard, where the maximum of the  $j_{\rm x}$  distribution is shifted signi cantly to negative values caused by the transport from the right to the left through the billiard.

## V. THE VORTEX SPATIAL AUTO-CORRELATION FUNCTION

A very useful quantity to characterize the vortex structure of a vector eld is the vorticity. Up to a factor 1/2 it is identical with the rotation of the current density,

The calculation of the corresponding distribution function P (!) follows exactly the same lines as for the current distribution and yields

can be taken directly from the experim ent.




FIG. 6: D istribution of the vorticity for the ferrite billiard at 6.41 GHz corresponding to Fig. 1b. The dashed line corresponds to Eq. (6), where =  $\frac{P}{h!^2 i}$ , see Eq. (7).

Figure 6 shows the vorticity distribution for the example shown in Fig. 1b for the ferrite billiard. The dashed line has been calculated from Eq. (6). Again the parameter was not tted but taken from the experiment.

For the wave function to be zero both real and in aginary part have to be vanish. As a consequence there are no longer nodal lines, but only nodal points. Each nodal point corresponds to a vortex in the corresponding ow pattern. Since the distance between neighboring node lines is of the order of half of a wave length both for real and in aginary part, the mean spacing between neighboring nodal points is of this order of magnitude as well.

U sing the random -superposition -ofplane waves approach, Berry and Dennis [16] calculated two types of vortex spatial auto-correlation functions, one of them called pair correlation function and de ned by

The norm alization  $g_0$  is determined such that g(r) ! 1for r ! 1. The other correlation function discussed by the authors, the charge auto-correlation function  $g_0$  (r), di ers from expression (8) only by the fact that the sign of the vorticity is taken into account,

Since for  $g_0$  (r) pairs of vortices with di erent senses of rotation enter with a negative sign, we have  $g_0$  (r) ! 0




FIG. 7: Vortex pair correlation function  $\hat{g}(x)$  for the ferrite billiard, see Eq. (8), where x = kr and  $\hat{g}(x) = g(r)$ . The solid line has been calculated from an integral expression given by Berry and Dennis [16].

for r! 1. For the explicit expressions of g(r) and  $g_0$  (r), which are quite complicated, the reader is referred to the original work. From the spatial auto-correlation function the distribution of nearest distances between vortices can be calculated which has been studied by Saichev et al. [17].

The experimental study of the vortices is more dicult than that of the dierent types of distribution functions discussed above, since it involves the determination of the zeros of real and in aginary part of the wave function. Because of the applied grid period of 5mm, the precision in determining distances is only moderate, and, more problem atically, it is impossible to resolve vortices lying very close together which is very often the case for vortices with dierent sign. In this situation a reliable determination of the distance distribution is not possible. The determination of the charge correlation function  $g_0$ , too, did not work because of the cancellation of

positive and negative term s, leading to an intolerable increase of the noise level. But the pair correlation function g could be determ ined. Since the wave number k enters the pair correlation function as a scaling factor only, we may write  $g(r) = \hat{g}(x)$ , where x = kr. This allows to improve the statistics by superimposing the results from di erent frequencies. Figure 7 shows the resulting pair correlation function  $\hat{g}(x)$  obtained from current patterns at 43 di erent frequencies in the range from 4 to 8 G H z, by extracting the found vortices by hand. The frequency regimes showing a ow into the probe antenna were carefully avoided. Though the statistics is only m oderate, the oscillations predicted by theory are clearly observable. The hole observed in the experim ental histogram at sm all distances re ects the above mentioned di culty

to resolve closely neighboring vortices.

We can thus conclude that the experimentally obtained distributions of wave function amplitudes, currents, and vortices are in quantitative agreement with the predictions of the random -superposition-of-plane-waves approach, if the wavefunction is chaotic.
