The penetration depth in $Sr_2R uO_4$: Evidence for orbital dependent superconductivity

A bstract. { The apparent T^2 -tem perature dependence of the London penetration depth in Sr_2RuO_4 is discussed on the basis of a multi-gap model with horizontal line nodes. The in uence of the nodes in combination with nonlocal electrom agnetic response leads to low-tem perature behaviors as $T^2 \ln T$ in the London limit and as T^2 in the P ippard limit. These behaviors appear only at very low tem perature. On the other hand, the interplay of the superconductivity of di erent bands is responsible for the observed T^2 -like behavior over the wide tem perature range. The experimental data can be tted well with a set of material parameters as was used in the specie cheat tting.

Since the discovery of the superconductivity in the layered perovskite compound Sr_2RuO_4 [1], much e ort has been devoted to the identication of its C coper pairing symmetry 2]. An early theoretical prediction of the spin-triplet pairing [3] is supported by the NMR K night shift measurement, which shows no change in the spin susceptibility on passing through the superconducting transition at T_c (= 1.5K) [4]. Moreover, SR measurements reveal the appearance of an intrinsic magnetism with the onset of superconductivity, which was attributed to pairing with broken time reversal symmetry [5]. These two experiments consistently identify the superconducting phase as the chiral p-wave state $d_1(k) = z_{-1}(T)(k_x^2 + ik_y^2)$, an analog to the A-phase of the super uid ³He. Here a representative form of the gap function,

 $(k) = (i \ y)$ d (k), is given in the d-vector representation 3[6]. Such a gap function arises in a weak-coupling theory for a two-dimensional Ferm i liquid with spin-orbit coupling [3, 7, 8]. This pairing state suggests a nodeless quasiparticle gap, 1 (T).

As sample quality in proved, however, power-law temperature dependence was observed in various quantities, such as speci c heat 9], NQR relaxation rate [10], therm alconductivity [11, 12] and ultrasonic attenuation [13]. These notings seem ed to indicate the unexpected existence of line nodes in the gap and motivated the investigation of models with vertical (pseudo) line nodes [14, 15, 16]. Heat transport measurements, however, gave no evidence of strong anisotropy of the gap in the basal plane, essentially excluding vertical line nodes [11, 12]. If at all, nodes would have to be horizontal, i.e., parallel to the k_x - k_y -plane [6]. Still such a gap structure alone seem ed insu cient to account for all the therm odynamic data.

M otivated by these experim ental situations and the fact that Sr_2RuO_4 has three conduction bands, called , and , Zhitom irsky and Rice (ZR) proposed a multi-gap scenario, in c EDP Sciences

which the prim ary nodeless gap, $d_1 (k)$, is developed in the single \active" band (-sheet), while the secondary gaps with horizontal line nodes of the form,

appear in the other (\passive") bands (, -sheets) through an interband Cooper pair scattering [17]. Then this scenario was used to give a very good t in the speci c heat over the whole tem perature range. The picture of an orbital dependent superconductivity (ODS) [18] provides a consistent view in m any other aspects. Identifying the -band as the dom inant band for superconductivity m akes sense in view of the fact that ferrom agnetic spin uctuations, bene cial to spin-triplet pairing, are slightly enhanced in this band [19, 20], while the other two bands show very strong spin correlations for the nite incom m ensurate w ave vector [21, 22]. In addition, the chiral p-wave state is stabilized by spin-orbit coupling relative to all other triplet states, if the -band is dom inant [23].

On general grounds, how ever, all scenarios involving line nodes are ham pered by the fact that line nodes can appear in a spin triplet pairing state only accidentally, if spin-orbit coupling is present. B bunt has shown that, in general, only point nodes appear by sym m etry reasons [24]. In order to generate rigorous line nodes the ZR scenario requires exclusively the interlayer pairing for the - bands. Any inplane pairing component would leave point nodes only, in a rigorous sense. N evertheless, we will assume the presence of horizontal line nodes for the time being, and later discuss consequences of the presence of the inplane pairing components.

In contrast to other therm odynam ic quantities, the apparent T²-dependence over wide tem perature range below 0.8 K observed in the London penetration depth, (I), for elds along the z-axis, [25] seem s incompatible with line nodes, since a simple-m inded theory would lead a T-linear behavior. Bonalde et al. ascribed T²-behavior in their data to nonlocal e ects, as was discussed by K osztin and Leggett (KL) in the context of the high-tem perature superconductors [25, 26]. The KL-theory is based on the fact that for the large lim it of the G inzburg-Landau (GL) parameter = (0)= $_0$ (London limit), a small portion of the Fermi ¹) should be treated in the nonlocal lim it. This surface in the vicinity of the nodes (would alter the power-law from the linear to a T²-behavior. While this discussion is applicable rigorously for very large 🛛 and in the very low-tem perature regim e only, B onalde et al. argued that the relatively small (2-3) of SgR uO₄ could lead to a wider tem perature range, even **(**0**)** ¹ 0:6T_c, below which the KL renorm alization appears. A lthough there up to T were several further theoretical explanations for the peculiar power-law behavior [16, 27, 28], a clear understanding has not been achieved yet.

In this Letter, we show that the rigorous asymptotic power-law behaviors in (T) due to nonlocale ects are restricted to very low temperatures in both the London (1) and the P ippard (1) lim its. Instead, based on the ODS model the overall T²-dependence and beyond can be tted welland consistently with the speci cheat data. Thereby the non-locality of the electrom agnetic response is essential for the tting of the experimental data and the resultant G inzburg-Landau (G L) parameter = 2.3 is good agreement with the experimental value.

We restrict our discussion to the clean lim it and choose the sample geometry so that the x-z-plane surface is exposed to magnetic eld parallel to the z-axis, so that both the vector potential A and the screening currents j are oriented parallel to the x-axis. The penetration depth is obtained from the electrom agnetic response kernel, K (q;T) = (4 = c)j(q)=A(q), as

assuming a specularly re ecting surface.

We only consider intraband pairing so that in the lowest order each band separately contributes to the response kernel,

H ere the zero-tem perature penetration depth in the London lim it has been de ned as $_{0} = \frac{1}{m} \frac{1}{c^{2}=4} \frac{1}{ne^{2}} = \frac{1}{m} \frac{1}{n} \frac{1}{m} \frac{1}{n}$, where n_{1} and m_{1} are the density and the electrive mass of electrons in the band l. The ratio, $_{1} = (n_{1}=m_{1})=(n=m)$, gives a measure for the contribution of each band to the current density at T = 0. The dimensionless response kernel has the form

where $!_n = (2n + 1)$ T is the ferm ionic M atsubara frequency. Here, we have assumed cylindrical Ferm i surfaces for simplicity and used $(0 j l_1 j = 0 k)$ q = 0 for the present geometry. The nonlocality appears via $Q_1 = qv_{F_1}=2 = (q=2_{01})_{-1}(0)$ where the dimensionless variables $q = q_0$ and $_{01} = _{0} = _{01}$ with the coherence length for each bands, $_{01} = v_{F_1} = _{-1}(0)$, were introduced. For nodeless gaps or gaps with horizontal line-nodes, the angular integral in eq. (4) yields

where $g(z) = \begin{pmatrix} p \\ 1+z^2 \end{pmatrix}$ 1)=z. At zero tem perature, replacing 2 T $\begin{bmatrix} P \\ n \end{bmatrix}$ by $\begin{bmatrix} R_1 \\ 1 \end{bmatrix}$ d!, we obtain

where $g_0(z) = (2=z) \tan^1(z) \ln(1+z^2)=z^2$.

We consider now the contributions from the bands with horizontal line nodes, i.e., the passive bands in the ZR scenario (l = 2), since their quasiparticles would dominate the low-temperature behavior, while those in the totally gapped dominant band are inactive. A nalogous to the KL theory, we evaluate the average over k_z for an approximate gap form in the vicinity of the nodes. It leads to

where $K_1(0;T) = 2 \ln 2 (T = 2(0))$ is the usual T-linear contribution to the kernel and $t = T = T_L$ with $T_L = Q_2 = q = (=2_{02})_2(0)$. For horizontal line nodes the universal function F (z) has a form di erent from the KL-expression:

and f (x) = 1= (e^x + 1). Note that F (z) has the asymptotic form, F (z) $^2=6z \ln 2$ for z 1 and 1 z=6 ln 2 for z 1. Since K_2 (q;0) = 1 q=6 $_{02}$ 1 in the London limit ($_{02}$ 1) (eq. (6)), the deviation of (T) from its zero-temperature value, (0) (= $_0$), is given by

An appropriate estimate of eq. (9) gives the following asymptotic expression for $T < 0.05T_L$,

In the P ippard lim it ($_{02}$ 1) we use $g(z) = z^2$ in eq. (5). Then, the M atsubara sum can be evaluated straightforwardly

From eq. (2) we obtain

where $(0) = {}_{0} = (2 = 3^{p} - 3)(=4_{02})^{1=3}$. At low temperature the main contribution in eq. (11) comes from k_{z} =c. Evaluating the k-average in eq. (11) or using the large-q limit of eqs. (6) and (7), the low-temperature expression is given by

where $T_P = _2(0)=$. The deviation from the T²-dependence becomes visible for T larger than $0.3T_P$. Note that the prefactor of the T² term in both lim its is determined by the inverse of the characteristic temperatures, i.e. the smaller $_2(0)$ gives the faster increase of (T) close to T = 0.

In conclusion, the power-law behaviors due to nonlocale ect are restricted to tem perature below T . For any , T has a value between both limits, i.e., $0.05T_L < T < 0.3T_P$, which is much lower than $_2(0)$. Since T $< 0.17T_c$ even with the maximal gap, $_2(0) = _{BCS} = 1.76T_c$, it already excludes a reasonable thing of the T²-behavior with a single-gap model including horizontal line nodes for Sr_2RuO_4 .

We now turn to the multi-gap scenario for $\mathrm{Sr}_2\mathrm{RuO}_4$ [17], in which the temperature dependence of the gap magnitudes are given by an elective two-band model; = = $_2$ (T) and = $_1$ (T). In the gap equations, the pairing interactions are defined as $V_{11} = -g\,\hat{k}-\hat{k}^0, V_{22} = -2g_4\,(\hat{k}-\hat{k}^0)\cos(k_zc=2)\cos(k_z^0c=2)$ for intraband coupling and $V_{12} = -2g_3\,(\hat{k}-\hat{k}^0)\cos(k_z^0c=2)$ for the interband C coper pair scattering. We estimate various other material parameters from the definite averaged) band masses over their carrier densities, $V_F = 0.68v_F$, the (Fermi surface averaged) band masses over their carrier densities, $V_{11} = 0.20 : 0.44 : 0.36$ and the densities of states at the Fermi level, $N_{01} : N_{02} = 0.57 : 0.43$. We is the parameters as g = 0.4 (in units of the inverse total density of states), $g_2 = g_1 = 0.85$ and $_{02} = _{01} = (-_2(0) = -_1(0)) = 0.68$. This leaves two free parameters for thing: $g_3 = g_1$ and $_{01}$.

Figure 1 shows that the tem perature dependence of the gaps $_1(T)$ for di erent interband couplings $g_3=g_1$. In the absence of interband coupling $(g_3 = 0)$ a second phase transition occurs for $_2$ at tem perature $T=T_c$ 0.2 yielding a gap of order $_2(0)=_{BCS}$ 0.2. The stronger the interband coupling the less visible the feature of this transition becomes. For strong interband coupling all gaps are tied together and act like a superconductor with a single

order parameter. The ZR tting of the speci c heat suggests that we are in an intermediate regime of interband coupling, $g_3=g_1 = 0.07$.

In Fig. 2 we compare the calculated penetration depth for various values of $g_3=g_1$ and $_{01} = 2.0$ with the experimental data by Bonalde et al. [25] with $_{01} = 700A$ [29]. For the weak interband coupling, the penetration depth increases rapidly at low temperature below $T=T_c$ 0.2, which rejects both the smallness of the passive-band gap, $_2$ (0), and the rapid decrease of $_2$ (T) at $T=T_c$ 0.2. For the strong interband coupling, the T²-increase due to the passive bands is easily overshadowed by the active-band contribution, showing a monotonous

increase with concave shape. Interm ediate interband couplings give a tem perature dependence with a weak convexo-concave shape by subtly combining the contributions from both bands. The experimental data indeed exhibit this type of behavior. The moderate interband coupling, $g_3=g_1=0.07$, which is exactly the same parameter as ZR to the specific heat measurement, also reproduces the observed tem perature dependence over the wide tem perature range.

Next we x the interband coupling constant to the value optim ized by ZR $g_i=g_1 = 0.07$ and use $_{01}$ as the only free tting parameter. Figure 3 shows curves for various values of $_{01}$, where the resultant GL parameter for the active band, $_1 = (0)=_{01}$, is shown in the parenthesis. The slopes of the whole curve monotonously decrease starting from the London lim it and approaching the P ippard lim it. Irrespective of a measure of non-locality, all curves show the convexo-concave shape. The best tting for the experimental data is given by $_{01} = 2.0$ with $_1 = 2.3$, which is slightly smaller than the generally cited value 2:6 [29]. We also estimate $_{2}=_{1}=_{01}=_{02}$ 0:66. The small discrepancy between measured and ours is very plausible, in view of the fact that = 2.6 results from the measurement of the London penetration depth by means of SR in the mixed state. The order parameter in the passive bands with a larger coherence length is more easily dim inished by a magnetic

eld than that of the active band. Consequently, the SR-measurem ent observes a larger London penetration depth, where screening currents from the - bands are reduced. This explains the smaller value of the very-low - eld penetration depth as measured by Bonakle et al. [25, 29]. Our t suggests a low - eld value of (0) 16000 compared to SR-derived value of (0) 1900A which is rather likely only due to the -band contribution [29].

So far we have assumed horizontal line nodes in the passive bands due to interlayer C ooper pairing (ZR scenario). As an opposite limit, we consider the nodeless gap, $d_2 = z_2$ (T) ($\hat{k_x} + i\hat{k_y}$), corresponding to the case of the intra layer pairing only. Trying the same thing procedure we nd only a minor di erence at very low temperatures as shown in Fig.3 (this solid line). While the di erence is small in (T), the removal of the nodes would be more easily visible in the speci c heat data.

We have shown that the nonlocal response for the horizontal line node yields $T^2 \ln T$ behavior in the London lim it, while T^2 power law in the P ippard lim it yet at quite low tem - perature. On the other hand, the ODS m odel in combination with nonlocal response naturally explains the apparent T^2 -dependence in a quantitatively consistent way with the speci c heat

tting. Concerning the question of nodes, it seems that the London penetration depth data are less a ected by nodes than the speci c heat data. Eventually, a more anisotropic but nodeless gap shape would likely be su cient for good ts in any case. In view of the com plicated quasiparticle spectrum in the multi-gap com pound Sr_2RuO_4 , it is di cult from present experimental data to come to conclusive answer concerning the detailed gap shape.
