Abstract

We consider nonequilibrium systems with complex dynamics in stationary states with large uctuations of intensive quantities (e.g. the tem perature, chemical potential or energy dissipation) on long time scales. Depending on the statistical properties of the uctuations, we obtain diemente ective statistical echanical descriptions. T sallis statistics follows from a ²-distribution of an intensive variable, but other classes of generalized statistics are obtained as well. We show that for small variance of the uctuations all these diement statistics behave in a universal way.

E instein never accepted Boltzm ann's principle $S = k \log W$, because he argued that the statistics (W) of a system should follow from its dynamics and, in principle, could not be postulated a priori [1, 2]. Remarkably, the Boltzm ann-Gibbs (BG) statistics works perfectly for classical systems with short range forces and relatively simple dynamics in equilibrium . A possible consequence of Einstein's criticism is that for systems with su ciently com plex dynamics, other than BG statistics might be appropriate. Such a statistics has indeed been proposed by T sallis [3] and has been observed in various com plex system s [4] [17]. For these types of system s the form alism of nonextensive statistical mechanics [19, 20] is a useful theoretical concept, in the sense that a more general Boltzm ann factor is introduced which depends on an entropic index q and which, for q = 1, reduces to the ordinary Boltzm ann factor. Applications of the form alism have been m ainly reported for multifractal systems, systems with long-range interactions and nonequilibrium system s with a stationary state. Several types of generalized stochastic dynam ics have been recently constructed for which T sallis statistics can be proved rigorously [4, 5, 6]. Physical applications include 2-d and 3-d turbulence $[7]{[14], m \text{ om entum spectra of hadronic particles produced in e⁺ e$ annihilation experim ents [15, 16], the statistics of cosm ic rays [17], and m any other phenom ena.

In this letter we will quite generally deal with nonequilibrium systems with a long-term stationary state that possess a spatio-tem porally uctuating intensive quantity. We will show that after averaging over the uctuations one can obtain as an elective description not only T sallis statistics but an in nite set of more general statistics, which we will call 'superstatistics'. We will consider several concrete examples. A parameter q can be de ned for all these new statistics and given a physical interpretation. For q = 1 all superstatistics reduce to the Boltzm ann factor electron of or small amplitudes of the methanics. O ne of our main results is universality for small amplitudes of the

uctuations. If the variance of the uctuations is small, then the rst-order corrections to the ordinary Boltzm ann factor are the same for all superstatistics (i.e. those of T sallis statistics). On the other hand, for large variances quite di erent behaviour from T sallis statistics can be generated. We calculate the higher-order correction terms of various examples of superstatistics.

Experim ental evidence for superstatistics that is nearly T sallis but has tiny corrections beyond T sallis has very recently been provided by Jung and Sw inney [23], by careful analysis of velocity uctuations in a turbulent Taylor-C ouette ow. M oreover, experim ental studies from fusion plasm a physics provide possible evidence for non-T sallis superstatistics based on F- distributions [24]. All this illustrates the need for a more general approach towards generalized statistics for complex dynam ical system s.

Let us now outline the theory. Consider a driven nonequilibrium system that is composed of regions that exhibit spatio-tem poral uctuations of an intensive quantity. This could be the inverse tem perature , or equally well the pressure, chem ical potential, or the energy dissipation rate in a turbulent

uid [5, 11, 12]. We will select the temperature here as our uctuating quantity but it could be anything of the above. We note that even the uctuation theory of Onsager and Machlup does not treat this case and is restricted to uctuations of extensive therm odynam ic variables [18]. We consider a nonequilibrium steady state of macroscopic system, made up of many smaller cells that are temporarily in local equilibrium. Within each is approxim ately constant. Each cell is large enough to obey statistical œll assigned to it, according to a probability mechanics, but has a di erent density f (). We assume that the local tem peratures in the various cells change on a long time scale T. This time scale T is much larger than the relaxation time that the single cells need to reach local equilibrium. It is clear that our model is a suitable approximation for a continuously varying tem perature eld that has spatial correlation length of the order of the cell size L and a tem poral correlation length T.

A Brownian test particle moves for a while in a certain cell with a given temperature, then moves to the next cell, and so on. Its velocity v obeys

$$\underline{\mathbf{v}} = \mathbf{v} + \mathbf{L} (\mathbf{t}); \tag{1}$$

where L (t) is G aussian white noise. The inverse tem perature of each cell is related to the parameters and $^{by} = = ^{a}$. However, unlike ordinary Brownian motion, the parameter is not constant but changes tem porally on the time scale T and spatially on the scale L. These changes are ultimately produced by the very complex dynamics of the environment of the Brownian particle. It has been proved by one of us [5] that after averaging over the uctuating this simple generalized Langevin model generates T sallis statistics for v if is a ²-distributed random variable. Moreover, the obtained distributions for v were shown to t quite precisely distributions of longitudinal velocity di erences as measured in turbulent Taylor-C ouette ow s [5, 10], as well as measurements in Lagrangian turbulence [12, 13].

Let us here generalize this approach to general distributions f() and general (e ective) Ham iltonians. In the long-term run (t >> T), the station-

ary probability density of our nonequilibrium system arises out of Boltzm ann factors e E associated with the cells that are averaged over the various uctuating inverse temperatures . If E is the energy of a microstate associated with each cell, we may write

$$B(E) = \int_{0}^{Z_{1}} df()e^{E}; \qquad (2)$$

where B is a kind of elective Boltzm ann factor for our nonequilibrium system, the superstatistics of the system. In a sense, it represents the statistics of the statistics (e ^E) of the cells of the system. B (E) may signil cantly dier from the ordinary Boltzm ann factor, which is recovered for f() = (0). For the above simple example of a Brownian test particle of mass 1 one has $E = \frac{1}{2}v^2$, so that the long-term stationary state consists of a superposition of G aussian distributions e ^E that are weighted with the probability density f() to observe a certain . But our consideration in the following applies to arbitrary energies E associated with the cells, not only $E = \frac{1}{2}v^2$. The central hypothesis of our paper is that generalized Boltzm ann factors of the form (2) are physically relevant for large classes of dynam ically complex systems with uctuations.

One immediately recognizes that the generalized Boltzm ann factor of superstatistics is given by the Laplace transform of the probability density f(). Although there are in nitely many possibilities, certain criteria must be fullled which signi cantly reduce the number of physically relevant cases:

- f () cannot be any function but must be a norm alized probability density. It may, in fact, be a physically relevant density from statistics, say Gaussian, uniform, chi-squared, lognorm al, but also other, as yet unidenti ed, distributions could be considered if the underlying dynam ics is su ciently com plex.
- 2. The new statistics must be normalizable, i.e. the integral $\begin{bmatrix} R_1 \\ 0 \end{bmatrix}$ B (E)dE must exist, or in general the integral $\begin{bmatrix} 0 \\ 0 \end{bmatrix}$ (E)B (E)dE, where (E) is the density of states.
- 3. The new statistics should reduce to BG -statistics if there are no uctuations of intensive quantities at all.

We will now consider several examples of superstatistics (later we will see what is universal to all of them). The distribution f() is ultimately determined by the invariant measure of the underlying dynamical system

and a priori unknown. Gaussian – uctuations would generate one of the sim plest f (), but these types of models are unphysical since they allow for negative with some non-zero probability. Instead, we need distributions where the random variable is always positive.

Uniform distribution

As a very simple model where everything can be calculated analytically let us rst consider a uniform distribution of on some interval [a;a + b], i.e.

$$f() = \frac{1}{b}$$
 (3)

for 0 = 0 a a + b, whereas f() = 0 elsewhere. The mean of this distribution is

$$_{0} = a + \frac{b}{2} \tag{4}$$

and for the variance one obtains ${}^2 = h {}^2i \qquad {}^2_0 = b^2 = 12$. The superstatistics of this model follows from the generalized Boltzmann factor

$$B = \int_{0}^{Z_{1}} e^{-E} f() d = \frac{1}{bE} e^{(0 \frac{1}{2}b)E} e^{(0 + \frac{1}{2}b)E} :$$
(5)

This is normalizable for any E 0. Hence this is a reasonable model of superstatistics. For small be one obtains, by series expansion of $e^{\frac{1}{2}bE}$,

$$B = e^{-b^{E}} (1 + \frac{1}{24}b^{2}E^{2} + \frac{1}{1920}b^{4}E^{4} + ...)$$
(6)

Clearly, for b! 0 ordinary statistical mechanics is recovered.

2-level distribution

Suppose the subsystem s can switch between two di erent discrete values of the tem perature, each with equal probability. A physical example m ight be a B rownian particle that can switch between two di erent states with di erent friction constants, or two di erent chem ical potentials. The probability density is given by

f () =
$$\frac{1}{2}$$
 (a) + $\frac{1}{2}$ (a + b): (7)

The average of is again given by

$$_{0} = a + \frac{b}{2}$$
 (8)

and for the variance one obtains ${}^2 = h {}^2i$ ${}^2_0 = b^2=4$. The generalized Boltzm ann factor becomes

$$B = \int_{0}^{2} e^{-E} f() d = e^{-0E} \frac{1}{2} e^{\frac{1}{2}bE} + e^{\frac{1}{2}bE} :$$
(9)

This is normalizable for any E 0. For small be one obtains

$$B = e^{-b^{E}} \left(1 + \frac{1}{8}b^{2}E^{2} + \frac{1}{384}b^{4}E^{4} + \cdots\right)$$
(10)

G am m a-distribution

The assumption of a G amm a (or 2 -) distributed inverse temperature leads to T sallis statistics, so far the most relevant example of superstatistics. W e may write the G amm a distribution as

$$f() = \frac{1}{b(c)} \frac{1}{b} e^{-\frac{1}{b}}; \qquad (11)$$

where c > 0 and b > 0 are parameters. The number 2c can be interpreted as the elective number of degrees of freedom contributing to the uctuating . The average of is $_0 = {R_1 \atop 0} f()d = bc$ and for the variance of one obtains $^2 = b^2c$.

The G amma distribution naturally arises if n = 2c independent G aussian random variables X $_k$ with average 0 are squared and added. If we write

$$= \sum_{k=1}^{X^{n}} X_{k}^{2}$$
(12)

then this is G amma distributed with density (11). The average of is of course given by n times the variance of the G aussian random variables X_k . In this sense the G amma distribution arises very naturally for a uctuating environment with a nite number n of degrees of freedom.

The integration over yields the generalized Boltzm ann factor

$$B = \int_{0}^{Z_{1}} e^{E} f() d = (1 + bE)^{c};$$
(13)

i.e. the generalized Boltzm ann factor $(1 + (q \ 1)_{0}E)^{\frac{1}{q-1}}$ of nonextensive statistical mechanics [3, 19, 20] if we identify $c = \frac{1}{q-1}$ and $bc = _{0}$. It is norm alizable for c > 1 (if (E) = 1).

W e m ay also write B = exp f $c \log (1 + bE)$ g and expand the logarithm for sm all bE . The result can be written in the form

$$B = e^{-0E} (1 + \frac{1}{2}(q - 1))^{2} E^{2} - \frac{1}{3}(q - 1)^{2} {}^{3} E^{3} + ...)$$
(14)

where q is the entropic index of nonextensive statistical mechanics.

Log-norm aldistribution

The log-norm aldistribution

$$f() = \frac{1}{s^{2}} \exp \left(\frac{(\log \frac{1}{m})^{2}}{2s^{2}} \right)$$
(15)

yields yet another possible superstatistics (see also [21] for a related turbulence model); m and s are parameters. The average $_0$ of the above lognorm aldistribution is given by $_0 = m^{\frac{1}{W}} \overline{w}$ and the variance by $_{1}^{2} = m^{2}w$ (w 1), where $w = e^{s^2}$. The generalized Boltzm ann factor $B = {}_{0}^{1} f() e^{-E} d$ cannot be evaluated in closed form, but in leading order we obtain for sm all variance of the inverse temperature uctuations

$$B = e^{-0E} (1 + \frac{1}{2}m^2w (w - 1)E^2 - \frac{1}{6}m^3w^{\frac{3}{2}} (w^3 - 3w + 2)E^3 + ...): (16)$$

F-distribution

The last example we want to consider is that of a 2 [0;1] distributed according to the F-distribution [22]

$$f() = \frac{((v + w) = 2)}{(v = 2)} \frac{bv}{w} = \frac{v^2}{2} \frac{\frac{v}{2}}{(1 + \frac{vb}{w})^{(v + w) = 2}};$$
 (17)

Here w and v are positive integers and b > 0 is a parameter. We note that for v = 2 we obtain a T sallis distribution. However, this is a T sallis distribution in -space, not in E-space as in eq. (13).

The average of is given by

$$_{0} = \frac{W}{b(W - 2)}$$
(18)

and the variance by

$${}^{2} = \frac{2w^{2}(v + w - 2)}{b^{2}v(w - 2)^{2}(w - 4)};$$
(19)

The Laplace transform cannot be obtained in closed form, but for small variance of the uctuations we obtain the series expansion

$$B (E) = e^{-0E} 1 + \frac{w^{2}(v + w - 2)}{b^{2}v(w - 2)^{2}(w - 4)}E^{2}$$
$$\frac{4w^{3}(v + w - 2)(2v + w - 2)}{3b^{3}v^{3-2}(w - 2)^{3}(w - 4)(w - 6)}E^{3} + \dots (20)$$

F-distribution in -space have also been recently studied by Sattin and Salasnich [24], who point out possible applications in fusion plasm a physics.

W hile in general the large-E behavior is di erent for all superstatistics (it strongly depends on the function f()), we now show that the low-E behavior is universal. We note that for the above ve distribution functions the rst-order corrections to the Boltzmann factor e 0E in eqs. (6), (10), (14), (16), (20) can all be written in a universal form. When expressing the generalized Boltzmann factor in term softhe average temperature $_0$ and the variance 2 of the various probability densities f(), one always obtains the same result for small ,

$$B = e^{-0E} (1 + \frac{1}{2} {}^{2}E^{2} + O({}^{3}E^{3})); \qquad (21)$$

where is the standard deviation of the distribution f(). Thus in the lim it of approaching ordinary statistics, the generalized Boltzm ann factor of superstatistics has a universal quadratic correction term $(1 + \frac{1}{2} {}^2 E^2)$.

Let us now prove this universality. For any distribution f () with average $_0 = h i$ and variance $_2^2 = h^2 i \int_0^2 we can write$

$$B = he^{E} i = e^{0E} e^{+0E} he^{E} i$$

$$= e^{0E} he^{(0)E} i$$

$$= e^{0E} 1 + \frac{1}{2} {}^{2}E^{2} + \frac{X^{1}}{r=3} \frac{(1)^{r}}{r!} h(0)^{r} i E^{r} : (22)$$

Here the ∞ e cients of the powers E ^r are the r-th m om ents of the distribution f () about the m ean, which can be expressed in terms of the ordinary m om ents as

$$h(_{0})^{r}i = \begin{array}{c} X^{r} & r \\ j = 0 \end{array} h^{j}i(_{0})^{r} ^{j}: \qquad (23)$$

Due to the universality proved above, it now makes sense to de ne a universal parameter q for any superstatistics, not only for T sallis statistics. By comparing eq. (14) and (21), we generally de ne a parameter q by the relation

$$(q \ 1) \ _{0}^{2} = \ ^{2};$$
 (24)

or equivalently

$$q = \frac{h^{2}i}{h^{2}i^{2}}$$

For example, for the log-normal distribution we obtain from eq. (25) q = wand for the F-distribution $q = 1 + \frac{2(v+w-2)}{v(p-4)}$. The physical meaning of this generally de ned parameter q is that $q = 1 = -\frac{1}{0}$ is just the coeccient of variation of the distribution f (), de ned by the ratio of standard deviation and mean. If there are no uctations of at all, we obtain q = 1 as required. For small E the corrections to the ordinary Boltzm ann factor e 0E are universal and given by the factor $(1 + (q = 1)) {}^{2E}_{0} {}^{2}$

Since for small E all superstatistics are the same and given by T sallis statistics, we also have a maximum entropy principle for the normalized Boltzm ann factors of all our superstatistics in terms of the T sallis entropies [3, 19] with an entropic index q given by eq. (25). For su ciently small variance of the uctuations they all extrem ize the T sallis entropies subject to given constraints, no matter what the precise form of f() is.

However, di erences arise if E is not small. Then there are many different superstatistics described by di erent B (E), and the densities given by B (E) do not extrem ize the T sallis entropies in general. Rather, as shown very recently by T sallis and Souza [25], they extrem ize more general classes of entropy-like functions. The Boltzm ann factor of the exam ples of super-statistics that we considered above, if expressed in terms of the universal param eters q and $_0$, can be written as

B (E) =
$$e^{-0E}$$
 (1 + $\frac{1}{2}$ (q 1) ${}_{0}^{2}E^{2}$ + g (q) ${}_{0}^{3}E^{3}$ + :::); (26)

where the function g(q) depends on the superstatistics chosen. W e obtain

$$g(q) = 0$$
 (uniform and 2 level) (27)
= $\frac{1}{(q-1)^2}$ (C amm a) (28)

$$= \frac{1}{-(q^3 + 2)} (log normal) (29)$$

$$= \frac{1}{3} \frac{(q \ 1)(5q \ 6)}{3 \ q} \quad (F \ w \text{ ith } v = 4):$$

For su ciently large variance 2 or energy E one can distinguish between T sallis statistics and other superstatistics by the third-order term g (q) $_0^3$ E 3 , which describes the rst signi cant di erences between the various superstatistics and hence provides more information on the underlying complex dynam ics. In the turbulence applications described theoretically in [5, 11, 12] and experimentally in [10, 7], the uctuating intensive quantity is related to the energy dissipation rate of the ow, and the uctuations of this quantity are indeed large. Moreover, the energy E essentially corresponds to the square of local velocity di erences in the uid, and these are also measured up to very large values. Therefore these experiments can well provide precise information about the kind of superstatistics needed to describe the complex dynam ics.

An interesting question is what type of averaging process is the physically m ost relevant one for a generic system with intensive parameter uctuations. We may either work with unnormalized Boltzmann factors e E that are and then nally normalize by doing the integration over averaged over all energy states E (type-A superstatistics), or we may work with locally normalized distributions $p(E) = \frac{1}{Z(E)}e^{-E}$ and average those over all (type-B superstatistics). Since in general the normalization constant Z depends on , the result will di er slightly. However, case B can be easily reduced to case A by replacing the distribution f() by a new distribution f() :=CZ()¹f(), where C is a suitable norm alization constant. In other words, type-B superstatistics with f is equivalent to type-A superstatistics with f. Our formula (25) relating q and the variance of the uctuations is valid for both type-A and type-B superstatistics, just that all expectations h:::i m ust be formed with either f (type-A) or f (type-B). For example, if $E = \frac{1}{2}u^2$, then Z() = p = and hence f() $^{1=2}f()$. If f() is given by the -distribution eq. (11), then type-A superstatistics yields $q = 1 + \frac{1}{c}$, whereas

type-B yields $q = 1 + \frac{2}{2c+1}$.

To sum marize, in this letter we have introduced a class of generalized statistics, which we have called 'superstatistics'. T sallis statistics is a special case of these superstatistics. The dynam ical parameter q of eq. (25) can be de ned for all these new statistics. For sm all variance of the uctuations we have shown that there is universal behavior of all superstatistics. For large variance there are di erences which provide inform ation on the underlying com plex dynam ics. In general, com plex nonequilibrium problems may require di erent types of superstatistics. T sallis statistics is just one exam ple of m any possible new statistics. There is no a priori reason to expect that other superstatistics would not be present in nature, thus con ming the relevance of E instein's remark.
