# A form factor approach to $n$ ite tem perature correlation functions in $\mathrm{C}=1 \mathrm{CFT}$

#### Abstract

The excitation spectrum of speci c conform al eld theories（CFT）with central charge c＝1 can be described in term s of quasi－particles w ith charges $Q=p ;+1$ and fractional statistics properties． U sing the language of Jack polynom ials，we com pute form factors of the charge density operator in these CFTs．W e study a form factor expansion for the nite tem perature density－density correlation function，and nd that it shows a quidk convergence to the exact result．T he low－tem perature behavior is recovered from a form factor $w$ ith $p+1$ particles，while the high－tem perature lim it is recovered from states containing no m ore than 3 particles．


## I．INTRODUCTION

O ne of the extraordinary features of low－dim ensional condensed $m$ atter system $s$ is that they possess fractional characteristics．Very soon after the discovery of the fractional quantum $H$ all e ect，it was understood that the excitations of such states of $m$ atter carry both fractional charge and fractional exchange statistics．Later，H aldane 1］proposed an interpretation of these statistics as being exclusion statistics，a concept that can be de ned for any dim ension．It states that the presence of a particle i restricts the dim ension of the $H$ ilbert space that is available to another particle $j$ by an am ount $g_{i j}$ ，called the exclusion statistics param eter．This generalizes the $P$ auliprinciple for ferm ions．

The low－energy e ective theory for a fractionalquantum H all（fqH）system is a chiralconform al eld theory（CFT）， and it has been found［分］that these edge theories can be analyzed in term $s$ of quasi－particles w ith fractional charge and statistics．M ore general chiral R CFT spectra can be buitt out of fractional statistics excitations through what is known as the \universal chiral partition function＂［3］．In the follow ing，we will be interested in the edge CFT of a principal Laughlin state at lling fraction $=1=p$ ，where $p$ is an integer．The edge theory is that of a com pacti ed boson at radius $R^{2}=\mathrm{p}$ ．The chiralH ibert space of the theory has been understood 著］as a collection ofm ulti－particle states built out of fundam ental quasi－particle excitations．For $=1=\mathrm{p}$ ，they are edge electrons，of charge（ e），and edge quasi－holes，of charge（ $e=p$ ），both described by prim ary elds of the CFT．

It was shown［2，4］that these quasi－particle excitations obey fractional（exclusion）statistics based on the $m$ atrix

It $m$ eans that edge electrons and edge quasi－holes are $p-$ and $1=p-o n s, w$ ith no $m$ utual exchusion．The $g=p$ and $g=1=p$ particles en joy duality properties，in that their therm odynam ic distribution functions are dual to each other．
$T$ hese properties are rem in iscent of the C alogero－Sutherland（CS）model．Indeed，the chiralCFT for $=1=\mathrm{p}$ can be identi ed w th the continuum $\lim$ it of a CS m odelw ith interaction param eter equal to p fi．The relation betw een the fqH basis and the CS basis，de ned in term sof Jack sym m etric polynom ials，has been worked out in 6］．The Jack polynom ial technology is then available to com pute the action of observables on multi－particle states．From there， form factors can be obtained，as has been show $n$ in 目］．P roceeding in this $m$ anner，one does not have to rely on form factor axiom sfor integrable eld theories（F T ），since explicit com putations in a regularized CFT can be perform ed．

It has been proposed that，in integrable eld theories，correlation functions at nite tem perature can be represented in a form factor expansion．In such an expansion one adds the contributions to the correlator com ing from speci c multi particle states，each weighted by an appropriate m ulti－particle distribution function．There is an ongoing discussion on how precisely these ideas can be im plem ented for $\mathbb{F} T \mathrm{~s}$［1， $9,9,10$ ， 11$]$ ．In the context of $\mathrm{c}=1 \mathrm{CFT}$ ， a form factor expansion for a correlator can be com pared $w$ ith the exact result obtained thanks to the $K Z$ equations． In［6］，the expansion of a speci celectron $G$ reen function in the $=1=p$ chiralCFT was shown to converge quidkly

[^0]in term $s$ of the num ber of excitations considered. W e report here on progress $m$ ade in the sam e direction for the density-density correlation function, paying special attention to low-and high-tem perature lim its. At the technical levelour new results inchude
(i) an interpretation of the quasi-particle states $w$ ith non $m$ onotonic ordering of the $m i$ and $n_{j}$, in term sof vanishing' and scattered states', see eq. (26),
(ii) exact results for the action of the density operator on states $w$ ith up to three particles,
(iii) a precise de nition of the irreducible part of form factors $w$ ith $m$ ore than a single quasi-hole, in which case the sector index $Q^{\prime}$ plays an im portant role, see eq. 41),
(iv) consistency checks using the sum -rule eq. 17), based on the Sugaw ara form of the V irasoro operator in a CFT $w$ ith $U$ (1) sym m etry.

A nalyzing the form factor expansion for the density-density correlator, we dem onstrate that the leading asym ptotic behavior for low tem perature is given by the exciton' con guration w ith a single electron and p quasi-holes. M ore sunprisingly, we show by explicit computation that the high-tem perature lim it ( $m$ eaning the "! 0 lim it) of the $G$ reen function $h$ ( ") (")i, is recovered from form factors containing no $m$ ore than 3 particles. This rem arkable result is established w th the help of the identity eq. 54) satis ed by the therm odynam ic distribution function $\mathrm{n}_{\mathrm{g}}$ (") for particles satisfying exclusion statistics $w$ th param eter $g$.

O ur com putations in this paper can be view ed as a dry run for the com putation of non-trivial transport com putations in system s that are not CFT s but that do have quasi-particles w th well-de ned exclusion statistics properties (exam ples are niteN CS models or H aldane-Shastry spin chains). For the form alism to becom e of practical use, it needs further stream lining, possibly by $m$ aking and exploiting a connection $w$ ith the axiom atic approach to form factors, based on scattering data in IFT.

This paper is organized as follow s . In section $\mathbb{7}$, we introduce our notations by recalling the fqH basis construction in [6]. W e give the basic properties of the excitations and their expressions in term $s$ of Jack polynom ials. In section III, we give the expressions for form factors up to 3 particles for the density operator. In section IV we tum to the form factor expansion for the density-density correlation function. U sing the results of the preceding section, we show what are the di erent contributions to the low -tem perature and high-tem perature lim its. E xact num erical results w ill sustain our argum ents in favor of a quick convergence for the full correlation function.
II. FRACTIONALQUANTUM HALLSYSTEMSAND JACK POLYNOM IALS
A. fqH basis

The e ective low-energy theory for $a=1=p$ fqH system is a com pacti ed boson $w$ ith radius $R^{2}=p$, which is a chiralc = 1 CFT. The H ilbert space for this theory is obtained as a collection of sectors of zero $m$ odes. The sectors are labeled by an integer $Q$, which is the $U(1)$ electric charge $m$ easured in units of $e=p$. The partition function is

This Hilbert space can be understood as a collection ofm ulti-particle states, the fiundam entalquasi-particles being the edge electron and the edge quasi-hole, of charge $Q=p$ and $Q=1$ respectively. They are described by the conform alprim ary elds

$T$ he Fourier m odes of these operators can be interpreted as creation operators. T he independent m ulti-particle states that generate the chiralH ilbert space were identi ed to be

where $\mathbb{Q}>(Q=(\mathrm{P} 1) ;::: ; 1 ; 0)$ is the low est-energy state of charge $Q$. The identi cation was proven through the equality of the partition functions.

## B. Fractional statistics and duality

Fractionalexclusion statistics is a tool introduced by H aldane [] for the analysis of strongly correlated many boody system s. It is only based on the assum ption that the H ibert space is nite-dim ensional and extensive, i.e. particles are excitations of the considered condensed $m$ atter system, so it is a very generic concept. T he statistics are encoded in a $m$ atrix $g=\left(g_{i j}\right)$ corresponding to the reduction of the available Hilbert space for particle of type iby lling a one-particle state by a particle of type $j$. This is then a generalization of the P auliprinciple.
$T$ he them odynam ics for a gas of such particles have been w orked out by Isakov, o uvry and $W$ u (IO W ) 12, 13, 14]. $T$ he one-particle grand canonical partition functions $i$ and distribution functions $n_{i}$ are respectively given by the IO $W$ equations

In the case of f f $H$ at $=1=$ p the statisticalm atrix is given by (1), where electrons and quasi-holes are non-exclusive to each other. For $p=1$ we recover the Ferm i-D irac distribution functions, and for $p=2$ :

In general for $g$-ons, the distribution has a lim titing value for " ! 1 equal to $r_{9}^{m}$ ax $=1=g$ and an asym ptotic behaviour for" ! 1 equalto e".

T he transport properties of $g$-ons have been worked out in 15]. In the fqH case, one furtherm ore has a duality betw een $g$ - and $1=g$-ons, appearing in the identity

related to the fact that the rem oval of a $g$-on corresponds to the creation of $g 1=g$-ons. T his agrees w ith the physics of edge-to-edge tunneling in the fqH, in which the duality couples weak and strong back.scattering. It also m eans the quasi-particle basis proposed in 4) is not unique. Iso [5] proposed a basis m ade out of particles of one kind only,
lling up 1-particle states w ith energies extending over both positive and negative values. O ne shall see that our 'excitation' picture is $m$ ore practical to com pute physical quantities.

T he duality (9) can be used in the evaluation oftherm odynam ic quantities. In each Q sector, the partition function decom poses in a product of the partition function for electrons and that for quasi-holes. T hen, the speci cheat (or central charge) can be w ritten as a sum over the electron and the quasihole contribution, and using (9) one nds $c=1$ independent of $p$. D epending on the sign of an im posed Voltage, the $H$ all conductance is given by an electron or by a quasi-hole expression, of the general form

where $q=e=p$ or $q=e$ is the charge of the quasi-particle that carries the current. W e shall see that the dually is also instrum ental in the com putation of form factors and the evaluation of the form factor expansion.

> C. C orrespondence w ith Jack polynom ials

As for the fqH multi-particle basis, it has been shown to be in one-to-one correspondence w ith the orthogonal eigenbasis of the C alogero-Sutherland (C S ) m odel

It is then possible to build all the eigenstates of the H am iltonian using m ulti-J and - quanta. It is found that the states (4) are not $\mathrm{H}_{\mathrm{c}}$ s eigenstates, but that they rather act as head states that need to be supplem ented by a tail of subleading states. T he eigenbasis $w$ ill then be denoted by

From a di erent perspective, the analysis in has led to a basis of eigenstates of H cs , speci ed as
where the $U$ (1) charge $q$ runs over all integers, and $f g$ runs over all Y oung tableaus. $J_{f}^{1=p}{ }^{0} g$ is called a Jack sym $m$ etric polynom ial. They form a basis of the ring of sym $m$ etric functions $w$ ith a given scalar product. U seful details about them are reported in the appendix.

A one-to-one correspondence betw een fqH states (13) and CS states (14) is obtained through the identi cation (6]

O ur strategy willbe the follow ing. W e will set up the form factor expansion in term $s$ of the fqH basis, but do the actual com putation of the form factors using the representation in term s of Jack polynom ials, allow ing us to exploit what is known about them. In the appendix we present som e 'Jack polynom ial technology' that we have used for com puting the various form factors. In the next section we give an overview of the form factors that we obtained.

## III. OVERVIEW OFFORM FACTORS

In ref. [6], form factors for the electron creation operator have been studied. H ere we focus on the com putation of form factors for the charge density operator in the fqH edge at $\quad=1=p$. Its Fouriermodes are $i_{m}=i^{p} \bar{p} a_{m}=i p m$, so that it has a nice interpretation in the language of Jack polynom ials as a power sum. The form factors we are searching for are
< f g;qp m fi g;q> :

W e shallobtain them by developing the product of a pow er sum and a Jack polynom ialon the basis of Jack polynom ials. In the form er works on the C alogero-Sutherland model 16], where only zero-tem perature properties w ere com puted, one only considered form factors w th either the in or the out state equal to the vacuum . For such cases, only the expansion of power sum s on a basis of Jack polynom ials is needed. In the case of form factors of the general form 16, which appear in the form factor expansion for nite tem perature correlators, it is necessary to use a less traditional approach, com bining the expansion of the power sum $s$ in elem entary sym $m$ etric functions and the $P$ ieri form ula written in the appendix. This allows in principle to com pute any form factor. W e have obtained closed, analytic expressions for a num ber of form factors $w$ th up to three particles. To obtain them, we have proceeded by evaluating a few sim ple exam ples (the sm allerm's), con jecturing a general form, and then checking the con jectured form by using the follow ing sum rule

$W$ e report in the follow ing results for one-to three-particle states, in any $Q$-sector. In each case we give expressions for generalp, and then specify to the case $p=2$, which is the case analyzed num erically in section $\mathbb{I V}$.

## B. 2 quasi-particles

At the level of tw o particles, $m$ any-body e ects start to appear. It $m$ eans that the density operator is not acting on each particle individually, but rather on both at the sam e tim e.

$T$ his rule can be extended to $m$ ulti-particle states, and to quasi-holes. The latterbehave slightly di erently: one needs at least $(p+1)$ quasi-holes to have scattered states. $C$ learly, the prefactor $\frac{N_{f m_{2} ; m}{ }_{N_{f m}}{ }_{1}^{0} p ; m_{2}^{0}+p g}{}$ is analogous to the scattering phase that one expects in the continuum lim it of this theory.

T he factor appearing in front of the second term in the right hand side of these expressions corresponds to the reordering of the particles during the action of the density operator. W e shall call it a scattering factor, though it doesn't have the sam e physical origin as the one appearing in 26).

## C. 3 quasi-particles

For the case of form -factors w ith three quasi-particles, w e do not have com plete results, but we report the follow ing. W e distinguish betw een term $s$ where a single one, or tw o, or all three quasi-particles are a ected by the action of the density operator
w hen the density operator is a ecting only one or tw o of the quasi-particles, one obtains the one-or tw o particle action given above, m ultiplied by speci c scattering factors
when the density operator acts on all three quasi-particles, more com plicated many-body e ects appear for $p \in 1$. O ne has to de ne a new function
for tw o particles of the sam e type. H ere follow, case by case, the results we could obtain :

In the next section the various form factors presented here $w$ ill be used in a form factor expansion for the nitetem perature density-density correlation function.

W e now tum to the goal of com puting a nite-tem perature correlation function. Form ally, it am ounts to com pute

where $H_{N}$ is the $H$ ibert space of norm alized states. T he problem arising $w$ ith this expression is that it is hard to handle for any given quantum eld theory. Indeed, divergences appear in the correlators of the right-hand side and these need to be resum $m$ ed. In the context of ( m assive) Integrable F ield $T$ heory ( $\mathbb{F} T$ ), it has been proposed that, using the basis of the asym ptotic particle states in the zero-tem perature theory, one $m$ ay be able to rew rite 35), as a single sum free of divergences []]. The resulting form ula, called a 'rom factor expansion', can be evaluated by using scattering data, the them odynam ic Bethe A nsatz (TBA) and the form factor bootstrap (FFB) (see [17] for a discussion of how the TBA is recovered from the FFB). There is an ongoing discussion about how precisely the form factor expansion can be im plem ented in $\mathbb{F} T \mathrm{~s}$, in particular for the case of multi-point correlation functions 7, 8, 6, 10, 11].

For the case of $C$ onform al $F$ ield $T$ heory, there has been a sim ilar but independent proposal for writing nitetem perature correlators in term s ofquasi-particle form factors and appropriate therm aldistribution functions 目]. The idea here is that the YqH basis' 133) of eigenstates of the CS ham ittonian provides the proper notion of asym ptotic particle states', w ith sim ple, but non-trivial fractional statistics properties.

Them otivation for studying the form factor expansion for CFT has been that, if successful, this approach to nitetem perature correlation functions can possibly be extended to $m$ odels, such as quantum spin chains, that are gapless but that are not CFTs.

C om paring the proposed form factor expansions for $\mathbb{F} T$ and CFT (the particular CFT discussed in this paper), one is led to identify a 2 -body $S-m$ atrix of the sim ple form

in the them odynam ic lim it. It is still an open question whether the form factor com puted in $\mathbb{G}]$ and in this paper can be obtained by $m$ eans of an axiom atic approach, starting from these scattering data.

D is the irreducible form -factor, which we shall de ne $w$ ith precision. In (39), the subfactors are built from multi-particle states which are subsets of $f m_{i} ; n_{j} g$. Their leading state of the form (4) is the original one on which som e creation operators are canceled. It has then to be rew ritten w the correct charge sector. Speci c exam ples of our de nitions are,
the charge shiff ( p ) and the m om entum shift ( +1 ) being present for $\mathrm{Q}=0$.
$T$ his de nition can be interpreted as follow s. E ach form factorm ay appear as part ofbigger form factors. T he way to resum them is to use these irreducible form factors and the one-particle distributions. T his expansion has already proved successful in describing the $G$ reen function for the $=1=\mathrm{p}$ fiH [ $\mathrm{G}^{2}$ ]. In the follow ing we will concentrate on the density-density correlation fiunction, where $O(m)=p_{m} p$. M ost of the results $w i l l$ be given for any $p$, we w ill restrict to the $\mathrm{p}=2$ case for num erics.

U sing standard CFT m ethods, one nds the density-density correlator to be

W e shall com pare the results of the form -factor expansion $w$ th this exact result. $W$ e start (section A) by explaining how the procedure w orks for $\mathrm{p}=1$. It already contains all the features and is com pletely solvable. T hen (sections B and C), we treat the generalp case, where we evaluate the asym ptotics of the form factor expansion for "! 0 or 1 in closed form. Finally (section $D$ ), we discuss num erical results for the full correlation function for the case $p=2$.

These features for the asym ptots willbe shared for generalp, as we will see now .

B . Low -tem perature expansion

We look here at the "! 1 lim it, where the correlation function behaves asp "e".
For a generic m ulti-particle excitation, this lim it willbe dom inated by excitations for which one quasi-particle has a $m$ om entum $m_{i}$ bigger than $m="=a$, and all the others a $m u c h$ smaller one. The $m$ ain contribution com es from the term where the density operator acts only on the quasi-particle of $m$ om entum $m_{i}$. This contribution, which appears equally in all the subfactors of the irreducible form factor, is proportional to "1 $9 \exp (\mathrm{~m}$ ). The contribution from each other particle is of the form

where $S_{i j}$ is a scattering factor. These parts do not a ect the leading behavior for "! 1 and one nds a total contribution which falls o faster than "e ".

There is one exception to the above-m entioned rule. The form factor can becom e big if the interm ediate state is the vacuum, that is for an initial neutral excitation consisting of one electron and p quasi-holes. To see this we use the expansion of $p_{m}$ in term s of Jack polynom ials: we rem ark that for $=1=p$ this expansion is indeed restricted to states with 1 electron and p quasi-holes. C. H igh-tem perature expansion
$W$ hen contem plating a form factor expansion for nite tem perature correlators, one $m$ ay worry about the convergence in the high-tem perature ( " ! 0) lim it, where them al distribution functions do not e ectively suppress $m$ any-particle contributions. W e w ill see that in our case the situation is rem arkably good: using form factors $w$ ith up to three quasi-particles, we recover the exact high-tem perature lim it. To establish th is result, we use the follow ing identity for the equilibrium distribution function $\mathrm{n}_{\mathrm{g}}$ [15]

The curvesfor tw o electrons and two quasi-holes at $p=2$ are given in gure 4. As can be seen, the lim it "! 0 is indeed $12 \mathrm{~d}{ }_{1} \mathrm{n}_{2}^{2}\left({ }^{\prime} \mathrm{"}_{1}\right)=0: 9472$ for 2 electrons, and 0 for 2 quasi-holes.

Form ixed states ( 1 electron and 1 quasi-hole), 29) leads to the follow ing lim it for the irreducible form factor

## 3. 3 particles

C onsidering the argum ent given above, we are only interested in the contribution of 3 particles of the sam e type (3 electrons or 3 quasi-holes). As for 2 particles, we nd that the contribution in the lim it "! 0 com es entirely from the diagonal, where the energies of the three particles are the sam e. We have not been able to get an analytic expression for the high-tem perature lim it, but we present the follow ing con jecture

W e have strong support for this con jecture. First of all, thanks to 34), we are able to com pute the contributions from form factors for 3 electrons at $p=2$ for low values of $m>0$, all representing the lim it " =am! 0 . We reproduce the expected form (62) when $m=3$, and we expect that this result is stable for $m \quad 3$. Continuity for bigger values of $m$ (corresponding to nite " = am ) has been checked num erically, as is shown in gure 5. W e note that according to eq. 62) the num erical value of the $(3 ; 0)$ contribution at " $=0 \mathrm{w}$ ill be .1272 ; the num erical curve displayed in gure 5 gives a slightly sm aller value, due to the fact that a relatively large value of the discretization a had to be used.] Further support for the conjecture com es from the irreducible form factor for 3 quasi-holes for generalp at $m=1$, which directly gives the expression 62).

4. Sum of 1,2 and 3 particle contributions

W e are now ready to evaluate the sum of all contributions to the density-density correlator at "! 0. A dding the contributions from form factors $w$ ith 1,2 , or 3 quasi-particles of statistics $g$ results in


The density-density correlator has these contributions from electrons $(g=p)$ and from quasi-holes $(g=1=p)$. Through duality $g \mathrm{n}_{\mathrm{g}}(0)+1=\mathrm{g} \mathrm{n}_{1=\mathrm{g}}(0)=1$, leading to the result

in agreem ent with the exact result. $W$ e thus nd that the high tem perature lim it is saturated by contributions $w$ ith up to three quasi-particles, w ith the 3-particle contributions being absent in the special case $p=1$. In our view, this non-trivial, exact result gives strong support for the validity of the proposed CFT form factor expansion. W em ention that, in general, good convergence at the high-tem perature end is scarcely seen in form factor expansions.

## D. Full correlation function

In the two preceding sections, we have proved that the low - and high-tem perature asym ptotics for the densitydensity correlation function were recovered in the form factor expansion using only a few quasi-particles. We now observe that the integrated value of the correlator is recovered already at the level of the 1 particle contributions. O ne only needs the sum rule 17) and the procedure for building irreducible form factors to prove this. At the level of 1 particle, one gets

by duality. For any contribution $w$ ith $m$ ore than 2 particles, the integrated curve is 0 .
A ll these facts tend to show that the proposed form factor expansion gives a quick convergence for the full correlation function. This is indeed the case, as one sees on gure 6 , where the contribution from states $w$ ith up to 2 particles at $\mathrm{p}=2$ have been collected .

> V. CONCLUSION

W e have developed a form factor expansion for the density-density correlation function in the fqH edge CFT at $=1=\mathrm{p} . \mathrm{W}$ e have used the correspondence betw een a fqH basis $m$ ade of dual quasi-particles (electrons and quasiholes) and the Jack polynom ialbasis of the C alogero-Sutherland model. W e used 'Jack polynom ial technology' to study form factors, and we obtained analytical expressions for form factors with up to 3 excited particles. U sing these form factors in the proposed form factor expansion, we show ed that the convergence tow ards the exact correlation function is quick in term sof the num ber of excited particles. W e dem onstrated that in the high-and low-tem perature regim es, the expansion reproduces the exact result. This is a clear indication that the expansion is correct.

This result opens the way for the com putation of correlation functions for non-CFT theories, as soon as their excitations form a gas of fractional statistics particles. This is the case for the C alogero-Sutherland model, and the m odels derived from 五, like the H aldane-Shastry spin chain. O ffundam entalinterest also is the need to understand the connection betw een the therm odynam ic lim it of the CFT form factors and a Therm odynam ic Bethe A nsatz m ethod. This would allow for treating such com plicated problem s as im purities in edge-to-edge tunneling.
