Quasiparticles governing the zero-tem perature dynam ics of the 1D spin-1/2 H eisenberg antiferrom agnet in a magnetic eld

The T = 0 dynam ical properties of the one-dimensional (1D) s = $\frac{1}{2}$ Heisenberg antiferrom agnet in a uniform magnetic eld are studied via Bethe ansatz for cyclic chains of N sites. The ground state at magnetization 0 < M_z < N=2, which can be interpreted as a state with 2M_z spinons or as a state of M_z magnons, is recon gured here as the vacuum for a dierent species of quasiparticles, the psinons and antipsinons. We investigate three kinds of quantum uctuations, namely the spin uctuations parallel and perpendicular to the direction of the applied magnetic eld and the dimer uctuations. The dynam ically dominant excitation spectra are found to be sets of collective excitations com posed of two quasiparticles excited from the psinon vacuum in dierent con gurations. The Bethe ansatz provides a fram ework for (i) the characterization of the new quasiparticles in relation to the more familiar spinons and magnons, (ii) the calculation of spectral boundaries and densities of states for each continuum, (iii) the calculation of transition rates between the ground state and the dynam ically dom inant collective excitations, (iv) the prediction of lineshapes for dynam ic structure factors relevant for experim ents perform ed on a variety of quasi-1D antiferrom agnetic com pounds, including K C u F₃, C u (C 4 H 4 N 2) (N O 3)₂, and C u G eO 3.

I. IN TRODUCTION

Q uantum spin chains are some of the most intensively studied models representing strongly uctuating quantum many-body systems because of their am enability to exact analysis and because of the sustained interest in materials exhibiting quasi-one-dimensional magnetic properties. O fparticular interest are the dynamical properties in the low-temperature regime, rejecting strong quantum uctuations.

Q uantum uctuations result from the time evolution of nonstationary observables of a many-body system in the ground state. They can be investigated (experimentally, theoretically, or computationally) by dynamical probes. The three main ingredients of each dynamical probe, (i) interaction H am iltonian, (ii) ground state, (iii) dynamical variable, make a speci c set of collective excitations visible to the probe. The speci city is determined by the symmetries of all three ingredients.

A dynam icalprobe yields inform ation on spectrum and transition rates. D i erent sets of data are collected from the sam e m any-body system [ingredients (i) and (ii)] via particular uctuation operators [ingredient (iii)]. D i erent views of the quantum uctuations are litered out by operator speci c selection rules and transition rates.¹

C ollective excitations are modes in which some of the tightly coupled fundamental degrees of freedom (electrons, ions, atom s) move collectively in more or less complex patterns. The free-particle like normal modes known to exist in systems made of linearly coupled degrees of freedom are the inspiration of attempts to describe collective excitations quite generally as composites of elementary modes that are weakly coupled at most. This requires that the ground state of the system can be meaningfully interpreted as a physical vacuum in which certain kinds of elementary excitations (quasiparticles) m ove without attenuation and scatter o each other non-destructively.

In completely integrablem any-body systems, the identity of the quasiparticles in any given eigenstate is upheld on a rigorous basis and encoded by a set of quantum num – bers. All excited states can then indeed be generated system atically via the creation of quasiparticles from the ground state con gured as a physical vacuum. The interaction of the quasiparticles m ay not be weak, but it is of a kind which preserves their identity. The factorizability of the associated S-m atrices, which is characteristic of completely integrable systems, reduces all quasiparticle couplings to two-body scattering events for which a general solution can be form ulated, e.g. in the form of a Bethe wave function.^{2,3}

The focus here is set on the quasiparticles which government of the quantum uctuations of the one-dimensional (1D) $s = \frac{1}{2}$ Heisenberg antiferrom agnet in an external magnetic ed:^{4,5}

The ground state at $h_s = 2J$, fi j"" "i, has saturated m agnetization, $M_z = N = 2$. It is the reference state of the coordinate Bethe ansatz and plays the role of the vacuum for magnons (spin-1 quasiparticles). All eigenstates of H are described as con gurations of interacting magnons. The ground state at h = 0, Ai, has m agnetization $M_z = 0$. It contains N = 2 magnons. In the fram ework of the Bethe ansatz, it is recon gured as the physical vacuum for spinons, a species of spin- $\frac{1}{2}$ quasiparticles, and the entire spectrum of H is reinterpreted as composites of interacting spinon pairs. Likew ise at interm ediate elds, $0 < h < h_s$, the ground state fiis recon gured as a new physical vacuum, and the low - lying collective excitations are most e ectively described as composites of two new species of quasiparticles, named psinon and antipsinon.

In a recent paper,⁶ a detailed description of these quasiparticles in the fram ework of the coordinate Bethe ansatz was given. Their role in the zero-tem perature spin uctuations parallel to the direction of the magnetic eld was elucidated in the form of lineshape predictions for the associated dynam ic structure factor. Here we present a more com prehensive set of applications, which also includes the perpendicular spin uctuations and the dim er uctuations.

P hysical realizations of H eisenberg antiferrom agnetic chains have been known form any years in the form of 3D crystalline compounds with quasi-1D exchange coupling between m agnetic ions. For the study of m agnetic- eld e ects in the dynam ics as predicted in this paper, the coupling m ust not be too weak or else it will be hard to reach the low-temperature regime. It m ust not be too strong either or else it will be hard to reach a m agnetic eld that m akes the Zeem an energy comparable to the exchange energy. One compound that prom ises to be particularly suitable for this purpose is copper pyrazine dinitrate [Cu(C₄H₄N₂)(NO₃)₂].⁷

The spin uctuations can be observed directly via inelastic neutron scattering experiments. At very low tem – peratures, the dominant transitions in the scattering experiment are between the ground state JG i and a set of excitations j i that are reachable by one of the spin uctuation operators $S_q = N^{-12} n e^{iqn} S_n$, = x;y;z. In the T = 0 dynamic spin structure factors

Som e quasi-1D antiferrom agnetic com pounds, ofw hich C uG eO $_3$ is the most prom inent exam ple,^{8,9,10} are susceptible to a spin-P eierls transition, which involves a lattice distortion accompanied by an exchange dimerization. The dimer uctuations, D $_q = N \frac{1-2}{n} e^{iqn} S_n \frac{q}{q+1}$, as captured by the dynamic dimer structure factor

m ay not be as directly observable as the spin uctuations but an understanding of their quasiparticle composition is a matter of no less importance.

II. MAGNONS, SPINONS, PSINONS

The coordinate Bethe ansatz provides a natural classi cation of the eigenstates of (1) in term s of interacting m agnons. The structure of the Bethe wave function, its determ ination via the solution of the Bethe ansatz equations, and its use for the calculation of m atrix elements are sum m arized in the Appendix. For our discussion here it turns out to be su cient to consider r-m agnon scattering states of the set K $_r$. In the invariant H ilbert subspace of m agnetization M $_z$ = N =2 r, the B ethe quantum num bers of this set comprise, for 0 r N =2 and 0 m N =2 r, all con gurations

The Bethe ansatz suggests a threefold interpretation of the ground state jG i at 0 M $_z$ N =2 with quantum numbers

D epending on the reference state (pseudo-vacuum) used, it can be regarded as a scattering state of N =2 M_z m agnons, a scattering state of 2M $_z$ spinons, or the physical vacuum of psinons.⁶

The states in the set K_r then all contain the same number of magnons or spinons but di erent numbers of psinons. The integer quantum number m selects all states from K_r that contain m pairs of psinons. The ground state jG i at M_z = N = 2 r is the only state with m = 0. The quasiparticle role of the psinons in the 2-psinon (m = 1) and 4-psinon (m = 2) scattering states was highlighted previously.⁶

The excitations which are important in S_{zz} (q; !) (parallel spin uctuations) at M $_z$ = N = 2 r were found to consist of a sm all subset of K r which includes 2m psinon states over the entire range m . However, all 2m psinon states with signi cant spectral weight were found to belong to particular con gurations of Bethe quantum num bers I_i in which 2m1 psinons behave like a single degree of freedom with properties akin to those attributed to an antiparticle. The spectrum of S_{zz} (q;!) was thus identied as arising predom inantly from psinonantipsinon () excitations.⁶ Here our goal is to identify and interpret the dynam ically relevant excitations also for $S_{xx}(q;!) = \frac{1}{4}[S_+ (q;!) + S_+ (q;!)]$ (perpendicular spin uctuations) and S_{DD} (q;!) (dimer uctuations), where we expect psinons and antipsinons to occur in di erent com binations.

III. SYM M ETR IES AND CONSEQUENCES

N arrowing down the dynam ically dom inant sets of excitations and characterizing them as speci c quasiparticle con gurations proceeds in three steps. First we lim it the set of relevant excitations by the application of selection rules which are imposed by the symmetry properties of the H am iltonian (1) and the uctuation operators $S_q^z; S_q; D_q$ and which are valid for arbitrary system sizes. Then we identify additional selection rules that are valid only for N ! 1 . Finally, we identify from the states not yet excluded those whose transition rates are predom in nant in $S_{zz}(q; !), S_+(q; !), S_+(q; !), and S_{DD}(q; !)$.

This last step, which here is carried out empirically, may very well nd its ultimate justication by further symmetries related to complete integrability.¹¹

A. Selection rules for arbitrary N




FIG.1: Transitions between the ground state jG i with quantum numbers $S_T = S_T^2 = M_z$ and six classes of excitations permitted by m icroscopic selection rules (R ef.12). Each class may contribute to exactly one of three dynamic spin structure factors. Class (ii) also contributes to the dynamic dimer structure factor. Fewer classes of permissible excitations exist for $M_z = 0$ (h = 0) and $M_z = N = 2$ ($h = h_s$).

The conservation laws of the total spin $S_{\rm T}$ and its z-component $S_{\rm T}^z$ in ply that transitions between eigenstates of (1) induced by the (nonstationary) spin uctuation operators $S_{\rm q}^z$, $S_{\rm q}$ (vector) and the dimer uctuation operator D $_{\rm q}$ (scalar) satisfy stringent selection rules. The six classes of excitations with permissible transitions from j i with $S_{\rm T}$ = $S_{\rm T}^z$ = M $_z$ for the uctuation operators $S_{\rm q}^z$; $S_{\rm q}$ (p $_{\rm q}$ are all listed in Table I. The locations of these classes of excitations relative to the ground state in the (S_T; $S_{\rm T}^z$)-plane are shown in Fig.1.

We note that classes (ii), (iii), and (vi) include the sets K_r for r = R; R 1; R + 1, respectively, while the remaining three classes (i), (iv), and (v) include sets of states that belong to the same S_T multiplets as the sets K_R or K_{R+1}. Table I also lists the Bethe quantum num - bers I_i; i = 1;:::; r for the type-K_r or equivalent states and describes how the rapidities z_i ; i = 1;:::; r for these states are obtained.

B. Selection rules for N ! 1

Before we begin evaluating matrix elements from Bethe ansatz solutions in production mode, we take note that the rotational symmetry of the Hamiltonian (1) and the vector nature of the spin uctuation operator $(S_q^x; S_q^y; S_q^z)$ imply the following rigorous relations between transition rates involving excitations that belong to the same $S_T - m$ ultiplet:¹²

The signi cance of the relations (6) is not limited to their usefulness in reducing computational work. The magnetization is an extensive quantity, in plying M_z / N at h \notin 0. All transition rates for class (i), (iv), (v) excitations are then suppressed by factors N or N² relative to the transition rates of class (ii), (iii) excitations. The consequence is that in a macroscopic system at h \notin 0, the spectral weight of all class (i), (iv), (v) excitations in the T = 0 dynamic spin structure factors S (q;!) is negligible.¹³

C. Selection rules related to integrability

We shall nd empirically that in each one of the remaining classes (ii), (iii), and (vi) there exists a twoparameter set of excitations which governs one of the dynamic structure factors of interest here. We shall name these sets P2, P3, and P6, respectively (see Table I). Corresponding nite-N spectral contributions of class (i), (iv), and (v) states can be inferred from Eqs. (6). The associated sets P1, P4, and P5 have their position in the (q; !)-plane shifted vertically relative to the sets P2, P3, and P6 because of the Zeem an splitting, and the spectral weight of the form er is suppressed by factors N or N² as explained previously.

IV. DYNAM ICALLY DOM INANT EXCITATIONS

In our search for the dynam ically m ost relevant excitations, we focus on the case of magnetization M $_z=N=\frac{1}{4}$ (half the saturation value). We explore the transition rates for the spin and dimer uctuation operators between the ground state JS i and the type-K $_r$ states in the classes (ii), (iii), (vi). These excitations are found to contribute m ost of the spectral weight to the dynam ic spin and dimer structure factors.

A. Perpendicular spin uctuations (P3)




FIG.2: Psinon vacuum jG i for N = 16; M $_z$ = 4 and states with q=0 from the set K $_3$ out of class (iii). The I_i values are marked by the positions of the magnons (sm all circles). The spinons (large circles) mark I_i -vacancies. A subset of the spinons are called psinons (gray circles) The wave numbers $q=k=k_G$ are given in units of 2 =N .

The spectral weight in S $_+$ (q;!) is carried exclusively by class (iii) excitations (see Table I). A systematic study of the transition rates of type-K_R $_1$ states for m = 0;1;2;::: reveals that the dominant contributions to the spectral weight come from two-psinon () states. The Bethe quantum numbers of the states involved in these transitions are shown in Fig. 2 for N = 16 and M_z = 4. The top row represents the ground state [G i, which contains fourm agnons (sm all circles) or eight spinons (large circles). This is the psinon vacuum at R = 4. The next row is the low est-lying two-psinon () state excited from [G i. This excitation also plays the role of the psinon vacuum (m = 0) at R = 3. It is then characterized as containing three m agnons or ten spinons.

M obilizing the two innerm ost spinons turns them into psinons (gray circles). The remaining verows in Fig.2 represent states (m = 1) at 0 < q for R = 3. The state in the second row is also counted as a state. Hence there are six of them in total for N = 16. Freeing up two additional spinons from the sidelines produces a set of four-psinon states (m = 2) of which the states (m = 0;1) are special members. The maximum number of psinons that can be m obilized at R = 3 is equal to the number of spinons: 2M $_z = 10$.




FIG. 3: (a) Energy versus wave number of the excitations at $M_z = N = 4$ for N = 64 (circles) and N ! 1 (continuum P3 between curves). (b) Integrated intensity of S + (q) (inset) and relative contribution (main plot) for N = 12;16;20;24;28.

W e have calculated the transition rates $j_G \beta_q j^{(iii)} i_J^2$ between the ground state for N = 24, M_z = 4 and all 2m -psinon excitations. We found that the states are predom inant. They are listed in Table II along with the momentum and energy transfer of the associated spectral lines. For N ! 1 the states form the continuum P3 in (q; !)-space. In Fig. 3(a) we have plotted all states belonging to P3 for N = 64 (circles) and the spectral boundaries for N ! 1. The range of P3 is restricted to

N ote that the continuum P3 is displaced by q = relative to the two-psinon continuum discussed in the context of Ref. 6. The psinon vacuum used for P3 is the state in the rst row of Fig. 2. In Ref. 6 the state in the second row is the vacuum. These choices are dictated by the di erent uctuation operators considered now and then.

The relative integrated intensity of the states, S $_{+}$ (q)=S $_{+}$ (q), is plotted in Fig. 3 (b) for various N at xed M $_{z}$ = N =4. Corresponding data for the absolute integrated intensity S $_{+}$ (q) are shown in the inset. W e observe that there is virtually no intensity at jrj qs, outside the range of continuum P3. As jrj increases from qs toward , S $_{+}$ (q) increases gradually and at an accelerated rate. The value at the zone boundary diverges

in the therm odynam ic lim it: S $_+$ () N $^{1-1=}$, with an exponent (M $_z$ =N) that assumes the value 14,15

for the situation at hand. It rejects the divergence S $_{+}$ (q) j qjⁱ⁼¹ for N = 1. The relative contribution to S $_{+}$ (q) rises rapidly from zero at q & qs toward a value exceeding 97.8% at q = . The solid line in the inset is obtained from a two-parameter t, aj qjⁱ⁼¹ + b, of the data at q =2.

W hen we decrease M $_z$ at xed N, the soft mode at q = remains stationary while the soft mode at $q = q_s$

m oves to the left. At M $_z = 0$, the states become the two-spinon triplets. The two-spinon part of S $_+$ (q;!) is exactly known for N ! 1 .^{16,17} C onversely, when we increase M $_z$, the softm ode at q = q m oves to the right and thus narrows the range of P 3 continually. At saturation (M $_z$ =N = $\frac{1}{2}$) the function S $_+$ (q;!) vanishes identically.

B. D im er and parallel spin uctuations (P2)




FIG. 4: P sinon vacuum jG i for N = 16; M_z = 4 and set of states with 0 q out of the set K₄. The I_i are given by the positions of the m agnons (sm all circles) in each row. The spinons (large circles) correspond to I_i-vacancies. The psinon () and the antipsinon () are m arked by a large and a sm all grey circle, respectively.

The parallel spin uctuations were already analyzed in Ref. 6. The relevant excitations are contained in the set K_R out of class (ii). This set is subdivided into sets of 2m -psinon states for 0 m M_z = N = 2 R. Each set for m > 0 contributes one branch of excitations with signi cant spectral weight to S_{zz} (q;!). Figure 4 shows the con gurations of Bethe quantum numbers I_i of all these states for N = 16; M_z = 4. The top row represents the psinon vacuum (m = 0). The four groups of states undemeath represent the dynam ically dom inant branches of 2m -psinon states for m = 1;:::;4.

We argued that the I_i -con gurations of these excitations suggest a simpler interpretation in terms of two quasiparticles, namely one psinon () and one antipsinon (). We reinterpreted the series of dynamically dom in nant branches taken from 2m-parameter sets of multiple-psinon states as a single two-parameter set of scattering states. These states form the continuum P2 for




FIG.5: (a) Energy versus wave number the excitations at $M_z=N = 1=4$ for N = 64 (circles) and N ! 1 (partially folded continuum P2 outlined by solid lines). (b) Integrated intensity S_{zz} (q) (inset) and relative P2 contribution (m ain plot) for N = 12;16;20;24;28;32. (c) Integrated intensity $S_{D,D}$ (q) (inset) and relative P2 contribution (m ain plot) for N = 12;16;20;24;28. The lines in (b) connect the N = 32 data points and the lines in (c) the N = 28 data points. The values of S_{zz} (=2) and $S_{D,D}$ (=2) extrapolated to N ! 1 are m arked (+).

N ! 1 in the (q; !)-plane as illustrated in Fig. 5(a). From the shape of the continuum with its soft modes at q = 0 and $q = q_s$, where

and with the partial overlap along a stretch of the upper boundary, we reconstructed the energy-m om entum relations of the and quasiparticles.⁶

The corresponding search for the dynamically dominant dimer excitations again points to the continuum P2. The transition rates for the uctuation operators S_q^z and D_q in a system with N = 16, $M_z = 4$ are listed in Table III for comparison. These data suggest that the spectral weight in $S_{D,D}$ (q;!) is concentrated more heavily at lower energy than is observed in S_{zz} (q;!). A more quantitative discussion of this evidence will follow in Sec.V.

Finite-N data for the integrated intensities S_{zz} (q) and $S_{D D}$ (q) are presented in Figs. 5 (b) and (c), respectively. Both static structure factors rise from zero at q = 0 to a cusp-likem axin um at q = $q_s = =2$, where the softm ode is located. The cusp is of the form jq_s qj¹. A two-parameter t, aN¹ + b, of the data at q = q_s yields the extrapolated values S_{zz} (=2) ' 0:307 and S_{DD} (=2) ' 0:641. On approach to q = , the intensity drops more drastically in S_{DD} (q) than in S_{zz} (q).

For both kinds of uctuations, the intensity at q q_s is almost exclusively originating from excitations. At $q = q_s$, the relative contributions to S_{zz} (q) and $S_{D\,D}$ (q) are estim ated to be at least 93% and 95% , respectively, in the lim it N ! 1. At q & qs the parts of S_{zz} (q) and S_{DD} (q) decrease monotonically but remain dom inant except in the immediate vicinity of the zone boundary. The data suggest a qualitative di erence in how the relative intensities approach zero as q ! If the behavior near the zone boundary can be described by a power-law, j qj, then we predict & 1 for the dimer uctuations and '0:3 for the spin uctuations.6

Upon varying the value of M_z, the continuum P2 changes its shape continuously. In both lim its, M_z=N ! 0 and M_z=N ! $\frac{1}{2}$, it degenerates into a single branch and then vanishes.^{6,12} At M_z = 0 the dimer uctuations and the spin uctuations are produced by entirely di erent sets of excitations. S_{zz} (q; !) is known to be dominated by the continuum of two-spinon triplet

excitations,¹⁶ which are Bethe ansatz solutions with real rapidities. $S_{D\ D}$ (q;!) is presumably governed by two-spinon singlet excitations, which are Bethe ansatz solutions with complex rapidities.¹⁸

C. Perpendicular spin uctuations (P6)

For nite N, the spectral weight in the dynam ic structure factor S_+ (q; !) probes excitations from classes (iv)–(vi). However, we know from Sec. IIIB that the intensities of class–(iv) and class–(v) excitations are bound to fade away in the lim it N ! 1. The class–(vi) excitations contain the set K $_{\rm R+1}$. It turns out that m uch of the spectral weight in S_+ (q; !) is carried again by excitations. However, the transitions IG β_q^+ j i probe the states in a di erent invariant subspace than the transitions IG β_q^- j i, IG p_q j i do. This causes some dram atic changes in the spectrum and in the spectral-weight distribution.




FIG. 6: Psinon vacuum jG i for N = 16; $M_z = 4$ and set of states with 0 q out of the set K_5 . The I_i are given by the positions of the m agnons (sm all circles) in each row. The spinons (large circles) correspond to I_i -vacancies. The psinon () and the antipsinon () are marked by a large and a sm all grey circle, respectively. The last row describe a state from class (v) which belongs to the same S_T -multiplet as the psinon vacuum.

The di erences are best illustrated by Fig.6 in relation to Figs.2 and 4. The top row in all three gures shows the I_i -con guration of the ground state jG i for N = 16, $M_z = 4$. The remaining rows in Fig.4 represent the states in the same invariant subspace, whereas the




FIG.7: (a) Energy versus wave number the excitations at $M_z = N = 4$ for N = 64 (circles) and N ! 1 (partially folded continuum P6 outlined by solid lines). (b) Integrated intensity S_+ (q) (inset) and relative P6 contribution (main plot) for N = 12;16;20;24;28. The solid line in the inset results from a two-parameter t as explained in the context of Fig. 3.

remaining rows in Fig.2 represent the states in the subspace with one less magnon (i.e. two more spinons). The rst state (second row in Fig.2) also plays the role of the psinon vacuum in that subspace.

The second row in Fig. 6 represents the lowest excitation probed by hG β_q^+ j i and, at the same time, the psinon vacuum with one more magnon (i.e. two less spinons). The three groups of ve states undermeath represent the complete set of states in the same invariant subspace. Because the momentum transfer for these

states is relative to a di erent psinon vacuum than was the case for the states discussed in Fig. 4, the observable spectrum of the continuum P6 which em erges for N ! 1 [Fig. 7 (a)] is the m irror im age of the continuum P2 [Fig. 5 (a)].

The last row in Fig.6 is not exactly a state. It di ers from the in the previous row only by the smallest change in one Bethe quantum number. This class-(v) state belongs to the same S_T -multiplet as the ground state jG i (top row). We have included it here because its transition rate is signi cant. In fact, it is the only excitation at q = 0 with a nonzero transition rate. Even though it is not a member of the set K_{R+1}, its contribution to S_+ (q;!) marks a natural endpoint of the continuum P6. The excitation energies and transition rates pertaining to all states shown in Fig.6 are listed in Table IV.

The integrated intensity S_+ (q) as shown in Fig.7(b) is almost at in the region 0 q q_s . The intensity at q = 0 is exactly known:¹²

At $q > q_s$ the function S_+ (q) rises gradually and with increasing slope ending in a divergence at q = -. The

dictates that the singularity is the one already described in Sec. IV A: S₊ (q) j q_{j}^{\dagger} ^{= 1}.

The relative contribution to the integrated intensity is largest near the zone center and near the zone boundary as shown in the inset to Fig. 7 (b). It gradually drops from 100% at q = 0 to 20% at the soft-mode position $q = q_s$ and then rises back to 72:5% at q =. Note that the N-dependence of the relative intensity data is much stronger at $q > q_s$ than at $q = q_s$. We shall see that the qualitatively di erent N-dependences are also observed in transition rates, from which interesting conclusions can be drawn.

V. LINESHAPES

To calculate the lineshapes of the and contributions to the dynam ic spin and dim er structure factors we use, wherever applicable, the product ansatz

discussed at some length in Ref. 6. The factor D(q; !) is the density of or states, which can be evaluated for very large N via Bethe ansatz. The factor M (q;!) represents the scaled transition rates N $\Im G \ \beta_q j i \hat{f}$, = z;+;, or N $\Im G \ p_q j i \hat{f}$ between the ground state and the sets of or states. These matrix elements are also calculated via Bethe ansatz but only for much sm aller system s.

For the applications considered here, the product ansatz depends on a reasonably fast convergence, within the spectral boundaries of the continua P 2, P 3, and P 6, of the nite-N transition rate data toward a smooth function M (q;!) as N ! 1. Problem s with this ansatz arise when the nite-size excitations for which transition rates are available are subject to signi cant energy shifts caused by the quasiparticle interaction. For

and scattering states, these are e ects of (N^{-1}) as discussed in R ef. 6. The exercise of caution is also indicated when the scaling behavior of the nite-size transition rates changes at spectral boundaries as is frequently the case.

Notw ithstanding these caveats, the product ansatz is a useful tool for merging the best available transitionrate data and density-of-states data. It was successfully tested for the two-spinon excitations at M_z = $0.^{16}$ Any major distortions of the lineshapes predicted by the product ansatz can be avoided if we om it all data points of M (q; !) that are shifted across spectral boundaries. Any theoretical and computational advances that make it possible to calculate transition rates for larger system s will improve the predictive power of the product ansatz.

A. $S_{D D}$ (q;!) and S_{zz} (q;!)




FIG.8: (a) Density of states at q = =2 for N = 2048. (b) D in er (D D) and parallel spin (zz) transition rates between the psinon vacuum and the states at q = =2 for N 32 (zz) and N 28 (D D). (c) Lineshape at q = =2 of the contribution to S_{zz} (q; !) and S_{DD} (q; !). All results are for M_z = N=4. The scales in (b) and (c) on the left (right) are for D D (zz).

W hat can be observed in a xed-q scan of the dimer and parallel spin uctuations at $q = q_s$? The lineshape determ ination of S_{DD} (=2;!) is illustrated in Fig. 8 in comparison with corresponding data for S_{zz} (=2;!) as shown in Fig. 8 of Ref. 6. The rst factor in the product ansatz is the same for both sets of data, namely the density of states in continuum P2. It has the characteristic shape with a square-root divergence at the upper band edge !_U as shown in panel (a).

The scaled transition rates M_{zz} (=2;!) and M_{DD} (=2;!) [panel (b)] are monotonically decreasing functions. For both kinds of uctuations the data at low frequencies are consistent with the power-law divergence,

with 2 = 0.468 ::: as predicted by conform al invariance. It is near $!_U$ where the two sets of data di er most. W hile both transition rate functions tend to vanish at $!_U$, this tendency is considerably slower for the parallelspin uctuations than for the dim er uctuations. The resulting lineshapes are dram atically di erent.

We saw that the slow approach to zero at $!_{U}$ of the parallel spin transition rates M $_{zz}$ (=2;!) combined with the divergence in D (=2;!) produces a diverging

trend at $!_{U}$ in S_{zz} (=2;!). The result is a characteristic double-peak structure.⁶ The more rapid approach to zero of the dimer transition rates M_{DD} (=2;!) overcomes the divergence of D (=2;!) and produces a single-peak lineshape in S_{DD} (=2;!).




FIG. 9: (a) Density of states at q = =4;3 =4 for N = 2048. (b) D in er transition rates between the psinon vacuum and the states at q = =4;3 =4 for N = 16;24. (c) Lineshape at q = =4;3 =4 of the contribution to $S_{D,D}$ (q;!). All results are for M $_z = N = 4$.

Now we consider the wave numbers halfway between the soft mode q_s and the zone boundary or the zone center. The lineshape determ ination via product ansatz of $S_{D D}$ (q;!) at q = -4, 3 = 4 is illustrated in Fig.9. The corresponding data for the parallel spin uctuations were shown in Fig.9 of Ref. 6. For this situation the upper edge of one band (q = -4) coincides with the low er edge of the other band (q = 3 = 4).

Even though the number of available data points for dimer transition rates is limited, there is a clear indication that the lineshapes of the dimer uctuations again consist of single-peak structures with a divergence at the lower band edge $!_{\rm L} \notin 0$ and a shoulder reaching to the upper band edge $!_{\rm U}$, in strong contrast to the double-peak structures predicted for the lineshapes of the parallel spin uctuations.

In sum m ary, the spectral-weight distribution of the dynam ic structure factors which probe the dimer and parallel spin uctuations have m any commonalities but also some very distinct properties. In both cases, the dominant spectrum is the continuum P2 of states within the invariant M_z subspace which also contains the ground state jG i. Both functions S_{DD} (g;!) and S_{zz} (g;!) are strongly peaked along the lower continuum boundary $!_L$ (q). Only the latter is also peaked along the upper continuum boundary $!_U$ (q). The divergence along $!_L$ (q) is caused by the transition rates, whereas the divergence along $!_U$ (q) is a density-of-states e ect.

B. S + (q;!)




FIG.10: (a) Density of states at q = for N = 2048. (b) Perpendicular spin transition rates between the psinon vacuum and the states at q = for N = 12;16;20;24;28. (c) Lineshape at $q = \text{ of the contribution to S}_{+}(q;!)$. All results are for $M_z = N = 4$.

Here we focus on the lineshape at q = of the con-tribution to the dynam ic spin structure factor S₊ (q; !). The continuum P3 of states was previously found to be dom inant. The results predicted on the basis of the product ansatz are shown in Fig. 10.

The density of states has the same characteristic shape as seen previously. The spectral weight is strongly concentrated in the lowest nite-size excitation. The scaling behavior of the transition rate for that state, N $jG j_{q} j i j^{2}$ (1=N)¹⁼², translates, via conformal

for the spectral-weight distribution of the in nite chain. The solid line represents a two-parameter t, a! $1^{12} + 2^{12} + 2^{12}$, of the data points representing the lowest excitation for N = 12;16;20;24;28. The transition rate data at higher frequencies appear to approach zero su ciently rapidly to overcome the divergent trend of the density of states to produce a monotonically decreasing spectral-weight distribution with a cusp singularity at the upper continuum boundary.

Sim ilar single-peak lineshapes are expected for xed-q scans across the range of the continuum P3. Hence the

contribution to the perpendicular spin uctuations is a structure that is strongly peaked along the lower continuum boundary $!_{\rm L}$ (q) in the shape of the psinon dispersion⁶ and a shoulder reaching to the upper boundary $!_{\rm U}$ (q) of the continuum P2. Given the strong divergence of S $_+$ (q; !) at $!_{\rm L}$ (q), the perpendicular spin uctuations o er the most promising way to measure the energy-momentum relation of the psinon quasiparticle by means of neutron scattering.

Here we are back to focusing on lineshapes produced by excitations as in Sec. V A, but not in the same invariant M_z subspace. Nevertheless, the continuum P6 as depicted in Fig. 7(a) produces, at q = =2, a band of equal width and location as continuum P2 depicted in Fig. 5 did.




FIG. 11: (a) Density of states at q = -2 for N = 2048. (b) Perpendicular spin transition rates between the psinon vacuum and the states at q = -2 for N = 12;16;20;24;28. (c) Lineshape at q = -2 of the contribution to S₊ (q;!). All results are for M_z = N = 4.

The data used in the product ansatz applied to S_+ (=2;!) are shown in Fig.11. The density of states is exactly the same as in Fig.8. The data for the transition rates are monotonically increasing with !. The trend in the low-frequency limit is that M_+ (=2;!) approaches a nite value, possibly zero. Given the fact that D_- (=2;!) is at at low frequencies, the same trend is observed in S_+ (=2;!). The prediction of conform al invariance for the leading infrared singularity is

At the upper band edge $!_{\rm U}$, the transition rate data exhibit a pronounced maximum which could either signal a divergence or a cusp singularity for the in nite system. W hatever the case may be, this enhancement amplies the divergent density of states in S_+ (=2;!).

Recall that the parallel spin uctuations exhibit a double-peak lineshape at the soft-m ode wave num ber q_s . By contrast, the lineshape of the perpendicular spin uctuations at the soft-m ode wave num ber q_s is a single-peak structure with the spectral weight concentrated near the upper band edge. For other wave num bers we do at present not have enough transitions rate data points for

a useful application of the product ansatz. N evertheless, from the few data points which we do have some interesting conclusions can be drawn.

In the transition rate data currently available we observe that the spectral weight is heavily concentrated in a single excitation for any given $q \in =2$. For $0 \quad q < q_s$ that excitation is located along the lower boundary of continuum P6 and for $q_s < q$ along the upper boundary. Both boundaries have the shape of the antipsinon dispersion.⁶ Therefore, the contribution of S_+ (q; !) to the perpendicular spin uctuations o ers the most direct way to measure the dispersion of the antipsinon quasiparticle by means of neutron scattering { not once but twice, in di erent parts of the Brillouin zone.




FIG.12: (a) Unscaled and (b) scaled transition rates for S_+ (q;!) at $M_z = N = 4$ for N = 12;16;20;24;28.

The outstanding role of the excitations along the two antipsinon branches at $q < q_s$ and $q > q_s$ is illustrated in Fig. 12, where we have plotted the transition rates $jG \ \beta_q^+ j \ i \ j$ versus q of all states from continuum P6 across various system sizes. However, the role of the nite-N excitations which are part of these dom inant branches is di erent at $q < q_s$ and $q > q_s$. This is evident by comparison of panels (a) and (b) which show di erently scaled transition rates N $\ jG \ \beta_q^+ j \ i \ j$.

To make sense of the data in this representation we must distinguish three scenarios and ask the question: Forwhat value of the scaling exponent do the transition rate data exhibit m inim al N -dependence?

(i) For states that are inside a continuum, the product ansatz requires requires that the exponent = 1 m inim m izes the N -dependence of the transition rate data.

(ii) For states that m ark the boundary of a continuum where the spectral-weight distribution has a divergent singularity that is not caused by a divergent density of states the exponent which m inim izes the N -dependence of the transition rate data is in the range 0 < < 1.

(iii) For states that form a branch with nonvanishing spectral weight in the lim it N $\, ! \, 1$, the exponent that m inim izes the N -dependence is $\, = \, 0 \, .$

There is an ple evidence for the scenario in the results presented earlier. The data in panel (a) strongly indicate that the third scenario is realized for the antipsinon branch at $0 < q < q_s$. The evidence is rigorous for the isolated excitation at q = 0 which carries all the spectral of S_+ (q;!) as discussed previously.

Panel (b) suggests that the second scenario applies to the antipsinon branch at $q_s < q$. The exponent = 1= = 0:653::: used here is suggested by conformal invariance, but there is a strong possibility that the singularity of S₊ (q; !) along the antipsinon branch at $q_s < q$ is governed by a q-dependent exponent. The insets to Fig. 12 show the N-dependence of the corresponding data at q = , which is o the scale used in the m ain plots. At the zone boundary, the width of continuum P6 has shrunk to zero, which is likely to a ect the N-dependence of the transition rate singularly, as indicated.

In conclusion, this study m akes predictions of unprecedented detail for the lineshapes of the spin and dimer uctuations in the 1D s = $\frac{1}{2}$ H eisenberg antiferrom agnet at zero temperature and nonzero m agnetic eld. Forem ost am ong these predictions is the direct observability in the perpendicular spin uctuations of the dispersion relations for the two quasiparticles which play a crucial role in this situation: the psinon and the antipsinon.

In the past, The Bethe ansatz was rarely used for the purpose of calculating matrix elements. The main determent has been the need of evaluating the sum P 2 S_r over the r!m agnon permutations in the coe cients (A 2) of the Bethe eigenvectors (A 1). How ever, the tide is now changing rapidly for two reasons: (i) the availability of vastly higher computational power, (ii) theoretical advances that make it possible to reduce matrix elements of Bethe wave functions to determ inantal expressions.¹⁹

In the following, we sketch how the matrix elements can be manipulated e ectively by using the Bethe wave functions directly. The use of the determ inantal expressions of Bethe ansatz transition rates for the calculation of dynamic structure factors will be reported elsewhere.²⁰

In designing an e cient algorithm, we must heed the fact that in the calculation of a single matrix element,

the sum P 2 S_r is evaluated many times, once for every $coe cient a(n_1; :::; n_r)$ of the two eigenvectors involved. Under these circum stances, it is imperative that the algorithm has rapid access to a table of permutations. Such tables can be generated recursively by powerful algorithm s.²¹

The computationale ort can be reduced considerably if we use the translational sym metry of (A 1), guaranteed by the relation $a(n_1 + 1; \dots; n_r + 1) = e^{ikl}a(n_1; \dots; n_r)$ between Bethe coe cients (A 2) pertaining to basis vectors that transform into each other under translation. Translationally invariant basis vectors have the form

The rotationally invariant subspace for xed N = 2 r, which has dimensionality D = N $\models [r!(N \ r)!]$, splits into N translationally invariant subspaces of dimensionality D $_k$, one for each wave number k = 2 n=N; n = 0; $\ldots; N$ 1. The memory requirements for the calculation of one such matrix element are 6.7M B for N = 18;r = 9 and 73M B for N = 20;r = 10.
