## Sem iclassical Theory of Chaotic Quantum Transport

W e present a re ned sem iclassical approach to the Landauer conductance and K ubo conductivity of clean chaotic m esoscopic system s. W e dem onstrate for system s with uniform ly hyperbolic dynam ics that including o -diagonal contributions to double sum s over classical paths gives a weak-localization correction in quantitative agreem ent with results from random matrix theory. W e further discuss the magnetic eld dependence. This sem iclassical treatm ent accounts for current conservation.

A mong the prominent wave phenomena which constitute mesoscopic behavior of small phase-coherent conductors, weak localization (W L) represents one key mechanism. This quantum e ect shows up as a decrease in the average conductivity with respect to the classical one. W L, originally observed for light and electron waves in disordered sam ples, has been extensively studied during the last decade for electrons in ballistic conductors, i.e. mesoscopic cavities or quantum dots where the elastic mean free path is considerably larger than the system size. W L is attributed to constructive interference of electron waves which are either coherently backscattered from in purities in disordered systems or multiply re ected at the boundaries of ballistic devices.

In describing ballistic transport sem iclassical methods have attracted much interest, since they establish a direct link between quantum transport properties and features of the corresponding classical dynamics, e.g. chaotic, integrable, or mixed behaviour [1,2]. This was demonstrated for clean m icrostructures in a sem inal sem iclassical approach [3] to the average re ection in the Landauer fram ework: the W L peak pro le (as a function of a magnetic eld) was shown to be Lorentzian for chaotic systems, probing in an impressive way the imprint of the classical dynam ics on a measured quantum e ect [4]. However, while the line shape of the W L peak agreed with results from random matrix theory (RMT), the approach turned out to be inadequate to give the correct W L m agnitude for ballistic system s, contrary to the di usive case [5]. This long-lasting problem to sem iclassically obtain the correct leading-order quantum correction to the conductance is related to the so-called diagonal approximation used. It is based on the consideration of a restricted class of pairs of paths built from each backscattered orbit and its tim e-reversed partner, which m oreover violates current conservation [6]. Sim ilarly, W L is not captured in a related sem iclassical approach to the K ubo conductivity of ballistic system s [7].

The possible relevance of pairs of non-identical backscattered paths, di ering slightly in their initial directions, was rst pointed out by Argam an [3]. Later, A leiner and Larkin [9] approached the problem of ballistic W L using both, perturbation theory and supersymmetricalmethods to derive a RMT result for the conductance. However, their techniques still rely on the presence of quantum scatterers (to regularize the Liouville operator) and strictly speaking do not treat the case of a clean, disorder free, system. Their approach was sem iclassically interpreted in Ref. [10] arguing that di raction-induced sm all angle scattering is relevant for ballistic W L.

Here we present an adequate, current-conserving sem iclassical treatment of the problem to quantitatively describe the average quantum conductance in clean chaotic systems without relying on any diraction or impurity scattering e ects. We consider the leading-order o diagonal contribution in a sem iclassical loop expansion of the Landauer conductance. The relevant o -diagonal terms consist of pairs of orbits which are very close almost everywhere (in con guration space), and di er only in whether they undergo or avoid a self-intersection with sm all crossing angle [11]. Our results are strictly derived for chaotic systems with uniform ly hyperbolic dynam ics, but related results for ballistic cavities indicate [14] that they apply to general chaotic system s.

We rst compute sem iclassical conductance contributions beyond the diagonal approximation in the Landauer fram ework and later return to the corresponding problem in the K ubo formalism. Consider a two-dimensional, classically chaotic clean cavity with two leads of width w (w<sup>0</sup>) attached that support N (N<sup>0</sup>) open channels. The Landauer formula for the conductance G then reads [15]

Here  $t_{nm}$  (E;B) denotes the transition amplitude between incoming and outgoing channels m and n at energy E in the presence of a magnetic eld B. We rst consider the case of time-reversal symmetry, B = 0, and return to the B-dependence of W L later. We assume that the ergodic time is much smaller than the escape time of the cavity and that contributions from direct, lead-connecting processes are negligible. Then the following RM T results for the transmission and relation amplitudes hold which we give for later reference [16,17]:

0 ur conductance calculation is based on the sem iclassical representation of transm ission am plitudes [18],

The sum runs over all lead-connecting trajectories which enter into the cavity at (x;y) with an angle  $\sin_m = m = (kw)$  and exit the cavity at  $(x^0;y^0)$  with angle  $\sin_n = n = (kw^0)$ , where n = n, and p = -k is the momentum, see Fig. 1 (a). In Eq. (4), S is the classical action, M<sub>21</sub> an element of the stability matrix, and  $= sgn(n)sgn(m) exp[i (m y=w ny^0=w^0 = 2+1=4)]$  is a phase factor where contains the M orse index. An expression corresponding to Eq. (4) holds true for  $r_{nm}$  in

term s of paths re ected back. The Landauer Eq. (1) contains products  $t_{nm} t_{nm}$  which sem iclassically amounts to evaluate double sums over an in nite number of trajectory pairs. In a treatment of the energy-averaged conductance most pairs, consisting of orbits with uncorrelated actions, will cancel each other upon summation. The existing sem iclassical approach [3] is based on the diagonal approximation, where only pairs of identical orbits or orbits related to each other by time inversion are taken into account. Then the phase factors from Eq. (4) cancel, and one has  $j_{nm} f_{diag}^2 = \ \sim (2ww^0) \ (nm) j \cos \ n \cos \ m M_{21} j^1$ .

First we give an alternative further evaluation of this expression employing the sum rule [19,20]

The sum runs over all orbits with periods T, which begin and end in intervals  $dy^0$  and dy around  $y^0$  and y with xed orientations of the initial and nalvelocities. (E) is the energy surface in phase space; (E) = 2 m A for billiards of area A. The factor (T) exp(T=) (for T!1) accounts for the exponential loss of particles with velocity v which escape through the openings characterized by the escape rate

Upon applying the sum rule (5) to the diagonal contribution, integrating over the lead cross sections, and including a factor 4 for each tupel (n;m) one nds for the transm ission coe cient of an ergodic system

Correspondingly, the quantum relection coe cient reads in the diagonal approximation

The sem iclassical evaluation at this level yields the (k = 0)-term of the RMT result (2,3). Note that the use of the sum rule (5) allow sus to compute individual transm ission and re ection coe cients, while Ref. [3] gives results only for the entire classical transm ission and re ection.

Summing the rst term in Eq. (8) over all channels yields the classical rejection  $R = N^2 = (N + N^0)$ . The second term in Eq. (8) arises from contributions to  $jr_{nn} f$  from backscattered orbits paired with their time-reversed partners (elastic enhancement). This gives rise to the diagonal contribution to W L,  $R_{diag} = N = (N + N^0)$ , as derived in [3]. In the lim it  $N = N^0$ ! 1 one has  $R_{diag} = 1=2$ , deviating from the RMT result  $R_{RMT} = 1=4$ .




FIG.1. Sketch of an o -diagonal trajectory pair form ed by a self-intersecting classical orbit (solid line) with small crossing angle " and a neighboring orbit (dashed) di ering mainly in the region around the self-intersection. The paths represent orbits with many relections at the system boundaries. They contribute to the quantum transmission (a) and relection (b).

In the following we go beyond the diagonal approxin ation and consider pairs of di erent trajectories as sketched in Fig.1 in coordinate space. They consist of a long, self-intersecting orbit (solid line in Fig. 1a),b)) with sm all crossing angle " form ing a closed loop and a second orbit in its close vicinity (dashed line). The two orbits follow the two open trajectory segments, beginning and ending at (exponentially) close points at the lead m ouths, in the same but the loop in opposite direction. Given a self-intersecting orbit with small "we showed that the neighbouring orbit indeed exists by linearizing the motion in its vicinity [19]. The action di erence S (") of the two orbits is computed by expanding the action around the self-intersecting orbit up to second order. The resulting formula for S, expressed through the elements of the stability matrices for the loop and the two open segments, is rather involved. Hence, we will focus from now on onto chaotic systems with uniform ly hyperbolic dynam ics characterized by a single Lyapunov exponent

and no conjugate points. One then nds [19]

Since a partner orbit is associated with each selfintersection with small crossing angle, we compute the conductance contribution from all such orbit pairs by rst summing for each orbit (n;m) over all "selfintersections and nally by integrating over ". Using Eq. (9) for the action di erences occuring in  $t_{nm}$   $t_{nm}$ (with  $t_{nm}$  from Eq. (4)) and the sum rule (5) one nds for this 'bop' contribution

In the sem iclassical lim it (~ ! 0) the contribution from sm allangles is dom inant. In Eq. (11), the density P (";T) of self-crossings with angle " for a long orbit of time T can be expressed as an integral over all loops, associated with the self-crossings, with times  $T_{m \ in}$  (") < t < T:

where  $p_{erg} = 1 = (2 \text{ m A})$  is the ergodic classical return probability. The lower cuto accounts for the fact that, ow ing to the exponential divergence of neighboring orbits in a hyperbolic system, a m inim um time  $T_{m in}$  (") is required to form a closed loop from two trajectories starting at the crossing with initial angular di erence ". Hence  $T_{m in}$  (") can be estimated from c ' "exp( $T_{m in}$  (")=2) with coforder . Detailed num erical and analytical studies [12] have shown that this indeed holds true and that the num ber of crossings for T ! 1 is given by

with  $T_{m in}$  (") = (2= ) log("=c). The integral (11) over the leading-order T<sup>2</sup> term in Eq. (13) is purely in aginary, and thus its contribution vanishes. However, the contribution to I(";T) of the second, logarithm ic term in Eq. (13) is nite and gives (~=2m A)T, independent of .We then obtain from Eq. (10)

Hence, the lack of short loops with  $t < T_{m \text{ in}}$  (") gives rise to a negative quantum correction to the transmission.

Correspondingly, we nd for the loop correction to the re ection coe cient

Here, as for the diagonal contribution (8), backscattering into the same channel is twice as probable.

Sum m ing over all initial and nal channels we obtain for the leading-order quantum transm ission and re ection  $T_{\rm loop} = N N^0 = (N + N^0)^2$  and  $R_{\rm loop} = N (N + 1) = (N + N^0)^2$ . For N; N<sup>0</sup> 1 we have  $R_{\rm diag} + R_{\rm loop}$ , N N<sup>0</sup> =  $(N + N^0)^2$ . For N; N<sup>0</sup> 1 we have  $R_{\rm diag} + R_{\rm loop}$ , N N<sup>0</sup> =  $(N + N^0)^2$  =  $T_{\rm loop}$ . This im plies conservation of the average current in the sem iclassical lim it. Considering o -diagonal terms allows us to sem iclassically com - pute W L corrections consistently either in transm ission or re ection. They precisely coincide with the RM T result  $T_{\rm RM T} = 1=4$  for N = N<sup>0</sup>! 1 . Com parison with the RM T results for nite N; N<sup>0</sup> suggests that the kth order term s in Eqs. (2,3) correspond to sem iclassical k-loop contributions; the diagonal term s are considered as 0-loop and the orbits in Fig. 1 as 1-loop term s.

Since the closed loops form ed by the o -diagonal orbit pairs are traversed in opposite directions, see Fig. 1, these orbits acquire an additional action or phase di erence in the presence of a weak magnetic eld B due to the ux enclosed. For a uniform perpendicular eld the action di erence is  $4 \text{ AB} = _0$ , where A is the area of the loops and  $_0$  the ux quantum . We assume that the distribution p(t;A) of enclosed areas for trajectories of time t is G aussian with a system speci c parameter ,

This is usually well fulled for chaotic systems [1{3]. For nite B - elds we have to perform an additional integration of the eld\_induced phase di erences over the area distribution:  $_{1}^{}$  dAp(t;A)cos(4 AB =  $_{0}^{}$ ) = exp(t= $_{B}^{}$ ), with the magnetic time t<sub>B</sub> = (4 B =  $_{0}^{}$ )<sup>2</sup>: Up to timescales T<sub>m in</sub> (") a negligible ux is enclosed by loops with small crossing angles. We consider this by a respective time shift when inserting exp(t= $_{B}^{}$ ) into the integral (12) over loop lengths:

In Eq. (17) we used  $T_{m in}$  (")  $t_B$ . This corresponds to the original assumption,  $T_{m in}$  (") , in the range of interest,  $\pm$ . Only the term linear in  $T_{m in}$  (") contributes to the integral (11), and we eventually obtain, after computing the T-integral (10), a Lorentzian eld dependence of the transmission coe cient:  $\pm_{nm}$  (B)  $\frac{2}{L_{oop}}$  ( $\pm_{nm}$  (0)  $\frac{2}{L_{oop}} = (1 + = t_B)$ , A corresponding result applies to  $j_{nm}$  (B)  $\frac{2}{L_{oop}}$ . This coincides with the Lorentzian W L lineshape obtained in the diagonal approximation [3], making clear why the diagonal terms already qualitatively account for the W L peak pro le. The entire W L

correction from the diagonal and o diagonal (1-loop) contribution then reads, in terms of the classical re ection and transmission coe cients r  $_{\rm cl}$  and t $_{\rm cl}$ ,

O ur re ned sem iclassical approach to the Landauer conductance yields the correct W L m agnitude and lineshape.

The Kubo conductivity reads, in terms of advanced (retarded) Green functions G (r;r<sup>0</sup>;E) (for a system  $[e^2 \sim = (4 \text{ A})] \text{Trf}_x \text{ Gv}_x \text{ Gg}; \text{ with}$ of area A), =  $G = G^+ G^-$ . The trace is sem iclassically evaluated in position representation by approximating the products of G reen functions involved through double sum s over classicalphase-carrying paths. Pairing identical orbits in the diagonal approximation leads to the classical K ubo conductivity [2,7,8]; o -diagonal terms are again required to compute W L for chaotic systems. As a prototype of an extended clean chaotic system consider, e.g., a twodim ensional Lorentz gas. This has been experim entally realized by regular arrays or disordered ensem bles of antidots in two-dimensional sem iconductor heterostructures [21]. The antidots act as classical scatterers giving rise to di usive motion on long time scales, while the dynam ics for interm ediate tim es is governed by chaotic scattering.

O ur sem iclassical treatm ent of W L is based on o diagonal pairs of paths which have much in common with the orbits discussed above (Fig.1(b)): they consist of one long self-intersecting trajectory being backscattered after multiple bounces with antidots with nearly opposite mom entum and a neighboring orbit which follows the loop formed by the rst in opposite direction. A careful treatm ent of the conductivity trace integral for such pairs of backscattered paths (involving again cuto times logarithm ic in the crossing angle) gives rise to a non-vanishing negative quantum contribution at B = 0 [19].

This W L correction for chaotic systems with classical scatterers turns out to coincide with that from disordered systems with quantum in purity scattering. We nd

where t is the phase-coherence time and  $t_{el}$  the elastic scattering time due to rejections at the antidots. Dijusive motion on long time scales, accounted for in a sum rule similar to Eq. (5), is rejected in the ln. Eq. (19) coincides with the result of R ef. [9] for antidot systems when t is large compared to the Ehrenfest time.

The approach above can be generalized to treat linearresponse functions of other observables [19].

To conclude, a sem iclassical treatm ent beyond the diagonal approximation is appropriate to compute quantum corrections to the average conductance in clean chaotic conductors, both in the Landauer and Kubo framework. Chaotic classical dynamics is responsible for a logarithm ic angular dependence of the classical retum probability, respectively the loops involved, which turns out to be crucial for computing weak localization. Num erical results for billiards [14] show that this log "dependence holds true also for nonuniform ly hyperbolic systems indicating that the mechanism presented here is rather general. A sem iclassical evaluation of higher-order loop corrections is yet to be perform ed. W hile such term s are not negligible for the spectral form factor, the oneloop corrections considered here play the dom inant rôle for quantum transport in the mesoscopic regim e.
