Persistent Currents in Carbon Nanotubes

A bstract

Persistent currents driven by a static magnetic ux parallel to the carbon nanotube axis are investigated. Owing to the hexagonal symmetry of graphene the Ferm i contour expected for a 2D-lattice reduces to two points. However the electron or hole doping shifts the Ferm ienergy upwards or dow nwards and as a result, the shape of the Ferm i surface changes. Such a hole doping leading to the Ferm i level shift of (m ore or less) 1eV has been recently observed experimentally. In this paper we show that the shift of the Ferm i energy changes dram atically the persistent currents and discuss the electronic structure and possible currents for zigzag as well as arm chair nanotubes.

1 Introduction

There is a considerable research activity to explain physical properties of single-wall and multi-wall carbon nanotubes. Their remarkable magnetic and electrical properties stem from the unusual electronic structure of the graphene sheets - the quasi-2D material from which they are made. The in uence of magnetic eld on transport properties of carbon nanotubes has been explored, both in theory [1{3] and in experiment [4{6]. In our paper we consider the in uence of the magnetic eld on persistent currents and structural properties of these materials induced by their topology. The strong dependence of the band structure on the magnetic eld suggests large orbital magnetic response. Indeed, large magnetic susceptibilities were calculated and experimentally observed [7,8] for magnetic elds both perpendicular and parallel to the tube axis. These results suggest the existence of persistent currents.

In a nanotube the component of the momentum along the circum ference of the tube is quantized owing to the periodic boundary conditions. This raises the possibility of inducing persistent currents along the circum ference of the nanotube by a static magnetic eld applied parallel to the tube axis. They arise due to A haronov-Bohm e ect. Such currents, but in toroidal nanotubes, have been recently discussed theoretically [9,10].

Persistent currents in nanotubes bear som e resem blance with those in m etallic and sem iconducting rings or cylinders. It is wellknown that persistent currents in m esoscopic cylinders depend strongly on the correlation of currents from di erent channels [11] and on the shape of Ferm i surface [12]. The m agnitude of the currents increases with increasing curvature of the Ferm i surface. The current is strongest for the Ferm i surface having large at regions perpendicular to the direction in which the magnetic eld changes the wave vector k. The shape of the Ferm i contour expected for a 2D hexagonal lattice depends strongly on the band lling. For an undoped carbon nanotube $E_F = 0$ and the Ferm i surface reduces to two isolated Ferm i points instead of a whole contour. E lectron or hole doping shifts the Ferm i energy upwards or dow nwards. As a result, the shape of the Ferm i surface changes and this in uences the persistent currents. A substantial Ferm i level shift of (m ore or less) 1eV has been recently obtained [13] by the means of an electrochem ical gating.

In the present paper we study peristent currents induced by a static magnetic eld parallel to the axis of a single wall carbon nanotube. We investigate the magnitude and shape of the current as as well as their dependence on the hole doping. In particular we show that for zigzag nanotubes, for certain values of the hole doping, we can obtain a large enhancement of the persistent current. Finally, we brie y discuss the possibility of creating self-sustaining currents in multiwall nanotubes.

2 The structure of a nanotube

The nanotube is a rolled up strip of a graphene sheet. The rolling vector is $L_t = m_1T_1 + m_2T_2$ (the t index stands for transverse direction), where T_1 and T_2 form the standard basis vectors of the graphene lattice [14]. The vector of the length of the nanotube is $L_1 = p_1T_1 + p_2T_2$ (the l index stands for longitudinal direction). The four integers $(m_1;m_2)$ $(p_1;p_2)$ therefore de ne the geometry of the tube. The number of lattice nodes of the nanotube is $N = m_1p_2 - m_2p_1$: Note that L_t and L_1 do not have to be orthogonal (the nanotube is then twisted [14]) but for simplicity we always take in our paper the twist angle to be 0, i.e. $m_1;m_2;p_1;p_2$ such that they are orthogonal.

The wave vector $\mathbf{k} = (\mathbf{k}_x; \mathbf{k}_y)$ of an electron on a surface of a 2D cylindrical tube obeys two boundary conditions. The rst, periodic along the circum ference of

the nanotube, is

where, in the absence of magnetic eld, l_t^0 is an integer. The second boundary condition, which results in vanishing of the sinusoidal wave function at the ends of the nanotube, is

where l_1 is an arbitrary integer. The rst B rillouin zone of the whole graphene sheet is a hexagone whose vertices are $\left(\frac{2}{3^{b} \cdot 3}; \frac{2}{3}\right)$ and $\left(0; \frac{4}{3}\right)$. The wave functions with l_1 and l_1 are linearly dependent and therefore the rst B rillouin zone of the nanotube reduces to a half of the original hexagone. In our choice l_1 takes only positive values.

The energy of the k-th state of the hexagonal lattice, in the tight binding approximation, is well known [14] to be

is the resonance integral for the nearest neighbour interaction (we where = 3:033eV; typical for the carbon hexagonal lattice [9]). The energy take m ay change from 3 to 3. At the half-lling, when half of the possible states are occupied, the Ferm i level is at $E_F = 0$ and the Ferm i surface reduces to isolated points { vertices of the original hexagone. Only two of them, e.g. $K_1 = \left(\frac{2}{3^{\frac{1}{2}}};\frac{2}{3}\right)$ and $K_2 = \left(\frac{2}{3^{\frac{1}{2}}};\frac{2}{3}\right)$, are linearly independent and therefore de ne the whole Ferm i surface of the nanotube at $E_F = 0.W$ hen less than a half of the states are occupied (the nanotube is hole-doped), the Ferm i level lowers and becomes a set of curves (drawn as cotinuous bold lines in Fig. $2\{4a, and Fig. 6a\}$. At $E_F =$ the Ferm i surface is a half-hexagone whose vertices are at the centre of edges of the rst Brillouin zone (cf. Fig. 3a). In this case the number of occupied states N_e is equal to 3/4 of the half-lling, i.e. $N_e = \frac{3}{4}N$.

A fter applying the magnetic eld along the axis of the nanotube, all the wave-functions acquire the A haronov-Bohm phase factor $e^{i2} = 0$, where is the magnetic ux through the nanotube and $0 = \frac{hc}{e}$ is the ux quantum. This phase factor is equivalent to a shift in the momentum quantum number l_1^0

where l_t is an arbitrary integer. The magnetic eld induces persistent current along the transverse direction of the nanotube

Sum ming over all momentum states within the rst Brillouin zone and below the Fermi level, we obtain the overall current, induced by the magnetic ux.

W hen all the shifted states remain within the Brillouin zone and below the Ferm i level, the current is diam agnetic. If, due to the shift induced by , some states leave the Brillouin zone or cross the Ferm i level, and others enter it or cross the Ferm i level in the opposite direction, we witness a param agnetic jump of the current [15]. This total current depends also on the tem perature which suppresses its am plitude [12,15], but for sim plicity we assume here that T = 0.

3 Persistent currents in zigzag nanotubes

We have perform ed num erical calculations for nanotubes of various geom etries. First we discuss the case of a (14;0) (100;200) nanotube. The Brilbuin zone, at zero magnetic eld, for this nanotube is shown in Fig.1a. It is equivalent to the upper (or lower) half of the original Brilbuin zone of the graphene sheet [14].

In the half lling case (E $_{\rm F}$ = 0) there is one conduction electron per each lattice node i.e. N $_{\rm e}$ = N . (in our case N = 2800). This nanotube is not m etallic and there are no allowed momentum states in any of the Ferm i points (the condition for m etallicity of the tube is (m $_1$ m $_2$) $j_{n\ {\rm od}\ 3}$ = 0). The persistent current in units of $I_0=\frac{c}{_0}=1.29$ 10^4 A, induced by the magnetic eld is plotted in Fig.1b. The current is periodic with period $_0$ and diam agnetic at sm all .

A s the ref.[13] shows, the Ferm ienergy can be lowered by binding some of the electrons (hole doping) and then $N_e < N$. In the following we assume that the doping lowers the number of electrons to a constant N_e , which does not depend on . Therefore, as the distribution of the momentum states in the Brillouin zone changes with , the value of E_F must be adjusted to keep N_e

independent of . This is not the case for $E_F = 0$, where the number of states in the st Brillouin zone is constant (N $_e = N$) and does not depend on .

The Fig. 2a shows the reciprocal lattice and the Ferm i contour (bold line) for $N_e = 2744$ at = 0. It corresponds to the Ferm i energy shift of approximately 1eV, (or =3) which has been obtained experimentally [13]. The change of Ferm i energy with $=_0$ is shown in the Fig. 2b. We see that the oscillations are around =3 and have quite a substantial amplitude of approximately 0.07. The induced persistent current Fig. 2c has now four times higher amplitude and a di erent shape.

The most favourable situation for the enhancement of the current is when the Fermi level is at the value of . It corresponds to the number of electrons $N_e = \frac{3}{4}N$. The Fermi surface then becomes the smaller half-hexagon in the rst B rillouin zone (cfF ig. 3a), with the momentum lines parallel to its vertical edges. The oscillations of the Fermi level (shown on Fig. 3b) are three orders of magnitude smaller compared to the previous case of $N_e = 2744$. At = 0, a whole momentum line crosses the Fermi surface with the change of , which results in a large paramagnetic jump of the current (Fig. 3c).

The current's am plitude is 25-30 tim es higher com pared with the current at the half-lling. This is the largest persistent current possible to obtain in this nanotube. By further shifting the Ferm i level dow nwards, the Ferm i surface becomes curved and again the am plitude of the current gradually decreases.

The amplitude of persistent currents, at the most favourable value of 3=4 of half-lling, depends on the length and width of the tube. It is proportional to its length and decreases with its width. The reason for this is that the longer the tube is, the more dense are the states in the longitudinal direction, therefore, when a line of them crosses the Ferm isurface, the elect is proportionally greater. On the other hand, the wider the tube is, the smaller are individual currents:

Let us notice also what happens if the m₁ param eter of the nanotube (the one which determ ines its diam eter) changes. If m₁ is even, as in the previously discussed case, there is an even number of $k_t = const$ state lines inside the Ferm i contour for N_e = $\frac{3}{4}$ N (as in Fig. 3a) and the param agnetic jump of the current (Fig. 3c) occurs at integer values of $=_0$. If m₁ is odd, the number of $k_t = const$ state lines inside the Ferm i contour is odd and the param agnetic jump of the current occurs at half-integer values of $=_0$. We investigated such a situation and the result for a (15;0) (100;200) nanotube is illustrated in

Fig. 4. A gain a strongly enhanced current is obtained, but this time it is diam agnetic at sm all . This behaviour of the current bears a strong resem blance to what happens in a one-dimensional metallic ring: the currents like the one in Fig. 3c (\even" nanotube) occur if the number of electrons in the ring is even and the case from the Fig. 4c (\odd" nanotube) takes place for an odd number of electrons [15]. This analogy arises from the equivalent positions of the Ferm i level with respect to the last occupied state (line of states) in these two system s.

4 Persistent currents in arm chair nanotubes

At the half lling, the principal di erence between nanotubes of di erent chiralities is whether they are metallic or sem i-conducting. We know that if the nanotube parameters obey the relation $(m_1 \ m_2)_{j_{n} \text{ od } 3} = 0$, the tube is metallic, otherwise it is sem iconducting. This criterion follows from the speci c structure of the Brillouin zone at half-lling, and is not valid for $E_F \notin 0.At$ lower, or higher, band lling all the nanotubes are more likely to be metallic because when the Ferm ipoints become lines, the probability that some states lie on them increases.

The important feature is the shape of the tube's momentum spectrum. The chirality of the tube varies from (m;0) for zigzag nanotubes (where the momentum lines are parallel to the sides of the smaller, $E_F = hexagon$) to (m;m) for arm chair nanotubes (where they are parallel to one of the sides of the Brillouin zone). We now take the case of a (9;9) (150;150) nanotube which is shown in Fig. 5. Its length and width are similar to the (14;0) (100;200) tube and the number of electrons in the half lling case is $N_e = N = 2700$. The momentum lines are parallel to the sides of the Brillouin zone and the resulting current (Fig. 5b) has amplitude of the order of $2I_0$.

The current in this case is much smaller compared to the similar distribution of k-states within the allowed region in the Fig. 3a. The reason for the attenuation of the current in this case is that the individual currents (7) corresponding to the states at the edge of the Brillouin zone are much smaller than the currents carried by the states at the edge of the Ferm i surface. This can be seen by observing the equienergy lines at these edges (Fig. 3a and 5a).

Decreasing the number of electrons or lowering the Ferm i level does not enhance the persistent currents in this case. The reason for that is that the momentum lines $k_t = \text{const}$ are not parallel to any fragment of the Ferm i surface. An example of such a situation is shown in Fig. 6, where where $N_e = \frac{3}{4}N$. Both the attenuation and the oscillations of the current, as compared to the

half lling case, are caused by the lack of correlation between the states which now travel across the Ferm i surface separately.

In real systems, the temperature T > 0 would smooth down the oscillations shown in Fig. 6c and the resulting current would be very small.

5 Conclusions

The presence of quantized, delocalized electron states in carbon nanotubes should result in persistent currents. In carbon nanotubes, which are typically alm ost free of defects, these currents should be substantial and can change with doping. We have investigated the changes of the shape of the Ferm i surface with the hole doping and discussed the respective changes of persistent currents in zigzag as well as in arm chair nanotubes.

The currents are calculated under the assumption that the number of electrons is constant in the nanotube. They can be param agnetic or diam agnetic depending on the position of states in the stB rillouin zone and the shape of the Ferm i surface. We have shown that the largest currents can be obtained if the Ferm i energy is lowered from $E_F = 0$ (half lling case) to $E_F = 1$ (N $_{\rm e} = \frac{3}{4}$ N) for zigzag nanotubes. The Ferm i surface changes then from two separate points to a at contour and the induced persistent currents increase their amplitude 25–35 times. For chiral nanotubes such that m $_2 << m_1$ the enhancement of the persistent current at $E_F = -1$ can also be large. In arm chair nanotubes the situation is di erent, namely with hole doping

In aim chair nanotubes the situation is di erent, namely with hole doping the amplitude the peristent current decreases because the individual currents become less correlated.

The large am plitude of the obtained currents raises the possibility of obtaining self sustaining currents which produce the magnetic ux capable to maintain them selves even in absence of external magnetic eld [16]. However, spontaneous ux in single wall nanotubes will be very small { $= _0$ ' 10 ³ only. To discuss the problem of self-sustaining currents multiwall nanotubes are more suitable. This problem will be discussed in a forthcom ing paper. Below we will only brie y mention various possible cases.

In the case of multi-wall nanotubes, where many tubes are arranged in a coaxial fashion, the currents produced by all tube layers should superpose. However, the electrical properties of individual tubes have been shown to vary strongly from tube to tube [17]. First, let us assume that all the tubes have the same Ferm i energy $E_F = ...$ The most favourable case is when all (or a majority of) the tubes are of the zigzag type discussed in the section 3.

If all tubes have the same parity (even or odd) the amplitude of the total current is greatest { it can be 10-50 times larger than in a single wall nanotube. This current is param agnetic for even and diam agnetic for odd m₁ for sm all values of = 0. In such situation there is a large probability of obtaining self-sustaining currents.

W hen tubes belonging to the multiwall nanotube have di erent chiralities, the total current will be smaller due to the cancellation between currents from di erent tubes. However, the total current will not average to zero, and the net param agnetic current with period halving will be obtained. The least favourable case is when none of the tubes are of the zigzag type. The cancellation is then substantial and we obtain only a very small net current.

It seems that these novel and unusual properties of carbon nanotubes may have promising applications in areas such as the magnetoelectronics, e.g. in magnetic sensors.
