E ective eld theory for S = 1 quantum nem atic

For S=1 system with general isotropic nearest-neighbor exchange, we derive the low-energy description of the spin nematic phase in terms of the RP² nonlinear—model. In one dimension, quantum—uctuations destroy long-range nematic (quadrupolar) ordering, leading to the formation of a gapped spin liquid state being an analog of the Haldane phase for a spin nematic. Nematic analog of the Belavin-Polyakov instanton with $_2$ topological charge 1=2 is constructed. In two dimensions the long-range order is destroyed by thermal uctuations and at nite temperature the system is in a renormalized classical regime. Behavior in external magnetic—eld is discussed.

Low-dimensional spin systems have been attracting permanent attention of researchers over more than half a century. A rich palette of their physical properties determined by the essential role played by quantum uctuations makes them a very attractive playground for testing various theoretical concepts. In the last two decades, this interest has got a considerable in pact, motivated particularly by the increasing availability of quasi-low-dimensional magnetic materials. A number of exotic \quantum spin liquid" states has been discovered, the most wide known example being the famous Haldane phase in integer-spin antiferrom agnetic (AF) chains.

A generic exam ple of the H aldane phase is the isotropic H eisenberg spin-1 AF chain. However, the most general isotropic exchange interaction for spin S=1 includes biquadratic terms as well, which naturally leads to the model described by the following Hamiltonian:

where Sn are spin-1 operators at the lattice site n, and sum mation over the nearest neighbors is implied. There are indication $s^{2,3}$ that moderate biquadratic exchange is present in the quasi-one-dim ensional com pound = 0 corre- $LiVGe_2O_6$. The points and = spond to the Heisenberg ferro- and antiferrom agnet, respectively. In one dimension (1D), the model (1) is studied rather extensively, and a number of analytical and numerical results for several particular cases are available.^{1,4,5,6,7,8,9,10,11,12,13,14,15,16,17,18,19} It is m ly established that the Haldane phase with a nite spectral gap occupies the interval =4 < < =4, and the ferrom agnetic state is stable for =2 < < 5 = 4, while = 5 = 4 is an SU (3) symmetric point with highly degenerate ground state.20

Exact solution is available for the U in in-Lai-Sutherland (ULS) point = = 4 which has SU (3) sym metry. The ULS point was shown 12 to mark the Berezinskii-K osterlitz-Thouless (BKT) transition from the massive Haldane phase into a massless phase occupying the inter-

val =4 < < =2 between the Haldane and ferrom agnetic phase; this is supported by num erical studies.¹³

The properties of the remaining region between the Haldane and ferrom agnetic phase are more controversial. The other Haldane phase boundary = =4 corresponds to the exactly solvable Takhtajan-Babujian model; the transition at = =4 is of the Ising type and the ground state at < =4 is spontaneously dimerized with a nite gap to the lowest excitations. 4,5,6,7,8,9,13 The dimerized phase extends at least up to and over the point = =2 which has a twofold degenerate ground state and nite gap. 16,17,18

Chubukov¹¹ used the Holstein-P rim ako -type bosonic representation of spin-1 operators¹⁰ based on the quadrupolar ordered \spin nem atic" reference state with hS i = 0, hS_{x,y} i = 1, hS_z² = 0i, and suggested, on the basis of the renorm alization group (RG) arguments, that the region with $^>$ 5 =4 is a disordered nem atic phase. Early numerical studies²¹ seemed to have ruled out this possibility, and a comm on beliefnow 22,23 is that the dimerized phase extends all the way up to the ferrorm agnetic phase, i.e., that it exists in the entire interval 5 =4 < < 7 =4. However, recent numerical results²⁴ indicate that the dimerized phase ends at certain $_{\rm C}$ > 5 =4, casting doubt on the conclusion reached nearly a decade ago.

The aim of the present paper is to show that the lowenergy dynam ics of the model (1) for > 5 = 4 can be e ectively described by the nonlinear model for a unit director eld (i.e., a unit vector whose opposite directions are physically identical). The coupling constant becomes sm all in the vicinity of the ferrom agnetic phase boundary = 5 = 4. This form ulation allows one to establish many properties of the nem atic phase by using extensive results available for the standard (vector eld) 0 (3) nonlinear model. We also study the e ect of external magnetic eld, which can be easily incorporated in our form alism. We argue that in 1D the ground state is disordered, in a complete analogy with the Haldane phase in case of the vector O (3) model, and its elementary excitation is a m assive triplet. In 2D, long-range nem atic order exists only at T = 0. An explicit solution for the BelavinPolyakov instanton with half-integer charge in a (1+1)-dimensional isotropic nematic is presented.

W e start by introducing the following set of coherent states for S = 1:

The coherent state is characterized by vectors u and v satisfying the normalization constraint $u^2 + v^2 = 1$. The freedom to choose an overall phase factor can be xed by setting u v $_{\overline{R}}$ 0. It is easy to check that the resolution of identity $\frac{3}{4^2}$ D (u;v)ju;vihu;vj= 1 holds.

In what follows we are interested in the region around = 5 = 4, hence it is convenient to use the notation

U sing the states (2), one can construct the coherent state path integral, and the e ective Lagrangian will have the form



where the average of the local Hamiltonian for two neighboring sites 1 and 2 is, up to a constant, given by

Here we have included the Zeem an term B $_{\rm n}^{\rm P}$ S $_{\rm n}$ describing external magnetic eld B .




FIG. 1: Schematic T=0 phase diagram of the model (1) in the vicinity of the critical point $J_2=J_1$: (a) in dimension D=2; (b) in one dimension.

A ssum ing a uniform ground state and m in im izing hip i, one arrives at the mean-eld phase diagram shown in Fig. 1(a): at zero eld the ferrom agnetic phase with u = v = 1 = 2 is stable for $J_2 < J_1$, and at $J_2 = J_1$ one has a degenerate rst-order transition into the nematic phase with v = 0 and parallelalignment of u (actually, u and v can be used on equal term s, and we just voluntarily choose v to be zero in the ground state). Note that vector u is in this case a director since u and u correspond to the same state. In external eld the system acquires nite m agnetization hS i = B = $[Z (J_2 J_1)]$, where Z is the coordination number of the lattice, while nematic order persists in plane perpendicular to B. The magnetization increases with the eld, and at $B = Z (J_2)$ Ji) the nem atic undergoes a second order phase transition into the phase with fully saturated magnetic moment.

Our next aim is to study how the above classicalm eaneld picture changes due to quantum or thermal uctuations. We pass to the continuum limit in (4), viewing u and vas smooth eld distributions. From the meaneld solution one may assume that vu, and from the form

of the Lagrangian (4a) it is clear that v plays the role of m om entum conjugate to u, so that v will be eventually proportional to the time derivative of u (later this will be checked in a self-consistent way). We will thus keep only term s up to the second order in v, and derivatives of v will be neglected. Doing so, one obtains the following continuum version of the Lagrangian:

where V_0 is the volume of the elementary cell of the D-dimensional lattice, are vectors describing the position of Z nearest neighbors with respect to a given lattice site, and constraints $u^2 + v^2 = 1$, u = v = 0 are in plied. In what follows, we will assume for simplicity that the lattice is hypercubic, then Z = 2D, $V_0 = a^D$, and (k = r) = a c c, k = 1 ::: D, where a is the lattice constant.

The \slave" variable v under the assumption v under the assumption v can be integrated out, yielding

Substituting (6) back into (5) gives the following elective Lagrangian depending on u only:

where $c = 2Z J_2 (J_2 J_1)^{1=2} a=h$ is the characteristic lim iting velocity, and u now should be considered as a unit vector, $u^2 = 1$. Note that according to (6) a change of sign of u automatically means a sign change for v, so that u is in this approximation completely equivalent to u. The above description is valid at the energy scales E < E₀ = 2Z (J₂ J₁). One readily observes that (7) is nothing but the Lagrangian of the wellknown nonlinear model used as the e ective theory for antiferrom agnets^{1,25} (without the topological term). Even the additional terms in the second line of Eq. (7), describing the e ect of the external magnetic eld, are identical to those appearing in the model for antiferrom agnets. Thus, the low-energy dynam ics of model (1) in the nem atic phase is similar to the dynamics of an antiferrom agnet, with the only yet im portant di erence that instead of the unit vector of sublattice magnetization one now has the nem atic director u: the order param eter space is RP² instead of S². The -m odel form ulation, in contrast to the spinwave approach of Chubukov, 11 allows one to study full nonlinear dynam ics of the problem .

At zero eld, one can rewrite the Lagrangian (7) in a standard notation using dimensionless space-time variables $x = (x_0; x)$, x = r=a, $x_0 = ict=a$. The elective Euclidean action takes the following compact form:

with the coupling constant g is de ned as

Note that smallness of the coupling constant does not require a large-S approximation, and is controlled solely by the closeness to the ferrom agnetic phase boundary.

In one dimension (D = 1) continuous symmetry cannot be broken, and the ground state of (8) is disordered with exponentially decaying correlations. The correlation length for the usual O (3) (vector) model can be obtained within Polyakov's RG approach²⁶ as o (3) ae² =g. In the RP² -m odel, however, there is a rescaling in ow equations because of the change in the measure: the physical eld is not u, but the bilinear projector R = u T u. The action can be rewritten as

where hA; Bi = tr(ATB) denotes the scalar product. The function in the leading order is the same as for the O(3) model, 27 () = $\frac{1}{2}$, with the trivially rescaled coupling constant = 2g. Thus, for the correlation length in the RP 2 -model one obtains

in agreem ent with Chubukov's one-loop RG result 11 for interacting spin waves. The elementary excitation is a




FIG. 2: Belavin-Polyakov-type soliton in a spin nem atic: (a) the solution is given by w_1 (z) in the upper half-plane (respective to the line connecting points a and b), and by w_2 (z) in the lower half-plane, with the appropriate branch cuts shown as thick solid lines and numbers denoting the phase of w; (b) schem atic view of the solution, nem atic director u is shown as an ellipsoid in a projection onto the gure plane; white spot indicates the end of ellipsoid that is under the gure plane.

m assive spin-1 triplet, and the gap = hc= opens up exponentially slow as one moves away from the phase transition point $J_2 = J_1$:

The RP 2 and O (3) —m odels are also di erent with respect to their topological excitations. In the O (3) m odel there is a localized solution with nonzero $_2$ topological charge Q = $\frac{1}{8}$ d 2 " u (Qu Qu), known as the Belavin-Polyakov instanton (BPI). The simplest BPI with Q = 1 is described by w = (z a)=(z b), where the complex variable w (u) = (u_1 + iu_2)=(1 u_3) is dened as a function of the complex coordinate z = $x_1 + ix_0$, and generally any analytical function w (z) yields a solution. The BPI action $A_{BPI} = 4 hQ = g$ does not depend on the param eters a, b which can be interpreted as coordinates of elementary entities, merons, constituting a BPI. It was speculated, 25,29 that the correlation length $_0$ (3) / $e^{A_{BPI}=2h}$ is related to the concentration of merons.

In the RP² case the director nature of the eld makes possible BP I-type defects with half-integer Q, whose action is exactly one half of that for their O (3) model counterparts: $q \frac{\text{Indeed}}{z}$, consider a solution of the form $w = w_1(z) = \frac{\overline{z}}{z}$. For the O (3) model such a solution would be invalid, because it has a branch cut. In a

nem atic, however, w (u) and w (u) are physically identical, and the above solution can be matched with another one, w = w₂(z) = $\frac{z}{2}\frac{b}{a}$, so that w₂(u) = w₁(u) on some line. This is easily achieved by choosing the cuts as shown in Fig. 2. This solution has Q = $\frac{1}{2}$, and its action is just one half of that for the O(3) BPI. Curiously, this fact correlates with the extra factor $\frac{1}{2}$ in the correlation length exponent (11).

In the RP 2 m odel there is another type of topological defects, disclinations, characterized by a $_1$ topological charge (vorticity) q. It is argued that their presence could produce the BKT transition in the isotropic case. However, one can see that such a transition would occur above some critical value of the coupling $g_{\rm BKT}$ of the order of 1, and as long as $g=(1-J_1=J_2)^{1=2}-1$, one may expect that the disclinations will be bound in pairs and their elect can be neglected.

Our approach easily allows one to incorporate the effect of an external magnetic eld. Weak magnetic eld B < acts on the spectrum only in a trivial way (the Zeem an shift), but at <math>B = the gap closes and the system enters the critical phase with algebraically decaying correlations, which can be characterized as the Tom onaga-Luttinger liquid. The resulting phase diagram for 1D case is shown in Fig. 1 (b).

For D = 2, at zero tem perature the ground state should have long-range nem atic order, in agreem ent with

recent num erical results, 32 as long as g is sm all compared to some nite value g_c of the order of 1 which marks the transition into a quantum disordered phase. This latter transition is expected to be the same as a nite-temperature transition in the three-dimensional classical Lebwohl-Lasher model, which is the rst order supposedly due to the elect of disclination lines. 33 At T = 0 the phase diagram in presence of magnetic eld has the mean-eld form of Fig. 1(a). In sum m ary, we have shown that the low-energy dynam ics of the bilinear-biquadratic S = 1 system (1) for $^>$ 5 =4 can be e ectively m apped onto the RP 2 nonlinear model. We have argued that in one dimension this model exhibits a disordered nematic state, supporting early proposition of Chubukov 11 and recent numerical results 24 against the commonly adopted 21,22,23 point of view. Using parallels with the extensively studied vector version of the -m odel, one can easily extract necessary information on the properties of nematic phase. An instanton solution of the Belavin-Polyakov type with half-integer topological charge is presented.
