QUANTUM DYNAM ICS OF COUPLED BOSON IC W ELLS W ITH IN THE BOSE-HUBBARD PICTURE

A bstract

We relate the quantum dynamics of the Bose-Hubbard model (BHM) to the sem iclassical nonlinear equations that describe an array of interacting Bose condensates by in plementing a standard variational procedure based on the coherent state method. We investigate the dynamics of the two-site BHM from the purely quantum view point by recasting is the model within a spin picture and using then the related dynam ical algebra. The latter allow sus to study thorough ly the energy spectrum structure and to interpret quantally the classical symmetries of the two-site dynamics. The energy spectrum is also evaluated through various approximations relying on the coherent state approach.

1 Introduction

The simplest way to describe an array of interacting bosonic wells is represented by the second quantized Ham iltonian for charged bosons

where the operators $n_i = a_i^+ a_i$ count the number of bosons at the lattice site i, and the destruction (creation) operators a_i , (a_i^+) obey the canonical commutation relations $[a_i; a_j^+] = i_j$. The parameters T, U > 0, and represent the hopping am – plitude, the strength of the C oulom b on-site repulsion, and the chem ical potential, respectively. H am iltonian (1), known in the literature [1] as the Bose-H ubbard M odel (BHM), was originally derived as the lattice version of the second quantized $j j^4$ { eld theory used to m odel super uids adsorbed in porous m edia. It describes in fact a gas of identical charges that hop through a D dimensional lattice, and exhibit a repulsive action whenever two (or m ore) charges are situated at the sam e site. The bosonic character of the lattice stands in the fact that, in principle, an unlimited number of charges is allowed to occupy each lattice sites. On this account the BHM is able to m in ic appropriately various features of system s such as granular superconductors, short-length superconductors and Josephson junction arrays, hence deserving a grow ing attention in the recent years (see references in R ef. [2]). For the sam e reason the BHM seems to supply the appropriate theoretic fram ework in which describing an array of interacting Bose-E instein condensates.

The recent years have been characterized by rem arkable progresses in constructing experimental devices able to connesome hundreds of bosons so as to form real Bose-Einstein condensates (BEC) [3]. This has prompted as well the investigation of more structured situations in which two condensates (regarded as sites or wells led by condensed bosons within the BHM picture) can interact via tunneling processes [4]. In particular, a quite rich scenery of dynamical behaviors has been found to characterize the two-site case (named boson Josephson junction) in Ref. [5], where two coupled G ross-P itaevskii equations for two condensate wavefunctions are assumed as the minimal interaction scheme whereby describing interwell processes. This represents however the most general array of coupled BEC's so far realized even if BEC's with complex architectures have been constructed [6], and a large amount of both experimental and theoretic work has been devoted to construct arrays within the physics of uncondensed ultracold atom s in optical lattices (see Refs. [7], [8] and references therein).

D espite its almost purely theoretic value, it is interesting to illustrate for conceptual reasons the link between the BHM and a system of many bosonic wells regarded as interacting Bose condensates. We reconstruct such a correspondence in Sec. 2 for the general case and employ it in Sec. 3 to show how the two-site BHM coincides, in a sem iclassical picture, with a two-condensate system.

In this paper we shall focus our attention on the quantum dynam ics of the twosite case. Classically, the problem is known to be integrable since the dynam ics of the complex site variables z_1 , z_2 required to account for the system state (these identify with the wavefunctions of the two-condensate system) can be recast in terms s of two action-angle variables by exploiting the constant of motion N $j_{\rm R} j^2 +$ $j_{\rm Z} j^2$. The reliability of the classical picture comes, of course, from the fact that indeed the operators n, counts a large number of particle and thus identi es with its sem iclassical counterpart $j_{\rm R}$, j^2 via the correspondence scheme discussed in Sec. 2. A smaller number of particles per site makes reasonable recovering the quantum picture both because this is experimentally possible, and because it is interesting to investigate thoroughly the changes in the structure of the quantum states when going from the pure quantum regime to situations with an intermediate, more or less pronouced, sem iclassical character. Moreover, it is important to recall that the BHM exhibits a zero temperature -T phase diagram which contains regions of nite size (lobes) where the system loses its super uid character becoming an insulator [1, 2]. In this respect we are interested in making evident the structure of the two-site model eigenstates.

In Sec. 3 we review the sem iclassical form of the two-site dynamics and implement the standard requantization procedure for comparing it to the spectrum provided by the exact quantum treatment. In order to study the quantum dynamics of the two-site BHM in Sec. 4 we represent the Ham iltonian within a spin algebra realization based on the generators of su (2), in which the index of the algebra representation is proportional to the total boson number N. This establishes the equivalence between the usual description of the BHM Hilbert space through the bosonic Fock basis and a simpli ed picture relying on the angular momentum eigenstates. The latter, in turn, allow s one to use the su (2) coherent states (where the conservation of the total boson number has been already incorporated) when perform ing the classical limit.

The spin picture also provides the basis for developing in Sec. 5 the single-boson picture of the system dynam ics. This amounts to reconstructing the exact dynam ical algebra [9] of the two-site BHM . Explicitly, the model is reform ulated within an enlarged algebra {which identi es with su (N + 1) in its fundam ental representation { where the two-site Ham iltonian takes the form of a many-boson Ham iltonian on a (N + 1)-site lattice whose population is formed by a unique (e ective) boson. The algebraic formulation we introduce is viable to BHM 's with more than two site and provides a deeper insight of the dynam ics com plexity from the group-theoretic standpoint. M oreover, it appears particularly advantageous in studying the quantum counterpart of the nonintegrable classic dynam ics of the N-site BHM (N > 2). This problem will be considered elsewhere.

At the operational level, such an approach entails a reform ulation of the quantum dynamics in terms of a (classical) Ham iltonian which exhibits a quadratic dependence on the components of the su(2) picture states. In particular, such an Ham iltonian is employed in Sec. 6 to analyse various dynam ical regimes and to recognize the distinctive characters of both the super uid and the insulator behavior.

2 A rrays of condensates with in the BHM picture

The link that relates the BHM to a system of interacting boson condensates is easily established by in plementing the method used in Refs. [2, 10] for investigating the quantum dynamics of many-particle lattice models. To this end the one-dimensional (1D) Ham iltonian derived from (1)

su ces to generate a chain of M interacting wells namely the generalization of the case with two interacting condensates.

The method just mentioned combines the generalized coherent state picture of quantum systems with the time-dependent variational principle (TDVP) [9], and allows one to reformulate the quantum dynamical problem relative to (2) by a sem iclassical ham iltonian dynamics in terms of the expectation values

and generated within the TDVP procedure by H am iltonian $H_c(Z;Z) = hZ H_cZ$ i. The so-called trialm acroscopic wave function Z i here is assumed to have the form $Zi = {}^{0}_{j} \dot{z}_{j}i$, where 1 j M and $\dot{z}_{i}i$ are the G lauber coherent states [9] solutions of the standard equation $a_{j}\dot{z}_{j}i = z_{j}\dot{z}_{j}i$ for each j. The dynam ical equations for z_{j} (those for z_{j} are obviously obtained by com plex conjugation)

are derived [2] from the sem iclassical H am iltonian

through the standard form ulas $\underline{z}_j = fz_j$; H_cg based on the canonical Poisson brackets $fz_j; z \cdot g = (i=h)_{j;}$. It is easily checked as well that the basic feature $[H_c; N] = 0$ of the quantum system has a classical counterpart given by $fH_c; Ng = 0$, where $N = \sqrt{j} \cdot \frac{j}{2}$. The identication of z_j with the wavefunction of the j-th condensate establishes the link claim ed above, show ing explicitly that the elective dynam ics of BHM generates the classical dynam ics of coupled condensates.

3 Sem iclassical picture of the two-well system

It is interesting to derive the two-well dynamics from the general case of the M – site lattice described by H am iltonian (5). Upon assuming $z_{2s} = z_2$ and $z_{2s+1} = z_1$ (suppose that M is even and the lattice is endowed with periodic boundary condition), (5) leads to the two-site H am iltonian

This amounts to considering a special solution characterized by two independent complex variables with $j_1 j_1^2 + j_2 j_1^2$ representing the constant of motion. Remarkably, the same equations are obtained independently when assuming H to be the two-site H am iltonian equipped with the Poisson brackets $fz_a; z_bg = ab=ih$, a;b = 1;2. It is easily recognized that q-site models, where qp = M for some $p \ge N$, can be achieved by following the same procedure $(z_{+kq}, 0 \ k \ p, 1 \ q)$ and that their dynamics can always interpreted as solutions of the M-site model exhibiting the discrete translation symmetry $z_{j+kq} = z_j$, 8j, $0 \ k \ p$. The physical interpretation of such a symmetry is given by the Fourierm odes description of the dynamical variables M $b_q = -jz_j exp[iqj]$, where $q := 2 \ q=M$, $j;q \ge [1;M]$, and M $(j \ \gamma)_p \ qexp[iq(j \ \gamma)]$. By inserting the condition $z = z_{2s}$ and $z_1 = z_{2s+1}$ one nds $b_0 \ M \ (z_1 + z_2)=2$, and $b_{M=2} \ M \ (z_1 \ z_2)=2$ that in ply

Therefore the two-site model represents the simplest possible way to construct an excited state with respect to the condensed macroscopic state characterizing the zero temperature regime where $z_j = b_0 = \frac{M}{M}$, 8 j. Ham iltonian (6) can be rewritten as

where we have introduced the new canonical variables $N = jz_1 f + jz_2 f$, $D = jz_1 f + jz_2 f$, $D = jz_1 f + jz_2 f$, D = (1 - 2)=2, and = (1 + 2)=2 implied by $z_j = jz_j jexp(i_j)$. The new coordinates are equipped with the Poisson brackets

the dot denotes the time derivative d=d with = t=h. Based on the complete integrability of the system, and proceeding along the same lines of Ref. [10], one can reduce the above two equations to a unique one

where E = H is a given value of the energy, which reproduces the result achieved in Ref. [11]. Going to its second order version

This has the form D (t) = A on [($_0$);k], in which $A^2 = (1 + a = ^2)=(b^2)$, $k = (1 + a = ^2)=2$, and is a scale time that can be xed arbitrarily [12].

In order to implement the requantization precedure a la Brillouin-Einstein-K eller [13] the complete set of the xed point is requested. These are




Figure 1: (a) left gure illustrates the minimum separatrix (dotted lines) and the two separatrices (dashed lines) associated to each maximum pair for < 1=2; (b) right gure shows the merging of separatrices for = 1=2.

respectively. The structure of the D phase space depends on the parameter = T=N U. For < 1=2 the domains containing the maxima (consider, for example, those related to = =2 represented in Fig. 1a) are con ned by a separatrix

can increase inde nitely. A nother pair of separatrices con ne the curves encircling

the minimum. These are obtained from (8) by setting the reduced energy equal to $_{\rm S}$ and read

For = 1=2 the separatrices of the two maxima intersect in $= =2, D_m = 0$ thus elim inating the possibility of ballistic evolution of the phase. At the same time (see Fig. 1b) they merge with the minimum separatrices (16).




Figure 2: (a) left gure illustrates the eight-shaped separatrix encircling each maximum pair for 1=2 < < 1; (b) right gure shows the phase space for > 1.

For > 1=2 two-branch separatrix (15) form sa unique curve which is displaced vertically and pin the upper boundary of the phase space $(D_M = N)$ to the lower one (D $_{\rm M}~=~$ N). The values in the interval 1=2 < ~< 1 correspond to situations in which a new eight-shaped separatrix encircles the two maxima (see Fig. 2a) and divides the curves of motion that locally sourround each maxima from those that contain both. Equation (16) still describes such a separatrix centered in the saddle point ($D_m = 0$, = =2), but it is convenient to introduce the variable ==2 in view of the fact that $(1 \ 2)$ is now negative. In the limit $! (1=2)^+$ the vertical separatrix and the eight-shaped separatrix merge, while for ! 1 the maxima merge (see Fig. 2b) thus generating a conguration with a unique maximum which characterizes 1.

An approxim ate evaluation of the energy level distribution can be easily obtained for curves of motion close to the extrem alpoints just introduced. Upon expressing D as a function of

In general, the exact calculation of the above integral is quite di cult. Therefore it is convenient to reduce H to a diagonal quadratic form in proximity of both m in in a and m axim a. In the case of the m in im um (D = N 1; 1) the resulting Ham iltonians reads

The case when the H am iltonian exhibits two maxima is quite interesting in that the presence of pairs of isoenergetic trajectories (spatially disjoint) suggests the possibility for the system to undergo a tunneling e ect when considered quantum – mechanically. Indeed this is the case for $_{\rm S}$ < $_{\rm M}$, and 1=2 < < 1 where isoenergetic trajectories appear around the points

in the phase plane (D;). Due to the tunneling e ect, close to the value = 1=2 the rst order corrections in h must be accounted when approximating the energy levels.

A simple way to evaluate such an e ect is obtained via the following standard scheme [14] showing how the tunneling probability is nonvanishing when the barrier that separates the motions around P_R and P_L is nite. In this case a new relevant contribution (to the second order in the perturbative approximation) must be added to the energy levels (22).

Let H_R and H_L be the quadratic approximation of H around P_R and P_L , respectively, and $j_R i$ and $j_L i$ the eigenstates of H_R and H_L corresponding to the same eigenvalue E_M (n); the two eigenvalues:

4 The spin picture of the quantum dimer

The Ham iltonian of a lattice form ed by two sites (dim er) reads

where now N $n_1 + n_2$, whereas the factor T of the hopping term in place of T=2 is the only di erence distinguishing the open chain case from the case with the periodic boundary conditions $a_{M+j} = a_j$ with M = 2. Upon introducing the two-boson realization of the su (2) generators

This fact has two consequences: First, the size of the Hilbert space of the system, encoded in the eigenvalue J of J_4 , is related explicitly to a macroscopic feature of the system since $2J_4$ coincides with the total particle number operator N. The latter naturally plays the role of constant of motion within our group-theoretic picture in that J_4 is a group central element that is $[J_4; J_a] = 0$, a = 1; 2; 3. Moreover, (27) shows how, due the nonlinear term J_3^2 , H cannot be diagonalized via a simple unitary transformation of the group SU (2). In view of the nonlinearity of (27) the problem of diagonalizing H for any value of J can be faced either by expressing J_3^2 (and J_1) linearly in terms of the generators of a larger (dynam ical) algebra, or by constructing approximation procedures capable of retaining the relevant features of the spectrum. The latter point of view is assumed in this Section.

Consider rst the low part of the spectrum of H, the features of which should be relevant to the zero temperature phase diagram of the BH model. The spin form ulation of the problem allows one to implement an approximate approach based on the C asim ir operator. In fact, the observation that the classical energy m inimum is reached for $J_3 = J_2 = 0$, and $J_1 = + C$, where $C = J_1^2 + J_3^2 + J_2^2$ is a constant, leads to approximate J_1 as $J_1' C [1 (1=2C)(J_3^2 + J_2^2)]$ which implies

The variables $J_3; J_2$ (considered "sm all") account for sm all displacements around the energy minimum. At the quantum level, the inequalities $h_{J_s}i$ C concerning the expectation values of J_s , with C = J(J + 1) = N(N + 2)=4 >> 1, and s = 2;3make natural to adopt the perturbative scheme where the operator J_2 and J_3 can be treated as canonically conjugate variables since

Then, after labelling by the integer p the eigenstates of the harmonic oscillator term $[1 + T = (2U^{T_s}C_s)][J_3^2 + W^2J_2^2]$ contained in (28), where $W^2 = [1 + 2U^{T_s}C = T]^{-1}$, its eigenvalues are found to be CW (2p + 1) so that the spectrum of H reads

The approximation just implemented is of course exact for UN = 0. Hence its natural range of validity seems to be given by the condition T=N U 1, which can be interpreted semiclassically as the requirement that the expectation value of the hopping term $T_j J_1 i j' TN = 2$ is greater than the (maximum value of the) C oulom b expectation value $U h J_3^2 i' UN^2 = 4$. This appears to be consistent with the fact that the harmonic oscillator form of the above spectrum is originated by the spectrum of J_1 which is both linear and bounded from below. When T=N U < 1 the spin structure of the problem fully emerges since J_3^2 introduce the in uence of its quadratic degenerate spectrum.

The importance of the condition $T=N \cup 1$ is even more evident when describing the spectrum close to the maximum energy con guration. In this case the approximation $J_1' = \frac{c}{c} \frac{[1}{c} (1=2C) (J_3^2 + J_2^2)]$ makes appear in H the harmonic oscillator term $[T=(2U \cap C) \quad 1][J_3^2 + {}^2J_2^2]$ where ${}^2 = T=(T \quad 2U \cap C)$ which involves a spectrum of the form

For T=N U < 1 the system no loger exhibits a unique maximum so that the oscillator approximation of the problem does not work: the squared frequency ² becomes imaginary. The spin picture thus appears as the correct approach for understanding quantum mechanically the degeneracy caused by the presence of two (classical) symmetric maxima for T=N U < 1.

5 Two-well system dynam ical algebra

5.1 Single-boson picture

Considering the subalgebra su_N (2), in the spin representation J = N = 2 where N is the total number of boson, within the algebra A = su(M) allows us to recast the nonlinear Ham iltonian H in terms of a linear combination of generators belonging to A. The latter is therefore a dynam ical algebra for the system. The sim plest possible choice for A is provided by the two-boson operator realization of $su_Q(M)$ the generators of which have the standard form

where 1 q;p M = N + 1. The states jJ;m i constituting the standard basis of su_N (2) can be similarly realized within the column vector basis fjqi;1 q N + 1g via the identication jJ;m i jqi with m = J + 1 q. The ensuing matrix version of the su_N (2) generators reads

thus entailing that J_+ and J_3 can be rew ritten within su (M) (recall that M $\,$ N + 1) as

that, due to the norm alization condition, turn out to de ne the manifold $\Pr_{q=1}^{P_{1}} j_{q} j$ in the bosonic H ilbert space. Such a manifold is an hypersphere in C^{N+1} and represents the elective space in which the quantum dynamics of H can be reformulated in a classical form in such a way to mantain a complete equivalence with the original quantum problem. In fact the classical dynamics thus obtained actually concerns the time evolution of the components of j i once the initial condition j (0) i at t= 0 has been assigned.

Based on Eq. (36), the Schrödinger problem ($i\theta_t = 0$ can be rewritten as a set of equations of motion

where we have adopted the notation $m \approx q$, and $J(m) \approx R(q;J)$ with $m \approx J+1$ q, in order to make the present form alism closer to the spin picture introduced previously. Equations (37) can be derived in an independent way from the elective H am iltonian

representing the energy expectation value h $\frac{1}{2}$ j i H [], provided the Poisson structure f $_{q}$; $_{p}g = _{qp}$ =ih is assumed. The eigenfrequencies associated to (38) and the related periodic orbits coincide with the eigenvalues and the eigenstates of (37), respectively. The latter are obtained from the solution of the secular equation

that is easily derived from the equations of motion (37). The eigenstates components X_m in Eqs. (39) can be shown to be real.

5.2 Spectrum structure

Two symmetries characterize the structure of the eigenstates. The rst is realized via the action of the unitary transformation $U_1 := \exp[i \ J_1]$ which takes J_3 into $U_1J_3U_1^+ = J_3$ so that $[H;U_1] = 0$. The action of U_1 on the standard basis is given by U_1 in $i = \exp[i \ J_1]$ mi. This corresponds to implementing the component transformation X_m ! sX m with s = 1 in Eqs. (39) that remain unchanged in that $\int_{J} (m + 1) \int_{J} (m)$ for each m. Each eigenstate has therefore a denite symmetry character which we make explicit by writing the eigenstates as

in the symmetric and antisymmetric case, respectively. The energy spectrum is not degenerate in that one has that E \in E⁰ for any pair of states $\not\equiv$ i₊ and $\not\equiv$ ⁰i .

A further sym m etry is obtained by com bining the action $U_3J_1U_3^+ = J_1 \text{ of } U_3 = \exp[i J_3]$ on TJ_1 in H, with the change T ! T which restores the initial form of H. The corresponding change of the eigenstate components X_m ! exp[i m X_m is easily derived from the fact that the standard basis is acted on by U_3 according to the form ula U_3 jm i = exp[i m]jm i. This does not make change Eqs. (39) provided the sign of T is reversed as well.

An important feature of the eigenvalues structure is recognized by comparing the secular equations for $\pm i_+$ and $\pm i_-$. We rst consider the case when J is a half of an odd integer. Then equations (39) can be written in the reduced form

where = 1 (+1) must be taken in the antisymmetric (symmetric) case. The remarkable consequence of the presence of in (43) is that one may distinguish the eigenvalues associated with the symmetric states from those related to the antisym – metric ones depending on the sign of . How this happens is clearly shown by the eigenvalues equation. The latter is obtained iteratively via the recurrence equation for the determinant of the associated secular equation

D eveloping (45) by m eans of (44) a (J + 1=2)-th degree equation for E is obtained. For = 0 no di erence distinguishes the symmetric case from the antisymmetric case that therefore exhibit pairs of eigenstates with the same eigenvalues. As soon as is switched on each eigenvalues bifurcates relatively to the two possibilities > 0 and < 0. For small values of T the leading order in (45) is T, so that it reduces to

There results that only the two low est eigenvalues are distinguished from those of the unperturbed case. Increasing T allows one to improve the resolution: for example, to the order T^2 , the four low est eigenvalues are separated.

The same scheme holds when J is integer (m = 0;1;2:::) but the hierarchy described above exhibits two special cases, for m = 0;1:

with C = A; S, whereas Eqs. (42) account for 2 m J. The parameter must be set equal to one in the symmetric case (C = S), while in the antisymmetric case (C = A) the expected elimination of the component A_0 is realized by setting = 0. It follows that the H ilbert space dimension decreases while the secular equation will have a degree diminished of one. Explicitly, one has

which reduces to $0 = d\mathbb{E}; 1$ for ! 0. In the symmetric case a (J + 1)-th degree equation for E issues from (48) through the same form ula (44).




Figure 3: Energy level distribution for T = 4, U = 1, N = 41. The index m 2 [1;42] labels the energy eigenvalues.




Figure 4: Energy level distribution for T = 24, U = 1, N = 41. The eigenvalues are labelled by the index m 2 [1;42]. Three doublets are still visible for m < 6




Figure 5: T = 60, U = 1, N = 41: the in uence of UJ_3^2 in Ham iltonian (27) is almost negligible.

For T su ciently sm all the energy levels appear to be structured in doublets (see Fig. 3) that m in ick the emergence of the energy degeneracy actually reached only

for T = 0. The eigenvalues of the doublet sector satisfy the inequality E > TN, consistently with the role played classically by the saddle point energy $_{\rm s}$ of form ula (14). Thus the doublet number decreases when T is increased (see Figs. 4, 5). This e ects issues from the fact that both and are multiplied by T in (45) and (48), respectively. The limit T ! 0 thus incorporates the limits ; ! 0 whereby the degeneracy crops up (each E is associated to a pair fEi). The eigenstates generated (in the same limit) fEi (jn i j m i)=2 have the same self-energy E (0) = C (J) + 2U m² of the noniteracting m odel (com petition among the m m odes switched o by T = 0, that is, no interwell dynamics).

The splitting of energy levels caused by T \leq 0 guarantees the important feature that eigenstates are structured so as to have components that are either symmetric or anti-symmetric with respect to the inversion m ! m. A full degeneracy, in fact, should allow for the occurrence of states inducing a strong localization in proximity of those values of hJ₃i that classically correspond to the energy peak positions. In this case the eigenstates should exhibit a marked sem iclassical character that corresponds to states where either the components with m > 0 or those with m < 0 are strongly depressed in order to permit the localization e ect.

Despite the absence of states involving a stable localization around one of the two energy peaks for energy values E > T=U when T=UN < 1, the realization of localized states can be attained by superpositions of the two states corresponding to the doublets. Each such a pair of states is composed by a symmetric eigenstate and an antisymmetric one with an energy gap E which vanishes for T ! 0. The congurations where the system is localized undergo a periodic revival (with a life time proportional to 1=E) which ensues from the time dependence of the eigenstate interference mechanism.

6 D iscussion

The structure of Ham iltonian (38) allows us to interpret the time evolution of a generic state j i as the dynam ics of an ensemble of linear oscillators with a space-dependent coupling ($_{J}$ (m) depends on m) in the linear lattice of m modes. A certain amount of information can be extracted from (38) as to the form of the states j i close to the extrem al con gurations.

Let us consider, rst, the case ' 1 (we identify the classical parameter N with the eigenvalue N = 2J so that T=UN). The greatest coe cients of the hopping term (m ax [T_J(m)]' UN²=2) are comparable with the greatest coe cient of the C oulom b term (m ax [2Um²] = UN²=2). On the other hand, such two classes of terms involve di erent components that are labelled by m ' 0 and m ' N=2, respectively. The m inimum energy state is therefore characterized by components m = R_m exp(i_m) such that m m+1 (the phase-locking involves the m ost negative the hopping term), whereas the m odes jn j N=2 (jn j' N=2) must be m axim ally occupied (strongly depleted). The dynam ics of weaky excited states is expected to exhibit a sim ilarm ode partecipation with the breaking of the (collective order of the) phase-locking due to sm all phases' oscillations.

For opposite reasons the maximum energy state is characterized by an antiferrom agnetic type of phase order ($_{m+1} = _m +)$, while both the largest modes (jn j' N=2) and the sm allest ones (jn j N=2) contribute to maximize the energy. Such a phase order enables us to recognize the largest components of the maximum energy state starting from H am iltonian (38). Upon setting m' + m 1 to maximize the energy, and assuming that jj m j j m 1 j j m j j m 1 j m

For large values of J = N = 2 the labelm can be regarded as a continuous parameter so that the highest weight coe cient $[2Um^2 + T(_J(m) + _J(m + 1))]$ is singled out by dimension. This provides m [m (N² T²=U²)¹⁼²=2]' 0 where m =

 $(N^2 T^2=U^2)^{1=2}=2$ are the values for which j_m jm ust be maxim ized in order to reach to the highest energy con guration. This result matches exactly the classical representation of the maxim a in the phase space (see form ula (12)), except that quantum mechanically both the maxim a are involved in the dynamics. If 1, the solution m = 0 m ust be considered which rejects in a consistent way the coalescence of the two (classical) maxim a in a unique one.

The regime 1 is also intersting. This case is quite sensitive to the parity of N since the largest C oulomb term has gained a factor N with respect to the largest T-dependent term. If N is even (i.e. m assumes integer values) the system ground-state must be constructed in such a way that $j_0 j_m j \sin \alpha j_0 j d \cos \alpha$ not contribute to the C oulomb term. We thus approximate jiby neglecting any m such that m $\in 0$; 1. The resulting approximation of H [] reads

where we have assumed $j_{1} j_{1} j_{1}$ and the constraint $2j_{1} j_{1} j_{1} j_{1} j_{2} = 1$ holds. The latter suggests to set $2j_{1+1}j = sin$ and $j_{1}j_{2} j = cos$ in the above formula, which in turn appears to be minimized by tg = $2T_{1}(0)=U'$ TN = 2U. The ground-state energy thus reads

that reproduces the sem iclassical value E ' C (J) TN for T=U 1=N. If N is odd (m = 1=2; 3=2; ...) the C oulom b term never vanishes, and the main contributions to ground-state come from $_{1=2}$ and $_{+1=2}$, so that the related energy is approximated by

The characters distinguishing the even case and the odd case suggest the interpretation of such situations in terms of insulator and super uid states, respectively. In the odd case one has $m = 1=2; 3=2; \dots so$ that the ground-state is the superposition of the states N = 2; N = 2 + 1; and N = 2 + 1; N = 2 i which involves a perm anent one-boson tunneling between the two wells (super uid regime). In the even case the ground-state essentially coincides with jJ;0i N =2; N =2i which entails a stationary regin e where the two bosonic wells are equally led and the boson tunnelling is not favoured (insulator regin e). It is worth noting that any contribution of the hopping term turns out to be de nitely smaller than the Coulomb terms namely $\max[T_{u}(m)]' = 2 < \min[Um^2]' U when one sets$ $1=N^2$. The ensuing alm ost null in portance of the hopping term is precisely the signal of the transition from the super uid to the insulator regime which is known (see [1], [2]), for a given $1=N^{2}$. N, to take place at

A simple evaluation of the components X_m of the eigenstates associated with the energy spectrum extremes (where relative sign of X_m , X_{m+1} is denite) is obtained

by regarding m as a continuous parameter in Equation (39). In fact, upon setting $X_m = Y_m = \frac{p}{(J+m)!(J-m)!}$ and replacing Y_m_1 with Y_m d Y_m =dm in (39), one nds

where = +1 (1) for the minimum (maximum) energy state. The solution have the form $Y_m = Cm \exp(Um^2=2T)$ with = E = (2T) J and the consatant C is xed by in posing the state norm alization. The same treatment can be extended to the intermediate eigenstates but the sign oscillation of X_m 's, known from numerical calculation of eigenstate, requires a more accurate reform ulation of Eqs. (39) also involving a second derivative term.

7 Conclusions

In this paper we have focused our attention on the quantum aspects of the dynam ics of a two-site Bose-Hubbard model. The latterm in icks the interaction of two BEC's via tunneling e ect. This has led us to study thoroughly the nontrivial structure of the energy spectrum the upper part of which consists of a series of doublets if < 1, and has suggested the quantal interpretation of the degeneracy characterizing the classical congurations (a pair of symmetric orbits is associated to the same value of the energy).

The general fram ework in which we relate the quantum dynam ics of BEC's to the classical formulation usually employed for macroscopic condensates has been described in Sec. 2, where the purely quantum model of many lattice sites (bosonic wells coupled within the BHM picture) is reduced to a classical lattice eld theory by means of the TDVP procedure and the coherent state representation of the macroscopic (quantum) state of the lattice gas. Conversely, such a construction shows that a generic array of coupled BEC is naturally reconducted to the standard BHM and its generalization to nonperiodic lattice structures [15] when considered in a nonclassical regime (sm all or mesoscopic number of bosons per condensate).

Sec. 3 has been devoted to illustrate the classical form of the two-site model, its phase space, and the orbit structure therein. A fler discussing the integrable character of the system the dynam ics of which is completely accounted by canonical variables , D (see equations (9)), the requantization procedure a la BEK has been implemented. This provides integral (18) whose approximate solutions give the evaluation of energy levels (21) and (22) in proximity of the minimum and the maxima, respectively. The nice feature that (22) holds for < 1 has allowed us to incorporate the exchange elects via the procedure leading to formula (23). Such a result anticipates the basic trait of the spectrum represented by its doublet structure. The reform ulation of the two-site m odel in term s of a m acroscopic spin has been performed in Sec. 4. Such a picture of ers the possibility to approximate the energy spectrum in an independent way for levels close to the minimum and maximum values. The approximation well to the exact energy values for > 1 and shows implicitly how the exhaustive investigation of the spectrum unavoidably requires the spin picture. This paves the way for the construction of the dynamical algebra which is the base for the exact diagonalization of the model.

The realization of $\sup_{N} (2)$ within the larger algebra $\sup_{Q} (N + 1)$ in terms of a single-boson representation (Q = 1) has been developed in Sec. 5 and supplies the spin operators in the form (34). It provides the algebraic framework where the nonlinearity of J_{3}^{2} is eliminated and the H am iltonian becomes a linear superposition (see (35)) of $\sup_{1} (N + 1)$ generators. The procedure is easily generalized to manysite lattice [16]. The set-up developed leads to reform ulate the two-site model as a (N + 1)-lattice model described by the quadratic H am iltonian (35) and a population constituted by a single particle. The spin nonlinear dynamics has been nally reconducted to a classical problem with the quadratic H am iltonian (38) depending on the canonical variables $_{j}$ (these are the components of the wavefunction solving the Schrodinger equation) and $_{j}$. The proper modes of (38) coincides with the eigenvalues E of H that are grouped in two sectors E > TN and E < TN if 0 < < 1. The rst sector contains the doublets.

The basic result illustrated in Sec. 5 is that the levels of each doublet are associated to a symmetric state and an antisymmetric state exhibiting almost coincident secular equations. Their di erence, that turns out to be concentrated in one (or two) of the equations forming the hierarchy of equations for the eigenstate com ponents (see Eqs. (43) and (46)-(47)), has been represented via a parameter which pins analytically the symmetric and antisymmetric eigenvalues. This explains the origin of the doublet structure through a bifurcation mechanism which represents the main result of the present paper. In Sec. 6 the two site model ground-state has been interpreted for 1=2 as a state with a super uid (insulator) behavior for an odd (even) total particle number N thus showing how the germ of the lobe-like structure of the zero tem perature phase diagram is already present in a two-site lattice. The method and the analysis developed in the present work can be extended to lattices with a number of sites greater than two. The bifurcation mechanism explained above is expected to provide the base for studying the chaotic character of the trim er case. W ork on the three-site case is in progress along these lines [16].
