# In uence of a low magnetic eld on the therm aldi usivity of Bi-2212

#### A bstract

The therm all di usivity of a Bi-2212 polycrystalline sample has been measured under a 1T magnetic eld applied perpendicularly to the heat ux. The magnetic contribution to the heat carrier mean free path has been extracted and is found to behave as a simple power law. This behavior can be attributed to a percolation process of electrons in the vortex lattice created by the magnetic eld.

### 1 Introduction

W hen a magnetic eld is applied, it is well known that the superconductivity properties collapse, e.g. (i) the critical temperature  $T_c$  decreases [1], (ii) the critical current density decreases [2], (iii) the electrical resistance and (iv) the them o-electrical power become e nite below  $T_c$  [3, 4], (v) the therm alconductivity behaves anom alously [5, 6]... Indeed a magnetic eld is known as a C ooper pair breaker. In fact the behavior of the mean free path of electricity and heat carriers in e.g. high- $T_c$  superconductors materials is a widely discussed problem particularly in presence of a magnetic eld.

W ithout a magnetic eld, the thermal conductivity of these materials exhibits a hump below the critical temperature. The cause is not wholly clear nor really understood: there are di erent view points, based on the prom inence of an increase of the m ean free path of phonon, thus with reduced scattering [7, 8, 9, 10] or from an increase of the m ean free path of electrons [11, 12, 13, 14, 15, 16, 17], or a complicated combination of both due to the chem istry [18]. Note that the previously quoted references are only a m icrosam – ple of a huge literature on the subject, but not all reports (m ore than 300) can be quoted here.

On the other hand, in presence of any finite applied magnetic eld, this mean free path apparently decreases as indicated by the low ering of the therm al conductivity hump amplitude. The discussion of the ndings pertain to the understanding of the mixed state properties for d-wave (or s-wave as sometimes thought) superconductors, and the role of phonons and electrons in a magnetic

eld (see above references in appropriate cases, and also [19, 20, 21]). If they are more or less well understood at high eld and low temperature, their interpretation is not so trivial in the regions where the various phase transition lines merge into each other, thus near  $T_c$  and at low eld [22].

Since the therm ald i usivity is related to the therm alconductivity, the sam e fundam ental questions arise here, - less studies are found. The therm aldi usivity is known to be a good probe for measuring the heat carrier mean free path [23, 24, 25] and even nd out the relevance of Van Hove saddle points in High T<sub>c</sub> superconductors [26]. D iscussing the therm aldi usivity behavior below and above T<sub>c</sub> in absence of a magnetic eld has recently allowed us to distinguish the contribution of electrons and phonons in the dissipation process. On the other hand, com parison of the therm aldi usivity behaviors with and without magnetic eld below T<sub>c</sub> should allow for extracting the contribution of the magnetic eld. This would give interesting informations about electron-vortex interactions.<sup>1</sup> Here we show that such a contribution can be extracted, even close to T<sub>c</sub>, and at rather low eld. The experim ental data are our own m easurem ents on a polycrystalline Bi-2212 sample. Despite its polycrystalline morphology, the advantage of such a sample resides in the possibility to obtain it as a long bar out of a pellet, whence allowing a ne sensitivity of the measurem ents even at small eld. This compound and sample are expected to be representative of m ost high-T  $_{\rm c}$  superconductor m aterials, in particular of their anisotropic (2D) nature.

In a simple kinetic model form alism, the therm aldiusivity is de ned as the ratio between the therm alconductivity and the volum ic specic heat c, and can be thus expressed through

The behavior of this contribution can give very interesting informations about the vortex-heat carriers interaction below  $T_{\rm c}$ .

where v is the velocity of the heat carriers and `the m ean free path. A ssum ing v to be a constant in a restricted range of tem perature of interest, as here, the therm aldi usivity is thus an adequate (or direct) probe form easuring the m ean free path of heat carriers. W hen a m agnetic eld is applied, `m ay be rewritten as usual within the linear superposition approximation as [27]

where  $b_0$  and  $b_{mag}$  are the mean free path of heat carriers respectively without and with the in uence of an applied magnetic eld. From Eq.(1) and Eq.(2)

where  $_0$  and are the thermaldi usivities without and with magnetic eld respectively and  $_{m aq}$  is the magnetic contribution to the thermaldi usivity.

These form ulae serve as a basis for the discussion of the vortex-heat carrier interaction in the mixed phase near T<sub>c</sub>. After a description of the synthesis and of the characterization of the sample in Sect2, the measurements of the therm all di usivity of the Bi-2212 sample are presented in Sect3. The magnetic contribution to the mean free path is extracted and the results are then discussed.

## 2 Synthesis and experiments

Powders of  $B_{12}O_3$ ,  $SrCO_3$ ,  $CaCO_3$ , CuO and  $PbO_2$  were mixed mechanically together using an agathe mortar starting from a 2234 stoichiom etry in order to obtain a 2212-BSCCO (Bi-2212) stoichiom etric composition. This mixture was decarbonated at 800°C for 20h and melted in an alum ina crucible at 1075°C for 30 m inutes in air. The liquid was quenched between two room temperature copper blocks to form a glass. The pellets were heated in oxygen atm osphere on a barium zirconate substrates at 860°C for 50h [28]. D espite its polycrystalline m orphology, the advantage of such a sam ple is that it can be long. This allows a better sensitivity for the measurem ent and the elect of a small eld can be as such observed.

The electrical resistivity curve is represented on F ig.1. The superconducting m idpoint transition occurs around 85 K. At high temperature, the resistivity is linear with a 10m m resistivity at 0K and about 40m m at 225 K. W hen a m agnetic eld is applied, the resistivity transition m idpoint is shifted towards lower temperature, ca. 80 K for a 1.0 T eld.

The therm aldi usivity has been measured as described in [29] and the technique is brie y recalled here. A rod is rst cut out from one of the chemically characterized Bi-2212 pellet. One of the extrem it is of the bar is xed to a heat

sink, whilst the other is linked to a heather. Three them occuples are set along the sample at equal distances from each other. A heat pulse is sent through the sample from one end and the change of temperature is recorded by one of the therm occuples. This operation is renewed 3 times, namely once per therm ocouple. The signals recorded by the two extreme therm occuples give the limit ("boundary") conditions so as to compute the shape of the signal from the heat di usion equation, at the middle therm occuple, for dierent a priori values of the therm all di usivity. The results of such calculations are compared to the measured signal at the middle therm occuple. The best t allows us to deduce the value of the therm all di usivity at this temperature.

## 3 Results and discussion

In Fig2, the therm all di usivity is shown between 20 and 160 K. The black bullets () represent the therm all di usivity  $_0$  without any magnetic eld. As for the circles (), they symbolize the results with a 1.0 T magnetic eld applied perpendicularly to the heat ux, . The two curves are seen to be superposed on each other at high temperature. Such a magnetic eld is indeed too sm all to create any visible e ects on thermal properties in the normal state. On the other hand, the thermal di usivity di erently behaves below the critical temperature with and without the magnetic eld: in presence of a magnetic

eld the di usivity is slightly lower. Thus the magnetic eld shows its expected pair breaker role. In the fram ework of the electronic model for heat transport, [11, 12, 13] that means that the electron-electron scattering is enhanced, or in other words that electrons have a decreasing mean free path.

The inset of the Fig.2 is the therm aldi usivity with and without the 1.0 T m agnetic eld in a log-log plot. This plot emphasizes that a break in the slopes occurs at 85K, the critical temperature of the Bi-2212 phase. This should be expected from our previous report [25]. The change in magnitude is due to the sudden increase of the m ean free path of electrons below  $T_c$ . They are indeed less scattered by their counterparts since some electrons belong to condensed C ooper pairs in this temperature range. Thus the visible deviation between the therm aldi usivity with and without a magnetic eld shows that even a small magnetic eld (1.0 T here) markedly acts on the therm al transport in superconducting phase.

The magnetic contribution to the mean free path can be obtained from Eq.(3). The results are shown in Fig.3, i.e.  $r_{mag} = r_0$  versus the reduced tem – perature " = JT  $T_c j=T_c$ . Notice that some numerical smoothening data is necessary in order to reduce error bar propagation. It is seen that the norm alized value  $r_{mag} = r_0$  behaves as a power law with an exponent found to be equal to 0:5.

This power law behavior and the exponent value itself rem ind us of the A zlam azov-Larkin law [30, 31] for the paraconductivity in its mean eld regime.

The law is usually studied between the onset tem perature  $T_o$  and  $T_c$ , thus above  $T_c$ . However the A zlam azov-Larkin law holds also below  $T_c$  because of the scaling hypothesis universality. The tem perature region which is here above studied extends much below the critical tem perature and the precision of the data near  $T_c$  cannot be expected to lead to critical uctuations studied per se, but the mean eld exponent of superconductivity uctuations might be probed. It can be shown that the same type of contribution exists in the electrical () and therm al () paraconductivity  $\beta 2$ , 33, 34, 35]. With the trivial change of variables on the tem perature axis  $T_c$  ! 0 and  $T_o$  !  $T_c$  respectively, we can write ', ', for the paratherm al diffusivity, the notation indicating

in both cases the deviation form the normal state behavior. Remembering that

for a 3D type of uctuations [30, 31], and assuming that 1T is a low eld such that the Azlam azov-Larkin law is still obeyed we can from the amplitude obtain an estimate of the shortening of the zero temperature coherence length between zero and 1 T eld. A simple numerical calculation leads to  $l_0(0) = l_{mag}(0) = 0.938$ .

As e.g. for neutron scattering processes in disordered 2D (magnetic) system s [36] the total inverse correlation length can be assumed to be the sum of a strictly them altern and a geometrical term linked (in that case) to the disordered network, i.e. a relation similar to Eq.(2) for . This analogy indicates that the found power law behavior can be interpreted as resulting from a percolation process of heat carrier through a com plicated vortex state [19, 37], and further justi es the analogy with the A zlam azov-Larkin law for heat carriers in the mixed state at low elds. One might also wonder  $^2$  why a 3D behavior (and exponent is found rather that the exponent, i.e. ' 1.0 corresponding to a 2D behavior, since B i-2212 is expected to have an e ective dimensionality closer to 2 than 3. The argument stems from the anisotropy itself. At the critical tem perature itself, the coherence length diverges and one expects a 3D behavior. W hen departing from  $T_c$  the e ective dimensionality signature should appear, thus leading here to a 2D behavior. How ever this lasts as long as the tem perature is in the tem perature range lim ited by the onset of the true critical regime, i.e. the G inzburg-Levanyuk tem perature,  $\beta$ 1] and by the Law rence-D oniach tem perature, in anisotropic systems [32]. Away from the Law rence-Doniach tem perature, up to the onset tem perature, or at low tem perature down to the tem perature at which the coherence length saturates, one should recover a 3D regime [22]. In Bi-2212, this [Ginzburg-Levanyuk; Law rence-Doniach] tem perature range is estimated to be 50K,  $J_z = 4:1 \text{ m eV}$  [14] the exchange integral along the c-axis. The data where the exponent 1=2 is found is far away from the

critical regime, and thus is the signature of the geometrical disorder intrinsic to the polycrystalline system .

# 4 Conclusion

The m ixed state of high  $T_c$  superconductors still has to reveal m any features and to be understood. E lectrical and transport properties contain the signature of the various vortex phases, and to distinguish them is not so trivial. Here the m agnetic contribution to the m ean free path of heat carriers in a high- $T_c$  superconductor has been extracted in the low eld and in the near  $T_c$  region. It has been found to increase below  $T_c$  as a power law characterized by a 1=2 exponent. This behavior is linked to a percolation process of the electron scattering in the vortex network characterizing the m ixed state. We should emphasize that the above (temperature, eld) conditions are not rather usual ones for probing the m ixed state. If the di usivity was not so hard to m easure, its sensitivity to physical phenom ena would be a bonus for interesting conclusions. Such a rem ark m ay suggest new ways of probing whence understanding the (B;T) phase diagram.
