# D isclination M otion in $H$ exatic and Sm ectic-C $F$ ilm s

#### Abstract

W e present theoretical study of a single disclination $m$ otion in a thin free standing hexatic (or sm ectic-C ) lm, driven by a large-scale inhom ogeneity in the bond (or director) angle. Back- ow $e$ ects and own dynam ics of the bond angle are included. We nd the angle and hydrodynam ic velocity distributions around the m oving disclination, what allow s us to relate the disclination velocity to the angle gradient far from the disclination. D i erent cases are exam ined depending on the ratio of the rotational and shear viscosity coe cients.

## Introduction

Physics of thin liquid-crystalline $\mathrm{m} s$ has been a recurrent hot topic during the past decade because of their intriguing physicalproperties and w ide applications in display devices, sensors, and form any other purposes. H exatic and sm ectic-C liquid crystalline m s , we consider, belong to two-dim ensional system s w ith spontaneously broken continuous sym $m$ etry. Therefore an essential role in the behavior of the $\mathrm{m} s$ is played by vortex-like excitations (disclinations). D efects are alm ost necessarily present in liquid crystals, and their dynam ics plays a crucial role in the overall pattem organization. Early studies of defects focused on classifying the static properties of the defects and their interactions [1, 2]. M ore recently the focus has m oved to exam ining the dynam ics of defects (see, e.g., [3] and references herein). N ote that though in $m$ ost practical applications of liquid crystals, such as traditional display devices, defects destroy an opticaladjustm ent, and therefore are not desirable, there are noveldisplay designs (bistable, m ultidom ain liquid crystalline structures) just exploiting defect properties.

U nfortunately, theoretical researches of dynam ic characteristics of the m s are in a rather prim itive stage, in spite of the fact that experim ental dynam ic studies are likely to be more fruitful. It is largely accounted for by a com plexity of dynam ic phenom ena in the m s , and a complete and unifying description of the problem is still not available. M oreover, som e papers devoted to these problem (dynam ics of defects) claim contradicting results. These contradictions com e m ainly from the fact that di erent authors take into account di erent microscopic dissipation $m$ echanism $s$, but partially the source of controversy is related to sem antics, since di erent de nitions for the forces acting on defects are used (see, e.g., discussion in [4]).

In this paper we exam ine theoretically the disclination dynam ics in free standing hexatic and sm ectic-c ms at scales, $m$ uch larger than their thickness, where the m s can be treated as 2 d ob jects. O ur investigation is devoted to the rst (but com pulsory) step of defect dynam ics studies: a single point disclination in a hexatic or sm ectic-C $\quad \mathrm{m}$. A num ber of theoreticale orts $[5,6,7,8,9]$ dealw th sim ilar problem s. O ur justi cation for adding one m ore paper to the topic is the fact that we did not see in the literature a full investigation of the problem taking into account hydrodynam ic back- ow e ects. Evidently, these e ects can drastically m odify dynam ics of defects. The goal of this work is to study the disclination $m$ otion in free standing liquid crystalline m son the basis ofhydrodynam ic equations, containing som e phenom enological param eters (elasticity m odulus, shear and rotationalviscosity coe cients).

In our approach the disclination is assum ed to be driven by a large-scale inhom ogeneity in the bond or director angle providing a velocity for the disclination $m$ otion (relative to the $l m$ ). A s a physical realization of such non-uniform angle eld, one can have in $m$ ind a system of disclinations distributed $w$ ith a nite density. Then the inhom ogenety near a given disclination is produced by elds of other disclinations. O ne can also think about a pair of disclinations of opposite topological charges, then this inhom ogeneity is related to mutual orientational distortion elds created by each disclination at the point of its counterpart. In fact, the $m$ a jority of experim ental and num erical studies of disclination $m$ otions in liquid crystals and theirm odels $[10,11,12,13,14,15,16,17,18]$ is devoted just to investigation of the dynam ics of tw o oppositely charged defects. W e solve the hydrodynam ic equations and nd bond angle and
ow velocity distributions around the m oving disclination. T he results enable us to relate the disclination velocity and a gradient of the bond angle far from the $m$ oving disclination.

A $n$ obvious ob ject, where our results can be applied, is the $l m$ dynam ics near the B erezinskii-K osterlitz-T houless phase transition. The static properties of the $\mathrm{m} s$ near the transition have been investigated in a huge num ber of
papers starting from the fam ous papers by B erezinskii [19] and K osterlitz and $T$ houless [20]. There is som e literature discussing the theory of dynam ic phenom ena associated w ith vortex-like excitations in condensed matter physics: vortices in type-II superconductors (see, e.g., [21]), vortices in super uid ${ }^{4} \mathrm{H}$ e and ${ }^{3} \mathrm{He}$ (see, e.g., [22, 23]), dislocations in crystals and disclinations (and other topological defects) in liquid crystals (see [10, 11, 12, 13, 14, 24, 25, 26, 27]). $H$ ow ever, $m$ ost of the theoretical works on the topic start from phenom enological equations ofm otion of the defects, and our aim is to derive the equations and to check their validity.

O ur paper has the follow ing structure. Section I contains basic hydrodynam ic equations for liquid crystalline lm s necessary for our investigation. In Section II we nd the bond angle and the ow velocity around the uniform ly $m$ oving disclination in di erent regions, that allow s us to relate the disclination velocity to the angle gradient far from the disclination. D i erent cases, depending on the ratio of the rotationaland shear viscosity coe cients, are exam ined in Section III. The last section IV contains sum $m$ ary and discussion. A ppendix is devoted to details of calculations of the velocity and bond angle elds around the $m$ oving disclination. Those readers who are not very interested in $m$ athem atical derivations can skip this A ppendix nding allessential physical results in the $m$ ain text of the paper.

## I. BASIC RELATIONSFOR HEXATICAND SMECTIC-C FILMS

Let us form ulate basic relations needed to describe disclination motion in thin liquid crystalline lm s. Here we investigate freely suspended $\mathrm{m} s$ on scales, larger than the thickness of the $\mathrm{m}, \mathrm{s}$ where they can be treated as tw o-dim ensional ob jects. Such ob ject can be described in term $s$ of a m acroscopic approach, containing som e phenom enological param eters.

There are di erent types of the m ordering. Experim entally, hexatic and sm ectic- $\mathrm{C} \quad \mathrm{m} \mathrm{s}$ are observed. In these m s , as in 3 d nem atic liquid crystals, the rotational sym m etry is spontaneously broken. The sm ectic-c m s are characterized by the liquid crystalline director which is tilted with respect to the nom al to the $m$, therefore there is a speci c direction along the m . In the hexatic m s m olecules are locally arranged in a triangular lattioe, how ever the lattioe is not an ideal one. T he positional order does not extend over distances larger than a few m olecular size. $N$ evertheless, the bond order extends over $m$ acroscopic distances. Therefore the phase is characterized by the $D 6 \mathrm{~h}$ point group sym $m$ etry. The order param eter for the $s m$ ectic $C \quad \mathrm{~ms}$ is an irreducible tensor $Q$ (the subscripts denoted by $G$ reek letters run two values, since we treat the $\mathrm{m} s \mathrm{~s}$ as $2 \mathrm{~d} \mathrm{obj} j \mathrm{c} t \mathrm{~s}$ ). The hexatic order param eter is an irreducible sym $m$ etric sixth-rank tensor $Q$ [28], both such tensors have two independent com ponents. $N$ ote that the order in the sm ectic-c $\mathrm{m} s$ can be readily observed, by looking for in-plane anisotropies in quantities such as the dielectric perm eability tensor. B ecause of its intrinsic sixfold rotational sym $m$ etry, hexatic orientational order is hardly observable. H ow ever, it can be detected, e.g., as a sixfold pattem of spots in the in-plane m onodom ain X -ray structure factor, proportionalto Q (see, e.g., B] and references herein).

In accordance w th the G oldstone theorem, in the both cases of sm ectics-C and hexatics the only \soft" degree of freedom of the order param eter is relevant on large scales, which is an angle' (like the phase of the order param eter for the super uid ${ }^{4} \mathrm{He}$ ). It is convenient to express a variation of the order param eter in term s of a variation of the angle'. For the sm ectic-C m s the relation is

$w$ here is the two-dim ensional antisym $m$ etric tensor. For the hexatic $\mathrm{m} s$

$w$ here dots represent a sum of allpossible com binations of the sam e structure. Thus for the both $\mathrm{m} s$ sym $m$ etries the order param eter can be characterized by its absolute value $\mathbb{Z}$ jand the phase' which are traditionally represented as a complex quantity (see, e.g., [24]). For the hexatic $\mathrm{m} s$ the quantity is $w$ ritten as = jexp ( $6 i^{\prime}$ ), and for the sm ectic-C m sthe quantity is written as = jexp (2i').

The angle' should be included into the set of the m acroscopic variables of the ms . A convenient starting point of the consideration is the energy density (per unit area) $v^{2}=2+"$, where is the 2 d m ass density, $v$ is the m velocity, and " is the intemal energy density. The latter is a function of the $m$ ass density , the speci centropy , and the angle'. In fact, " depends on $r$ ', since any hom ogeneous shift of the angle ' does not touch the energy. For the hexatic m s, leading term s of the energy expansion over gradients of ${ }^{\prime}$ are

where K is the only (due to hexagonal sym $m$ etry) orientational elastic $m$ odule of the m . For smectic- C lm s one should introduce tw o orientational elastic $m$ odules, longitudinal and transversal $w$ ith respect to the director $n$,
determ ining a speci c direction in the $m: Q / 2 n n . H o w e v e r$, the anisotropy in realsmectic-C $\mathrm{m} s$ is weak because of the sm all tilt angle of the director. M oreover, uctuations of the director lead to a renorm alization of the m odules, and on large scales there occurs an isotropization of a sm ectic-C $m$ [29]. Therefore in this case we can use the sam e expression (1.3) for the elastic energy.

The com plete dynam ic equations for the freely suspended liquid crystalline m s , valid on scales larger than their thickness, can be found in [30]. W e are going to treat a quasistationary m otion ofthe disclination. At such m otionshard degrees of freedom are not excited. By other w ords, we can accept incom pressibility and neglect bending deform ations $w$ hich are suppressed by the presence of the surface tension in freely suspended $\mathrm{m} s$. In the sam e manner, for the quasistationary disclination $m$ otion the them o-di usive $m$ ode is not excited, what im plies the isotherm al condition. For freely suspended $\mathrm{m} s$ such e ects as substrate friction (relevant, say, for Langm uir m s) are absent. Thus at treating the disclination $m$ otion $w e$ can consider the system of equations for the velocity $v$ and the angle' solely. $T$ he equations are form ulated at the conditions $=$ const, $T=$ const ( $w$ here $T$ is tem perature) and $r v=0$.
$T$ he equation for the velocity follow from the $m$ om entum density $j=v$ conservation law

where $T$ is the reactive (non-dissipative) stress tensor and is the 2 d shear viscosity coe cient of the lm . For the tw o-dim ensional hexatics the reactive stress tensor is (see [30], chapter 6)

where \& = " @"=@ is the surface tension. N ote that the ratio $K \quad=^{2}$ is a dim ensionless param eter which can be estim ated by substituting 3d quantities instead of 2 d ones (since all the 2 d quantities can be estim ated as corresponding 3d quantities multiplied by the $m$ thickness, and the latter drops from the ratio). For all known liquid crystals the ratio is $10^{3} 10^{4}$ (see, e.g., [1, 2, 3, 31]), and can be, consequently, treated as a sm all param eter of the theory.
$T$ he second dynam ic equation, the equation for the bond angle, is

where is the so-called 2d rotational viscosity coe cient. W e did not nd in the literature values of the coe cient for thin liquid crystalline m s. Forbulk liquid crystals (see, e.g., $[1,2,3,31$ ) the 3d rotationalviscosity coe cient is usually few tim es larger than the 3d shear viscosity coe cient. Therefore one could expect $>$. How ever, to span a wide range of possibilities below we treat $==$ as an arbitrary param eter.

If disclinations are present in the m , it is no longer possible to de ne a single-valued continuous bond-angle variable'. H ow ever, the order param eter is a w ell-de ned function, which goes to zero at a disclination position. The gradient of $(t ; r)$ is a single-valued function of $r$ which is analytic everyw here exœept for an isolated point which is the position of the disclination. The phase acquires a certain nite increm ent at each tum around the disclination

where the integration contour is a closed loop around the disclination position, going anticlockw ise, and $s$ is a topologicalcharge of the disclination. For hexatic ordering $s=(1=6) n$, and for nem atic orientationalorder $s=(1=2) n$, $w$ here $n$ is an integer num ber. O ne can restrict oneselfto the disclinationsw ith the unitary chargen (i.e. $w$ ith $s=1=6$ for the hexatic $\mathrm{m} \mathrm{s}, \mathrm{s}=1=2$ for the sm ectic-C m s ) only, since disclinations w th larger jंjpossess a larger energy than the set of unitary disclinations w ith the sam e net topological charge, and thus the defects with larger charges are unstable w ith respect to dissociation to unitary ones. Therefore the disclinations $w$ ith the charges jn $j>1$ do not play an essential role in the physics of the $\operatorname{lm} \mathrm{s}[1,2,3,31]$. To bring expressions, given below, into a com pact form, we keep the notation s for the topological charge.

The static bond angle is determ ined by the stationary condition $E={ }^{\prime}=0$, where

There is a sym m etric solution ' ofor an isolated $m$ otionless disclination which satis es Eqs. (1.7,1.8), which has the follow ing gradient

$H$ ere $R$ is a position of the disclination. If the origin of the reference system is placed to this point then one can w rite $\prime_{0}=\operatorname{sarctan}(y=x)$, where $x$ and $y$ are coordinates of the observation point $r$. If som e dynam ic processes in the lm occur, then' varies in tim e and the distribution (1.9) is disturbed. It is perturbed also due to the presence of the bond angle distortion related to boundaries or other disclinations.

Below, we have in $m$ ind a case, when a system of large num ber ofdisclinations (w ith an uncom pensated topological charge) is created. For the 3d nem atics it can be done rather easily [1, 2, 3], since due to the intrinsic elastic anisotropy the energies of positively and negatively charged defects are di erent. W e do not aw are of experim entalor theoretical studies of defect nucleation $m$ echanism $s$ in free standing $s m$ ectic or hexatic $\mathrm{m} s . H$ opefilly, a situation with a nite 2d density of defects can be realized for the $\mathrm{m} s$ as well (for instance, the defects could appear even spontaneously as a m echanism to relieve frustrations in chiral sm ectic or hexatic 1 m s, i.e. analogously to the form ation of the A brikosov vortex lattice in superconductors [32]). E xam ining a m otion of the disclination in this case, we investigate a vicinity of the disclination of the order of the inter-disclination distanc. Then far from the disclination the bond angle' can be written as a sum const+ ur, where $u$ is $m u c h$ larger than the inverse inter-disclination distance (since the num ber of disclinations is large). N ear the disclination position the bond angle' can be approxim ated by the expression (1.9). O ur m ain problem is to establish a general coordinate dependence of ' and v, which, particularly, enables one to relate the bond gradient $u$ and a velocity of the disclination.

## II. FLOW AND ANGLE FIELDAROUNDAUNEORMLYMOVING DSCLINATION

H ere we proceed to the $m$ ain sub ject of our consideration, which is a single disclination, which is driven by a largescale inhom ogenety in the bond angle'. A disclination velocity is determ ined by an interplay of the hydrodynam ic back- ow and by the own dynam ics of the angle'. To nd the velocity, one has to solve the system of equations ( $1.4,1.5,1.6$ ) w ith the constraint (1.7), requiring a suitable asym ptotic behavior. A $s$ we explained in the previous section, at large distances from the disclination, the angle' is supposed to behave as const + ur. In addition, we are going to work in the reference system, where the m as a whole is at rest. That means, that the ow velocity, excited by the disclination, has to tend to zero far from the disclination.

Let us consider a situation, when the disclination $m$ oves $w$ ith a constant velocity V . In the case both the angle ' and the ow velocity are functions of $r \quad V t$ (where $R=V t$ is the disclination position). Then the equation for the velocity (1.4) is w ritten as

W e are looking for a solution, which is characterized by the follow ing asym ptotic behaviour at r! 1 : the velocity $v$ vanishes and $r^{\prime}$ tends to a constant vector $u$. It is clear from the sym $m$ etry of the problem, that the gradient $u$ of the bond angle is directed along the $Y$-axis, provided the velocity is directed along the $X$-axis. Therefore' ! uy at $r$ ! 1 . O ur problem is to nd a relation betw een the quantities $V$ and $u$, that is betw een the disclination velocity and the bond angle gradient far from the disclination. There are two di erent regions: large distances $r u^{1}$ and the region near the disclination $r \quad u^{1}$. At large distances corrections to the leading behavior' uy are sm all and the problem can be treated in the linear over these corrections approxim ation. In the region near the disclination ' is close to the static value (1.9) and the ow velocity v is close to the disclination velocity V (the special case when
the ratio $=$ is extrem ely sm all will be discussed in Subsection IIIC). Those two regions are separately exam ined below. The relation betw een $u$ and $V$ can be found by $m$ atching the asym ptotics at $r \quad u{ }^{1}$. A s a result, one obtains

where $C$ is a dim ensionless factor depending on the dim ensionless ratio $==$. This factor $C$ is of the order of unity if $1 . W$ e are interested in the asym ptotic behavior of $C$ at sm all and large.

## A. Region near the disclination

W e established that is a supenposition of the term $s / r^{+1} \exp (i m) w$ ith determ ined by Eq. (2.13). Then the velocity can be found from Eq. (2.10). To avoid a singularity in the velocity at sm all r, one should keep contributions w ith positive only. By other words, one can say, that the velocity eld contains contributions w ith all pow ens (2.13) but the factors at the term $s w$ ith negative are form ed at $r$ a (where $a$ is the disclination core radius), and therefore the corresponding contributions to the velocity are negligible at $r$ a (this statem ent should be clari ed and re ned for sm all negative exponents 1 in the lim it ofsm all, see below, Subsection IIIC). W e conclude, that the correction to $V$ in the ow velocity $v$, related to in Eq. (2.10), is negligible at $r$ a. Thus we com e to the non-slipping condition for the disclination $m$ otion: the disclination velocity $V$ coincides $w$ th the ow velocity $v$ at the disclination position.
$N$ ext, to nd ${ }^{\prime}$, one should solve the equation $(K=) r^{2 \prime}=$, where is determ ined from Eq. (2.9). Then, besides the part determ ined by the velocity, zero m odes of the Laplacian could enter ${ }^{\prime}{ }_{1}$. The m ost dangerous zero m ode is $U \mathrm{y}$, since it produces a non-zero m om entum $u x$ (and associated to it the $M$ agnus force)

to the disclination core. H ow ever, because of the condition $\leqslant 0$, all the contributions to the velocity correspond to zero viscous $m$ om entum ux to the origin. C onsequently, it is im possible to com pensate the $M$ agnus force by other tem s . $T$ he above reasoning leads us to the conclusion that the factor $U$ (and therefore the $M$ agnus force) $m$ ust be zero. Thus, ' ${ }_{1}$ contains only tem $s$, proportional to $r^{+1}$, with $>0$. This conclusion is related to the fact that for free standing liquid crystalline lm s any distortion of the bond angle unavoidably produces hydrodynam ic back-
ow motions (ie. $v \in 0$ ). Unlike free standing $\mathrm{m}, \mathrm{s}$, for the liquid crystalline m s on substrates (Langm uir m s) hydrodynam ic motions (back- ow s) are strongly suppressed by the substrate, and a situation when the back- ow is irrelevant for the disclination m otion could be realized.

Then using the procedure of A ppendix A 1, one can prove that the solutions from two regions can be matched at $r u^{1}$, and thus there are no new characteristic scales, indeed. We also note that the rotational viscosity is excluded from the hydrodynam ic equations at large. A though this is not true inside the disclination core provided that one can em ploy hydrodynam ics there (see A ppendix A 4), boundary conditions for v and' on the core reveal no dram atic behavior. This investigation can be based on the equations, form ulated in Subsection IIB, which are correct irrespective to the value of pr.

Explicit expressions, describing the velocity and the angle, are presented in Appendix A 1. They contain three dim ensionless functions $1(r=u)$, $c_{1}(r=u)$ and $c_{2}(r=u)$. Really, at ur 1 one can keep only zero term $s$ of the expansions of these functions into the Taylor series. Am ong these three coe cients only one is independent, see Eq. (A 10). Therefore the general solution could be expressed with a single free param eter, $\quad 1$ (0). The procedure corresponds to the follow ing construction of solutions of the equations of $m$ otion (2.15) in the region ur 1 . W e have to $m$ atch the solutions in the outer (far from the disclination) and in the inner (close to the disclination) regions at ur' 1. Technically the $m$ atching is equivalent to the appropriate boundary conditions for the outer problem at ur' 1, and these boundary conditions can be replaced form ally by the local source term $s$ in the equations, acting at ur' 1. O ne can expand these sources in the standard multipolar series. Thus we com e to the expansion over the gradients of -function. $T$ he expressions found in this subsection generalize the fam ous Lamb solution for the hydrodynam ic ow around a hard cylinder, (see, e.g., $33,34,35]$ ) where far from the cylinder the velocity eld is exponentially sm all everyw here except in the wake of the conps, i.e. in the very narrow angular sector ( $\backslash$ tail") . D isclination $m$ otion in liquid crystalline
$\mathrm{m} s$ can be regarded as m otion of a cylinder fram ed by a \soft" (i.e. deform able) orientational eld '. Due to the additional (w th respect to the classical Lamb problem) degree of freedom, our solution has two tails around the $m$ oving disclination: wake, beyond the disclination, and precursor in front of it. In fact, both degrees of freedom (the ow velocity and the bond angle) are relevant.

N$ ote also that, really, there is no crossover at $r u^{1}$ in the bond angle behavior in this situation.

what is a generalization of the StokesLambsolution [33,34]. H ow ever unlike the Lamb problem (a hard cylinder $m$ oving in a viscous liquid), in our case fv $v(r=a) j v$, i.e. we have a slipping on the core of the $m$ oving disclination. This slipping seem s natural in the lim it of extrem ely sm all values of , corresponding to the lim it
! 1 , that is to a strongly suppressed hydrodynam ic ow. P hysically, the property $m$ eans that the disclination can not be understood as a hard im penetrable ob ject in the case. It is worth noting also that found above logarithm ic behavior looks sim ilar as a general feature of the two-dim ensional hydrodynam ic $m$ otion, which com es from the well known fact (see e.g., [33,34,35]) that for two-dim ensional lam inar ow even for a sm all Reynolds num ber one cannot neglect nonlinear term $s$, which becom e relevant for large enough distances. H ow ever, in our case these non-linear term $s$ do not com e from the convective hydrodynam ic nonlinearity, they com efrom the nonlinear over' term $s$ in the stress tensor (1.4).

An explicit expression for' and its asym ptotics, corresponding to the considered case, are found in A ppendix A 2. An expression for the ow velocity eld, excited by the disclination m otion, is derived in A ppendix A 3.

## IV . CONCLUSION

Let us sum up the results of our paper. To understand physics, underlying the freely suspended m dynam ics, we studied the ground case, nam ely, a single disclination $m$ otion in a thin hexatic (or smectic-c) lm , driven by a inhom ogeneity in the bond (or director) angle. W e investigated the uniform m otion (i.e. one with a constant velocity). For this case we derived and solved equations ofm otion and found bond angle and hydrodynam ic velocity distributions around the disclination. It allow sus to relate the velocity of the disclination $V$ to the bond angle gradient $u=j r$ ' $j$ in the region far from the disclination. It is in fact the reason, why so $m$ uch e orts are needed: the fiull set of the equations should be solved everyw here, not locally only. W e established the proportionality coe cient $C$ (see Eq. (2.4)) in this non-local relationship which has a meaning of the e ective mobility coe cient. The coe cient C depends on the dim ension less ratio of rotational and shear viscosity coe cients.
$T$ here is little experim ental know ledge as far as the values of the coe cients and in hexatic and sm ectic-C ms are concemed. It is believed generally that the corresponding values in a $m$ (norm alized by its thickness) and in a bulk $m$ aterial are not very di erent $[3,31]$, and in this case we are in the regim e of $\quad 1$, when the coe cient $C$ is of the order of unity. H ow ever 1 case is not excluded from the both theoretical and $m$ aterial science points of view. We found for sm all 1 case the coe cient $C \quad 1=$-. We established a highly non-trivialbehaviour of the ow velocity and of the bond angle, which is power-like in $r$ near the disclination and extrem ely anisotropic far from it. A nd only for the case of extrem ely $s m$ all $\quad 1=\ln ^{2}$ (ua) (where $a$ is the disclination core radius), we found a
logarithm ic behavior C [ $\ln (u a)]^{1}$. Them ain $m$ essage of our study is that the hydrodynam ic $m$ otion (that is the back- ow ), unavoidably accom panying any defect $m$ otion in liquid crystals, plays a signi cant role in the disclination m obility. E xperim entalevidence (see, e.g., the recent publication [36]) show s that it is indeed the case.

O ur consideration can be applied to the $m$ otion of a disclination pair $w$ ith opposite signs. In this case the role by the scale $u^{1}$ is played by the distance $R$ betw een the disclinations. Then we nd in accordance w ith Eq. (2.4) that $@_{t} R / R^{1}$ w thout a logarithm (provided the tw ist viscosity coe cient is not anom alously sm all, see Subsection IIIC for the quantitative criterion). This conchision is con m ed by results of num erical sim ulations for 2d nem atics $[15,16,17,18]$. The authors of the w orks consider the equations of m otion in term $s$ of the tensor order param eter, consistently taking into account the coupling between the disclination $m$ otion and the hydrodynam ic ow. They com puted dynam ics of the disclination pair annihilation and found that the distance $R$ betw een the disclinations scales w th tim e $t$ as $t^{1=2}$, w thout logarithm ic corrections (as it follow $s$ from our theoretical consideration for any (excepting extrem ely sm all) value of the param eter. U nfortunately we did not nd in the publications $[16,17,18]$ the $m$ agnitudes of the the shear viscosity which was used in the sim ulations. Lacking su cient data on the values of
and we can at present discuss only the general features of the disclination dynam ics. For instance the authors [18] found num erically in one-constant approxim ation the asym $m$ etry of the disclination dynam ics $w$ ith respect to the sign of the topologicalcharge ( $s=1=2$ ). In our approach the asym $m$ etry naturally appears from nonlinear term $s$ in the stress tensor (1.5) and from the rst term in the right-hand side ofEq. (1.6) responsible for the di erent coupling of orientational and hydrodynam ic ow pattems for positive and negative disclinations. This results in the fact that sm aller positive exponents in Eq. (2.13) (corresponding to the $m$ inus in the brackets) for each $m$ are larger if $s=1=2$ than those for $s=1=2$. Thus, the disclination $w$ ith $s=1=2$ exerts a stronger in uence on the ow velocity, the qualitative conclusion that was arrived in [18].

A though the theory, presented in the paper, is valid for free standing hexatic or sm ectic-C liquid crystalline lm s , the generalschem e can be applied to Langm uir m s , that is for the liquid crystalline m s on solid or liquid substrates. Since the Langm uir $m$ is arranged on the substrate surface, then any its hydrodynam ic $m$ otion is accom panied by the substrate $m$ otion. T herefore for solid substrates a situation, when the hydrodynam ic back- ow is irrelevant for the disclination dynam ics, could be realistic. In Subsection IIIC (see also Appendix A 2) we exam ine this lim it, and reproduce the results of the works $[6,7,8,9]$, where the hydrodynam ic back- ow was neglected from the very beginning. As it concems to the Langm uir $\mathrm{m} s$ on a liquid substrate, this case requires a special investigation, how ever the approach and $m$ ain ideas of our paper could be useful as well.

O ur results can be tested directly by com paring with experim ental data for sm ectic-C m s . The hexatic order param eter, which has sixfold localsym $m$ etry is not coupled to the light in any sim ple way (and therefore idealhexatic disclinations are hardly observed in optics). H ow ever it is possible to observe the core splitting of the disclinations in tilted hexatic $s m$ ectic m s [26]. Indeed, due to discontinuity the tilt direction (w hich is locked to the bond direction) one can observe hexatic order and hexatic disclinations indirectly. The second possibility of checking our theoretical results is the classical light-scattering (where in typical experim ents wave vectors are $q=10^{2} \quad 10^{4} \mathrm{~cm}{ }^{1}$, and the frequency is! $<10^{8} \mathrm{~s}^{1}$ ). For a reasonably thick m the pow er spectrum of light scattering can have som e additional structure that reveals the disclination properties (e.g. defects are thought to be relevant to the very low-frequency noise observed in thin m s). Such kind of experim ental studies are highly desirable.

## APPEND IX A

H ere we present som e technical details, conceming the velocity and the bond angle elds around the disclination. $T$ he case of sm all is $m$ ostly treated, which is especially rich from the point of view of the space structure of the elds.

## 1. D istances far from the disclination

H ere we derive som e results for the far from the disclination region which are afterw ards applied to the case of sm all considered in Subsection IIIB.

Let us exam ine the harm onic function in Eqs. (2.16). Since the function is analytic in the region $r>u^{1}$, it can be expanded over derivatives of $\ln r$ there. $N$ ext, due to the sym $m$ etry of the problem, should be antisym $m$ etric in $y$.
