Optical conductivity of one-dim ensional narrow -gap sem iconductors

The optical conductivities of two one-dimensional narrow-gap sem iconductors, anticrossing quantum H alledge states and carbon nanotubes, are studied using bosonization method. A lowest order renorm alization group analysis indicates that the bare band gap can be treated perturbatively at high frequency/tem perature. At very low energy scale the optical conductivity is dominated by the excitonic contribution, while at tem perature higher than a crossover tem perature the excitonic features are elim inated by therm all uctuations. In case of carbon nanotubes the crossover tem perature scale is estimated to be 300 K.

I. IN TRODUCTION

O ne-dimensional (1D) narrow-gap sem iconductors can be realized in anti-crossing quantum Hall edge states $(AQHE)^1$ and carbon nanotubes $(CNT)^2$. The gaps in these system s are single particle gaps and not m any body gaps. Theoretically, they provide the unusual condition that the bare band gap t is m uch sm aller than the characteristic C oulom b energy scale E_c . Moreover, strong quantum uctuations are present in these systems, reecting the 1D character.

In understanding the excitation spectra of sem iconductors and insulators, the excitons which are the bound state of electron and hole play very in portant roles. In three dimensional sem iconductors excitons can be treated successfully by solving the Bethe-Salpeter equation³. However, in the strong coupling regine of 1D systems, the perturbative approaches are not expected to be reliable due to large quantum uctuations. If the C oulom b scale is much larger than the gap one m ight naively expect that exciton instability⁴ would occur. However, this sim ple picture neglects screening which is expected to be large due to the smallness of the gap. It is unclear whether a bound state of an "electron" and a "hole" can exist in the presence of strong quantum uctuations.

B osonization provides a natural fram ework for studying 1D narrow gap sem iconductors. B osonization m ethod allows the (alm ost) exact treatment of strong C oulom b interaction, and it also transforms the bare band gap term into the non-linear cosine potentials leading to a non-integrable sine-G ordon (sG) type m odel.⁵ It was argued that under certain conditions the excitons can exist even for the C oulom b interaction much larger than the bare gap, being accompanied by the enhanced single particle gap.⁵

In this paper we study the optical conductivities of AQHE^{1,5} and CNT in semiconducting phase, assum ing the absence of exciton instability. A simple low est order renorm alization group analysis shows that the cosine term [bare band gap] can be treated perturbatively at high frequency/tem perature. At low frequency/tem peterature the excitonic contributions dom inate the optical conductivity. The optical conductivity depends on the tem perature strongly. Especially at tem - perature higher than a crossover temperature scale $T_{\rm CT}$ all of the exciton features are completely eliminated by therm all uctuations. The crossover temperature scale is estimated to be about 300 K for CNT.

In connection with the present work we note the studies on the optical conductivities of M ott insulators.^{6,7} In those studies the M ott insulator problem is mapped to the exactly solvable sG model, and the optical conductivity is calculated using the form -factor approach based on the integrability and the perturbation with respect to the conformal eld theory. In particular, the behaviours near two-particle production threshold have been determ ined exactly. Even if the physical origin of the M ott gap is very di erent from our band gap, the optical conductivities sharem any sim ilar features, especially in high frequency region.

This paper is organized as follows: In Sec. II we introduce the models. In Sec. III we set up the form alisms for the computation of optical conductivity. In Sec. IV and V, the results for the optical conductivities of AQHE and CNT are presented, respectively. We close this paper in Sec. VI with sum mary.

II. M ODELS

First consider the spinless ferm ion case realized in the spin-polarized AQHE 1,5 The system is modeled by the following Ham iltonian

where $(x) = {}_{R}(x) + {}_{L}(y)$. The operator ${}_{R}(L)$ is the right-moving (left-moving) edge electron operator. ${}_{R} = {}_{R} {}_{R} {}_{R}$ is the (norm al-ordered) right-moving

edge electron density operator ($_{\rm L}$ is similarly de ned). V (x) = $\frac{e^2}{P} \frac{1}{x^2 + a^2}$ is the C oulom b interaction. a is taken be the shortest length scale of our problem . The C oulom b m atrix element is V (k) = $\frac{2e^2}{K_0} \left(a \frac{k}{2} \right) \frac{2e^2}{k_{\rm B}} \ln \frac{1}{k_{\rm B}}$. The tunneling between the right-m oving and left-m oving electrons is m odeled by H_t. Note that a single particle gap opens up near the Ferm i points due to this tunneling term , and this provides the bare band gap.

The interacting electron systems can be bosonized in a standard way.^{8,9,10} The phase elds are de ned by

The above action looks very similar to the sG model, except for the momentum -dependent C oulom b interaction V (k). If V (k) were momentum independent (local interaction in real space), the action would be exactly that of sG model.

Second we consider a model for the CNT in semiconducting phase. For CNT it is necessary to introduces two bands¹¹. Including also spin degrees of freedom we need four species of fermions $_{R=L;i=1;2; = ";#}$, and equivalently four species of boson phase elds $_{i=1;2; = ";#}$; $_{i=1;2; = ";#}$. It is convenient to introduce the charge/spin bosons

N ote that the C oulom b interaction acts only on the total charge sector (+). The bare band gap term S_t of the action Eq. (10) in plicitly assumes that the bosons $_i$ to be expressed in term s of charge/spin bosons .

III. OPTICAL CONDUCTIVITY : FORMALISM

The real part of the optical conductivity (!;T) can be computed from the K ubo form ula.

where the superscript R denotes the retarded G reen function and L is the system size. Practically it is convenient to compute the correlation function $^{\rm R}$ in imaginary time, and then analytically continue into the real time. The current operator for the action Eq. (4) of AQHE in imaginary time is given by $J = \frac{1}{2}$ (0). The correlation function in imaginary time can be expressed as

Let us rst compute the optical conductivity of Eq. (4) with vanishing bare band gap $[H_t = 0]$.

which corresponds to the ideal conductivity.⁹ The im purity pinning e ect would broaden the above delta function peak.

To assess the importance of the band gap term H $_{\rm t}$ in perturbation theory it is useful to investigate the renormalization group (R G.) ow of the coe cient of H $_{\rm t}$,

where $h_{\rm f}$ denotes the average over the fast degrees of freedom. The average of $_{\rm f}$ requires the speci cation of the momentum -energy range. We choose to integrate over the whole frequency and reduce the momentum cut-

Taking 1 to be the bare momentum cut-o , we can set 1a = 1. Clearly the R.G. ow Eq. (17) tells us that the coupling constant becomes larger as the cut-o decreases, and that eventually below a certain energy/momentum scale the perturbative expansion in fails. The above crossover energy scale $!_{CT}$ coincides with the soliton mass estimated by completely di erent argument.⁵

At energy scale below ! cr the cosine band gap term cannot be treated perturbatively anym ore. But at suf-

ciently low energy most of the excitations would occur near the bottom of cosine potential, and then we can expand the cosine term in power series. This expansion can be shown to be valid by rescaling the boson eld in the lim it of strong C oulom b interaction.⁵

(19) describes the exciton degrees of freedom, and the exciton dispersion relation is determ ined by the quadratic part of Eq. (19).⁵

where $S_{quartic}$ is the quartic term s in 4 boson elds. Since we are not interested in the explicit calculations of quantum corrections due to $S_{quartic}$ its detailed form is not displayed.

IV. THE OPTICAL CONDUCTIVITY OF ANTICROSSING QUANTUM HALLEDGE STATES

In this section we calculate the optical conductivity based on the action Eq. (4).

A. $T < T_{CT}$

For simplicity, consider T = 0 case. When ! !cr the cosine band gap term can be treated perturbatively as discussed in Sec. III. The "self-energy" M (i!;q) is given by

Notice that $e^{\frac{4}{2} \int \ln 1 = !^2}$ decreases slower than any other power law dependence. This is a characteristic of long range C oulom b interaction, and it has been studied by H. Schulz.¹³ The result Eq. (32) should be compared with the optical conductivity of M ott insulators.⁶

where M soliton is the soliton m ass of sG m odel which is speci ed by $S_{sG} = d^2x \frac{1}{16} (0)^2 + 2 \cos()$. Formally, our result Eq. (32) corresponds to the limit ! 0, namely deep in the sem iclassical limit. For the acutal comparison with the experimental data we might need the RG. improved perturbation theory¹⁴ as has been done in the M ott insulator case.⁶ That im – plies that the coupling constant becomes running coupling constant (!), and Eq. (32) can be re-expressed as (!;T = 0) $\frac{2}{1}$ (!) should be determined by solving the higher order RG. equations. In the lowest order RG. the result Eq. (32) is reproduced.

In the opposite case ! $!_{CT}$, the cosine term can be expanded into power series and the excitonic contribution will dom inate the optical conductivity. Calculating the optical conductivity using the expanded action Eq. (19) and neglecting the quantum correction due to the quartic term ⁴ we obtain

The quantum corrections due to the quartic term which introduce frequency dependent self-energy would broaden the sharp peak feature of Eq. (34).

The calculation of optical conductivity near ! !cr requires a non-perturbative treatment which is not available in our problem. But we can expect a peak at

 corresponding to the renorm alized particle-hole (soliton-antisoliton) production.⁶ In analogy with the result obtained from sG case away from the Luther-Emery point ($^2 = 1=2$), the square root singularity is not expected near the two particle threshold in our case since form ally our results in ply $! 0$ as discussed above.⁶

At high frequency we can use the optical conductivity obtained for T = 0 case.

In the high temperature regime there are no exciton peaks and the features of multi-particle productions. They are eliminated by thermal uctuations.

V. THE OPTICAL CONDUCTIVITY OF SEM ICONDUCTING CNT

In this section we calculate the optical conductivity based on the action Eq. (10). The calculations are essentially identical with those of AQHE.

The optical conductivity at low frequency is dominated by the excitonic contribution. U sing the action Eq. (30)the excitonic contribution can be calculated easily.

As in the case of AQHE the excitonic contributions and the features of multi-particle production are eliminated by thermal uctuations.

The crossover tem perature scale of the sem iconducting CNT can be estimated as follows: the sem iconducting gap t is the order of 10m ev, and the C oulom b energy scale can be taken to be 1 2eV^2 . Then, using the expression for the crossover energy scale Eq. (29) we get

Therefore, a drastic change of optical spectra of sem iconducting CNT is expected around room tem perature. The experim ental veri cation of the above change of optical conductivity would be most interesting.

VI. SUMMARY

The optical conductivities of two kinds of 1D narrow – gap sem iconductors, anticrossing quantum Hall edges and sem iconducting carbon nanotubes, are studied using bosonization method. A lowest order R G. calculation indicates that the tunneling term which gives rise to the bare band gap can be treated perturbatively for frequency/tem perature higher than a crossover scale. The crossover scale can be identi ed with the soliton m ass of the associated sine-G ordon m odel. Below the crossover energy scale the optical conductivity is dom inated by excitonic contribution characterized by a sharp peak. In particular, for the tem perature much higher than the

crossover scale, the optical conductivity can be determined over the whole frequency range by perturbative method. The excitonic features are found to be eliminated by thermal uctuations in the high temperature regime. The crossover temperature scale of the sem iconducting CNT is estimated to be around 300 K.
