Transition to spatially periodic patterns in nem atics under oscillatory shear ow: linear analysis

We consider the orientational instabilities, both hom ogeneous and spatially periodic, developing in a nem atic liquid crystal under rectilinear oscillatory Couette ow for director alignment perpendicular to the ow plane. Using numerical and analytical approaches we determ ine the critical amplitude of oscillatory ow instabilities, the critical wave number and the symmetry of the destabilizing mode. It was found, that by varying of the oscillatory ow frequency the instability changes its temporal symmetry. The mechanism of this transition is coupled with the inertia of the nematic uid. We also shown that an electriceld applied to the nematic layer can induce switching between instabilities with dierent spatial and temporal symmetries. The complete phase diagram of the ow instabilities is presented.

I. IN TRODUCTION

Nem atic liquid crystals (nem atics) represent one of the simplest anisotropic uid [1]. In order to describe the m acroscopic dynamics of these materials made up from elongated molecules one introduces as additional hydrodynamic variable a unit vector n, the director, which describes the axis of local pre-ered molecular orientation. The strong coupling between the director and velocity eld provides a number of interesting phenomena in nematics under ow of di erent types, such as pattern form ation [2,3], director tum bling [4], autowaves [3] etc.. The ow behavior of a nem atic strongly depends on the geometry and material parameters, in particular the viscosity coecients $_1::::_6$ known as Leslie coe cients. Two of these coe cients, 2 and 3, appear in the director equation and play an particular role in hydrodynam ic instabilities. $_2$ is supposed to be negative for m aterials m ade of rod-like m olecules, w hereas the sign of 2 is not restricted. If the nem atic is initially oriented within the ow plane (= x; z plane) then, in materials with $_3$ < 0 under steady ow (plane C ouette or P oiseuille type) the director tends to a liquat an angle $_{\rm fl}$ = tan $_{\rm fl}$ to the ow direction in the ow plane (= x direction), which corresponds to stationary hom ogeneous solution of the nem atodynam ic equations [5]. Such nem atics are called ow-aligning. The solution flwith appropriate sign of the square root was shown to be linearly stable in the case of steady ows [5{7]. In oscillatory ows the director tends f1. With a nonlinear velocity pro le, as in Poiseuille ow, this solution can lose stability [8,9]. to oscillate between In the case $_3 > 0$ under steady ow one has tumbling with a director proled depending strongly on the shear rate [4]. Nem atics with $_3 > 0$ are called non-ow-aligning. The picture of orientational transitions becomes even richer if the director is initially oriented perpendicular to the ow plane (y direction). This orientation corresponds, for sym m etry reasons, to a stationary hom ogeneous solution of dynam ic equations of nem atics. W ith appropriate surface alignment it can lose stability at a certain magnitude of the shear rate via a stationary bifurcation [10,11]. In the absence of external elds in steady Couette as well as Poiseuille ows the director pro lethen deforms hom ogeneously in space. In steady Couette ow a magnetic eld applied along the initial director orientation changes the type of instability from homogeneous to spatially periodic at a critical eld strength [10]. In Poiseuille ow the magnetic eld does not a ect the type of instability [11], but rolls can be observed above a secondary instability [11]. C lassical experiments of Pieranski and Guyon (PG) on oscillatory Couette ow [10] and recent experiments [12,13] show the appearance of a roll instability with the critical shear rate depending on ow frequency. It was shown by PG, that the tem poral symmetry of the instability is in uenced by an applied electriceld [10]. A theoretical treatment of the problem [10,14,15,2] gives the mechanisms of the instability and is in a good agreement with experimental results, including the change in symmetry. For oscillatory Poiseuille ow the situation is similar [16{18}]. In all the theoretical treatm ents [10,14{16,18] the inertia of the uid is neglected, which is reasonable for the low frequencies used. In the absence of an electric eld one then has no changes in the stability scenario as a function of the ow frequency.

In the present work we investigate num erically as well as analytically orientational instabilities, both hom ogeneous and spatially periodic, induced by plane, oscillatory Couette ow in nematics in the geometry with the director

pre-aligned perpendicular to the ow plane in a wide range of the ow frequencies. We look for hom ogeneous and spatially periodic instabilities and study the in uence of an electric eld on ow instabilities for both, negative and positive, dielectric anisotropy of nem atic. Recent experiments [12,13] show that high-frequency range could also be investigated experimentally as well.

II.GOVERNING EQUATIONS AND SYMMETRY

Let us consider a nem atic layer—lling the space—d=2 < z < d=2 bounded by in nite parallel plates, one of which (upper) oscillating harm onically along x with amplitude A and circular frequency !=2 f. The director is oriented (rigidly anchored) at the boundaries along y, i.e., perpendicular to the owplane. An electric eld of strength E can be applied along z.

Before any instability develops (su ciently small amplitude A) the director remains undistorted and the nematic behaves like an isotropic uid with viscosity $_3 = _4 = 2$. For further consideration let us introduce the dimensionless variables

Below it will be shown that for the stability problem the inertia of uid in the basic velocity eld can be neglected, so that the solution of (1) is $\sin p \ln v_x^0 = a (z + 1 = 2) \cos t$. In order to investigate the stability of (2) we linearize the nem atodynam ic equations [5] around this state

where the perturbations $n_i = n_i (y;z;t); v_i = v_i (y;z;t)$, fi = x;y;zg are small. Here we neglect the x dependence of perturbations assuming the wave vector of instability if not zero is perpendicular to the shear direction.

III. STABILITY ANALYSIS

A . G eneral form ulation

Let us collect all perturbations in the vector $Y = (v_x; v_z; n_x; n_z)^T$. From the F loquet theorem one can write the model solutions of (3-6) in the form

where is the growth rate, q is a wave number of instability. Instead of solving the Floquet problem (8) directly we will employ a Galerkin expansion [19]:

where c_{nk} are constant coe cients and $_n$ (z) is a set of trial functions, which satisfy boundary conditions (7), Chebyshev functions [20]

for v_z . Here m and m are the roots of the appropriate characteristic equations [21].

Due to the structure of Eqs.(3-6) the model solutions (8)-(9) have the denite parity in z and t (parity of Fourier modes). Thus, the symmetry types are divided into four groups (Table I). The z-parity of v_y is opposite to that of v_z whereas the t-parity is the same. Type I corresponds to the Y-symmetry and type II to the Z-symmetry in the notations of PG [10]. Type I and III suppose that v_z can have nonzero time averaged and rolls in this case are overturning, i.e. they rotate steadily. Rolls of II and IV type are oscillating.

Substituting (8)-(9) into (3-6) and projecting [19] onto the Galerkin modes one obtains a linear algebraic system for the expansion coe cients c_{nk} of the form

The expansions (8)-(9) are then truncated and the eigenvalue problem (12) can be solved. The condition < [(a;q)] = 0 for the largest sigm a yields the neutral curve a_0 (q). If one assumes a stationary bifurcation, i.e. = () = 0 at the threshold, then one has to solve the eigenvalue problem

which is much more convenient. The critical value a_c is given by $a_c = m \, \text{in}_q \, a_0$ (q), which also yields the critical wave number q_c . Using (12) we have checked that the rst bifurcation is really always stationary [22].

B.Results without electric eld

The calculations were done for material MBBA, see App. C for material parameters.

For ! $_{\rm d}$ 35 the rst instability developing in the absence of external elds is a hom ogeneous one (q. = 0) [10]. This could be expected already from the fact that in steady shear ow the hom ogeneous instability occurs rst [10]. At ! $_{\rm d}$ 35 PG have observed the transition to rolls of type I. Up to now the frequency region ! $_{\rm d}$ > 35 remains experimentally poorly investigated. Our analysis for ! $_{\rm d}$ 35 shows that roll instability of type I persists up to ! $_{\rm d}$ 4:1 10 where a transition to the rolls of II-type takes place (Fig.1). At the transition point the wave number jumps from 12 to 12. We have checked numerically that the appearance of this transition is related to the inertia of the nematic described by the parameter $_{\rm v}$. By neglecting the inertia term in the Navier-Stokes Eqs. (3-4), i.e. for $_{\rm v}$! 0, no such transition was found. Numerical analysis also shows that thresholds for instabilities of III and IV types are higher for all frequencies investigated.

In order to understand the mechanism leading to this transition let us analyze Eqs.(3)-(6). By acting with ℓ_y on Eq. (3) and with ℓ_{yy} ℓ_z on (4) one may eliminate the velocities. In the remaining equations for n_x and n_z we use a one-mode spatial approximation

appropriate for the symmetry of type I or II. Projecting the equations one obtains coupled second order ODEs for f(t) and g(t). Further simplications can be made by neglecting the terms proportional to P and $_{\rm v}$ ³. One then arrives at

that corresponds to the separation of the functions f and g into the stationary (index st) and oscillatory (osc) parts. Substituting (16) into (14)-(15) and using time averaging procedure one obtains the critical amplitudes for roll instabilities of I and II type

Let us analyze the form ulas (17). From (A1) one has that l_2 (q) is positive for large q (> 2) and very small q (1). Taking into account that l_1 (q) is positive for all q and the expression $[m_1m_2 + m_3(v_d)^{-1}]$ remains positive up to very large value of l_2 (10) one sees from rst Eq. (17) that in order to have a threshold l_2 has to be positive. Thus, only large q (rolls) and hom ogeneous instabilities can develop with symmetry of I type. In the second Eq.(17) the expression $[m_2l_1 - m_3(v_d)^{-1}]$ in the denominator changes sign with increasing frequency from positive to negative at the frequency given by

A lower lim it of the transition frequency is given by setting q=0 in (18). Below $(!_d)_{tr}$ one has $[n_2l_l] m_3(v_d)^{-1}] > 0$. The results for the approximate expressions (17) are included in Fig.1. The formulas (17) have an error of about 30% at small! $_{\rm d}$, which grows further with! $_{\rm d}$. This is an obvious consequence of the one-mode approximation. Nevertheless, the analytic expressions show all the important features of the numerically calculated thresholds, including the switching between the modes of I and II types. However, one should note that the frequency dependence of the critical wave number q_c in the one-mode approximation does for I type rolls not show the saturation like in the numerical calculations.

Since $_{\rm d}$ 1 for ! $_{\rm d}$ 1 one can see that $a_{\rm c}^{\rm II}$ is inversely proportional to ! $_{\rm d}$.

By increasing! $_{\rm d}$ the critical amplitude $a_{\rm c}$ (! $_{\rm d}$) of mode I appears to tend to a constant value already at rather low! $_{\rm d}$, where $_{\rm v}$ 1. Such behavior was found in [24] by an one-mode analysis. One can show that this feature is not a artefact of the one-time-mode approximation. The same result can be obtained by inspection of the high-frequency limit in (14)-(15) (see Appendix B).

Sum m arizing, we conclude from our analysis that increasing of the oscillatory ow frequency (for given cell thickness d) leads to switching from I to II sym m etry type roll instability. It has been shown that this transition is caused by the inertia of the nem atic uid described by the parameter $_{\rm v}^{-1}$. For MBBA m aterial parameters one has the transition at ! d 4:1 10 C onsequently, in the PG experiment [10] with the same liquid crystal and d = 240 m the transition frequency should occur of about 7 Hz (m axim al frequency in this experiment was 2 Hz). Recent experiments [12], [13] show that this transition could be observed.

${\tt C}$. ${\tt C}$ om parison with experiments

Experim ents of Mullin and Peacock (MP) [12] performed with the nematic E7 show the existence of a roll instability at least up to 160 Hz with d between 20 and 50 m. MP report, that the observation of probe particle have not shown any macroscopic ow, which could mean that the rolls are of Π , i.e., the oscillating type. We have found in the literature only the values of the elastic constants for E7 [23], so that we are not able to perform a direct comparison of our theoretical results with the MP experimental data. One can consider the in uence of material parameters variation on the instability type. The results of this consideration are presented in table Π . A good test for the quality of oscillatory C ouette ow realized in experiments is scaling law, which says, that A = d = F (! $\frac{2}{d}$), where F is some function to be determined from nematodynamic equations. The experimental data of MP [12] satisfy this test only in a rather narrow region of low frequencies, namely, up to about 40 Hz. At higher frequencies the scaling law becomes broken, which could be caused by failure of surface anchoring.




FIG.1. Critical amplitude a_c vs. ! $_d$ for MBBA. Solid lines are numerical calculations, dashed lines are approximations (17), points are experimental data from [13]. RI denotes roll instability, HI is homogeneous instability, Roman numbers denote the group of symmetry from table I.

O scillatory shear ow was investigated experimentally also by Anikeev and Kapustina [13]. The authors used an eutectic mixture of MBBA and EBBA, which is known to have almost the same material parameters as MBBA. A geometry where the director is anchored in the plane of the layer at an angle—to the shear direction was investigated. For the case $= 90^{\circ}$, which we are interested in, the frequency dependence of a_c and q_c are presented. The experimental points taken from [13] are given in Fig.1 together with theoretical curves. The agreement between experimental and theoretical data is good.

D . In uence of electric eld on the instability type and sym m etry





FIG.2. Phase diagram of instabilities induced by oscillatory shear ow and a ected by electric eld a nem atic with negative dielectric anisotropy. RI denotes roll instability, HI is hom ogeneous instability, Rom an numbers denote the group of symmetry from table I.

Applying an electric eld across the nem atic layer can lead to the switching in particular between the dierent types of temporal symmetry of rolls induced by oscillatory shear ow. In the case of MBBA a change of the roll instability

of I type to II type by increasing the electric eld strength was observed [10]. We performed the stability analysis of the linearized equations (3)-(6) in a wide range of oscillatory ow frequency and electric eld strength for MBBA, which has a negative anisotropy of the dielectric permeativity. We have found that the electric eld can change not only the temporal symmetry of instability, but also the spatial one. The phase diagram (Fig. 2) presents the area, where the rolls with symmetry type III appear at threshold. A coording to their spatial symmetry these rolls represent a double-layered structure, so that the critical wave number in this area is about two times larger than otherwise. For low values of ! an applied electric eld leads to an increase of the area of homogeneous instability (HI), so that the electric eld suppress the roll instability. The proles of the velocity and the director in the various modes are plotted in Fig. 3.




FIG. 4. Phase diagram of instabilities induced by oscillatory shear ow and a ected by electric eld in NLC with positive dielectric anisotropy. U_F is Freedericksz transition voltage. RI denotes roll instability, HI is hom ogeneous instability, Rom an numbers denote the group of symmetry from table I.

We have also calculated the phase diagram for a nem atic with positive dielectric anisotropy (Fig.4). The material parameters were taken from MBBA except for setting the dielectric anisotropy to be positive. In this case the phase diagram (Fig.4) presents an extensive area of rolls of II symmetry type. At low $!_d$ there is a switching between hom ogeneous instabilities of I and II types by varying the electric eld. Note, that under these conditions Freedericksz transition takes place at voltage U_F (3:74 V). As a result, when U approaches U_F , the critical shear amplitude a_c goes to zero.

The one-mode analysis in this case gives unsatisfactory agreement with the full numerical calculations, although it keeps all the important features (switching between modes etc.).

IV.DISCUSSION AND CONCLUSION

We obtained the complete phase diagram of the orientational instabilities, both hom ogeneous and spatially periodic, in nematic liquid crystal subjected to oscillatory C ouette ow based on the linear stability analysis of the full set of nematodynamic equations. It has been found for the rst time that the inertia of nematic uid, usually neglected in the theoretical considerations, is responsible for the new type of roll instability and switching between roll instabilities with dierent time-symmetry. The results of approximate analytical analysis show an essential features of the in uence of inertia of nematic uid on the instability scenarios and are in a good agreement with full numerical simulations of underlying equations. For the nematic liquid crystal MBBA increasing of ow frequency leads to the transition between rolls of I and II symmetry types.

Both these modes can be easily distinguished in the experiments. Although there are no reports concerning the observations of this transition, the recent experiments on oscillatory ow in nematics show that the technical possibilities are rich enough to observe such e ect.

We have also investigated the in uence of additional electric eld applied across the nem atic layer on the ow instabilities for the liquid crystals with negative and positive dielectric anisotropy. In case of MBBA it was found that the electric eld causes transition to the double-layered roll structure, which is intermediate regime between rolls of I and II types observed in [10]. A nother interesting point in the experimental investigations could be the transition between rolls of the same symmetry but quite dierent wave numbers at increasing of ow frequency (RIII1 and RIII2 in Fig 2).

Eqs. (B6) and (B7) represent the connection between a and q in implicit form, i.e. the neutral curve a0 (q). M in im izing a_0 (q) gives the critical values of the ow am plitudes a_c and the wave number q_c . Equation (B7) has no real roots for q > 0.5, so that when the uid inertia term is neglected only a roll instability of I symmetry type or homogeneous instability of Π sym m etry type can appear. Eq. (B6) gives a critical am plitude a_c 2:2 and wave number q and for, that is in a good agreement with numerical results (Fig.1). From (B7) it follows that the smallest threshold $a_c = 10.9$ corresponds to $q_c = 0$.

The above analysis shows the role of the elasticity described by terms proportional to d in the nem atodynam ic equations. The nature of these terms is singular, i.e. when neglecting these terms the critical ow amplitude vanishes $(a_c = 0)$, although for in nitesim al d there exists a nite value of a_c . A nother point is that at high enough frequencies ac does not depend on the ow frequency, which is in contrast to the case of director alignment in the ow plane [3], where the critical amplitude of roll formation under oscillatory shear ow decreases with increasing ow frequency.

d) R I III, tim e averaged.
