Quantum Collective Creep: a Quasiclassical Langevin Equation Approach

The dynamics of an elastic medium driven through a random medium by a small applied force is investigated in the low-temperature limit where quantum uctuations dominate. The motion proceeds via tunneling of segments of the manifold through barriers whose size grows with decreasing driving force f. At zero tem perature and in the lim it of sm all drive, the average velocity has the form v / exp[const=h f]. For strongly dissipative dynamics, there is a wide range of forces where the dissipation dom in a term of the velocity (force characteristics takes the form v / exp[S(f)=h]), with $S(f) / 1 = f^{(d+2)=(2)}$ the action for a typical tunneling event, the force dependence being determ ined by the roughness exponent of the d-dimensional manifold. This result agrees with the one obtained via simple scaling considerations. Surprisingly, for asymptotically low forces or for the case when the massive dynamics is dominant, the resulting quantum creep law is not of the usual form with a rate proportional to $\exp[S(f)=h]$; rather we nd v / $\exp[S(f)=h]$ corresponding to = 2 and = 2(d + 2)1) = (2)), with =2 the naive scaling exponent for m assive dynam ics. Our analysis is based on the quasi-classical Langevin approxim ation with a noise obeying the quantum uctuation (dissipation theorem. The many space and time scales involved in the dynam ics are treated via a functional renorm alization group analysis related to that used previously to treat the classical dynam ics of such system s. Various potential di culties with these approaches to the multi-scale dynamics both classical and quantum are raised and questions about the validity of the results are discussed.

I. IN TRODUCTION

Static and dynam ic properties of elastic system s in the presence of disorder have attracted the attention of physicists form ore than three decades. Vortices in superconductors¹, charge density waves in solids², dom ain walls in m agnets³, and geological faults⁴ are well-known examples of such system s. M athem atically, some of the problem s that arise in m odeling are related to those in Burgers turbulence⁵, stochastic grow th of surfaces⁶, and the stability of m atter⁷. The physics of dirty elastic system s thus in pacts on several disciplines. In this paper we focus on the dynam ic properties of driven elastic m anifolds at tem peratures low enough for quantum uctuations to play an im portant role, in particular, the phenom enon of quantum creep.




FIG.1. Tunneling (lower dotted line) and activated motion (upper solid line) of an elastic string in a disordered potential under the action of a weak external force f f_c .

In m any situations the elastic system can be driven by applied forces. For example, transport currents in superconductors cause a Lorentz force to act on vortices, while a magnetic eld applied to a ferrom agnet produces an elective force on domain walls. One of the primary quantities of interest in such systems is the average velocity v of the manifold as a function of the applied force f, its dependence on the tem perature, and on the magnitude of the random disorder that in pedes the manifold's motion. The presence of the random pinning forces renders the theoretical analysis di cult, as perturbation theory breaks down in most of the important regimes due to the deformations of the manifold on m any length- and time scales. However, some important general results are known: in the absence of them aland quantum uctuations the system stays pinned | i.e., the steady state velocity v = 0 | if the driving force f is smaller than a certain critical value f_c . At nonzero temperatures, even if the force f is smaller than f_c , the system will move with a nonzero velocity due to thermal creep, see Fig.1. In the limit f f_c the scaling theory of creep⁸^{{10}</sup> predicts the law

with U (f) ! 1 as f ! 0 and there is no linear response to an applied force. The quantity U (f) can be interpreted as a barrier separating two neighboring m inim a of the free energy on some appropriate length scale that depends on the applied force; on long length- and time scales, the manifold's motion proceeds via therm ally activated jumps of corresponding segments between di erent metastable con gurations.

Several in portant assumptions are made in order to derive Eq. (1). First of all, at least in its simplest form, it is assumed that the barriers between di erent metastable con gurations scale with length in the same way as the variations of the free energy that are caused by the balance between the random pinning and elasticity; in general one could consider two di erent scaling laws for these quantities¹⁰. Second, Eq. (1) is an A menius law with typical events dom inating the creep-like motion. In general, rare events, in particular regions with anom abusly high barriers, might lead to a modi cation of this law, perhaps to a form $v / \exp[$ (U (f)=T)] with € 1 an exponent characterizing the tails of the barrier probability distribution. Because of these assumptions, as well as the need for increased analytical understanding, it would be valuable to derive the classical creep law (1) starting from a microscopic description. P rogress in this direction has recently been made, see Refs. 11,12, where Eq. (1) has been derived from an at-least-partially controllable renorm alization group (RG) expansion. A line will discuss later in this paper. W e also note that neither the recent renorm alization group calculations nor the present paper address an important aspect of creep in m any contexts, in particular in the vortex lattice, i.e., the role of dislocations | the results are, so far, restricted to a truly elastic manifold with pinning weak enough that deform ations are too sm all to induce dislocations or other strongly nonlinear e ects¹³.

Experim ental investigations have shown that even at very low tem peratures creep of driven elastic system s, e.g., in vortex lattices¹⁴, of dom ain walls in m agnets¹⁵, and of charge-density waves in solids¹⁶, still persists. This phenom enon suggests an explanation in terms of quantum tunneling of the manifold between di erent metastable con gurations; the macroscopic manifestation of this is quantum creep¹⁷. By analogy with thermal creep, one would guess that

with S (f) a characteristic action for tunneling of a typical segment of the manifold whose size is determined by the applied force. In spite of a substantial number of studies of quantum creep¹⁴ there is as yet no theoretical analysis that starts from a microscopic description of a driven elastic manifold interacting with impurities; the main goal of this paper is to present a rst start at such an analysis, along with a discussion of the di culties involved. W e will show that a law of the form

can be obtained using a renorm alization group approach, as can the functional dependence of the action S on the external force f be found. W hether this is indeed the correct behavior is addressed at the end of the paper.

A natural tool to investigate quantum creep is the functional renorm alization group (FRG) expansion¹⁸, an - expansion near the upper critical dimension ($d_c = 4$) of the random manifold problem. This involves, intrinsically, an in nite number of marginal operators that can be combined into one or more functions. We will nd that in this approach a natural separation of the frequency scales occurs between inter-valley and intra-valley uctuations of the manifold. The inter-valley uctuations correspond to the motion of the manifold on large scales on which there are many separate valleys in the \landscape" caused by the random ness. The intra-valley uctuations correspond to the much faster motion of the manifold within one valley.

The paper is organized as follows. In section II we form ulate the model and nd the appropriate elective action. In section III we show how to derive the creep law (2) using scaling arguments. Next, we study the problem using the renormalization group expansion (section IV) and then summarize and discuss the main results. We end with an analysis of the limitations and problem atic aspects of both our and previous approaches to the creep problem in section V.

We describe the elastic medium by a non-dispersive elastic manifold interacting with a quenched random potential; this generic model captures all the essential physics while allowing for an extensive analytical treatment. The classical motion of the displacements u(z;t) of the manifold away from its undeformed state is described by the dynamical equation

where the friction force $(t_t u and the inertia (t_t^2 u are balanced by the elastic- (c u), random pinning- (F (u;z)), driving- (f), and therm al- (f_{th} (z;t)) forces. We will consider the case, applicable to dom ain walls, of d-dimensional manifolds in d + 1-dimensional random environments, so that z 2 R^d and u 2 R¹.$

The random pinning force F (u;z) is taken to be Gaussian random with mean zero and a correlator

where the overbar denotes an average over the disorder. The function (u) decays rapidly with a characteristic scale . The therm alnoise $f_{th}(z;t)$ is G aussian white with a correlator

with h:::i denoting the average over therm al uctuations.

In classical statistical mechanics we can reform ulate the problem posed by a stochastic di erential equation as an e ective eld theory^{19;20} with the help of the M artin-Siggia-Rose (M SR) approach. A fiber averaging over therm al uctuations the M SR-action corresponding to (4) has the form

with y(z;t) an auxiliary eld used to enforce the equation of p otion. The probability of a particular dynamical evolution u(z;t) under the stochastic process is proportional to $D[y] \exp fA_{MSR}[u;y]g$.

The main goal of this paper is to investigate the in uence of quantum uctuations on the system whose classical limit is described by Eq. (4). Again, it is convenient to formulate the problem as a eld-theory, i.e., to write the elective action describing the elastic system in the presence of quantum uctuations in a way analogous to (7). When calculating time-independent quantities in equilibrium systems (i.e., in the case f = 0) the corresponding quantum action has a Euclidean form and the quantum partition function can be written as an imaginary time path integral²¹. However, here we are interested in non-equilibrium properties ($f \in 0$) and the Euclidean action cannot be used.

A form alism allowing to study the real time dissipative quantum mechanics of a system is that of Feynman and Vemon²²: the quantum amplitude $(x_f;t_f;x_i;t_i)$ for a system to have a coordinate x_f at time t_f , if at time t_i it had a coordinate x_i , can be written as a path integral $x_{i,t_i}^{R_{x_f},t_f}$ D [x]exp (iS [x]=h), with S [x] the classical action. Consequently, the probability of the transition $x_i;t_i$! $x_f;t_f$ can be written in the form

In non-equilibrium quantum mechanics the functional (8) plays the same role as the partition function in equilibrium problem s. We see that the elective action can be written as is [k] is $[k^0]$ and includes two dimensions [k (t)] and $[k^0(t^0)]$.

The standard way to include dissipation is to write the action S[x] in the form $S[x] = S_0[u] + S_{bath}[X_{bath}] + S_{int}[x]$ representing the actions corresponding to the elastic manifold, the bath, and the interaction between the bath and the manifold, respectively (note that $x = (u; X_{bath})$ and $x^0 = (u^0; X_{bath}^0)$ are the coordinates describing both the manifold and the bath). In the Caldeira-Leggett model²³ the term $s S_{bath}[X_{bath}]$ and $S_{int}[x]$ are taken to be quadratic in the bath coordinate X_{bath} and hence can be integrated out at the expense of elective interactions that couple di erent times. The resulting action takes the form (see appendix A or Ref. 24)

The Fourier transform of the elective noise correlator (t t^2) of the bath uctuations obeys the quantum uctuation { dissipation theorem,

where is related to the spectral density of the bath, see appendix A.

The action (9) allow sone, in principle, to investigate all the properties of a driven elastic medium in the presence of quantum uctuations. The classical limit, the M SR action $A_{MSR} = iS=h$ can be recovered by expanding the random potential energy U in the y- eld and substituting u by u and y=h by y. Such an expansion is valid at high tem peratures and it has been argued²⁵ that it also applies to the limit h! 0 at T = 0. This suggests that the dynam ics of quantum system s in the sem iclassical regime, where tunneling processes through large barriers dom inate, can be described by Eq. (4) with the noise obeying the uctuation {dissipation theorem (10); this is called the quasi-classical Langevin equation²⁵ (Q LE) approach. In a num ber of papers^{26;27} the Q LE has been used to study the non-equilibrium dynam ics of quantum system s. In particular, in Ref. 26 the quantum tunneling of an overdam ped quantum particle has been studied using this approximation. Writing the inverse lifetime of a metastable state in the form = Pe^{S=h} with S the tunneling action and P the prefactor, it turns out²⁶, that the Q LE gives the correct value of the tunneling action S up to a multiplicative factor of order unity (note that for quadratic system s the Q LE is actually exact, as is the expansion U ($\alpha + \gamma=2;z$) U ($\alpha = \gamma=2;z$) $\hat{U}(\alpha;z)$ y for this case).

In this paper we use the QLE to study quantum creep in a disordered medium. A lthough we would like to do better, we are primarily interested in obtaining the correct scaling laws and asymptotic forms; the exact coe cients are of less interest. The action (7) with the quantum noise (10) is much simpler to analyze than the full quantum action (9). We believe that the QLE should be a useful tool for investigating the dynamics of quantum systems as it appears to capture the essential physics, while being | at least relatively | tractable analytically. Quantum uctuations appear in the QLE approach as an elective random force with a correlator (t), see (10), acting on the system. The quantum decay of a metastable state then is equivalent to the them ally activated escape of a particle driven by colored noise²⁸.

III. SCALING ARGUMENTS

A.Statics and Therm alC reep

An elastic manifold subject to a random potential behaves as an assembly of approximately independently pinned segments of a characteristic size that is determined by the balance between the pinning and elastic forces. The driven motion of the manifold is dominated, both classically and quantum mechanically, by successive jumps of segments of the manifold between subsequent metastable con gurations. In order to understand this behavior one needs to consider various characteristic scales.

The characteristic size of the collectively pinned segments is of order L_c [$c^{2} = (0)$]^{1=(4 d)}, the Larkin length over which the typical distortion of the manifold ju(L_c) u(0) j is of order , the scale of the correlations in the random pinning landscape. The characteristic energy scale of the deformations on scale L_c is U_c $c^{2}L_c^{d^{2}}$. Beyond

 L_c , the typical displacements of the manifold grow as ju(L) u(0)j (L=L) with the wandering exponent, = (4 d)=3 for the random force case, while d_{i1} 0.2083 (4 d) for a short-range correlated random potential; the di erence in energy between metastable con gurations deviating on a scale L by a displacement u(L) is controlled by the balance between the elastic- and pinning energies, both of which have a magnitude of order U_c (L=L_c) with the energy exponent = d + 2 2 and the wandering exponent given above.

In the presence of an applied force f it is favorable for a segment of size L to move into the neighboring metastable valley if the energy fL^d u(L) fI^d (L=L_c) gained due to the presence of the force is larger than the di erence of the elastic-plus pinning energies between the two con gurations; for small forces, this will only occur for large segments. Equating the two energy scales, we obtain the minimum characteristic size of a segment that can move to the lower energy site⁸,

where $f_c = I_c^2$ is the critical applied force needed to move the manifold in the absence of thermal or quantum uctuations. The scale L_f is the minimum size of a segment that can hop in order to lower its energy; the macroscopic motion then proceeds via jumps of segments of this characteristic size over distances

separating two neighboring metastable con gurations.

Consider rst the classicalmotion, i.e., thermal creep: The conventional assumption is that the height of the energy barrier that must be summounted for such a motion to occur classically is determined by the scaling of the static energy $U_c (L=L_c)$ (we will discuss the validity of this assumption later in this section). The characteristic height of the barrier that dominates the motion at a small force f then is

B.Quantum Creep with D issipative D ynam ics

The quantum tunneling of segments of the manifold can be estimated in a manner analogous to their classical thermal activation: Let us assume that the manifold is located in one of the metastable con gurations and subject to a small driving force f. One expects the lifetime of such a state to be proportional to exp (S=h), with S the characteristic action describing the tunneling through the barrier separating the metastable minimum from one with a lower energy. We estimate S using the standard theory of the decay of metastable states. We estimate over those of inertia; the Euclidean action of the manifold then can be written in the form

with the imaginary time and the dissipative coe cient. In order to nd S one needs to nd the imaginary time trajectory connecting the initial and nalcon gurations of the manifold and calculate its action. We emphasize that as our problem is a non-equilibrium one, the full quantum action (9) should be used. However, at low driving forces, the problem we study is a quasi-stationary one, as the lifetime of a metastable state is large and the manifold can be considered to be in local equilibrium. Therefore we can use the simpler (Euclidean) action (15) instead of the full dynam ic action (9).




FIG.2. Tunneling of a particle with an elective mass L_f^d and dissipative coelline to L_f^d through a barrier of height U (f) and width L_f .

In estimating the tunneling action we nd the size L_f of the tunneling segment as in the classical case of them all creep, since this is determined by the static balance between the variations in the pinning energy and the energy gain due to the external force. Furthermore, we assume that there is only one characteristic time scale f associated with the tunneling process. We can then consider the tunneling event, crudely, as an elective process in which a point-like object with a friction coellection $f = L_f^d$ tunnels through a potential barrier of height U (f) and extent u_f , see Fig.2. The saddle-point of the action (15) is minimized when

where we have substituted the dynam ic term by its characteristic value and U (f)= u_f is the characteristic force acting on the \particle". The tunneling time f is given by $f = \int_{f}^{2} u_f^2 = U(f)$, resulting in the tunneling action

with S $^{2}L_{c}^{d}$ the characteristic scale of the dissipative action of a segment with the diameter of the order of the Larkin length L_{c} . The velocity of the manifold is related to S (f) via (2).

The characteristic crossover tem perature T_{cr} from quantum to classical creep can be obtained by com paring U (f)=T and S (f)=h, ie.,

gives the scaling conjecture for the dissipative lim it.

C.Quantum Creep with Inertial D ynam ics

We now assume that the inertial term in the action is more important for the tunneling process than the dissipation. In this case the Euclidean action analogous to that given by (15) can be written in the form

with the mass density of the manifold. The size L_f of the tunneling segment is the same as in the dissipative case. In order to nd the action S (f) one again needs to nd the tunneling time f; comparing kinetic and pinning energies for the saddle-point conguration, we nd (with $f = L_f^d$ the elective mass of the tunneling object)

with S $(U_c L_c^d)^{1=2}$ the characteristic action with inertial dynamics on the Larkin scale L_c . The quantities L_c and U_c have been de ned in section IIIA above. The characteristic crossover temperature can be determined as in the dissipative case and is given by T_{cr} (hU_c=S) (f=f_c)¹⁼⁽²⁾.

D.Assumptions

Two in portant assumptions have been made in order to derive the scaling prediction (2): First of all, it has been assumed that the barriers for the manifold's motion scale in the same way as the variations of the energy. If there are two independent exponents = d 2+2 parametrizing the static energy scaling and > characterizing the scaling of energy barriers^{29;30}, then the barrier for therm alcreep will have the form U (f) / L_f . The simplest assumption for the quantum motion is that this same barrier height is the appropriate one for the quantum barrier traversal. While the dissipative result (17) would remain the same (as S_{diss} fu_f^2 does not depend on the height of the tunneling

barrier), the result for the inertial dynam ics would take the form $S_{inertial} / L_{f}^{(d++2)=2}$.

We should emphasize, how ever, that if > then this is because the dynam ics on intermediate length scales a ects that on the large scale L_f . A dependence of the large scale dynam ics, of interest for quantum creep at small applied forces, on the intermediate scale physics can also occur quantum mechanically; but the way in which it occurs could be quite di erent from the classical situation and it is possible that each type of quantum dynam ics has its own exponent $_Q$ distinct from the classical value 31 . Once we adm it the possibility of a dependence of the tunneling dynam ics of large segments on the dynam ics at intermediate scales, the basic assumptions of the scaling arguments given above break down. But this is exactly the kind of problem for which a renorm alization group framework is needed.

A nother potentially in portant e ect that was not taken into account in the simple scaling analysis sum marized above are rare events: in general, it is possible that the velocity is not controlled by the typical barriers | or, more precisely, by the tunneling through these typical barriers | but by rare anom alously large barriers. In the simplest scenario, this could give rise to a quantum creep law of the form $v / \exp f$ [S (f)=h]g, with ϵ 1 a non-trivial exponent characterizing the tail of the distribution of barrier heights. Just such a phenom enon controls the tem perature dependence of the di usion coe cient of a single particle di using in a G aussian random potential ³², see the discussion in section IV E. O ne mechanism for an exponent > 1 is that rare, rather than typical, events dom inate the macroscopic motion.

IV . RENORMALIZATION GROUP ANALYSIS

A.Derivation of RG Equations

Having presented the basic scaling arguments for both classical and quantum creep, we now turn to the main task of this paper, an attempt to derive the creep laws from a microscopic description of the dynamics. With the roughness exponent vanishing in dimensions d > 4, one expects that $d_{e} = 4$ is the upper critical dimension of random ly pinned elastic manifolds, an expectation which turns out to be correct both for the equilibrium properties in the absence of a driving force and for the uctuation less (T = 0) critical depinning transition at f_{c} in the presence of a driving force f. A renormalization group expansion about $d_{e} = 4$ then allow s one to investigate the various large scale properties of the pinned elastic manifold¹⁸. An important feature of this renormalization group analysis is the fact that even to low est order one has to take into account in nitely many variables, in practice by renormalizing a function that is essentially the correlator [u (z) u (z⁰] of the random force (but see the discussion in Ref. 33 and in section V B).

The functional renorm alization group (FRG) approach has been successfully applied to both static equilibrium ¹⁸ and uctuationless (T = 0) depinning problem $s^{34;35}$. Recently, the FRG has also been applied to the therm al creep problem ^{11;12;36}, although its applicability is far more problem atic. For forces f f_c , the motion proceeds either by activation or tunneling of large segments between di erent metastable minim a and thus the dynam ics is intrinsically non-perturbative: in particular, the dynam ic exponent z, which is shifted only slightly from its naive value of two near the critical depinning transition, must be radically modiled in the creep regime. Nevertheless, it appears (though, see section V) that for therm al depinning one can handle this within the FRG and renorm alize until a scale is reached

beyond which the disorder can be taken into account perturbatively and the equation of motion can be solved. By retracing back the FRG ow, one can then determ ine the average velocity of the manifold. We will follow this approach here, but return later in the paper to question its validity both for the quantum and classical cases.

Form ally, in both classical and quantum cases, the RG analysis of creep involves the ow away from the static (f = 0) xed-point that controls the undriven pinned system under the action of a small applied force f; under the RG transform ation the parameters describing the system ow in such a way that eventually the e ects of disorder can be neglected beyond a certain length scale. But there is an important di erence between the classical and quantum cases: In the classical case¹² one can restrict the analysis to the low-frequency limit, i.e., including the friction term ($@_tu$) alone into the renorm alization procedure is su cient. This is a consequence of the fact that, to exponential accuracy, classical creep does not depend on the dynamics (e.g., inertial versus dissipative) of the system. In the quantum case, it will turn out that an analogous treatment leads to a spurious \localization transition" where the average velocity of the manifold drops to zero at a nite length scale. L_c , see section IV B. In order to carry out a correct analysis one must include all the frequencies into the renorm alization group; speci cally, we must make the substitution

It has been argued above that in order to investigate quantum creep we can use the action (7) with the correlator given by (10). It is convenient to perform the disorder average in (7) and work in a frame moving at the average velocity of the manifold, i.e., we substitute u(z;t) ! u(z;t) + vt. In the regime of interest for quantum creep, the motion of the elastic manifold can be represented as jumps between di erent metastable states and the lifetime of each metastable state is large. It is thus possible to extract some information about the dynamic properties of the system, in particular, the average velocity v, from static equations if we cuto the renormalization group ow at the relevant length scale, here, $L_f = L_c (f_c = f)^{1=(2)}$, see section III (a similar situation arises in the conventional theory of the decay of metastable states: although the original problem is formally non-equilibrium, the system is trapped for a long time in the local equilibrium state corresponding to a local minimum of the free energy; one can approximate the partition function of the system by that calculated assuming quasi-equilibrium and then due of the probability out of the local potential well). This is why we could use the Euclidean action instead of the full quantum mechanical action in section III. For values of the RG variable 1 smaller than $\ln (L_f = L_c)$ we then can use the appropriate static versions of RG equations.

The RG ow equations are obtained by integrating over fast modes in the elective action (23) with the last two terms in the action treated as perturbations about the quadratic action. We write all the equations, except those for

the correlator $_1(u)$, the temperature T_1 , and the P lanck constant h_1 , at nite velocity. We will use the subscript l in order to distinguish renorm alized quantities at length scale $L = {}^{1}e^{1}$ from bare quantities without subscripts, e.g., $= {}_{0}$, $T = T_0$, $h = h_0$, $(u) = {}_{0}(u)$, etc. Introducing the large momentum cuto we obtain to leading non-trivial order in ${}_{1}$,

Both the dynamic exponent z = z (1) and the roughness exponent (1) are at our disposal to adjust for convenience; it will generally be most useful to choose to be the l-independent value giving rise to a well behaved xed point function (u) in the absence of uctuations or drive. How best to adjust z (1) we reserve for later; conventionally it would be chosen to x the coe cient in the low-frequency part of D₁(!), in the dissipative situation studied here, of ₁. this quantity plays a crucial role in the dynamic renormalization. Eqs. (28), (29), (31), (30), and (33) have been obtained before in the discussion of classical creep¹²; they are the same in the quantum case, while Eq. (32) is di erent, how ever. We now show how it can be obtained and in what respect it di ers from its classical analog.

Writing the functions $_{1}(v)$ and $R_{1}^{2}(;)$ as Fourier integrals we obtain Eq. (32), which explicitly includes the full dependence of the displacement eld u (z;t) on time, i.e., it is nonperturbative in frequency. In the classical analysis of R ef. 12 it was assumed that the low-frequency lim it of the RG equations is valid for all frequencies, i.e., for !! 0 the only in portant term is that containing $_{1}$ et u (corresponding to $_{1}$ i! u (!) in Fourier space). The equation analogous to (32) then is given by its low-frequency lim it, i.e., instead of the full dependence u (z;t) u (z;t) one considers on by the rst term of its Taylor expansion in t the frictional coe cient $_{1}$. In the classical lim it this approach leads to reasonable results. By contrast, ignoring the frequency dependence of the dynam ics in the quantum case leads to a spurious \localization transition", in plying a zero average velocity of the manifold below a smallbut non-zero driving force f and in the presence of quantum uctuations h \in 0. We will discuss this issue in section IV B.

In the case of a purely dissipative dynamics there is another problem that occurs even at the initial stage of the renorm alization: the integral in the expression for $C_1^>$ (;t= 0) diverges at large frequencies, see Eqs. (35) and (24). For large ! the noise _1(!) (see (10)) and the dynam ic spectrum $D_1(!_R)$ are both proportional to ! for a dissipative dynam ics and, consequently, $C_1^>$ (;t= 0) diverges logarithm ically as _d!=! at large frequencies, see (24). This is not unexpected: it is just such a logarithm ic frequency dependence that can cause localization in m odels with a single degree of freedom coupled to a bath that provides a linear friction³⁷; thus integrating out all the frequencies at once is problem atic even for short wavelength deform ations of the manifold. In reality, we expect that an inertial term

 ℓ_t^2 u or som e other frequency dependence describing the small scale dynamics will provide a cuto at high frequencies (at !₀ = for the inertial case); alternatively one could introduce a sharp cuto by hand. W e will consider both possibilities later, noting now that how this is done will a ect the results farm ore than one m ight expect.

B.Structure of the Quantum RG Flow

The main goal of the remainder of this section is to analyze the system of RG equations derived in section IV A in the lim it of sm all driving forces. We rst discuss the in portant features and then provide a more detailed analysis in the following section. First, let us analyze the renorm alization (28) of the force-force correlator. In the absence of quantum and therm all uctuations (i.e., (!) = 0 for all !), the correlation function C_1^{-1} (; t = 0) is zero. In this case, the nonlinearities in the ow equation of the function $_1(u)$ cause it to become nonanalytic on a nite length scale, even if the bare correlator $_0$ (u) is analytic, see Ref. 18. This is easily seen by di erentiating Eq. (28) twice with respect to u and substituting u = 0, resulting in an equation for the evolution of the quantity $\begin{bmatrix} 0 \\ 1 \\ 0 \end{bmatrix}$ (0) alone. The simple autonom ous ow equation for $\begin{bmatrix} 0 \\ 1 \end{bmatrix}$ (0) leads to a divergence at a nite scale l_c $\begin{bmatrix} 1 \\ 1 \end{bmatrix}$ $l_c^2 = \begin{bmatrix} d & 4 \\ 0 \end{bmatrix}$ (0)], producing the Larkin-orpinning length L_c ' $[c^2 = 00(0)]^{1=(4 d)}$ $[c^{2}]^{2} = (0)]^{1=(4 d)}$ where collective pinning goes over into strong pinning. Beyond L_c, the perturbative description breaks down as multiple competing minim a appear in the pinning energy landscape. The in nite second derivative suggests that the function 1(u) will have a discontinuous rst derivative at u = 0, i.e., $\frac{0}{1}(+0) =$ $_{1}^{0}(0) \in 0.0$ n length scales shorter that I_{c} , the sm oothness of $_{1}(u)$ rejects the smooth reversible evolution of a segment as it is pulled by its neighboring regions. But on larger length scales the internal deform ations of the segment will cause it to jump discontinuously and irreversibly from one metastable con guration to another | this is rejected in the discontinuity in ${}^{0}_{1}$. At the scale L_c the force correlator essentially has reached its xed point shape with a height (0) (c²)² d² d² d² d² and a width e¹c, resulting in a has reached its xed point shape with a height $cusp j = (0+)j = (c^2)^2 = de^{-l_c}$, see appendix B.

In the presence of small quantum or thermal uctuations the coe cient $_1 C_1^>$ (;t = 0) becomes nonzero and this leads to a smearing of the cusp in $_1(u)^{11;12;38}$. The derivative $_1^0(0)$ of the correlator at the origin is zero for $C^>$ (;t = 0) \notin 0 but changes rapidly in a boundary layer around the origin. The cusp that was present in the absence of uctuations is smeared over a region $u_{sm ear}$ which can be estimated by comparing¹² the terms $_1j_1^0(0)j$

 $j_{1}^{0}(u = u_{mear}) = u_{mear}$ and $[d = (c^{2})^{2}]_{1}^{0^{2}}(u)$ in (28). The derivative $j_{1}^{0}(u > u_{mear})$ approaches the xed point value 0(+0) found in the absence of uctuations and we obtain the boundary width $u_{mear} = (c^{2})^{2} = d = (c^{2})^{2}$. The curvature $j_{1}^{0}(0)$ $[d = (c^{2})^{2}] = 0(0+) = 1$ then diverges as the uctuations renormalize to zero on large scales.

Physically, $u_{sm ear}$ (1) can be understood in terms of the equilibrium response of a segment of size $L = 1e^{1}$ to the motion of its neighboring regions. U sually, a small displacement of neighboring regions will cause only a small readjustment of the segment of interest within its local energy minimum. The exceptions to this occur when the minimum energy con guration of the segment jumps from one con guration to another as its neighboring regions are slightly displaced: it is these jumps that give rise to the cusp in (u) in the absence of uctuations. At non-zero temperature or in the presence of quantum uctuations, the behavior will not change much except near these jumps, where there will be a range of positions of the neighboring regions over which the segment of concern will have a non-negligible probability to be in either of two distinct con gurations. This will result in a smearing of the cusp

in $_1(u)$ over the scale $u_{sm ear}(l)$ of neighboring region displacements on which this split probability typically occurs. On large scales, the fact that the energy scale grows as L means that it is much less likely that the position of a segment will uctuate between two energy minima. This is releated in the renormalization towards zero of $_1$ and the concomitant ow towards zero of the smearing scale $u_{sm ear} / _1$. Summarizing, the function $_1(u)$, whose renormalization is given through equation (28), develops under the RG in the following way: At the scale L_{cr} , $_1(u)$ is close to its uctuationless xed-point function $_1(u)$, with uctuations a ecting its behavior only in the vicinity of the point u = 0 via a smearing of the discontinuity in $_1^0$ in a boundary layer whose size is controlled by $_1$. Once we know how the function $_1(u)$ evolves, we can substitute it into the other RG equations and see how other quantities renormalize under the RG ow.

In addition to $u_{sm ear}$, there are two other in portant displacement scales: the characteristic scale of the xed-point correlator (u) and the scale u_{vel} associated with the velocity u_{vel} $_1v_1=c^2$. The latter is the product of the velocity v_1 and the characteristic timescale $_1=c^2$ of the low-frequency part of the response function $R_1^>$ (;t) at wavelengths of the order of the cuto 1 . At scales some what larger than the Larkin length L_c / $^1e^{l_c}$,

This is a consequence of the fact that v_1 is exponentially small (/ exp f [S (f)=h]g) in h, while $u_{sm ear}$ proportional to a power of h_1 and is a static quantity that does not depend on h_1 (in the classical case the relevant displacement scales obey the same relation with the role of h played by the tem perature T). During the RG ow, $u_{sm ear}$ decreases gradually with decreasing h_1 whereas u_{vel} increases rapidly due to the sharp increase in the viscosity $_1$.

Eventually at some scale both $u_{sm ear}$ and u_{vel} are of the same order. At this scale, which is the crossover scale L_{f} appearing in the scaling arguments for creep, the functions ${}^{0}_{1}(vt)$ and ${}^{00}_{1}(vt)$ are roughly given by ${}^{0}(+0)$ and ${}^{00}(+0)$ on the time scales that dominate in Eqs. (29), (31), and (32). At even longer scales, u_{vel} eventually becomes comparable to f, see Ref. 12. Beyond this scale the random ness is electively smoothed by the motion of the manifold and can be neglected or treated perturbatively.

In analyzing the renorm alization of other quantities by the random pinning forces, we thus see that there are two in portant regimes:

it was argued¹² that this latter regim e resembles that of the critical depinning transition³⁴ in the absence of uctuations; we can then approximate ${}_{1}^{0}(vt)$ by ${}_{1}^{0}(+0)$ and ${}_{1}^{0}(vt)$ by ${}_{1}^{0}(+0)$. These two regimes are separated by the scale L_f discussed in section III. We will now show how the scale L_f $L_{c}(f_{c}=f)^{1=(2)}$ naturally appears in the solution of the RG equations and separates the two regimes.

In order to do so we concentrate on the force equation (29) which involves the slope ${}^{0}_{1}(v_{1}t)$ of the disorder correlator near the origin. The latter is small and vanishes at u = 0 for $1 < l_{c}$, hence $f_{1} = e^{(2 - 1)t}f$ grows exponentially (since the velocity v_{1} of the manifold is exponentially small we can neglect the term ${}_{1}v_{1}$ in the equation for f_{1}). In the absence of uctuations the slope ${}^{0}_{1}(v_{1}t)$ ${}^{0}(0+)$ rapidly turns on as the correlator forms a cusp at l_{c} ; if the disorder term $({}^{d}=c^{2})j$ ${}^{0}(0+)j$ overcom pensates the scaling term (2) e^{2} ${}^{1}l_{c}f$, the force will start renorm alizing to zero while in the opposite case it will continue to increase. B alancing the two terms we not the critical force density f_{c} $c = I_{r}^{2}$.

Fluctuations sm earing the correlator on the scale $u_{sm \ ear}$ soften and delay the depinning transition until the growing width u_{vel} of the response function encloses the emerging cusp in $_1(u)$ at l_f , $u_{vel}(l_f)$ $u_{sm \ ear}(l_f)$. Below l_f we have $_1^0(v_1t)$ $_1^0(0) = 0$ and the force increases exponentially $f_1 = e^{(2 \)^1}f$; starting with a sm all force f f_c , depinning occurs as the cusp emerges at $u_{sm \ ear}(l_f)$ $u_{vel}(l_f)$. We thus see that the characteristic length scale for creep | the size L_f of the segments that can jump to lower the energy | appears naturally within the RG fram ework. We emphasize, however, that L_f is entirely determined by static properties; so far we have not had to address the crucial issue of dynam ic renorm alizations | to these we now turn.

The crucial quantity needed for the dynamic renormalization is $\frac{00}{1}(0)$, which can be obtained from Eq. (28) by comparing $\frac{100}{1}(u)$ with the nonlinear terms evaluated at the origin u = 0. This yields¹²

The validity of this condition to exponential accuracy is due to the following argument: At the scale L_{dyn} where $u_{vel} = _{1}v_{l}=c^{-2}$ we have a velocity $v_{l} / l = _{1}$ as the e ects of pinning are negligible beyond this scale. On intermediate scales, i.e., between L_{f} and L_{dyn} both $_{1}$ and v_{l} renormalize but not exponentially; the only exponentially large renormalization originates from scales between L_{c} and L_{f} . Thus, to exponential accuracy, we can ignore the renormalization on scales larger than L_{f} (and smaller than L_{c}) and justify (47) (note that, in general, only such dynamic quantities as $_{1}$ and v_{l} are exponentially renormalized, i.e., proportional to exp[const L_{f}], with ~ a positive constant).³⁹

The crucial equations for calculating the renorm alized velocity are Eqs. (31) and (32). Substituting v_1 by zero in these equations and perform ing the Fourier transform ation in Eq. (31) we obtain the two equations

Strictly speaking the FDT is not applicable for $v \in 0$, but its appearance here is understood to be consistent with our assumption of being close to local equilibrium and our use of the approximation v = 0 in the RG equations for $L < L_f$. Using Eqs. (25), (36), and (50) one can see that the expressions (48) and (49) are identical up to scaling term s.

Before embarking on the complete analysis it is instructive to see what happens if we simply keep the leading low-frequency form of D (i!) as is conventionally done in dynamic renormalization group calculations. To do this we substitute the Ansatz $D_1(i!) = _1j!$ j for all frequencies into (53). This would presum ably mean that the velocity goes to zero in the presence of a nonzero force and quantum uctuations, a result that appears to be implausible. O focurse, what one must check in any situation where some parameter in an elective action diverges under the RG ow is, whether this is due to an unphysical restriction of the space of relevant parameters, a breakdown in whatever approximations that have been made in deriving the RG ow, or some other elect. In our case, it will turn out that the renormalization of the whole frequency spectrum is very important. This should be contrasted with the classical case for which one can obtain the result v / exp[U (f)=T] by considering the low-frequency limit only¹².

D.RG Analysis of Dynam ic Response

We now turn to the analysis of the RG ow equations (55) and (56). In order to nd the ow of the function $D_1(!)$ it is convenient to make the unconventional choice z(l) = 0 and allow $_1$ to change arbitrarily. If one is more comfortable with a owing dynamical exponent z(l), one can work more generally with the quantity




FIG.3. Die rent regimes relevant in the integration of the dynamical equation (60): For $< \sim_0$ the integration is split into two regimes 0 < 1 < 1 and 1 < 1, while for $> \sim_0$ the integration involves only one regime.

For $L > L_1$ the behavior of B_1 is always dom instead by the inertia and the result (74) takes over.

In the end we see that the coe cient B₁ / 1= $_1$ describing the uctuations rounding the cusp in the correlator $_1$ increases dram atically with increasing scale 1 (with a correspondingly decreasing $_1$). Substituting E₁! E₀e²¹+G₁! B₁+ (= $_c$) in the integral of (62), we see that the integration is squeezed to the high energy side where it is ultimately cuto by the inertial term (= 2) or a more general cuto (= $_c$). Hence the remaining high-frequency uctuations measured with respect to the typical barriers U (L) at this scale determ ine the smoothing coe cient $_1$. 


FIG. 4. Schematic renormalization of the dynamic spectrum $D_1(i!)$ for a dissipative/massive initial dynamics, $D_0(i!) = j! j + j^2$, with a crossover at ! = !. The spectrum is renormalized di erently on small and large frequencies: in the region $D_1(i!) = c^2$ the spectrum is double{exponentially enhanced and grows as $j! jexp[conste^1]$, with > 0 an exponent depending on the specie dynamics. For $D_1(i!) = c^2$ the renormalization takes the di erent form $D_1(i!) = !e^{(2-2i)!} + !^2e^{(2-2i)!} + F_1$, with F_1 independent of the frequency !.

Going back to the dynamical equation (60), we see that B_1 not only determ ines the low-frequency part but the entire function $D_1(i!)$ (we assume z = 0 and identify with !). A schematic renormalization of the dynamic spectrum $D_1(i!)$ is shown in Fig.4: the low-frequency part at ! < \ddagger_1 ($c^2 = 1 \exp(B_1)$ where $D_1 < c^2$ remains linear, $D_1(i!)$ 1!, but is boosted exponentially with 1 exp(B_1) (with B_1 itself growing exponentially in 1). At frequencies above \ddagger_1 the upward renormalization is reduced and the response $D_1(i!)$ develops a at intermediate regime. Finally, at high frequencies ! > \ddagger_0 the renormalization remains small, while the shape of the dynamical response again releases the form of the original bare dynamics D_0 with an additional shift / $c^{2}B_1$. It is this high-frequency part of D_1 that dom inates the in portant renormalization of $_1$ at low frequencies. We attribute the strongly motion, while the remaining modes at intermediate and high frequencies describe its intra-valley motion smoothing the disorder landscape. In the next section we will discuss the meaning, signi cance, and problem atic aspects of the unusual dynam ical renormalization scheme uncovered above.

E.Results:Quantum Creep

The physical quantities of primary interest can be obtained from the analysis of the previous section. In particular, using the relation (47) we not the creep velocity at low forces in the inertial case,

with an unknown constant coe cient incorporated into S \cdot . But at asymptotically low forces f f_{I} the inertial term in the action dominates and the behavior of the velocity crosses over to the inertial result (81). For the dissipative

case, the result is similar to that obtained using scaling arguments in section IIIB in the intermediate regime, but the logarithm ic factor causes the velocity to decrease slightly faster with decreasing force than anticipated. By contrast, in the inertial case the creep velocity is much smaller that anticipated: it can be written in the form $v / exp = (S_{m ass}(f)=h)^2$, with $S_{m ass}(f)$ the characteristic action obtained in section IIIC using scaling arguments. At asymptotically low forces, this result is also valid for the more generalm odel including a dissipative dynamics at low frequencies and an inertial dynamics at high frequencies.

F.Results: Classical Creep and Crossover

At high tem peratures the coe cient $_1 = C_1^>$ (;t = 0) is independent of the dynam ics and the evolution of the spectrum $D_1(i!)$ does not feed back into $_1$. Equation (79), written in terms of the bare tem perature, then takes the form

One can nd the crossover temperature from classical to quantum creep by comparing the exponents in (83) and (81) with U (f)=T. For the inertial case,

which is different from the naive result obtained via simple scaling arguments, see section III. For the dissipative case, the crossover temperature depends on the regime. For intermediate forces, it is the same as that given by the naive scaling arguments (up to a logarithmic factor), but for $f_{\rm I}$ the crossover temperature is again given by the result (85) for the inertial case.

G. Interpretation

As mentioned earlier, a dependence on h of the form (81) might be expected if the dynamics were dominated by atypical barriers. A simple example is given by a classical particle di using in a short-range correlated random potential. At positive temperatures there is a linear response to an external force with the inverse mobility of the particle proportional to $dUP(U) \exp(U=T)$, where P(U)dU is the probability density of barriers U. For the case of a Gaussian distribution of the random potential, we see that $v / f \exp(-const=T^2)$, resulting in a non-A menius temperature dependence.

A nalogous e ects can occur in quantum transport: C onsider a quantum particle of mass m and with a dissipative coe cient 1, tunneling through a succession of barriers of random heights U but, for sim plicity, uniform width a. The inverse m obility of such a particle can be written as

The exponent contains a sum of two actions, the rst due to dissipation and the second describing the inertial response. One can see that even if the dissipation is strong, in the lim it h ! 0 the inertial e ects can dominate: the integral in (86) is calculated using the method of steepest descent and since the massive contribution to the action is proportional to $\frac{P}{U}$, it will contribute a term larger than the dissipative one. In particular, with a G aussian distribution of barriers of the form P (U) exp[$(U=U_0)^2$] this leads to $/ \exp[\left(\frac{P}{m U_0} a=h \right)^{4=3}$] and we obtain a similar non-trivial dependence on h as found above in (81) for the creeping elastic manifolds of interest here.

In this simple single-particle example it is easy to understand what is going on: Because the particle must tunnel through a succession of barriers, the dynamics is dominated by the largest ones as long as there is a su ciently long tail to the barrier distribution; the smaller the quantum uctuations, the larger the barriers that dom inate. For the probability distribution function P (U) chosen above, U ' $p_{\overline{m} aU_0^2 = h}^{2=3}$! 1 for h! 0. The form of the tail of the distribution of barriers thus dom inates the mobility and gives rise to the unusual dependence on h. The fact that

for small h the dom inant barriers are high in plies that the characteristic time scale for tunneling through the barrier is short (in the above case the time is given through ' a m = U); this is what causes the long-time behavior as manifested in the mobility to be dom inated by the inertia rather than by the dissipative response. In the case of interest here, the elastic manifold, the barriers that must be sum ounted depend on the driving force | the lower the force, the higher these barriers are. If one assumes that the barriers relevant for tunneling have an unbounded distribution similar to the toy model studied above, it is not surprising that it is the inertial dynam ics that dom inates the lim it of low forces.

However, the reason for the anomalous dependence on h is more subtle for the elastic manifold with its many degrees of freedom. As can be seen from the analysis in the previous section, the anomalous dependence can be traced back to the dependence of the quantum uctuations on one length scale, as parametrized by $_1$, on the random pinning at smaller scales. Very crudely, this might be interpreted as leading to an increase of the elastic in the tunneling motion of a segment of size L_f . Determining whether or not this is a reasonable interpretation must wait for a better understanding of the physics underlying the RG results and whether these are valid.

V.VALIDITY OF RG RESULTS

In both the previous and the present work on classical and quantum creep of elastic manifolds the validity of the approximations that underly the RG formulation have not been carefully examined. In unpublished work⁴¹ one of the problematic aspects, the possible elects of tails in the distribution of local elective friction coel cients, has been investigated. Here, we brie y summarize the potential problems that this suggests as well as more basic ones that have not, to our know ledge, been raised previously.

A.Random Friction

O ne di culty, analyzed in Ref. 41, is already apparent in the toy model of a single particle in a random potential: the broad distribution of times to go through or over barriers. In particular, as discussed in section IV E above, for a single particle the mobility is dominated not by the typical or even the average rate for overcoming the local barriers, but by the average time to overcome them; and the average time is dominated by anom alously large barriers. A s this problem already arises in the classical case both in the toy model and for elastic manifolds, we restrict our discussion to the simpler classical limit.

The main idea of the RG is to derive equations which relate the renorm alized parameters of the eld theory to the bare ones. Very often the parametric space of the bare and renorm alized theories are identical. In other words, if the bare theory is described by the parameter set $\binom{(1)}{0}$; $\binom{(2)}{0}$::: the renorm alized theory will be described by the same set of variables $\binom{(1)}{1}$; $\binom{(2)}{1}$::: An example of this kind of RG is the ⁴ theory to one-loop order. It could be, how ever, that under the RG ow additional variables $\binom{(1)}{1}$; $\binom{(2)}{1}$::: are generated even if their bare values are zero. These variables might be strongly relevant and feed back to the original set of parameters. An example of such a behavior, which we could handle successfully, has already been considered above: in order to obtain sensible results we had to introduce a function D₁(i!) describing the dynam ics on all frequencies. In this paragraph we will show that another set of dangerous variables is generated under the RG ow | these variables describe the probability distribution function of waiting times. In the RG scheme considered above them ost crucial quantity is the renorm alized viscosity 1 which is proportional to the waiting time at the scale 1. We will show that the random ness due to the point-like disorder will produce a random and spatially inhom ogeneous distribution of frictions which appears to be very broad and hence cannot be properly described by its rst moment 1 alone.

Let us then consider random ness in the local e ective friction coe cients from the beginning and assume that the friction is a function = [u(z);z] of both the displacement u(z) and the internal coordinate z of the manifold. The local has the natural interpretation as a characteristic time to overcome barriers involving the smaller length scale deform ations that have already been integrated out. The simplest case to consider is a random potential that is periodic in u with a locally random phase shift; such a model is applicable to charge density waves (CDW s). Because of the periodicity, for CDW s we can expand the function (u;z) into the Fourier series and there will be a component that is independent of u and only depends on z; we consider the e ects of such random ness here.

We assume that (z) is a random short-range correlated variable with cumulants ⁽ⁿ⁾; e.g., the rst three take the form (z) = (1), (z), (

These renorm alizations involve the behavior of the correlator $_1(u)$ at the origin whose grow that long length scales is crucial for the renorm alization group analysis, see the above discussion. We can keep track of the most dangerous term s by substituting $_1^{(0)}(u)$ by $_1^{(0)}(0)$ in (91). The renorm alization of the cum ulants $_1^{(n)}$ from the above process can be written in the form

furtherm one, there are non-linear term s that create higherm on ents from low erm on ents, see appendix C.As $\binom{0}{1}(0)$ grow sexponentially with l, i.e., as a power of the length scale, the cum ulants $\binom{(n)}{1}$ grow very rapidly. The n² coe cient and the positivity of $\binom{0}{1}(0) / 1=T_1 / e^{-1}$ in Eq. (92) in ply that the high orderm on ents grow so fast that ratios of the form $\binom{(n)}{1}=\frac{1}{n}$, which naively are expected to be dimensionaless (in the RG sense), then selves grow exponentially with increasing length scale. Indeed, the high orderm on ents increase so rapidly with n that, if these results are taken literally, the distribution of 1(z) has such a long tail that it is not uniquely determined by its moments | and it is certainly not well characterized by its mean 1(z) = 1. Note that a random friction 1(z) is not dangerous near the zero-tem perature depinning transition (f f_c f_c) as in this case $\binom{0}{1}(0)$ should be substituted by $\binom{0}{1}(0+) > 0$ and Eq. (92) suggests that $\binom{(n)}{1}$ renorm alizes to zero for any n (although it will actually be stabilized at a small value of the order of an n-dependent power of because of other terms).

The analysis in appendix C shows that even if initially the friction is non-random, the disorder term alone will generate the corrections to the second cumulant. The second cumulant will then generate the third cumulant to the next loop order, and so forth. As the cumulants grow extrem ely rapidly, the RG ow becomes essentially uncontrollable. However note, that there is still an approximation in the above analysis: we have substituted the argument of the second derivative of the disordered correlator $\begin{pmatrix} 0 \\ 1 \end{pmatrix}$ (u) by zero in Eq. (91). In order to be accurate we have to include the term s of the form

cf. Eq. (91), into the action, i.e., we have to renorm alize one more function $F_1(u)$. Under the RG transform ation this function will produce a new set functions, and so forth | it is presently unclear how all these variables can be analyzed in a regular way.

O ne way that one m ight hope to m ake progress is to rew rite the equations of m otion so that instead of having to deal with a random on the left hand side, one works with a random m obility = 1= on the right hand side. This quantity, as it is bounded from above by the fastest m otion, is unlikely to have troublesome long tails in its distribution. But the appearance of a random m obility multiplying all the spatially random pinning forces introduces additional technical complications into the form alism and it is presently not clear how to handle them. Nevertheless, there are a lot of constraints on the renorm alization, e.g., the static response will not be m odi ed by the random ness of either the pinning or the m obility at any wavelength. W hether this is enough to make possible a fully controlled analysis of at least the classical therm al creep regime is an interesting challenge.

B.Underlying Form ulation

It is possible that the apparent runaway of the distribution of the local friction coe cients is indicative of a breakdown in the basic scaling assumption that underlies this and earlier work: If the barriers for motion scale with an exponent that is larger than the exponent = d + 2 controlling the scaling of uctuations in m in in alenergies and the renorm alization of the inverse tem perature, then the present scheme where the dynam ics is controlled by static properties, such as the correlator (u), cannot be valid. One then has to take into account all the dangerous variables discussed above.

It is instructive to go back to the original form ulation of the RG expansion for the depinning in the absence of uctuations³³, henceforth NF. In the derivation of the ⁴ theory from the Ising model for conventional equilibrium phase transitions, the starting point is an expansion around a mean eld theory and the actual \ eld" (x) used in the RG form ulation is closely related to the local eld ective eld | applied plus exchange | acting on a spin rather than to the spin itself. If the interactions are long but nite range, these elds will be slow ly varying in space and weakly uctuating, enabling a system atic expansion to be started.

NF focus on one segment z and use the linear combination u(z;t) of the displacements of other segments that determine the elastic force on z as the basic eld, which is hence intrinsically a coarse-grained quantity. The underlying local displacements we will here call w(z;t). The segment z feels a linear restoring force proportional to u(z;t) = w(z;t), plus the applied driving force, plus a quenched random pinning force that is a function of w(z), and therm all noise. The vertices in the elective eld theory are given by correlations and responses of w(z;t) to the time-dependent elds u(z;t). In particular, the force-force correlator (u) that plays an essential role is related to the average

over the random pinning forces and, at positive temperature, them allooise. In general, is a functional of u(z;) over all times . For zero temperature depinning, the case of primary interest, the possible elds u are limited to those that are non-decreasing in time. In this case, it can be seen that the crucial parts of (which are su cient to analyze the depinning critical behavior) depend only on u(z;t) = u(z;t) and the functional simplifies to a function of this one variable: it is then of the form assumed for (u). In particular, if u does not change between t and t⁰, w will not change either unless the w at the earlier time was the cause of a jump out of a form erly stable con guration into another; this jumping case can be handled by putting in time delays into the denition of u and, beyond this, the local dynamics will be independent on the history of u prior to time st and t⁰.

As soon as one considers a more general dynam ics | e.g., still uctuationless but with the applied force allowed to decrease with time, non-monotonic stress transfer kernels, or thermal noise | the simplication of the functional does not occur. In general, it is then not clear how to proceed. In the case of interest for the present paper, one could rst assume, as in all expansions about a mean eld theory, that the elds are slow ly varying in space and time and weakly uctuating about a uniform ly advancing solution which has a slow mean velocity v. The local displacements will lag behind due to the pinning but will be pulled ahead by the driving force: the balance of these e ects determines the velocity (force relation. W ith thermal uctuations, the displacements will lag less than they would otherwise because at low velocities they have the time to sum ount energy barriers. Consider now the e ects of a time dependent change in u(z;t) on hw (z;t) i. If this change is very slow, w will follow approximately adiabatically. But if the change is relatively fast | as it can be due to the fast motion of a neighboring segment over a barrier | how the local displacement w will respond will depend crucially on whether it has already been near a sum ountable barrier for some time, and thus is likely to have already sum ounted it, or has recently arrived near a barrier and could thus be pushed over it by the change in u. Thus we expect the responses and correlations of w to depend on the whole prior (and intervening) history of the elds u.

The basic issue that must be addressed to make further progress is whether or not the essential information about the basic activation processes can be subsumed in simplied functions, such as the force-force correlator (u u⁰), that appear in the formulation used in the present paper (note, how ever, that as we are performing an epsilon expansion, the central limit theorem is likely to be helpful: as we go from one scale to another, we can always assume that there is a large number of segments (or elective intermediate scale segments) whose dynamics contributes to the elds on larger scales). One possible route to proceed is to start by considering the nature of the typical elds that will arise from the thermally activated motion of large segments on the dynamics at smaller scales and ask whether the local responses to these are typically simple enough to be captured by the type of approximations used here.

We leave further work on these points as a challenge for the future. It is worth noting, how ever, that the physical origin of the problem s, the intrinsic history dependence of the phenomena of interest, arise in many other non-equilibrium systems with many degrees of freedom. Better understanding of them in this context is thus likely to bear fruit more generally.

C.Alternative Expansions

M any of the di culties encountered in this paper would be lessened if the energy scale | and hence the barriers | did not grow rapidly with length scale. One way to get around this di culty might be to consider an expansion about a di erent limit, one in which not only the roughness exponent is small, but also the scaling exponent for the energy. In d-dimensionalmanifolds with long range elastic interactions that fallo as $1=r^{d+}$ with 0 < < 2, the upper critical dimension for both uctuationless depinning and rough manifolds in equilibrium is $d_c = 2$ (i.e., = 0 at $d = d_c$). The energy scaling exponent is = d + 2 so that for small, (g) = is also small. One might then hope to attempt an expansion in and = d_c d simultaneously. This would have the advantage that, assuming the barrier scaling exponent is also small for small near d_c , the exponential dependence of the velocity on the length dependent barriers would be relatively weak and hence, perhaps, system atically controllable. W e m ust also leave this and other possible limits about which m ore controllable expansions might be attempted for future research.

D.Quasiclassical Langevin Equation

In addition to potential problem swith the renorm alization group form ulation that are analogous to those discussed above for classical creep, in order to obtain results for quantum creep we have resorted to a quantum Langevin equation to approximate the quantum dynamics. We would like to be able to investigate this form alism more deeply and understand its limitations and regimes of validity. It is instructive to rst consider simpler problem s.




FIG.5. Tunneling of an overdam ped particle out of a 1D potential well in the presence of an external force f. The quantum mechanical answer for the tunneling action is of the form $S / 1=f^2$, f! 0. The action obtained via the QLE is determined only by the region $x_0 < x < x_1$. Since $x_1 = x_0 = x_2 = x_1$, the QLE overestimates tunneling e ects (i.e. gives smaller action).

The QLE can be used to analyze tunneling of a single particle if the barrier separating the m etastable state from the lower-energy stable one has a single characteristic height and width. In this case the tunneling action obtained from the QLE di ers from the true one only by a factor of order unity. In principle, the QLE can lead to an overestim ation of the tunneling rate. For example, consider an overdam ped particle (w ith viscosity) in a 1D potential well U (x) of depth U_0 with a m inim um at x = 0 and U (x) rapidly decaying for x ! 1. In the presence of an external force f, see Fig. 5, the well becomes m etastable and the particle will leave. The quantum action S can be estimated as

This action is dominated by a region of width 1=f where the potential U (x) is negligible but fx is less than the depth of the well: this yields S / $1=f^2$ as f ! 0. If we use the QLE approximation, the tunneling action would be

much smaller than the true W KB value in the limit f ! 0: since the QLE is a local approximation, the only relevant part of the potential would be that for $x < x_1$, with x_1 the point where U (x) fx is maximal. In the QLE, once the random force that obeys the quantum uctuation {dissipation theorem brings the particle to the point x_1 , the particle can have the well and the region $x > x_1$ that dominated the W KB action does not matter. Since in the limit $f ! 0, x_1 x_0 x_2 x_1$, the tunneling action obtained within such an approach is much smaller than the correct one, $S_{QLE} ' (x_1 x_0)^2 S$; the QLE can thus drastically overestim ate tunneling rates.

We believe, how ever, that for the quantum creep problem considered in this paper the QLE should be a reasonably accurate approximation for the action whose exponential determines the velocity (81): in the naive scaling arguments, the elective potential wells that segments must tunnel out of have only one characteristic width and height. Nevertheless, the results we obtain from the QLE and RG analysis yield a much largere ective action for the tunneling than the naive scaling arguments. The source of this is unlikely to be due to the QLE approximation as, by analogy with the single particle case above, we would expect that, if anything, then the QLE would underestimate the tunneling action. This argument is reinforced by noting that the scaling analysis in section III can be applied directly to a system driven by a stochastic force obeying the quantum FDT for which the QLE is exact: these would lead to the same results as those obtained from the scaling arguments for the full quantum dynamical problem, see also Ref. 26.

VI.CONCLUSIONS

In this paper we have considered the motion of an elastic manifold driven through a disordered medium at low tem peratures where quantum uctuations are in portant. We have focused on the lim it of sm all driving forces (f f_c) for which the average velocity of the manifold is small and dom inated by quantum tunneling through barriers between locally stable con gurations. Using an at-least-partially controlled RG expansion, we nd that the resulting creep velocity is exponentially sm all in a power of 1=f. W hile for strong dissipation we nd an interm ediate range of forces where the creep law agrees with the result of simple scaling estimates (up to logarithm ic corrections, cf. (17) and (83)), we nd that the results of the RG analysis are more complex. In particular, at asymptotically sm all forces the creep velocity has the non-trivial form (81), com bining an underlying massive (or other high-frequency) dynamics with an unexpected non-Arrhenius-like dependence on h. The structure of the renorm alization group ow is rather subtle and very di erent from that for classical creep. In particular, because of the importance of both rapid motion during a tunneling event and the slow overall motion, it is necessary to consider the dynam ics of the manifold at all frequencies !. This is in contrast to the classical case for which Chauve et al.¹² considered only the low-frequency lim it of the dynam ics. In the quantum case such a low -frequency approximation would lead to a spurious "localization transition" with the average velocity of the manifold dropping to zero at a smallbut nite value of the driving force. A lthough future in provem ents based on the analysis of the com plete quantum mechanical action (9) rather than the quantum Langevin approximation might change some of the results presented here, we believe that the main feature, the importance of the whole spectrum of frequencies for the tunneling dynamics, will persist.

In spite of the subtleties that appeared in the analysis we have carried out there are further di culties associated with both the broad distribution of barriers and the underlying eld theoretic form ulation of expansions about m ean eld theory. A lthough we have not resolved all the di culties, and thus are not sure whether the present results are truly system atic, we have noted the physical and form all sources of the problem s in ways that we hope will help direct future progress.

APPENDIX B:FIXED POINT FUNCTION OF THE CORRELATOR

APPENDIX C: DANGEROUS RELEVANT VARIABLES

A s m entioned in section V A, the RG ow generates dangerous relevant variables corresponding to the cum ulants of the friction distribution⁴¹. From a physical point of view, the friction coe cient in the equation of motion (4) is always spatially inhom ogeneous due to the presence of disorder, so that the bare values of the cum ulants describing the friction distribution are always nonzero. It turns out that under the RG transform ation these cum ulants grow

extrem ely rapidly and the description of the therm ally activated or quantum motion in terms of the renormalized viscosity $_1$ or the function $D_1(!)$ (see section IV D) alone is not appropriate. Since the renormalized viscosity on a certain lengthscale corresponds to the waiting time on this scale, we conclude that the broad distribution of the friction (it is broad as the cum ulants grow very rapidly) in plies a broad distribution of waiting times. Hence, the proper description of the problem requires renormalization of the waiting time probability distribution function rather than its rstm oment alone. The main goal of this appendix is to show how the dangerous variables are renormalized under the RG ow . We will also show that even if initially all of them are zero, they will be generated by the random pinning. We will restrict ourselves to the case of high tem peratures; the same variables will be generated in the quantum case.

Let us assume that the friction in the equation of motion (4) is a spatially inhomogeneous function of the coordinate; in general, = (u;z). For simplicity, we neglect the dependence on u (this does not change the result qualitatively). A physical realization where this approximation is valid is the pinned charge-density-wave: the friction

(u;z) is a periodic function of u and, hence, can be expanded in a Fourier series; (z) then is the u-independent (the zeroth) harmonic. Below we will assume that the -disorder and the -disorder are uncorrelated and short-ranged; in reality, these two types of disorder should be correlated. If we take these correlations into account, the dangerous variables will still exist and the RG ow will be similar. In this section we assume that the response function has the form $1 = ck^2$ i₁!, i.e., we do not consider the full dynam ic response associated with D₁(!); this approach is valid in the classical case, see sections IV C and IV F.




FIG.6. Elements used in diagram s: (a) the displacement eld u; (b) the iy-eld; (c) the response function $R^{>}$; (d) crosses denote derivatives, with respect to time in the u-eld if the cross is on a solid line, or with respect to the time di erence in the response function if the cross is on a response function line; (e) diagram matic representation of the correlator ; (f) diagram matic representation of random friction terms (1^{n} (n) $\underbrace{u}(z;t_{k})$ iy (z;t_{k}), see (C1); dots ::: stand for further om itted lines.

In the last equation, we have used (C 3) in order to express averages over fast modes through response functions and have integrated over z^0 using (C 5).




FIG.7. Dangerous diagram s contributing to the renorm alization of the cum ulants of the friction-coe cient distribution. These terms arise from averaging over fast modes in $hA_{rand}A_{dis}i_{>}$: (a) with multiplicative factors n (n 1) (due to the permutation symmetry), (b) with multiplicative factor 2n, (c) with multiplicative factor 2n (n 1), (d) with multiplicative factor n (n 1)=2. For convenience we draw some of the iy-elds and response functions at a 45 degrees angle or deform the lines.

Note that in the diagram matic language integrating by parts corresponds to drawing u-eld lines out of the wavy vertex and moving crosses (i.e., time-derivatives) from the response functions down to the displacement elds. The low-frequency expansion of the diagram in Fig.7 (a) then takes the form of the diagram in Fig.6 (f) [this low-frequency analysis involves the expansion of the argument u (z; 1) u(z; 2) of the correlator in a Taylor series in powers of $\begin{pmatrix} 1 & 2 \end{pmatrix}$; the rst term (equal to zero) of this expansion produces the desired contribution]. The rst two terms in the curly brackets do not feed back to the random friction cumulants, while the third and fourth terms give the desired contribution. The multiplication factor of the diagram in Fig. 7 (d) is equal to n (n - 1)=2.




FIG.8. D iagram s describing the generation of the second cum ulant of the friction distribution; their low -frequency expansions feed back to the second cum ulant.

The system of RG equations (C17) and (C18) has been derived to low est order in 4 . To next order, the second cum ulant will generate the third cum ulant. To third order, the third cum ulant will generate the fourth cum ulant, etc., i.e., all cum ulants will be generated in the RG ow even if all of them (except for the rst one) are equal to zero initially. From a physical point of view, the friction will always be random as the point-like in purities suppress the order parameter random ly and, hence, the dynamic characteristics of the medium (e.g., a superconductor) is random as well. Since $\binom{0}{1}(0) / 1=T_1 / e^1$ and the correction due to disorder grows as n^2 for large n, the random friction probability distribution becomes very broad and one needs to take into account all its moments and not just the friction $_1$ only. In order to obtain Eqs. (C17) and (C18) we have made the approximation $u(z;t_1) = 0$ in the nal expressions for D_1 , D_3 , D_1 , and D_2 ; in general, how ever, one needs to renorm alize the full functional (93). During the RG procedure, other terms will be generated and it is unclear at this stage how to take all these terms into account in a controllable way.
