D ynam ical surface structures in multi-particle-correlated surface grow ths

We investigate the scaling properties of the interface uctuation width for the Q-m er and Q-particle-correlated deposition-evaporation m odels. These m odels are constrained with a global conservation law that the particle number at each height is conserved m odulo Q. In equilibrium, the stationary roughness is anom alous but universal with roughness exponent = 1=3, while the early time evolution shows nonuniversal behavior with grow the exponent varying with m odels and Q. N onequilibrium surfaces display diverse growing/stationary behavior. The Q-m er m odel shows a faceted structure, while the Q-particle-correlated m odel a m acroscopically grooved structure.

I. IN TRODUCTION

Since the dynam ical scaling theory for kinetic surface roughening [1] was suggested, num erous surface grow th m odels have been studied [2]. The interface uctuation width W developed during time t, starting from the at surface, follows the scaling ansatz

$$W (L;t) = L f(\frac{t}{L^{Z_{W}}}); \qquad (1)$$

where L is linear size of the substrate. The scaling function f(x)! const: for x 1 and f(x) x (= $=z_W$) for x 1 [1,2]. One-dimensional (ID) models with conventional local growth dynamics display the universal roughness exponent = 1=2, as exemplied in the K adar-Parisi-Zhang (KPZ) universality class [3] and the Edwards-W ilkinson (EW) class [4].

A 1D surface can be mapped on the time trajectory of a particle in 1D by identifying the heighth (x) at each column x with the particle position n (t) at time t = x. The step heights are bounded and uncorrelated beyond a nite distance in the substrate direction. This im plies that the particle performs a random walk without long-range di usion and long-range tem poral correlations, which is the characteristic of the norm al random walks. Therefore the interface width scales with exponent = 1=2, corresponding to the dispersion of norm al random walks: n (t) $t^{=2}$.

Recently, Noh, Park, and den Nijs [5] introduced a dissociative dim er deposition-evaporation model with restricted solid-on-solid (RSOS) constraint. The surface grows and erodes by the deposition and evaporation of dim ers aligned with the surface. These dim ers dissociate on the surface such that evaporating dim ers do not necessarily consist of original partners. They found that the equilibrium surface is anom abusly rough with = 0.29(4) and conjectured the exact value of = 1=3 by exploring a close relationship between the dim erm odel and the even-visiting random walk model [5,6]. They also argued that the anom alous value of = 1=3 is universal in generalized Q-m er type equilibrium models (Q 2).

The Q-m er aspect requires that the num ber of particles at each surface height level m ust be conserved m odubQ. The dissociative nature translates it into a nonlocal global constraint. So 1D surfaces of Q -m er m odels correspond to tim e trajectories of a random walker with a global constraint that the walker should visit each site (height level) Q multiple tim es before it term inates. The dispersion of Q-visiting random walkers (QVRW) is much more suppressed than the norm alones and be $t^{=3}$ for Q haves asymptotically as n(t) 2 [6{8]. This leads to the conjecture that the roughness exponent is = 1=3 for general Q -m er type equilibrium m odels except for the monom er lim it (= 1=2 for Q = 1).

However, the QVRW ensemble is not equivalent to the ensemble generated by the Q-mer dynamics. In fact, there exist in nitely many constants of motions in the Q-m er dynam ics. For example, the Q-m er dynam ics conserves a local-type quantity. Upon deposition/evaporation of a Q-mer, the surface heights at Q consecutive columns change by one unit simultaneously. It leads to conservation of k = 2 = Q component of the Fourier transform ed surface height, de ned $\sum_{x=1}^{n} \exp [ikx]h(x)$. Surface con gurations as ĥ(k) with di erent values of fi(k = 2 = Q) are dynamically disconnected by the Q-merdynamics. The phase space for the QVRW ensemble is divided into dynam ically disconnected sectors, labeled by \tilde{h} (k = 2 = Q). However, there is much more com plex structure inside each sector. Each sector decom poses into in nitely many disconnected subsectors, which can be characterized by a nonlocal construct, i.e. so called irreducible string [9]. Therefore, the Q-m er dynam ics is strongly non-ergodic and the scaling property m ay be sector-dependent.

Starting from a at surface of size L as multiples of Q, one can explore only a subsector (null string) with $\Re (k = 2 = Q) = 0$. Numerical results for dimer dynamics [5] show strong nite size corrections and the extrapolation to in nite size limit overshoots signi cantly the expected value of = 1=3 [5], even though statistical errors are too large to conclude whether this overshooting is real.

This may be due to strong non-ergodic behavior of the Q-m erdynam ics. In Ref. [6], N oh et al. allow di usion of a single particle on a terrace, which restores broken ergodicity partially. Jum ps across steps are forbidden. A certain combination of deposition/evaporation and di usion may be equivalent to a process of deposition/evaporation of Q particles not necessarily at Q consecutive colum ns but random ly placed on a terrace. It clearly does not conserve h (k = 2 = Q) and opens some dynam is for Q = 2 still show strong nite size corrections but the overshooting is weakened and the estim ated asymptotic value of = 0:31 (3) is a little bit closer to the conjectured value of 1=3 [6].

In this paper, we introduce a new model that fully restores the ergodicity. We allow deposition/evaporations of Q particles at random ly chosen Q columns with equal surface heights. These columns do not necessarily share the same terrace. These processes still conserve the global mod Q conservation at each height level and open all possible dynamic connections between sectors. We call this model as Q -particle-correlated depositionevaporation model. The ensemble generated by this new type dynamics should be equivalent to the QVRW ensemble. As we shall see later, we nd that the nite size corrections for Q = 2 are still considerable but the overshooting is fairly reduced. Our estimate for is now ' 0:33(3), which is fully consistent with the QVRW

conjecture.

W e also investigated the scaling properties for Q -m er m odels and Q -particle correlated m odels for Q = 3 and 4. Interestingly, the asymptotic scaling seems to set in m uch earlier than Q = 2 m odels and the estimated values of are very close to 1=3 in both m odels. These results may suggest that the phase space structures for Q = 2 and Q 3 bear an intrinsic di erence like in the m onolayer version of the Q -m erm odels [9].

T in e-dependent behavior in early time regime is much m ore complex and sector-dependent. Various interesting dynam ic properties have been reported by G rynberg in the body-centered solid-on-solid (BCSOS) version of Q-m er m odels [10]. In this paper, we focus only on a subsector (null string) containing a at surface. O ur num erical results show that the scaling exponent in Eq.(1) varies slightly but de nitely with Q in both Q-m er and Qparticle correlated m odels. O ur estimated values of for the Q-m er m odels are consistent with those for the BC-SOS version, but di erent from those for the Q-particle correlated m odels. It may re ect non-ergodic nature of the Q-m er dynam ics. In contrast to the universal scaling property in the steady state (universal), the dynam ic properties characterized by vary with m odels and Q.

Excursion o equilibrium in mediately changes the surface structure drastically [5]. W ithout balance between deposition and evaporation, the surface grows or erodes inde nitely with time. In the Q-mer models, these nonequilibrium surfaces turn out to be always faceted due to spontaneous form ation of pinning valleys or pinning hill tops [5]. In nite systems, the surface displays a repeated jerky motion in time, i.e., alternating series of locking in a facet shape and unlocking/evolving into another facet shape. Time scale of this jerky motion is dom inated by duration of a facet shape, which diverges exponentially with system size. The global facet structure in the steady state assures that the interface width W scales as system size L (= 1). A long with the exponential time scale, one can predict that W logt for early time regime. These results are con immed numerically.

In case of the Q-particle-correlated models, nonequilibrium surfaces are not sharply faceted but display a global grooved structure with considerable local uctuations. This surface is similar to those found in the conserved RSOS (CRSOS) model [11]. The roughness exponent is found to be = 1:00 (5) for all Q 2. Early time grow th behavior is governed by a power law with nonuniversal exponent varying with Q and the magnitude of deposition/evaporation bias.

Outline of this paper is as follows. In Sec. II, we introduce the Q-particle-correlated models as well as the Q-m er models. In Sec. III and IV, we present num erical results for the scaling properties of the equilibrium and nonequilibrium surfaces, respectively. Similarities and di erences between two models are discussed. We conclude with a brief sum mary and discussion in Sec.V.

II.M ODELS

Consider the 1D surface con gurations described by integer height variables h(x) = 0; 1; 2; ... with x = 1; ...; L. They are subject to the RSOS constraint, <math>h(x) = h(x + 1) = 0; 1, and periodic boundary conditions, h(x + L) = h(x).

The growth rule for the Q-particle-correlated deposition-evaporation model is as follows. First, select Q columns $fx_1;x_2; :::;x_Q$ g random ly. These columns do not have to be adjacent to each other. If the heights $fh(x_j)g$ of the selected columns are all equal, i.e., $h(x_1) = ::: = h(x_Q)$, then simultaneous deposition of Q particles, $h(x_i) ! h(x_i) + 1$ for i = 1; :::, Q, is attempted with probability p, or simultaneous evaporation, $h(x_i) ! h(x_i) 1$ for i = 1; :::, Q, with probability q = 1 p. Any attempt is rejected if it would result in violating the RSOS constraint. If any selected column height di ers from other selected one, no dynamics occurs and we select a new set of Q columns random ly. A fter L such selection processes, M onte Carlo time t is incremented by one unit.

The equal height condition, $h(x_1) = \dots = h(x_Q)$, constrains a set of selected columns and generates correlated

grow th. W ithout this condition, any set of random ly selected columns can evolve and the ordinary monom ertype R SO S model is recovered. One can consider a more restrictive constraint on selected columns. An interesting and limiting case is to require the immediate adjacency of selected columns. This is the dissociative Q -m er deposition-evaporation model. In this Q -m er model, we attempt to select Q consecutive columns only. The other evolution rules are equivalent to the Q -particle-correlated model. The generalization of both models to higher dimensions should be straightforward and will be discussed elsewhere [12]. In this paper, we focus on 1D cases only.

III.EQUILIBRIUM SURFACES

W ith balance between deposition and evaporation processes (p = q), the detailed balance condition is satis ed. In the stationary state, the G ibbs-type equilibrium surface is obtained. In this section, we investigate the scaling property of the equilibrium surfaces for the Q-m er and Q-particle-correlated m odels and also their dynam ic property approaching to equilibrium. We measure the interface uctuation width W as

$$W^{2}(L;t) = \frac{1}{L} \frac{X^{L}}{x=1} h(x;t) \frac{1}{L} \frac{X^{L}}{x=1} h(x;t) ; (2)$$

where L is the substrate size. We start with a at surface of size L as a multiple of Q, otherwise the surface is forcefully pinned to the initial position.

A .stationary state roughness

For nite size scaling analysis, we run M onte C arlo simulations for system size $L = 2^n$ (n = 4; :::;10) in case of Q = 2 and 4, and L = 2 3^n (n = 2; :::;6) in case of Q = 3. The interface width is measured and averaged over at least 100 independent M onte C arlo runs for each system size. It grows in early time regime and saturates to a nite value, which depends on size L. We again average over data in the saturated regime (t L^{z_W}) to estim ate the stationary value of the width, W (L;t=1).

As explained in Eq. (1), W (L;t = 1) scales as L in the large L limit. Fore cient data analysis, we introduce e ective exponents $_{\rm eff}$ as function of L

$$_{eff}(L) = \frac{\ln W (2L; t=1) \ln W (L; t=1)}{\ln (2L) \ln L}; \quad (3)$$

The value of can be retrieved by taking the L ! 1 limit for $_{\rm eff}$ (L).

E ective exponents for the Q-m er m odel are plotted against 1=L in Fig. 1. For the dimer case, one can see usual 1=L type nite size corrections for small L, but strong crossover corrections near $L = 2^8$. The extrapolation of $_{eff}$ to the in nite size limit seems to overshoot signi cantly the expected value of = 1=3. However, the statistical errors are too large to conclude that our num erical results exclude the possibility of = 1=3. In fact, it is quite di cult to reduce statistical errors considerably with moderate computing usage, because W is very small even for large L (less than 4 for $L = 2^{10}$). We estimate = 0.29 (4) for the dimermodel. For Q = 3 and 4, we do not not strong crossover corrections and our num erical data converge to = 1=3 very nicely. We estimate = 0.32 (4) for the trim erm odel and = 0.33 (3) for the 4-m erm odel.

D ata for the Q-particle-correlated m odels are shown in Fig. 2. For Q = 2, we nd again strong crossover corrections, but the overshooting is fairly reduced. W e estimate = 0.32(3); 0.33(2) and 0.32(4) for Q = 2;3, and 4, respectively. These results are fully consistent with the QVRW conjecture.

B.T im e dependent behavior

In this subsection, we investigate the early time behavior of the interface width. We measure the interface width for system size L = 10^4 for Q = 2 and 4, and L = 2 $\frac{4}{9}$ for Q = 3 up to t = 10^5 5 16 and average over at least 100 independent samples. In early time regime (t L^{Z_W}), it grows algebraically as W t, see Eq.(1). To estimate the value of , we introduce e ective exponents eff as a function of t

$$_{eff}$$
 (t) = $\frac{\ln W$ (t) $\ln W$ (t=10)
 $\ln t$ \ln (t=10): (4)

The value of can be retrieved from the long time limit for $_{\rm eff}$ within t $~L^{\,z_{\mathbb N}}$, where nite size e ects are negligible.

E ective exponents for the Q -m erm odel and the Q particle-correlated model are plotted against t in Fig. 3 and 4, respectively. A fifer initial transients, $_{eff}$ become stabilized around an asymptotic value. We estimate by averaging $_{eff}$ in the stabilized regime. As seen in Fig. 3, the estimated values for are 0.108(1) for the dimer, 0.100(1) for the trimer, and 0.098(3) for the 4merm odel. Surprisingly, the value of decreases slightly but de nitely with Q. Our noting is consistent with the result for the BCSOS type Q-merm odel [10].

The Q-particle correlated models show even strong variance of on Q. >From Fig. 4, we estimate = 0.194(1), 0.140(2), 0.097(2) for Q = 2, 3, and 4.0 ur results suggest that continuously varies and approaches zero in the large Q limit.

The steady state scaling is quite universal and does not depend on Q (2). This universality has been well established through a mapping to the Q-visiting random

walks [6]. In contrast, our num erical results strongly support nonuniversal dynam ic scaling depending on Q. As yet, we do not have any reasonable explanation for this type of nonstandard scaling behavior.

It is not quite supprising that the Q-m er and Q-particle-correlated m odels display di erent dynam ic scaling behaviors. The Q-m er dynam ics are not ergodic, in contrast to the Q-particle-correlated dynam ics. The non-ergodicity slows down the dynam ics and the growth exponent should be smaller, which is consistent with our num erical nding.

It is interesting to see that initial transients for the Q-m er and the Q-particle-correlated models are completely upside down. We can give a reasonable explanation for this. In case of the Q-m erequilibrium model, it is clear that the early time behavior resembles the Edward-W ilkinson type (monom er model), because the system does not feel the Q-m er aspect initially before pinning valleys/hilltops start to form. So, eff should decrease from $_{\rm EW}$ = 0.25 to converge to the asymptotic value. The Q-m er aspect should appear earlier for larger Q with the same substrate size. We expect that the initial transients survive for shorter period for larger Q, which can be seen in Fig. 3.

In case of the Q-particle-correlated model, it is very di cult to grow the surface at the beginning. As Q particles deposit on random ly placed Q sites, it is di cult to form aggregated islands on which one can deposit more particles to grow the surface. So in the very early time regime, the surface would grow in a layer-by-layer fashion. So $_{eff}$ will start from zero and increase to the asymptotic value. Here, the initial transients last longer for larger Q. The rejection rate for the Q particle deposition/evaporation on the random ly selected sites increases exponentially with Q. In fact, the initial transient behavior is so huge for Q = 4 that we use a rather sm all substrate size L = 10^3 in Fig. 4.

IV . NONEQUILIBRIUM SURFACES

W ithout balance between deposition and evaporation (p \notin q), the surface may grow (p > 1=2) or erode (p < 1=2) inde nitely with time, if one starts with a at surface of size L as a multiple of Q. Due to the time reversal symmetry, the growing surface at deposition probability p should be identical to the inverted eroding surface at 1 p. In the monomer version (Q = 1), it is well known that the unbalance (p \notin q) becomes a relevant perturbation to the EW xed point and drives the system into the KPZ universality class. In this section, we investigate the scaling property of the nonequilibrium growing/eroding surfaces for Q 2.

The nonequilibrium surfaces for the Q -m erm odel and the Q -particle-correlated m odel show com pletely distinct characteristics in both dynam ic evolution and stationary m orphology. The form er ones always facet, while the latter ones form global grooved structures. For clarity, we discuss these two models separately in this section.

A.Q-m er m odel

The nonequilibrium surfaces of the Q -m erm odel display sharply faceted structures. Fig. 5 shows the time evolution of surfaces for the dimerm odel at p = 0.6 and 0.1 in a typical simulation sample. In the growing surfaces, the faceting is caused by the spontaneous form ation of pinning valleys. For the dimerm odel, any at segment with odd size acts as the nucleus of a pinning valley. Such valleys can not be led up by deposition of dimers and one empty blocked site always remain at the valley bottom . Pinning valleys can annihilate only in pairs, and only if their valley bottom s are at the same height. Therefore, the only way to remove pinning valleys and grow the surface is the evaporation of the entire hill between two pinning valleys.

In nite systems, the surface moves like shock waves. The initially at surface evolves into a faceted shape with only two remaining pinning valleys. The valleys are sharp and the hilltops are rounded with a typical size $_0$. Approaching the equilibrium point, $_0$ diverges and the facets disappear. The annihilation time of this last pair scales exponentially with system size. A fler its annihilation, the surface grows into another faceted shape very fast and the whole evolution repeats itself. D etails of this motion have been reported in Ref. [5].

For general Q -m er m odels, there exist Q 1 di erent kinds of pinning valleys with n empty blocked sites at the valley bottom (n = 1;2;:::;Q)1). Two pinning valleys with n and m empty blocked sites merge into a pinning valley with n + m empty blocked sites. W hen n + m is a multiple of Q, the valley can be led up and the surface can grow. Even though the surface evolution details are di erent for each ${\tt Q}$, the basic evolution characteristics are equivalent, i.e., a repeated jerky motion of locking into a facet shape and sudden evolving into another facet shape. Time scale of this jerky motion is dominated by exponentially long duration of a facet shape. If one starts with a at surface of size L that is not a multiple of Q, at least one pinning valley always survives and the surface is pinned to the initial position.

The interface width W of the faceted surface in Fig.5 should be proportional to the substrate size L. Therefore, the stationary roughness exponent is trivially = 1. E ective exponents $_{eff}$ for the Q-merm odel are plotted against 1=L in Fig.6. As expected, $_{eff}$ converge to 1 for all Q. For sm all sizes, nite size e ects are present due to nite duration time of the facet shape.

The early time growing behavior also can be predicted from annealing dynamics of pinning valleys. Starting

from a at surface, the surface grows fast at the beginning and m any pinning valleys appear. The presence of pinning valleys slows down the growth and the surface m ay grow only when two pinning valleys m erge together by annealing out the hill between them . As seen in Fig. 5, only a sm all region on the hilltops can be active by deposition/evaporation processes. Near the valley, the ram ps are inactive due to the RSOS constraint. So, the annealing time of the hill should scale exponentially with lateral size of the hill. A fter this tim e scale, the surface advances fast locally up to the order of the hill height. In the faceted structure, the hill height should be proportional to the hill size. In this point of view, one can conclude that the local surface uctuation should grow logarithm ically with time. A sany other time scale is present, we logt in the early time regime [5,10]. expect that W

In Fig. 7, we plot W against logt. For all Q, it shows a nice linear behavior. For clarity, we assume that W [log t] and plot e ective exponents $_{eff}$, de ned similarly in Eq. (4), versus t in the inset. They converge rather slow by but nicely to 1. We estimate that = 1:1(1).

B.Q-particle-correlated m odel

Surface morphology for the Q-particle-correlated model is very surprising. Fig. 8 shows the time evolution of surfaces for Q = 2 at p = 0.6 and 0.1 in a typical simulation sample. In contrast to the Q-mermodel, the surfaces are not faceted but show a global grooved structure with considerable local uctuations.

Starting from a at surface, sm all scale hills and valleys start to form and merge into a few macroscopic hills and valleys. These macroscopic hills/valleys contain considerable roughness in microscopic scale. E specially the hilltops of the growing surface are broad and rough with high activity of deposition/evaporation processes. In contrast, the valley bottom s are rather localized and their ram ps are quite steep without much activity. However, they are not extrem ely localized or sharp as in the faceted structure of the Q-mer model. The valley bottom s do not last long exponentially with system size, but only algebraically. Therefore, there is no well-de ned repeated motion of the growing surface. A few macroscopic valleys merge and split stochastically in the steady state regime.

In Fig. 9, we plot $_{eff}$ against 1=L for Q = 2;3; and 4. We estimate that = 1:00(5) for all Q. In contrast to the Q-mermodel, the early time growth behavior for the Q-mermodel, the early time growth behavior for the Q-particle-correlated model is governed by a power law with exponent varying with Q and p. We plot $_{eff}$ against t at p = 0:6 in Fig. 10. Our estimates at p = 0:6 are = 0:460(1), 0.325(1), and 0.214(2) for Q = 2;3 and 4. The value of increases with increasing p (or deposition/evaporation bias). The power-law type growth is consistent with our groove form ation picture. The ram ps near the valley are still active, so the annealing time of the hill between two valleys does not scale exponentially but algebraically.

A similar grooved structure could be found in the so called conserved RSOS (CRSOS) model [11] and other models with roughness exponent 1 [2]. It may be quite interesting to investigate similarities and di erences among these models with grooved structures. For exam – ple, the grooved structure in the CRSOS model displays a sharp peak and a rounded valley, which is just the reverse of that in our model. Moreover, the physical origin for occurrence of macroscopic grooves is not well explored. More detailed investigation is left for the future study.

V.SUMMARY AND DISCUSSION

We investigated the scaling properties of the interface uctuation width for the Q-mer and Q-particlecorrelated deposition-evaporation models. Both models are constrained with a global conservation law that the particle number is conserved modulo Q at each height level. A 1D surface of these models can be mapped on a random walk trajectory with Q-visiting global constraint.

W hen deposition and evaporation are balanced, one can obtain G ibbs-type equilibrium surfaces in the stationary state. Then, the dispersion of the Q-visiting random walks (QVRW) can translate into the stationary roughness of equilibrium surfaces. However, the Q-m er dynamics is not ergodic and can not generate all possible QVRW con gurations. This non-ergodicity may generate huge corrections to scaling and hinder the numerical analysis for the stationary roughness. E specially for the dimer model, we found a signi cant overshooting of roughness exponent in nite-size-scaling analysis. In this paper, we introduce the Q-particle-correlated model that fully restores the ergodicity. O ur numerical study showed that the overshooting is fairly reduced and our estimate for is fully consistent with the QVRW result.

We also studied the time-dependent behavior in the early time regime. Interestingly, the growth exponent varies with models and Q (see Table 1), in contrast to the robustness of . Therefore, these models correspond to a series of new universality classes.

W hen the evolution dynam ics is biased, the surface can grow or erode inde nitely with time. A sthe detailed balance is violated, the steady-state surface con gurations do not form a G ibbs-type ensemble. We numerically investigated the scaling properties of these nonequilibrium surfaces. The Q -m erm odels display shock-wavelike evolutions and nally form a macroscopic facet, while the Q particle-correlated m odels follow an ordinary power-law type grow th and form a macroscopic grooved structure. Like in the equilibrium cases, the steady state roughness do not depend on Q, but the grow th exponent for the Q-particle-correlated m odels varies with Q and the deposition/evaporation bias. These values are listed in Table 1.

In summary, we found a series of new universality classes in deposition-evaporation models with a global conservation law. Even though the stationary roughness in equilibrium can be explained in term sofQVRW models, the growth diversity is not fully understood. The scaling properties for growing/eroding surfaces for the Q-particle-correlated models are surprising and wait for a reasonable intuitive explanation. G eneralization to higher dimensions are under current investigation.
