Strong charge transfer e ects in the M g2p 1 core-level spectrum of M gB $_2$

Abstract

The two available M g2p¹ core-level spectra of the recently discovered high-tem perature superconducting M gB₂ crystal exhibit interesting structures, but contradict each other. This motivated us to perform ab initio calculations on the core-level spectra of cluster models. The computed spectra reveal unusual rich and intense structures triggered by a B 2p_z ! M g3s,3p charge transfer.

The discovery of superconductivity below 39 K in $M gB_2$ [1] has triggered an avalanche of publications devoted to this and related compounds. The main reason for such an unprecedented interest in $M gB_2$ is that the mechanism responsible for the transition from a norm al to a superconducting state at the remarkably high temperature of 39 K seems to be the conventional BCS phonon pairing [2, 3, 4, 5, 6]. Thus, studying properties of M gB₂ m ay give a clue to the problem of the high-temperature superconductivity, where num erous scenarios other than phonon pairing have been proposed (see Ref. [7]).

In contrast to the known high-tem perature superconductors that contain atom s of d and f elem ents, M gB₂ consists of light atom s, which allows one to treat this compound using accurate ab initio m ethods. A coording to the electronic band-structure calculations reported in the literature [B, 9, 10, 11, 12, 13, 14], M gB₂ can be thought of as a compound m ade of honeycom b layers of electronically depleted M g and electronically enriched B (Fig. 1). There are, therefore, spatially separated layers of M g and B atom s that can play the roles of electron acceptor and donor reservoirs, respectively. D epending on the degree of exibility of the donor electrons, one m ay expect a charge instability in M gB₂ with respect to external perturbations. Such kind of instability in M gB₂ m ay be responsible for the excitation m ode involves coherent charge uctuations between the B and M g layers and, according to R ef. [15], m ay be of relevance for understanding the m echanism of high-tem perature superconductivity in M gB₂.

The properties of the ground state of M gB₂ that favour charge transfer processes at low excitation energies m ay also have an impact on the spectroscopy of highly excited states. In particular, the corresponding valence charge transfer (CT) excitations accompanying ionization of M g core levels m ay appear in the spectrum as shake-up (energetically above the intense m ain line) or even as shake-down (below the m ain line) satellites. The intensity and the energy of the satellites are controlled by the strength of the coupling between the core hole and the respective valence-excited core-hole congurations and by their relative energies. To zeroth order in the interaction with the core hole, the energy of the satellite relative to the energy of the main state (the state dom inated by the single core hole conguration) is equal to the energy of the respective valence excitation in the neutral system. In M gB₂ the

energies of the lowest valence CT excitations are estimated to be 0.5, 2.5 and 5 eV [15]. We, therefore, expect to nd low-lying CT satellites in the Mg core ionization spectra of this compound. The available experimentally recorded spectra dier substantially from each other [16, 17]

In the present paper we report an accurate ab initio G reen's function study of the ionization of M g2p electrons in M gB₆ and M g_2B_4 fragments of the bulk M gB₂ (as indicated in Fig. 1). In both clusters the M g2p spectrum exhibits markedly intense CT satellites at low energies. We also computed the ionization of a related new molecular M gB₆ cluster which is shown to be a stable species at its optim al C_{6v} geometry. The general appearance of the spectral features in this molecular cluster resembles that obtained for the bulk clusters.

DETAILS OF THE CALCULATIONS

Core ionization spectra were computed using the ab initio G reen's function (GF) m ethod within the algebraic diagram m atic construction scheme (ADC) in fourth order of the C oulomb interaction (ADC (4)) [18, 19]. This m ethod takes into account not only all terms through fourth order but also includes partial sum m ations of diagram s to in nite order. The GF ADC (4) m ethod accurately accounts for orbital relaxation. W hat is important is that the m ethod m aintains a balanced description of orbital relaxation and electron correlation. The GF ADC (4) m ethod has proved to yield a very good description of core ionization [19, 20, 21]. An integral-driven in plem entation [22] of the original ADC (4) code [23] was used, enabling us to handle cases where the explicit GF m atrix would have been too large to compute the whole spectrum (the size of the GF m atrices was 2,400,000 for M q_2B_4 and

1,200,000 for M gB₆ clusters). The Hartree-Fock orbitals and their energies used as input data for the G F AD C (4) m ethod have been calculated using the GAM ESS-UK package [24] with the 6-311G * atom ic basis for B [25] and M g [26]. In addition, the d function on M g is selected as prescribed in Ref. [27]. The quality of this medium -sized basis set for the G F AD C (4) core-hole calculations on M g and Be clusters has been assessed in Refs. [20, 28].

The nuclear geom etry in the M gB_6 and M g_2B_4 fragments of the M gB_2 crystal has been taken from R ef.[1]. The geom etry of the M gB_6 m olecular cluster has been optimized at the level of fourth-order M ller-P lesset m any-body perturbation theory. This results in a planar B_6 ring with a B-B distance of 3.012 a.u. and the M g atom is situated 3.346 a.u. above the

centre of the ring (C $_{6v}$ sym m etry). These distances are slightly di erent from those of the M gB $_6$ fragm ent of the M gB $_2$ crystal where the B-B distance is 3.367 a.u. and the M g atom is at 3.329 a.u. above the plane of the B ring. For the crystal structure see F ig. 1.

RESULTS AND DISCUSSION

Our computed M g2p ionization spectra are shown in Fig. 2 in comparison with the available experimental data. A key nding of our calculations is that the electronic structure of all the clusters responds quite strongly to the creation of the core hole in the M g2p levels. This strong response is mostly associated with the $B 2p_z$! Mg3s,3p charge transfer and m anifests itself in the appearance of satellite structures of considerable intensity, which, in the spectra of the M gB₆ clusters, can be seen at energies of 3, 6 and 10 eV (Fig.2). In the spectrum of the M g₂B₄ cluster the B! M g charge transfer gives rise to a prom inent satellite peak at 2 eV, with further structures again at 6 and 10 eV. The satellite peaks have been labelled A, B and C in the theoretical spectra of Fig. 2. It is suprising that, as the gure shows, these intense structures emerge by accumulation of intensity of num erous core-hole states. A general feature of all the spectra is that many low -lying individual shake-up and even shake-down satellites appear, some of them at energies as low as 0.1 eV below the main line, which is de ned as the line of highest intensity. The appearance of satellite peak A, especially in the spectrum of $M_{2}B_{4}$, is in good agreement with the experimental $M_{2}B_{2}$ spectrum of Ref. [16], which also exhibits an intense structure at 2 eV above the main line. This di ers rem arkably from the other experim ental M g2p spectrum of M gB₂ [17], also shown in Fig. 2. The latter shows an utterly di erent band shape and only a sm all hum p 2 eV above the maximum of the broad low energy band. can be discerned at

Let us begin our discussion with the $M g_2B_4$ fragment cluster. This cluster has the stoichiometry of the bulk $M gB_2$ and contains atom s of two adjacent unit cells of the crystal (Fig.1). A most intriguing feature of the $M g2p^{-1}$ spectrum of the cluster is that there is no isolated m ain line and actually a dominating m ain line does not exist at all (Fig.2). At low resolution a dominant peak, which we may denote as main peak, is seen in the spectrum, but this peak is broad and consists of m any lines with rather sm all individual intensities. The most intense among them exhibits an intensity as sm all as 22% of the total spectral intensity. We encounter here a breakdown of the main line which is very unusual for core

spectra of systems not containing d and f m etal atoms. The mechanism responsible for this breakdown, as well as for the appearance of the A, B, and C satellite structures in the spectrum, is a pronounced $B2p_z$! Mg3s,3p charge transfer.

In the ground state of the cluster an electron has been transferred from the M g atom s to the borons. The creation of the core hole in the M g2p level initiates a charge transfer in the opposite direction. By ionizing the M g2p level the charge is thus transferred back from the boron zigzag to the core-ionized M g sites. This transferred charge screens the initial core holes giving rise to the appearance of the satellite structures A, B, and C and to the breakdown of the main line. Each of the structures consists of very many individual states which are strong m ixtures of singly-excited and doubly-excited core-hole electronic con gurations, where in addition to the core hole one or two valence electrons are excited, respectively. In the spectrum, the satellites acquire their intensity by borrowing it from the core-hole con guration. The intensity borrowed is controlled by the strength of the coupling between the core-hole and the excited con gurations. U sually, the intensity acquired by states that are dom inated by doubly-excited con gurations is very small because the coupling of such con gurations to the core hole appears only in second order in the C oulom b interaction. By contrast, singly-excited states can acquire considerable intensity in the spectrum because their coupling to the core hole appears already in storder in the Coulomb interaction. In our case the following picture emerges. The valence doubly-excited states appear at 2 eV above the main line and their spectral density is much higher energies as low as than that of singly-excited states. As usual, the intensity is borrowed by the singly-excited states, which are CT states in our case. Due to the presence of the doubly-excited states and their interaction with the singly-excited ones, this intensity is redistributed among the many states available. Therefore, instead of nding a few states with appreciable intensities, we nd structures A, B and C, which are considerably broadened by multiple splittings. This mechanism of broadening may also play a role in forming the shape of the spectrum of solid $M qB_2$. In the latter case, the peaks m ay have rather large widths due to the fact that the valence excitations, which in the computed M g_2B_4 cluster comprise only a limited number of transitions between molecular orbitals, become transitions between electronic bands.

A swe mentioned above, a remarkable feature of the spectrum of $M g_2 B_4$ is that peak A is especially intense and appears at 2 eV above the main line. Its energy and even its intensity relative to the main peak resemble strikingly those of the structure observed at

2 eV in the experim ental spectrum of Ref. [16].

The other cluster model of the M gB₂ crystal, the M gB₆ fragment, does not have the stoichiom etry of M gB₂ but contains the main structural motif of the B layers of the crystal, that is the B₆ planar ring. The physics of core-ionization of this cluster is similar to that found for M g₂B₄. Strong B 2p_z ! M g3s,3p charge transfer processes are responsible for the appearance of the satellite structures A, B and C in the M g2p⁻¹ spectrum. These structures consist of m any lines with sm all individual intensities, as in the case of M g₂B₄. We observe also in M gB₆ a breakdown of the main line; however, this breakdown is not as pronounced as that encountered in the M g₂B₄ cluster.

The spectrum of the molecular M gB₆ cluster resembles to a large extent the spectrum of the M gB₆ fragment of the M gB₂ crystal (Fig. 2). This is not very suprising because the geometry of the M gB₆ molecular cluster is rather close to that of the M gB₂ crystal. Similarly to the M gB₆ and M g₂B₄ fragments, the B $2p_z$! M g3s,3p charge transfer is responsible for the appearance of intense satellite structures in the spectrum. The structure of the M gB₆ molecular cluster is of particular interest. A coording to our calculations the B₆ planar ring alone is not stable. This ring is, however, stabilised by the electronic charge transfer from the M g atom to the boron ring in the ground state of M gB₆. The similarity of the geometry of this cluster to that of the crystal indicates that this mechanism may also be of relevance for the stabilisation of the crystal structure of M gB₂.

A general feature of the M g2p core hole screening in all our clusters is that the $B2p_z$! M g3s,3p charge transfer processes are dominant. Interestingly, the related valence $B2p_z$! M g3s,3p charge transfer excitations have been shown to be of importance for understanding the mechanism of high-tem perature superconductivity in M gB₂ [15]. O ur calculations show that the $B2p_{x,y}$! M g3s,3p charge transfer processes make only minor contribution to the screening of the core hole. A coording to the band structure calculations,

 $(B 2p_{x,y})$ states, which are quasi-two-dimensional states, form the metallic properties of M gB₂ [8, 9, 10, 11, 12, 13, 14].

A coording to our calculations, the total intensity borrowed by satellites is 60% in the spectra of the M gB₆ clusters and 80% in the spectrum of M g₂B₄. This high satellite to m ain line intensity ratio is not typical for light element compounds where satellites usually acquire 20-30% of the total spectral intensity. In this respect the clusters studied here can rather be related to the class of strongly correlated system s. These include also known

high-tem perature superconductors. A nother feature of the M g-B clusters, which they share with these superconductors, is that the main mechanism responsible for the appearance of intense satellite structures in the core-level spectra is a charge transfer mechanism.

It is worthwhile to discuss the experimental M g2p 1 spectra. The band shapes of the two experimental spectra available in the literature are very dierent from each other (Fig. 2). A coording to Ref. [16], the surface of the prepared c-axis oriented thin lm of M gB₂ grown on an R-plane sapphire was initially contaminated with dierent M g oxides, hydroxides and carbonates. The ionization of the M g2p level in these compounds contribute to the bulk M gB₂ spectrum at energies of 2 eV. The experimental spectrum (b) shown in Fig. 2, how ever, has been measured for the M gB₂ surface cleaned by non aqueous chemical etching. The authors of Ref. [16] claimed that the etching yields the high-quality surface free of surface compounds. They demonstrated that the intensity of the 2 eV peak in the spectrum indeed decreases considerably after the etching but this peak does not disappear entirely.

The authors of Ref.[17] also measured the M g2p 1 spectrum from a thin lm of M gB₂ grown on an sapphire substrate. In contrast to the spectrum (b) [16] there is only a small hump observed in the spectrum (a) at 2 eV above the most intense peak (Fig. 2). That is not the only di erence between the (a) and (b) experimental spectra. The spectrum (a) reported in Ref. [17] clearly exhibits an intense line at 1eV below the most intense peak. There is no similar structure in the spectrum (b) [16]. It should be noted that the M gB₂

In was grown by the authors of Ref. [17] using a method di erent from that of Ref. [16]. The authors of Ref. [17] claim ed that their M gB_2 surface was initially clean, in contrast to the lm obtained initially in Ref. [16].

It is not clear why the two experimental spectra have so dimensional shapes. There can be still in purities in the prepared $M gB_2$ samples or there may be structural irregularities specific to each of these experiments. We should note, however, that the spectrum (a) seems to be a superposition of the spectrum (b) and some other structure contributing to the spectrum at 1 eV below the highest peak (Fig. 2). The absolute energy of the peak maximum is the same in both experimental spectra. Based on our ab initio calculations alone, we cannot identify the factors which make the experimental spectra measured in Refs. [16, 17] so dimension. Obviously, this situation should be clarified experimentally. Our calculations support the experimental results reported in Ref. [16].

W e have calculated the spectra of clusters of lim ited size. U pon increasing the size of the

cluster, one can expect changes in the spectral bandshapes. A coording to our analysis one of the e ects related to the size of the cluster is the broadening of the satellite structures, and also some additional structures can appear in the spectra of larger clusters. We argue, however, that these changes cannot be signi cant. The main mechanism responsible for the com plicated structure of the spectra of the clusters is the B! M g charge transfer. The strength of this process, and consequently the intensity of the corresponding lines in the spectrum, is controlled by the overlap between the B2p and M g3s,3p orbitals. Therefore, charge transfer from B atom swhich lie near the core-ionized M g site make the dom inant contribution to the screening of the M g2p core hole, whereas charge transfer from boron atom s far away from the core-ionized M g atom cannot be strong, due to a small hB 2pjM g3s; 3pi overlap. Thus, we do not expect signi cant m odi cations of the spectra of larger clusters com pared to the spectra of our relatively small ones.

The electronic structure of the M gB_6 m olecular cluster sheds some light on the factors stabilising the structure of the M gB_2 crystal. The boron planar honeycom b conformation is stabilised through electron donation from M g in the ground state of the cluster. In the M g2p core-ionized states this transferred charge goes back to the M g site and screens the core hole. The strength of this screening in the molecular cluster is similar to that in the cluster models of the M gB_2 crystal and therefore the core-ionization spectra are similar as well.

To sum marize, our accurate ab initio G reen's function calculations reveal strong manybody charge transfere ects in the M g2p⁻¹ spectra of the M gB₆ and M g₂B₄ fragments of the M gB₂ crystal and in the spectrum of the m olecular M gB₆ cluster. Three groups of satellites appear in the spectra at 2-3, 6 and 10 eV above the main line. The appearance of the 3 eV peak in our computed spectra and especially of the peak at 2 eV in the spectrum of M g₂B₄ re ects quite closely the experimental spectrum reported in R ef. [16]. The two experimental M g2p⁻¹ spectra of M gB₂ available in the literature are very dierent from each other. This fact, together with the results of our calculations, call for more elaborate experimental studies on the core-level spectra of M gB₂.
