Bosonization and phase Diagram of the

one-dimensionalt Jm odel

Abstract

We present an analytic study of the phase diagram of the one-dimensional t J model and a couple of its cousins. To deal with the interactions induced by the no double occupancy constraints, we introduce a deformation of the Hubbard operators. When the deformation parameter is small, the induced interactions are softened, accessible by perturbation theory. We combine bososnization with renormalization group techniques to map out the phase diagram of the system. We argue that when ! 1, there is no essential change in the phase diagram. C om parison with the existing results in the literature obtained by other methods justi es our deformation approach.

I. IN TRODUCTION

A . H istorical review

Since the discoveries of quantum Halle ects and high T_c oxides in 1980's, the strongly correlated systems have been of great interests both theoretically and experimentally. As far as the high T_c problem is concerned, the t J model is believed to be the appropriate starting model H am iltonian, because it captures the essence of the interplay between charge and spin degrees of freedom in superconducting C u oxides^{1,2}. A lthough high- T_c cuprates are (at least) two-dimensional systems, it is very interesting to study its one-dimensional (1D) counterpart. As argued by Anderson¹, two-dimensional strongly correlated systems may share some properties of 1D systems. In addition, the physical understanding of the 1D system s is also extrem ely helpful for the study of the ladder system s, which have been realized experimentally and have attracted a lot of attention in recent years³ {⁵.

In the 1D systems, the phase space of particle scattering is highly restricted. The occurrence of a single scattering event will spread quickly among all other particles, which invalidates the concept of individual excitations. Consequently, we are often confronted with correlated collective excitations. On the other hand, in some cases we can bene t from such phase space restriction. N am ely, the many-particle scattering matrix could be nicely decom posed into the product of two-particle ones which satisfy the so-called Y ang-B axter integrable conditions⁶. This property provides us with the possibility to exactly solve some 1D models, e.g., the Hubbard model⁷, the H eisenberg model^{8,9}, and the supersymmetric t J model¹⁰. The exact solutions in turn provide us with powerful guidelines to develop and to justify certain approximate schemes for other problem s.

In some sense, the 1D t J m odel could be viewed as a descendant of the H ubbard m odel in large on-site repulsion lim it. N amely, the strong coupling lim it of the H ubbard m odel can be m apped into the weak coupling lim it of the t J m odel. N aively, one m ay speculate that the integrability of the 1D H ubbard m odel would be inherited by the t J m odel in

the whole parameter space. Unfortunately, this speculation is not correct: The t J model is only integrable at two special points in parameter space. The reason for this difference is that, in contrast to other 1D integrable models, the Hilbert space of the t J model is highly constrained: Double occupancy of any site is completely excluded. Furthermore, the integrable points of the t J model are located in the strong coupling regime (jJj = 2t in our convention below), not in the weak coupling lim it. Therefore, the integrability of the supersymmetric t J model is not simply inherited from the Hubbard model. Rather it is better to be viewed as a separate miracle of the interacting 1D many-particle system. Since the 1D t J model can not be exactly solved at a generic point in parameter space, the analytical studies of the t J model have been a painstaking task even in the 1D case.

To illustrate the points more clearly, let us take a close look at the t J model. The model delineates the behavior of hard core ferm ions on a discrete lattice, and the dynamics is given by the model H am iltonian

Here P is the projection operator that prohibits double occupancy of any site, and the spin orientations (with =1 for ", and -1 for #); t is the hopping am plitude and J the anti-ferrom agnetic (J > 0) or ferrom agnetic (J < 0) coupling. Due to the aforem entioned constraints, at each site the states j_a > can only be one of the follow ing three possible states: with a = "; #, and a = 0 (em pty). This H ilbert space is neither ferm ionic nor bosonic. O ne can check that the projection operators $ab = j_a$ > < bj close, under commutation and anticommutation, to form a sem i-simple supersymmetric Lie algebra, the Spl(1;2) given by the relations¹¹

where $_{i}^{0}$ and $_{i}^{0}$ are ferm ionic operators that, respectively, create and annihilate a single electron. The bosonic operator 0 are identified as the generators of the group SU (2). Using these operators, the t $_{J}$ m odel can be neatly written as

in terms of the bilinears in the generators of Spl(1;2). But the price we have to pay is to introduce both ferm ionic and bosonic operators simultaneously. As a consequence, it is di cult to make a simple, controlled approximation in this representation. To overcome the di culties associated with the no-double-occupancy constraints, the slave boson and slave ferm ion method^{12;13} and, more recently, the supersymmetric Hubbard operator method¹⁴ have been invented to treat the t J m odel, with the hope of the mean eld ground statebeing relevant to the high-T_c problem. However, after more than one decade e ort, it seems that a reliable ground state is still elusive.

B.Deform ed Hubbard operators

The sem inal work by Jordan and W igner¹⁵ and, later, by Lieb, Schultz, and M attis¹⁶ provides an alternative idea to handle the above hybridized situation in statistics: Nam ely the spin operators are uniform ly expressed in terms of ferm ionic operators, though the spin system s are neither bosonic nor ferm ionic ones. In the same spirit, one can also rewrite the t J m odel in terms of ferm ions exclusively.

In addition to rewriting the magnetic interactions using the ferm ionc realization of the spin operators

one may introduce as well the Hubbard operators¹⁷

and rewrite the hopping terms in terms of them. These operators also realize the constraints that exclude double occupancy on each lattice site. In this way, one gets a formulation of the t J model completely in terms of fermionic operators.

However, one in mediately sees that the old hopping term swill induce extra four-ferm ion and six-ferm ion interactions. These interactions are "hard" ones, in the sense that their strengths are exactly the same as the hopping amplitude t. This fact de es the attempts to treat the additional four- and six-ferm ion terms perturbatively. Therefore, at rst glance, it boks silly to adopt this strategy to solve the t J model unless new techniques can be invented to make the induced interactions tractable.

In the present paper we propose a technique that allows us to deal with these induced four-and six-ferm ion interactions. The key point is to use the idea of "adiabatic continuity" to soften the above-m entioned interactions induced by the no-double-occupancy constraints. N am ely, we propose to introduce the following deformed Hubbard operators

with a deform ation parameter 0 < 1. When approaches to unity, we recover the genuine Hubbard operators (5). For 0 < < 1, there is a non-zero probability to allow leakage into states with double occupancy. With these deformed Hubbard operators (6) replacing the genuine Hubbard operators (5) in the hopping term s, we get a deform ation of the original t J m odel. The deformed m odel has the advantage that for small , the induced four- and six-ferm ion interactions are no longer \hard". This is because these interactions have strengths proportional to the deform ation parameter and, therefore, is tractable in the sense of perturbation theory when is small.

Though small values of may not be \physical", after extracting possible structures in the phase diagram for small, we analytically continue our results back to = 1. The fundamental assumption underlying this continuation is the adiabatic continuity, namely that when the Hamiltonian of the model is adiabatically changed with varying from a small positive value to unity, there is no essential, qualitative change in the phase diagram of the model, though various phase boundaries in parameter space may undergo a continuous deformation. Historically, our idea of considering a deformed model is parallel to the ideas that underlie the replicamethod in treating disordered system, or the large N expansion in eld theory. A ctually, even in the eld of 1D exactly solvablem odels one can nd a precedent: Yang and Yang⁹ proposed the X X Z m odel as a deform ation of the X X X m odel, i.e. the $spin-\frac{1}{2}$ 1D H eisenberg m odel, and used it to justify the B ethe A nsatz m ethod in the latter by rst studying the large anisotropic lim it and then continuing back to the isotropic lim it. In this paper we will rst discuss som e sim pler cases and give argum ents to justify the adiabatic continuity assumption together with our deform ed H ubbard operators.

O fcourse, practically the justi cation m ay depend on how we treat the deform ed m odel, which is a fully ferm ionized m odel containing four- and six-ferm ion interactions. In the present paper, we are going to combine the bosization m ethod and perturbative renorm alization group (RG) techniques to deal with the deform ed t J m odel. Namely we rst bosonize the deform ed m odel, and then use the RG ow s to m ap out the phase diagram of the bosonized m odel. W e will argue that the phase diagram obtained in this way does not change in an essential way, when the deform ation parameter varies from a small positive value to unity.

For convenience, we will start with a simplied model. Namely, we will rst consider a model in which the magnetic spin-spin interactions are Ising-like, i.e. of the form $J_z \,^P_j S_j^z S_{j+1}^z$. This model, together with the usual hopping term, we call the t J_z model. Then with a bit more complication, we would like to modify the isotropic magnetic interactions in eq. (1) to anisotropic X X Z -type interactions:

This model we call as the t J_{2} J_{2} model. The phase diagram of the SU (2) invariant t J model can be obtained in the double lim it with J_{2} ! J_{2} (the isotropic lim it) and with the deformation parameter ! 1 (the physical lim it with no double occupancy).

The paper is organized as follows: In section II, we discuss the phase structure of the extrem ely anisotropic limit of thet J_2 J model, namely, thet J model. The convention of our bosonization scheme is also presented in detail in this section. Then the discussions of the phase diagram for the 1D t J J model are presented in the section III. In section IV,

we compare our results with other work. The discussions and conclusions are summarized in the section ${\tt V}$.

II. AN EXTREMELY AN ISOTROPIC LIM IT : THE T $\neg\!J_Z$ M ODEL

A.Themodel

The 1D t J_2 model represents a strongly anisotropic limit of the SU (2) t J model, in which only has the Ising part of the magnetic interactions been included. W ithout hopping, this simplication is signicant for understanding purely magnetic interactions. However, with hopping the model is more interesting in that it has incorporated the interplay between hopping and the exchange interactions, which makes the physics of the model highly nontrivial. Therefore, the model has recently attracted a lot of interests²⁶. It is known from the numerical studies that the low-energy physics in both the t J_2 and t J models¹⁹ shares some common features even in two dimensions. In the real world, the possible origin of exchange anisotropy is the spin-orbital coupling²⁰. In the extrem ely anisotropic limit, the Ham iltonian (for the t J_2 model) reads

Following Eq. (4), we use the representation of S_{i}^{z} given by

Note the appearance of the Hubbard operators (5) in the hopping term s. It is the presence of the second term in eq. (5) that realizes the no double occupancy constraints, As a consequence, the term H_0 (t) is no longer a simple hopping of ferm ions: M ore interaction term s with four or six ferm ions are induced, with strengths of the sam e order of m agnitude as the hopping am plitude t. How to deal with these interaction terms is an important issue.

To reduce the strengths of the interaction terms induced by the no double occupancy constraints, we propose to deform the model H am iltonian (8) by replacing the H ubbard operators with the deform ed H ubbard operators (6), resulting in

The H am iltonians H_i(i = h;1;2;3), in term s of the genuine ferm ion operators c_j and c_j^{γ} , are given by

which represents the genuine hopping term, and

Here H_1 and H_2 are the induced four ferm ion repulsive interaction to prevent double occupancy of the same lattice site, and the H_3 term is attractive, representing the e ects from the six ferm ion interactions that compensate to the excessive repulsion in H_1 and H_2 . It is easy to see that now in the deform ed m odel, all the induced term s H_1 , H_2 and H_3 are proportional to the deform ation parameter in Eq. (6). If is small, the induced interactions are "softened", becoming tractable in perturbation theory. In the limit of

! 1, the total e ects of the three terms precisely prevent double occupancy for each lattice site.

By using Eq. (9), the exchange term $U(J_z)$ is given by

In this way, we rewrite the t J_2 model in terms of ferm ion creation and annihilation operators exclusively. To look for the low energy elective Hamiltonian, we perform the standard procedure to bosonize the t J_2 model in the next subsection.

B.Bosonization

The hopping term is easily diagonalized by Fourier transform, the energy spectrum is given by

where a is lattice spacing. In the ground state, all the states with momentum lower than the Ferm imomentum k_F are lled. For a generic lling factor = N = M with N the particle number and M the number of lattice sites, the Ferm imomentum is

To get the low energy elective action for the excitations, we only need to focus on m omenta close to $k_{\rm F}$ and linearize the spectrum as

where the Ferm ivelocity is given by $v_F = 2ta \sin (k_F a)$. The second term is a constant and can be shifted away by redening the energy zero point. We will drop it throughout the rest of the paper.

In one dimension, the denition of exchange statistics is am biguous, since the no double occupancy condition excludes the possibility to physically exchange spatial position of two particles. This makes the statistics of ferm ionic particles lose its absolute meaning and make an alternative description in terms of bosons possible. This situation is quite dimensional case, where the exchange statistics of particles has an absolute meaning. In two dimensions, the denition of particle statistics only marginally makes sense and we can transmute the statistics arbitrarily by attaching the Chem-Sim ons ux to particles (the composite of particle and ux is dubbed as anyon^{21,22}). The statistics transmutation procedure in one dimension is called bosonization; it has been widely used in exploring the physics in one dimensional system $s^{23,24}$.

In practice, it is convenient to discuss the bosonization in real space. To do so, we expand the lattice ferm ion in terms of continuum elds

where x = ja is used. A fter linearization and dropping fast varying term s, we get the low energy elective H am iltonian for the H _h term as

describing a one-dimensional relativistic D irac particle in continuum.

In the following, we use the bosonization rule to bosonize the t J_2 model:

The introduction of $1 = \frac{p}{2}$ a in Eq. (22) maintains the correct dimension for the eld $_{P}$ (x) which has dimension [length] $^{1=2}$ (see Eq. (19)). The elds are angular variables and thus dimensionless. To get the correct anticommutation for fermionic elds, we also require the bosonic elds $_{P}$ (x) satisfy the following commutation relations

where "(x) is the Heaviside step function.

U sing these bosonization rules, we get the bosonic description for the hopping term (21) as

To organize the spin and charge m odes m ore elegantly, we introduce new pairs of dual elds as follows:

Here the introduction of num erical factor $1 = \frac{p}{2}$ is to maintain the commutation relation in Eq. (29). The subscript \s" means the spin mode and \c" the charge mode. Using these spin-charge separated modes, the bosonic Ham iltonian (26) can be cast into the following form

To bosonize the induced interaction term s H_{1,2}, we note that, roughly speaking, both the H₁ and H₂ term s are of the type of H ubbard-like on-site interactions in the continuum lim it and, therefore, provide interactions to renorm alize the charge/spin velocity and the controlling parameters (i.e. K_{c=s}; see below) and the cosine term in the spin sector. By taking m icroscopic details of these two term s into account, we get an extra num erical factor $\cos(k_F a) = \cos(-2)$. Both term s have the same bosonized form. Namely, the bosonized form of H₁ + H₂ is

Now we come to discuss the six-ferm ion term H $_3$ in the continuum limit; after a straight-forward but tedious calculation we get

To get a sensible continuum limit, we have to take a ! 0, but keep ta nite consistently. An elegant way to accomplish this is to use the following operator product expansion (OPE):

The last thing in bosonizing the t J_z model is to bosonize the magnetic interaction U (J_z) in Eq. (15). We decompose it into the following combinations:

It is worth noting that the absence of charge variables in the U (J_z) term is natural, since we are dealing with pure magnetic interactions.

Therefore, after collecting all the results, the low energy e ective H am iltonian for the bosonized form of the t J_{m} model is nicely written as

The velocities $v_{c=s}$ are renormalized by magnetic interactions and the interactions induced by the no double occupancy conditions:

The controlling param eters K $_{\rm c=s}$ are given by

In passing, we would like to stress that the above results are derived for small and J_za. However, the general result of a renom alization of $v_{c=s}$ and K_{c=s}, but with no other changes, is expected to be valid more generally^{29;30}. In other words, the functional forms of the low energy elective H am iltonians H_{c=s}, being basically dictated by the symmetry requirements, survive even if the interactions are strong, while the above values of $v_{c=s}$ and K_{c=s} are not universal. Therefore, we conclude that if we adiabatically continue the value of to unity, the low energy elective H am iltonians H_{c=s}, with the renorm alized values of $v_{c=s}$ and K_{c=s} not restricted to those given by Eqs. (45) and (47).

C. The phase diagram

Now we are in the position to discuss the possible phase diagram for the t J_z model. For convenience, we only discuss the anti-ferrom agnetic case, namely, we assume $J_z > 0$.

At rst, we notice that the spin and charge degrees of freedom are well separated just like what happened in other 1D interacting models. However, from the expression for the controlling parameters $K_{c=s}$, we have already seen the interesting interplay between hopping and magnetic interactions. The phase diagram is determined by the competition of above two energy scales(t and J_z). This is quite di erent from the case of the Hubbard model or the X X Z model where the controlling parameter is only determined by the interaction strength. However, the charge sector is massless, described by a quadratic Ham iltonian with no m ass term. This m eans that charge excitations are gapless and the charged sector of the system is m etallic. In contrast, the know ledge on the fate of the spin sector needs m ore work. The situation is similar to that of the Hubbard model.

The fate of the spin sector is determ ined by the well-studied sine-G ordon H am iltonian. In the spin sector we have the following renorm alization group equations $(RGE)^{30,29}$:

where is a positive, regularization dependent parameter. With these two RG equations in hand, we can readily analyze the phase diagram for the spin sector.

(i) When
$$K_s > 4$$
 and $jg j = \frac{K_s}{4} = 1 = 1$, the spin sector ows to the xed point line:

Thus we get the Luttinger liquid behavior for the spin sector. Following the Balents-Fisher's notation⁵, we say that the system is in the C 1S1 phase; here more generally a C m S n phase means a phase with m massless charge modes and n massless spin modes respectively.

(ii) W hen parameters K $_{\rm s}$ and g satisfy one of the following conditions:

then the RGE ows toward g = +1. In this case, the behavior of the system is overwhelm – ingly determined by the minima of the cosine term. For g > 0, these minima are given by

but due to the angular nature of the variable s, we can have only two distinct ground states, distinguished by the even and odd values of n. This state is identified to be Peierls ordering of spin degrees of freedom. Due to quantum tunneling, degeneracy of the ground state is rem oved. Consequently, the excitations above either ground state are gapful. The dom inant contributions to the mass gap come from the topological soliton excitations in the dilute gas approximation of solitons and anti-solitons. Therefore, in this phase, the spin sector is gapful, and we classify the phase of the system as a C1S0 phase.

(iii) In contrast to the case (ii), if the parameter K $_{\rm s}$ and g satisfy one of the following two conditions:

then the RGE ows toward g = 1. An argument similar to that in the case (ii) gives the ground states determined by

In this state, we have a staggered expectation value for the z component of the spin. Therefore, the spin ordering is Neel-like.

In sum mary, we construct the phase diagram for the t J_2 model in Figure 1.

III. THE T J_2 J_Z MODEL

In this section, we will discuss the modi ed version (7) of the t J model. Again the change to make is in the magnetic interactions. In addition to the U (J_z) term discussed in the last section, we now add the X Y part, U (J_2), of the anti-ferror agenetic interactions:

Following the bosonization procedure presented in the preceding section, we get the bosonized form for U (J_2) as

Therefore, for the modi ed t J model (7), we have the bosonized low energy e ective H am iltonian

where the H am iltonian of the charge sector, H_c , is still given by Eq. (42), since the X Y part of magnetic interactions only changes spin dynam ics. In contrast, due to the extra U (J₂), the H am iltonian H_s of the spin sector has been drastically modi ed to

Compared to the t J_2 model, the Ham iltonian H_s now has two extra terms with the coupling constants g and g respectively. The spin velocity (v_s) and controlling parameter (K_s) are still the same as those in Eqs. (45-47). Using Eq. (60), the coupling constants g and g are determined to be

Due to the appearance of the interaction term g , which has a non-zero conform alspin, the dynam ics for the spin sector becom es much more involved. When we use the scaling arguments to discuss the relevance of the interaction terms, we need to be more careful. We'd better use the RG ow for the Hamiltonian (62) to discuss the details of the spin dynamics. Fortunately, up to one loop level, the RGE for a Hamiltonian like (62) have been studied thoroughly, though in quite di errent context^{27 {29}. The resulting RGE for the double cosine term g is

the double cosine term in the H am iltonian (62) is always irrelevant. Of course, the action of RG will generate more terms, such as single cosine terms. However, the arguments of these single cosine terms are twice bigger and these terms are more irrelevant than the existing terms. Thus we can neglect them. This situation is quite di erent from that of the two coupled Luttinger liquid case^{27 {29}. Therefore, we only need to focus on the following e ective H am iltonian

where we have introduced $\tilde{s} = \frac{p_{K_s}}{K_s}$ and $\tilde{s} = \frac{p_s}{K_s}$. The denitions of s and \tilde{s} are

It is now easy to observe that the low energy e ective H am iltonian possesses the following duality property: N am ely, the H am iltonian (67) is invariant under the following transformation

Note that such a duality does not appear in the t J_2 model or in the Hubbard model. But it is also interesting to note that it appeared in the 1D X Y Z Thirring model²⁹ and in the case of two coupled Luttinger liquids^{27 {29}. C om pared with the sine-G ordon system, the sym metry of Eq. (67) is discrete, while there is a hidden U (1) sym metry in the sine-G ordon system, which rejects the U (1) invariance of its dual ferm ionic model (the M assive Thirring model).

It is also easy to get the scaling dimension for the cosine terms of the eld $_{\rm s}$ and its conjugate $_{\rm s}$ as

Therefore, one of the two cosine terms is always relevant, which is associated with the ordering of the - or - eld. Let us discuss the following two dimensions separately.

(i) When the scaling dimension < 2, the $\cos(2_s)$ term is relevant. This case is similar to the t J case, and the system eventually owns to the spin-Peierls phase for g > 0 or the Ising-N celorder for g < 0 respectively.

(ii) W hen the scaling dimension < 2, the $\cos(\frac{p}{2}_s)$ term is relevant. In this case, since g is always negative, therefore the system ow s tow and the Ising-N eel phase only.

In sum m ary, we see that the phase diagram in F ig. 1 can only be partially accessed in the J m odel. The di erence in the two cases rejects the fact that the duality transform ation (69) can only be realized in part of the parameter space, since the coupling constant g is de nitely negative, while the coupling constant g can be either negative or positive, depending on the interplay between t and J_z .

IV.CONCLUSIONSAND DISCUSSIONS

In this paper, the phase diagram of the most general 1D t J, J model is discussed based on bosonization and RGE. To make sense of the bosonization procedure for the interactions induced by no double occupancy constraints, we have introduced deformed Hubbard operators (6), which contain a deformation parameter . While at = 1 the no double occupancy constraints at each site are recovered, the case with a small positive is accessible to perturbative RG analysis. Since the basic structure of the bosonized low energy e ective H am iltonian is argued to be determ ined only by the sym m etry requirem ents, the bosonized form of the low energy e ective H am iltonian with a sm all deform ation param eter

is expected to survive the limit ! 1. However, we can not simply use the values of $v_{c=s}$ and $K_{c=s}$ to make precise predictions on the phase diagram, since these values are not reliable at = 1. We should take the strategy in which both $v_{c=s}$ and $K_{c=s}$ are considered as phenom enological parameters.

For the case with $J_z = J_2$, the model is reduced to the so-called t = J_z model. In this case, the spin sector can ow to three distinct phases: the gapless phase, the spin-Peierls phase, and the Ising-Neel phase, depending on the range of the parameters, meanwhile the charge dynam ics remains always gapless. In the case with $J_z > J_{zc}$, where the J_{zc} represents the value to make g = 0 and K $_{\rm s}$ < 4 , the system ows to the Ising-Neel ordering in spin dynamics. We identify this phase as the so-called phase separation (PS) phase. For the case with $J_z < J_{zc}$ and $K_s < 4$, the spin sector eventually ows to the spin-Peierls phase which is gapful. We can identify this phase as a superconducting phase (SC). Finally, for $K_s > 4$, the spin sector ows toward a gapless phase and thus the system ows toward the Tom onoga-Luttinger liquid phase. Such a phase is consistent with the phase diagram constructed by Los A lam os group in Ref. 26, where the authors m apped the t J m odel into the 1D X X Z model and construct the phase diagram from the knowledge of exact solutions for the 1d X X Z model. This consistency also helps us to justify our proposal to use the deform ed Hubbard operators and the continuation from the case of 1 to the desired case = 1.

In the opposite limit, namely J_2 , J_z , the modiled to J model can be reduced the the to J, model. In this case, we still have g generally non-zero due to the no-double-occupancy induced interactions. Therefore, the phase diagram of the to J, model is expected to be similar to the case of the most general to J, J, model. Namely, the system is generically gapful in the spin sector and thus can not ow toward the Tom onoga-Luttinger phase. This result is a little bit di erent from the naive speculation that the total should be basically similar to the total. From our study, we conclude that there are some

delicate di erences between the two cases, since the X Y part and the Ising part of the magnetic interactions play a di erent role in spin ordering.


