The elastoplastic response of and moisture di usion through a vinylester resin { clay nanocom posite

A bstract

Experimental data are reported on the elastop lastic response of and m oisture diffusion through a vinylester resin (m ontm orillon ite clay nanocom posite w ith various amounts of ller. Two simple models are developed for the elastop lastic behavior of a nanocom posite and for the anom abus di usion of penetrant molecules. A djustable parameters in the constitutive equations are found by tting the observations. It is revealed that some critical concentration of ller exists (about 1 wt.?): in the sub-critical region of concentrations, molecular mobility of the host polymer strongly decreases with the clay content, whereas in the post-critical dom ain, the ller fraction weakly a ects mobility of chains.

1 Introduction

This paper is concerned with the elastoplastic behavior of and moisture di usion through a nanocom posite consisting of a vinylester resin matrix lled with montmorillonite clay particles.

The choice of vinylester resin is explained by the fact that this therm osetting polym er is widely used as a matrix for glass-reinforced polym er com posites em ployed for construction and repair of bridges and other civil structures (Valea et al., 1998; Patel et al., 1999).

M ontm orillonite (M M T) is a commonly used clay with a layered structure that is constructed of two tetrahedral sheets of silica surrounding an octahedral sheet of alum ina orm agnesia (M asenelli-Varlot et al., 2002). The layers (with thickness of 1 nm) are stacked by weak dipole forces, while the galleries between the layers are occupied by m etal cations. P rocessing of clay particles for preparation of an intercalated nanocom posite consists of two stages:

- The growth of the basal (interlayer) spacing by exchanging the metal cations with an intercalating reagent (conventionally, alkylammonium ions). This process facilitates intercalation of polymer chains into the galleries between the clay layers (Chang et al., 2002).
- 2. Treatm ent of intercalated particles by a com patibilizer (a swelling agent, a functional oligom er, or a low molecular weight polymer) to improve m iscibility between the organics-modi ed silicate layers and the host matrix (Tyan et al., 2000; M a et al., 2001; Chang et al., 2002).

P reparation and analysis of m icro-structure and physical properties of nanocom posites with polymeric matrices led with MMT clay have been a focus of attention in the past couple of years. It was found that polymer{clay nanocom posites possess m any desirable properties, such as increased m oduli and strength, reduced gas permeabilities, decreased adsorption of organic liquids, etc. (K in et al., 2002). However, no detailed analysis of interaction between m olecules of a host matrix and the silica sheets has been performed so far.

The objective of the present study is to investigate how the presence of intercalated M M T clay a ects the mobility of polymeric chains. We focus on two main processes, where this mobility is revealed:

- 1. elastoplasticity (which is attributed to sliding of junctions in the polymeric network with respect to their reference positions in the bulk material),
- 2. moisture di usion (whose rate is governed by the ability of penetrant molecules to move through the host network).

In civil engineering applications, these two processes are of essential in portance for the prediction of durability and perform ance of constructions.

To evaluate the e ect of nano-particles on the mobility of macromolecules, we focus on a model nanocomposite where no compatibilizer is used. Because of low miscibility between the clay particles and the vinylester resin, we do not expect that the presence of intercalated clay particles noticeably improves the mechanical and transport properties of a nanocomposite compared to those of the neat resin (M a et al., 2001). Our aim is to demonstrate that the concentration of nano-particles a ects the parameters that characterize mobility of polymeric chains in mechanical and di usion tests in similar ways.

In the past two decades, a number of constitutive models have been proposed for the elastoplastic and viscoplastic behavior of glassy polymers, see, e.g., Boyce et al. (1988), M angion et al. (1992), H asan and Boyce (1995), D avid et al. (1997), D rozdov (2001) and the references therein. Three shortcom ings of these models should be mentioned:

the stress{strain relations were developed to correctly describe the mechanical behavior of polymers near the yield point (which is not the case for vinylester resin where fracture occurs earlier than yielding, see Figures 1 to 5 below),

the constitutive equations contain a number of adjustable parameters which cannot be determined with a high level of accuracy by thing data in uniaxial tensile tests,

the material constants are not explicitly expressed in terms of the physical quantities that describe molecular mobility.

To assess constrains in posed by the clay particles on the mobility of macrom olecules in a host matrix, we develop a simple model that contains only three adjustable parameters with a transparent physical meaning. Only one of these parameters rejects mobility of chains, and it can be easily found by thing stress{strain curves in uniaxial tensile tests with small strains.

D i usion ofm oisture in polym er com posites has attracted substantial attention in the past decade, see, e.g., C ai and W eitsm an (1994), B avisi et al. (1996), Vanlandingham et al. (1999), M arcovich et al. (1999), R oy et al. (2000), C hen et al. (2001), R oy et al. (2001), U schitsky and Suhir (2001), to m ention a few. It was dem onstrated that di usion of penetrants in several glassy polym ers is anom abus (non-Fickian), with the m ass gain proportional to some power of time that di ers from 0.5 (the latter is characteristic for the Fickian di usion).

Two approaches were recently proposed to model the anom alous di usion. A coording to the rst (the fractional dynam ics concept), conventional derivatives with respect to time and spatial variables in the di usion equation are replaced by fractional derivatives, see M etzler and K lafter (2000) and the references therein. A coording to the other (R oy at al., 2000), a constant coe cient of di usion is replaced by a decreasing function of time (by analogy with a relaxation modulus for a viscoelastic solid).

Our experimental data (see Figures 6 to 10 below) reveal that moisture di usion in the neat vinylester resin is practically Fickian, while the anom alous transport of water molecules is observed with an increase in the clay concentration. This phenom enon may be explained by the fact that the water molecules are bounded to hydrophilic surfaces of clay layers, where they become immobilized. A two-stage di usion process with immobilization of penetrant molecules has been previously studied by Carter and Kibler (1978) and Gurtin and Yatom i (1979). Unlike these works, we assume that bounded molecules cannot have the sites where they were im mobilized. This allows the number of adjustable parameters to be substantially reduced. The di usion process is governed by di erential equations with only three material constants that are found by matching the water uptake curves plotted in Figures 6 to 10.

The exposition is organized as follows. Observations in uniaxial tensile tests and in moisture di usion tests are reported in Section 2. Constitutive equations for the elastoplastic response are derived in Section 3 by using the laws of therm odynam ics. A djustable parameters in these relations are determined in Section 4. A model formoisture di usion is developed in Section 5 and its material constants are found in Section 6. A brief discussion of our notings is presented in Section 7. Some concluding remarks are formulated in Section 8.

2 Experim ental procedure

2.1 Preparation of sam ples

The polymer used was DERAKANE 411-350 epoxy vinylester resin (Dow Chemical Co.) containing 45 wt.~ of dissolved styrene. To cure the resin at room temperature, it was mixed with 0.5 wt.~ of 6% cobalt naphthenate catalyst (Sigma Aldrich Co.). Additionally, 0.05% of 99% N,N dimethyl aniline (Lancaster Synthesis, Pelham, NH, USA) was used as an accelerator, and 1.5% of methyl ethyl ketone peroxide with 9% of active oxygen (Sigma Aldrich Co.) as an initiator.

A montmorillonite clay C loisite 10A (Southern C lay Products Inc., G onzales, TX, U SA) treated with benzyl (hydrogenated tallow alkyl) dimethyl quaternary ammonium chloride was used as received. Neat resin coupons were cast by pouring the reaction mixture into Te on molds with the dimensions 50 12.5 mm and the thickness ranging from 0.2 to 0.6 mm. The organically treated clay was added to the liquid resin and m anually stirred. Them ixture was then degassed in a vacuum oven to remove air bubbles. A flerwards, the catalyst, initiator and accelerator were added. The mixture was allowed to cure at room temperature for 24 hours, and it was subsequently post cured in an oven for 3 hours at 90 C.

TEM (transm ission electron m icroscopy) m icrographs of the nanocom posite sam ples show that the clay is reasonably uniform ly distributed, and the silica sheets are random ly oriented (Shah et al., 2002). The clay exists as expanded aggregates m ade up of 2 to 10 sheets with the interlayer distance ranging from 4.4 to 5.0 nm, which con rm s the form ation of an intercalated nanocom posite.

2.2 M echanical tests

D um bbell specim ens for m echanical tests were cut following ASTM D 638 speci cation. Tensile tests were performed at ambient temperature by using a 100 kN Instron machine model 8501 with a cross-head speed of 0.254 mm/min. This strain rate ensures practically isothermal loading conditions. The strain was measured independently using a strain gauge a xed to the mid-point of the specimen. The tensile force was measured by a standard load cell. The engineering stress, was determined as the ratio of the tensile

force to the cross-sectional area of a specim en in the stress-free state. For any concentration of ller in a nanocom posite, , four specim ens were tested. Typical stress{strain diagram s are presented in Figures 1 to 5. These gures demonstrate that the response of the neat resin is strongly nonlinear, but the nonlinearity of the stress{strain curves is reduced with an increase in the ller content.

DSC (di erential scanning calorim etry) measurements show that the glass transition temperature of the neat vinylester resin is about 97 C, and it increases with concentration of clay reaching 117 C at = 5.0 wt.% (Shah et al., 2002). Because the material at room temperature is far below its glass transition point, we disregard its viscoelastic response and attribute the nonlinearity of the stress{strain curves to the elastoplastic behavior.

2.3 Diusion tests

D i usion tests were perform ed by immersing samples with rectangular cross-section in distilled water at room temperature (T = 25 C). The samples had a dry mass ranging from 120 to 400 mg. They were stored in a controlled hum idity chamber, and contained 0.05 0.005 wt.-% water at the beginning of di usion tests. The sam ples were periodically rem oved, blotted dry with a lint-free tissue, weighed and re-immersed in the water. A typical experiment lasted ten days, and, on the rst day, readings were taken as frequently as every 15 m in. The balance used had an accuracy of 1 mg, and 3 to 5 replicate runs were carried out for a given set of condition. Typical dependences of the relative moisture uptake, versus the reduced time, t, are plotted in Figures 6 to 10. The reduced time, t, is given by

where t is time elapsed from the beginning of a test, and 21 is thickness of a sample. The relative moisture uptake, , is dened as

where R (t) is the mass gain at the reduced time t and R (1) is the maximal mass gain. Observations on samples with various thicknesses (not presented) show that the mass gain curves plotted in the reduced coordinates (; t) are superposed fairly well.

Figures 6 to 10 dem onstrate that moisture di usion in the neat resin is roughly Fickian, but it becomes strongly anom abus with an increase in the ller content.

The aim of the remaining part of this work is to develop constitutive equations for the elastoplastic behavior and moisture di usion in a nanocom posite and to nd adjustable parameters in these relations by matching the experimental data plotted in Figures 1 to 10.

3 A model for the elastop lastic response

To simplify the analysis, we model a nanocomposite as an equivalent network of macromolecules bridged by junctions (entanglements, physical cross-links and particles of ller). Because the viscoelastic behavior of the nanocomposite is disregarded, the network is treated as permanent (we suppose that active chains do not separate from junctions and dangling chains do not merge with the network within the experimental time-scale). To describe the elastoplastic behavior of the network, we assume that junctions slide with respect to their reference positions in the bulk material. For uniaxial deformation, sliding of junctions is determined by a plastic strain $_{\rm p}$. A dopting the conventional hypothesis that the macro-strain, , is transmitted to all chains in the network by surrounding macromolecules, we write

where $_{e}$ is an elastic strain. We accept the mean-eld approach and treat $_{e}$ and $_{p}$ as average elastic and plastic strains per chain.

It is assumed that under active loading, the rate of changes in the strain, $_{\rm p}$, with time, t, is proportional to the rate of changes in the macro-strain ,

where the coe cient of proportionality, \prime , is a function of the elastic strain $_{\rm e}$.

The following restrictions are imposed on the function ' ($_{\rm e})$:

- 1. The coe cient of proportionality in Eq. (4) vanishes at the zero elastic strain, '(0) = 0.
- 2. The function ' m onotonically increases with $_{e}$ and tends to som e constant a 2 (0;1) for relatively large elastic strains,

The constant a determ ines the rate of sliding in junctions at the stage of a developed plastic ow.

To approxim ate experim ental data, we use the function

which satis es the above conditions. This function is determined by two adjustable parameters, a and e, where a is the limiting value of ' at \large" elastic strains, and e > 0 is a constant that characterizes how \large" an elastic strain, e, is.

A chain is modelled as a linear elastic solid with the mechanical energy

where is an average rigidity per chain. Multiplying the energy, w, by the number of chains per unit volume, n_0 , we not the strain energy density

where $E = n_0$ is an elastic modulus. It is worth noting that the elastic modulus, E, may di er from the Young modulus. The latter is conventionally de ned as the tangent of the angle between the tangent straightline to the stress(strain curve at sm all strains and the horizontal axis. These two quantities coincide when the elastic strain, _e, is equal to the macro-strain, . For the elasto-plastic response of a nanocom posite, when the stress{ strain diagram substantially di ers from a straightline, E exceeds the Young modulus determined by the traditionalm ethod.

For isotherm al uniaxial deform ation, the C lausius-D uhem inequality reads,

Constitutive equations (3) to (5) and (7) are determined by 3 adjustable parameters:

- 1. the elastic modulus ${\rm E}$,
- 2. the rate of developed plastic ow a,
- 3. the strain, e, that characterizes transition to the steady-state plastic deform ation.

To nd these quantities, we match experimental data depicted in Figures 1 to 5.

4 Fitting observations in mechanical tests

It follows from Eqs. (3), (4), (5) and (7) that in a uniaxial tensile test, the stress is given by

where the plastic strain, p, satis es the nonlinear di erential equation

We begin with m atching the experim ental data in a test on the neat vinylester resin, see Figure 1. To nd them aterial constants, E, a and e, we x some intervals $[0;a_{max}]$ and $[0;e_{max}]$, where the \best-t" parameters a and e are assumed to be located, and divide these intervals into I subintervals by the points $a_i = i$ a and $e_j = j$ e (i; j = 1; :::; I) with $a = a_{max} = I$ and $e = e_{max} = I$. For any pair, $fa_i;e_jg$, we integrate Eq. (9) num erically (with the step $= 1.0 \quad 10^5$) by the Runge{K utta m ethod. G iven $fa_i;e_jg$, the elastic m odulus E = E (i; j) is found by the least-squares technique from the condition of m inimum of the function

where the sum is calculated over all experimental points, $_k$, depicted in Figure 1, $_{exp}$ is the stress measured in a tensile test, and $_{num}$ is given by Eq. (8). The \best-t" parameters a and e m in in ize the function F on the set fa_i;e_j (i; j = 1;:::;I)g. Fitting the observations results in e = 2:11 10³.

We x this value of e and proceed with m atching observations in tensile tests on other specimens by using only two m aterial constants, E and a, which are determined by the above algorithm. The average values of E and a (over 4 sam ples) are depicted in Figures 11 and 12, where the vertical bars stand for the standard deviations of these parameters.

A flerwards, we match experimental data in tensile tests on specimens with various contents of ller, . The same algorithm of thing is employed with the xed value $e = 2.11 \ 10^3$. Figures 1 to 5 demonstrate fair agreement between the observations and the results of numerical simulation. The elastic modulus, E, and the rate of developed plastic ow, a, are plotted versus the ller content, , in Figures 11 and 12. The experimental data are approximated by the phenomenological equations

where the coe cions E $_{j}$ and a_{j} (j = 0;1) are found by the least-squares technique.

5 A model for the moisture di usion

A sample is treated as a rectilinear plate with thickness 21. We introduce Cartesian coordinates fx;y;zg, where the axis x is perpendicular to the middle plane of the plate, and the axes y and z lie in the middle plane. Length and width of the plate are assumed to substantially exceed its thickness, which im plies that the moisture concentration depends on the coordinate x only.

A fter the plate is im m ersed into water, three processes occur in the com posite m aterial:

- 1. sorption of water m olecules to the plate faces from the surrounding,
- 2. di usion of the penetrant into the plate,
- 3. adsorption of water m olecules on the surfaces of clay layers, where these m olecules become imm obilized.

It is conventionally accepted that the rate of sorption in glassy polymers noticeably exceeds the rate of di usion (Chen et al., 2001), which im plies that the sorption equilibrium is rapidly established. The equilibrium condition is given by

where n is the moisture concentration at time t at point x [the number of water molecules in the polymeric matrix occupying a volume with the unit area in the plane (y;z) and the thickness dx reads n (t;x)dx], and n is the equilibrium moisture concentration in the matrix on the faces of the plate.

D i usion of the penetrant through the matrix is described by the mass conservation law

where J(t;x) stands for the mass ux, and $n_1(t;x)$ denotes the concentration of water molecules immibilized at the surfaces of clay layers.

The mass ux obeys the Fick equation

where D is diusivity. Equation (13) is tantam ount to the assumption that diusion occurs through the polymeric matrix only. However, the coe cient of diusion, D, is assumed to depend on the volume content of ller, because the presence of particles results in a decay in the molecular mobility of polymeric molecules which provides the driving force for diusion of penetrants.

A dsorption of water molecules on the surfaces of ller is determined by the rst-order kinetic equation

A coording to Eq. (14), the rate of adsorption is proportional to the concentration of the penetrant in the matrix, n, and to the current number of \noccupied sites" on the surfaces of ller, $n_1 \quad n_1$, where n_1 is the total number of sites where water molecules can be immobilized. In the general case, the rate of adsorption, k, and the maximal concentration of unoccupied sites, n_1 , are functions of the clay content, because the presence of nanoparticles a ect mobility of chains in the polymeric matrix, and, as a consequence, their chemical potential.

Neglecting the moisture content in a sample before testing, we adopt the following initial conditions:

Equations (12) to (14) with initial conditions (15) and boundary condition (11) uniquely determ ine the di usion process. The moisture mass gain (per unit mass of the sample) is given by

where is the average mass of a penetrant molecule, and is mass density of the matrix.

Our aim now is to transform Eqs. (11) to (16). For this purpose, we introduce the dimensionless coordinate, x = x=1, and the reduced moisture concentrations, c = n=n and $c_1 = n_1=n$. Combining Eqs. (1), (12) and (13), we arrive at the mass ux equation

Equations (17), (19) and (26) with initial conditions (21) and boundary conditions (22) are determined by 3 adjustable parameters:

- 1. the reduced di usivity D ,
- 2. the rate of m oisture adsorption on nanoparticles K ,
- 3. the reduced concentration of unoccupied sites on the surfaces of ller C .

These constants are found by thing the experimental data in di usion tests.

6 Fitting observations in di usion tests

We begin with m atching the experim ental data for the neat vinyl resin depicted in Figure 6. Because in the absence of ller, m oisture is not adsorbed on the surfaces of particles, we set C = 0 in Eq. (17). Equations (17), (21) and (22) are reduced to the conventional boundary problem for the di usion equation

which is resolved by the nite-di erence method with an explicit algorithm. Given a coecient of di usion, D, we divide the interval [0;1] into M subintervals by points $x_m = m \times (m = 0;1;:::;M)$ with x = 1=M, introduce discrete time $t_n = n t$, and replace Eq. (27) by its nite-di erence approximation

The coe cient D is determined by the following procedure. We x some interval $[D_{\min}; D_{\max}]$, where the \best-t" value of D is supposed to be located, and divide this interval into I sub-intervals by the points $D_i = D_{\min} + iD$ (i = 0;1;:::;I), where $D = (D_{\max} D_{\min})=I$. For any D_i , Eq. (28) is solved numerically (with the steps x = 0.05 and t = 0.005 that ensure the stability of the numerical algorithm), and the function (t_n) is given by Eq. (29). The \best-t" value of D is found from the condition of minimum of the function

where the sum is calculated over all point t_k depicted in Figure 6, $exp(t_k)$ is the relative m assignine measured in the test, and $exp(t_k)$ is determined from Eq. (29). A fler the \best-t" di usivity, D_i, is found, the procedure is repeated for the new interval $[D_{i1}; D_{i+1}]$ to guarantee an acceptable accuracy of matching observations. Figure 6 demonstrates fair agreem ent between the experimental data and the results of numerical simulation.

To ensure that the numerical results are independent of the choice of the steps of integration, x and t, we repeat integration of Eqs. (28) and (29) with the \best-t" parameter D and the new values x = 0.01 and t = 0.0005. No dimension observed between the curve plotted in F igure 6 and the curve obtained by the numerical integration of Eqs. (28) and (29) with the decreased steps in time and the spatial coordinate.

The above procedure is repeated to match observations in the tests on 4 di erent samples. The average value of di usivity is presented in Figure 13, where the vertical bars stand for the standard deviation.

It is worth noting that the algorithm of thing experimental data used in this work diers from the conventional procedure employed by Shah et al. (2002), according to which the coe cient of di usion was determined by matching the initial parts of the mass gain diagrams (where the function (t) is approximately linear).

The same numerical algorithm is employed to match experimental data on polymeric nanocomposites with various amounts of ller. The dierence in the treatment of observations consists in the following: (i) Eq. (28) are replaced by the nite-dierence approximation of Eqs. (17) and (19); (ii) the \best-t" values are simultaneously determined for 3 adjustable parameters: D, C and K. Figures 7 to 10 show good agreement between the experimental data and the results of numerical analysis. The average values of D [this quantity is found from Eq. (18)], C and K (over 4 tests) are plotted versus the ller fraction, , in Figures 13 to 15. The dependences of these parameters on the concentration of ller are approximated by the linear equations

where the coe cions D $_{j}$, C $_{j}$ and K $_{j}$ (j = 0;1) are found by the least-squares technique.

It follows from Eq. (25) that the maxim alm oisture uptake per unit mass of the matrix, $R_{pol} = n =$, is given by

U sing experim ental data for R (1) and the values of C determ ined by m atching observations, we calculate R_{pol} from Eq. (31) and plot this parameter versus the clay content in Figure 16.

7 D iscussion

Figure 11 dem onstrates that the elastic m odulus, E, decreases with the clay content, , in the region of sm all concentrations of ller (< 1.0 wt.%), and remains practically constant when exceeds 1.0 wt.%. A coording to Figure 16, the ller fraction, , a ects them axim alm oisture uptake, R_{pol} , in a similar way. These dependences of the parameters E and R_{pol} seem quite natural, because these quantities characterize the m acro-response of a nanocom posite in tensile and di usion tests. They m ay be explained by a progressive decrease in the degree of cross-linking with the grow th of clay concentration (B haradwaj et al., 2002), which results in a decrease in the number of active chains (whose ends are linked to nearby junctions) compared to the neat vinyl ester resin. This is plies that the elastic m odulus (proportional to the free volum e per unit active chains) is increased. F igures 11 and 16 show that the concentration of chains reaches its limiting value rather rapidly (when the ller content is about $_c = 1 \text{ wt.}$, and an increase in the clay concentration above this critical value does not a ect the cross-linking process.

Figure 12 dem onstrates that the rate of developed plastic ow, a, strongly decreases with in the region below the critical concentration of ller, $_{\rm c}$, and it weakly decreases with when the clay content exceeds its critical value. Figures 13 and 15 reveal that the coe cient of di usion, D, and the rate of adsorption of water molecules on surfaces of nano-layers, K, dem onstrate sim ilar dependences on the ller fraction. This behavior of the quantities a, D and K appears to be in agreement with our physical intuition, because all these parameters relect mobility of polymeric chains. A coording to Figures 12, 13 and 15, thism obility is drastically reduced with in the sub-critical region, and it proceeds to decrease (however, rather weakly) when the ller content exceeds the critical concentration $_{\rm c}$. The conclusion that the mobility of chains in the polymeric matrix decreases with the clay content is also con rm ed by DSC measurements (Shah et al., 2002) which reveal the the glass transition tem perature monotonically increases with

Figure 14 reveals that the parameter C linearly increases with . It follows from Figure 16 and Eqs. (25) and (31) that the maximal moisture content in the polymeric matrix, n, is independent of the clay fraction. This result together with Eq. (20) and Figure 14 in plies that number of sites on the clay layers where water molecules are immobilized, n_1 , linearly grows with the ller concentration. The latter assertion is in agreement with the main assumptions of our model (the total number of sites where the penetrant molecules are immobilized equals the product of the average number of these sites per particle by the number of clay particles), and it may be treated as a conmutation of the kinetic equations for the anomalous moisture di usion.

The similarity in this behavior of the quantities a, D and K as functions of the clay concentration, , provides a way to substantially reduce the number of (time-consum ing) moisture di usion experiments. If the parameters a and D decrease with in the same fashion (our analysis of observations on vinylester resin nanocomposite with MMT particles treated with vinylbenzine trimethylammonium chloride con rms this hypothesis), the function a() can be determined with a high level of accuracy in standard tensile tests, whereas only a few moisture di usion tests are necessary to not the dependence of di usivity on the clay content, D = D ().

8 Concluding rem arks

M echanical and di usion tests have been performed on a nanocomposite with vinylester resin matrix and montmorillonite clay ller at room temperature. Experimental data in tensile tests demonstrate that the mechanical behavior of the neat vinylester resin is strongly elastoplastic, whereas an increase in the clay content results in a decrease in the plastic strain (due to the constrains on mobility of junctions between polymeric chains imposed by nano-particles). Observations in di usion tests show that moisture di usion in the neat resin is Fickian, whereas it becomes noticeably anom alous (non-Fickian) with the growth of the clay content. This transition is ascribed by adsorbtion (immobilization) of the penetrant molecules on surfaces of hydrophilic clay layers.

Constitutive models have been proposed to describe the elastoplastic response and anom alous moisture di usion in a nanocomposite. Both models are determined by 3 adjustable parameters that are found by thing the experimental data. Fair agreement is demonstrated between the observations and the results of numerical simulation.

The following conclusions are drawn:

- 1. A critical concentration of clay is found, c 1 wt.~, corresponding to both mechanical and di usion tests. The ller content, , strongly a ects the material constants in the sub-critical region, and its in uence becomes rather weak in the post-critical dom ain.
- 2. The quantities independent of m olecular mobility, such as the elastic modulus, E, and the maxim alm oisture uptake by the polymeric matrix, R_{pol} , are not a ected by the concentration of clay particles when the ller content exceeds its critical value.
- 3. The quantities relecting m obility of polymeric chains, such as the rate of developed plastic ow, a, the coe cient of di usion, D, and the rate of moisture adsorption on nano-particles, k, strongly decrease with the ller content in the sub-critical region, and proceed to decrease (with smaller rates) at $> _{c}$.




Figure 1: The stress MPa versus strain for neat vinylester resin. Circles: experimental data. Solid line: results of numerical simulation




Figure 2: The stress MPa versus strain for nanocomposite with = 0.5 wt.. Circles: experimental data. Solid line: results of numerical simulation




Figure 3: The stress MPa versus strain for nanocomposite with = 1.0 wt.. Circles: experimental data. Solid line: results of numerical simulation




Figure 4: The stress MPa versus strain for nanocomposite with = 2.5 wt.. Circles: experimental data. Solid line: results of numerical simulation




Figure 5: The stress MPa versus strain for nanocomposite with = 5:0 wt.. Circles: experimental data. Solid line: results of numerical simulation




Figure 6: The relative moisture uptake versus the reduced time t $(h^{\frac{1}{2}}/mm)$ for neat vinyl ester resin. C incles: experimental data (21 = 0.56726 mm). Solid line: results of numerical simulation




Figure 7: The relativem of sture uptake versus the reduced time t $(h^{\frac{1}{2}}/mm)$ for nanocom – posite with = 0.5 wt.%. Circles: experimental data (21 = 0.25373 mm). Solid line: results of numerical simulation




Figure 8: The relativem of sture uptake versus the reduced time t $(h^{\frac{1}{2}}/mm)$ for nanocom – posite with = 1:0 wt.~ . Circles: experimental data (21 = 0.20108 mm). Solid line: results of numerical simulation




Figure 9: The relativem of sture uptake versus the reduced time t $(h^{\frac{1}{2}}/mm)$ for nanocom – posite with = 2.5 wt.%. Circles: experimental data (21 = 0.22013 mm). Solid line: results of numerical simulation




Figure 10: The relative moisture uptake versus the reduced time t $(h^{\frac{1}{2}}/mm)$ for nanocomposite with = 5:0 wt.~ Circles: experimental data (21= 0:2032 mm). Solid line: results of numerical simulation




Figure 11: The elastic modulus E GPa versus the clay concentration wt.. Circles: treatment of observations. Solid lines: approximation of the experimental data by Eq. (10). Curve 1: E₀ = 4:83, E₁ = 0:85; curve 2: E₀ = 3:97, E₁ = 0:0




Figure 12: The rate of developed plastic ow a versus the clay concentration wt.~ . Circles: treatment of observations. Solid lines: approximation of the experimental data by Eq. (10). Curve 1: $a_0 = 0.22$, $a_1 = 0.19$; curve 2: $a_0 = 0.04$, $a_1 = 0.01$




Figure 13: Diusivity D $10^7 \text{ mm}^2/\text{s}$ versus the clay concentration wt.%. Circles: treatment of observations. Solid lines: approximation of the experimental data by Eq. (31). Curve 1: D₀ = 9:01, D₁ = 3:91; curve 2: D₀ = 6:11, D₁ = 0:24




Figure 14: The dimensionless parameter C versus the clay concentration wt.%. Circles: treatment of observations. Solid line: approximation of the experimental data by Eq. (31) with $C_1 = 0.19$




Figure 15: The adsorption rate K 10^3 h⁻¹ versus the clay concentration wt.-%. Circles: treatment of observations. Solid lines: approximation of the experimental data by Eq. (31). Curve 1: K₀ = 14:68, K₁ = 12:85; curve 2: K₀ = 2:14, K₁ = 0:19




Figure 16: The maxim alm oisture uptake per unit mass of the matrix R_{pol} % versus the clay concentration wt.%. C inclus: treatment of observations. Solid line: approximation of the experimental data by the constant $R_{pol} = 0.75$ %
