1D model for the dynamics and expansion of elongated Bose-Einstein condensates

W e present a 1D e ective m odel for the evolution of a cigar-shaped B ose-E instein condensate in tim e dependent potentials whose radial com ponent is harm onic. W e apply this m odel to investigate the dynam ics and expansion of condensates in 1D optical lattices, by com paring our predictions with recent experim ental data and theoretical results. W e also discuss negative-m ass e ects which could be probed during the expansion of a condensate m oving in an optical lattice.

I. IN TRODUCTION

The realization of B ose-E instein condensates (BEC s) in 1D optical lattices provides an in portant tool to investigate the super uid and coherence properties of m acroscopic quantum system s. Recent experiments have allowed to probe static and dynam ic features of these systems such as the Josephson e ect [1, 2], the emergence of squeezed states [3], the transition from super uid to dissipative dynam ics [4], B loch oscillations [5], interference patterns produced by freely expanding condensates [6, 7], and band spectroscopy [8].

These results have stim ulated a great interest also from the theoretical point of view, and several models have been proposed to interpret the experimental data. In particular, new analytic results have been derived in the so called \tightbinding regime", based on the assumption that the condensate wave functions in di erent sites are well separated [2, 6, 9].

A very important point would be to compare these results with the num erical solution of the full 3D G ross-Pitaevskii equation (GPE) that describes the dynam ics of BECs at very low tem peratures, allowing also for the exploration of the weak binding regime. However, in general the solution of the 3D GPE is a form idable task that su ers severe lim itations due to the large m em ory storage and com putational tim es required to sim ulate the experim ental con gurations. To overcom e these di culties the GPE is usually reduced to a 1D equation by means of a static renorm alization of the inter-atom ic scattering length [10, 11, 12], by using the fact that these systems are e ectively one-dimensional. This allows for a realistic description of the trapped axial dynam ics, but at the cost of loosing any information on the radial degrees of freedom . In general this reduction is indeed too rude, since the transverse dimensions actually play a crucial role both during the expansion, when the 1D constraint is rem oved, and during the trapped dynam ics, where the interplay between the axial and radial com ponents is necessary to account for collective excitations, e.g. quadrupole oscillations.

Recently the authors of [13] have proposed an e ective 1D wave-equation for BECs con ned in cylindrically symmetric potentials, by using a di erent approach that keeps track also of the transverse dim ensions of the condensate. The derivation is based on a variational Ansatz and the wave function of the condensate is factorized in the product of an axial component and a gaussian radial one. The axial wave function satis es a 1D non polynom ial Schrodinger equation (NPSE) that gives rem arkable results for the axial ground-state and dynam ics of cigar-shaped condensates in cylindrically symmetric traps. However, the derivation in [13] is based on the assumption of a static harm onic radial con nem ent, and therefore the NPSE is not suitable to study the dynam ics under variation of the trapping potential, in particular the ballistic expansion of the condensate after being released from the trap.

In this paper we present a new model that combines the idea of gaussian factorization with the unitary scaling and gauge transform ations of [14, 15], allowing for a suitable description of both the transverse and longitudinal evolution of elongated BECs in the presence of a time-dependent harm onic potential plus an arbitrary axial component. The above transform ations are used to reabsorb the evolution due to the time variations of the harm onic potential, the latter being replaced by an e ective con nem ent that makes feasible a gaussian factorization even in the case of a sudden release of the external con nem ent. The evolution of the system is described by an e ective 1D GPE that is dynam ically rescaled (dr-GPE) by m eans of the transform ations of [14, 15]. Despite the one dimensional character of this equation, the m odel is capable to account for the transverse dynam ics through an algebraic equation for the radial width coupled to the dr-GPE. Therefore this model represents an useful tool to describe both the dynam ics and the expansion of BECs in elongated geometries.

The Paper is organized as follows. In Section II we present the derivation of the dr-GPE, and in Section IIIA we discuss its properties in the presence of a pure harmonic potential, by making a comparison with analytical results in the Thomas-Fermi limit. In Section IIIB

we use the dr-GPE to discuss the dynam ics and expansion of BECs in the presence of 1D optical lattices, by com paring its predictions with recent experim ental and theoretical results [2, 6, 9]. We also present a method to probe negative-m ass e ects during the expansion of a condensate in the presence of an optical lattice.

II. THE MODEL

W e consider a condensate con ned in a tim e-dependent harm onic trapping potential $U_{\rm ho}$ with an additional axial component $U_{\rm 1D}$

The Gross-Pitaevskii equation for the wave-function of the condensate can be derived from the functional [16]

where N is the number of condensed atoms, $g = 4 h^2 a = m$ the coupling strength, m the atom ic m ass and a the inter-atom ic scattering length.

In order to account for the time-dependent variations of the con ning potential it is convenient to apply the unitary gauge and scaling transform of [14, 15]. Therefore we introduce a rescaled wave function $\sim(x;t)$, depending on the rescaled spatial coordinates x_i $r_i = _i(t)$ and related to the true wave function (r;t) by

The scaling parameters $_{j}$ (t) are solutions of [14]

with the initial conditions (0) = 1 and -(0) = 0.

The use of this scaling equations has two advantages: (i) the evolution of ~due to the variation of the harm onic trapping potential is mostly absorbed by the scaling and gauge transform [17] (in the Thom as Ferm i lim it j~j is frozen to its initial value); (ii) the rescaled wave function ~ always evolves in the presence of a ctitious harmonic con nement, that depends on the trapping frequencies at t = 0, and therefore the gaussian factorization is applicable even in the case of ballistic expansion, when the real trapping is turned o.

In case of elongated condensates we can obtain a 1D e ective model by factorizing the rescaled wave function (x;t) in the product of an axial component (z;t) and a gaussian radial component (x;y;t; (z;t)), allowing for an exact integration over the transverse coordinates [12, 13]

W ith this choice the transverse size of \sim is characterized by the width (z;t) that is expected to be a slow ly varying function of time, since most of the evolution due to the variation of the trapping potential is absorbed by the unitary transform (3). We note that from Eq. (3) and (5) even the true wave function can be expressed in the factorized form

The equations of motion for ~ and can be derived by using a variational procedure from the action (2), integrating out the dependence on ~. The problem can be further simpli ed in the so called \slow ly varying approximation", that is when the contribution given by the axial variations of the radial wave function ~ is negligible, $r^2 \sim r_2^2 \sim [13]$. In this approximation the action becomes

where it is possible to distinguish the contributions of the gaussian integration to the kinetic and potential energy (respectively the terms proportional to 1=2 and 2). The requirement of stationarity of this functional yields the

By combining Eqs. (11) and (12) we get a 1D nonlinear Schrödinger equation for $\tilde{}$, depending on the parameters

 $_{\rm j}$ solution of Eq. (4), that we call dynam ically rescaled G ross-P itaevskiiequation (dr-GPE). This equation is energy conserving and requires the sam e computational effort of a simple 1D-GPE, since the num erical solution of Eq. (4) is straightforward. In the particular case of a tim e-independent harm onic potential Eqs. (11) and (12) reduce to the NPSE of [13].

The contribution due to the transverse part of the energy, that has been neglected within the approximation $r^2 \sim r_2^2 \sim$, can be estimated by considering the integral

where ⁰ Q. We have veried that, in the case of a general time-dependent harm onic trapping, the contribution of this term is a negligible fraction of the total energy (less than 0:1%) in a wide range of trap anisotropies $!_z=!_?$ and number of atom s N . As we show in the next Section, even in the presence of an optical lattice along the axial direction, where the density can show deep m odulations on a short scale, the model gives quite accurate results.

In the rest of the paper we consider som e applications of the m odel and m ake com parisons with analytical results in the Thom as Ferm i (TF) limit, full 3D num erical solutions of the GPE and experimental results, where available. The parameters are chosen in the range of typical experiments at LENS [2, 4, 6]. In particular, we model condensates formed by 2 1⁴0 N 2 ⁵litom sof⁸⁷Rb in a cigar-shaped conguration with axial and radial harmonic trapping frequencies respectively $!_z = 2$ 9 Hz and $!_2 = 2$ 92 Hz.

To num erically solve the model, we use a Runge-K utta algorithm for the scaling equations and a FFT split-step m ethod for the dr-GPE evolution, m apping the wave function on a discretized lattice [18, 19, 20]. The ground state of the system is found by using a standard im aginary tim e evolution [16].




FIG.1: Comparison of the dr-GPE and TF predictions for the radial size of a condensate in a pure harm onic potential as a function of the number of atom s N. The shift between the two curves is expected since the TF approximation truncates the tails of the wave function, leading to a systematic underestimate of the ground state size, especially for small N.

III. A P P L IC A T IO N S

A. Harm onic trapping

W e start by considering the case of a condensate conned in a pure harm onic potential. As discussed in [13], the ground state axial pro le given by the gaussian factorization (5) reproduces the full 3D solution much better than other known 1D m odel in both the weakly and strongly (TF) interacting regimes. The m odel also provides reasonable results for the radial pro le: the gaussian Ansatz, though slightly overestimating the central glensity, gives a prediction for the rm s radius R rm s

 hr_2^2 i really close to the analytical TF result even in case of very large number of atom s, as shown in Fig. 1.

A remarkable feature of the dr-GPE is the possibility to describe the interplay between longitudinal and transverse oscillations induced by modulations of both the axial and radial part of the trapping potential. To illustrate this aspect we consider the low-lying collective excitations induced by a sudden variation of the transverse external con nement. In particular we start with a condensate in the ground state of an anisotropic trap with $!_{?} = 2$ 92 Hz and, at t = 0, we suddenly switch the transverse frequency to a nalvalue of $!_{?} = 2$ 80 Hz, thus inducing shape oscillations involving both the radial and axial directions. For very elongated conden-




FIG.2: Evolution of the axial (Z_{rm s}, top) and radial (R_{rm s}, bottom) sizes of a condensate performing shape oscillations, respectively obtained solving the dr-GPE and the TF Eqs. (4) and (15): in both graphs it is possible to observe the superposition of the quadrupole and the faster transverse breathing frequencies (N = 2 10^5 , !_z = 2 8:7 Hz).

sates in the TF regime, these oscillations are characterized by the guadrupole and transverse breathing frequen- $\overline{5=2!}_{z}$ and $!^{TB} = 2!_{?}$ respectively [16]. In cies, $!^{Q} = i$ Fig. 2 we show the behavior of the radial and axial sizes (respectively R $_{\rm rm~s}$ and Z $_{\rm rm~s}$ hz^2i), comparing the dr-GPE predictions with the TF values. The agreem ent is rem arkably good for both the frequency and am plitude of the oscillations; the slight shift between the two curves is expected, due to the truncation of the tails of the wave function in the TF approximation (see Fig. 1). Despite the 1D (axial) character of the dr-GPE, Fig.2 shows that the equation wellm in ics the predicted coupling between the axialand radial degrees of freedom . We have checked that the same behavior can be reproduced by changing the axial trapping instead of the radial one, or by using a resonant drive.

A nother main di erence between our model and any static 1D renormalization of the GPE (1D-GPE) comes out when we consider the ballistic expansion of a condensate suddenly released from the trapping potential. In fact, in the typical experimental regimes the free expansion of a condensate is governed by the TF equations [16]

where $_{i}$ (t) are solutions of Eq. (4) with $!_{z}$ (t) = $!_{?}$ (t) = 0. In the case of a 1D GPE a similar relation holds for




FIG.3: Axial and radial sizes (respectively $Z_{\rm rm~s}$ and $R_{\rm rm~s}$) of the condensate during a free expansion from a pure harmonic potential, as obtained with the dr-GPE and within the TF approximation in 1D and 3D.

the axial size, except that now the only scaling parameter obeys

One immediate consequence of Eq. (16) is that in the TF limit a 1D GPE equation obtained through a sim – ple renormalization of the coupling constant, although suited to reproduce the (axial) ground state of the system, in general overestimates the repulsive character of the interaction during the expansion. This is shown in Fig. 3 where we plot the axial size of the expanding condensate as obtained from the dr-GPE and the 1D and 3D TF scaling. The nice agreement between the dr-GPE solution and the full dimensional case is due to the use of the scaling equations and to the dynamically reduced nonlinearity of the equation (11) that, in the strongly interacting (TF) limit aN $j^2 j^2$, takes the form

The inset of Fig. 3 shows that even for the transverse dynamics, despite the 1D character of the dr-GPE, the agreem ent with the 3D (TF) solution is rem arkably good.

B. Optical lattice

W e now turn to consider the case of a condensate in a 1D optical lattice. Experimentally this is realized by m eans of a retro-re ected laser beam which creates a periodic potential of the form

where $_{opt}$ is the wavelength of the laser, E_r $h^2=2m _{opt}^2$ is the recoil energy of an atom absorbing one lattice phonon and s is a dimensionless parameter controlling the intensity of the lattice. Here we chose $_{opt}$ = 795 nm and intensities in the range 0 s 6 as reported in the experiments [2, 4, 6].




FIG. 4: Axial density (z) (top) and m s transverse radius, averaged only on the transverse coordinates and plotted as function of the axial coordinate (bottom); the insets show the central region of the condensate ($N = 5 \ 10^4$, s = 5).

The ground state of the system is characterized by deep periodic variations in the axial density and by pronounced m odulations in the radial width, that are well reproduced by our model even for high values of lattice intensities. This is evident in Fig. 4 where we com pare the axial density

with the full 3D solution.

To address the issue of collective excitations we consider both dipole oscillations induced by a sudden displacement of the harm onic potential (here we use z = 5 m), and quadrupolemodes excited as before by changing the harm onic transverse con nem ent.

C oncerning the form er, on general grounds one expects a frequency shift which can be explained in terms of a mass renorm alization due to the s-dependence of the dispersion relation in the lowest band of the periodic potential [4, 21]: $\binom{D}{z}$! $m = m \binom{D}{z}$. In a recent paper it has been predicted, by using a tight binding A nsatz, that the same e ective mass m can account also for the modication of the quadrupole frequencies [9]: for elongated condensates in the TF regime one expects a linear relationship between the two frequencies, $\binom{D}{z} = 5 = 2 \binom{D}{z}$, independently of the lattice intensity s.




FIG.5: E ective mass m , normalized to the unperturbed value m, as a function of the lattice intensity s, obtained respectively from the dipole (continuous line) and quadrupole (dashed) frequencies, and compared to the case of a single particle in a periodic potential (dotted). In the inset the frequency of the dipole m ode is compared with the experimental data and theoretical curve (dashed-dotted) from [2].

In Fig.5 we compare the e ective m ass extracted from the dipole and quadrupole modes with that of a single particle in a periodic potential, near the Brillouin zone center [21]. This picture shows that the predicted relation between $!_z^Q$ and $!_z^D$ is very well veri ed also in the weak binding regime of sm all s, and that the e ects of m ean eld interaction and of harm onic trapping (both included in the dr-GPE description) give only a minor correction to the single particle picture in a uniform periodic potential. Our results are also in good agreem ent with a recent experim ent realized at LENS [2], as shown in the inset of Fig. 5.

O ther interesting features of BECs con ned in 1D opticallattices are the interference e ects which take place after the rem oval of the com bined optical harm onic trapping potential. In fact, the free expansion of the system




FIG.6: A xial density of the central peak, as obtained respectively with the dr-GPE, a Schrödinger propagation and the 1D-GPE introduced in [11], com pared with the experimental distribution of [6] (the wings are due to the presence of a sm all therm alcom ponent), after $t_{exp} = 29.5$ m s.

causes the single condensates form ing the initial array to overlap and leads to the form ation of neat interference patterns, showing up as lateral peaks moving with quantized speeds $v_n = n$ $2h_{\overline{o}pt}m$ (with n integer) [6]. This is essentially a 1D e ect, which re ects the momentum distribution of the ground state along the axial direction, and it is well reproduced by our model, regarding both the position and the population of the rst lateral peaks. An interesting point concerns the axial expansion of the central peak. A careful analysis of the expanded density pro le shows that, com pared to other existing 1D equations, the dr-GPE gives a better estimate of the axial size of the central peak. In fact, as can be seen in Fig. 6, a (free) Schrodinger propagation of the ground state underestim ates the axial width, while the statically renormalized 1D-GPE introduced in [11], though appropriate to describe the ground state, largely overestim ates the axial size after the expansion, as discussed in the previous section. This is indeed due to the fact that the mean eld term of the dr-GPE has a linear character $(/ j^{-}j$ see Eq. 17) which lies between the Schrodinger (/ j f) and the GPE (/ j f) cases. Our model gives accurate predictions also for the radial expansion of the central peak, which is essentially govemed by the TF scaling solution, in agreem ent with the experim ental values and the theory of [6].

We conclude this section by discussing a time-of- ight m ethod that could be used to probe the dispersion relation in the presence of a periodic potential [23], allowing for the investigation of negative-m asse ects during the expansion in an optical lattice. The idea is the following: we start with a condensate in the ground state of a pure harm onic potential, and we accelerate it up to a given velocity v = hq=m in the axial direction, e.g. by exciting a dipole motion in the harm onic potential. Then we switch o the trap and adiabatically ram p an optical




FIG.7: Structure of the lowest bands for a single particle in a 1D periodic potential with s = 2 (solid lines), compared to the free particle case (dashed). The inset shows the behavior of the e ective mass m , inversely proportional to the band curvature, in the rst band for s = 2.

lattice along the longitudinal direction up to a desired height s. Here we consider the case of a linear ram p of 15 m s, which is su cient to ensure the adiabaticity of the process [24] for the velocities considered here. We have indeed veri ed that applying the reverse ram p after the rst one, the additional Fourier com ponents of the wave function at q 2 lg (with linteger) disappear.

W ith this procedure we can load the condensate in a Bloch state of axial guasim om entum hg and band index n, and therefore explore e ects of e ective m ass (which depends on s, n and q) far from the Brillouin zone center, during the expansion of the system . In particular, since mean eld e ects are ruled out after few milliseconds, the radial and axial expansion are alm ost decoupled, and the latter can be accounted for by the single particle mass renorm alization, as shown in Fig. 7 [8, 21]. The advantage of loading the condensate in the lattice only after the acceleration procedure is that in the reverse case the occurrence of dynam ical instability e ects prevents the possibility of accelerating the condensate above a critical velocity $v_c < v_B$ [22], where $v_B = hq_B = m = h=m$ is the Bragg velocity.




FIG.8: Evolution of the axial width of a condensate which is loaded during the expansion in a 1D optical lattice, for various velocities: $q=q_B = 1.3;1.2;0$ (continuous line), 0:4;0:685 (dotted), 0:75;0.8, respectively from top to bottom. The lattice intensity is ramped linearly in the rst 15 m s of expansion, and then kept xed at the value s = 2 for other 10 m s (see the inset).

In Fig. 8 we show the evolution of the axial size of the condensate during the expansion in the optical lattice, for various initial velocities v. The behavior of the system is essentially determ ined by the single particle e ective mass which characterizes the di usive (kinetic) term in the evolution equation (as stated before, mean eld effects become negligible after few milliseconds of expansion). Indeed, the gure shows that when q approaches the value $q = 0.6895 q_B$ at which the single particle effective mass for s = 2 becomes in nite (see Fig. 7), the expansion in the direction of the lattice gets frozen. For values between q and q_B , m becomes negative, and the condensate starts contracting. On the contrary, when




FIG. 9: A spect ratio after 25 m s of expansion, for a condensate loaded adiabatically in a 1D optical lattice of height s = 2, as a function of the condensate velocity.

the condensate is baded in the second band, that is for $q \, > \, q_B$, the expansion is enhanced due to the strong positive curvature near the second band edge.

Since the transverse expansion is only weakly a ected by the presence of the lattice, these dram atic e ects on the axial expansion can be directly measured on the as-

IV. CONCLUSIONS

We have presented an elective 1D model for the evolution of an elongated Bose E instein condensate in time dependent potentials whose radial component is harmonic, in the presence of an arbitrary axial potential. The model exploits the scaling and gauge transform ations of [14, 15], that reabsorb most of the evolution due to the time-dependent variation of the harmonic potential. This makes possible a gaussian factorization for the radial part of the condensate wave function, even in case of a free expansion after the release from the trap.

The evolution of the system is described by a nonlinear 1D wave equation (dr-GPE) for the axial wave function, dynam ically rescaled by m eans of the aforem entioned transform ations. D expite the 1D character of the dr-GPE, the m odel also accounts for the radial dynam ics of the system, that is necessary to correctly describe collective oscillations and the free expansion of the condensate.

The accuracy of the model has been tested by comparing its predictions with the TF solution in case of pure harm onic trapping and with recent experim ental and theoretical results for the dynam ics and the expansion of BECs in 1D optical lattices. We have also shown that the quasim om entum dependence of the elective mass has dram atic consequences, which could be easily accessed in the experiments by accelerating and letting expand a condensate in an optical lattice.
