Shifts of the nuclear resonance in the vortex lattice in Y B a_2 C u_3 O $_7$

The NMR and NQR spectra of 63 Cu in the CuO₂ plane of YBa₂Cu₃O₇ in the superconducting state are discussed in terms of the phenom enological theory of G inzburg-Landau type extended to low er tem peratures. We show that the observed spectra, Kum agai et al., PRB 63, 144502 (2001), can be explained by a standard theory of the Bernoulli potential with the charge transfer between CuO₂ planes and CuO chains assumed.

I. IN TRODUCTION

A lready in 1969 R ickayzen has derived the them odynam ic correction to the electrostatic B emoulli potential in superconductors and has proposed to use this correction to study the pairing interaction.¹ C apacitive m easurem ents of the B emoulli potential have not show n any signal of this correction, how ever.²^{{6} It turned out that the therm odynam ic correction is cancelled by the surface dipole,⁷ therefore, it can be accessed only by m easurem ents probing the bulk of the superconductor. For a long time, there was no experimental method to ful-

ll this task so that the therm odynam ic correction to the electrostatic potential and the related charge transfer have rem ained a theoretical topic^{8 {12} with no experim ental justi cation.

The experiment aimed at the charge transfer in the bulk of the superconductor has been performed only recently. Kum agai, Nozaki and Matsuda¹³ (KNM) reported very precise m easurem ents of the nuclear m agnetic resonance (NMR) and the nuclear quadrupole resonance (NQR) spectra fortwohigh-T_c materials, a slightly overdoped Y B a_2 C u_3 O $_7$ and an underdoped Y B a_2 C u_4 O $_8$. Comparing NMR and NQR frequencies they found that the magnetic eld, present in NMR while absent in NQR, causes changes of the electric eld gradient (EFG) in the vicinity of the nucleus. In this way they st observed the charge transfer in the Abrikosov vortex lattice. They also pointed out that the conventional theory of the vortex charge completely fails to explain the experimental data giving a wrong sign and too sm all am plitude of the magnetic eld e ect on the EFG.

In this paper we discuss the KNM experiment in terms of a phenomenological theory of G inzburg-Landau (GL) type proposed in Refs. 11,12. This theory is extended by features necessary to describe a layered structure of YBCO, in particular the CuO chains which serve as charge reservoirs. Unlike in a conventional superconductor, where the charge is transferred on a long distance from the vortex core to the region between the cores, in

the YBCO the dom inant role plays a local charge transfer between the CuO₂ planes and the CuO chains. This local transfer will be shown to explain the observed sign and am plitude of the magnetic eld e ect on the EFG. At low temperatures, there are two important corrections, the space variation of the magnetic eld and the small but nite disorientation of the axis c in individual grains of the measured sam ple.

A.Electric eld gradient e ect in the vortex lattice

Let us brie y recall the experim ent of K um agai, N ozaki and M atsuda.¹³ The 63 C u atom in the C uO₂ plane subjected to the magnetic eld, B k c, with a number of holes, N, has NMR frequencies $_1 = _{Cu}B$ and

The rst term describes the coupling of the nuclear magnetic momentum to the magnetic eld, B = 9:4 T in Ref. 13. The nucleus ^{63}Cu has spin 3/2 and its Zeem an coe cient is $_{\text{Cu}}$ = 11:312 M H z/T.

The second term of (1) is the EFG e ect. The nucleus 63 Cu has a cigar shape elongated in the direction of its magnetic momentum and this electric quadrupole feels gradients of the electrostatic eld due to a non-spheric charge of electrons and ions in its vicinity. The largest gradient of the electric eld (the principal axis of the EFG tensor) is parallel to the axis c. The density dependent contribution to the EFG is attributed to the local interaction between nucleus with d-states on the Cu site. The experimental $t^{14;13}$ to the EFG e ect yields C = 25 M Hz and A = 34 M Hz per hole.

The NQR frequency includes the asymmetry correction, $_{NQR} = _0^{-1} + ^2=3$, where is the di erence between gradients in the a and b directions scaled to the gradient in the c direction. For the Cu atom in the plane of YBa₂Cu₃O₇ the a-b asymmetry is rather weak, $1 + ^2=3 + 2:6 + 10^4$. The frequency $_0$ corresponds to the NMR in the zero magnetic eld, $_0 = C + AN_0$, where N_0 is the number of holes in the superconducting non-magnetic state.

A combination of the resonance frequencies,

would be zero if the magnetic eld has no e ect on the number of holes on the Cu sites. Actually, this is the case for temperatures above T_c . Below the critical temperature, the shift is non-zero indicating changes of the quadrupole coupling due to the e ect of the magnetic eld on the hole density. Brie y, serves as a sensor of the charge transfer in the Abrikosov vortex lattice.¹³

B.Charge transfer between chains and planes

In this paper we evaluate the shift \cdot . To motivate our approach we want to recall the way in which the experimental data are obtained. The measurement yields distributions F_{2;3} () of the NMR frequencies, see Fig. 3 in Ref.13. The frequencies $_{3;2}$, used by KNM in formula (2) are positions of the maxim a of F_{2;3} (). Since NMR lines have a nite width , each site of a local frequency $_{2;3}$ (r) contributes to the spectrum by the Lorentzian

The integral runs over the 2D volume, $= {}^{K}$ dr, covering the elementary cell of the Abrikosov vortex lattice. The magnetic eld B and the density N are functions of r, the frequencies _{2,3} depend on r via (1). The experimental magnetic eld is the mean value, B = hB i.

The nite line width is crucial for the interpretation of the KNM experiment. The observed contributions of the quadrupole shifts are less than 25 kH z which is much smaller than the width of the spectral line 140 kH z. In this limit, the maximum of the spectral line is given by the mean value and the lowest statistical variations,

The variations are important at low temperatures due to a strong compression of the magnetic eld in vortex cores resulting in a strong space-dependence of the Zeeman e ect. C lose to the critical temperature the variations vanish and the maxim a of the NMR lines approach the mean frequencies, $_{2;3}$ h_{2;3}i. C lose to T_c one nds from (1) and (2) that

A coording to (5), the shift rejects how many holes have been removed from the CuO_2 plane. The in-plane charge transfer contributes only via variations giving, as shown below, a negligible correction at all tem peratures.

C.Plan of the paper

The physical picture we assume here is based on properties of the non-magnetic state of YBCO. The superconducting state appears mainly in CuO_2 planes, in chains the gap is induced by the proximity e ect. The transition to the superconducting state shifts the chem – ical potential in the same manner as in conventional superconductors.^{10;12} This shift is large in planes, where the pairing mechanism is located, while it is negligible in chains. In equilibrium the electrochemical potential is constant so the unequal shift of the chemical potential results in the charge transfer between plains and chains, until the equilibrium condition is established by the electrostatic potential.

The magnetic eld partially suppresses the superconducting component what leads to a partial backward charge transfer. In the numerical treatment we assume both mechanisms, the transfer between chains and planes and the in-plane transfer. We show that this backward transfer between chains and planes brings the dom inant contribution to the shift .

In the next section we introduce the Law rence-D on iach model of the layered superconductor. In Sec. III we derive a set of equations for the GL function, the vector potential, and the electrostatic potential. The charge density is obtained from the Poisson equation adapted to the layered structure. In the Sec. IV we evaluate the distributions $F_{2,3}$ () from the frequencies $_{2,3}$ (r) given by (1) with the theoretical values of B (r) and N (r) obtained from the extended GL theory $^{12}.$ In Sec.V we present num erical results and discuss the individual contributions to the experim ental data. We show that the approximation (5) applies close to the critical temperature, but at low tem peratures the space variation of the magnetic eld leads to appreciable corrections. In Subsec. C we compare our results with the model for conventional (not layered) superconductors and explain why the conventionalm odel results in the reversed sign and too sm all am plitude of the line shift. In Subsec.D we include a correction for sam ples m ade of c-oriented grains and show that the deviations from the ideal orientation are important at low temperatures. Sec. VI contains a sum m ary.

II. LAW RENCE DONIACH MODEL

The model of layered superconductors has been proposed by Law rence and D oniach¹⁵, see also Ref. 16. We associate the direction z with the c axis of the YBCO and introduce a layer index j and an additional index which speci es the CuO₂ layer position, $z_j = jD - \frac{1}{2}D_{pp}$, where D = 11:65 A is the period along the axis c and D_{pp} = 3:17 A is the distance between two neighboring planes. Positions of layers of chains are $z_i^c = jD + \frac{1}{2}D$:

In the spirit of the tight-binding description, the variable z is replaced by the layer index. The wave function becomes a function of the layer index, (x;y;z) ! $_{\rm i}$ (r), and the 2D coordinate r (x;y).

A.K inetic energy

The kinetic energy is composed of parts parallel to the planes and the Josephson coupling along the caxis. The kinetic part of the free energy for the motion in the layer is treated within the isotropic e ective mass,

where A i is the in-plane component of the 3D vector potentialA (x;y;z;). The masses in both planes are identical, $m = m_p$. For simplicity we assume the 2D e ective mass m_c in the chain layer to be isotropic, too.

The motion between layers is represented by the Josephson coupling,

The phase factors of the o -diagonal term s are given by the c-component of the 3D vector potential. For B k cwe can use a gauge in which the c component of the vector potential is zero. In this gauge, all three phases are zero, j = 0. The total kinetic free energy is a sum over all layers, $F_{kin} = \operatorname{dr}^{P}_{j} (f_{kin}^{j} + f_{kin}^{j})$.

B.Condensation energy

Following Bardeen^{17;18} we use the Gorter-Casim ir free energy to describe the condensation. We assume that the energy released by the form ation of C ooper pairs is located in CuO_2 planes. In terms of the wave function the contribution of planes to the free energy reads¹²

where p is the plane contribution to Som m erfeld's (linear coe cient of the electronic speci c heat), and

is the fraction of superconducting holes in the given plane. The denom inator of (9) is the total density of pairable holes, $n_j = 2j_j f + n_{nor}^{j}$, which is a sum of the superconducting density and the density of norm alholes.

In the chains we treat the condensation energy as negligible. The free energy thus includes only the contribution due to the reduced entropy, $f_{con}^{jc} = \frac{1}{2} cT^{2^{p}} \overline{1} \overline{\$}_{j}^{c}$. The meaning of symbols is analogous to the case of glangs. Again, the sum over all layers reads F_{con} = dr f_{con}^{j} .

C.Coulom b interaction

The total density of holes is linked to the 2D density of charge, $j = en_j + k_{latt}$, which creates the electrostatic potential,

We have moved the superscript into subscript and lifted the index j since all equivalent layers are at identical potentials, $'_{i} = '_{m}$. The electrostatic potential then reads

W hen inverted, the relation (12) yields the density of charge in terms of the electrostatic potential,

In our approach the electrostatic potential is evaluated from the request of constant electrochem ical potential, and the relation (14) is used to evaluate the charge transfer.

The total free energy is the sum of the components discussed above and the Helmholtz free energy of the magnetic eld, $F_{M} = drdz \frac{1}{2_{0}} (B = B_{0})^{2}$. Note that the magnetic energy does not have a layered structure but it is given by a 3D integration. The magnetic eld is the 3D rotation of the vector potential, B = rotA.

The total free energy, F = $F_{\rm kin}$ + $F_{\rm con}$ + $F_{\rm C}$ + $F_{\rm M}$, is a functional of the wave function , the vector potential A and the norm aldensity $n_{\rm nor}$. By variations with respect to these functions one arrives at equations of motion. For the conventional superconductor, this procedure is described in Ref. 12. We do not present its straightforward modi cation for the layered structure but discuss directly the results.

A.M axwellequation

The functional variation F = A yields the M axwell equation,

In principle, Josephson currents in the c direction m ay be also present. From the translational and m irror sym – m etries it follows that no Josephson currents ow between two neighboring CuO_2 planes. A ssuming very sm all Josephson coupling between the chains and planes we neglect also the current between these layers.

The Maxwell equation (15) has the integral form

For the YBCO with its large London penetration depth, $_{\rm Lon} = 14000 \, \text{A}$, the vector potential changes only negligibly along the c axis. Indeed, the applied m agnetic eld 9.4 T results in a vortex distance of 157 A, which is small compared to $_{\rm Lon}$. The space m odulation of the m agnetic eld is thus covered by the lowest Fourier com – ponents of the Abrikosov lattice. Since the vortex distance is large on the scale of the YBCO lattice constant D, one can take the long wave length limit, k ! 0, in which (18) reads

In the approximation (19) the vector potential is identical in chain and plane layers so that we can skip its index.

B.Schrodinger equation

The Schrödinger equation of a system consisting of three periodically repeated layers has a complicated notation. We isst write down this equation in its general form and then reduce it by symmetries and the approximation of weak Josephson coupling between chains and planes. The result oriented reader can skip reading details of the equations in this section.

The variation $F = \frac{1}{j}$ results in the set of Law rence-D on iach equations

W e have used zero phases of the Josephson term s.

For B k c, all CuO_2 planes are identical, therefore, j = j = j+1 p. The chain layers are also identical, $j = j_1$ c. This simplifies the set (20) to two 2D Schrödinger equations

follow from the variation of the condensation energy. The potential in chains consists of the entropy term only.

If one neglects the e ect of the charge transfer on the material parameters $(n_p; n_c; "_{con}; _p; _c)$, the set of equations (19) and (21-22) is closed. As in the ordinary GL theory this set describes the magnetic properties of the

system . In fact, the transferred density of holes is very sm all com pared to the total densities np and nc. Therefore in the rst step, the magnetic eld B and the wave function can be evaluated from this set with no regards to the electrostatic phenom ena. The charge transfer is evaluated in the second step from the wave function .

C.Electrostatic potential

From variations of the free energy with respect to the normal densities np;c one nds the electrostatic potential¹²

The right hand sides represent local changes of the chem ical potential. Equations (23) thus express that the electrochem ical potential rem ains constant.

One can see that the electrostatic potential in planes diers from the potential in chains. At rst glance, these potentials di er by the term

W e have used the G orter-C asim ir form ula for the condensation energy, " $_{con} = \frac{1}{4} {}_{p}T_{c}^{4}$ and the assumption that the therm odynam ic properties of the superconducting phase are dom inated by planes.

For YBCO the term (24) is much larger than any other term in the set (23). This is due to a rather strong dependence of the critical tem perature T_c on the density of holes in planes. B latter's approxim ation¹⁰ of the electrostatic potential includes the second term of (24) only. For sim plicity we use B latter's approxim ation by taking

Using approximation (25) in the Poisson equation (14) one obtains the 2D density of holes needed to evaluate the electric eld gradient e ect on the NMR lines.

D.Lim it of weak Josephson coupling

W ithin the approximation (25) the electrostatic potential depends only on the wave function in planes. For a weak coupling between chains and planes, J_{cp} ! 0, the set of two non-linear equations (21) sim pli es to a single equation,

The wave function corresponds to the 3D density of pairable holes, n = $2n_{\rm p}\text{=}D$. As one expects, in the lim it of weak Josephson coupling, the magnetic properties are described by the custom ary GL theory.

To sum m arize our approach, we use the num erical code developed originally as a solver of the GL equations.¹⁹ Its modi cation to the Bardeen's approximation has been discussed in Ref. 12. The output is the magnetic eld B and the wave function . The wave function is scaled to its layered counterpart p and used in (25) to provide us with the electrostatic potential in planes. From the Poisson equation (14) we obtain the density of holes in the C uO_2 planes as

In our num erical treatm ent below we use the full expression (28). It should be noted, how ever, that the long wave length limit k ! 0, i.e., $p(k) = \frac{1}{D_{p}} (k)$, gives nearly the same result. As the relative errors due to the long wave length approximation are of the order of 10^{-3} , one can say that the charge is transferred locally from planes to chains. If the charge of planes and chains in the vortex core is sum m ed together, the vortex cores remain nearly neutral.

IV.ELECTRIC FIELD GRADIENT EFFECT

Now we are ready to evaluate the NMR lines. The energy levels of the nucleus with spin I = 3=2and spin component along the magnetic eld, m =3=2; 1=2;1=2;3=2, read⁰

Here Q is the quadrupole m om ent of the nucleus, q is the EFG which depends on the transferred charge, and is the angle between the principal axis of the EFG tensor and the magnetic eld.

The NMR frequencies are di erences between neighboring levels, $h_1 = E_{1=2} - E_{1=2}$, $h_2 = E_{1=2} - E_{3=2}$, and $h_3 = E_{3=2} = E_{1=2}$. The empirical formula (1) corresponds to the magnetic eld parallel to the axis c. W hen the magnetic eld declines from the axis c by angle , the EFG e ect on the NMR frequencies is reduced,

The amplitude of the local magnetic eld changes in space, $B = hBi + B \cdot A$ lthough the deviations B from the mean eld are rather small, they bring an appreciable contribution to the NMR frequencies on the scale of the shift \cdot . The EFG e ect depends on the angle given by disorientations of grains in the sam ple. In the appendix we show that the contribution of the magnetic eld perpendicular to the axis c which appears even in

a perfectly oriented crystal due to the layered nature of diam agnetic currents is negligible.

For a quantitative discussion of the EFG e ect, it is advantageous to compare the NMR frequency with its value in the absence of diam agnetic currents, $_{2;3} = \frac{_{2;3}^{ref}}{_{2;3}}$

where $C_u = 14.38 \text{ A}^2$ is the area per C u atom in a single plane. The density p^0 describes the transfer of holes in the non-m agnetic state. Since the non-m agnetic state is isotropic, i.e., it has only the component k = 0, from (25) and (28) one nds

A . A verage over grain orientation

So far we have discussed a single crystal. The sample m easured by KNM 13 is made, how ever, from c oriented grains. O fcourse, there is a sm allbut nite scatter in the orientation of individual grains. The angle then varies from grain to grain keeping its value independent of the tem perature and the magnetic eld, provided that the applied magnetic eld is parallel to the m ean orientation. The observed NMR lines are the average over all grains.

W e assume that the azim uthal and the polar angles and are given by the Boltzm ann distribution,

where E_{or} is the energy needed to disorient the grain during a preparation at tem perature T_{prep} . One can integrate out the polar angle,

For $E_{or} = k_B T_{prep}$, which is a necessary condition to prepare a well oriented sample, the large angles are very unlikely and one can use the approximation

where $c^2 = k_B T_{prep} = E_{or} m$ easures the scatter of angles.

The average over the orientation of grains has to be performed in addition to the natural line width. The observed distribution of frequencies thus reads,

The integral over in (38) can be evaluated analytically in term softhe exponential integral of com plex arguments. This step, however, is not favorable numerically. A faster numerical scheme is obtained if one rst evaluate the distribution $F_{2,3}$ of an ideally oriented sample via (3) with the NMR frequency of a perfectly aligned m agnetic eld (1). The angular averaging is then covered by a convolution,

From the experimental data of KNM we estimate 140 kHz and $\frac{3}{2}_{0}$ $_{c}^{2} = 0.9 = 126$ kHz. For these values the maximum of the lower NMR frequency is shifted by 78:3 kHz while the maximum of the upper frequency is shifted by 78:3 kHz. This shift appears at any temperature and it is subtracted in the evaluation of the EFG e ect. The upper integration limit, $^{2}=4^{2}_{c}$ 10^{3} , can be replaced by in nity or a smaller cut o at convenience.

V.NUMERICAL RESULTS

O ur num erical treatm ent follows the three steps m entioned above. In the rst step we evaluate the G L function (r) and the magnetic eld B (r) of the Abrikosov vortex lattice using Bardeen's extension of the G L theory represented by the set of equations (19,26-27). In this step we take the magnetic eld as parallel to the axis c neglecting its small perpendicular component in individual grains.

In the second step we use B latter's approximation (25) to evaluate the electrostatic potential in planes from the wave function. The charge density is obtained from the Poisson equation (28) and is rescaled to the transfered number N (r) of holes per Cu site via (33).

In the third step we evaluate the local NMR frequencies for the magnetic eld parallel to the axis cusing (32) with = 0. The distribution F of the NMR frequencies for a single crystal with B k c is obtained via space averaging of Lorentzian lines (3). The distribution F of the NMR frequencies for the granular sample is obtained from F via the convolution (39). The maximum frequencies $_{2,3}$ of the crystal and granular samples are found from the maxim a of $F_{2,3}$ and $F_{2,3}$, respectively. The latter one can be compared with the experimental results of KNM, the former represents our prediction for sim ilar measurements that, as we hope, will be performed on single crystals in future.

The material parameters of the $YBa_2Cu_3O_7$ from Ref. 21 are: the density of pairable holes n=5 10^{27} m 3 , the elective mass m $_{\rm p}$ = $6.92\,{\rm m}$ e, the critical temperature T_c = 90 K, and the Sommerfeld constant $_{\rm p}$ = 302 JK 2 m 3 . These values give a London penetration depth $_{\rm Lon}$ = 1.4 10 7 m, an upper critical eld B_{c2} = 96.5 T, and a GL parameter at the critical temperature $_0$ = 55. In Fig. 2.16 Plakida^{21} shows results of Junod^{22} according to which the charge transfer $0.03\,e$ from chains to planes per Cu site leads to a decrease of the critical temperature by 30 K. This corresponds to 0 $\ln T_c$ =0 $\ln n_p$ = 4.82. We take the permittivity = 4_0 . We do not discuss the YBa_2Cu_4O_8 for which we could not not relevant material parameters.

A.Space variation of the NMR frequency




FIG.1. The lowerNMR frequency $_2$ (r) in the crystalat $T = 0.6 T_c$. The frequency releases the triangular structure of the Abrikosov lattice. The maxim a are at the vortex cores.

Figure 1 shows the shnet plot of the lower NMR frequency $_2$ (r) for T = 0.6 T_c and = 0. The variation is of the order of 100 kHz, which is comparable to the line width.




FIG.2. The Zeeman e ect $_{z}$ (r) = $_{Cu}$ B (r) (upper), and the EFG e ect $_{EFG}$ (r) = A N (r) (lower). Parameters are the same as in Fig. 1.

In Fig.2 we plot the contribution of the Zeem an e ect, $_{Z} = _{Cu} B$, and the EFG e ect, $_{EFG} = A N$ separately. One can see that the Zeem an e ect is about seven times larger that the EFG e ect. The main contribution to the spatial variation of the NMR frequency is thus due to the compression of the magnetic eld in vortex cores. On the other hand, the EFG has nonzero m ean values, therefore, it contributes more to the observable shift of the maxim a of the NMR line.




FIG.3. The Zeeman e ect $_{\rm Z}$ (r) = $_{\rm Cu}$ B (r) (upper), and the EFG e ect $_{\rm EFG}$ (r) = A N (r) (lower), for T = 0.9 T_c.

At tem peratures close to T_c , the space variation of the Zeem an e ect is reduced following the reduced compression of the magnetic eld in the vortex cores. Fig. 3 shows a decomposition of the lower NMR line into the Zeem an part and the EFG e ect for $T = 0.9 T_c$. One can see that here the amplitude of the EFG e ect is close to the amplitude of the Zeem an e ect. Note that the mean value of the EFG is larger than its spatial variation. This signals that the mean value provides a good approximation at this tem perature.

B.NMR lines of a single crystal




FIG.4. The distribution F_2 () (solid line) compared with the Lorentz distribution $F_{\rm Lor}$ () = $\frac{1}{2+2}$ (dashed line) at T = 0:6 $T_{\rm c}$ and = 50 kHz. The experimental line width is = 140 kHz. We use the narrow line to make its deform ation more visible.

Above the critical temperature, the NMR lines of a single crystal are given by the Lorentzian distribution. Below T_c the space variation of the magnetic eld deform s the lines so that their centers of mass (i.e., mean values) are not identical to their maxima, see Fig. 4.

The deform ation of the NMR line seen in Fig. 4 can be correlated with the space distribution of the NMR frequency presented in Fig. 1. The vortex cores supply frequencies in the range from zero to 75 kH z above the m ean value. Their contribution is visible as the extended left shoulder of the line in Fig. 4. The interm ediate region between vortices supplies frequencies about 25 kH z below the m ean value. Their contribution results in a shift of the m axim um of the NMR line.




FIG.5. The maxima $_{2,3}$ (dashed lines) and mean values h $_{2,3}i$ (full lines) of the lower and upper NMR lines (below) as a function of temperature. The corresponding shifts, $=\frac{1}{2}(2)$ ($_2$) and h $i=\frac{1}{2}(h + 3i)$ h $_2i$) are plotted above.

The temperature dependence of the mean values $h_{2;3}i$ and the maxim $a_{2;3}i$ is presented in Fig. 5.

The mean value is independent of the space variation of the magnetic eld, h $_{2;3}i = _{Cu}hBi$ AhN i = AhN i, because hBi = 0 by de nition. The di erence between the mean value and maximum thus shows the e ect of the spatial variation of the magnetic eld on the position of the maximum. Since the mean value is proportional to the charge transfer while the position of the maximum is a rather complicated quantity, the tem perature region in the vicinity of T_c is more recommendable for the experimental exploration. We reserve the symbol T_c for the critical tem perature in the absence of the magnetic eld, $T_c = 90$ K. In the magnetic eld B = 9:4 T, the actual phase transition is at T = 0:931 T_c .

The deviation of the maximum from the mean value depends on the line width. This is illustrated in Fig. 5 by the line of articially chosen width = 50 kHz. In the limit of very broad lines, ! 1, the position of the maximum becomes identical to the mean value. This trend is also seen from the formula (4).

C.Conventionalm odel

Let us make a small detour and assume that there is no charge transfer between chains and planes. In other words, no screening by chains is assumed and the charge is transfered exclusively inside the CuO₂ planes. In this case the system would behave as a conventional superconductor in which the charge is transfered from the vortex cores into the region between them. In this model, the charge density is given by $_{\rm p}$ = $\prime_{\rm p}$ =L_{pp}, while other relation remain the same as in the case of the above layered m odel.




FIG.6. Them axim a $_{2,3}$ of the lower and upperNMR lines as a function of tem perature (below) and the shift (above) in the absence of screening chains.

O ne can see in Fig. 6 that the sign of is opposite to the sign of the model with screening by chains. A lso, the magnitude of is extrem ely small. A typical shift is less than 1 Hz while the typical shift is more then 1 kHz in the case where the chains are accounted for. The values observed by KNM are about 10 kHz. O ur result thus con rms the estimate of KNM that the conventionalm odel of the vortex charge fails to explain their experimental data.¹³

W hen the transfer between chains and planes is prohibited, the am plitude is reduced by twom echanisms. First, the charge transfer accross the vortex core happens on a distance which is much larger than the distance between chains and planes. Second, the mean value of the shift is zero, h_ii = 0, because the charge of planes is conserved, N₀ hN i = 0. The line shift thus results merely from the statistical variations which are small due to the large line width, see (4).

A n explanation of the reversed sign follows the argum ent given already by KNM \cdot^{13} Since the magnetic eld is m uch sm aller than H $_{c2}$, the area of vortex cores is m uch sm aller than the area between them . A coordingly, cores have a negligible weight in statistical variations so that the charge between cores determ ines the line shift. This charge is opposite to the charge of cores, consequently the reversed sign of the line shift results from the conventionalm odel.

D.A veraging over grain orientation




FIG.7. The maxim a $_{2;3}$ of the lower and upper NMR lines as a function of temperature (below) and the shift h i (above) of = 140 kHz of Fig.5 com pared with the averaging over grain boundaries according to (39).

A sm entioned, KNM have used a granular sam ple with a high but not perfect orientation of YBCO grains.¹³ The averaging over the grain orientation (39) results in an additional shift of the NMR frequencies, see Fig. 7. The grain disorientation contributes mainly at low temperatures where it leads to shifts of about 5 kHz, while the value predicted for the single crystal reduces with tem – perature.




FIG.8. Comparison of the theory with experiment. The experimental data are the dots with error bars, the theoretical prediction is the full line and the theoretical value for the single crystal is shown as a dashed line.

Figure 8 com pares our theoretical results with the experim ental data of KNM . Apparently, the agreem ent is only qualitative. We have obtained the correct sign but the theoretical amplitude is about two or three times sm aller than observed.

In the tem perature dependence one can identify three regions. Above the critical tem perature there is no charge transfer between chains and planes. Indeed, neglecting the second temms in the potential (23) we have neglected the therm ally induced charge transfer in the norm alstate which appears for unequal energy derivatives of the density of states, $\ell_p = \ell_n \in \ell_c = \ell_n c$. The experimental data of KNM ¹³ above the critical tem perature justify this neglect.

In the narrow region between T_c and 0.93 T_c the sam – ple is superconducting only if the magnetic eld is absent. The NQR frequency is thus measured in the superconducting state while the NMR frequencies are measured in the normal state. In this temperature region the observed frequencies are free of space uctuations giving a direct experimental access to the charge transfer caused by the superconducting transition. Since in both cases (NMR and NQR) the magnetic eld and the transfered charge are hom ogeneous, the averaging over the grain orientation is the sam e as in the normal state above T_c . A ccordingly, the granular sample used by KNM should provide data com paring well with the single crystal. Unfortunately, this region is not covered by su ciently detailed data in Ref. 13.

The region between 0:93 $T_{\rm c}$ and $T_{\rm c}$ can be used to experimentally test our assumption about the charge transfer between chains and planes. In the absence of the charge transfer between chains and planes, the shift is exactly zero since there are no vortices to cause the in-plane transfer.

Below $0.93 T_c$ the sample is superconducting even in the presence of the magnetic eld, i.e., the Abrikosov vortex lattice enters the game. Let us rst discuss the

m ean value. W hen the magnetic eld penetrates the sample, the superconductivity is suppressed in the vortex cores. The charge transfer induced by vortices is crudely proportional to the product of the superconducting fraction and the area of the vortex core. As the tem – perature is reduced, the superconducting fraction grows while the diam eter of the vortex cores shrinks down. For a GL parameter independent of the tem perature, the product remains constant. W ithin Bardeen's approximation the GL parameter slightly decreases with the tem perature, 12 therefore, the charge transfer reduces as T $! \ 0.$

At temperatures below 0:7 $T_{\rm c}$ the maximum of the NMR line in the granular sample is strongly shifted by the angular averaging. According to our results, the granular samples in this temperature region cannot be used to access material properties.

VI.SUMMARY

W e have shown that the experimental results of Kum agai, Nozakiand M atsuda can be explained in terms of a standard theory of the electrostatic eld in superconductors extended by features necessary to describe the layered structure of YBCO. The agreement of our theory with the experiment is only qualitative. Our results thus do not exclude possible alternative mechanism $s^{23;24}$.

In conclusion, the charge transfer between CuO chains and CuO₂ planes in YBa₂Cu₃O₇ provides a qualitative explanation of the electric eld gradient e ect on the NMR lines. At low temperatures the e ect of the charge transfer is spoiled by two additional e ects: the space m odulation of the Zeem an e ect reduces the shift of the m axim a of the NMR lines; the disorientation of grains in the sample increases the shift. From this point of view it is advisable to m ake precise m easurem ent near the critical tem perature where the charge transfer dom inates.

Our study does not cover two realistic features that can increase the amplitude of the observed shift of NMR lines tow ards the experim ental values. First, the charge is transfered from the copper to the apex oxygen, i.e., the distance between planes and chains D $_{\rm cp}$ = 424 A should be reduced to the Cu-O distance 2.3 A. This will enhance the charge transfer by a factor 1.8. We did not include this simple correction as its consistent implementation requires to use the non-local dielectric function and the m icroscopic treatment of electronic states. A similar type of enhancement would result from a higher value of the dielectric constant. We have used $= 4_0$ while values as large as = 100_0 has been advocated.²⁵ Second, the magnetic anisotropy of YBCO enhances the deviations of the magnetic eld from the axes c in individual grains. At low tem peratures this e ect should be stronger in agreem ent with the observed trends. This correction is om itted because of an unknown vortex pinning.

It is apparent from the experimental data of KNM

that an explanation of the NMR lines in the underdoped $Y B a_2 C u_4 O_8$ will be more complicated. Unfortunately, we could not discuss $Y B a_2 C u_4 O_8$, because we have not found a relevant set of material parameters.

APPENDIX A: INNATE PERPENDICULAR MAGNETIC FIELD

The magnetic eld perpendicular to the axis c appears in the sample from two sources. First, the observed sam – ples are made from many grains with a small but nite scatter of the orientation of the c axis. This contribution is discussed in the main text. Second, since diam agnetic currents are in planes, the magnetic eld is more com – pressed in layers of planes than in layers of chains. This part of the perpendicular eld is innate to the layered system and appears also in single crystals.

Here we show that the innate perpendicular m agnetic eld can be neglected. The m agnetic eld is given by the vector potential A. For B k c, the component of A along the c axis is zero, see (17). The perpendicular m agnetic eld thus reads,

The vector potential (17) has a cusp at the positions of layers. This cusp appears due to the singular 2D current of the selected layer, say at z_j^+ . From the m irror symmetry follows that the current in the z_j^+ -layer does not contribute to the perpendicular magnetic eld in the center of this layer, i.e., at z_j^+ where the Cu nuclei sit. We can thus avoid the cusp by taking neighbor layers only. The m irror symmetry also shows that all equivalent $z_{j^0}^+$ layers spaced symmetrically above and below z_j^+ give zero net contribution. A coordingly, the perpendicular magnetic eld in the vicinity of z_0^+ (for $j_z \quad D_{pp}=2j \quad D_{pp}=2)$ is given by the reduced vector potential,

The maximum of the current is at the edge of the vortex core, i.e., at r 2^{-} , where = = is the GL coherence length. The amplitude of the vector potential at this point, A = $_{0}=(2 \text{ r}) = _{0}=(2 \text{ p} - 2)$, gives the current density $_{0}\text{j} = A = ^{2} = _{0}=(2 \text{ } 2^{-3})$. For the YBCO parameters, (D $_{2}\text{D}_{\text{pp}}$)=4 = 1.33 A, = 55, and = 1400 A, one nds B₂ 6 10^{4} T. This eld is far too small shifting the NMR line by $_{0}\frac{3}{2}\sin^{2}$ 0.2 Hz. We have used $_{0}$ = 31.5 MHz.
