M agneto-optical re ectivity of superconducting M qB_2 single crystals

W e present m agneto-optical re ectivity results in the basal-plane of the hexagonal M gB₂. The data were collected on a mosaic of M gB₂ single crystals with $T_c = 38$ K from the ultraviolet down to the far infrared as a function of temperature and m agnetic eld oriented along the c-axis. In the far infrared there is a clear signature of the superconducting gap with a gap-ratio 2 =k $_B$ T_c 12, well below the weak-coupling value. The gap is suppressed in an external magnetic eld, which is a function of temperature. W e extract the upper critical eld H $_{c2}$ along the c-axis. The temperature dependence of H $_{c2}$ is compatible with the H elfand-W ertham er behaviour.

Since the discovery of superconductivity in M gB₂ with T_c 40 K [1], substantial experim ental activity has been devoted to elucidate the nature of its superconducting state. The issue is to assess whether M gB₂ is one of the best-optim ized B ardeen-C coper-Schrie er (BCS) m aterials or whether its superconducting properties stem from a novel pairing m echanism. The amplitude of the superconducting gap and its spectroscopic signature, as a function of tem perature and m agnetic eld, are expected to depend on the driving m echanism [2].

Infrared spectroscopy is a very prom ising and powerful method for the observation of the gap. Optical experiments, besides being contact-less techniques, o er the in portant advantage that the electrom agnetic radiation penetrates deeply inside the bulk. Analysis of previous optical data [3, 4, 5, 6] revealed gap values in the range 2 3 6 m eV, which are rather sm all com pared to the BCS estimate 2 = 12 meV [2]. The range of superconducting gaps proposed for M gB₂ is even wider when considering other techniques, such as Ram an or tunneling spectroscopy, photoem ission or specicheat [7, 8, 9, 10, 11], which yield values of 2 between 3 and 10 m eV. This wide spread of gap values is also accompanied in some cases by deviations from the BCS tem perature dependence, pointing to com plex behaviour in this novel superconductor. Possible origins of the large gap distribution m ight include e ects associated with the sam ple quality (i.e., in perfections and distribution of the surface composition) and with the specimen type (i.e., polycrystalline or lm s). More intrinsic origins of the wide range of gaps com prise the existence of an anisotropic (s-wave) superconducting gap as well as a multi-gap mechanism [12]. It has been also conjectured that the di erent values of the gap m ight be partly explained by the preferential sensitivity of particular experiments to dierent portions of the gap distribution [12].

Here, we present infrared re ectivity data R (!) on high quality single crystals of M gB_2 with well-characterized optical surface parallel to the basal-plane. We focus our attention to the dependence of R (!) to the magnetic eld oriented along the c-axis at selected tem peratures close to and below T_c . The corresponding real part of the optical conductivity exhibits a depletion of oscillator strength due to the opening of the superconducting gap. The gap size is less than half the value expected from an isotropic BCS model. By applying magnetic elds along the c-axis we induce a suppression of superconductivity, as suggested by the disappearance of the gap. W e extract the upper critical eld H $_{c2}$ along the c-axis and nd it to be compatible with the Helfand-W ertham er [13] calculation. This seem s to indicate that no unconventional m echanism needs to be invoked to explain the bulk upper critical eld. M oreover, our magneto-optical results suggest a dirty-lim it m etallic norm al state.

Single crystals of M gB₂ with $T_c = 38$ K were grown using a high-pressure cubic anvil cell and were synthesized from a precursor mixture of 99.9% pure M g pow-der and 97% pure am orphous boron. The crystals were grown in a BN container of 6 m m diam eter under a pressure of 30 kbar. The tem perature was increased up to $1800 \ ^{\circ}$ C and kept constant for 0.5 h. The tem perature was then decreased and pressure released. F lat crystals of M gB₂ of a size up to $1.2 \times 0.8 \times 0.05$ m m³ have been obtained [14]. W e built a m osaic consisting of three crystallites from the same batch and with optical surface oriented perpendicular to the c-axis.

W emeasured the optical reectivity R (!) in the basalplane of the hexagonal M gB $_{\rm 2}$. The m osaic had an optical m easurable surface of 2x2 mm². The largest crystallite has been placed in the center of the mosaic. A series of m easurem ents identifying di erent spots on the specim en were performed and equivalent results were collected, excluding important e ects due to the surface scattering. In the far infrared (FIR) spectral range, data were collected as a function of temperature (1:5 300 K) and with varying magnetic eld H (0 7 T) oriented along the c-axis with possible m is a liquid ent of less than 5^0 . The FIR spectral range (i.e., 20 600 cm⁻¹) was covered with a Bruker Fourier spectrom eter equipped with He-cooled G e bolom eter detector and with an O xford m agnet cryostat with appropriate optical windows. We present our

FIR results down to approximately 25 cm 1 , the lower frequency limit where the collected data are reproducible over several runs and in dimensions of tem – perature and magnetic eld. Because of the mosaic conguration of our specimen as well as the residual surface scattering and dimensional limit elects, we cannot fully trust the data below 25 cm 1 .




FIG.1: Magnetic eld dependence (H k c) of the far infrared optical re ectivity R (!), measured in the basal-plane, of a mosaic of M gB₂ single crystals at (a) 1:6 K and (b) 20 K. The re ectivity at 40 K in zero eld is shown in both gures, as reference for the normal state behaviour. The arrow marks the energy where total re ection is reached at 1:6 K, as signature for the superconducting gap. The thin dotted line highlights the extrapolation towards zero energy for the K ram ers-K ronig transform ation. The inset in part (a) gives the overall behaviour of R (!) at 300 K up to 10^5 cm⁻¹.

Figure 1 provides an overview, showing the magnetic eld dependence of R (!) in FIR at 1:6 and 20 K [15]. The norm alstate R (!) at 40 K and 0 T is shown in Fig. 1, as well. At zero eld R (!) at T < T_c is rem arkably enhanced below 50 cm ¹: R (!) at 1:6 K reaches the total re ection at about 30 cm¹, while R (!) at 20 K is still enhanced but only approaches the total re ection. By applying a magnetic eld along the c-axis, the obvious trend at all tem peratures is to reduce the enhancem ent of R (!) (e.g., already at 1:6 K and 4 T R (!) clearly deviates from the total re ection behaviour seen at 0 T). At any tem perature, there is a speci c m agnetic eld for which R (!) recovers the norm al state shape. We have also veried the eld independence of R (!) above 38 K . It is worth mentioning that our FIR results in zero eld merge nicely with the submillimeter range data of Pimenov et al. obtained with a M qB_2 lm [3]. As it will be stressed below, the change of slope in R (!) for $T < T_c$ with respect to the norm all state behaviour (i.e., at 40 K) is associated to the optical manifestation of the superconducting gap (arrow in Fig. 1a). W hile the overall R (!) shape below T_c is compatible with the BCSlike behaviour [2], we note the rather pronounced drop of R(!) in FIR. This leads to a shallow minimum in R(!) at about 100 cm ¹ [15], which bears a striking sim ilarity with the result on thin $\ln [3]$. In passing, the consequence of such a minimum is an excitation spectrum, which may be interpreted within a multiband (i.e., two-D rude com ponent) scenario [15, 16, 17]. Above 50 cm $^{-1}$

the spectra were found to be tem perature and m agnetic eld independent. The inset of Fig. 1 displays an overall view of R (!) at 300 K, measured up to 10^5 cm 1 , which is in fair agreement with R (!) on Ims and dense polycrystalline sam ples [3, 16, 18]. Therefore, the 300 K re ectivity was used in the K ram ers-K ronig transform ation in order to calculate the optical conductivity. To this end, the standard extrapolation was employed above 10^5 cm 1 [19]. Below 25 cm 1 R (!) at T > T_c was extrapolated using the H agen-R ubens law [19]. Below T_{c} , R (!) was approximated to 100% when R (!) reached total re ection at nite frequency in the measured spectral range, otherw ise R (!) was assumed to gradually increase to 100% for ! ! O. A Iternative extrapolation methods were checked for ! ! 0 but this issue does not a ect the main argum ent of our discussion.




FIG.2: Magnetic eld dependence (H k c) of the conductivity ratio $_{1s} = _{1n}$ at selected tem peratures in the FIR spectral range. The norm alstate $_{1n}$ corresponds to the m easurem ent at 40 K in zero eld.

Figure 2 shows the magnetic eld dependence of the ratio of the real part $_1$ (!) of the optical conductivity to its norm al state value (at 40 K) at selected tem peratures. Focusing rst on the 0 T data, we observe the

strong depletion of $_1$ (!) for T < T_c. The conductivity is very sm allor even zero (i.e., as a consequence of the total T_c (Fig. 1)) below 30 cm 1 and then re ection for T increases m onotonically at higher photon energies. W e identify the frequency, where the onset of absorption (i.e., increase of $_1(!)$, Fig. 2) occurs, as the superconducting gap value. The superconducting gap 2 31 cm 1 T_c for our M gB₂ single crystal agrees (3:8 m eV) at T fairly well with those previously achieved with optical methods on lm s (3 5 m eV [3, 4, 5]), as well as on polycrystalline samples (3 4 m eV [6]). The resulting gap-ratio 2 = $k_B T_c$ 12 seems to con m the trend of an optical superconducting gap in M gB₂ substantially below the estim ate of the weak-coupling BCS theory [2].

There is an increasing consensus for a double gap scenario [20, 21]; the larger gap with $2 = k_B T_c$ 4 associated with the two-dimensional -band and the smaller one with 2 =k_BT_c 13 associated with the threedimensional -band [22]. All optical data consistently show a single gap feature [3, 4, 5, 6] and seem to rather yield the lower lim it of the gap distribution. W hile theoretical calculations of the optical conductivity within a multi-gap scenario would be imperative, we note another intriguing aspect of our data: the optical conductivity rises in a s-w ave like m anner but m uch m ore steeply than a Mattis-Bardeen (MB) calculation for photon energies larger than the gap [2, 23]. A sim ilar situation was encountered already in the superconducting fullerenes [24]. It was shown that the E liashberg form alism can explain this behaviour. It goes beyond the MB calculation by taking into account a realistic phonon spectrum (i.e., also phonon assisted absorptions, like in the Holstein process) and arbitrary in purity scattering [15, 24].




FIG.3: Temperature dependence of H $_{c2}$ along the c-axis, evaluated from the optical experiment. The thick dashed line is compatible with calculations due to Helfand and W ertham er (HW) [13].

Another key aspect of this study is the possibility to exploit bulk sensitive and contact-less optical data in order to extract the upper critical eld H _{c2} along the caxis. The elds for which the norm al state is recovered (i.e., the conductivity in Fig. 2 yield a ratio close to one) represent the optical counterpart of H $_{\rm c2}\,$ along the c-axis. These characteristic elds are shown in Fig. 3 [25]. W hile the tem perature-grid considered here does not allow any conclusion about possible anom alous curvature of H_{c2} (T) (particularly close to T_c), it is safe to say that our values of H $_{\rm c2}$ are compatible with the tem perature dependence derived by Helfand and W ertham er (HW) (Fig. 3) [13]. This also agrees with the trend seen in other experiments [26, 27, 28]. The roughly linear tem perature dependence of H c2 above 20 K, besides being in broad agreem ent with the BCS theory [2], allows the determ ination of H_{c2} (0) within the HW approach: 0:7 (dH_{c2}=dT)T_c = 5:2 T [13]. This value is in H_{c2} (0) accord with the T ! 0 lim it of the optical estimation of H $_{c2}$. O ur values of H $_{c2}$ along the c-axis are somehow larger than those estim ated from the therm al conductivity [26], torque m agnetom etry [27], m agnetization and specic heat [28] on single crystals. As far as the com parison with magneto-transport data is concerned, our H $_{\rm c2}$ values agree perfectly with the most recent data of W elp et al. [28] but are substantially lower than those of Sologubenko et al. [26]. In order to explain the discrepancy between H $_{\rm c2}$ from the therm alconductivity and from the resistivity, Sologubenko et al. argued that surface e ects are in portant in relation to superconductivity.

From $H_{c2}(0)$ 52 T along the c-axis, we can calculate the coherence length in the basal-plane [13]: (0) = $(0:7 \quad 0=2 \quad \text{H}_{C2}(0))^{1=2}$ 7 nm, a value in broad agreem ent with estimations from other experiments [12, 26, 28]. For com parison, the BCS coherence length, calculated with the expression $_0 = hv_F = (0)$ 52 nm using the opti-15 cm 1 , is three times larger than the calqap (0) value $_{0} = hv_{F} = 1.76k_{B}T_{c}$ $17 \text{ nm for } T_c = 38 \text{ K}$ and the Ferm ivelocity $v_F = 4.8 \times 10^7$ cm =sec [2,22]. O by iously, these values of 0 su er from the fact that the gap ratio is sizeably smaller than the weak-coupling lim it prediction (i.e., $2 = 3.52k_{\rm B}T_{\rm c}$). In accordance with previous optical investigation [4, 5, 16], our norm al state properties 1.8x10¹⁴ sec [15], which suggests a relaxation time leads to the m ean free path l= v_F = 8.5 nm . Our value of l is sm aller than or at most com parable to the coherence length. This, together with the fact that the optical scattering rate 1= 2, puts M gB_2 among the so-called dirty lim it superconductors [2]. All optical experim ents so far [3, 4, 5, 6, 16, 18] unanim ously support the dirty lim it scenario. However, this is a controversial and puzzling issue, since magnetic and therm odynamic probes are more in favor of the clean lim it [26, 28].

In summary, we have performed magneto-optical measurements on M gB₂ single crystals. Besides identifying the signature of the superconducting gap with $2 = k_B T_c$ 1.2, we have also extracted H_{c2} along the c-axis. It remains to be seen how one can reconcile an overall BCS-like H_{c2} with less conventional manifestations of the superconducting state, like the small gap value. Moreover, the controversy about the clean versus dirty limit scenario awaits resolution.
