Abstract

We study the steady state properties of a 2D granular mixture in the presence of energy driving by employing simple analytical estimates and Direct Simulation M onte Carlo. We adopt two different driving mechanisms: a) a hom ogeneous heat bath with friction and b) a vibrating boundary (therm alor harmonic) in the presence of gravity. The main indings are: the appearance of two di erent granular temperatures, one for each species; the existence of overpopulated tails in the velocity distribution functions and of non trivial spatial correlations indicating the spontaneous formation of cluster aggregates. In the case of a uid subject to gravity and to a vibrating boundary, both densities and temperatures display non uniform proles along the direction normal to the wall, in particular the temperature proles are di erent for the two species while the temperature ratio is almost constant with the height. Finally, we obtained the velocity distributions at di erent heights and veri ed the non gaussianity of the resulting distributions.

I. IN TRODUCTION

G ranularm aterials present a rich and intriguing phenom enology, which has attracted the interest of the scientic community since the nineteenth century [1]. However, in spite of its recent progress the theoretical study of granular gases, i.e. of uidized granular particles, is certainly less advanced than that concerning ordinary molecular uids. The reason for this state of a airs is the presence of dissipation due to inelastic collisions and of friction with the surroundings, which prevents these system to reach therm odynam ic equilibrium. In fact, in order to render stationary a granular system one needs to inject continuously energy into the system. This can be done, for instance by shaking or vibrating the grains.

In the present paper we illustrate the results of a num erical investigation concerning the properties of a two component granularm ixture, modeled, following an established tradition, by inelastic hard spheres (IHS) with di erent masses, restitution coe cients, radii, and subject to di erent forms of external drive. The physical motivation for our study stems from the fact that in nature most granularm aterials are polydisperse from the point of view of their sizes and/or of their physical and mechanical properties. The theoretical study of granularm ixtures has attracted so far the attention of several researchers[2, 3, 4, 5]. These studies comprehend both freely cooling and uniform ly heated granularm ixtures and have been performed almost contemporaneously with laboratory experiments [6, 7]. The most striking outcom e is the lack of energy equipartition, i.e. the presence of two di erent kinetic tem peratures, one for each species.

In the present paper our interest will be concentrated on the stationary state obtained by applying an energy feeding mechanism, represented by a uniform stochastic driving force or by a vibrating wall. In the rst case the work of Barrat and Trizac [4] and Garzo et al. [5] provides a simple theoretical account, based on the Boltzm ann equation approach and on the Direct Simulation M onte Carlo method (DSMC) [8, 9], of the lack of energy equipartition.

The present work di ers from the recently appeared papers dealing with granularm ixtures in several aspects:

the heat bath, which drives the system, is at nite tem perature, since we have introduced a nite friction of the particles with the surroundings and we have considered the possibility of having spatially inhom ogeneous states;

in addition, we considered a second situation in which the particles subject to a vertical gravitational eld receive energy an isotropically from the bottom vibrating wall of the container;

in both cases we provide information about the presence of inhomogeneities in the system, e.g. density clustering and non-uniform density and temperature pro les.

In Sec. II we present the model uid and two di erent mechanisms of energy supply. In sect III we discuss the rst sub-model, the one with the heat bath, and obtain by means of an approximate analytic method an estimate of the partial temperature of each component. Subsequently we study the same sub-model with a D SM C algorithm. In sect. IV we study numerically the second sub-model (the one with gravity and vibrating wall) by means of D SM C simulations. Finally in the last section, V, we present our conclusions.

II. DEFINITION OF THE MODELS

We shall consider a dilute inelastic gas constituted of N₁ particles of m ass m₁ and N₂ particles of m ass m₂ subject to some kind of external driving (this will be specified in the following). We suppose that the interactions between the grains can be described by the smooth inelastic hard spherem odel (IHS) [10], thus we specify only the radius of the spheres, their m asses and the fraction of the kinetic energy dissipated at each collision. This can be done by dening three different restitution coecients $_{ij}$, i.e. $_{11}$; $_{22}$, and $_{12} = _{21}$, which account for normal dissipation in collisions among particles of type i and j. No internal degrees of freedom (e.g. rotations) are included.

O ne can describe the velocity changes induced by the instantaneous inelastic collisions of sm ooth disks labeled 1 and 2 of diam eter $_1$ and $_2$ by the following equations:

where $f_1 = 2(x_1 x_2) = (1 + 1)$ is the unit vector along the line of centers x_1 and x_2 of the colliding disks at contact and x_1 ; x_2 are the species (1 or 2) to whom particles

1 and 2 belong. An elementary collision conserves the total momentum and reduces the relative kinetic energy by an amount proportional to $\begin{pmatrix} 1 & 2 \\ 1 & 2 \end{pmatrix}$ =4. The collision rule we have adopted excludes the presence of tangential forces, and hence the rotational degrees of freedom do not contribute to the description of the dynam ics.

Since the particles su er mutual collisions and loose kinetic energy, in order to achieve a steady state, one needs to supply from the exterior som e energy. The energy source has been modeled in two di erent fashions.

In the st sub-model we have assumed that the particles, besides su ering mutual collisions experience a uniform stochastic force and a viscous dam ping [11, 12]. The presence of the frictional, velocity-dependent term in addition to the random forcing, not only is motivated by the idea of preventing the energy of a driven elastic system ($_{12}$! 1), to increase inde nitely, but also m in ics the presence of friction of the particles with the container. Moreover a uctuation dissipation relation is assumed between the viscous force and the intensity of the noise. Even in extended systems with small inelasticity the absence of friction m ay cause some problem s of stability [15]. We shall be mainly interested in the stationary situation determined by the balance between the energy feeding mechanism and the dissipative forces due both to the inelasticity of the collisions and to the velocity-dependent frictional force.

In the second sub-model the grains are constrained to move on a frictionless inclined plane and the bottom boundary vibrates (as a therm al [13] or determ inistic [14] oscillating wall) giving energy only to the particles bouncing on it. Periodic boundary conditions are assumed laterally.

Since we consider throughout only su ciently low density systems successive binary collisions are electively uncorrelated and Boltzm ann equation can be used to describe the non equilibrium dynamics. In fact, by assuming the validity of the Boltzm ann molecular chaos hypothesis, introduced to treat the collision term, it is straightforward to derive the governing equations for the probability density distribution function of each species. Moreover in this situation we are allowed to perform Direct Simulation M onte C arb to integrate num erically the inhom ogeneous Boltzm ann equation of the sub-models.

III. UN FORM LY HEATED SYSTEM

In order to see the e ect of the heat bath let us consider the system in the absence of collisions. In this case, the evolution of the velocity of each particle is described by an 0 mstein-U hlenbeck process. If we require that the two components must reach the same granular temperature in the limit of vanishing inelasticity we have two dimensional procession in the limit of vanishing inelasticity we have two dimensional process.

A. Spatially Uniform solutions

W hen we take into account collisions among particles equations (5) become two coupled Boltzm ann equations modied by the presence of a di usion term due to the therm alnoise. We shall rst consider a spatially homogeneous case in order to derive the temperature of each species in the homogeneous stationary state. This represents a sort of mean eld approximation. In fact, in the original Boltzm ann equations the collisions are considered to occur only between particles at the same spatial location, whereas here these can occur between arbitrary pairs of particles regardless their spatial separation. In the present subsection we compute the second moments, $\langle v_i^2 \rangle$, of the distribution functions in order to determ ine the partial temperatures and their ratio. A lthough the method of derivation of the equations for the partial temperatures is not original, we present it in order to render the paper self-contained and because it shows the dimensions between the particular heat bath we employed and those chosen by other authors [4]. First, indicating by $n_i = N_i = V$ the partial density of species i, we notice that both eqs. (5) possess the same equilibrium solution:

although the relaxation properties are di erent. Only upon adding the inelastic collision term the two species display di erent tem peratures. The resulting Boltzm ann equation for a granular mixture is [2, 3, 4]:

The primed velocities are pre-collisional states, which can be obtained by inverting eqs. (1)

Due to the presence of the heat bath terms the system reaches asymptotically a steady state, characterized by time independent pdf's. By imposing the vanishing of the time derivatives we obtain:

Eq. (15) determ ines the partial tem peratures once the f_i are known. In practice one can obtain an estimate of T_i by substituting two M axwell distributions:

By solving num erically the nonlinear system of eqs. (16) one obtains the steady values of the partial tem peratures in the spatially hom ogeneous situation.

In gs.1 and 2 we report the tem perature ratio $\frac{T_1}{T_2}$ as a function of a common restitution coe cient , having chosen equal coe cients $_{11} = _{22} = _{12} = _{12} = .$ A ssum ing identical concentrations, and a varying the mass ratio $\frac{m_1}{m_2}$, we studied the cases 1 and 2.




FIG.1: G ranular tem perature ratio $T_1=T_2$ vs. obtained with the heat bath, case 1, hom ogeneous, using $T_b = 1$, = 0:1 and di erent m ass ratios.

We notice that with the second recipe (case 2) the temperature ratio is an increasing function of the mass ratio $m_1 = m_2$: this is exactly the opposite of what happens for the case 1. The experimental observation [6] suggest that the trend of case 2 is the right one. In other words, in the case 2 both the friction term and the power supplied are proportional to the mass of the two species and such a property is probably true also in the experiments. This is why we shall use the recipe of case 2 in the following D SM C simulations.




FIG.2: G ranular tem perature ratio $T_1=T_2$ vs. using the second recipe for the heat bath, case 2, hom ogeneous, with $T_b = 1$, = 0:1 and various m ass ratios.

B. Non uniform solutions

In the present section we illustrate the results obtained simulating the system with the heat bath (with recipe 2, i.e. equation (3b)) by the so called D irect Simulation M onte C arlo according to the implementation described in [16].

At every time step of length t each particle is selected to collide with a probability $p_c = t = c$ (where c is an a priori xed mean free time established consistently with the mean free path and mean squared velocity) and seeks its collision partner among the other particles in a neighborhood of radius r_B , choosing it random by with a probability proportional to their relative velocities. Moreover in this approximation the diameter is no more explicitly relevant, but it is directly related to the choices of p_c and r_B in a non trivial way: in fact the B ind algorithm allows the particles to pass through each other, so that a rigorous diameter cannot be de ned or simply estimated as a function of p_c and r_B . In this section, to indicate the degree of damping, we give the time $_b = 1$ instead of . This is useful to appreciate the ratio between the mean collision time $_c$ and the mean

In the present section we chose N $_1$ = N $_2$ = 500 and T $_b$ = 1, and equal restitution




FIG.3: Granular tem perature ratios $T_1=T_2$ vs. m ass ratio m $_2=m$ 1 for a binary m ixture (D SM C simulation) with di erent values of , N $_1 = N_2 = 500$, $L^2 = 1000$, $T_b = 1$, $_b = 10$, $_c = 0.16$, and recipe 2




FIG. 4: G ranular temperature ratios $T_1=T_2$ vs. restitution coe cient for a binary mixture (D SM C simulation) with di erent values of $m_1=m_2$, $N_1 = N_2 = 500$, $L^2 = 1000$, $T_b = 1$, $_b = 10$, $_c = 0.16$, and recipe 2

coe cients for all collisions and $_{c} = 0.16$. As illustrated in gures 3 and 4 the two com ponents display di erent granular tem peratures in agreem ent with the analytical predictions of the hom ogeneous Boltzm ann equations. We also comment that the ratio $T_1=T_2$ is very sensitive to the mass ratio and much less to di erences in the restitution coe cients and concentrations. This is in agreement with experimental observations [6].

At a ner level of description we consider the rescaled velocity pdf for di erent values of the inelasticity parameter and di erent m ass ratios m $_2$ =m $_1$ = 2.0 ne sees that not only the deviations from the G aussian shape become m ore and m ore pronounced as we increase the inelasticity parameter (1), but also the shape of the two distributions di er appreciably in the tails even after velocity rescaling to m ake the two pdf's have the same variance. Such a property is similar to the one already reported in [3]. One can also observe that the rescaled pdf of the lighter species has slightly broader tails. The m ass ratio also controls the deviations from the G aussianity of the velocity pdf's. W hereas it is known that the departure from the M axwell-B oltzm ann statistics is triggered by the inelasticity of the collisions, the larger the inelasticity the stronger the deviation, to the best of our know ledge this is the rst num erical evidence of the phenom enon, predicted w ithin a M axwell m odel in ref. [3]. C om paring gs. 5 and 6 one sees that the m ass asymmetry enhances the non gaussianity of the pdf.

We have also studied the limits of low and high $_{\rm b}$, in gure 7, to show how the velocity distributions change. For values of the characteristic time of the heat bath, $_{\rm b}$, comparable with the collision time, $_{\rm c}$, the dynamics is essentially controlled by the stochastic acceleration term. This fact renders the two partial temperatures very close and makes the velocity distributions nearly M axwellian. As $_{\rm b}$ increases we have observed that the energy dissipation due to the inelasticity makes the temperatures of the two species di erent. M oreover, the temperature ratio displays power law decreasing trend as a function of $_{\rm b}$ whose strength depends on the mass ratio (see gure 8).

In order to obtain information about the spatial structure of the mixture we have performed an analysis of the following correlation function, already introduced in the context of granular media by [11, 12, 17]:




FIG.5: Rescaled (to have variance 1) velocity distributions P (v) vs. v in the num erical experiment with the therm albath (DSMC simulation), for binary mixtures of particles with mass $m_1 = 0.5$ and $m_2 = 1$, with $N_1 = N_2 = 500$, $L^2 = 1000$, $T_b = 1$, $_b = 10$, $_c = 0.16$, recipe 2, and di erent values of

For a spatially hom ogeneous system we expect that C (r) r^{d_2} with $d_2 = d$ the dimension of the embedding space. However, in the cases we have studied, we found that $d_2 < d$ (see g 9), a signature that the system tends to clusterize. The larger the value of $_b$ the stronger the deviation.

IV. SYSTEM W ITH GRAVITY AND HEATED FROM BELOW

W e turn, now, to illustrate the results relative to an inelastic m ixture subject to gravity and con ned to a vertical plane of dimensions $L_x = L_y$. In the horizontal direction x we assumed periodic boundary conditions. Vertically the particles are con ned by walls. Energy is supplied by the bottom wall vibrating stochastically or periodically according to the method employed in [16] for a one component system.

The vibration can have either a periodic character (as in ref. [18]) or a stochastic behavior with them alproperties (as in [13]). In the periodic case, the wall oscillates vertically with the law $Y_w = A_w \sin(!_w t)$ and the particles collide with it as with a body of in nite mass




FIG.6: Rescaled (to have variance 1) velocity distributions P (v) vs. v in the num erical experim ent (D SM C simulation) with the therm albath, for binary m ixtures of particles with m ass m₁ = 0.5 and m₂ = 5, with N₁ = N₂ = 500, L^2 = 1000, T_b = 1, $_b$ = 10, $_c$ = 0.16, recipe 2, and di erent values of

with restitution coe cient $_{w}$, so that the vertical component of their velocity after the collision is $v_{y}^{0} = _{w}v_{y} + (1 + _{w})V_{w}$ where $V_{w} = A_{w}!_{w}\cos(!_{w}t)$ is the velocity of the vibrating wall. In the stochastic case we assume that the vibration amplitude is negligible and that the particle colliding with the wall have, after the collision, new random velocity components $v_{x} 2$ (1;+1) and $v_{y} 2$ (0;+1) with the following probability distributions:

In thism odel we assume that the particle do not feel any external (environmental) friction. In all simulation we have chosen $N_1 = N_2 = 100$, g = 1, $m_1 = m_2 = 2 = 1 = 4$, $L_x = L_y = L = p \frac{p}{N}$.

The Boltzm ann equations for the partial distribution functions f (r;v;t) with = 1;2 read




FIG.7: Rescaled (to have variance 1) velocity distributions P (v) vs. v in the num erical experiment (D SM C simulation) with the therm albath, for binary m ixtures of particles with m ass $m_1 = 0.5$ and $m_2 = 5$, with $N_1 = N_2 = 500$, $L^2 = 1000$, = 0.2, $T_b = 1$, dimensional values for $_b$, $_c = 0.16$, with recipe 2, and dimensional values of

The simulation results show that the tendency of the grains to form clusters is enhanced by such a choice of driving mechanism with respect to the hom ogeneous heat bath of the previous section. In the latter the noise acting uniform ly was more elective in breaking the clusters. In addition the gravitational force tends to group the particles in the lower portion of the container for not too large driving frequencies [16].

Fig 10 illustrates the partial density pro les and granular temperature pro les in the presence of a therm al wall of intensity $T_p = 20$. The density pro les di er slightly near the bottom wall where both present a maximum (see inset). The temperature pro les are di erent, putting again in evidence a strong lack of equipartition in the system. Interestingly, the temperature ratio is almost constant along the vertical direction, notw ithstanding the partial pro les are non constant. We have also performed numerical simulations with a harm onically vibrating wall: as the maximum velocity of the vibrating wall (which, for




FIG.8: Tem perature ratios $T_1=T_2$ vs. the viscosity time $_b$ in the numerical experiment (DSMC simulation) with the therm albath for a binary mixture of particles with m assm $_1 = 0.5$ and m $_2 = 5$, with N $_1 = N_2 = 500$, $L^2 = 1000$, = 0.2, $T_b = 1$, di erent m ass ratios, $_c = 0.16$, with recipe 2, and di erent values of




FIG.9: Correlation function used to compute the correlation dimension d_2 , C (r) vs. r (see text for de nition), for a binary m ixture (D SM C simulation) with m₁ = 0:5, m₂ = 5, _c = 0:16, T_b = 1, N₁ = N₂ = 500, L² = 1000, = 0.2, with di erent values for _b




FIG.10: Pro les for density and granular temperature n (y), T (y) vs. y for a binary mixture with $m_1 = 0.5$, $m_2 = 2$, on an inclined plane with a therm albottom wall (DSM C simulation) with $T_w = 20$, $N_1 = N_2 = 100$, $L^2 = 200$, = 0.6, w = 1, g = 1; the dashed lines indicate the ratios for both pro les.

A = 1, is equal to !) increases, the position of the density maximum raises indicating that gravity becomes less and less relevant. As far as the partial temperatures are concerned gure (11) illustrates the corresponding situation.

One sees that the temperatures (see inset) next to the wall attain their largest value, then drop to increase again. This indicates that the region far from the bottom is hotter because of the lower density of the gas and of the lower collision rate. A sthe wall temperature increases the temperature becomes more hom ogeneous far from the bottom due to the major hom ogeneity in density. We also notice a small segregation elect.

Finally, we present the velocity distributions measured in the system with a therm alwall. Since the tem perature depends on the vertical coordinate y we have computed the velocity pdf at di erent heights. The various pdf are plotted in gure (12) after a suitable rescaling. We observe that the distributions deviate appreciably from a Gaussian shape and display overpopulated high energy tails.

Interestingly the value obtained by our simulation for the temperature ratio, having




FIG.11: Pro les for density n(y) vs. y and ratios between granular temperatures of the two species $T_1(y)=T_2(y)$ vs. y, for a binary mixture (DSMC simulation) with $m_1 = 0.5$ and $m_2 = 2$, on an inclined plane with an harmonic oscillating bottom wall with A = 1, di erent values of !, $N_1 = N_2 = 100$, $L^2 = 200$, = 0.9, w = g = 1.

chosen $\frac{m_1}{m_2} = 0.3$ and a single restitution coe cient = 0.93, $\frac{T_1}{T_2} = 0.75$ is not too far from the value obtained experimentally by Feitosa and Menon [6] which is 0.66 = 0.06. One should recall that in our \setup" only the lower wall supplies energy to the system, whereas in the experiment both walls vibrate.

V. CONCLUSIONS

To sum marize we have studied the steady state properties of a granular mixture subject to two di erent classes of external drive.

In the case of an heat bath acting hom ogeneously on the grains, we have st obtained the tem peratures of each species by employing an approximate analytic method. We have then solved numerically the equations by allowing the density and the tem peratures to be spatially varying and analyzed the spatial correlations and the velocity distributions.

F inally, we turned to investigate the properties of the m ixture in the presence of gravity




FIG.12: Rescaled distributions (to have variance 1) of velocity P (v) vs. v for particles taken in stripes at di erent heights, for a binary m ixture (D SM C simulation) with $m_1 = 0.5$, $m_2 = 2$, on an inclined plane with a therm albottom wall with $T_w = 20$, $N_1 = N_2 = 100$, $L^2 = 200$, = 0.6, g = 1.

and inhom ogeneous drive.

The present results not only con m the predictions of di erent tem peratures for the two species for all types of drive, but also show the existence of di erent shape functions for the velocity distributions and of overpopulated high energy tails in agreem ent with the ndings based on M axwellm odels β].

In order to obtain a direct comparison with experiments we employed parameters comparable to those utilized in the experimental work of ref. [6] and found temperature ratios not too far from the ones there reported. In spite of this success, the agreement seems to be limited to the average properties, while it is clear from the observation of the density proles computed numerically that a better treatment of the excluded volume e ect is necessary in order to obtain a more realistic description of the system. Finally, in view of the approximations inherent to the Boltzmann approach, we have not tried to include neither the elect of rotations of the grains nor the friction with the lateral walls which might be both relevant [19].
