E ects of an external drive on the uctuation-dissipation relation of phase-ordering system s

A bstract. { The relation between the autocorrelation C ($t;t_w$) and the integrated linear response function ($t;t_w$) is studied in the context of the large-N model for phase-ordering systems subjected to a shear ow. In the high temperature phase $T > T_c$ a non-equilibrium stationary state is entered which is characterized by a non-trivial uctuation-dissipation relation (t_w) = ~(C (t_w)). For quenches below T_c the splitting of the order parameter eld into two statistically independent components, responsible for the stationary Cst (t_w) and aging C^{ag} (t=t_w) part of the autocorrelation function, can be explicitly exhibited in close analogy with the undriven case. In the regime t t_w t_w the same relation (t_w) = ~(Cst (t_w)) is found between the response and Cst (t_w), as for $T > T_c$. The aging part of ($t;t_w$) is negligible for t_w ! 1, as without drive, resulting in a at (C) in the aging regime t t_w t_w .

Understanding non-equilibrium processes is a central topic of modern statistical physics. Many systems in nature are observed in a persistent non-equilibrium regime. Among these two important categories can be identified according to the asymptotic state towards which they evolve. Systems subjected to a change of therm odynam ic variables, such as temperature or pressure, belong to the first class. In this case, an equilibrium state is approached which, how ever, can be hardly reached if the ergodic time grows in the therm odynam ic limit. This is usually observed when the initial and first nal states are separated by a phase transition. Typical examples are glassy materials or phase-separating systems quenched below the critical temperature. The offent dynam ics in this case is characterized by the aging property of the autocorrelation function [1]. A different situation, on the other hand, is observed when external power is injected into a system with rate for by doing work on it, as in the case of stirred or sheared materials. In this case a time translational invariant (TTI) stationary regime can be entered, depending on the therm odynam ic parameters, which is not an equilibrium state.

A characterization of non-equilibrium states has been given in di erent contexts by generalizing the uctuation-dissipation theorem (FDT). In equilibrium the FDT relates the integrated linear response function (t t_i) to a perturbation applied at time t_w and the autocorrelation function C (t t_w) of the unperturbed system through (t t_w) = (1=T) [C (0) C (t t_w)]. In stationary states these quantities still depend on the time di erence so that (t t_w) = ~[C (t t_w)], where ~ is a non trivial function that may give informations on the o -equilibrium properties. A lso in the late stage evolution of aging system s the dependence of the response function on the two times generally enters through the autocorrelation, (t;t_w) = ~[C (t;t_w)], as originally observed by Cugliandolo and Kurchan [2] in the fram ework of mean eld glass models.

In these cases the uctuation dissipation ratio (FDR) X (C) = Td (C)=dC describes deviations from equilibrium, where X (C) 1, and di erent physical informations can be extracted from it. First, $T_{eff} = TX^{-1}$ (C) can be interpreted as an elective temperature of the system, di erent from that of the therm all bath, as recognized in turbulence [3] or glass physics [2, 4]. Second, the theorem by Franz, M ezard, Parisi and Peliti [5] connects the FDR of aging system s to the static properties of the equilibrium state through dX (C)=dC $j_{C=q} = P(q)$, where P (q) is the equilibrium probability distribution of the overlaps [6]. M oreover it was argued recently [4, 7] that aging and driven system s can be related through the o -equilibrium generalization of the FDT because X (C) is expected to be the same in the limit of sm all entropy production, namely for t_w ! 1 in aging system s or ! 0 in driven system s.

In this Letter we study this subject in the framework of the large-N model for systems with non conserved order parameter [8] under plain shear ow; this is a solvable theory which retains the basic features of the equilibrium and o -equilibrium kinetics of several non-disordered systems, such as liquid crystals [9], which are relevant for m any applications. In this context the autocorrelation and the response functions are exactly computed and the uctuation dissipation ratio discussed explicitly. The model is particularly suited for a unitary discussion of the FDT in the di erent non-equilibrium situations discussed above, which correspond to dynam ical states at di erent tem peratures. In particular, for T larger than a critical tem perature $T_c()$, a stationary state is entered, for long enough times, characterized by a non-trivial X (C). By quenching below $T_c()$, instead, the complex interplay between the phase-ordering process and the external drive gives rise to peculiar aging properties. N onetheless, by recognizing that a separation of the degrees of freedom into two statistically independent contributions, responsible for the stationary C st (t t_w) and aging C ^{ag} (t=t_w) part of the autocorrelation, can be explicitly performed, the interpretation of the dynam ics is clari ed by the analogy with the phase-ordering kinetics of the undriven case.

The model describes the system in term s of an N-component vectorial order parameter eld $\stackrel{\prime}{\sim}$ (r;t) through the G in zburg-Landau ham iltonian

where r; u and are positive constants. When a convective eld v is imposed the dynamics of the generic component of a non-conserved order parameter is described by the equation

where is a transport coe cient and the gaussian stochastic variable ~, representing therm al

noise, obeys h (r;t)i = 0 and h (r;t) $(r^{0};t^{0})i = 2T$; $(r^{0})t$ (t^{0}) , with < :::> denoting ensem ble averages. In the following we will set = 1. The velocity v is chosen to be a planar C ouette or shear ow v = yq, where is the spatially hom ogeneous shear rate, and e_{x} is a unit vector in the ow direction. In the large-N limit sum ming over in nitely many components e ectively realizes an ensem ble average and the substitution

becomes exact [10]. Given space-translational invariance the average squared eld uctuation S (t) = h'^2 i does not depend on the spatial coordinates and (3) is form ally linearized. In momentum space it reads

where we have dropped the component index, due to internal symmetry, h (k;t)i = 0 and h (k;t) $(k^0;t^0)i = 2T(2)^D$ $(k + k^0)$ (t = 0). The form alsolution of Eq.(5) can be obtained from the know ledge of the conguration at an arbitrary time to by the method of characteristics

where is a regularization cut-o, provides the self-consistent closure of the model. The know ledge of g(t), therefore, amounts to the solution of the theory.

The existence of critical temperature was shown $\underline{\text{in}}$ [11]. For small = ² in D = 3 the critical temperature behaves as $T_c() = T_c(0)$ [1 + a ²], where a is a positive constant. In general, it can be shown that, in this model, $T_c()$ is a monotonously increasing function of the shear rate. We will consider quenches from an high temperature disordered state to a nal temperature T_F . In the following we will brie y discuss the most relevant case D = 3. A complete analysis, containing also more technical details, will appear elsewhere [12]. g(t) can be evaluated by Laplace transform techniques, similarly to the case = 0 [13], yielding

where $g_{+};g_{c};g_{c}$ are constants. s_{0} (T) is related to the longitudinal coherence length by $s_{0} = 2$ (T)². These behaviors are rem iniscent of the case without shear [13], where the algebraic decay of g(t) below the critical temperature is a signature of the power-laws characteristic of the phase-ordering process. Then, in the case of a quench from high temperature to T_{F} below T_{c} (), the e ects of shear change the phenom enology of the phase-ordering process but do not interrupt it. Moreover, since T_{c} () > T_{c} (0), com plete phase-ordering is always observed for each $T_{F} < T_{c}$ (0), regardless of the presence of shear. This is an important di erence with respect to the case offen considered [7] where the aging process is interrupted by a power

input. This is what happens when we shake, for instance, a mixture of water and oil to make droplets smaller. A ctually the possibility of stabilizing a state with a nite coherence length by shearing a phase-ordering system is a debated question [14, 15] which may depend crucially on hydrodynamic e ects [16].

From the know ledge of g (t) two-time quantities can be computed.

The next point is the calculation of the linear response function R (k;t;k⁰;t⁰) = (2)^D h' (k;t) = h($\stackrel{0}{k}$;t⁰) j₁(k;t) = 0 (with t $\stackrel{0}{t}$) to a perturbation ñ (r;t) entering the ham iltonian through d^{D} rñ (r;t) $\stackrel{\sim}{}$ (r;t) $\stackrel{\sim}{}$ (r;t) $\stackrel{R}{}$ From this quantity the integrated response function is obtained as (t;t_w) = $\stackrel{R}{}_{t_w}^{t} dt^{0}$ (2) $\stackrel{2D}{}_{t_w}^{D} dt^{D} k^{0}R$ (k;t;k⁰;t⁰) expf (k² + k¹²) = (2 $\stackrel{2}{}_{t_w}^{2}$) g.




Fig. 1. { T_F st (t t_r) is plotted against Cst (t t_r) for a quench to a naltem perature T_F = (21=20) T_c (), with t_r = 10⁵ and = 1. Solid lines correspond to = 1;10⁻¹;10⁻², bottom up. The dashed line, which is almost indistinguishable from the case = 10⁻², is the equilibrium behavior = 0. The inset shows X (C).

W riting the argument of $(t t_r)$ in terms of $C^{st}(t t_r)$ through (9) one obtains the uctuation dissipation relation $(t t_r) = \sim (C^{st})$ plotted in Fig.1. The comparison with the case without shear, regulated by equilibrium FDT, shows that for small $(t t_r)$ the two curves collapse but, for larger time di erences the lines with $\leftarrow 0$ bend and lower asymptotic values are reached. The behavior of the FDR is shown in the inset of Fig.1. Starting from X (0) = 1, this quantity decreases to a minimum and then raises towards X (C) = 1 again when C ! 1. Therefore one nds a di erent and more complex behavior with respect to the two-tem perature scenario proposed for driven supercooled uids [21].

 $T_F = T_c$ ()

For quenches at the critical tem perature the asymptotic behavior of the two time quantities considered above is the same as for $T_F > T_c$ (), with $s_0 = 0$ in (9) and (10). In particular C (t;t_w) and (t;t_w) in the large t_w limit depend only on t t_w.

 $T_F < T_c$ ()

The situation is more complex when quenches below $T_c()$ are considered. In this case, using (6), in the large t_w lim it the autocorrelation function can be separated into two contributions, namely $C(t;t_w) = C^{st}(t-t_w) + C^{ag}(t=t_w)$, which depend, respectively, on the difference and on the ratio between the two times, as usually found in aging system s. This is the signature of a fundamental property of the order parameter eld (r;t), which decomposes below $T_c()$ into the sum of two independent stochastic elds (r;t) = (r;t) + (r;t) responsible for the stationary and aging properties of the kinetics, as discussed in [17]. In system s with a scalar order parameter [18] the physical interpretation of this decomposition goes as follow s: given a

con guration at time t well inside the late stage scaling regime, one can distinguish degrees of freedom (r;t) in the bulk of domains from those (r;t) pertaining to the interfaces. The

rst ones are driven by therm al uctuations and behave locally as in equilibrium; the second ones retain memory of the noisy initial condition, and produce the aging behavior. In the lim it N ! 1 the separation of ' (k;t) can be explicitly constructed, identifying in (6) the two contributions

in complete analogy with the case = 0 [19]. For large-N, where topological defects are unstable and domains are not well de ned, the recognition of the degrees of freedom associated to (k;t) and (k;t) is not straightforw and as for scalar system s. Nevertheless, the possibility of the splitting (11,12) of the order parameter indicates that the same fundamental property is shared by system s with di erent N.

Building the autocorrelation functions of the new elds C (t;t_R) = (2) $^{2D} \stackrel{R}{d^{D}} kd^{D} k^{0}$ h (k;t) (k^{0} ;t_w)iexpf ($k^{2} + k^{(2)}$)=(2) gand C (t;t_w) = (2) $^{2D} \stackrel{d^{D}}{d^{D}} kd^{D} k^{0}$ h (k;t) (k^{0} ;t_w)i expf ($k^{2} + k^{(2)}$)=(2) git is possible to prove that, for t_w =t₀ su ciently large, they coincide, respectively, with C st (t;t_w) and C ^{ag} (t;t_w).

C om ing back to the two-time observables the TTI part Cst (t t_w) takes the same form as at $T_F = T_c$ (), namely (9) with $s_0 = 0$. This quantity decays from Cst (0) = M² (0) M² (T_F) to zero fortime di erences of order t_w. Here M (T_F) = M (0) [L $T_F = T_c$ ()]¹⁼² is the spontaneous magnetization at stationarity. The aging part, instead, is given by

showing that C^{ag} stays approximatively constant, C^{ag} (t=t_w) ' M² (T_F), for t t_w t_w and decays for large time dimensions as (t_w =t), with = 5=4, as opposed to the undriven case where = 3=4. Computing the response function it is found that the aging part is negligible for large t_w and (t;t_w) behaves as at T_c(), so that (10) with s₀ = 0 is obeyed.




Fig. 2. { T_F (t;tw) is plotted against C (t;tw) for a quench to a naltem perature $T_F = T_c$ ()=2, with tw = 10⁵ and = 1. Solid lines correspond to = 1;10⁻¹;10⁻², bottom up. The dashed line is the case with = 0.

We turn now to discuss the relation between $(t;t_w)$ and C $(t;t_w)$. In the case without shear [19], the equilibrium FDT relates ${}^{st}(t, t_w)$ and $C^{st}(t, t_w)$ by $T_F {}^{st}(t, t_w) = C^{st}(0) C^{st}(t, t_w)$ at every temperature. In the range of times $t_w {}^{st}(t, t_w)$ grows to its saturation value M ${}^2(0) M^2(T_F)$. Then, plotting $T_F {}^{st}(t;t_w)$ against C $(t;t_w)$ one gets the straight line with negative slope on the right of Fig. 2. For larger time di erences, in the aging regime $t_w {}^{st}(t, t_w)$ is a constant, because the aging part of the response is negligible for $t_w {}^{st}(t, t_w)$ are not related by equilibrium FDT but, instead, through $\sim (C^{st})$ (Fig.1). Then in the param etric plot of $(t;t_w)$ vsC $(t;t_w)$ (Fig.2) one nds, in place of the straight line with negative slope, the curve $\sim (C^{st})$ which corresponds to the sim ple translation of the one plotted in Fig.1. For C $(t;t_w) < M^2(T_F)$ the plot is at for the same reasons as for = 0.

However, due to the bending of ~ (Cst), the asymptotic value (1) is dimensioned in the case = 0. It is interesting to observe that the relation T_F (1) = M² (0) M² (T_F) characteristic of the undriven case is generalized to $T_F = (1) = M²$ (0) M² (T_F). Therefore a relation analogous to the case = 0 holds between the response function of a system with shear rate =2 and the stationary magnetization in the presence of a shear rate twice as large. This parameter-free analytical prediction is am enable of experimental testing.

In sum mary, in this Letter we have studied the e ects of a shear ow on the uctuationdissipation relation in the large-N model for phase-ordering. This approach allows for the analytical computation of two times quantities and the explicit identication of the stochastic

elds (r;t), (r;t) responsible for the stationary and aging properties of the kinetics below $T_c()$. The FDT relating the stationary parts of the correlation and response function in the undriven case is generalized under shear into a non-trivial relation $st(t = t_r) = -(C^{st}(t = t_r))$, which is obeyed at every temperature. Below $T_c()$ the lack of time translational invariance is testiled by the aging contribution $C^{ag}(t=t_r)$ to the correlation function, which behaves asymptotically as $(t_r = t)$, where = (D + 2)=4 is a generalization of the F isher-H use exponent [20] to sheared system s. The aging part of the response, on the other hand, is always negligible in the large t_r limit, resulting in a at part of the one observed without shear, the most notable modil cation being the dil erent relation between $st(t = t_r)$ and $C^{st}(t = t_r)$. The comparison with the case = 0 will be discussed further in [12].

The applicability of the two-tem perature scenario proposed in [21] for supercooled uids to di erent slowly relaxing systems and, in particular, to the phase-ordering kinetics is a debated [16] issue which is worth of further studies. A coording to this scenario an external input of energy stabilizes an aging system into a power-dependent stationary state. In the small limit the uctuation dissipation plot of this state is a broken line. This provides the identication of two well de ned tem peratures: The bath tem perature \mathbb{F} and an elective tem perature of the system. The results of this Letter allows this problem to be addressed in the context of the large-N model. We not that a phase-ordering system is not stabilized by shear. This result agrees with R ef. [15], where a di erent approximation scheme is developed. A similar behavior was found in [22] for the stability of the ferrom agnetic phase of the asym metric spin-glass model in the mean- eld limit. This feature is at variance with the basic assumption of the scenario proposed for supercooled uids. Furtherm ore, the behavior of X (C) shown in the inset of Fig. 1 shows that a two-tem perature interpretation of the uctuation dissipation relation does not hold in this case.

The relevance of these results to real physical system s where N is nite and hydrodynam ic e ects m ay play a relevant role is a crucial point that deserves further investigations.
