## Macroscopic Quantum Coherence in a repulsive Bose-Einstein condensate.

W e consider a Bose-E instein bicondensate (BEC) of  $^{87}$  R b, trapped in two di erent internal levels, in a situation where the density undergoes a sym m etry breaking in m om entum space. This occurs for a suitable number of condensed atom s within a double well dispersion curve, obtained by R am an coupling two internal states with two tilted and detuned light elds. Evidence of bistability results from the G ross-P itaevskii equation. By second quantization, we evaluate the tunneling rate between the two asym m etric states; the e ects of losses on coherence are also considered.

The transition from a super uid to a M ott insulator has been recently dem onstrated for a B ose E instein condensate (BEC), m ade of atom s with repulsive m utual interactions in a lattice potential [1]. Such a phenom enon goes beyond the m ean eld approximation and its explanation requires to take into account the quantum uctuations of the matter eld. W hen the quantum tunneling between adjacent sites dom inates the interaction energy, the probability distribution for the atom ic occupation of a single site is Poissonian. In the opposite case the minimum energy is obtained reducing the quantum uctuation of the local occupation number.

In a previous paper we have studied a sim ilar problem, but with only two wells and an attractive interaction [2];In this case the opposite e ect occurs, that is, raising the atom number, i.e. the interaction energy, the minimum energy state is obtained increasing the atom ic uctuation in each site. This is indirectly dem onstrated by the num ericalobservation of the sym m etry breaking at a critical number of atoms. Approaching the threshold value, the quantum uctuations increase, whereas above that value they blow up and a new minimum quantum state appears. The associated probability distribution of the condensate barycenter displays two peaks, that can be considered as the dead and alive states of a Schrodinger cat (SC), whose coherent superposition is called M acroscopic Quantum Coherence (MQC). This term was introduced to describe the coherent superposition of two m acroscopically distinct quantum states that di er for the value of a collective variable [3]. The phenom enon is observable only for attractive interactions, that tend to cluster the atom s in one of the two wells. By contrast, a repulsive interaction tends to reduce the quantum uctuations and to distribute the same number of atom s in each well, as observed in Ref. 1. MQC has been observed with trapped ions [4] and m icrowave elds in high-Q cavity [5].

In this work, we discuss the feasibility of MQC in a BEC of mutually repulsive atoms. A repulsive interaction acts in the momentum space as an attractive interaction, therefore we expect that for a double well dispersion curve the symmetry breaking occurs in the reciprocal space. Such a dispersion curve can be obtained by two detuned and tilted light elds, that transfer a

net momentum to atoms as they jump from an internal state to another. We study the problem by nding the stationary solutions of two coupled G ross-P itaevskii equations (GP) discretized over a space lattice. The system undergoes symmetry breaking in momentum space for a suitable number of atom s and two new stationary states are created. We then introduce a quantum two mode model, with the two modes chosen in such a way as to reproduce the stationary solutions of GP, and evaluate the quantum uctuation-mediated tunneling rate between the two asymmetrical states. If the coupling with the environm ent is negligible, MQC occurs between these states. A Ram an scheme for creating a superposition state with two R b condensates in di erent internal quantum levels has already been discussed in Refs. 6, 7; how ever both papers lim it them selves to co-propagating light beam s, and this im plies applicability problem s, as discussed in Ref.2.

Here we refer to <sup>87</sup>R b atom s, but our num erical results apply also to  $^{23}N$  a, if some parameters are rescaled. In a previous work [8] we considered atom s in two di erent hyper ne levels (F = 1,  $m_F = 1$  and F = 2,  $m_F = 1$ ), however the associated depletion rate [9] is too high for our purposes. Here we consider condensate atom s that are optically trapped in the two Zeem an levels F = 1, 1 and F = 1,  $m_F = 1$ . An all optical conm <sub>F</sub> = densation has been reported in Ref. 10, alternatively, the condensate can be created with a magnetic con nement and transferred into an optical trap [11]. A hom ogeneous magnetic eld has to be applied to remove the energy degeneracy. These levels are quasi-resonantly coupled by means of two Raman elds L and R.W e call  $_0$  and  $_1$ the elds associated with the  $m_F = 1$  and  $m_F = 1$  levels, respectively. Furtherm ore we call 2 the upper state of the D<sub>1</sub> transition.

The starting equations are

where  $H_0 = H_1 + g_{00} j_0 f + g_{01} j_1 f$ ,  $H_1 = H_1 + g_{11} j_1 f + g_{10} j_0 f$  and  $g_{ij} = 4 h^2 a_{ij} = m \cdot a_{ij}$  5:5nm [12] are the

s-wave scattering lengths between atom s in i and j levels. We have called H<sub>1</sub> =  $(h^2=2m)r^2 + V$  the one atom term of the H am iltonian, where V is the trapping potential. The eld am plitudes E<sub>L;R</sub> are rescaled in order to be expressed in frequency units. They are thus the Rabi frequencies of the one-photon transition. h!<sub>2</sub> is the energy of the upper state of the one photon transition; h!<sub>0;1</sub> are the energies of the m<sub>F</sub> = 1;1 levels, respectively. We set !<sub>0</sub> = 0. In the adiabatic approximation, 2 can be expressed in terms of 1 and 0 as  $2 = E_L e^{i(K_L \times it)} + E_R e^{i(K_R \times it)} + F_R e^{i(K_R \times i$ 

W e introduce the gauge transform ation

where  $k_d = \tilde{k}_L$   $\tilde{k}_R$  and  $!_d = !_L$   $!_R$ . As a result, the equations of m otions become

Here,  $\frac{\mathbb{E}_{L}\mathbb{E}_{R}}{\mathbb{E}_{R}}$  is the two photon R abi frequency, taken for simplicity as time independent and real, and the frequency is given by =  $!_{1} \cdot !_{d} + (\pounds_{L} \hat{\mathcal{I}} \cdot \pounds_{R} \hat{\mathcal{I}}) = .$ We assume  $\pounds_{L} \hat{\mathcal{I}} = \pounds_{R} \hat{\mathcal{I}}$  and  $!_{d} = !_{1}$ , hence = 0.

If the number of atom s is su ciently small, we can neglect the nonlinear terms. Furtherm ore, let us initially consider a spatially hom ogeneous condensate (no trap potential). As a consequence, Eqs. (4) reduce to two linear equations with constant coe cients, and the eigenvalue problem in the reciprocal space is ruled by two linear algebraic equations for the transform ed elds  $_0$  (K) and  $_1$  (K). The momenta of the atom s in the two levelsm  $_{\rm F}$  = 1 and m  $_{\rm F}$  = 1 are respectively h (K K<sub>d</sub>=2) and h (K + K<sub>d</sub>=2).




FIG.1: (a) D ispersion curves of a free atom for  $\mathfrak{K}_d j=2$  4.5  $10^5 \text{m}^{-1}$  and = 200s  $^1$ . (b) D ensity distributions j  $_{0;1}$  f for  $k_d = 2$  4.5  $10 \text{m}^{-1}$ , = 1100s  $^1$ ,  $!_k = !_2 = 2$  100s  $^1$  and three di erent boson numbers: N = 1390 (solid), 1420 (dashed), 1460 (dot-dashed).

Solving the eigenvalue problem we nd the two dispersion curves  $h!(k) = h^2k^2 = (2m)$  f  $[h^2k_dk = (2m) + h = 2j + h^2 j j^2 g^{1=2}$ , plotted in Fig. 1a for = 200s<sup>1</sup> and  $jk_d j = 2$  4.5 jn0<sup>1</sup>. As shown in the gure, the electrom agnetic coupling modi es the parabolic dispersion curves associated with the two hyper ne levels, lifting the degeneracy at their intersection point. The energy gap for = 0 is 2h j j. By varying one can rise or lower the energy separation between the two m inim a. For = 0 the two m inim a have the same energy. Introducing the harm onic trap potential, the ground state has no longer a de nite m om entum. Furtherm ore, the two wells of the dispersion curve are equally populated by quantum tunneling (F ig. 1b, solid line).

W hen the number of atom s is su ciently high, a sym m etry breaking occurs because of the atom ic interactions. W e report in Fig. 1b the distributions  $j_0 f$  and  $j_1 f$  for

= 0 and for three di erent values of the number of atom s N.  $_{0;1}$  are the Fourier transform s of the ground state solution  $(\tilde{}_0; \tilde{}_1)$  of Eqs. (4) for a spherical trap potential V corresponding to equal longitudinal (!<sub>2</sub>) and

radial  $(!_k)$  trap frequencies. As it results, this interaction clusters the majority of atom swithin a single well, thus contrasting the quantum tunneling across the barrier. Due to the geometry of the problem, and taking into account that the scattering lengths  $a_{ij}$  are practically equal, there is another ground state which is obtained from that of Fig. 1b by inverting the horizontal axis and interchanging  $_0$  and  $_1$ . Thus we have two stable stationary states with equal energy. The numerical evidence of Fig. 1b is also supported by a synthetic variational argum ent, already exploited in Ref. 2 for L i, and based upon a suitable two mode approximation.

The matter eld uctuations allow the passage from one to the other state. If the decoherence is negligible, coherent oscillations between such states can be observed, demonstrating MQC. To evaluate the oscillation frequency we quantize the two mode system, as done in Ref. 2. First of all, we write the classical H am iltonian corresponding to the equations of motions (4), taking  $g_{00} = g_{11} = g_{01}$  g

(from now on we om it the tilde on the 's, even though we are always in the gauge Eq. (3)). We then introduce the spinorial ground states

where  $_{0g}$  and  $_{1g}$  are the ground state wave-functions associated with the two internal states.  $\sim_{g;2}$  is obtained from  $\sim_{g;1}$  by interchanging the spinorial components and inverting the axes.




FIG.2: First and second excited energy levels of the rubidium BEC versus the excess of atom s above the breakup value N<sub>i</sub> for  $!_k = 2$  100s<sup>1</sup> and some values of  $!_2$ . In the inset we plot N<sub>d</sub> for the same values of the trap frequencies.




FIG. 3: Three-body and two-body (inset) loss rates. The latter one refers to atom s trapped in the F = 1;m = 1 level and represents an upper limit [13].

It is convenient to use the basis vectors  $a = a_{g;1} + a_{g;2}$ and  $\tilde{b} = \tilde{q}_{i1}$  $\sim_{q;2}$ . We write the quantized spinorial eld of the bicondensate as  $(x) = \hat{a}_a(x) + \hat{b}_b(x)$ , and substitute this expression in the operator version of Eq. (5). Thus, we obtain a reduced Ham iltonian H<sub>red</sub> of the same form found in the attractive case of Ref. 2. By H red, we evaluate the di erence between the lowest eigenvalues, which provides the tunneling rate. In Fig. 2 we plot the rst and second energy level as a function of the number of atoms and for some values of  $!_2$ . The energy of the ground state is set to zero, so the energy of the rst level gives the tunneling frequency. The entanglem ent between the condensate and the lost atom s induces a decoherence of the superposition. Using the approach of Ref. 2, we nd that the coherence is given by  $\mathcal{C} = e^{-M}$ , where M is the num ber of lost atom s and = 1 2  $d^3x_0(x)_1(x)=N$ . The quantity  $N_d = 1$  is the number of atom s which must be lost in order to reduce the coherence by 1=e. The inset of Fig. 2 shows how Nd scales with N. The relevant loss processes are two-body inelastic and threebody collisional decays. In Fig. 3 we report the average three-body and two-body (inset) loss rates, the latter one refers to atom s in the m = 1 level. We have used the upper lim it of 1:6  $10^{16}$  cm <sup>3</sup>=s for the two-body loss rate 10<sup>30</sup> cm<sup>6</sup>=s for the three-body procoe cient and 5:8 cesses, both of them measured in Ref. 13 for the trapped Zeeman level F = 1;m = 1. Two-body decay can occur also by means of collisions between atoms in different Zeem an levels. W e suppose that the corresponding loss rate is of the same order of magnitude as the measured value. From Figs. 2,3 we nd that the decoherence e ects are negligible during a MQC oscillation period. For high  $!_{2}$  the threshold N<sub>i</sub> and the loss rates are lower. For  $!_2 = 2$ 200 400s<sup>1</sup> the overall loss rate is much smaller than the corresponding tunneling frequencies. Therefore we can observe m any oscillations before a single atom is lost. For  $!_2 = 2$  100s<sup>1</sup> the loss




FIG. 4: D istribution P (m) for some parameters. The solid, dashed and dashed-dot lines correspond to P (m) at the initial time, at a quarter of period and half a period, respectively.  $!_{?}$  is (a-b) 2  $100s^{1}$ , (c-d) 2  $200s^{1}$  and (e-f) 2  $400s^{1}$ .

rate is > 5s<sup>1</sup>. W ith a tunneling frequency of 8H z also in this case we can observe an oscillation before a single atom is lost. If the loss of atom s does not transfer energy to the trapped atom s, the escape of a few atom s does not reduce the superposition coherence (inset of F ig 2), but modi es slightly the tunneling rate. In Ref. 14 it is shown that inelastic collisional processes induce local variations of the mean-eld interparticle interaction and are accompanied by the creation/annihilation of elem entary excitations. This phenom enon depends on the density and is completely negligible in our case. Notice that Eqs. (4) are invariant if N is varied by a factor and the lengths and the energies are multiplied by 2, and 70s<sup>1</sup> the threshold respectively. So for  $! = !_? = 2$ is  $N_i = 1980$ . By the two mode model we nd that the tunneling frequencies are reduced by nearly a factor 0:5. However the two-body and three-body decay rates are reduced by the factors 0:25 and 0:125, respectively.

As we have shown in Ref. 2, the probability distribution P (m) associated with the observable  $\hat{M} = \hat{a}^{y}\hat{b} + \hat{a}\hat{b}^{y}$  displays two peaks for the ground state, that are the alive and dead state of the Schrödinger cat. This observable is associated with the population measurement in one of the two Zeem an levels. To observe the coherence we have to put the system in one of the two states, that corresponds to take a superposition of the ground and rst excited state of the condensate. This can be obtained measuring with a nondemolition technique (e.g. a phase contrast technique) the population in a Zeem an level when only the ground state is populated. This observation collapses the P (m) distribution to one peak.

servation collapses the P (m) distribution to one peak, as discussed in Ref. 2. If the energy transfer is not too large we expect that only the rst two energy states are populated. W ith this initial preparation the system begins to oscillate at the frequencies of Fig. 2 between the two Schrodinger cat states, as reported in Fig. 4. At the initial time only one peak is present (solid line). At a quarter of period corresponding to the frequency separation between ground and rst excited state, the P (m) displays two peaks (dashed line). At half a period the only peak is that absent at the initial time, thus there is a coherent oscillation between the two states. D etecting such an oscillation would provide evidence of a SC at an interm ediate time when both peaks are present.

Notice that if we had N loosely coupled or independent atom s (N g su ciently low or even zero) the superposition of ground and rst excited state would have a single peak, oscillating as a coherent state inside a harm onic potential. This would by no means be a SC. On the contrary, we have shown that, for N g su ciently high, we have a two peak distribution with the two partial barycenters at nearly constant positions. During the evolution, the two peak am plitudes oscillate, that is, the probability to nd the system in either state oscillates.

In conclusion, we have shown that a double well dispersion curve can be obtained by a suitable R am an coupling. In this situation a symmetry breaking in momentum space is demonstrated solving two coupled G ross-Pitaevskii equations. The condensate can oscillate between the two emerging asymmetrical steady solutions (SC states) by means of the eld quantum uctuations (MQC). We have found that it is possible to obtain an oscillation frequency between the SC states around 100s<sup>1</sup>. In order to neglect the therm all activation, 50 the second excited level energy (E2) has to be higher than the therm alenergy. From Fig. 2 we can see that  $E_2$ ranges between 100  $300s^{-1}$ , that correspond to a tem perature of 0:7 2:3nK . If the cooling is perform ed below the threshold, when the sym m etry breaking does not occur, the required tem perature can be 5nK . How ever it may not be necessary to coolat very low tem peratures the whole condensate, but just the involved degrees of freedom, provided that this latter ones are weakly coupled with the other modes, which act as a therm albath. W e rem ark that for low densities the evaporative cooling allows to reach much lower temperatures, because of a sm aller three-body decay rate. To be sure that no excitation is present one could tailor the trapping potential in such a way that only the rst two levels are bound. In this work we have chosen the parameters for which the tunneling frequency is much larger than the decoherence rate, however the symmetry breaking and the super-Poissonian atom uctuations below threshold can be observed with a much higher number of atom s, thus these phenom ena are observable with the present technology.
