# Invalidity of the Landauer inequality for inform ation erasure in the quantum regime

A known aspect of the C lausius inequality is that an equilibrium system subjected to a squeezing dS < 0 of its entropy must release at least an amount jiQ j = T jiS jof heat. This serves as a basis for the Landauer principle, which puts a low er bound T ln 2 for the heat generated by erasure of one bit of inform ation. Here we show that in the world of quantum entanglement this law is broken, suggesting that quantum carriers of inform ation can be more e cient than assumed so far.

### 1. IN TRODUCTION

The laws of them odynam ics are at the basis of our understanding of nature, so it is rather natural that they have applications beyond their original scope, e.g. in computing and information processing [1, 2, 3, 4, 5, 6, 7, 8]. The rst connection between information storage and them odynam ics was made by von Neumann in the 1950's [2]. H is speculation that each logical operation costs at least an am ount of energy T ln 2 was too pessim istic. Landauer pointed out that reversible \one-to-one" operations can be performed, in principle, without dissipation; only irreversible operations \m any-to-one" operations, like erasure, require dissipation of energy, at an am ount at least equal to the von Neumann estimate T ln 2 per erased bit [4, 5]. This conclusion is a direct consequence [8] of the C lausius inequality, which connects the change of heat with the change of entropy.

The principal in portance of erasure am ong other inform ation-processing operations arises because it is connected with changes of entropy, and thus cannot be realized in a closed system. One needs to couple the inform ationcarrying system with its environment. Therefore the process is accompanied with changes in heat, to be determined by therm odynamics. It was shown rigorously that all computations can be performed using reversible logical operations only [6].

Here we will consider them odynam ic aspects of erasure at low tem peratures, so low that quantum e ects start to play an important role. We choose the simplest example: a one-dimensional Brownian particle in contact with a therm all bath at temperature T, subject to an external con ning potential. The main new aspect arising at low temperatures is an entanglement of the Brownian particle with the bath. Therefore, even when the total system is in a pure state, the subsystem (the Brownian particle) is in a mixed state. Thus its stationary state cannot be given by equilibrium (G ibbsian) quantum therm odynamics. We stress that this situation is not at all exceptional, since it appears even for a sm all but generic coupling provided that temperature is low enough.

O urm ain result will show that when entropy of the particle is decreased by external agents, nam ely when a part of the inform ation carried by it is erased, the particle can absorb heat in clear contrast with the classical intuition. Later we shall apply this result to show that there is not anything sim ilar to Landauer bound at low tem peratures. Indeed, we point out that sim ilar violation occurs for a spin  $\frac{1}{2}$  particle coupled to a harm onic bath (spin-boson m odel). Thus in this respect quantum carriers of inform ation can be more e cient than their classical analogs.

### 2. ERASURE OF INFORMATION AND GIBBSIAN THERMODYNAM ICS

Since inform ation is carried by physical system s, m essages are coded by their states, namely every state (or possibly group of states) corresponds to a \letter". The sim plest example is a two-state system, which carries on one bit of inform ation. The basic model of source of inform ation in Shannonean, probabilistic inform ation theory [13, 14, 15] assumes that the carrier of inform ation can be in di erent states with certain (so called a priori) probabilities. In other words, the m essages of this source appear random ly and the m easure of their expectation is given by the corresponding probabilities. In the quantum case this situation is described by a density matrix

which m eans that the carrier occupies a state  $j_{n}$  is with the a priori probability  $p_n$ . M oreover, di erent quantum states are exclusive,  $l_{n}$  is  $l_{n}$ .

The fundam ental theorem by Shannon [13, 14, 15] states that the inform ation carried by an inform ation source is given by its von Neum ann entropy,

The physical meaning of this result can be understood as follows. A source which has lower entropy occupies fewer states with higher probability. It can be said to be better known, and therefore the appearance of its results will bring less inform ation. In contrast, a source with higher entropy occupies more states with lower probability. Its messages are less expectable, and therefore bring more inform ation. The rigorous realization of this intuitive arguments appeared to be the most straightforward and fultful proof of the Shannon theorem [15, 17]. Notice that the entropy appears here on the inform ation theoretical footing and not as purely therm odynam ical quantities [15].

E rasure is an operation which is done by an external agent in order to reduce the entropy of the inform ation carrier. This means that in its nal state the carrier brings less information, i.e. some amount of it has been erased. In particular, a complete erasure corresponds to the minimization of entropy. Following standard assumptions [16, 17] we will model external operations by a time-dependent H am iltonian H (t) of the carrier, namely some of its parameters will be varied with time according to given trajectories. If the information carrying system is closed, then its dynamics is described by the von N eum ann equation

The entropy remains constant in time. In order to change it, one has to consider an information carrier, which is an open system. In that case a part of its energy will be controlled (i.e. transferred or received) by its environment as heat. Indeed, the average energy of the carrier U = trH (t) (t) changes during a time dt as:

The last term represents the averaged mechanical work dW produced by an external agent [16, 17]. The rst term in rh.s. of Eq. (2.5) arises due to the statistical redistribution in phase space. We shall identify it with the change of heat dQ [16, 17], so Eq. (2.5) is just the rst law of therm odynamics.

## 3. QUANTUM BROWNIAN PARTICLE IN CONTACT W ITH A BATH

As explained, at low temperatures of the bath the Brownian particle is not described by the quantum G ibbs distribution, except for very weak interaction with the bath. Therefore, its state at low temperatures has to be found from rst principles, starting from the microscopic description of the bath and the particle. This program was realized in [9, 10, 21, 22]. In particular, in [9, 10] we investigated statistical therm odynam ics of the quantum B rownian particle.

Here we consider a simple example, a harm onic oscillator with Ham iltonian

H (p;x) =

where m is the m ass, and a is the width. The state of this particle can be described through the W igner function [17]. In quantum theory this object plays nearly the same role as the comm on distribution of coordinate and m om entum in the classical theory. The stationary W igner function reads [21, 23][9, 10]:

where  $T_x = ahx^2 i$  and  $T_p = hp^2 i$  m are two elective tem peratures, to be discussed a bit later. Eq. (3.2) represents the state of the particle, provided that the interaction with the bath was switched on long time before, so that the particle already came to its stationary state. The elective tem peratures  $T_p$  and  $T_x$  depend not only on the system parameters m, T, and a, but also on the damping constant which quantiles the interaction with the thermal bath, and on a large parameter which is the maximal characteristic frequency of the bath. In particular, the G ibbsian limit corresponds to ! 0. Then the distribution (3.2) tends to the quantum G ibbsian:  $T_x = T_p = \frac{1}{2} \cdot !_0 \operatorname{coth}(\frac{1}{2} - !_0)$ ,

where  $!_0 = \int_{a=m}^{p} \frac{1}{a=m}$ . In the classical limit, which is realized for ~! 0 or T ! 1, the dependence on and disappears; both  $T_p$  and  $T_x$  go to T. The appearance of the elective temperatures in the quantum regime can be understood as follows. For T ! 0 quantum G ibbs distribution predicts the pure vacuum state for the particle. Due to quantum entanglement this cannot be the case for a non-weakly interacting particle, so must  $T_x$ ,  $T_p$  depend on , and, being non-trivial, they have to be obtained from is principles, as the state is not G ibbsian. We will be interested by the so-called quasi-O hm ic limit where is the largest characteristic frequency of the problem, the most realistic situation for information storing devices. In this limit one approximately has:

The expressions for heat and work are generalized from Eqs. (2.5) by simply using the W igner function W (p;x) instead of  $\cdot$  One can prove by a direct calculation that quantities  $T_p$ ,  $T_x$  do deserve their nom enclature, since the classical C lausius equality can be generalized as

for variation of any parameter. We will be especially interested in variation of the mass and the width of the potential. The corresponding changes of heat read

One can show that Q = Qa = 0, Q = Qm = 0, for all values of parameters including, of course, the classical limit. The work done on the system is

#### 4. HEAT ABSORPTION W ITH (OUT) ENTROPY DECREASE

Now we will show that there are erasure processes, namely processes where  $dS_{vN} = 0$ , which are accompanied by an absorption of heat. We noticed already that heat is always absorbed, when the mass is increased. There is a mass-increasing process, where  $dS_{vN} = 0$ , since one has at very low temperatures:  $(S_{vN} = 0) = 0$ . An analogous argument can be brought about in the weak-coupling case, ! = 0, and low-temperature limit:

This also implies @w = @m < 0. Recall that the corresponding expression for @Q = @m was positive. This just means that for the variation of m we have an interesting case where heat is absorbed when entropy is decreasing. This is a counterexample for the general validity of the Landauer principle.

In another approach we considered the spin-boson model [26], where a spin- $\frac{1}{2}$  particle is coupled to a bosonic bath. There it is possible to give a pulse, where the spin is rotated very fast, but, since it is only rotated, entropy is conserved. Nevertheless, there are cases where heat can be extracted from the bath.

The Landauer principle requires dissipation (release) of T jdS junits of energy as a consequence of erasure of jdS j units of information. This was believed to be the only fundamental energy cost of computational processes [4, 5, 6, 8]. Though in practice computers dissipate much more energy, the Landauer principle was considered to put a general physical bound to which every computational device interacting with its thermal environment must satisfy. Indeed, in several physical situations the Landauer principle can be proved explicitly [8].

The main purpose of the present paper was to provide counterexamples of this principle, and thus to question its universal validity. In the reported case all general requirements on the information carrier and its interaction with the bath are met. The only new point of our approach is that we were interested by su ciently low temperatures, where quantum e ects are relevant. The Landauer principle appeared to be violated by these e ects (in particular, by entanglement). The result occurs in the two most standard models, namely the Caldeira-Leggett model (central oscillator coupled to a harm onic bath) and the spin-boson model (two-level system coupled to such a bath), and therefore should be very general.

Recently the Landauer bound attracted serious attention from the eld of applied information science [27]. There is a belief that it can be approached by further miniaturization of computational devices. It is hoped that the present paper will help to understand limitations of the Landauer principle itself, which may lead to unexpected mechanisms for computing in the quantum regime.
