## Quantum -dot lithium in strong-interaction regime: Depolarization of electron spins by magnetic eld

M agnetic eld usually leads to a polarization of electron spins. It is shown that in a system of strongly interacting particles applying m agnetic eld m ay lead to an opposite e ect { depolarization of electron spins. R esults of the work are based on an exact-diagonalization study of quantum -dot lithium { a system of three C oulom b interacting two-dimensional electrons in a parabolic con nem ent potential.

It is well known that, applying a magnetic eld to a system of charged particles (e.g. electrons) results in the polarization of their spins. Indeed, being placed in a potential box, N electrons occupy the low est-energy states (two ones with opposite spins per state), to minimize their total kinetic energy. The total spin of the system S will then be small compared to N =2. If the system is now placed in a magnetic eld B, the Zeem an energy competes with the kinetic energy and favours the spin alignment along the eld. The larger the magnetic eld, the more electron spins ip over, and at su ciently strong B the whole system appears to be in the fully spin-polarized state with S = N =2.

This picture is valid if the inter-particle interaction is not too strong and can be neglected. In a system of strongly interacting particles the interaction can polarize the system already in the absence of magnetic eld. An example is a (spin-polarized) W igner crystal, which was shown to be the ground state of a system of strongly interacting electrons on a positive jellium background.<sup>1</sup> E lectron-electron interaction forces electrons to occupy higher single-particle energy levels (which reduces the C oulom b energy at the cost of the kinetic one), and favours the ground state with a large total spin S ' N =2.

Now one can ask, what happens with the system of strongly interacting particles, already spin-polarized by the inter-particle interaction, if to place it in a magnetic eld. At rst glance one could think that the magnetic

eld B = (0;0;B) will only split the ground state with S = N =2 onto sublevels with di erent total-spin projections S<sub>z</sub> = N =2; (N =2 1);:::. It turns out how ever that there exist situations when the growing magnetic eld reduces the total spin S of the system (i.e. forces the back spin-ip of som e electrons). This unusual effect is a consequence of a competition of the kinetic, Coulomb and Zeem an energies and may occur only in systems of strongly interacting particles. In this paper we dem onstrate the feasibility of this interesting e ect by the example of quantum -dot lithium { a system of three two-dimensional (2D) electrons in the harm onic oscillator potential.

Q uantum dots<sup>2</sup> are ideal physical objects for studying e ects of electron-electron correlations. In these systems, realizable in m odern sem iconductor heterostructures, 2D electrons m ove in the plane z = 0 in a lateral harm onic oscillator potential V (r) = m<sup>?</sup>! $_0^2$ r<sup>2</sup>=2, r = (x;y). The C oulom b interaction parameter in dots

is de ned as the ratio of the oscillator length  $l_0 = h = m^2 !_0$  to the electron electron electron electron electron (here m<sup>2</sup> is the electron electron electron ass, and !\_0 the oscillator frequency). The parameter can be varied in a wide range, as opposed to natural atom s, which allow some to study properties of the dots as a function of the interparticle interaction strength. Quantum dots were intensively studied in recent years by a variety of experimental and theoretical techniques, see e.g. Refs.<sup>2</sup><sup>{7</sup></sup> and references therein.

M any-body quantum states of quantum -dot lithium (N = 3) are characterized by quantum numbers  $L_z$  (projection of the total angular m om entum on the z axis), S and  $S_z$ . In zero magnetic eld energies of these states can be written in the form

where  $F_{LS}$  are some functions of the interaction parameter . The functions  $F_{LS}$  () have been calculated in Ref.<sup>8</sup> using exact-diagonalization technique (convergency of the m ethod was studied in detail in<sup>8</sup>; the accuracy of results for the energy of levels was shown to be better than 5 10<sup>4</sup>% at 10). Levels (2) are degenerate with respect to  $J_{Lz} j$  L and  $S_z$ . In nite magnetic elds we calculate the energy levels and m any-body wave functions, as functions of two dimensionless variables and  $_{c} = !_{c} = !_{0}$ , by the form ulas

=  $(1 + {}^{2}_{c}=4)^{1=4}$ , which directly follow from the H am iltonian of the dot (here !<sub>c</sub> is the cyclotron energy, m<sub>e</sub> is the free electron m ass, and g<sup>2</sup> is the electron energy.

Q uantum -dot lithium is an atom, in which strong C oulomb interaction does lead to a full spin polarization in the absence of magnetic eld.<sup>9,8</sup> In the regime of weak C oulomb interaction ( <  $_{\rm crit}$  = 4:343, Ref.<sup>8</sup>) its ground state is partly spin-polarized, (L;S) = (1;1=2). At strong interactions ( >  $_{\rm crit}$ ) the ground state is fully polarized, with (L;S) = (0;3=2). In the weak interaction regime <  $_{\rm crit}$  magnetic eld dependencies of the ground state properties were studied in a num ber of papers earlier, see Refs.<sup>10 {13</sup>. In the present paper we report results on the ground state properties of quantum – dot lithium for a broad range of parameters, including the regime of strong C oulomb interaction >  $_{\rm crit}$ .




FIG.1. M agnetic eld dependencies of the ground state levels  $E_{L_zSS_z}$  [the curves are labeled as ( $L_z;S_z$ )] in the regime of weak (a and b), = 2, and strong (c), = 8, interactions. Zeem an splitting is ignored in Figures (a) and (c), and included, with parameters of G aA s dots (g<sup>?</sup> = 0.44, m<sup>?</sup>=m<sub>e</sub> = 0.067), in Figure (b).




FIG.2. Coulom b interaction { magnetic eld diagram s ( vs  $_{\rm c}$ ) for the ground states of quantum -dot lithium, without (a) and with (b) Zeem an splitting (G aA s param eters are assumed). The areas 0, 1, 2, ... are labeled as ( $L_z;S_z$ ). States with L 10 are not shown.

In Figure 1 we show energies of a number of groundstate levels as a function of B in the weak and strong interaction regimes (parameters of G aAs quantum dots were used when necessary). When B increases, the system oscillates between partly ( $S_z = 1=2$ ) and fully  $(S_z = 3=2)$  spin-polarized ground states, with the total angular momentum of the fully polarized states being multiples of N . Between the fully polarized states with L = 3, 6, 9, :::, pairs of partly polarized states appear, with L = 1 and 2, 4 and 5, 7 and 8, and so on. If Zeem an splitting is ignored, these partly polarized states can be the ground states at all magnetic elds. If Zeem an splitting is included, only fully spin-polarized ground states with L = N integer survive at strong B. Full c diagram s for the ground states of quantum dot lithium with di erent L and Sz are shown in Figure 2. Sim ilar results for quantum -dot helium (N = 2) were obtained in Ref.<sup>14</sup> (in helium the system oscillates between the singlet, S = 0, and triplet, S = 1, ground states with even and odd values of L respectively). In the weak-interaction regime our results quantitatively agree with those obtained in R ef.<sup>10</sup> (exact-diagonalization technique) at 2.

A new and interesting feature of the energy spectrum of quantum -dot lithium is seen in Figure 1c (the regime of strong C oulom b interaction, = 8) at sm all m agnetic elds. In the strong-interaction regime, > crit, the B = 0 ground state is fully spin-polarized and has the total angular m om entum L = 0, while the rst excited state is partly polarized and has the total angular momentum L = 1. When B increases, the ground state (0;3=2) has, mainly, a positive dispersion (  $^{2}_{c}$ ), due to the second term in Eq. (3) (the weak negative dispersion due to the Zeem an term  $g^2m^2 cS_z$  can be ignored because of the sm all value of prefactors g<sup>?</sup>m<sup>?</sup>). The rst excited state (1;1=2) has a strong negative dispersion due to the st term  $_{\rm c}L_{\rm z}$ =2 (L<sub>z</sub> < 0 in the ground state). These two low est-energy levels cross each other at a certain critical magnetic eld  $B = B_{crit}$  (). The corresponding dim ensionless critical param eter crit () is of order 0.1 at > 6, F igure 2. R elation between B<sub>crit</sub> and  $_{c}^{crit}$ , for typical parameters of G aAs quantum dots, can be written in the form

which gives B<sub>crit</sub> ' 12 m T at ' 8. At B > B<sub>crit</sub> the totalspin and its projection are 1=2 and + 1=2 in the ground state, while at B < B<sub>crit</sub> they were 3=2 and + 3=2, respectively. The growing magnetic eld thus causes a back spin-ip of one electron in the dot. This som ew hat unexpected result is a direct consequence of strong C oulom b interaction in the dot at > crit. In the weak inter- $_{\rm crit}$  the critical eld B  $_{\rm crit}$  ( ) is zero, action regime and the e ect is absent. The assumption on the purely parabolic con nem ent potential in the dot is not essential for this e ect. It should also be seen in three-electron system swith non-parabolic con nem ent, if the Coulom b interaction is su ciently strong to polarize the system in the absence of magnetic eld. The nature of the  $L_z SS_z$ states (behaviour of electron and spin densities, as well as pair-correlation functions) can be understood on the basis of Eq. (4) and results of  $Ref.^8$ .




FIG.3. M agnetic m om ent (in the Bohr m agneton units) of quantum -dot lithium in the moderate (= 3) and strong (= 8) C oulom b-interaction regimes. Zeem an splitting is included.

Finally, we brie y discuss B -dependencies of the m agnetic m om ent of the dot, =  $@E_{GS} = @B$ , at zero tem – perature ( $E_{GS}$  is the ground-state energy). Figure 3 exhibits two typical (B)-curves, in the weak and strong C oulom b interaction regimes. The magnetic m om ent strongly oscillates as a function of B, in accordance with the energy curves in Figure 1. At low magnetic elds, the quantum -dot lithium atom is paramagnetic in the regime of weak interactions, and mainly diamagnetic in the regime of strong interactions (except of the region of the very small elds, where it is paramagnetic due to the small g<sup>2</sup>S<sub>z</sub> contribution to the energy).

To sum marize, we have reported results of an exactdiagonalization study of quantum-dot lithium in nite magnetic eld. In the regime of strong C oulomb interaction, which was not treated in the literature so far, we have found a new and unexpected e ect of spin depolarization of the quantum-dot lithium atom by weak magnetic eld (the total spin S changes from S = 3=2 to S = 1=2 with the growth of B). The predicted e ect is the case in the regime of strong C oulomb interaction >  $_{\rm crit}$  = 4:343 and in magnetic elds of order of 1 m T. It could be observed in capacity-, transport-, and R am anspectroscopy experiments on quantum-dot system s.
