Finite Size Scaling analysis of the avalanches in the 3d Gaussian Random Field Ising Model with metastable dynamics

A num erical study is presented of the 3d G aussian R andom Field Ising M odelat T = 0 driven by an external eld. Standard synchronous relaxation dynam ics is employed to obtain the magnetization versus eld hysteresis loops. The focus is on the analysis of the number and size distribution of the magnetization avalanches. They are classified as being non-spanning, 1d-spanning, 2d-spanning or 3d-spanning depending on whether or not they span the whole lattice in the different space directions. Moreover, nite-size scaling analysis enables identification of two different types of non-spanning avalanches (critical and non-critical) and two different types of 3d-spanning avalanches (critical and subcritical), whose numbers increase with L as a power-law with different exponents. We conclude by giving a scenario for avalanche behaviour in the therm odynam ic limit.

I. INTRODUCTION

Systems with rst-order phase transitions exhibit a discontinuous change of their properties when driven through the transition point. Som etim es, due to the existence of energy barriers larger than them al uctuations, such system s evolve following a path of metastable states and exhibit hysteresis. M etastable phenom ena develop more often in the case of systems at low temperature and with quenched disorder. In many cases the rst-order phase transition occurs, instead of at a certain transition point, in a broad range of the driving param eter and the discontinuity is split into a sequence of jum ps or avalanches between metastable states. Moreover, under certain conditions such avalanches do not show any characteristic spatial or time scale: the distribution of their size and duration becomes a power-law. This fram ework, which has sometimes been called uctuationless rst-order phase transitions [1, 2], is one of the basic mechanisms responsible for power-laws in nature [3]. Experim ental examples have been found in a broad set of physical systems: magnetic transitions [4], adsorption [5], superconductivity [6], martensitic transform ations [7], etc.

A paradigm atic model for such uctuationless rst-order phase transitions in disordered system is the G aussian R andom Field Ising M odel (GRFIM) at T=0 driven by an external eld H . The amount of quenched disorder is controlled by the standard deviation of the G aussian distribution of independent random elds acting on each spin. M etastable evolution is obtained with appropriate local relaxation dynamics which assumes a separation of time scales between the driving eld rate dH =dt and the avalanche duration. The response of the

system to the driving eld can be followed by measuring the total magnetization m (H). The response exhibits the above-mentioned metastable phenomena: hysteresis and avalanches.

Since the model was introduced some years ago [8, 9], di erent studies (num erical and analytical) have been carried out in order to characterize the hysteresis loops m (H) and the magnetization avalanches [10, 11, 12, 13, 14, 15]. Two of the most well-studied properties are the num ber of avalanches N () and the distribution D (s;) of avalanche sizes s along half a hysteresis loop. For large am ounts of disorder (> $_{\text{c}}$) the loops look sm ooth and continuous. They consist of a sequence of a large number of tiny avalanches whose size distribution D (s; > decays exponentially with s. On the other hand, for small am ounts of disorder (< c), besides a certain number of sm all avalanches, one or several large avalanches produce a discontinuity m in the hysteresis loop. For an interm ediate critical value c the distribution D (s; c) of avalanche sizes s can be approximated by a power-law: D (s; c) s.

M any of the properties of the GRFIM have been understood by assuming the existence of a T = 0 critical point ($_{\rm c}$;H $_{\rm c}$) on the metastable phase diagram. The more recent estimation [13] renders: $_{\rm c}$ = 2:16 0:03 and H $_{\rm c}$ = 1:435 0:004. Although partial agreement on the values of the critical exponents has been reached, other features are still controversial.

One of the fundam ental problems is the denition of the order parameter. From a thermodynamic point of view the discontinuity of the hysteresis loop mesems to be an appropriate order parameter if m > 0 for < c and m = 0 for > c. Nevertheless, in the T = 0 numerical simulations, due to the nite size of the system and for a given realization of disorder, all the magnetization changes are discontinuous. Note that this does not occur for standard thermal numerical simulations in which, due to thermal averaging, magnetization is continuous for nite systems. Only nite-size scaling

analysis will reveal which are the \large avalanches" and whether or not avalanches become vanishingly small in the therm odynam ic lim it. It is thus very important to study the properties of the \spanning" avalanches. These are avalanches that, for a nite system with periodic boundary conditions, cross the system from one side to another. In particular it would be interesting to measure the number N $_{\rm S}$ () of spanning avalanches and their size distribution D $_{\rm S}$ (s;).

A second unsolved question, related to the previous one, is the spatial structure of the avalanches. It has been suggested that they are not compact [10, 16]. A fractal dimension (df = 1=0.34 < 3) has been estimated from the avalanche size distribution [11]. It would be interesting to understand how such a fractal behaviour may, in the thermodynamic limit, represent a magnetization discontinuity.

A third problem is the de nition of the scaling variables in order to characterize the critical properties close to the critical point (c;Hc). When focusing on the study of avalanche properties, it should be pointed out that the scaling analysis is performed by using quantities (N () and D (s;)) measured recording all the avalanches along half a hysteresis loop. The measurem ent of non-integrated distributions, i.e. around a certain value of H , will require large amounts computing e ort in order to reach good statistics for large enough system s. Therefore, the dependence on the eld H is integrated out and the distance to the critical point c is m easured by a single scaling variable u (). A Ithough in pioneering papers [8, 9] the most usual scaling variable $_{\rm c}$) = $_{\rm c}$ was used in order to scale the avalanche size distribution, forthcom ing studies [10, 11, 13] changed the de nition to $u_3 = ($ $_{\rm c})$ = . Apparently both definitions are equivalently close to the critical point, but it can be checked that the \phenom enological" scaling of the distributions D (s;) using u_3 (with $u_3 > 0.04$) as suggested in the inset of Fig. 1 in Ref. 10, is not possible when using u_1 .

Finite-size scaling analysis has been carried out [13, 16] for the number of spanning avalanches N s (;L). Nevertheless, such nite-size scaling has not been presented either for the avalanche size distributions D (s; ;L) or for the number of non-spanning avalanches N_{ns} (;L). Most of the studies [10, 13] have proposed collapses by neglecting the fact that simulated systems are nite. There is an exception [12, 17] for which the scaling of the avalanche distributions with L has been studied. In this case, nevertheless, the dependence on the distance to the critical point has been neglected and, consequently, param eterdependent exponents have been obtained. In our opinion, scaling of the avalanche distribution must be studied on a two dim ensional plane, including a scaling variable which accounts for the nite-size L and another which accounts for the distance to the critical point.

P revious studies have provided simulations of very large system sizes (up to L=1000) [14]. This has been advantageous for the study of self-averaging quantities.

N evertheless, the properties of the spanning avalanches are non-self averaging. This is because, as will be shown, the number of spanning avalanches per loop does not grow as L^3 . This means that, in order to obtain better accuracy, it is more important to perform averages over dierent disorder congurations (which will be indicated by h i) than to simulate very large system sizes.

In this paper we present intensive num erical studies of the metastable 3d-GRFIM and focus on analysis of the spanning avalanches. In section II the model, the de nition of a spanning avalanche and the details of the num erical simulations are presented. In section III raw numerical results are given. In section IV som e of the Renorm alization Group (RG) ideas will be reviewed, which will be taken into account for the analysis of the critical point. A nite-size scaling analysis of the avalanche numbers is presented in section V. The same analysis for size distributions and their k-m om ents are presented in sections VI and VII respectively. Section VIII presents a discussion on the behaviour of magnetization. The discussion of the results in relation with previous works is presented in section IX. Finally in section X a full sum mary and conclusions is given.

II. M ODEL

The 3d-GRFIM is de ned on a cubic lattice of size L L L.On each lattice site (i=1;:::;E) there is a spin variable S_i taking values 1. The Ham iltonian is:

where the rst sum extends over all nearest-neighbour (n,n) pairs, H is the external applied eld and h_i are quenched random elds, which are independent and are distributed according to a Gaussian probability density

where the standard deviation $\,$, is the parameter that controls the am ount of disorder in the system . Note that $hh_i i$ = 0 and $hh_i^2 i$ = 2 .

The system is driven at T = 0 by the external eld H . For H = +1 the state of the system which minimizes H is the state with maximum magnetization m = $P_{i=1}^{3} S_{i}=L^{3}=1$. When the external eld H is decreased, the system evolves following local relaxation dynamics. The spins ip according to the sign of the local eld:

where the sum extends over the 6 nearest-neighbouring spins of s_i . A valanches occur when a spin ip changes the sign of the local eld of som e of the neighbours. This

may start a sequence of spin ips which occur at a xed value of the external eld H, until a new stable situation is reached. H is then decreased again. This \adiabatic" evolution corresponds to the limit for which avalanches are much faster than the decreasing eld rate. Note that, once the local random elds are xed, them etastable evolution is completely deterministic, no inverse avalanches may occur and the hysteresis loops exhibit the return point memory property [8].

The size of the avalanche's corresponds to the number of spins ipped until a new stable situation is reached. Note that the corresponding magnetization change is $m=2s=L^3$.

For a certain realization of the random elds, corresponding to a given value of , we have recorded the sequence of avalanche sizes during half a hysteresis loop, i.e. decreasing H from +1 to 1. The two main quantities (see Table I) that are measured after averaging over dierent realizations of disorder, are the total number of avalanches per loop N (;L) and the distribution of avalanche sizes D (s; ;L), normalized so that:

Note that given this normalization condition and the fact that s is a natural number, then D (s; ;L) 1.

The num erical algorithm we have used is the so-called brute force algorithm propagating one avalanche at a time [14]. We have studied system sizes ranging from $L = 5 (L^3 = 125)$ to $L = 48 (L^3 = 110592)$. The mea-

sured properties are always averaged over a large number of realizations of the random eld con guration for each value of . Typical averages are performed over a number of congurations that ranges between 10^5 for L = 16 to 2000 for L = 48.

We have used periodic boundary conditions: the num erical simulations correspond, in fact, to a periodic innite system. Therefore, strictly speaking, all avalanches are in nite. Nevertheless, we need to identify which avalanches will become important in the therm odynamic lim it. The de nition that best matches this idea is the concept of spanning avalanches: those avalanches that, at least in one of the x, y or z directions, extend over the length L. This de nition is very easy to implement numerically in the brute force algorithm. Spanning avalanches are detected by using three (x;y;z) m ask vectors of size L whose elements are set to 0 at the beginning of each avalanche. During the evolution of the avalanche the mask vectors record the shade of the ipping spins along the three perpendicular directions (by changing the 0's to 1's). When the avalanche nishes, it can be classied as being non-spanning, 1d-spanning , 2d-spanning or 3d-spanning depending on the number of such mask vectors that have been totally converted to 1. The number and size distribution of 1d, 2d and 3d-spanning avalanches is also studied and averaged over di erent realizations of disorder. Table I shows the de nitions of avalanche numbers and distributions that will be used throughout the paper. In Table II the list of m athem atical relations between the avalanche numbers and distributions is given. We will use the subscript to indicate any of the avalanche numbers or distributions in Table I.

It should be mentioned that, although the de nition of spanning avalanches used in this paper is equivalent to the de nition in previous works[13, 14, 16], the average number of spanning avalanches N $_{\rm S}$, in some cases, does not coincide with the previous estimations. We guess that the reason is because, in previous works, the method used to count spanning avalanches was averaging twice the 2d-spanning avalanches and was averaging three times the 3d-spanning avalanches. There-

fore, in order to compare, for instance with Ref. 13, one should take into account that their number of spanning avalanches N is not equal to the present N $_{\rm s}$ but satis es: $N = (N_1 + 2N_2 + 3N_3)=3$. Moreover, we should point out the following remark before presenting the data. As a consequence of the num erical analysis, several \kinds" of avalanches will be identied (see Table I). Such a separation in di erent kinds will, in som e cases, be justied by the measurement of dierent physical properties (such as whether the avalanche spans the lattice or not) but, in other cases, will be an \a priori" phenom enological hypothesis to reach a good description of the data. Although some authors will prefer to identify such new \kinds" of avalanches as \corrections to scaling", it will turn out that after the nite size scaling analysis we will be able to identify which dierent physical properties characterize each \kind" of avalanche.

III. NUMERICAL RESULTS




FIG. 1: A valanche size distribution corresponding to (a) = 1:7, (b) = 2:21 and (c) = 2:6. Data have been obtained from a system with size L = 24 after averaging over 10^5 realizations of the disorder.

Fig. 1 shows an example of the distribution of avalanches D (s; ;L) on a log-log scale for three values of corresponding to a system with size L = 24. The qualitative behaviour of D (s; ;L) is that already described in the introduction: when is decreased the distribution changes from being approximately exponentially damped (> c) to a distribution exhibiting a peak for large values of s (< c). Therefore, one can suggest that at the critical value c the distribution exhibits power-law behaviour. Nevertheless, it is also evident from Fig. 1 that the nite size of the system masks this excessively simplistic description. Only after convenient nite-size scaling analysis shall we discover which features remain in the therm odynamic limit.




FIG. 2: A nalysis of the di erent contributions to D (s; ;L) for = 2:317 and L = 16. D ata corresponds to an average of $2\ 10^5$ realizations. (a) Full distribution, (b) distribution of spanning avalanches D $_{\rm S}$ (s; ;L); (c) D istributions D $_{\rm 1}$ (s; ;L), D $_{\rm 2}$ (s; ;L) and D $_{\rm 3}$ (s; ;L).

The peak occurring for < $_{\rm C}$ is basically caused by the existence of spanning avalanches. This is shown in Fig.2 where the peak in D (s; ;L) Fig.2(a)] is compared with the two contributions D $_{\rm ns}$ (s; ;L) and D $_{\rm s}$ (s; ;L) Fig.2(b)].

As can be seen the distribution of spanning avalanches D_s(s; ;L) is far from simple. It exhibits a multipeak structure caused by the contributions from $D_1(s; ; L)$, D_2 (s; ;L) and D_3 (s; ;L) shown in Fig. 2c. M oreover, D₃ (s; ;L) itself also exhibits two peaks suggesting that the 3d-spanning avalanchesm ay be of two di erent kinds. W e shall denote critical 3d-spanning avalanches (indicated by the subscript 3c) as those corresponding to the peak on the left and subcritical 3d-spanning avalanches (indicated by the subscript 3) as those corresponding to the peak on the right. As will be explained below, the 1dspanning avalanches, the 2d-spanning avalanches and the critical 3d-spanning avalanches do not exist in the therm odynam ic \lim it except when = \int . This is the reason for having chosen the word \critical" for this kind of 3d spanning avalanche. It will also be shown that, in the therm odynam ic lim it, subcritical 3d-spanning avalanches only exist for c. As regards the non-spanning

avalanches, they will also be classi ed into two types at the end of this section, although this separation cannot be deduced from the behaviour in Fig. 2(b).




FIG. 3: A nalysis of the dependence of D $_1$ (s; ;L) (top), D $_2$ (s; ;L) (m iddle) and D $_3$ (s; ;L) (bottom) with . D ata correspond to averages of 2 10^5 realizations of a L = 10 system with (a) = 1:9, (b) = 2:2, (c) = 2:5 and (d) = 2:8.

Fig. 3 shows the evolution of D $_1$ (s; ;L), D $_2$ (s; ;L) and D $_3$ (s; ;L) when is increased. Note that the right-hand peak of D $_3$ (s; ;L) shifts to smaller values of s and becomes at, indicating that the mean size of these subcritical 3d-spanning avalanches decreases. Moreover, above $_c$ [Fig. 3 (d)] this right-hand peak disappears and a peak on the left emerges.




FIG. 4: Number of spanning avalanches in 1d (a), 2d (b) and 3d (c) as a function of . The di erent curves correspond to L=5;8;10;12;16;24;32 and 48 as indicated by the legend. Lines are a guide to the eye.

Besides the normalized distributions, it is also interesting to analyze the actual average numbers of spanning avalanches N $_1$ (;L), N $_2$ (;L) and N $_3$ (;L), which also exhibit singular behaviour at $_{\rm c}$ as shown in Fig. 4.

From the direct extrapolation of the data corresponding to di erent system sizes to L ! 1 , we can make the following assumptions: in the therm odynamic limit N $_1$ () and N $_2$ () will display a —function discontinuity at $_{\rm C}$. N $_3$ () will display step-like behaviour: for < $_{\rm C}$ there is only one 3d-spanning avalanche, for > $_{\rm C}$ there are no 3d-spanning avalanches and at = $_{\rm C}$ the data supports the assumption that N $_3$ will also display

a —function singularity at the edge of the step function. This reinforces the suggestion that there are two di erent types of 3d-spanning avalanches: as will be shown, in the therm odynam ic limit, the number of subcritical 3d spanning avalanches N $_{\rm 3}$ behaves as a step function, whereas the number of critical avalanches N $_{\rm 3c}$ exhibits divergence at $_{\rm c}$.




FIG. 5: (a) Total number of spanning avalanches N $_{\rm s}$ (;L) and (b) non-spanning avalanches as a function of for different system sizes L as indicated by the legend. Lines are a quide to the eye.

The total number of spanning avalanches N $_{\rm S}$ (;L) and non-spanning avalanches N $_{\rm nS}$ (;L), are displayed in Figs. 5(a) and 5(b) respectively. N $_{\rm S}$ (;L) shows, as a result of the divergence of N $_{\rm 3c}$, N $_{\rm 1}$ and N $_{\rm 2}$, a -function singularity at $_{\rm c}$ when L ! 1 suggesting that the critical point is characterized by the existence of 1 spanning avalanches. We would like to point out that previous studies have not clarified this result for the 3d-GRFIM [13]

The analysis of N $_{\rm ns}$ is m ore intricate. Fig. 5(b) shows that N $_{\rm ns}$ (;L) grows with and L. For large amounts of disorder (! 1) one expects that the hysteresis loop consists of a sequence of non-spanning avalanches of size 1. Therefore, their number will equal L 3 . To reveal this




FIG. 6: Number of non-spanning avalanches N $_{\rm ns}$ (;L) divided by L $^{\rm 3}$ as a function of and di erent system sizes, as indicated by the legend. The inset shows the behaviour of the same quantity as a function of L for di erent values of . The dashed line indicates the value N =L $^{\rm 3}$ = 0.028 and the continuous line is a tofthe behaviour proposed in equation (26).

behaviour Fig. 6 shows the dependence of N $_{\rm ns}$ (;L)=L 3 as a function of . One expects that these lines tend to 1 when ~!~1 . Moreover, a closer look reveals that at $_{\rm c}$ ' 2:21, there is a contribution to N $_{\rm ns}$ (;L)=L 3 which decreases with system size. For low values of one expects that non-spanning avalanches always exist, except at = 0. This last statement can easily be understood by noticing that an approximate lower bound to the number of non-spanning avalanches can be computed by analyzing how many of the spins S_i will ip by them selves, independently of their neighbours, due to the fact that the local edd h_i is either larger than 6 or smaller than 6. This analysis renders $N_{\rm ns}$ =L 3 > $_{\rm err}$ (6=) where $_{\rm err}$ is the error function.

From these considerations, we expect that for L ! 1 the curves in Fig. 6 tend to a certain limiting behaviour which increases smoothly from 0 to 1. This can also be appreciated in the inset in Fig. 6, which shows the behaviour of N $_{\rm ns}$ (;L)=L 3 as a function of L for four di erent values of the am ount of disorder: = 1:7, = 2:21 $^\prime$ $_{\rm c}$, = 2:5 and = 2:7. The four curves exhibit a tendency to extrapolate to a plateau when L ! 1 . For the case of $^\prime$ $_{\rm c}$ an estimation of the extrapolated value is N $_{\rm ns}$ ($_{\rm c}$;L)=L 3 ! 0:028.

Consequently, it is necessary to consider the existence of, at least, two kinds of non-spanning avalanches. Those whose number N $_{\rm n\,s0}$ increases as L 3 will be denoted as non-critical non-spanning avalanches (with the subscript ns0), and those whose number N $_{\rm n\,sc}$ increases with L with a smaller exponent will be called critical non-spanning avalanches (with the subscript nsc). In fact, a log-log plot

of N $_{\rm ns}$ ($_{\rm c}$;L)=L 3 0:028 versus L provides an estimation for this exponent N $_{\rm nsc}$ ($_{\rm c}$;L) 0:085L 2 :02.

All the assumptions that have been presented, corresponding to behaviour in the thermodynamic limit, will be con med by the nite-size scaling analysis presented in the following sections.

IV. RENORMALIZATION GROUPAND SCALING VARIABLES

The basic hypothesis for the analysis of the above results using RG techniques is the existence of a xed point in the multidim ensional space of H am iltonian parameters. This xed point sits on a critical surface which extends along all the irrelevant directions. By changing the two tuneable parameters and H, the critical surface can be crossed at the critical point ($_{\rm C}$; H $_{\rm C}$). As has been explained in the Introduction concerning the analysis of the avalanche number and size distributions, the dependence along the external eld direction H has been integrated out. One expects that such integration m ay distort some of the exponents and the shape of scaling functions, but not the possibility of an RG analysis. This

is because the integration range crosses the critical surface where the divergences occur.

For a L! 1 system we assume a unique scaling variable u() which measures the distance to $_{\rm c}$. The dependence of u on should be smooth, but its proper form is unknown [18]. We will discuss three dierent possibilities:

1. The standard choice is to use a dimensionless rst approximation by expanding u() as:

Nevertheless, in general, the correct scaling variablesm ay have a dierent dependence on . For instance, thism ay be due to the existence of other relevant parameters, such as the external eld, which has been integrated out.

2. A second choice is to extend the expansion of u()

to second order by including a tting am plitude A:

3. A third choice, which has been used in previous analyses and may be \phenomenologically" justied is:

Note that the Taylor expansion of this function is:

Fig. 7, shows the behaviour of the three scaling variables u_1 (), u_2 () and u_3 (). For the representation of u_2 we have chosen A=0.2, which is the result that we will t in the following sections. The three choices are equivalently close enough to the critical point. Nevertheless, the amplitude of the critical zone, where the scaling relations are valid, may be quite dierent. Since A<0, the variable u_2 cannot be used for c_2 since c_3 c. A similar problem occurs with c_3 since, due to its asymptotic behaviour c_3 ! 1 for ! 1), system s with a large value of cannot be distinguished one from another.

For the nite system, the magnitudes presented in Table I, depend on , L and, in the case of the size distributions, on s. In order to identify the scaling variables,




FIG.7: Comparison of the behaviour of the three choices for the scaling variable u, discussed in the text. We have used c=2.21.

Let us consider a renorm alization step of a factor b close to the critical point [19, 20], such that lengths behave as:

C lose to the critical point the system exhibits invariance under re-scaling. Therefore, in order to propose a scaling hypothesis of the numbers of avalanches N and the avalanche size distributions D , it is important to construct combinations of the variables u, L and s, w hich remain invariant after renormalization. Note that these three invariant quantities are not independent since equation (12) corresponds to equation (14) multiplied by equation (13) to the power of 1=d.

V. SCALING OF THE NUMBERS OF AVALANCHES N (;L)

The discussion in the previous section, enables us to propose the following scaling hypothesis:

The exponent characterizes the divergence of the avalanche numbers at the critical point when L ! 1. Note that this denition of (which is the same used in previous works [13]) is not consistent with the standard nite-size scaling criterion for which them agnitudes grow with exponents divided by . [19, 20, 21].

As will be shown, the behaviour of the number of 1d-spanning avalanches, 2d-spanning avalanches and critical 3d-spanning avalanches can be described with the same value of $_1$ = $_2$ = $_{3c}$ = , so that:

W e have tried, without success, to scale the number of critical non-spanning avalanches with the same exponent . We therefore need to de ne a dierent exponent $_{\rm nsc}$, so that:

As regards the number of N $_3$ avalanches, which is different from zero away from the critical point in the thermodynam ic limit, we propose a scaling hypothesis that is compatible with the limiting behaviour at = 0 and = 1. This leads us to the following assumption:

since in the absence of disorder we expect that the hysteresis loop displays a single avalanche of size L^3 , and, consequently the number of avalanches must be N $_3\ =\ 1$ independent of the value of L .

As regards N $_{\rm N\,SO}$ it has already been discussed that such avalanches will exist in the therm odynam ic lim it for all values of . Moreover, they are probably not related to critical phenomena at $_{\rm c}$. For this reason we propose the following non-critical dependence:

In particular, as already mentioned, for large values of disorder (! +1) these avalanches will be of size s=1, and their number will be N $_{ns0}$ (1) = L^3 .

It should also be mentioned that the scaling equations (15) adm it alternate expressions by extracting the variable uL $^{1=}$ with the appropriate power so that it cancels out the dependence on L:

N evertheless, such expressions are not very useful for the scaling analysis close to $_{\rm c}$ since they will display a large statistical error due to the fact that u! 0 when! $_{\rm c}$.




FIG. 8: (a) Scaling plot of the number of 1d-spanning avalanches according to equation (16) using u_1 as the scaling variable. The values of the free parameters for the best collapses are indicated by the legend. Symbols correspond to the sizes indicated in the legend of Fig. 4. (b) Same plot, but using the scaling variable u_2 . Note that in this case there is an extra free parameter. (c) Same plot but using u_3 . The continuous line in (b) shows the tofa Gaussian function.

Figs. 8 and 9 show the best collapses corresponding to equations (16) and (17) with the three di erent choices for the variable u, explained in section IV. Data corresponding to L = 5;8;10;12;16;24;32 and 48 have been used. The quality of the collapses close to c is quite good in the three cases. The values of the free param eters that optimize each collapse are indicated on the plots. By visual comparison one can see that u2 is the best choice since it allows the smaller sizes to collapse too. Of course, this is because the collapses in this case have an extra free-param eter A. As regards the quality of the overlaps, no remarkable di erences are observed between the choices u_1 and u_3 . In the following collapses we will use u_2 with A = 0.2. Thus, the best estimations of the free param eters are: c = 2.21 0.02, = 1.2 0.1 and = 0:10 0:02.

The procedure for improving the collapse of the data corresponding to di erent system sizes, which will be used many times throughout this paper, renders what we will call the best values" of the free parameters. Errorbars represent the estimated range of values for which the collapses are satisfactory. We would like to note that the obtained value of $_{\rm c}$ (for the three choices of the variable u) is slightly higher than the value $_{\rm c}=2:16$ 0:03 proposed in Ref. 13.

It is interesting to note that the scaling functions N_1 and N_2 can be very well approximated with Gaussian functions. The ts, shown in Figs. 8 (b) and 9 (b), have three free parameters: the amplitude a, the peak position x and the width w. The best numerical estimations are: $a_1=0.946$ 0.004, $x_1=2.691$ 0.008, $w_1=1.293$ 0.008, $a_2=0.497$ 0.002, $a_2=2.227$ 0.007 and $a_2=1.086$ 0.007.

From the fact that the scaling functions in Figs. 8 (b) and 9 (b) are bounded and go exponentially to zero for $u_2L^{-1}=!$ 1 (as can also be checked from a log-linear plot) one can deduce that, in the therm odynam ic lim it, 1d-spanning avalanches and 2d-spanning avalanches only exist at = $_{\rm C}$. Their numbers increase as $L^{0:10}$ with amplitudes N $_1$ (0) = 0:12 0:01 and N $_2$ (0) = 0:07 0:01. Moreover, the peaks of the scaling functions N $_1$ and N $_2$ which are displaced from $u_2=0$, account for the fact that for a nite system the maximum number of 1d and 2d spanning avalanches occurs for a certain $_{\rm C}$ (L) which shifts towards $_{\rm C}$ from above.

As regards the 3d spanning avalanches, according to the previous discussions one m ust consider the contributions from N $_{\rm 3c}$ and N $_{\rm 3}$. From the scaling assumptions (18) and (20) and the last closure relation in Table II one can write:

This equation indicates that N_3 (;L) cannot be collapsed in a straightforward way. We propose here a method to separate the two contributions in equation (23). This method, which we will call double nite-size scaling (DFSS), will be used several times throughout the paper for the analysis of similar equations. By choosing

two systems with sizes L_1 and L_2 and amounts of disorders $_1$ and $_2$ so that $u(_1)L_1^{1=}=u(_2)L_2^{1=}$, one can write:

Thus, we can check for the collapse of data corresponding

to di erent pairs of $(L_1;L_2)$. From the num erical point of view, the DFSS m ethod works quite well. An analysis of error propagation reveals that the scaling function corresponding to the contribution with a smaller exponent will display more statistical errors.

Fig. 10 shows the results of the DFSS analysis of N $_3$ according to equation (23). The di erent symbols, in this case, indicate the values of $\rm L_1$ and $\rm L_2$ used for each set of data. Fig. 10 (a) corresponds to N $_3$ (u $_2\rm L^{1=}$) and Fig. 10 (b) corresponds to N $_{\rm 3c}$ (u $_2\rm L^{1=}$). It should be emphasised that such collapses are obtained without any free parameter. The values of , c, and A are taken from the previous collapses of N $_1$ and N $_2$.




FIG. 10: (a) Numerical estimation of N $_3$ ($u_2L^{1=}$) and (b) of N $_{3c}$ ($u_2L^{1=}$). Data have been obtained according to equations 24 and 25. Symbols, according to the legend, indicate the values of L_1 and L_2 used for obtaining each data set. The continuous line in (b) is a tofaGaussian function.

Again, from the shape of the scaling functions we can deduce the behaviour in the thermodynamic limit: from the crossing points of the scaling functions with the $u_2 = 0$ axis, we not that N_{3c} ($_c$;L) = $(0.16 \quad 0.02)L^{0.10}$ and N_3 ($_c$;L) = $0.79 \quad 0.02$. As occurred previously

with the number of 2d and 1d spanning avalanches, N_{3c} can also be very wellapproxim ated with a G aussian function with amplitude $a_{3c}=0.706-0.005$, peak position $x_{3c}=1.244-0.007$ and width $w_{3c}=0.802-0.009$. The fact that N_{3c} ($u_2L^{1=}$) vanishes exponentially for $u_2L^{1=}$! 1 con ms that, in the thermodynamic limit, such avalanches only exist at the critical point. Furthermore, from the fact that N_3 tends to 1 and to 0 exponentially fast when $u_2L^{1=}$! 1 we deduce that one subcritical 3d-spanning avalanche will exist for < c and there will be none above this value.

To end with the analysis of the number of avalanches, we will separate the two contributions to N $_{\rm ns}$:

In this case the DFSS method cannot be applied since $N_{\rm nsc}$ and $N_{\rm ns0}$ depend on dierent variables. A sixtheak of the validity of this hypothesis has already been presented in section III. The tof equation (26) to the data corresponding to = _c (u = 0) , shown in the inset of Fig. 6, gives estimations of _nsc ' 2.02 , $N_{\rm ns0}$ (_c) = 0.028, and $N_{\rm nsc}$ (0) = 0.085. Furthermore, we can also check that the derivative with respect to behaves as:

Fig. 11(a) demonstrates that the data (estimated using a two-point derivative formula) is compatible with this behaviour. The line shows the best t (with two free param eters: N $_{\text{nsc}}^{0}$ (0) and N $_{\text{nso}}^{0}$ ($_{\text{c}})) of the func-$ 3 = 0:15. One obtains tion (27) with $_{nsc} + 1 =$ $N_{\rm nsc}^{0}$ (0) = 0.136 0.011 and $N_{\rm ns0}^{0}$ (c) = 0.102 0.003. The good agreem ent is a test of the dependence with the variables uL¹⁼ and of the functions N_{nsc} and N_{ns0} respectively. To go further into the analysis of N ns, one must provide som e extra hypothesis on the shape of the scaling functions. G iven the fact that we have found alm ost a perfect Gaussian dependence of the scaling functions N_1 , N_2 and N_{3c} one can guess that N_{nsc} will also have a Gaussian dependence. By forcing the Gaussian function to satisfy $N_{nsc}(0) = 0.085$ and the fact that that $\tilde{N}_{nsc}^{0}(0) =$ 0:136 (from previous estimations) we end up with a trial function with a single free parameter that should be enough to satisfactorily scale the data from Fig. 6.




FIG. 11: (a) A nalysis of the consistency of Eq. (27). The points correspond to num erical data and the line is the best t (with two free param eters) by xing the value of $_{\rm nsc}+$ 1= to the previous estimations. (b) Scaling plot revealing the behaviour of N $_{\rm ns0}$ (). The continuous line shows the behaviour of the approximate lower bound $_{\rm err}$ (6=) estimated from the spins that ip independently of their neighbours. The inset shows the Gaussian function N $_{\rm nsc}$ (u $_{\rm L}$ L $^{\rm 1}$) used for the separation of the two contributions to N $_{\rm ns}$.

The best collapse is shown in Fig. 11 (b) which corresponds to N $_{\rm n\,s0}$ (). The function N $_{\rm n\,sc}$ used for the collapse is shown in the inset and corresponds to a G aussian function with am plitude $a_{\rm n\,sc}=0.985$, peak position $x_{\rm n\,sc}=0.6$ and width $w_{\rm n\,sc}=1.485$. It is interesting to note that the peak position of this scaling function occurs at a value $u_2 L^{1=}=x_{\rm n\,sc}<0$ as opposed to the case of the previous scaling functions N $_1$, N $_2$ and N $_{\rm 3c}$ for which the peak position was at $u_2 L^{1=}>0$. This indicates that

the properties of the 1d, 2d and 3c critical avalanches have opposite shifts with nite size L compared to the nsc critical avalanches.

To end with the analysis of the number of non-spanning avalanches it is interesting to compare the function $N_{\rm ns0}$ () with the approximate lower bound ($_{\rm err}$ (6=)) discussed in section III, which is represented by a continuous line in Fig. 11(b). The di erence between the two curves, which becomes bigger when increases, is due to the existence of clusters of several spins (not considered in the extremely facile analysis presented here) that ip independently of their neighbours contributing to the number of non-critical non-spanning avalanches.

VI. SCALING OF THE DISTRIBUTIONS OF SIZES D (s; ;L)

C lose to the critical point there are dierent ways to express the invariance of the size distributions corresponding to dierent choices of a pair of invariants among the three exponents proposed in equations (12), (13) and (14). For any generic distribution D (s;;L) one can write the following nine generic expressions:

A lthough we have used the generic index , it is evident that such assumptions can only be proposed for the distributions of avalanches of a single kind, i.e. D $_{\rm 1}$, D $_{\rm 2}$, D $_{\rm 3c}$, D $_{\rm 3}$ and D $_{\rm nsc}$. For the composite distributions D $_{\rm 3}$, D $_{\rm s}$, D $_{\rm ns}$ and D , one expects m ixed behaviour, and concerning D $_{\rm ns0}$ we cannot expect a dependence on uL $^{\rm 1}$. The exponents could also be dierent for the dierent kinds of avalanches, but as will be discussed in the following paragraphs, in all cases = 1 except for $_{\rm nsc}$, which will take a larger value.

As argued before, when scaling the numbers of avalanches, the last three expressions (34), (35) and (36) are not very useful for the numerical collapses because they introduce large statistical errors. Moreover, when trying to check the collapses expressed by equations (29) and (32), the two independent variables of the scaling function converge to zero when the critical point is approached. Thus, such a collapse cannot be checked for u = 0. Therefore, the interesting scaling equations are (28), (30), (31) and (33).

The behaviour of the scaling functions is, in some cases, restricted by the normalization conditions. If scaling holds for the whole range of s=1; from equation (28), one can write:

For those distributions for which the integral converges, it is necessary that $=1.\,W$ expect that this condition can be applied to the cases of D $_1$, D $_2$, D $_{3c}$ and D $_3$. In these four cases, as can be seen in F ig. 2 (c), the distributions show a marked decay in the two limits of s! 0 and s! L 3 . (N ote that the plots have logarithm ic scales and that D $_{3c}$ and D $_3$ correspond to the left-hand and right-hand peaks in D $_3$ respectively). For the distribution D $_{nsc}$ the exponent $_{nsc}$ can be larger than 1 since this distribution m ay extend into the smalls region and convergence of the integral in (38) cannot be ensured.




FIG. 12: Collapses corresponding to D´1 sL d_f ; $u_2L^{1=}$. The three cuts of the scaling surface are taken at $u_2L^{1=}=121$, $u_2L^{1=}=0$ and $u_2L^{1=}=0:56$. Note that on each cut we have plotted 5 lines (with dierent shades of grey) corresponding to L = 8;10;12;16 and 24. Symbols on the horizontal plane show the behaviour of the rst moment of the distribution according to the legend in gure 4. The line is a guide to the eye.

Fig. 12 shows a 3d view of the collapses corresponding to D $_1$ sL $^{\rm d\,_f}$; $u_2 L^{1=}$. The lines show three cuts of the scaling surface corresponding to $u_2 L^{1=}=121$, $u_2 L^{1=}=0$ and $u_2 L^{1=}=0$. The collapses of the curves corresponding to the di erent sizes are satisfactory within statistical error. The only free parameter in this case is df. The best estimation renders a fractal dimension df = 2:78 0:05 for such 1d-spanning avalanches. Similar behaviour is obtained for D $_2$ sL $^{\rm d\,_f}$; $u_2 L^{1=}$. A lthough, in principle, we have considered df as a free parameter, the best collapses are obtained with the same value df = 2:78 as that obtained for the 1d-spanning avalanches.

The analysis of D $_{3c}$ and D $_{3}$ is more dicult. According to the corresponding distribution relation (see Table II), and assuming the scaling hypothesis (18), (20) and (28), one can write:

where we have taken into account the fact that for the subcritical 3d-spanning avalanches $_{\rm 3d}=1$ and they have a fractal dimension $d_{\rm 3}$. Although it is possible to conceive a DFSS treatment to separate the two contributions in (39), the hard numericale ort needed as well as the associated statistical uncertainties make it very dicult. In the next section we will show that it is enough to analyze the behaviour of the k-m oments of the distributions to obtain the critical exponents.

VII. SCALING OF THE k-M OM ENTS OF THE DISTRIBUTIONS

Besides the scaling of the entire distributions D (s; ;L) that exhibit large statistical errors, it is also useful to analyze the behaviour of their k-m om ents. For those distributions for which the integral in Eq.(38) converges (and, therefore, = 1), we can check the corresponding scaling functions. By using a similar argument

as that used for deriving equation (38), we get:

As an example of such collapses, we have indicated the behaviour of the scaled rst m oment of the distribution D $_1$ (s; ;L) on the horizontal plane of Fig. 12. In this case the collapses are obtained without any free parameter.

As will be seen later, it is more convenient to analyze the scaling behaviour of the products N hs^k i . By using equations (15) and (40), one gets:




FIG. 13: Collapses corresponding to N $_1$ (;L)hs k i $_1$ (;L) (a) and N $_2$ (;L)hs k i $_2$ (;L) (b). Symbols indicate the system sizes according to the legend.

Fig.13 shows the collapses corresponding to the $\,$ rst m oment (average size) of D $_1$ and D $_2$. No free parameters are used in this case. Similar scaling plots can be obtained from the analysis of the second moments with the same set of scaling exponents.

As regards the scaling of N $_3$ hsi $_3$, multiplying expression (39) by s, sum m ing over the whole s-range, and




FIG. 14: Collapses corresponding to N $_3$ (uL $^{1=}$) $_3^1$ (u2L $^{1=}$) (a) and N $_3$ c (u2L $^{1=}$) $_3^1$ cu2L $^{1=}$) (b). Symbols indicate the values of L $_1$ and L $_2$ used for the DFSS analysis according to the legend in Fig.10. The inset in (a) reveals the power-law behaviour N $_3$ $_3^1$ (ju2 J $^{1=}$) 3 with $_3$ = 0.024.

This equation can be separated by a DFSS analysis. Figs. 14 (a) and 14 (b) show the collapses corresponding to N_{3c} $\frac{1}{3c}$ and N_{3} $\frac{1}{3}$ respectively. The only free parameter in this scaling plot is the fractal dimension of the subcritical 3d-spanning avalanches. The best value is $d_3=2.98$ 0.02. Note that the shape of the scaling function in Fig. 14 (b) indicates that, in the them odynam ic limit, the critical 3d-spanning avalanches only contribute to the rst-moment for =

On the other hand, the shape of the scaling function in Fig.14(a) indicates that, in the them odynam ic lim it, the subcritical3d-spanning avalanchesm ay contribute to the rst moment in the whole $u_2 < 0$ range. Note that,

as revealed by the inset in Fig. 14(a), the behaviour in the region of negative values of $u_2L^{1=}$ is N $_3$ $_3^1$ (j u_2 j $_2^{1=}$) $_3$ with $_3$ = 0.024 0.012. This numerical value is compatible with the equation:

This hyperscaling relation, when introduced into equation (42), results in a second term that grows with ${\rm L}^3$. As will be analyzed in the next section, such a term will be responsible for the order parameter behaviour in the therm odynam ic \lim it.

The analysis of the moments of the non-spanning avalanches presents extra di culties, as occurred in the




FIG .15: (a) Behaviour of N $_{\text{NS}}$ ($_{\text{c}}$;L) hs k i_{nS} ($_{\text{c}}$;L) as a function of L for k=1 and k=2 in log-log scale. (b) Behaviour of the derivative with respect to of the same two magnitudes. In both cases, the lines show the best ts of Eq.44 and its derivative at = $_{\text{c}}$.

As explained previously, the DFSS cannot be applied, given the dierent dependence on uL 1= and of the two term s in (44). The possibility of using a trial function is, now, more di cult since we cannot make a straighforward hypothesis on the shape of $\frac{k}{n \, \text{sc}}$. In order to the value of $_{n\,sc}$ and $d_{n\,sc}$ we can analyze the dependence of the k-m om ent (for k = 2 and k = 3) and its derivatives with respect to at = $_{c}$ (u = 0). Data is shown in Fig. 15(a) and Fig. 15(b) with log-log scales. The alm ost perfect power-law behaviour for di erent values of k and for the derivatives, indicates that the second term in (44) plays no role in c. This is because the exponent of the rst term is much larger than 3. Indeed, the best ts are obtained with $d_{nsc} = d_f = 2.78$ 0:02 which render large values of the and $_{nsc} = 1:65$

exponent of the rst term (> 5.8). Sim ilar ts can be obtained from higher moments with the same values of the exponents d_{nsc} and d_{nsc} .

VIII. MAGNETIZATION DISCONTINUITY

In this section we discuss the behaviour of the discontinuity m in the magnetization of the hysteresis loop. We would like it to behave as an order parameter. For large systems, it is clear that only spanning avalanches may produce a discontinuity in the magnetization. We can evaluate the total average magnetization jump m s due to the contribution of all the spanning avalanches (1d, 2d, 3c and 3).

Fig. 16(a) shows the behaviour of m $_{\rm S}$ versus for different system sizes. A coording to the scaling analysis in the previous section, m $_{\rm S}$ will behave as:

This equation tells us that m $_{\rm S}$ will display a m ixed scaling behaviour. The rst term in (46) accounts for the contributions of the 1d-spanning, 2d-spanning and critical 3d-spanning avalanches. We can de ne an exponent $_{\rm C}$ so that:

This relation is the same relation that other authors have called \violation of hyperscaling" [11, 13, 22]. From our best estimations of , and df, we obtain $_{\rm c}=0.15$ 0.08.

At this point, it is interesting to compare equations (43) and (47.) We would like to note that we could also have introduced an exponent 0 that would transform Eq. (43) into an equation similar to (47). Nevertheless, the quality of the scalings of the numbers of 3d-spanning avalanches in Fig. 10 shows that such an exponent 0 is either zero or very small. Moreover, an analysis of the behaviour of N_{3} for uL 1 ! 1 reveals an exponential drift versus N_{3} = 1 which reinforces the idea that there is no need for an hyperscaling exponent 0 . Note that a value 0 > 0 implies that the number of subcritical 3d-spanning avalanches (3) will be in nite, in the therm odynam ic limit. On the other hand, our assum p-

tion that $^0=0$ indicates that N $_3$ behaves as a step function in the therm odynam ic lim it.

By inserting equations (43) and (47) into (46) one can easily read the m ixed scaling behaviour of m $_{\rm S}$:

where, $_{\rm c}$ = 0:12 and $_{\rm 3}$ = = 0:02. is a scaling function with a peaked shape (it corresponds to the sum of the scaling functions in Figs. 13 (a), 13 (b) and 14 (b)) and $^{\rm 0}$ is twice the scaling function in Fig. 14 (b). Consequently, in the therm odynamic limit, only the second term associated to the subcritical 3d-spanning avalanches will contribute to the magnetization jump (order parameter). For nite systems, the rst term may a ect the scaling of the data close to $_{\rm c}$ given the peaked shape of

This behaviour can be observed in Figs. 16(b) and 16(c), where the two possible scalings show the breakdown of the collapse for $u_2L^{1=} < 0$ when using the exponent $_c=$ and the breakdown of the collapse for $u_2L^{1=}$ '0 when using the exponent $_3=$. The larger the system, the better will be the data collapse in Fig. 16(c) and the worse will be the collapse in Fig. 16(b).

IX . D ISC U SSIO N

Table III shows a sum mary of the exponents that characterize the avalanche num bers and distributions obtained from our num erical simulations. We would like to point out that such exponents are independent of and L in a very large region around the critical point both for $\,>\,\,_{\rm C}$ and $\,<\,\,_{\rm C}$ simultaneously. Such an achievement has not been possible in previous analyses, even with larger system sizes. The reason is that some of the contributions we have identified (namely 3 and ns0), which reduce nite size elects, were previously neglected.

In Table III we also indicate previous estimations of the exponents found in the literature [13]. The comparison is quite satisfactory. Let us analyze the eight exponents:

Although the value of does not fall within the error bars in Ref. 13, we have already argued that the exact de nition of the scaling variable u used

for the collapses m ay introduce some deviations in this value. By using u_1 we obtain = 1:14 and using u_3 we obtain = 1:4.

As regards our value is in agreement with the value previously reported [13] (We would like to note that in Ref. 13, the authors also report a value of 0.015 0.015 probably due to a misprint). The fact that this exponent is non-zero in plies that there are in nite spanning avalanches at the critical point in the therm odynam ic lim it.

As $regards_{nsc}$, to our know ledge there are no previous nite-size scaling analyses of the number of non-spanning avalanches.

Concerning ${\bf q}$ and d_3 , the numerical values are consistent with the value $d_f=2.98$ 0.43 estimated previously [10]. We shall note that this previous estimation was obtained from the analysis of the distributions of non-spanning avalanches. It should therefore correspond to our d_f and not to our d_3 (which corresponds to the subcritical 3d-spanning avalanches). Note also that the dierence between d_f and d_3 suggests that there might be real physical dierences between such two kinds of avalanches. The possibility of distinguishing them in the numerical simulation will be studied in a future work.

The exponent $_{\rm nsc}$, according to our de nitions, describes the scaling behaviour of the distribution of critical non-spanning avalanches. Previous measurements of a similar exponent, have analyzed N $_{\rm ns}$ without distinguishing between critical (nsc) and non-critical (ns0) non-spanning avalanches and have not considered the fact that the system is nite. We can estimate what the value of an excive exponent $_{\rm eff}$ will be for the distribution of non-spanning avalanches for very large systems. From equation (44), taking k > 1, and large values of L,

only the rst term in the sum survives, so that:

Combining the last two equations, we get an estimation for the pseudo-scaling behaviour of the k-m om ent of the non-spanning avalanches:

If one approxim ates N_{ns0} () by N_{ns0} ($_c$) and in poss hs i_{ns} L $^{(eff k 1)d}$ f S k (uL 1e) it is possible to deduce that the electric exponent is $_{eff}$ = $_{nsc}$ + (3 $_{nsc}$) = df. From our numerical estimations of the different exponents in Table III, one obtains $_{eff}$ = 2.00 0.06. This value is in very good agreement with the value $_{eff}$ = 2.03 0.03 found previously [13]. Nevertheless, we would like to point out that according to our analysis, such an exponent is not a real critical exponent and, therefore, will depend on for nite systems as has been found previously [16].

As regards the values of $_{\rm C}$ and $_{\rm 3}$ we would like to note that previous analyses have not identied the two contributions to m $_{\rm S}$. It is therefore not strange that di erent values have been obtained previously: 0:17 0:07 [8], 0:0 0:43 [11], 0:035 0:028 [13]. The larger the system , the closer the elective exponent become sto $_{\rm 3}$.

Finally, it is interesting to compare the behaviour of spanning avalanches, with the problem of percolation [23]. In percolation, the number of percolating clusters behaves as a step function, in the therm odynam ic lim it for d < 6, exactly as N $_3$. The order parameter is, in this case, the probability for a site to belong to the percolating cluster. However, this is precisely what we are evaluating by the function N_3 hsi₃ = L^3 which is the second term in (46) and is the only relevant term in the therm odynam ic lim it. As occurs in percolation, the hyperscaling relation (43) between $_3$, and d_3 is fullled since only one in nite avalanche contributes to the order param eter for ! c from below. M oreover, in the percolation problem for d > 6 [24], the number of percolating clusters exhibits, besides the step function, an extra function singularity at the percolation threshold. In our case (3d-GRFIM) we also have such a contribution at

= $_{\rm c}$, which we have identied as 1d, 2d and critical 3d-spanning avalanches [the rst term in (46)]. The existence of such an in nite number of avalanches exactly at $_{\rm c}$ (the number of which grows as L) in plies the breakdown of the hyperscaling relation $_{\rm c}$ = [3 (+ d_f)].

X. SUMMARY AND CONCLUSIONS

In this paper we have presented nite-size scaling analysis of the avalanche numbers and avalanche distributions in the 3d-GRFIM with metastable dynamics. A fter proposing a number of plausible scaling hypotheses, we have con med them by obtaining very good collapses of the numerical data corresponding to systems with sizes up to L=48.

The rst result is that, in order to obtain a good description of the num erical data, one needs to distinguish between di erent kinds of avalanches which behave differently when the system size is increased. A valanches are classied as being: non-spanning, 1d-spanning, 2dspanning or 3d-spanning. Furtherm ore, we have shown that the 3d-spanning avalanches must be separated into two classes: subcritical 3d-spanning avalanches with fractal dim ension $d_3 = 2.98$ and critical 3d-spanning avalanches with fractal dimension $d_f = 2.78$, as the 1d and 2d spanning avalanches. Non-spanning avalanches occur for the whole range of . W e have also proposed a separation between critical non-spanning avalanches and non-critical non-spanning avalanches in order to obtain good nite-size scaling collapses. The non-critical nonspanning avalanches are those whose size is independent of the system size and whose number scales as L³. The critical non-spanning avalanches also have a fractal dim ension $d_f = 2:78$.

The second in portant result, is the scenario for the behaviour in the therm odynam ic limit: below the critical point, there is only one subcritical 3d-spanning avalanche, which is responsible for the discontinuity of the hysteresis loop. Furtherm ore, at the critical point there are an in nite number of 1d-, 2d-, and 3d-critical spanning avalanches.

For nite systems, the six dierent kinds of avalanches can exist above, exactly at and below $_{\rm C}$. The nite-size scaling analysis we have performed has also enabled us to compare dierent scaling variables u, which measure the distance between the amount of disorder in the system and the critical amount of disorder $_{\rm C}$. The best collapses are obtained using the variable $u_2=(_{\rm C})^2=_{\rm C}+A$ $[(_{\rm C})^2=_{\rm C}]^2$ with A=0.2.

So far the analysis presented in this paper, is restricted to the analysis of the numbers and distributions of avalanches integrated along half a hysteresis loop. Our analysis of the average magnetization discontinuity m starts from the hypothesis that only spanning avalanches may contribute to such a discontinuity. However, as a future study, we suggest that the measurement of correlations in the sequence of avalanches and the analysis

of non-integrated distributions, m ay reveal details of the singular behaviour at the critical eld H $_{\rm c}$. For instance, non-spanning avalanches could show a tendency to accumulate in H $_{\rm c}$, in the thermodynam ic limit. This could change some of the conclusions reached in this work.

As a nal general conclusion we have shown that it is not necessary to simulate very large system sizes to estimate the critical exponents for this model. In order to identify the dierent kinds of avalanches it may even be better to analyze small systems with larger statistics.




FIG. 16: (a) Behaviour of the total contribution of the spanning avalanches to the magnetization jump as a function of . The inset reveals the crossing behaviour at < $_{\rm c}$. (b) Scaling of m $_{\rm S}$ by considering the 1d, 2d, and the critical 3d-spanning avalanches. Note the lack of collapse for the region $u_2L^{1=}$. 0. (c) Scaling of m $_{\rm S}$ by considering the subcritical 3d-spanning avalanches. Note the lack of collapse for the region $u_2L^{1=}$ 0. Symbols indicate the system sizes according to the legend.
