Therm odynam ic properties of the SO (5) m odel of high- T_c superconductivity

Abstract

In this paper we present calculations of therm odynam ic functions within Zhang's SO (5) quantum rotor theory of high- T_c superconductivity. U sing the spherical approach for the three-dimensional quantum rotors we derieved explicit analytical form what for entropy and special heat related to the lattice version of the SO (5) nonlinear quantum -sigm a model. We present the temperature dependence of these quantities for various settings of relevant control parameters (quantum uctuations, them ical potential). We not our results in overal qualitative agreement with basic therm odynamics of high- T_c cuprates.

I. INTRODUCTION

The theory unifying antiferrom agnetism (AF) and superconductivity (SC) to describe global phase diagram of high-T_c superconductors was recently proposed by Zhang. In this approach, based on symmetry principles, a three-dimensional order parameter (the staqgered m agnetization) describing the AF phase and a complex order parameter (with two real components), describing a spin singlet d-wave SC phase are grouped in ve-component vector called a \superspin". The SO (3) sym m etry of spin rotations (which is spontaneously broken in the AF phase) and the electro-magnetic SO (2) invariance (whose breaking de nes SC phase) along with well-de ned AF to SC and vice versa rotation operators form SO (5) symmetry. In the Zhang's theory both ordered phase arise once SO (5) is spontaneously broken and the competition between antiferrom agnetism and superconductivity is related to direction of the \superspin"in the ve-dimensional space. The low energy dynamics of the system is determined in terms of the Goldstone bosons and their interactions specied by the SO (5) symmetry. The kinetic energy of the system is that of a SO (5) rigid rotor and the system is described by a SO (5) non-linear quantum model (NLQ M). The SO (5) quantum rotor model o ers a Landau-Ginzburg-like (LG) approach for the high-Tc problem . However, it goes much beyond the traditional LG theory, since it captures dynamics. While the SO (5) symmetry was originally proposed in the context of an elective eld-theory description of the high-T_c superconductors, its prediction can also be tested within microscopic models. 2,3,4,5,6,7 For example, numerical evidence for approximate SO (5) symmetry of the Hubbard model came out from exact diagonalization of small sized clusters.8 The global features of the phase diagram deduced from SO (5) theory based on a spherical quantum rotors9 agree qualitatively with the general topology of the observed phase diagram of high-T_c superconductors. The quantitative investigation of the quantum critical point scenario within the concept of the SO (5) group, e.g. the scaling of the contribution to the electrical resistivity due spin uctuations showed linear resistivity dependence on temperature for increasing quantum uctuation { being a hallm ark example of anomalous properties in cuprate m aterials. The system atic studies of magnetic properties of the SO (5) theory showed that the theory yields a qualitative scenario for the evolution of magnetic behavior, which is consistent with experiments. 11 It qualitatively explains the results of experimentalm easurem ents (notably the NMR relaxation rates) with correct predictions of behavior of uniform spin susceptibility in high temperatures. Also the energy dependence of the momentum—integrated dynamic spin susceptibility show features, which are in qualitative agreement with experimental ndings.

Them all uctuations are pronounced in the high- T_c superconductors due to number of reasons. The carrier density is rather small, the anisotropy is large and the critical temperature is high. It turns out that deviations from the mean-eld behavior are present in the special cheat C at the superconducting transition temperature T_c . In the mean-eld BCS theory, a second order transition with a jump in a special cheat at T_c takes place. In contrary, in most high- T_c superconductors thermal uctuations seem to restore common behavior.

The aim of the present paper is to study quantitatively basic thermodynamic functions resulting from the SO (5) theory, thereby substantiating this theoretical framework. Our study may also provide a useful diagnostic tool for testing the basic principles of SO (5) theory by comparing the quantitative predictions (e.g., special heat) with the outcome of the relevant experiments.

The outline of the rem inder of the paper is as follows. In Section II we begin by setting up the quantum SO (5) Ham iltonian and the corresponding Lagrangian. In Section III we not closed forms of various thermodynamic functions. We calculate free energy, entropy and specic heat. Finally, in Section IV we summarize the conclusions to be drawn from outwork.

II. HAM ILTONIAN AND THE EFFECTIVE LAGRANGIAN

We consider the low-energy Ham iltonian of superspins placed in the nodes of a discrete three dimensional simple cubic (3D SC) lattice,

Indices i and j num ber lattice sites running from 1 to N - the total num ber of sites, while , = 1; :::;5 denote superspin $n_i = (n_1; n_2; n_3; n_4; n_5)_i$ components $(n_{AF;i} = (n_2; n_3; n_4)_i$ refers to antiferrom agnetic and $n_{SC;i} = (n_1; n_5)_i$ superconducting order, respectively). The superspin components are mutually commuting (according to Zhang's form ulation) and their values are restricted by the rigidity constraint $n_i^2 = 1$.

The rst part of the equation (1) is the kinetic energy of the system (being simply that of a SO (5) rigid rotor), where

are generators of Lie SO (5) algebra (expressed by total charge L_i^{15} , spin and so-called \ "operators), p_i are m om enta conjugated to respective superspin components:

and param eter u m easures the kinetic energy of the rotors (an analog of m om ent of inertia).

The second part of the Ham iltonian is the inter-superspin interaction energy with J being the sti ness in the charge and spin channel. In the 3D SC lattice, J is nonvanishing for the nearest neighbors and its Fourier transform

For convenience, we will further introduce the density of states

where K (x) is the elliptic integral of the rst kind and (x) is the step function 13 .

The last two parts of the equation (1) provide symmetry SO (5) breaking terms. In the result of their interplay, the system favours either the \easy plane" in the superconducting (SC) space $(n_1; n_5)$, or an \easy sphere" in the antiferrorm agnetic (AF) space $(n_2; n_3; n_4)$. The rst of two terms is defined as:

with the anisotropy constant w, w hich positive value favours AF state. The second term contains a charge operator L_i^{15} , w hose expectation value yields the doping concentration and the chem ical potential (measured from the half-lling), w hose positive values favour SC state.

The partition function $Z = T re^{H = k_B T}$ is expressed using the functional integral in the M atsubara \im aginary time" formulation (0 1=kT , with T being the temperature). We obtain:

The problem can be solved exactly in terms of the spherical model¹⁴. To accommodate this we notice that the superspin rigidity constraint ($n_i^2 = 1$) implies that a weaker condition also holds, namely:

Therefore, the superspin components n_i () must be treated as c-number elds, which satisfy the quantum periodic boundary condition n_i () = n_i (0) and are taken as continuous variables, i.e., $1 < n_i$ () < 1, but constrained (on average, due to Eq. (11)) to have unit length.

This introduces the Lagrange multiplier () adding an additional quadratic term (in n_i elds) to the Lagrangian (10). Fourier transform n (k;! \cdot) of the superspin components

The exact value of the partition function can be found in the therm odynam ic lim it (N ! 1), when the method of steepest descents is exact and the saddle point () = $_0$ satisfies the condition:

At criticality, corresponding order parameters susceptibilities becomes in nite and corresponding Lagrange multipliers are:

for AF and SC critical lines, respectively. Furtherm ore, using the spherical condition (11) and the values (16), we nally arrive at the expression for the critical lines separating AF, SC and QD (quantum disordered) states (for more special description these calculations see, Ref. 9,11).

III. THERMODYNAM IC FUNCTIONS

A. Free energy

The free energy is de ned as $f = (N)^1 \ln Z = ()^1 (0)$. Using the formula (14), we obtain:

A fter perform ing the sum m ation over M atsubara's frequencies, we obtain the free energy:

B. Entropy

The entropy is de ned as $S = k_B^{2} \frac{\text{ef}}{\text{e}}$. Using the formula (18) we obtain:




FIG. 1: Plot of the entropy S vs. chem ical potential = J and tem perature k_B T = J for xed uJ = 3 and w = J = 1. Solid lines indicate the projection of the T phase diagram.




FIG. 2: P lot of the entropy S vs. tem perature k_B T=J for w=J = 1, =J = 0.2 and di erent values of uJ, as indicated in the inset.

The dependence of the entropy on tem perature and chem ical-potential is shown on Fig. 1. Starting from T=0, the entropy increases in any ordered phase (AF or SC) until reaching T_c (or T_N). The further increase is slower, but saturation in higher temperatures is not observed. The absolute value of the entropy is lower for higher quantum—uctuation (see, Fig. 2). We not obtained results in qualitative agreement with experimentally measured properties of high- T_c superconductors (e.g. for Bi2212 compound, see Ref. 15).

C. Speci cheat

The specic heat at constant volume is de ned:




FIG. 3: Speci c heat vs. tem perature $k_B T = J$ for w = J = 1, uJ = 3 and various values of chem ical-potential, as indicated on the gure.

The tem perature dependence of the speci c is presented in Fig. 3. The low tem perature behavior of C (T) may be approximated by C (T) T^3 for =J=0 and C (T) $T^{2.5}$ for =J=0.44. For higher tem peratures (but still below transition temperature) the linear behavior of the speci c heat is observed. Reaching the critical temperature (T_c or T_N), the speci c heat experiences a nite jump (implying the value =0 for the critical exponent of the speci c heat). For higher temperatures, saturation is observed.

IV. SUMMARY AND FINAL REMARKS

In conclusion, we have calculated entropy and speci c heat dependence on temperature and various other param eters using the uni ed theory of antiferrom agnetism and superconductivity proposed for the high- T_c cuprates by Zhang and based on the SO (5) sym m etry between antiferrom agnetic and superconducting states. The theory of yields a qualitative scenario for the evolution of therm odynam ic functions behavior, which is consistent with experim ents. Most experim ental work on the specic heat in the high-Tc superconductors have concentrated on yttrium compound (Y-123). 16,17,18 Optimally doped Y-123 does not show a jump in the specic heat, but peak at Tc. However, the shape for overdoped Y-123 is intermediate between a BCS step and a -type transition. Furthermore, optimally doped Bi-2212 shows a symmetric anomaly (intermediate between -peak and nite jump). Experim entally, the speci c heat is not very sensitive to the critical exponent can ascertain that j j 1 for Y-123 com pounds. However, the result of the present work (= 0) agrees with the critical behavior of the 3D -XY model. Finally, checking the validity of basic principles of the SO (5) theory, by comparing parameters discussed here with relevant, obtained from calculations on microscopic models of high-Tc superconductors is still called for.
