## Fluctuation-D issipation relations in D riven G ranular G ases

W e study the dynam ics of a 2d driven inelastic gas, by m eans of D irect Sim ulation M onte C arlo (DSMC) techniques, i.e. under the assumption of Molecular Chaos. Under the e ect of a uniform stochastic driving in the form of a white noise plus a friction term, the gas is kept in a non-equilibrium Steady State characterized by fractal density correlations and non-G aussian distributions of velocities; the m ean squared velocity, that is the so-called granular tem perature, is lower than the bath tem perature. We observe that a modil ed form of the Kubo relation, which relates the autocorrelation and the linear response for the dynam ics of a system at equilibrium, still holds for the o -equilibrium, though stationary, dynam ics of the system s under investigation. Interestingly, the only needed modi cation to the equilibrium K ubo relation is the replacement of the equilibrium tem perature with an e ective tem perature, which results equal to the global granular tem perature. We present two independent num erical experim ent, i.e. two dierent observables are studied: (a) the staggered density current, whose response to an impulsive shear is proportional to its autocorrelation in the unperturbed system and (b) the response of a tracer to a sm all constant force, sw itched on at time  $t_{y}$ , which is proportional to the mean-square displacement in the unperturbed system. Both measures con m the validity of Kubo's formula, provided that the granular tem perature is used as the proportionality factor between response and autocorrelation, at least for not too large inelasticities.

### I. IN TRODUCTION

In the past few years granular materials [1] have become a fast growing eld of research. In this framework, a strong interest has arisen in the subject of the so-called granular gases, system s of grains at very low density so that the collisions can be considered always binary and instantaneous [2]. The collisions among the grains are dissipative, and the amount of energy lost in each collision is parametrized by the so-called restitution coe cient r (see below for a precise de nition). Since the energy of the system is therefore not conserved an external forcing is usually applied to obtain a dynamic stationary state. For this kind of system s, the analogy with perfect gases allows to introduce a granular temperature  $\beta$ ] de ned as the mean square uctuation of the velocity, that is  $T_G = hy hvijieven$  though the velocity distribution could not be G aussian.

In the case of zero external forcing [4] (i.e. the so-called free cooling), granular tem perature decreases in time and goes asymptotically to zero when all the particles nally stop. W hen an energy input feeds the system, instead, the granular tem perature m ay reach a stationary value and severalm odeling for the stochastic driving have been proposed employing a constant [5, 6, 7, 8, 9] or a random [10] restitution coe cient.

In num erical simulations or in experim ents,  $T_G$  is often measured taking the average < > on the whole system. However strong uctuations in the local granular temperature are usually observed [7]. Even considering only the global granular temperature, i.e. for sm all spatial inhom ogeneities, it is not clear to which extent  $T_G$  can be considered the \temperature" of the system.

There are of course several possible paths to face this problem . One interesting point of view is that of investigating the response properties of an external therm on eter coupled to a granular gas [11]. This corresponds to study the uctuation-dissipation properties of the system [12]. For a system slightly perturbed from its stationary equilibrium state linear response theory allows to relate the response to the correlation functions through the uctuation-dissipation relations [13].

In the simplest case, given a perturbing eld , a uctuation-dissipation relation relates the response of an observable B at the time t, after an impulsive perturbation at time 0, to the correlation of the observable B and the eld A, conjugated to , measured in the unperturbed system,

where T is the equilibrium temperature of the system .

Recently Green-Kubo expressions for a homogeneous cooling granular gas have been obtained [14, 15, 16] and num erical simulations have con rm ed their validity [17]: cooling granulars lack an equilibrium state, therefore the H on ogeneous C ooling State (which is characterized by scaling properties) is used as reference state to be perturbed, but in this case the G men-K ubo relations must be changed in order to keep into account new terms arising from the time dependence of the reference state and the non-conservative character of collisions (see [15]). However, in the case of steady state granular gases, a rigorous derivation of G men-K ubo relations has not yet been performed to our know ledge.

In this paper we perform numerical investigations in order to check the validity of standard K ubo form ulas [13, 18] to steady state inelastic gases. We perform in particular two dierent sets of numerical experiments on heated granular gases. We choose two dierent conjugated pairs of variables constituted by the autocorrelation of a given variable and the corresponding response to a perturbation applied to the gas. K ubo's form ula, i.e. the proportionality between response and the autocorrelation in the unperturbed system, is verified to hold using the granular temperature as the correct proportionality factor, at least for not too strong inelasticities (r > 0.5). For stronger inelasticities (sm aller values of r) K ubo's form ula can be verified with a different elective temperature. It should be noted how the adopted simulation scheme election for example in [7]) which assumes M olecular Chaos hypothesis and therefore neglects short range correlations. For this reason, for very strong inelasticities the B oltzm ann equation (and the D SM C scheme) cannot be considered realistic and one should use M olecular D ynam ics simulations.

These results di er from the analogous results obtained for dense granular assemblies, where \slow " degrees of freedom them alize at an e ective tem perature which is far higher than the external in posed tem perature [19, 20]. However the gas-like state of granular matter has nothing to do with these systems, as their stationary state is governed by a rapid decay of the uctuations and the granular tem perature turns out to be the right choice in the description of linear response to slight perturbations.

The outline of the paper is as follows. In section II we dene the model as well as its simulation scheme and give a brief review of known results about the peculiar features of its non-equilibrium stationary state. Section III reviews K ubo's formula and its extension to non-H am iltonian perturbations. In section IV we describe num erical experiments using a sinusoidal shear and measuring as response the density current. In section V we perform a di usion vs. mobility experiment upon a tracer (i.e. perturbing a single particle). Finally section V I is devoted to the conclusions.

# II. THE MODEL

We simulate a gas of N identical particles of unitary mass in a two-dimensional box of side  $L = \frac{p}{N}$  with periodic boundary conditions. The particle collisions are inelastic: the total momentum is conserved, while the component of the relative velocity parallel to the direction joining the center of the particles is reduced to a fraction r (with 0 r 1) of its initial value, low ering in this way the kinetic energy of the pair:

where  $v_1^0$  and  $v_2^0$  are the velocities of the colliding particles after the collision.

In the interval between two subsequent collisions, the motion of each particle i is governed by the following Langevin equation [7]:

where the function  $_{i}(t)$  is a stochastic process with average  $h_{i}(t)i = 0$  and correlations  $h_{i}(t)_{j}(t^{0})i = (t t^{0})_{ij}$ ( and being component indexes), i.e. a standard white noise. This means that each particle feels a hot uid with a tem perature  $T_{B}$  and a viscosity characterized by a time  $_{B}$ .

The question about the most proper way of modeling a stochastic driving is still open. Many authors for instance use Eq. (3) without viscosity [5]. This is equivalent to the lim it  $_{\rm B}$  ! 1 and  $T_{\rm B}$  ! 1 with keeping D =  $T_{\rm B} = _{\rm B}$  constant. In this lim it long and short-range correlations in the velocity and density elds have been observed [8]. We have measured correlations in the velocity eld in the model with viscosity, concluding that they are highly reduced by the viscous term that breaks G alilean invariance (the fram e v = 0 is preferred) [21]. Our choice of the stochastic

driving with viscosity has the following advantages: a) it guarantees that in the elastic limit (r = 1) the system, after a transient time of the order of  $_B$ , still reaches a stationary state, characterized by a uniform density and a G aussian distribution of velocities whith temperature  $T_B$ ; b) it is a heat bath with a well de ned nite temperature  $T_B$  that can be compared with the granular temperature  $T_G$  and the elastic temperature  $T_{eff}$  measured by means of F luctuation-D issipation relations (see ahead).




FIG.1: Rescaled (in order to have unitary variance) distribution of the horizontal component of the velocity of the gas P ( $v_x$ ) versus  $v_x$ , with N = 500, L<sup>2</sup> = N, heat bath with  $T_b = 1$ ,  $_b = 10$ ,  $_c = 1$ , and di erent restitution coe cients. The Gaussian is plot as a reference for the eye.

In spite of the drastic reduction of velocity correlations, this model exhibits several interesting features which are parametrized by the restitution coecient r and the ratio,  $_{C} = _{B}$ , between the mean free time (the average interval of time between two subsequent collisions of the same particle) and the viscosity time. When  $_{B} > _{C}$  and r < 1 the system is in a non-equilibrium stationary state with a granular temperature  $T_{G} < T_{B}$ . This state is characterized [7] by fractal density clustering and non-G aussian distributions of velocities (see g.(1)) with a dependence upon r and  $_{C} = _{B}$ . This situation persists when D irect Simulation M onte C arb (D SM C) [22] is used to perform more rapid and larger simulations of the system. The D SM C simulation scheme consists of a discrete time integration of the motion of the particles. At each time step of length t the follow ing operations are performed:

- 1. Free stream ing: Eq. (3) is integrated for a time step t disregarding possible interactions among the particles.
- 2. Collisions: every particle has a probability p = t = c of undergoing a collision. Its collision mate is chosen among the particles in a circle of xed radius  $r_B$  with a probability proportional to its relative velocity. The unitary vector n, which should be parallel to the line joining the centers of particles, is chosen random ly instead and the collision is perform ed using rule (2).

### III. SHORT REVIEW ABOUT KUBO'S FORMULA

In this section we review the Kubo's formula, which must hold in the case of equilibrium dynamics. First we show the case of an Ham iltonian dynamics, and then for non-Ham iltonian equilibrium dynamics of a system subjected to an (in pulsive) shear force. The rst case is presented just for completeness and to set the notations, the formulas presented in the second case will be num erically checked for an elastic system and extended to the inelastic case in the next sections.

A. Kubo's form ula for H am iltonian system s

For an H am iltonian system, the tem poral evolution of the phase space distribution f (p;q;t) is ruled by the Liouville equation:

where L and L<sub>ext</sub> are the Liouville operators relative to the unperturbed H am iltonian and to its perturbation respectively. They are de ned by m eans of classical Poisson bracket:

The perturbation is assumed to be given by coupling a force (t) with an observable of the system  $\hat{A}$ , i.e.:

The phase space distribution is assumed to be canonical (i.e. at equilibrium) in the in nite past:  $f(p;q; 1) = f_{eq}(p;q)$ . An approximate solution of (4) to the storder in the perturbation  $iL_{ext}$  is given by:

W ith this approximation, the deviation, due to the perturbation (6), of the expectation of a physical quantity  $\hat{B}$  can be written as the following convolution:

where h::: $i_t$  denotes averages taken over the ensemble given by f (p;q;t);  $B_A$  (t t<sup>0</sup>), called response function, represents the response  $\hat{B}$  (t) to the pulsed force (t) = (t), and reads:

where  $A = \hat{A}$  hA i (and identically for  $\hat{B}$ ), while  $(p_t;q_t)$  is the in age of the initial phase point (p;q) determ ined by the total H am iltonian (including the perturbation).

K ubo has shown that the response function can be written in a simpler form [13, 18]:

#### B. Fluctuation-D issipation for non-H am iltonian equilibrium systems (the case of shear force)

Let consider a gas of particles and de ne a non-conservative perturbation (force) acting on particle i placed at  $r_i$  (t) at time t as

where  $k = (k_x; 0)$  (having chosen  $k_x$  compatible with the periodic boundary conditions, i.e.  $k_x = 2n_k = L_x$  with  $n_k$  integer and  $L_x$  the linear horizontal dimension of the box where the particles move). Note that must have the dimensions of a momentum, i.e. of a velocity (taking unitary masses). With this choice, eqs. (12b) becomes:

This is a uctuation-dissipation relation which expresses the fact that the response of the k-component of the transverse current to the perturbing eld in eq. (19) is proportional to the auto-correlation of the same transverse current measured in the system without perturbation.

The real part of the response calculated at k (per unit of perturbing eld) is directly computable and reads:

The rst set of measures we have performed has been aimed to verify relation (22) for a system as described in the previous paragraph. In order to do this we have used the following recipe proposed in [23]:

- 1. Initialize system U with random positions  $fr_i^U$  (0)g and random velocities  $f_{r_i}^U$  (0)g.
- 2. Let it evolve with the unperturbed dynamics until time  $t_w$  which must be chosen larger than the largest characteristic time of the system (e.g. <sub>c</sub> or <sub>b</sub>). The unperturbed dynamics consists of the time-discretized (t) integration of the Langevin equation (3):

plus inelastic collisions with parameter r (restitution coe cient). The collisional step is separated from the Langevin step and is in plemented by means of a local M onte Carlo, i.e. random choice of pairs to collide inside a region of diameter  $r_B$ ; the collision probability is proportional to a xed collision frequency  $1 = _c$  and to the relative velocity of the particles;  $_c$  is chosen to be compatible with an hom ogeneous gas-like dynamics, i.e.  $_c r_B = \frac{hv^2 i_1}{hv^2 i_1}$ .

- 3. At time  $t_w$  a copy of system U is created (and named P) and the vectors  $fy_i(t_w)g$  and  $fx_i(t_w)g$  memorized in order to be used in the computation of the auto-correlation.
- 4. The system U is let evolve with the unperturbed dynamics. The system P is made evolve with the additional forcing described in eqs. (11) and (19) for only the time step  $[t_w; t_w + t]$ , i.e. the equation for the update of velocities in this particular step being:

with  $k_x = 2$   $n_k = L_x$ . Note again that the perturbation intensity has exactly the dimensions of a velocity.

5. The dynamics of system s U and P are thereafter followed in the unperturbed style, i.e. using eq. (23). The functions to be measured are:

where = t t<sub>w</sub>. It is expected that R (0) = 1=2 and C (0) =  $hv^2 i$ , while R (1) = C (1)! 0.

6. The above steps are repeated form any di erent realizations (or even in the same realization, provided its length is much longer than the typical correlation time) and the averages over those realizations of R (t  $t_w$ ) and C (t  $t_w$ ) are computed (see gure 2).

To the aim of checking the whole numerical machinery, we rst consider the r = 1 elastic case. In all the cases investigated we have checked the linearity of the response by changing the perturbation amplitude in the range 2 [0:005;0:05]. Within the speci c framework chosen for the observables, the K ubo formula to be veried is given

by:

W e have perform ed the following experiments:






FIG.2: Left: time dependent response to the impulsive shear perturbation dened in 11 and 19: R (t  $t_w$ ) vs. t  $t_w$  for three simulations with elastic systems, one without therm albath and two with therm albath, and with diment choices of the wave number  $n_k$  of the perturbation. Right: time correlation function C (t  $t_w$ ) vs. t  $t_w$  for the same systems. In the simulations r = 1, N = 500,  $_c = 1$ , and for the two cases with the heat bath  $T_b = 1$  and  $_b = 10$ . The applied force has = 0.01,  $_w = 100$ . The averages have been obtained over 10000 realizations.




FIG.3: Param etric plot of R (t  $t_w$ ) vs. C (t  $t_w$ ) for the num erical experiment of type I (in pulsive shear perturbation) with r = 1, with or without heating bath, and for di erent choices of the wave num ber  $n_k$  of the perturbation. The initial temperature for the case without heat bath is chosen to be 1 while  $T_b = 1$  ad  $_b = 10$  for the two cases with the heat bath. N = 500,  $_c = 1$ , = 0.01,  $n_k = 8$ , with average over 10000 realizations, using  $t_w = 100$ .

gas with elastic interactions and absence of therm albath (see gure 3).

gas with elastic interactions with the therm albath (see gure 3).

From gure 2 it can already be appreciated that response and autocorrelations in the elastic gas decay on a time of the order of  $_{\rm c}$  (how ever this decay is not exponential, as can be observed in the inset of the gure). The parametric plot of the two curves in gure 3 shows the perfect agreement with equation (26) using = 1=T<sub>b</sub>. In this case, of course, T<sub>b</sub> T<sub>G</sub>.

W e have repeated the sam e m easures on the gas with restitution  $\cos$  cient r < 1, i.e.

gas with inelastic interactions with the bath (in this case the bath is essential, to avoid cooling), see gure 4.

obtaining again a very good agreement with equation (26) using  $= 1=T_G$ . This is the main nding in this set of numerical experiments: even if the gas is out of equilibrium, being driven by a thermal bath at temperature  $T_b$ , its unperturbed autocorrelation is still proportional to the linear response, and its elective temperature measured by means of F luctuation-D issipation theory is exactly the granular temperature  $T_G$ . This is true for every inelasticity r 0.5.

At lower inelasticities we have still obtained an agreement with equation (26) but with a  $T_{eff} = 1 = 6 T_G$ : we do not think that these measures can be interesting, as the DSMC algorithm is not reliable at such values of r. A real

It also must be noted that relation (26) is veried for many values of the wave number  $n_k$ , i.e. the system does not show a scale dependent e ective temperature.




FIG.4: Param etric plot of R (t  $t_w$ ) vs. C (t  $t_w$ ) for the num erical experiment of type I (in pulsive shear perturbation) with r < 1, with heating bath, and for di erent choices of the wave num ber  $n_k$  of the perturbation.  $T_b = 1$  and  $_b = 10$ , N = 500,  $_c = 1$ , = 0.01,  $n_k = 8$ , with averages over 10000 realizations, using  $t_w = 100$ .

## V. FLUCTUATION -D ISSIPATION MEASURE II: DIFFUSION

A nother independent con m ation of the validity of the m odi ed Linear R esponse theory for granular gas com es from the study of the di usion properties, i.e. of the large time behavior of the m ean squared displacement B (t; t<sub>w</sub>) = hjr(t) r(t<sub>w</sub>) j i 2D (t t<sub>w</sub>). In this case the Einstein relation is expected to hold D = < jyj >  $_{corr}$ , where  $_{corr}$  = d hv(t<sub>w</sub> + )v(t<sub>w</sub>) i: this relation however, often addressed as a sort of FD relation, is always veri ed and just represents a check of the correctness of the simulation. Instead some surprise could arise from m obility m easurements: a small static drag force (switched on at time t<sub>w</sub>) of intensity (in the direction of the unitary vector x of the x axis) is applied to a given particle (tracer, e.g. particle with index 0 and position r<sub>0</sub>). The tracer reaches, as a result of the viscous force generated by the gas surrounding it, a limit constant velocity such that (t; t<sub>w</sub>) hj(r<sub>0</sub>(t) r<sub>0</sub>(t<sub>w</sub>)) xji t, where is the mobility which is expected to be related to the di usion coe cient through the E instein relation = D =hv  $_x^2$ i = 2D =T (if the force is applied on the direction x in the two-dimensional system).

In our experiments we have checked the linearity of the relation between  $h_{x_0}(t) = x_0(t_w)$  is  $h_{y_0}(t) = r_0(t_w)$  and  $h_{y_0}(t) = r(t_w)$  is (see g.5). In particular if K ubo's form ula was valid one should have:

with = 1=T if the system is in therm odynamic equilibrium at temperature T.

In all the simulations we have checked the linearity of the response by changing the perturbation amplitude in the range 2 [0:005;0:05].




FIG.5: Simulations of systems coupled to a therm albath with elastic or inelastic collisions. N = 500,  $_c = 1$ ,  $T_b = 0.1$  and  $_b = 10$ , = 0.01,  $_w = 100$ . The results are obtained by averaging over 10000 realizations. Left: mean squared displacement B (t;t\_w) vs.t t\_w.Right: Integrated response (t;t\_w) to a constant force applied to the particle numbered as 0 vs.t t\_w.

Figure 5 shows the mean squared displacement (in the unperturbed system) and the x displacement of the tracer (when it is accelerated) divided by the intensity of the perturbing force versus time: it can be appreciated how both these quantities grow linearly with time, de ning the di usion coe cient and the mobility.

Figures (6,7) report the parametric plots of the response to the force versus the mean squared displacement in the unperturbed system, showing how relation (27) is very well satis ed at dierent inelasticities. We hat can be observed in this kind of measures is a departure from the relation  $= 1=T_G$  already at inelasticity r = 0.5 (i.e. where the check of uctuation-dissipation theorem with the rst type of measures still was positive): it appears that  $= 1=T_{eff}$ 

with  $T_b > T_{eff} > T_G$ . This breakdown of uctuation-dissipation relation should be related to cluster formation (i.e. spatial lack of hom ogeneity), which is present even in the case of DSMC solutions of Boltzm ann equation (see for example [7]). This violation is more pronounced than in the previous experiment, therefore appearing earlier, because this is a \local" m easurement of FD, i.e. only one particle is perturbed: this means that the uctuations of the local granular temperature strongly in uence the trajectory of the tracer and its statistical properties.




FIG.6: Param etric plot of  $(t;t_w)$  vs.B  $(t;t_w)$  for the num erical experiment of type II (constant force applied on one particle) with r = 1, r = 0.8 and r = 0.7, with heating bath, and for di erent choices of the intensity of the perturbation, using  $T_b = 0.1$  ad  $_b = 10$ , N = 500,  $_c = 1$ ,  $t_w = 100$ . The results are obtained by averaging over 10000 realizations.

## VI. CONCLUSIONS

In conclusion in this paper we have investigated the validity of K ubo's relations in D riven G ranular G ass in two dimensions. We have compared in particular two sets of measures. On the one hand we have measured the proportionality factor between the response of the staggered density current to an impulsive shear forcing and its autocorrelation function in the unperturbed system. On the other hand we have monitored the velocity of a tracer by checking the proportionality between its response to a small constant force, switched on at time  $t_w$ , and its mean squared displacement in the unperturbed stationary state.

In both cases a proportionality is observed, in analogy with the Linear Response theory for equilibrium dynamics. Furtherm one the proportionality factor in the K ubo form ulas is equal to the inverse of the granular temperature (at least for the restitution coe cients larger than r > 0.5), which hence plays the role of the equilibrium temperature in the elastic case. It is important to remark how these results are recovered by two completely independent measurem ent schemes.




FIG.7: Param etric plot of  $(t;t_w)$  vs. B  $(t;t_w)$  for the num erical experiment of type II (constant force applied on one particle) with r = 0.5, with heating bath, and for di erent choices of the intensity of the perturbation, using T<sub>b</sub> = 0.1 ad <sub>b</sub> = 10, N = 500, <sub>c</sub> = 1, with average on 10000 realizations, using t<sub>w</sub> = 100. This case r = 0.5 exhibits a slope compatible with T<sub>eff</sub> = 0.051 which is above T<sub>G</sub>.

Several remarks are in order. First of all, though a granular gas is a non-trivial out-of-equilibrium system, from the point of view of its therm odynamics it exhibits properties which seem much simpler than the corresponding properties observed in a compacting granular medium. In this case in fact apparently no slow modes are present or at least their presence does not give raise to the existence of several elective temperatures depending on the time-scales investigated [12]. On the other hand the proportionality factor between response and autocorrelation we have found cannot be considered a temperature from the point of view of equilibrium therm odynamics since it does not rely on any known statistical ensemble.

A nother point to stress concerns the validity of the zeroth principle of them odynam ics. The question that im mediately arises could be summarized as follows: if the granular temperature represents the correct temperature from the point of view of the Fluctuation-D issipation Theorem, should we expect it rules the thermalization properties of two di erent granular gases put in contact? As already mentioned the answer to this question is far from being trivial as witnessed by all recent results obtained on mixtures [25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35] where a lack of equipartition is observed. However these results (validity of uctuation-dissipation relations and lack of equipartition) can coexist simply because heated granular gases have not only a therm all source but also a therm all sink (dissipative collisions) and therefore any zero principle should be stated in term sofa balance equation am ong energy uxes instead of a strict equivalence between temperature of system s in contact.

We again remark, also, that there are other common ways of driving a granular gas in a stationary state, e.g. stochastic driving without viscosity [8], stochastic restitution coe cient models [10], multiplicative noise models [9] and so on. In some of these models a more pronounced departure from hom ogeneity (for example correlations in the velocity eld [8]) and therefore a breakdown of uctuation-dissipation relations should be investigated.
