## Gauge-invariant G reen function in 3+1 dim ensionalQED (QCD) and 2+1 dim ensionalAbelian (Non-Abelian) Chern-Sim on theory

By applying the simple and e ective m ethod developed to study the the gauge-invariant ferm ion G reen function in 2+1 dimensionalnon-compact QED, we study the gauge-invariant G reen function in 3+1 dimensionalQED and 2+1 dimensionalnon-compact C herm-Sim on theory. We also extend our results to the corresponding SU (M) non-Abelian gauge theories. Im plications for Fractional Q uantum Halle ect are brie y discussed.

### I. IN TRODUCTION

In any system sofgauge elds (A belian or N on-A belian ) coupled to m atters (ferm ions or bosons), the conventional G reen function is de ned as:

 $G(x;y) = \langle (x) (y) \rangle$  (1)

In momentum space, the fully-interacting Fermion G reen function in Eqn.1 takes the form G (k) =  $\frac{ik}{k^{2+}x}$ . In 4 (3) dimensional space-time, it corresponds to  $\frac{x}{x^4}$  ( $\frac{x}{x^3}$ ) where the anom abus dimension can be calculated by standard Renormalization G roup (RG) by extracting UV divergences. Unfortunately, this G reen function is not gauge invariant, depends on the xed gauge in which the calculation is done.

Schwinger proposed the following Gauge-invariant Green function [1]:

where the inserted D irac string makes the Schwinger G reen function gauge invariant.  $G^{\text{inv}}$  depends on the the integral path C from x to y. For simplicity reason, we take C to be a straight line [2].

In fact, the path C should be determined by the underlying physical system s. In QED or QCD, in principle, one should perform average over all possible paths from x to y with som eweights, but what kind of weight factors should be used is still unclear. Non-sm ooth paths with cusps or intersections will also cause additional com plications. Perturbative QCD makes sense only at short distance, so choosing straight line m ay be reasonable. See [3] for som e prelim inary discussions. In condensed m atter systems such as Fractional Quantum Hall E ects or High Tem perature Superconductors (HTS), form ulated on a lattice, the physical quantities such as real electron G reen function in FQHE or Angle Resolved Photo-Emissions Spectroscopy (ARPES) in HTS are independent of path, therefore taking a straight line is not only simplest and also plausible. In [29], we will discuss the path dependence of gauge-invariant G reen functions in dierent condensed matter systems formulated on lattices.

In Q uantum C hrom odynam ics (Q C D), the Schwinger gauge-invariant G reen function is closely associated with the hadronic bound states and was studied before [3]. In recent years, its importance in condensed matter system was recognized in the contexts of Fractional Q uantum H all system s [4] and high temperature superconductors [5[7].

By a singular gauge transform ation which attaches two ux quanta to each electron, an electron in an external magnetic eld was mapped to a composite ferm ion in a reduced magnetic eld [8{10]. A lthough transport properties which are directly related to two particle G reen functions can be directly studied in the composite ferm ion language, the tunneling density of states which is directly related to the single particle electron G reen function is much more di cult to study. In fact, the single particle electron G reen function is equal to the gaugeinvariant G reen function of the composite ferm ion which was evaluated for non-relativistic ferm ions by phenom elogical argum ents in R ef. [4].

Most recently, the importance of gauge-invariant Green function of ferm ion to Angle Resolved Photo-Emission (ARPES) data in high temperature superconductors was discovered independently by Rantner and W en (RW ) [5] and the author [6] in di erent contexts. Starting from U (1) or SU (2) gauge theory of doped M ott insulators [11{13], RW discussed the relevance of this gauge-invariant G reen function to ARPES data. They also pointed out that in tem poral gauge, the equal-space gauge-invariant G reen function in Eqn 2 is equal to that of the conventional gauge dependent one in Eqn.1. Starting from a complementary (or dual) approach pioneered by Balents et al [14], the author studied how quantum [7] or therm al [6] uctuations generated hc=2e vortices can destroy d-wave superconductivity and evolve the system into underdoped regime at T = 0 or pseudo-gap regime at nite T. In the vortex plasm a regime around the nite tem perature K osterlitz-T houless transition [15], the vortices can be treated by classical hydrodynam ics. By Anderson singular gauge transform ation which attaches the ux from the classical vortex to the quasi-particles of d-wave superconductors [16{19], the quasi-particles (spinons) are found to move in a random static magnetic eld generated by the classical vortex plasm a [6]. The electron spectral function G  $(x;t) = \langle C (0;0)C^{y}(x;t) \rangle$  is the product of the classical vortex correlation function and the gauge invariant G reen function of the spinon in the random magnetic eld. Techniqually, this static gauge invariant G reen function is di erent from the original dynam ic Schwinger gauge invariant G reen function. C onceptually, both are single particle gauge-invariant G reen function and are physically measurable quantities.

Recently, two di erent m ethods are developed to calculate the gauge invariant G reen function Eqn 2. The author in R ef. [20] evaluated it in a path integral representation. In Ref. [21], by applying the methods developed to study clean [22] and disordered [23] FQH transitions and superconductors to insulator transitions [24], the author developed a very sim ple and e ective m ethod to study the gauge invariant G reen function. In the context of 2+1 dimensionalmassless Quantum Electro-Dynamics (QED3) [25,12,13], the author studied the gauge-dependent G reen function both in tem poral gauge and in C oulom b gauge. In temporal gauge, the infrared divergence was found to be in the middle of the contour integral along the real axis, it was regularized by deforming the contour into com plex plane by physical prescription, the anom alous dimension was found and argued to be the same as that of gauge-invariant G reen function. How ever, in Coulomb gauge, the infra-red divergence was found to be at the two ends of the contour integral along the real axis, therefore un-regulariable, anom alous dim ension was even not de ned. This infra-red divergence was shown to be canceled in any physical gauge invariant quantities such as function and correlation length exponent

as observed in Refs. [22{24]. The author also studied the gauge-invariant G reen function directly by Lorentz covariant calculation with di erent gauge- xing param eters and nd that the exponent is independent of the gauge xing param eters and is exactly the same as that found in tem poral gauge.

In this paper, we apply the simple and e ective method developed in Ref. [21] to study the two interesting physical systems: 3 + 1 dimensional QED and 2 + 1 dimensional Chem-Sim on theory and their corresponding SU (M) non-Abelian counter-parts. The importance of the rst system is obvious in high energy physics. The second system is closely related to the high temperature behaviors of 3 + 1 dimensional QED or QCD. It may also describe FractionalQ uantum H all (FQH) transitions [10,27,22,23]. The gauge invariant G reen function Eqn 2 is a relativistic analog of tunneling density of state in FQH system studied by phenom elogical method in [4].

The paper is organized as follows. In the next section, we study QED 4 in both tem poral gauge and Lorentz covariant gauge, we also extend our results to non-A belian SU (M) QCD. In section III, we study QED 3 with Chem-Sim on term also in both tem poral gauge and Lorentz covariant gauge, we also extend our results to non-A belian SU (M ) Chern-Sim on theory. Finally, we reach conclusions by sum marizing our results in three simple and intuitive rules.

### II. 3+1DIMENSIONALQED

The standard 3 + 1 dimensional massless Quantum Electro-Dynamics (QED4) Lagrangian is:

W here a is a four component spinor, a = 1; ;N are N species of D irac ferm ion, are 4 4 m atrices satisfying the C li ord algebra f; g = 2.

In contrast to QED 3 studied in [21], the coupling constant e is m arginal ( or dim ensionless) at 4 space-tim e dim ension. Straight-forward perturbation su ces.

W ith the gauge xing term  $\frac{1}{2}$  (0 a )<sup>2</sup>, the gauge eld propagator is:

By extracting UV divergence, we nd the anom abus exponent for the gauge dependent G reen function in Eqn.1  $\,$

Note that in Landau gauge = 0, vanishes ! In usual textbooks, the detailed calculations were given in Feym ann gauge = 1 with =  $\frac{e^2}{8^2}$ . Obviously, is a gauge-dependent quantity and its physical meaning in any Lorentz covariant gauges is not evident. In the following section, we will calculate in two Lorentz non-covariant gauges: tem poral gauge and Coulom b gauge.

### A. The calculation in Tem poral gauge


As stated in the introduction, the main focus of this paper is the gauge-invariant G reen function Eqn 2. In tem poral gauge, the equal-space gauge invariant G reen function is the same as the gauge dependent one [5].

The strategy taken in Ref. [21] is to calculate the conventional G reen function in temporal gauge  $a_0 = 0$  and then see what we can say about the gauge invariant G reen function. As shown in [21] in the context of QED 3, in temporal gauge and C oulom b gauge which break Lorentz invariance, we run into both UV and IR divergences. A sensible and physical method was developed to regularized these plaguey IR divergences. Here we take the sam e strategy and apply sim ilar method to regularized these IR divergences in the context of QED 4.

W ith the notation  $K = (k_0; \tilde{\kappa})$ , in  $a_0 = 0$  gauge, it is easy to nd the propagator:

The one-loop ferm ion self-energy Feym ann diagram is

The corresponding expression is

By using standard matrices C li ord algebra and suppressing the prefactor  $ie^2$ , we can simplify the above equation to:



We choose the external momentum K to be along z axis, then  $Q_4 = Q \cos ;Q_3 = Q \cos _1 \sin ;Q_2 = Q \cos sin _1 sin ;Q_1 = Q sin sin _1 sin ;d^4Q = Q^2 dQ d sin _1 d _1 sin^2 d . Setting x = cos , we nd the logarithm ic divergence:$

The integral can be rew ritten as:

A sexpected, we run into  $\mathbb{R}$  divergence at x = 0 which is in the middle point of the contour integral on the real axis from 1 to 1. Fortunately, by physical prescription, we can avoid the  $\mathbb{R}$  singularity at x = 0 by deforming the contour as shown in Fig 2

The divergent part in Eqn.10 becom es:

Putting back the prefactor ie<sup>2</sup>, we get the nalanswer:

W e can identify the anom alous dim ension as

W e expect this is the correct anom alous dimension of the gauge-invariant G reen function Eqn 2 in QED 4. It is consistent with the result in [3,20] achieved with very di erent m ethod.

In the above calculation, we choose a cut-o in 4m om entum Q, Just as in QED 3 studied in [21], we can introduce an alternate cut-o  $\sim$  only in 3-m om entum q, but integrate the frequency q<sub>0</sub> freely from 1 to 1 . U sing the sim ilar infra-red regulization scheme as in Fig. 2, we nd exactly the same answer as Eqn.13. This agreem ent indeed shows that the exponent Eqn.13 is universal independent of di erent cut-o s or di erent renorm alization schemes.

Just as in QED 3 studied in [21], we could evaluate the G reen function in C oulom b gauge  $Q_i a_i = 0$ . As in tem poralgauge, we also run into IR divergence. In both cut-o Q < and cut-o q < ~, we run into IR divergences at x = 1 which are at the two end points of the contour integral on the real axis from 1 to 1. Unfortunately, from physical prescription, we are unable to avoid the IR singularities at the two end points x = 1 by deform ing the contour. Therefore, we are unable to identify anom alous exponent. Furtherm ore, the results are different in the two di erent cuto s. This should cause no disturbance, because, in contrast to the G reen function in tem poral gauge, the G reen function Eqn.1 in C oulom b gauge does not correspond to any physical quantities. All these IR divergences should disappear in any gaugeinvariant physical quantities like function and critical exponents. The nalanswers for these physical quantities should also be independent of di erent cut-o s or di erent renorm alization schem es.

### B. Lorentz covariant calculation

In this subsection, we will calculate the gauge invariant G reen function directly in Lorentz covariant gauge Eqn 4 without resorting to the gauge dependent G reen function. We will also compare with the result achieved in tem poral gauge.

The inserted D irac string in Eqn. 2 can be written as:

where parameterizes the integral path C from x to y.

We will follow the procedures outlined in detail in Ref. [21]. (1) Combining the source current with the ferm ion current j (x) = (x) (x) to form the total current j<sup>t</sup> (x) = j  $(x) + j^{s} (x)$  (2) Integrating out a in the Lorentz covariant gauge Eqn.4, we nd:

W here Z is the partition function of QED4 and W is given by:

The rst term in Eqn.17 is just the conventional longrange four-ferm ion interaction mediated by the gauge eld, it leads to the anom alous exponent in the covariant gauge given in Eqn.5:

Note that in Landau gauge = 0,  $_1 \sin p \ln p$  vanishes !

The second term in Eqn.17 is given by:

Extracting the leading terms as ! 1 turns out a little bit m ore di cult than its 2 + 1 dim ensional counterpart discussed in [21]. Fortunately, the independent part was already given in R ef. [28] in a di erent context:

W here is the Euler constant. The linear divergence is a arti-fact of the momentum cut-o and should be ignored in Lorentz invariant regularization.

W e only need to evaluate the dependent part:



Eqn. 23 is essentially quadratic in the ferm ions. Com – bining it with the free ferm ion action leads to:

In principal, the propagator of ferm ion  $\langle x_1 \rangle \langle x_2 \rangle \rangle$  can be calculated by inverting the quadratic form in the above equation, but it is not easy to carry out in practice. Instead we can construct perturbative expansion in real space by the following Feym ann diagram s in Fig.3

The corresponding expression is:

Being just quadratic, there is no bops in the above Feym ann series. But there may still be potential divergences.

The explicit expression for Fig.3b is

It is easy to see the second term in Eqn 27 is convergent. While the UV divergences in the third term in Eqn 27 exactly cancels as follows:

The logarithm ic divergence in the rst term in Eqn 27 cancels exactly that of independent term in Eqn 28. Only the dependent divergence in Eqn 28 survives:



This is exactly the same as that calculated in the temporal gauge. As expected, the gauge xing parameter drops out in the anom alous dimension although  $_1$ ;  $_2$ ;  $_3$  all depend on separately.

### C. 3+1 dim ensional N on-A belian SU (M ) Q C D

The calculations in the last two subsections on A belian QED can be straight-forwardly extended to N on-A belian SU (M) QCD by paying special attention to the internal group structure of SU (M) group.

In temporal gauge, the one-loop ferm ion self-energy Feym ann diagram in SU (M ) QCD is

The corresponding expression is

where  $T^{c}$  with c = 1;  ${}^{2}M 1$  are  $M^{2} 1$  generators of SU (M) group. a; d; b = 1; ; M are M color indices of ferm ions transforming as a fundamental representation of SU (M) group.

It is easy to see

where  $(T^{c})_{ab}^{2} = C_{2} (F)_{ab}$  with the quadratic Casimir  $C_{2} (F) = \frac{M^{2}}{2M}$  for the fundamental representation of SU (M) group.

From Eqn.13, we have

For SU (3) QCD,  $C_2$  (F) = 4=3, then  $SU(3) = \frac{e^2}{2}$  which is consistent with the result achieved previously with di erent m ethod [3,20].

Eqn.35 can also be derived by using the Lorentz co-variant calculation presented in the last subsection.

The results achieved in this section is not new, but two new, simple and e ective methods are developped to rederive these old results. In the next section, we will use these new methods to derive new results in gauge theories with Chem-Sim on term.

# III. 2+1DIMENSIONALNON-COMPACTQED WITHCHERN-SIMONTERM

In the two component notations suitable for describing T im e reversal and P arity breaking mass term and C hem-S im on term, the standard 2+ 1 dim ensional massless Q uantum E lectro-D ynam ics Lagrangian with C hem-S im on term is:

W here a = 1; ;N are N species of D irac ferm ion [26].

This Lagrangian was used to describe FQH transitions in [10,27,22,23]. As shown in [27], in straightforward perturbation expansion, there is no extra UV divergences from the CS term in one-loop. One has to go to two loops to see the extra UV divergences from the CS term. Instead of going to two loop calculations, we resort large N expansion by scaling the coupling constant as g=Nin Eqn.36. Integrating out N pieces of ferm ions generates an additional dynam ic quadratic term for the gauge eld:

To one-loop order [27]:

Adding the gauge xing term  $\frac{1}{2}$  (@ a )<sup>2</sup>, we can get the propagator of the gauge eld in the covariant gauge:

Changing the last localgauge xing term to a non-local gauge xing term [25] leads to

In the follow ing, we follow the same procedures in Ref. [21], paying special attention to the extra e ects due to the CS term .

### A. The calculation in Tem poral gauge

W ith the notation  $K = (k_0; \tilde{K})$ , in  $a_0 = 0$  gauge, we can invert Eqn 39 to nd the propagator:

It is known that the anti-symmetric CS propagator does not contribute to divergence to one-loop order [27], the result in Ref. [21] can be directly applied by replacing 16=N by  $\frac{B g^2}{N}$ :

W e expect this is the correct anom alous dimension of the gauge-invariant G reen function E qn 2 in 2+1 dim ensional C hem-Sim on theory.

The tunneling density of state (!)  $!^1$ . That is positive indicates the tunneling DOS increases due to the Chem-Sim on interaction.

#### B. Lorentz covariant calculation

In this section, we will calculate the gauge invariant G reen function directly in Lorentz covariant gauge E qn .41 without resorting to the gauge dependent G reen function. W e will also compare with the result achieved in tem poral gauge.

First, let's see what is the contribution from the rst term in Eqn.17. As shown in [27]. the anti-symmetric CS propagator in Eqn.41 does not lead to divergence, the symmetric part of the propagator leads to

In evaluating the contribution from the second term in Eqn 17, the extra piece due to the CS term is:

O by iously, this extra term vanishes due to the antisym metric tensor. The result in Ref. [21] can be directly applied:

Finally, in evaluating the contribution from Fig.3b, the extra term due to the CS term is:

where  $x_2 = x_1 = x$ .

A fler straightforward manipulation, the above equation can be simplied to:

It is easy to nd the potential UV divergences in the rst term and second term, in fact, vanish separately ! A gain, the result in Ref. [21] can be directly applied:

In all, the nalanom abus exponent is

This is exactly the sam e as that calculated in the tem - poral gauge.

A lthough evaluating all these (1=N)<sup>2</sup> corrections is beyond the scope of this paper, we have established  $\,$  m ly our results Eqn 50 to order 1=N .

### C . N on-A belian SU (M ) C hern-S im on gauge theory

It is useful to extend our results on Abelian CS theory established in the two previous subsections to Non-Abelian CS theory. Non-Abelian gauge theories arise both in high temperature superconductors [11] and FQHE [31]. In contrast to the state at lling factor at

= 1=2 which has a gapless Ferm i surface, the state at lling factor 5=2 m ay be a gapped paired quantum H all state [31]. This paired state m ay be a N on-A belian state where the quasi-particles m ay obey non-A belian statistics [31]. The e ective low energy theory of non-A belian states can be described by SU (2) Chem-Sim on gauge theory.

Extension to relativistic SU (M) Non-Abelian CS theory discussed in [30] is straightforward. By using the rule derived in section IIC, to the order of 1=N, we get the result:

$$=\frac{M^{2}}{2M}\frac{1}{1+(\frac{g^{2}}{16})^{2}}\frac{1}{12^{2}N}$$

This results could be achieved both in temporal gauge and in Lorentz covariant gauge presented respectively in the previous two subsections.

### IV . CONCLUSIONS

In this paper, using the simple and powerful methods developed in [21], we calculated the gauge-invariant ferm ion G reen function in 3+1 dimensional QED, 2+1 dimensionalQED with Chem-Sim on term and their corresponding SU (M) non-A belian counter-parts by dierent m ethods. The calculations in temporal gauge with dierent cut-o s and Lorentz covariant calculation with dierent gauge xing parameters lead to the same answers. These facts strongly suggest that Eqn.13 is the correct exponent to one-loop and Eqn. 43 is the correct exponent in the leading order of 1=N. These m ethods was previously applied to study 2 + 1 dimensionalQED and have also been applied to m any dierent physical system s [29]. We sum marize our results with the following three useful rules of thum b:

Rule 1: In tem poral gauge, Infra-red divergence is always in the middle of the integral and can be regularized by deforming the contour. The nite exponent is the anom alous exponent of the gauge invariant G reen function.

Rule 2: In Coulom b gauge, Infra-red divergence is always at the two ends of the contour integral and can not be regularized by deform ing the contour. The anom alous exponent is even not de ned. but the IR divergence will be canceled in any gauge-invariant physical quantity.

Rule 3: The anom abus exponent of gauge-invariant G reen function is equal to the sum of the exponent of gauge-dependent G reen function in Landau gauge and the exponent of the inserted D irac string also in Landau gauge.

A lthough we demonstrated the above three rules of thum b only to one-loop or to the order 1=N . We expect they allhold to any loops or to any order of 1=N .
