Structure, Structural Relaxation and Ion Di usion in Sodium Disilicate Melts

We have investigated N a_2 Si₂O₅ melts with inelastic neutron scattering at temperatures up to 1600 K. The SiO network relaxes on a time scale of ns, whereas the Na ion relaxation dynamics are found on a time scale of 10 ps. The elastic structure factor exhibits at '0:9 A ¹ an emerging prepeak which becomes more pronounced with increasing temperature. The prepeak is caused by the form ation of sodium rich regions in the partially disrupted SiO tetrahedral network.

Silicate melts have great relevance both in earth science and technology: The physical properties of magma (molten silicate rock) dominate many geological processes and technological glasses are synthesized from the molten state. These silicate melts, natural and technological, are multicom ponent systems. A considerable effort has been made to investigate a wide range of silicate melts with the general aim of linking structural with physical properties and to develop an atom ic level understanding of their structure and dynam ics [1]. Nevertheless, experiments on the structure and microscopic dynamics in the viscous melt well above the conventional glass transition temperature Tq are rare. Here, we present inelastic neutron scattering results on sodium disilicate melts and show that at temperatures well above T_{α} signicant changes in the elastic structure factor occur that are caused by sodium rich regions in the partially disrupted Si-O tetrahedral network. The existence of sodium rich regions has a strong in uence on the sodium ion transport and m ay very well be the cause for the weak tem perature dependence of the viscosity at higher tem peratures. Our results on structure and dynamics can be rationalized using results of recent molecular dynamics sim ulations [2].

A lkali silicates are a simpli ed analog for most magmas and technological glasses. Compared with pure silica, with a caloric glass transition temperature $T_{\rm g}$ at $^{\prime}$ $1500\,\rm K$, the addition of Na_2O partially disrupts the SiO_2 network structure resulting in a halving of the $T_{\rm g}$ at sodium disilicate. In addition, sodium disilicate has been the subject of extensive molecular dynamics simulations [2{4}] and thoroughly investigations [5,6]. Inelastic neutron scattering covers a dynamic range that gives insight not only into dynamics on microscopic time scales but also into the medium range structure of silicate melts. In addition, the results can provide input for simulations used e.g. to model magma properties in volcanic activity and are an experimental test of molecular dynamics simulations.

Sodium disilicate Na2Si2O5 was synthesized from ul-

trapure Na $_2$ CO $_3$ and SiO $_2$ powders. The mixture was melted in a Pt crucible and stirred with a Pt $_{80}$ Rh $_{20}$ spindle at superliquidus tem peratures until it was hom ogeneous and bubble free. Di erential scanning calorimetry yielded a glass transition temperature at '741K in agreement with the literature value at T $_g$ ' 737K [6]. For the neutron scattering experiment the sample was encapsulated in a Pt sample cell giving an annular sample geometry of 40mm in height, 22.5mm in diameter and a 1.25mm wall thickness.

We performed inelastic neutron scattering measurements on the time-of-ight spectrometer IN 6 at the Institut Laue-Langevin in Grenoble. An incident neutron wavelength of = 5:1 A 1 yielded an energy resolution of E = 93 eV (FW HM) and an accessible wave number range at zero energy transfer of $q = 0.3 2.0 \,\text{A}^{-1}$. Spectrawerem easured in the glass at 400 K and in the viscous melt at 800K and between 1200K and 1600K in steps of 100 K . During cooling m easurem ents were repeated at each tem perature. No change between spectra obtained during heating and cooling could be detected. A dditional high-energy resolution spectra at 300 K, 1300 K, 1400 K, 1500 K, and 1600 K were obtained on the new backscattering spectrom eter [8] of the N IST Center for Neutron Research in Gaithersburg having a sub-eV energy resolution and, in the set-up used, an accessible wave number 1:6A 1. range of q = 0.6

The raw data reduction consists of normalization to a vanadium standard, correction for self absorption and container scattering, and interpolation to constant wave numbers q in order to obtain the scattering law S(q;!). Further, S(q;!) was symmetrized with respect to the energy transfer h! by means of the detailed balance factor. Whereas scattering from the Si and O atoms is exclusively coherent, Na scatters coherently and incoherently. The incoherent scattering from Na rejects itself in a at background in the elastic structure factor S(q;!=0).




FIG.1. Elastic structure factor S (q;! = 0) of sodium disilicate: Toward small q the signal is dominated by the incoherent contributions of the sodium atom s. The maximum around ' 1:7A 1 rejects the scattering of the partially disrupted tetrahedral SiO $_{4}$ network. W ith increasing temperature a pronounced shoulder is emerging at q' 0.9A 1 . The decrease in intensity at q values larger than ' 1:1A 1 in turn mainly rejects the Debye{W aller factor.

Figure 1 displays the elastic structure factor of glassy and viscous sodium disilicate. Toward small q the signal is dominated by incoherent contributions of the sodium

atom s. The maximum around ' $1.7\,\mathrm{A}^{-1}$ re ects the coherent scattering mainly of the disrupted tetrahedral SiO network. The intensity at q values larger than ' $1.1\,\mathrm{A}^{-1}$ is decreasing with increasing tem perature and q which is well accounted for by the Debye{W aller factor. In contrast, at q' $0.9\,\mathrm{A}^{-1}$ a pronounced prepeak is emerging with increasing tem perature. We note that the signal is independent on thermal history indicating a process in thermoequilibrium as a cause for this change.

Our S (q; ! = 0) at 400K and 800K are consistent with neutron di raction results on sodium tetrasilicate $Na_2Si_4O_9$ [9] where at temperatures up to some 180K above T_q spectra display only a little change in the structure factor. ²⁹Si nuclear magnetic resonance (NMR) m easurem ents on sodium disilicate [10] in the m etastable melt up to 876K report a continuous but small change in the number of 0 atoms surrounding a Siatom with increasing tem perature. At higher tem peratures motion of the atoms becomes too fast for conventional NMR techniques. From wide angle X-ray di raction on various sodium and potassium silicates and sodium disilicate at 295K and 1273K in particular, previous workers [11] cam e to the conclusion that the structure of silicate melts is insensitive to tem perature change. However, data quality especially in the q range below ' 12A 1 is rather poor. The molecular dynamics simulations on sodium disilicate melts [2] do indeed exhibit a shoulder in the static structure factor at $q=0.94\,\mathrm{A}^{-1}$. The molecular dynamics simulations [2] link this prepeak to a characteristic length scale of regions where the network is disrupted and where the sodium concentration is enhanced.




FIG. 2. High{energy resolution backscattering spectra of a sodium disilicate melt. A round q' 1:6A 1 the signal is dominated by the coherent scattering of Si and 0 . At 1600 K structural relaxation of the Si-O network is on a ns{time scale causing a broadening of the quasielastic line. The line represents a t (1) giving a relaxation time of 4ns and a stretching exponent = 0:75 0:1.

Figure 2 shows high (energy resolution backscattering spectra of sodium disilicate melts at $q=1.6\,\mathrm{A}^{-1}$. A measurement of the glassy sample at 300 K represents the instrumental resolution prole R (q;!). Above 1400 K as a mall broadening of the signal can be resolved. A round q' 1:6A the signal is dominated by the scattering of Siand 0. Structural relaxation of the partially disrupted tetrahedral SiO network leads to a quasielastic broadening in the spectra. A common feature of structural relaxation in glass forming liquids is a stretching of correlation functions over a wider time range than expected for exponential relaxation [12,13]. The line is a twith the Fourier transform of the Kohlrausch stretched exponential function convoluted with the instrumental resolution function:

A best tofexpression (1) with B=0 gives a relaxation time of 4ns and a stretching exponent =0.75 0:1. B=0 demonstrates that the dynamics of all atoms contributing to the quasielastic signal are on the same time scale. Scattering on considerabely faster relaxation or vibration (ps time scale) results in a at background. At 1600K sodium disilicate has a viscosity of 4.5Pas

[6]. The relaxation time is consistent with the relaxation time estimated from viscosity showing that the data in Fig. 2 indeed display the network dynamics. A twith a stretched exponential function to the coherent intermediate scattering function of Si and O correlations at $1.6A^{-1}$ as obtained by the molecular dynamics simulations [2,7] gives = 0.83 in accordance with our result.

At tem peratures up to '2 T_g the di usive dynam ics of the alkali atom s in silicate melts is appreciably faster than the structural relaxation [14]. Figure 3 displays the scattering law S (q;!) of sodium disilicate as obtained on the neutron time-of-ight spectrom eter IN 6. Wellbelow $q=\ 0.5\,\text{A}^{-1}$ the signal is dominated by the incoherent scattering on sodium . Di usive motion of sodium causes a broad quasielastic signal. The lines in Fig. 3 are ts with expression (1), where the function represents the elastic scattering contribution to the signal and B its am plitude. Best ts have been obtained with a stretching exponent within [0.7,0.8] in accordance with the MD simulations result of = 0:77 for the incoherent intermediate N a scattering function [2,7]. < 1 indicates that Na di usion is not a simple activated process. Resulting relaxation times (Fig. 3) show a small change with tem perature with '29ps at 1200K and '13ps at 1600K.

Compared to other multicomponent glass forming liquids investigated so far the changes in the elastic structure factor of sodium disilicate melts are unexpected. Viscous metallic ZrTiNiCuBemelts show a similar temperature dependence of viscosity [15] as sodium disilicate when plotted versus $T_q = T$ at tem peratures well below the liquidus. In addition, di usive dynamics of various atoms, that are smaller than the large structural Zr atom s, are appreciably faster than structural relaxation and also decoupled from viscous ow [16]. Toward higher tem peratures the tem perature dependence of the viscosities of ZrT iN iCuBe and sodium disilicate deviate [6] which may very well be the result of the sodium rich regions in sodium disilicate: The formation of sodium rich regions leaves regions with a lower sodium concentration and hence with a less disrupted Si+O network leading to a higher viscosity of the entire system.

B esides a non-exponential structural relaxation viscous m etallic m elts exhibit a fast relaxation process [17] which can be visualized as a rattling of the atom s in the transient cages formed by their neighbors. This { so called { fast relaxation, that prepares structural relaxation responsible for viscous ow, has been predicted by the mode coupling theory (MCT) of the liquid to glass transition [12] and has been found in many experiments and simulations on a variety of other glass forming systems [18]. Molecular dynamics simulations on sodium disilicate show that the predicted factorization property for Siand O correlationsholds in the fast relaxation regime [7]. The signal in the fast relaxation regime, typically around 1 meV, is in sodium disilicate governed by the

incoherent contributions of the di using sodium atoms. However, since the sodium disilicate spectra do not show an indication for an additional fast process, its amplitude has to be small compared to the quasielastic line originating from the sodium di usion. This compares well to results of a neutron scattering experiment on another network forming melt: In liquid GeO $_2$ a fast MCT relaxation process could not be detected up to T = 2 T_g [19].

A recent molecular dynamics simulations study on sodium tetrasilicate [20] suggests the existence of sodium rich channels having a distance of about 6-8 A. The prepeak at 0.9 A ¹ corresponds to the distance between these channels. A similar behavior has been found in the MD simulations on sodium disilicate [7]. The microscopic picture given by the molecular dynamics simulations [2,7,20] of regions that exhibit a higher sodium concentration is in agreement with our results.

In conclusion, we have investigated structure and dynam ics in sodium disilicate melts with inelastic neutron scattering. The viscous melt well above T_g exhibits changes in the elastic structure factor: With increasing temperature a pronounced prepeak emerges at ' 0.9 A 1 caused by sodium rich regions in the disrupted Si-O network. High resolution quasielastic neutron scattering shows structural relaxation of the partially disrupted Si-O tetrahedral network to be on a nanosecond time scale at $1600\,\mathrm{K}$. The structural relaxation is non-exponential with a stretching exponent ' 0.75. Inelastic neutron scattering reveals di usive dynamics of the sodium ions on a $10\,\mathrm{ps}$ time scale. Even in the equilibrium melt the Sodium ions di use in a relative immobile Si-O matrix.




FIG. 3. Scattering law S (q;!) at q = $0.5\,\mathrm{A}^{-1}$ m easured on the neutron time-of- ight spectrom eter IN 6.D i usion of sodium ions results in a broad quasielastic signal that is described by (1) with a stretching exponent within [0.7,0.8] and relaxation times at some 29 ps at 1200 K and some 13 ps at 1600 K.
