Pocket M onte C arlo algorithm for classical doped dim er m odels

We study the correlations of classical hardcore dimer models doped with monomers by Monte C arlo simulation. We introduce an elicient cluster algorithm, which is applicable in any dimension, for dimerent lattices and arbitrary doping. We use this algorithm for the dimer model on the square lattice, where a nite density of monomers destroys the critical conmerned on the two-monomer problem. The monomers form a two-component plasma located in its high-temperature phase, with the C oulomb interaction screened at nite densities. On the triangular lattice, a single pair of monomers is not conmed. The monomer correlations are extremely short-ranged and hardly change with doping.

I. IN TRODUCTION

M odels of classical dim ers on a lattice play an important role in polym erphysics, but their statisticalm echanics has proven to be of great value in a much wider range of settings. P rom inently, in the early days of the resonating valence bond theories¹ of high-tem perature superconductivity, R okhsar and K ivelson² proposed that dim ers could act as caricatures of singlet (valence') bonds betw een spins 1/2, with the hardcore condition on the dim er con gurations translating the constraint that each spin participate in exactly one singlet bond with a neighboring spin. R esonances between di erent con gurations generate a quantum dynam ics for the resulting R okhsar K ivelson quantum dim erm odels (RK-QDM).

These RK -QDM s are also of interest as elective theories, as they appear as limiting cases of d = 2 + 1 dimensional Ising gauge theories which are dual to frustrated Ising models.³ Central in this context is the question of con nement { can two test charges be separated in nitely far at nite cost in free energy? In the dimer model, these test charges are monom ers, representing spinons or holons in the RVB theory.

In the context of RK quantum dim erm odels, classical dim er models play a crucial role because, for a particular choice of parameters, the quantum wavefunction is an equal-amplitude superposition of all classical dimer con gurations⁴. For this reason, dim er-diagonal correlation functions can be obtained from the classical (equally weighted) average over all dim er con gurations. At zero doping, such correlations can be obtained analytically using P fa an m ethods introduced by K asteleyn⁵ and developed further by a number of authors.⁶ These methods have been extended to obtain correlation functions of a pair of m onom ers on the square lattice, $7^{,8}$ although it is not clear whether asymptotic monomer correlations can in general be obtained in closed form along those lines. Present analytical approaches do not allow an exact treatment of nite monomer densities; this is related to the absence of an analytical solution of the twodimensional Ising model in a magnetic eld".

To reach the RK point in the presence of doping, it

is necessary not only to ne-tune two ratios of magnitudes of kinetic and potential energies but also a hopping phase.² This procedure is not innocuous, but classical correlations are also interesting because they are those of the quantum model at high temperature. There, hopping and resonance as well as any potential energies included in the dimer model are much smaller than the therm al energy. The classical correlations can remain non-trivial as a result of the projection onto the space of monom erdimer coverings. One is thus interested in the presence of (at least short-range¹⁰) correlated structures, and how they change with doping.

In this paper, we present an e cient numerical algorithm for simulating classical monom er-dimermodels. The algorithm is analyzed in some detail, and we mention possible uses for related problem s.

O ur main results are the following. Firstly, a pair of monomers on the triangular lattice is deconned, with a correlation length of less than one lattice constant. This is in keeping with the very short-range dimer correlations on that lattice.¹¹ On the square lattice, the critical dimer correlations⁷ generate a C oulom b interaction, with monomers on the same (di erent) sublattice having equal (opposite) charges. At nite density, the monomers form a two-dimensional two-component plasm a in its D ebyescreened high-temperature phase. For both square and triangular lattice, the monomer correlations decay monotonically with increasing density, without any sign of additional new correlations on any length scale.

W e note that the study of monom er-dim erm odels goes back a long tim e^{12} However, we have not found in the literature an evaluation of the correlations studied here.

II. POCKET ALGORITHM FOR MONTE CARLO SIMULATION OF DIMER MODELS




FIG.1: Transition graphs of initial (black) and nal (gray) con gurations of the pocket algorithm presented in this paper. Left: In the presence of monomers the graph can be open; right: transition bop touching the symmetry axis. The cluster move consists in ipping the cluster - N ote that we may also ip the dimers enclosed by a bop, and that the transition graph crosses the symmetry axis at most twice.

O verlaying two hardcore dimer con gurations generates what is known as their transition graph; this graph consists of disjoint subgraphs of dimers alternating between the two con gurations { such subgraphs are shown in Fig. 1.

An open graph, as shown on the left of Fig. 1, must

A ny M onte C arlo m ove corresponds to a transition graph of the initial and nalcon gurations. The sim plest transition graphs arise from two pairs of dimers (for the square and triangular lattice) or from three (hexagonal lattice), which wind around a unit cell of the lattice. A M onte C arlo algorithm based on these local m oves can have the same convergence problems as the local sim ulation m ethods for, e.g., the ferrom agnetic Ising m odel near the C unie temperature due to critical slow ing dow n. T his problem is particularly acute for the square lattice dimerm odel, which has critical correlations. E lem entary m oves with m any participating degrees of freedom can give rise to a substantial reduction of the M onte C arlo correlation time.

Several algorithms have been proposed to locate long connected transition graphs.¹⁴ Typical problems in this context include diverging overhead (most of the time spent looking for a long loop is essentially wasted) and diminishing return (e.g. a long loop may end up invading the full system, or dynamically important moves may not be generated for su ciently large systems). The bocket algorithm 'we present here for hardcore dimers generates subgraphs from two con gurations related by a global lattice symmetry. The algorithm obtains long transition graphs with minimal overhead: on lattices of size L L, no moves need to be rejected, and any dimer encountered during the construction participates in the move. In addition, there is no need for bookkeeping.




FIG.2: D in er algorithm.a: Sym m etry axis and seed dim er (dark gray), sole initial elem ent of the set P, the 'pocket'.b: An elem ent of the pocket has been re ected with respect to the sym m etry axis (and transferred from P to A, the set of regular dim ers). It overlaps with two (dark) dim ers, which are transferred from A to P. The move construction com es to an end when P is empty.

The pocket algorithm proceeds in a series of moves, at the beginning of which we random ly pick a sym metry axis, and a seed dimer (see Fig. 2). At this initial stage of the move construction, the seed is the sole element of a set P (the 'pocket', lled with dark dimers), while all other (light gray) dimers belong to a set A. Further in the move, dimers are shu ed around between sets A and P in the following way: At each step, an arbitrary

element i of P is relected with respect to the symmetry axis, and m oved to A. If i overlaps with other elements of A (dark dimers shown in Fig. 2b), the latter are m oved from A to P. The move is completed as soon as the pocket P is empty. During the whole construction, the algorithm keeps no memory of the graph, and nal success is assured by the underlying symmetry of the lattice in combination with the hardcore property of the dimers.

The pocket algorithm is equivalent to the pivot-cluster algorithm,¹⁵ which has been applied successfully to severalhard-sphere problem s.^{16,17} It provides a greatly sim – pli ed in plem entation, as the M onte C arlo m ove is constructed without ever explicitly considering the cluster. In the speci c application of dimermodels, we also use re ections with respect to symmetry axes rather than point re ections. On the square lattice, for example, the algorithm is ergodic if we allow both diagonal and horizontal-verticalaxes. The rst choice allow s to change the num bers of horizontal/vertical dimers, the second one permits to m ove through the dimerst winding number sectors. The algorithm was tested against exact enum eration for system s up to size L = 6.

Transition graphs generated by the pocket algorithm, as shown in Fig. 1, are symmetric with respect to the symmetry axis, and cross it at most twice.

An analogous property holds in higher dimensions. For dimers on a three-dimensional lattice, for example, the appropriate operations are rejections with respect to random ly chosen symmetry planes of the (nite) lattice. A gain, any transition graph is symmetric with respect to this symmetry plane, and crosses it at most twice. This places a strong constraint on the transition graph, which cannot invade space. If we used rejection with respect to a point, as was appropriate in other applications,¹⁵ the move would conserve the total number of dimers of a given orientation, and also generate frequent transition graphs completely invading the lattice.

Transition loops generated by the algorithm allow to

ip not only the loop itself but also all the dimers inside the (gray) loop area, which is symmetric with respect to the axis (see the example in Fig. 1). This modi cation, as well as simple generalizations where the pocket is initially populated by more than one dimer, or by a specially positioned dimer, have not yet been studied. We also note that this algorithm applies to otherm odels that can be mapped onto (not necessarily nearest-neighbor) dimerm odels.¹⁸

For the undoped system on the square lattice, the pocket algorithm generates transition loops of average length proportional to L. A more detailed analysis is provided in the appendix.

III. DIMER MODELSAT FINITE MONOMER DENSITY

We now turn to the problem of the correlations of m onom ers in a background of dim ers on the square and triangular lattices. We evaluate the m onom er two-point correlation function for a range of dopings.

The monomer two-point function is dened as follows. Let Z (r) be the partition function of the monomer-dimer problem with a monomer xed at the origin and another at site r: Z (r) counts the number of allowed con gurations subject to the pair of monomers being xed. The two-point function is then dened to be proportional to Z (r): C (r) Z (r)=Z₀; the constant of proportionality, Z₀, is somewhat arbitrary. We choose to norm alize the correlations such that a random distribution of monomers would give C (r) = 1. For the two-monomer problem however, to make contact with the previous literature,⁷ we normalize the pair correlations such that (a) C (1) = 1=z and (b) list zC (r) in Tab. I, where z is the coordination of the lattice.

For the square lattice, the two-monomer correlations were obtained by Fisher and Stephenson⁷ and by Hartwig⁸ by perturbing the Pfa an matrices introduced by Kasteleyn.⁵ For the triangular lattice, there is as yet no analytic expression for the asymptotics of the monomer correlations,¹⁹ and we have obtained the exact L = 6 results by explicit enumeration.

A. The square lattice




FIG. 3: M onom er correlations along a coordinate axis: (1) pair correlations on the square lattice with L = 64. The t is to an analytic asym ptotic expression generalized to include periodic boundary conditions. Sam e-sublattice correlations vanish. (2) Fourm onom ers on a square lattice with L = 128. The low er curve corresponds to m onom ers on the sam e sublattice, the upper to m onom ers on di erent sublattices. The upper curve is again com pared to the appropriate asym ptotic function, whereas the low er curve is tted to a power-law r^{1-2} . The deviation of the upper curve from the asym ptotic expression for large r is due to screening.

To test the algorithm, rst consider two-monom ercorrelations, calculated by several authors for the square lattice. In Fig. 3 and Tab. I, we compare our data against the analytical results. Note that the t against the analytical asymptotic expression in Fig. 3 was done using a distance variable $\mathbf{r} = \sin(\mathbf{r} - \mathbf{L}) = (-\mathbf{L})$ to take into account periodic boundary conditions for a torus of length L.²¹

The t is against the analytic asymptotic expression, and in Tab. I, we show a comparison of analytical and num erical results.²⁰ The results agree to within the num erical accuracy of 10⁻³, which im proves even further for larger m onom er densities, , as the signal-to-noise ratio increases with the num ber of m onom er pairs as ². A m ore accurate estimate could be obtained by nite-size scaling.

TABLE I: M onte C arb versus exact results form onom er pair correlations, zC (r), on the square (left) and triangular (right) lattices. The norm alization here is zC (1) = 1. Even distances in the square lattice refer to sites on the adjacent row.⁷ For the simulations presented here, the statistical error is about 10 3 for both lattices.

For two monomers on opposite sublattices, the form of the correlations, C (r) = a r¹⁼² de nes an entropic C oulom b interaction between the two monomers: V (r) = $\frac{1}{2}$ log r log a . Note that whereas the pair of monomers are critically con ned { C (r) ! 0 algebraically as r ! 1 { the expectation value of their separation grows with system size: hri / L.

As the square lattice is bipartite, dimers have one end on each sublattice. This means that on a torus, there are no dimer congurations with the two monomers present on the same sublattice: in this case, C (r) 0.

The question whether there is an elective interaction of the same form is nonetheless interesting. To avoid the sublattice constraint, we have investigated four monomers on a large lattice of size L = 128. For monomers on opposite sublattices, the results are essentially unaltered from the two monomer case, at least for separations which are not too large (r L); for m onom ers on the sam e sublattice, we now obtain C (r) = $a_{+} r^{+1=2}$, so that the m onom ers on each sublattice act as if they had equal and opposite C oulom b charge.

The L-dependence of the ratio a =a₊ is xed by the fact that the square lattice is at a critical point. This allows to write the nite-size scaling ansatz C (r) = L²c(r=L), where c(x) is a function only depending on the ratio of r and L, and does not depend on L. The prefactor L² follows from the requirement that the area undemeath the curves remain xed as L! 1. W ith c (x) / x¹⁼², we obtain a =a₊ / L.A t for L = 128 and four holes gives a =a₊ L=2.

The dimension for the monomers, V (r) = $(qq^0=2) \log r$, with a sublatticedependent sign of the monomer charge q (jqj=1). It is natural to expect this C oulom b interaction to be screened if the monomer density is nite, and their correlations to be no longer critical. In fact, for a nite density, , of monomers, a new length scale arises, namely the average interparticle spacing, d 1=2.

To analyze the details of the screening analytically, we model the monomer system by a classical, continuous two-dimensional two-component plasma. With a dimensionless coupling of = 1=2 (the prefactor of the logarithm), this plasm a is located well in its high-temperature phase. This phase extends up to = 2, where the continuum approximation breaks down as the plasm a collapses in the absence of a repulsive hard core to the interaction.

In this high-temperature regime, we expect Debye screening to be operative. The resulting long-distance connected correlations have been obtained in Ref. 22 (where an expression going beyond Debye screening is given); they are

$$r - \frac{r}{2r} \exp(r - r);$$

with the D ebye screening length: $_{D} = 1 = \frac{p}{2}$, and with = to lowest order in the coupling. The choice of sign depends on the sublattice.

W ith the new length scale, $_{\rm D}$ / d, the criticality of the correlations is destroyed, although the critical behavior remains visible for r $_{\rm D}$. This is why it was possible to nd the two-particle interaction from the fourm onom er problem above.




FIG .4: M onom er correlations C for di erent m onom er densities, against the scaled distance variable r= $_{\rm D}$, for the square lattice with L = 64.

In order to determ ine whether this scenario is indeed realized for the monom er-dim er m ixture, we have plotted C (r) versus the scaled distance $r = _D$ for varying monom er densities for a system of size L = 64 (Fig. 4).

From the form of the expression for C (r), all curves should collapse on top of one another. However, for a

nite system, one has to take into account the presence of two length scales, L and $_D$, with the added feature that $_D$ < L, so that a simple one-parameter nite-size scaling ansatz no longer applies. For $_D$ L (large m onom er densities), the collapse works indeed very well.




FIG.5: M onom er correlations C against the scaled distance variable r= $_{\rm D}$ at xed m onom er density = 2=64 for square lattices of size L = 64; 128; 256.

The data do not collapse at small densities, which is a nite-size e ect: In Fig. 5, we plot the monomer correlations at a xed monomer density = $2=6\hat{4}$ for

L = 64; 128 and 256. W hereas the two-hole problem su ers from the sublattice pathology, one can see that the data for L = 128 and 256 collapse nicely for short distances, with disagreem ent arising for distances around L=2 where the periodic boundary conditions becom e im portant.

In the region where they collapse, the curves in Figs. 4 and 5 agree with the asymptotic D ebye prediction for large values of $r = _D$. At small r, the e ectively unscreened behavior is visible, leading again to a unique curve for C (r).

B. The triangular lattice

D in er correlations on the triangular lattice are known to be short-ranged,¹¹ and not critical as is the case for the square lattice.⁷ This leads one to expect that the monom er correlations will also be short-ranged as the presence of a monom er should have little e ect at a distance large com pared to the dim er correlation length.




FIG. 6: M onom er correlations C, along a coordinate axis at variable doping for a lattice of size L = 24. The abscissa is in units of lattice spacings. Correlations are normalized against a random distribution. Inset: two-m onom er correlation in a lattice of size L = 12, In both cases, the x-axis denotes separation along one of the lattice vectors. Note that the y-axis only varies by less than 15%.

We have plotted the correlations of a pair of m onom ers in the inset to Fig. 6. The correlation length indeed is so sm all that already for a triangular lattice of size L = 12, nite-size e ects are no longer detectable. This is also

shown in Tab. I.

At large' distances, the correlations tend to a constant, nonzero value of C (1) = 0:1495 0:0001. (This value is given, in keeping with the convention of the square lattice case, with a normalization such that C (1) = 1=6.) They do so with an extrem ely short correlation length, which we cannot determ ine accurately as there are only about 3 data points above the noise level. This makes it hard to t an asymptotic form, as the presence of a power-law and/or oscillatory multiplicative factor cannot be detected on this basis. From the absence of any signal for distances beyond r = 3, we conclude that the correlation length is less than one lattice spacing.

This nonzero large-distance lim it of the monom er correlation function implies that monom ers in the classical hardcore dimermodel on the triangular lattice are decon-

ned { the free energy for m onom ers a distance r apart does not diverge as r ! 1. This contrasts with the square lattice, where this quantity diverges logarithm ically.

U pon further doping, the correlations barely change (see Fig. 6); a sm all decrease of the correlations only becom es visible for a doping level of 1=8. This is not unexpected as the average m onom er spacing always remains well above the two-m onom er correlation length.

IV. CONCLUSION

We have studied the correlations of monom er-dimer mixtures on the square and triangular lattices with a new M onte C arb algorithm. The monom ers interact via the background of dimers: the critical correlations of the dimers on the square lattice give rise to a two-monom er interaction of long-range C oulom b nature, whereas the disordered triangular correlations generate an exponentially decaying one.

The triangular model is deep in its disordered phase,




FIG.7: Distribution of transition loop lengths for the square lattice with L = 64.




FIG.8: Distribution of transition loop lengths for the triangular lattice with L = 64.

where it remains in the presence of a nite density of m onom ers. The square m odel, located at a phase boundary, is driven into a disordered phase on doping. This effect is rendered analytically by m odeling the m onom ers as a two-dimensional two-component plasma, with the long-range correlations given by a simple D ebye-screened form.

Appendix

In this appendix, we analyze the distribution of transition graph lengths in the undoped dim erm odel, where only loops are generated. These loops can be of several types: disconnected pairs of loops not touching the sym m etry axis, connected loops passing through the symmetry axis, but not winding around the box, and nally those winding around the box. Each of these distributions strongly depends on the lattice and on the details of the choice of axes. The distribution of loop lengths, , generated by the pocket algorithm is shown in Fig.7 for the square lattice. W hereas the disconnected loops follow a nice power law distribution P ()_{disconnect} < L, and are always made up of an even numfor ber of dimers, the connected loops are distributed as $^{\rm 0:75}.$ For the re ection about a di-P ()_{connect} agonal, the loop lengths are always even, whereas they

are odd for the horizontal-vertical re ections that do not wind around the lattice. If a loop does wind around the box, its length can be odd or even. Notw ithstanding this intricate structure, we nd that the mean loop length grows as L , with = 1:00 0:01. On the triangular lattice, the distribution of loop lengths is also nicely split into connected and disconnected loops (see Fig. 8). There, we nd for the mean loop length = 1:47 0:02. We note that the algorithm is biased towards longer subgraphs of the transition graph of a con guration with its re ection with a factor proportional to their length.

Finally, it would be interesting to analyze the expo-

nents in more detail, in particular as the square model m aps onto a height model, 23 whereas the triangular one does not. 24
