# Granular ow down a rough inclined plane: transition between thin and thick piles

The rheology of granular particles in an inclined plane geometry is studied using molecular dynamics simulations. The ow {no- ow boundary is determined for piles of varying heights over a range of inclination angles . Three angles determine the phase diagram : r, the angle of repose, is the angle at which a owing system comes to rest; m, the maximum angle of stability, is the inclination required to induce ow in a static system; and max is the maximum angle for which stable, steady state ow is observed. In the stable ow region r < max, three ow regimes can be distinguished that depend on how close is to r: i >> r: Bagnold rheology, characterized by a mean particle velocity  $v_x$  in the direction of ow that scales as  $v_x / h^{3-2}$ , for a pile of height h, ii) > r: the slow ow regime, characterized by a linear velocity prolew ith depth, and iii)

 $_r$ : avalanche ow characterized by a slow underlying creep motion combined with occasional free surface events and large energy uctuations. We also probe the physics of the initiation and cessation of ow. The results are compared to several recent experimental studies on chute ows and suggest that dierences between measured velocity proles in these experiments may simply be a consequence of how far the system is from jamming.

### I. IN TRODUCTION

The ow properties of granular materials puzzle engineers and physicists alike. Despite numerous experimental studies of heap ows, avalanches, and chute ows, there still does not exist a general consensus on the nature of typical granular ow. Early systematic experiments in inclined plane geometries were concerned with ow rates of granularmaterial down chutes<sup>1{3</sup>, usually with smooth bases. Large regions of plug ow were observed, i.e. the whole bulk of the material slid down the plane at a velocity determined by the input mass rate and inclination angle of the chute. K inetic theories for the inclined plane problem can explain some aspects of this ow behaviour for nearly elastic particles on smooth chutes<sup>4;5</sup>. O ther studies have determined structural features in the ow in two dimensional (2D) experiments<sup>6</sup> and simulations<sup>7;8</sup>. Still, there has not been the same success in predicting ow s down rough inclines for inelastic, frictional particles.

D etailed m easuring techniques have been developed recently to capture various ow properties of granular m aterial down rough inclined planes<sup>9</sup><sup>{11</sup></sup> and in heap ow geom etries<sup>12</sup><sup>{14</sup></sup>. A ccom panying these m ore thorough experiments, further theoretical treatments have also em erged<sup>10;15 {18</sup></sup>, together with full three dimensional (3D) com puter sim ulations<sup>19 {22</sup>. D espite this grow th in literature, there appears to be a disturbing feature of these studies: reports on quantities such as velocity proles di er quite dram atically. While some reports are agreement with the pioneering results of B agnold<sup>23;24</sup>, others are not.

In 1954, Bagnold<sup>23</sup> proposed a momentum transfer picture to describe his experimental results on inertial granular ow. This simple 2D model describes the collisional process between particle layers during ow. The resulting relations

predict a shear stress that is proportional to the square of the strain-rate,

where the strain-rate is defined as the derivative of the velocity in the direction of fow (x) with respect to depth (z), \_  $@v_x(z)=@z$ . Typically, in local, New tonian, hydrodynam ic treatments of granular dynam ics<sup>17</sup>, the relationship = \_ is used, combined with the kinetic term /  $T^{1=2}$ , where is a viscosity and T is the granular temperature (to be discussed in section IIIB). Since the strain-rate is also proportional to the square root of the granular temperature \_ /  $T^{1=2}$ , Eq. 1 is then recovered. Bagnold's argument, applied to the case of bulk granular ow, is predicated on a constant density depth-profile with no-slip condition at the base. This leads to a velocity depth-profile of the form, h i

for a pile of total height h, where z is measured from the bottom of the pile. Because Bagnold scaling comes naturally from dimensional analysis in the absence of intrinsic time scales, one might expect that most studies would observe this kind of rheology. However, results depend strongly on the experimental procedure; proles of this form have only been reported in a few instances<sup>9</sup>.




FIG.1. Schem atics of experiments used to study gravity-driven, granular ows. The (a) heap ow geometry used by Lem ieux and Durian<sup>12</sup> and Kom atsu et al<sup>13</sup>, and (b) the inclined plane geometry employed by Pouliquen for chute ow studies<sup>9</sup>. Our simulations correspond closely to the Pouliquen experiments.

O ne m ethod to study gravity-driven ows is to construct a wedge-shaped static pile that evolves to produce an inclined surface close to the angle of repose of the m aterial<sup>12 {14</sup>, Fig.1(a). We term these heap ows. Here, the inclination of the surface is determ ined by m aterial properties. To study ow, m aterial is supplied via a hopper-feeder m echanism at the high end of the pile and ow is induced at the free surface. In this case, although the ow rate m ay be varied by changing the discharge rate of the hopper, the system typically ow sonly in a thin surface layer, indicated by the shaded region in Fig.1(a), which is of order 10 particles diam eters in depth. In one such experiment, Lem ieux and Durian<sup>12</sup> observed avalanche behavior for low particle ux, characterized by sporadic downstream m ovem ent at the free surface. On increasing the particle ux, a velocity pro le with depth was observed to be approximately exponential in the thin surface layer. M ore recently, utilizing a sim ilar experimental geom etry, K om atsu et al.<sup>13</sup> found that the Stationary' bulk m aterial beneath the surface ow actually undergoes very slow, creeping'm otion with a well-de ned exponential velocity pro le at longer times.

A nother m ethod uses inclined planes to study ow s and avalanches, typically with rough beds designed to reduce slip at the base, thereby avoiding plug or unstable  $ow^{19;25;26}$ . We term these chute ow s. Roughness is introduced onto the chute by gluing particles to the chute base<sup>9;11;27</sup>, or by attaching a frictional material to the base, such as the velvet cloth used by D aerr and D ouady<sup>28</sup>. Chute ow studies of two and three dimensional system s with rough bases report depth-averaged velocities with both linear<sup>10;11</sup> and non-linear dependence<sup>9;11</sup> on height. The geometry for these experiments is shown in Fig. 1 (b). The material is contained in a reservoir at one end of a plane inclined at a variable angle with respect to the horizontal. A first the gate to the reservoir is opened, material ow's down the incline. Steady ow occurs only at high enough angle; while ow's come to rest quickly on the rough bed for small inclination angles<sup>29</sup>. Increasing the gate opening leads to thicker ow's down the incline: there are no dead zones along the incline and all the material ow's down the chute. This allow's one to independently control the inclination angle and material ux of the pile, in contrast to the heap experiments.

U sing a range of inclination angles and ow depths, Pouliquer<sup>9</sup> m easured the depth-averaged ow velocity of m aterial for piles of di erent thickness. The velocity in the direction of ow scaled with height of the pile as  $y / h^{3=2}$ , which has a di erent form from the heap ow results reported by Lem ieux and D uriah<sup>2</sup> and A zanza et al.<sup>10</sup>. How ever, A noey's comprehensive experimental investigation<sup>11</sup> dem onstrated that during the course of one experiment, a range of ow behaviors is obtained that depends, am ong other parameters, on the ow rate of the material. A noey's results suggest that the di erent ow pro les observed are not necessarily in contradiction, but may be a consequence of the conditions under which the measurements are made.

In our earlier studies<sup>21,22</sup>, we simulated the rheology of dense, cohesionless, frictional spheres in inclined plane geometries. Employing periodic boundary conditions in the ow and vorticity directions, our simulations can be considered equivalent to the experimental set up in Fig. 1 (b), for an in nitely long chute far away from the material reservoir and side walls, with a continuous supply of material. Our previous study was concerned with the ow of thick piles on rough bases over a range of tilt angles where we found Bagnold scaling in stable steady ow, for a range of parameters (e.g. particle friction and inelasticity, and inclination angles).

To investigate the discrepancies between the various experimental results previously mentioned, we have extended our previous computational studies of granular dute ows to cover a wide range of pile thickness, from very thin to very thick piles, both near and far from the angle of repose  $_{\rm r}$ . We show here that even thick piles experience a crossover in behavior from B agnold rheology to linear velocity proles, and also avalanche-like ow near the angle of repose. We therefore rene our denition of stable, steady state ow : we report on three distinct steady state

ow s observed in our simulations which m atch the experimentally observed ow s reported by Lem ieux and D uriah<sup>2</sup> (avalanches), A noey<sup>11</sup> (linear velocity proles), and P ouliquen<sup>9</sup> (B agnold scaling). Our main conclusion is that the observed behavior is strongly dependent on how close the system is to jam ming or how close is to r.

In the next section we brie y describe the simulation procedure. In section III we present the results of our simulations, in particular de ning the phase space of our study and describing transitions between the ow properties of thick and thin piles both near and far from the angle of repose. We also present results for our analyses on the initiation and cessation of ow in section IV. In section V we sum marize the main conclusions of this work.

#### II. SIM ULATION PROCEDURE

Here we brie y introduce the simulation model; a thorough description of the technique is available elsewhere<sup>21,22</sup>. We model N cohesionless, frictional, and inelastic spheres of diameter d and mass mowing on a xed, rough bed of area A with a free top surface. A lthough most of our results are for monodisperse systems, we have veried that our results hold for system s with small polydispersity<sup>30</sup>.

W e em ployed a 3D contact force m odel that captures the m a jor features of granular particles: interactions between spheres are m odeled as H ertzian contacts with static friction. The implementation of the contact forces, both the norm al forces and the shear (friction) tangential forces, is essentially a reduced version of that em ployed by W alton and B raun<sup>31</sup>, developed earlier by C undall and Strack<sup>32</sup>. Norm al and tangential forces acting on particle i due to contact with particle j are given by

where  $_{ij}$  is the particle-particle overlap,  $n_{ij}$   $r_{ij}=r_{ij} = (r_i r_j)=jr_i r_jj$  is the unit norm alalong the line of centers, for particle i situated at  $r_i$  and j at  $r_j \cdot v_{n,t}$  are relative velocities in the norm aland tangential directions respectively, and  $u_{t_{ij}}$  is the elastic tangential displacement that is set to zero at the initiation of a contact.  $m_e$  is the elastic mass and  $k_{n,t}$  and  $n_{,t}$  are elastic and viscoelastic constants respectively. Thus in a gravitational eld g, the force on particle i arises from New ton's second law for the translational and rotational degrees of freedom,

and the force on particle j is determ ined from Newton's third law.

As shown in Fig. 2, we de ne ow to be parallel to the x-direction, z the height normal to the base, and y, the vorticity axis, is normal to the xz-plane. Values for the friction coe cient, and the elastic and viscoelastic coe cients (which are related to the moduli of the material) are chosen to be characteristic of real materials. For all simulations in this study we set = 0.50,  $k_n = 2$  10m g=d,  $k_t = \frac{2}{7}k_n$ ,  $n = 50^p$  g=d, and  $t = n = 2^{33}$ . The time-step  $t = 10^4$ , where = p d=g. For a millimeter sized particle 0.01s. All simulations were run for at least 1 10 t before any quantities were measured.

Figure 2 shows snapshots of owing systems where the area of the chute base A  $I_X$   $L_Y = 20d$   $10d = 200d^2$ , and we vary the total number of particles N. The xed chute bed is made from a random close packing of particles with the same diameter as those in the bulk, minicking gluing particles onto a chute base as in Ref.<sup>9</sup>, for example. In section IIIB we kept A =  $200d^2$  xed. In section IV, we used a base with dimensions A = 200d  $10d = <math>200d^2$ . We have show n<sup>22</sup> that results for thick piles are robust with respect to the dimensions of the chute base. The height of a static pile h = N=A depends on the density of the static packing , or equivalently the volume fraction

=6 (  $0.60^{22}$ ) which is de ned in the hard sphere limit (where the subscripts denote the static values). In the owing state, the actual height of the pile increases with inclination angle due to dilation elects of the ow. However,

the dependence of h, and therefore , on is weak. We nd that the computed bulk volume fractions vary over a small range,  $0.55^{<}$  < 0.60, for steady state ows for the particular parameters chosen in this pape<sup>22</sup>. Thus for the simulations h = N = 6A : for N = 5000, h 22d.




FIG.2. Con guration snapshots for system s of various sizes with a chute base of xed area  $A = 200d^2$ , that is inclined at an angle = 24 to the horizontal, where (a) N = 8000, (b) N = 6000, (c) N = 4000, and (d) N = 2000. The xed rough base is denoted by the black particles, the owing particles are grey, and the frame is a guide to the eye xed at the height h 39.6d of the N = 8000 system to provide a comparison between the di erent ow heights.

### III. R E SU LT S




FIG.3. The h phase diagram for granular chute ow, where h is the height of the pile. The lled squares are the simulation data for  $_{r}$  (h) and we indicate the ow line as a to Eq.7. The open squares are  $_{m}$  (h). Solid circles are  $_{max}$  (h), the angle at which we observe the onset of unstable ow. Route A corresponds to a path taken by keeping the angle xed and reducing the system size N, whereas Route B has N xed and decreasing inclination. These routes are discussed in section IIIB.

In our previous studies<sup>21;22</sup>, we roughly determ ined the range of parameters where steady state ow existed for chute ows, focusing mainly on steady state ow for thick piles away from r. We found that r is approximately independent of height for piles of su cient depth. In this work we perform a more thorough analysis of the entire region of the h phase space. We determ in eseveral dierent ow regimes within the stable, steady state region which are qualitatively identical to several experimental observations in inclined plane geometries, on avalanche dynam ics<sup>28;34</sup> and theology<sup>9{12</sup>. A lthough the exact location of the boundaries of the phase picture shown in Fig. 3 are dependent on speci c particle parameters, such as the friction and dam ping coe cients, the features we report here are general to system s that exhibit steady state ow.

#### A.Phase Behavior

The overall phase behaviour is determ ined by the height of the pile h and the angle of inclination , as characterised in 2D by Pouliquen and Renault<sup>29</sup>. A prominent feature of that study is the existence of a ow line, later observed in 3D experiments by Pouliquen<sup>9</sup> and also in studies of avalanches<sup>28</sup>. The ow line denes the angle of repose as a function of height of material owing r(h). One can equivalently refer to this in terms of the conjugate variable  $h_{stop}()^9$ : r(h) is the angle at which a pile of thickness h will cease to ow, and conversely,  $h_{stop}()$  gives the maximum thickness of material that will cease to ow at an inclination angle . Various theoretical treatments have also successfully predicted the existence of the ow line<sup>8</sup><sup>i35</sup>. Experimental<sup>27;28</sup> and numerical<sup>36</sup> studies have also identified distinct sub-regions within the stable ow regime of which more will be discussed below.

In order to quantify this boundary with precision for our system, we perform ed a number of simulations to generate the h phase diagram shown in Fig. 3. Initially, a static packing with a volume fraction 0:60, at =  $0^{37}$ , is tilted until ow is observed. The maximum angle of stability m is dened as the angle at which ow is initiated and largely depends on construction history of the initial static packing, such as the roughness of the supporting bed and the packing fraction of the initial con guration<sup>38</sup>. The angle of repose r is dened as the inclination angle at which the system subsequently jams and ow ceases upon reducing back down.

Our initial packing was generated by taking a owing system and gradually reducing the inclination down to 0 and then allowing the system to relax until it became completely static. Experimental studies on avalanches have shown that m can uctuate over a range of 3 4 for di erent packings with the same height because of construction history e ects<sup>7</sup>.

We have also observed avalanche-like dynamics in our simulations. We characterise avalanches as distinct from regular or continuous ow by observing the time evolution of bulk quantities of the system such as bulk kinetic energy or stress. For continuous ow, the stress or bulk energy will uctuate about a well-de ned mean value, with

uctuations typically less than 10% of the mean. In the case of avalanches, the stress and energy uctuate about a mean value with 0 (1) uctuations, indicative of sporadic ow that mainly occurs at the free surface. We also checked any possible system size dependence. To compare with our smaller system s, we studied a system with N = 32000 and A = 80d 40d (i.e. approximately 10d high on a base with an area four times our standard system size). We again observed avalanche-like behaviour for the big system, although we cannot rule out that in the limit of in nite system size, avalanches might not be observed.

From our extensive study, we were able to determ ine the following general features of w dwn inclined planes: there are three principal regions, corresponding to no w, stable w, and unstable w. For a pile of given thickness h, and xed m icroscopic interaction parameters, these three regions are separated by two angles: r, the angle of repose, and  $m_{ax}$ , the maximum angle for which we observe stable w.

- No ow < r: the system does not ow. Starting from = 0, an inclination of = m > r is required to initiate ow. As m is approached, a few particles at the free surface rearrange and tumble short distances before coming to rest, but this does not lead to bulk motion or  $ow^{39}$ . r is the angle at which ow ceases on reducing the inclination from a owing state it is the lowest angle at which ow is observed and depends on material properties (friction and inelasticity)<sup>40</sup>, as well as the roughness of the supporting bed.
- Stable ow  $r < m_{ax}$ : bulk ow is observed (after ow is initiated). The bulk averaged kinetic energy of the system is constant with time and the entire pile is seen to be in motion while no slip is observed at the bottom with these rough boundary conditions. The stable ow region can be divided into the following three regimes:
  - Continuous ow I >> r: away from the ow line, the rheology is well approximated by Bagnold scaling, Eqs. (1) and (2).
  - Continuous ow II  $_{r}$  <  $_{m}$  : close to the ow line, the rheology is not Bagnold-like, rather the velocity pro le is better approximated by a linear relationship with depth v(z) / z. The upper boundary  $_{m}$  is also seen in experimental studies of avalanches and dimentiates between dimentiates ow mechanisms, depending on whether one is above or below  $_{m}$ <sup>28</sup>.
  - A valanching ow r: Very close to the angle of repose, but just above it, regular continuous ow is not observed, rather in this regime, steady state involves slow, underlying creep motion of the entire pile combined with sporadic free surface motion down the incline. In the vicinity of r, extrem ely large energy uctuations are observed<sup>1</sup>.
- Unstable ow  $> m_{ax}$ : the development of a shear thinning layer at the bottom of the pile results in lift-o and unstable acceleration of the entire pile.  $m_{ax}$  becomes approximately constant for h > 10d.

The ow descriptions above capture the principal observations of several dimensions experiments of gravity-driven ow  $\hat{S}^{j,1;12;28}$ . In particular, the transition from no ow to avalanche ow at  $_{r}$  is similar to the observations

reported by Lem ieux and Durian<sup>12</sup> for low material ux. The transition from avalanches to our continuous ow II regime appears to resemble the observations reported by Daerr and Douady<sup>28</sup> of avalanche studies for  $_r < < _m$ . Sim ilar observations have been reported for rotating cylinder experiments<sup>42</sup>.

Pouliquen<sup>9</sup>, later veried by Daerr and Douad $y^{28}$ , characterized the ow line – the dividing line between no ow and ow. Using an empirical argument, Pouliquen suggested the following relation:

where  $_1$  is the angle at which  $_r$  becomes independent of depth,  $_2$  is the largest value of  $_r$ , and 1 is a characteristic length scale. In Fig. 3 we t Eq. 7 to our simulation points and obtained the following tting parameters;  $_1 =$ 19:60 (19:55),  $_2 = 28:50$  (27:75), and 1 8:5d, where the values in parentheses are the data points from the simulations. Our simulations not only predict the phase behavior of chute ows, but also capture the subtle features emerging in recent experiments. In the following sections we present various depth proles of density, velocity, and stress to better quantify the transitions between thin and thick piles.

#### B.Depth Pro les

We computed depth proles as a function of z for the packing fraction , velocity in the direction of  $w_{x}$ , strain-rate \_, shear stress  $x_z$ , and granular temperature T (see de nition below), for a range of system sizes and inclination angles. Since our simulations employ periodic boundary conditions in the plane perpendicular to height, our simulations are not in uenced by the elects of side walls and are therefore equivalent to measurements made along the centre line of a real chute  $w_x$ , away from the edges. It has been recognised that proles taken at the side walls are signilized to a real chute from those made along the centre line  $line^{\frac{1}{2}/20}$ .

Because of the dependence of r on h, we approached r in two ways: xing the inclination angle of the chute and observing ow in system s of di erent heights until ow ceased for a pile of height  $A_{op}$  () (route A). A Itematively, we held N xed and reduced the inclination angle of a owing state down to r (h) (route B).




FIG.4. Depth proles of the packing fraction , for systems of various size N, varying in heights from h 40d to 5d for = 24 : route A in Fig.3.

R oute A : Figures 4-7 show various bulk proles for route A, that is, system s at a xed inclination angle of = 24 but of varying sizes, N = 8000; 5000; 3000; 2000; 1000. The density proles in Fig. 4 exhibit a constant density region throughout the bulk of the material which is a familiar observation for thicker system  $s^{22}$ .




FIG.5. Depth proles of the velocity in the direction of ow (top panel) and the corresponding strain-rate (bottom panel), each normalized by their maximum value, for various system sizes for = 24. Note the depth is normalized by the respective height for clarity. Legend as in Fig.4.

The ow velocity  $\chi$  and strain-rate \_ pro les shown in Fig. 5 are for the same systems reported in Fig. 4. For m oderate to thick piles, h > 15d, the velocities and corresponding strain-rates scale with height. However, for h < 15d, there are signi cant di erences. The velocity pro les, top panel in Fig. 5, for the thinner piles at rst become more linear with depth, then ultimately have a curvature opposite to that of the thicker piles. This gradient transform ation is more apparent from the strain-rate curves (bottom panel Fig. 5): for thicker piles \_ decreases from the chute base tow and the free surface of the owing pile, whereas in thinner piles there is a range of system sizes where \_ constant throughout the pile, leading to a linear velocity pro le. For thinner system s still, \_ increases near the free surface.

In this work, we de ne the \granular tem perature" T to be the averaged velocity uctuations about the m ean bulk ow velocity at that height, T  $h^2 i h^2 i h^2$ . The tem perature in the ow direction is de ned as  $T = h^2 i h^2$

although the data for thinner piles is considerably noisier.




FIG.6. Pro le of the granular temperature  $T_x = T_x^{max}$ , in the direction of ow as a function of z for various system sizes for = 24. Legend as in Fig.4.




FIG.7. Rheology data for various system sizes for  $= 24 : v_x \cdot v_z$ . Legend as in Fig.4.

Similarly, the rheology plot in Fig. 7 shows that thicker piles display Bagnold rheology: xz / 2, but there is a transition away from this as the piles become thinner. For thin piles,  $5 < \frac{h}{d} < 15$ , the strain rate is approximately constant away from the free surface and the chute base. For the thinnest piles h 5d, the strain rate decreases with shear stress. This may come about from competing length scales in the system, i.e. the thickness of the ow determ ines the separation between the top free surface and the chute base. Some theoretical treatments based on these considerations have been used to explain the di erences between observed velocity pro les in owing piles.




FIG.8. Depth proles of the packing fraction , for a system with a xed number of particles, N = 6000, over a range of inclination angles, route B in Fig.3.

R oute B : Figures 8-11 show depth pro les for a system taken along route B in Fig. 3. These are for a system of xed size N = 6000, where we vary the inclination angle down toward r. In Fig. 8 the density pro les for the system N = 6000 are shown for a range of inclination angles = 25;23;22;21;20. We see the constant density region, where the bulk density decreases with increasing angle due to dilatancy e ects. However, there are no qualitative di erences between the behaviour at di erent angles.

For the velocity and strain-rate pro les shown in Fig. 9, di erences do emerge, and these di erences m in ic the behavior observed along route A.Away from the ow line, the velocity pro les scale as Eq. 2, whereas for system s at low er angles the velocity pro les change to linear. \_ changes likew ise as does the granular temperature (shown in

Fig.10).




FIG.9. Pro les for the velocity in the direction of ow  $v_x$  (top panel) and the corresponding strain-rate \_ (bottom panel), each normalized by their respective maximum values, for a system with a xed number of particles, N = 6000, over a range of inclination angles inclination angle. The height is normalized by the system size. Legend as in Fig.8.




FIG.10. Pro le of the x-component of the granular temperature  $T_x = T_x^{max}$  for a system with a xed number of particles, N = 6000, over a range of inclination angles. Legend as in Fig.8.




FIG.11. Rheology data for a system with a xed number of particles N = 6000, over a range of inclination angles: \_\_\_\_\_\_ norm alized by (\_\_\_\_\_\_\_r) vs. xz. Legend as in Fig. 8.

In Fig. 11 we plot the rheology curves for the di erent angles. We have rescaled \_ by  $(_r)$ , for convenience. We not that for system s with  $(_r)^{>}$  1:0, the rheology plots scale well. However, for the system that is closest to  $_r$ , the ow behavior is very di erent, though similar to the di erences observed along R oute A.

Therefore the two routes A and B indicated in Fig. 3 o er complem entary paths to similar states. Because of the very nature of the dependence of r on h, the ow properties of systems at di erent angles and di erent heights show similarities provided they are taken equivalently close to r.

### C.Velocity Scaling

Pouliquen<sup>9</sup> showed that ows of thick and thin piles approximately obey a simple scaling relation. Nondimensionalizing v, the velocity measured along the centre line at the top of the owing pile by  $p \overline{gh}$ , where g is the acceleration due to gravity and h is the measured height of the pile, one obtains the Froude number Fr  $v = p \overline{gh}$ . By plotting the Froude number against  $h=h_{stop}$ , where  $h_{stop}$  () is the height of a pile at which a system owing at an angle would stop, Pouliquen was able to collapse his full data set of systems with di erent particle size and properties. Pouliquen proposed the simple scaling relation,

$$\frac{\mathbf{p}}{\mathbf{gh}} = \frac{\mathbf{h}}{\mathbf{h}_{\mathrm{stop}}}$$
(9)

where the coe cient was to the experimental data, resulting in an apparently universal value, exp = 0.136.




FIG.12. Froude num ber  $v = \frac{p}{gh}$  as a function of  $h = h_{stop}$  for di event inclinations. A measure of the slope gives sim = 0.147, compared with Pouliquen's experimental determination of exp = 0.136.

The quantity  $h_{stop}$  encodes details of the particle roughness, the base roughness and all other intrinsic properties of a particular system . A coordingly, one need only measure  $h_{stop}$  of the system in question to determ ine the ow properties. In a similar vein, in Fig. 12 we plot the ow velocity, taken from the top of the owing pile, non-dimensionalised by  $p = \frac{1}{gh}$  for each height h against h=h\_{stop}. The data agrees well with a linear relation, giving a coe cient sim = 0.147, which is in good agreement with the experimental result determined by Pouliquen<sup>9</sup>, exp = 0.136.

The scaling relation Eq. 9 although simple, appears to be quite robust. Pouliquen<sup>43</sup> and also Andreotti et al.<sup>44</sup>, have taken Eqs. 9 and 7 to predict phase behaviour and ow properties. Their resulting analyses of granular fronts captures m any of the m ain features of granular ows. However, as yet, there is no underlying explanation for these seem ingly simple relationships.

#### IV . IN IT IAT ION AND CESSATION OF FLOW

We have also studied the initiation and cessation of ow, something di cult to probe experimentally. For these studies we used large system s,  $A = 200d 10d = 2000d^2$  and h = 50d, providing better resolution for these processes. In addition, any size elects due to thin samples do not complicate our observations.

We have previously studied initiation of ow from a crystalline static state in 2D<sup>22</sup>. A fler such a system is tilted, a disordering front propagates upwards from the bottom of the pile, melting the ordered structure, until the entire pile is disordered and ows in its steady state form. A lthough the starting state in 3D need not be ordered, we nd that ow initiation in 3D also undergoes a similar bottom -up process.

In itiation was studied for a disordered, static packing of our larger system that was tilted from = 0 to 24. See Fig. 13. At the instant of ow initiation, the system slips at the bottom boundary and begins to ow as a plug as indicated in Fig. 13 (a). Particles closest to the base undergo collisional motion with the xed bed leading to the creation of a granular temperature front, as shown in Fig. 13 (b). This therm alization front propagates up the pile, disrupting the plug region. A fler the original initiation slippage, the slip region disappears and the velocity pro le appears approximately linear with height, with a crossover to the plug region. A fler the plug phase melts, the system dilates slightly, leading to a velocity pro le of the Bagnold steady state form.




FIG.13. Initiation of ow: time evolution of the depth proles of, (a) the velocity in the direction of ow and (b) the granular temperature in the direction of ow, at the initiation of ow for a static state (h 50d), initially at = 0, that is tilted to 24. Initial failure occurs near the base, the pile then \heats up" from the bottom of the pile, a therm alization front propagates up the pile with time, disrupting the plug ow above it. The lowest curve starts at t = 025 after the system is rst tilted, and we plot curves for t = 0.50; 1; 2; 3, and 4 respectively.

C essation was observed for a system that was initially in steady state ow at = 24, as the inclination angle was reduced to = 18, which is below r. See Fig. 14. Although it may seem intuitive to expect an exact reversal of the initiation process, this is not observed. A fler is reduced to below the angle of repose, particles at the bottom of the pile, which have the sm allest velocities, come to rest rst becom ing trapped by the rough base. The frozen layer then serves to trap the slow ly moving particles above it. This trapping front propagates up the pile towards the free surface, as indicated in Fig. 14 (a). A consequence of this is that the granular tem perature cools from the chute base as the whole system gradually comes to rest. We note the emergence of a thin salitating region at the free surface during the cooling process.




FIG.14. Cessation of ow: time evolution of the depth proles of, (a) the velocity in the direction of ow and (b) the granular temperature in the direction of ow, for the cessation of ow of a system with h 50d. Initially in steady state ow with = 24, the inclination angle is then reduced to 18 < r leading to the gradual stopping of ow into a jammed state. Particles moving slowest at the base stop owing rst, leading to a freezing front that propagates up the pile. The top curve is taken at a time 100 after the angle is rst reduced to below the angle of repose, and subsequent curves are separated by 10 later.

During this trapping process the pile exhibits two distinct behaviors separated by the trapping front. Below the trapping front, the particles are frozen into a pack, whereas above the trapping front, particles continue to ow. As the trapping front m oves up the pile, the depth of the owing section continuously shrinks with time. As shown in Fig. 14 (a), this leads to a bulk velocity prole that consequently transforms from Bagnold-like ow to linear with depth until ow ceases. Essentially, ow cessation is a transient version of route B in Fig. 3 for ow at one angle over a range of ow heights.

A nother feature of ow transitions is in understanding the stress response of the system upon initiation and cessation of ow . Classical treatments of granular media<sup>45</sup> dem and that failure will only occur if the ratio of the shear stress to the normal stress equals the tangent of the angle of repose,

$$xz = zz \tan r$$
 (10)




FIG.15. Ratio of the shear stress to the normal stress  $x_z = z_z$  as a function of the tangent of the angle of inclination for initiation of ow (squares) and cessation of ow (circles). The open symbols correspond to static states and the led symbols are owing. The lines indicate the positions of  $r_{rm}$ . The stress ratio is linear with tan , but ow will not occur unless the stress ratio remains above tan r in the case of a system already owing, or exceeds tan m for initiation of ow.

However, Eq. 10 needs to be modi ed to take into account the history dependence of the starting point of ow for

initiation at  $_{m}$ , and the general stopping point of ow for essation at  $_{r}$ . In Fig. 15 the stress ratio  $_{xz} = _{zz}$  is plotted as a function of inclination angle for initiation of ow (circles) and cessation of ow (squares). We see that  $_{xz} = _{zz}$ is linear with tan . Still, to observe ow from initiation, the stress ratio must exceed tan  $_{m}$ , or for ow to cease its value must be reduced to below tan  $_{r}$ . In other words, the shear stress can have a non-zero value and remain static as long as the stress ratio is sm aller than the tangent of  $_{r}$  or  $_{m}$ . The particular stress state of the static system is very much history dependent and com es about from the imposed conditions at the instant the system became static<sup>41</sup>.

### V.CONCLUSIONS

We have performed a systematic simulation study of inclined plane, gravity-driven ow of granular materials, elucidating the reasons behind the discrepancies that exist between several dierent experimental procedures. These arise as a consequence of how far the system is from jamming, or how close the inclination angle of the pile is from the angle of repose.

We have accurately determined the ow phase diagram for a system with a particular interaction parameter set, indicating the height dependence of the angle of repose and the maximum angle of stability. We have also determined the boundary between steady state and unstable ow and nd that the maximum angle for steady state ow also exhibits height dependence. This suggests the existence of an intrinsic length scale in granular ows and form s part of our work in progress.

For thick enough piles owing on a rough inclined plane, say  $h^{>}$  20d, the velocity profiles and rheology follow B agnold scaling. As one reduces the height of the for owing pile, a continuous transition from B agnold rheology to linear velocity profiles through to avalanche-like dynamics occurs, until finally, one reaches the angle of repose r, and

ow ceases. As a result, one can obtain various velocity proles and ow behaviors not only through changing the height of the owing pile, but also by varying the inclination angle of the chute, such that there is an overlap region

where one can obtain similar ow properties through either procedure. These features can be used in surface ow treatments<sup>46;47</sup> to better predict the evolution of an avalanche surface.

O ur investigation on the initiation and cessation of ow shows that the initiation process starts from failure at the base that results in a \heat" front that propagates up the pile. Upon cessation of ow, an elective freezing front propagates up the pile with particles becoming trapped in the frozen layer until the whole system comes to rest. In some cases, ow initiation or cessation only occurred after many time units (approximately equivalent to 20 seconds for a 1mm sized particle). A consequence of these indings is that experimental reports of various ow behaviour in owing piles may also be due to the time window of observation. In general, we have captured all the major observations from experiment, including quantitative agreement of the scaling parameter , Eq. 9, from Pouliquen's empirical theory<sup>9</sup>.
