Therm odynam ical Study on the Heavy-Ferm ion Superconductor PrO s₄Sb₁₂: Evidence for Field-Induced Phase Transition

We report measurements of low-tem perature speci c heat on the $4\vec{f}$ -based heavy-ferm ion superconductor PrOs₄Sb₁₂. In magnetic elds above 4.5 T in the normal state, distinct anomalies are found which demonstrate the existence of a eld-induced ordered phase (FIOP). The Prnuclear speci c heat indicates an enhancement of the 4f magnetic moment in the FIOP. U tilizing a Maxwell relation, we conclude that anomalous entropy, which is expected for a single-site quadrupole K ondo model, is not concealed below 0.16 K in zero eld. We also discuss two possible interpretations of the Schottky-like anomaly at 3 K, i.e., a crystalline- eld excitation or a hybridization gap form ation.

The f-electron-related heavy ferm ion (HF) system s exhibiting superconductivity had been found only in C e and U interm etallic compounds. Therefore, the recent observation of the rst P r-based heavy ferm ion superconductivity (HFSC) in a led skutterudite PrO s Sb₁₂ [1] has profound scienti c signi cance.

The $4f^2$ conguration of Prions in intermetallic compounds had been considered to be quite stable in view of no observation of strongly correlated electron behaviors until recent studies on PrInAg₂ [2] and PrFe₄P₁₂ [3{5], in which this picture breaks down. In PrFe₄P₁₂, which is also a member of the led skutterudites, we have shown by speci cheat [3], electrical resistivity [4] and de Haasvan A lphen (dHvA) elect measurements [5] that HF behaviors appear in high elds where a nonmagnetic ordered state, probably of quadrupole origin, is suppressed. To our know ledge, $PrFe_4P_{12}$ is the only system in which such de nitive evidence for the $4f^2$ -based Fermi-liquid HF ground state has been obtained.

Compelling evidence for the HFSC in PrOs₄Sb₁₂ was given by a large speci cheat jum p $C=T = 0.5 J/K^2 m ol$ at $T_c = 1.85$ K on a pellet of com pressed pow dered single crystals [1]. The jum p is superim posed on a Schottky-like anom aly appearing at 3K.Bauer et al. attributed this peak to a doublet-triplet ($_3$ $_5$ in O_h-type notation) crystalline-electric- eld (CEF) therm al excitation, com bining with theirm agnetic susceptibility (T) and inelastic neutron scattering data. Since the 3 non-K ram ers doublet ground state has quadrupole degrees of freedom, they pointed out a possibility that the HF behavior is associated with a quadrupolar Kondo e ect [6] on the Pr-ion lattice. In order to con m this scenario, it is essentially in portant to clarify how the entropy R ln 2 associated with the 3 ground state is released and whether any residual entropy is hidden far below T_c or not.

In this letter, we report two important ndings in $PrOs_4Sb_{12}$ based on speci c heat and magnetization measurements on high-quality single crystalline samples: (1) clear evidence for the existence of a eld-induced ordered phase (FIOP) and (2) a con relation of no anomalous entropy concealed below 0.16 K in zero eld.

Single crystals of the led skutterudite P rO s_1 Sb₁₂ and

the reference compound LaOs4Sb12 were grown by Sbux method [7]. The raw materials were 4N (99.99% pure)-Pr, 4N-La, 3N-Os and 6N-Sb. No impurity phase was detected in a powder x-ray di raction pattern. The lattice parameter was determined to be a = 9.301 A for $PrOs_4Sb_{12}$ and a= 9.306 A for LaOs₄Sb₁₂. The observation of the dHvA oscillations in both compounds [7] ensures high-quality of the sam ples. The electrical resistivity (T) for PrOs₄Sb₁₂ shows qualitatively the same behavior as reported in ref. [1]. No K ondo-like behavior is visible in (I) although we cannot conclude whether any such behavior exists or not in the sm all 4f-electron contribution $_{4f}$ (T) estimated by subtracting (T) of LaO s4Sb12. Speci c heat C (H;T) for H k h100i was measured by a quasiadiabatic heat pulse method described in ref. [8] using a dilution refrigerator equipped with an 8-T superconducting magnet. The temperature increment caused by each heat pulse is controlled to be 2%. The bulk magnetization M ($_{0}$ H 7 T;T 1:9 K) wasmeasured with a Quantum -Design superconducting quantum -interference device (SQUID) magnetom eter.




FIG.1. Speci cheat C (T) of PrO SD_{12} in di erent magnetic elds. The broken curve represents the phonon part C_{ph}(T) determined from the C (T) data of LaO S_4SD_{12} .

Figure 1 shows the C-vs-T data for H k h100i. In zero eld, the data exhibit a Schottky-like anom aly with a maximum of 6.82 J/Km ol at 3.1 K, clearly showing the existence of a low -lying excitation in the f-electron system. In a C=T vs T plot (not shown), the peak appears at 2.1 K with a height of 2.8 J/K²m ol, which is 39 % larger than the value reported in ref. [1] for the compressed powdered single crystals, although the overall temperature dependence is similar. In our data, a jump of C=T = 0.52 J/K² m ol associated with the SC transition is observed at T_c = 1.81 K. D etails on the SC properties will be reported elsewhere [9].

As Fig. 1 reveals, the anomaly at 3 K is found to be drastically suppressed with increasing magnetic eld. This eld-sensitive behavior con m s that the low -lying excitation has a magnetic character. In 5 T, a kink appears at 0:7 K and changes the shape into a clear -type peak at $T_{\rm x}$ = 0:98 K in 6 T.W ith further increasing eld, the peak in the C (T) curve grows and $T_{\rm x}$ shifts to higher tem peratures. This is the clear therm odynam –




FIG.2. Magnetic eld vs tem perature phase diagram . The superconducting boundary is the data from ref. $[\!\! 1]$

ical evidence for the existence of a eld-induced ordered phase (FIDP) in T < T_x . The eld variation of T_x is plotted in a H -vs-T phase diagram of Fig.2.

To estimate the phonon contribution to the speci c heat, $C_{\rm ph}$, we measured C (T) of a single crystal LaO s_4Sb_{12} . The obtained $C_{\rm ph}$ (T) is shown in Fig. 1. Negligibly sm all and sm oothly-increasing $C_{\rm ph}$ below 4 K strongly indicates that 4f electrons play essential roles in both the Schottky-like anom aly at 3 K and the FIDP below T_x in PrO s_4Sb_{12} .

An uptum in C (T) below 0.5 K developing with magnetic eld is due to the nuclear Schottky contribution (C_n) . The observed C_n ism ostly caused by Prnuclei (nuclear spin I = 5=2 for 141 Prwith the natural abundance of 100%) because of the strong intrasite hyper ne coupling between the nucleus and 4f-electrons on the same




FIG.3. Magnetic eld dependence of estimated $A_n^{1=2}$ in the nuclear speci c heat $C_n = A_n = T^2$. (C T^2)¹⁼² at T = 0.2 K is also shown to provide an upper bound for $A_n^{1=2}$. The lines are guides to the eye.

Prion. This feature allows one to use C_n as an on-site probe for the Pr4f m agnetic moment; utilizing this, we have demonstrated that the ordered state in PrFe₄P₁₂ appearing below 6.5 K is non-magnetic in origin [3]. We analyze the C_n data to obtain information on the 4f magnetic moment of Prions in PrOs₄Sb₁₂, although the situation is complicated compared to PrFe₄P₁₂ because of a non-negligible Sb nuclear contribution. In order to separate C_n from C, we tentatively assume

$$C (T) = A_n = T^2 + T + T^n$$

at low temperatures. In eq. (1), the rst term represents C_n (the sum of all the nuclear contributions in $P rO s_4 Sb_{12}$) and the other two terms represent the lowtem perature excitation in C_e(T). The eld dependence of $A_n^{1=2}$ obtained by thing below 0.6 K is shown in Fig. 3. To show an upper bound for $A_n^{1\!=\!2}$ based on eq. (1), $(CT^2)^{1=2}$ at T = 0.2 K is also plotted. The observed zero- eld-value of $A_n^{1=2} = 2.9 \quad 10^{-2} \text{ [JK /m ol]}^{1=2}$ is attributable to the Sb nuclei quadrupole contribution 2:87 10 2 [JK /m ol]¹⁼², which is calculated from recent ^{121;123}SbNQR m easurem ents [10]. W ith increasing m agnetic eld, $A_n^{1=2}$ increases gradually and shows a slight upward curvature around the boundary of the FIOP.At the upper critical eld $_0H_{c2} = 22$ T, no anom aly can be seen. The eld-dependent part in the $A_n^{1=2}$ vs H curve is mostly due to the magnetic Prnuclear contribution; the magnetic contribution from 0s and Sb nuclei gives only

1% of the observed $% A_{n}$ eld dependence. This contribution to A_{n} can be expressed by

where R, A_{hf} , m_{Pr} and g_J are the gas constant, the magnetic dipole hyper ne coupling constant, the




FIG.4. Electronic part of entropy $S_e(T)$ calculated integrating $C_e(T)=T$ data. Slight adjustment has been made for the data of H \notin 0 so that the Maxwell relation $(@S=@(_0H))_T = (@M=@T)_{_0H}$ is satis ed; see text for the details.

site-averaged magnitude of the Pr magnetic moment $g_J (j_J J_z i f)^{1=2}$ and the Lande g-factor, respectively. Therefore, the eld-dependent part of $A_n^{1=2}$ in Fig. 3 reects the m_{Pr} vs H curve. U sing $A_{hf} = 0.052$ K, which was determined for PrFe₄P₁₂ [3] and is consistent with theoretical calculations [11,12], the experimental value $A_n^{Pr} = 0.105$ JK/m ol for $_0H = 8$ T leads to an estimation $m_{Pr} = 1.01$ B/Pr in this eld. The uptum at

4:5 T in $A_n^{1=2}$ (H) compared to a sm ooth extrapolation from the lower elds indicates that m_{Pr} (and probably also M) is enhanced in FIOP.

An enhancement of M in the FIOP is expected independently from the Ehrenfest's theorem :

which should be satis ed at the second-order phase boundary of the FID P. Since $dT_x = dH$ is positive in the m easured eld range as shown in Fig. 2, (@M = @T)_H should be negative; this feature was actually observed in a recent low-tem perature m agnetization study [13]. For $_0H = 6$ T, (@M = @T)_H ' 0:04 _B/PrK is calculated.

We obtained the temperature dependence of the electronic part of entropy $S_e(T)$ by numerically integrating the data of $C_e=T$ (C C_n $C_{ph})=T$ vs T. Since our measurements are made above 0.16 K, only $S_e(T)$ $S_e(T)$ $S_e(0.16 K)$ can be obtained from the present study. Therefore, we tentatively plot $S_e(T)$ in Fig. 4 putting $S_e(0.16 K) = 0$ for each magnetic eld; if $C_e=T$ 0.047 J/K²m ol at 0.16 K in zero eld continues down to T = 0, an error caused by this assumption would be $S_e(0.16 K)$ $S_e(T = 0) = 7$ 10 ³ J/K m ol, which is negligibly small. As a next step, the $S_e(T)$ curves for $_0H \neq 0$ T are vertically shifted so that the M axwell




FIG.5. M agnetization divided by applied m agnetic eld as a function of tem perature. The inset shows the tem perature dependence of inverse m agnetic susceptibility.

relation:

$$(@S_e = @(_0H))_T = (@M = @T)_{0H}$$

is consistently satis ed at 5 K by both the S_e and M data shown in Fig.5. The maximum shift of S_e required for the adjustment is 0.02 J/K mol, which is invisible in Fig. 4. Two S_e (T) curves for adjacent magnetic elds in Fig. 4 cross at a temperature (3 3.5 K), which coincides with the maximum temperature of the corresponding M =H vs T curve shown in Fig.5, demonstrating the consistency of the present data with eq. (4). We also con med that results of magnetocaloric e ect measurements are consistent with the S_e data shown in Fig.4.

There are two possible interpretations for the Schottky-like anomaly appearing at 3 K: (1) a CEF excitation superimposed on a moderately mass-enhanced quasiparticle excitation, or (2) a strongly energy-dependent quasiparticle excitation itself. In the case (1), is of the order of 10 1 J/K²m ol and C = T_c is not far from the BCS value, while in the case (2), (T) has a strong temperature dependence and C = (T_c)T_c ' 0:1 is quite sm aller than the BCS value.

In the case (1), the maxim a at 3 3.5 K in the M =H - vs-T curves as well as the eld-sensitive behavior of the Schottky peak indicate that the CEF rst excited state lying at $E_1=k_B$ 8 K is magnetic. In the CEF model proposed by Baueretal. [1], where the $_3$ $_5$ excitation leads to the Schottky peak in C (T) at 3 K, an entropy of R ln 2 associated with the $_3$ ground state should be hidden below 0.16 K in zero eld, if it is assumed that 4f electrons are well localized. Since applying magnetic

eld should cause a sm all but detectable splitting of the $_3$ doublet (e.g. an energy splitting E = 1.5 K in 4 T is calculated using the CEF parameters of x = 0.72 and W = 5.44 K from ref. [1]), a new low -T peak would appear in C (T) and thereby the hidden entropy would be released, i.e., $S_e (0 \text{ T}) = S_e (4 \text{ T})' \text{ R} \ln 2$ at 0.16 K.Our

 S_e data shown in Fig. 4 are clearly against this scenario, and we conclude that no anom alous entropy is concealed below 0.16 K in zero eld. [14]

If a 1 singlet is the CEF ground state, the rst excited state should be a magnetic triplet $_5$ ($_4$ in T_h notation [15]). Observed anisotropy in M , i.e., M (H ==h110i) ' M (H ==h111i) = 1:110 $_{\rm B}$ =Pr > M (H == h100i) = 1:095 _B = Prat 1.9 K in 7 T, asserts the $_{1}$ $_{5}$ level scheme (see Fig. 7 of ref. [3] for a calculation of M for a single-site Prion), although the absence of clear dow nw ard curvature in M (H) curves for all the three eld directions (see Fig. 5 for H == h100i) is not in agreem ent with the simple CEF predictions not only for 5 but also for the 3 $_5$ level schemes. The the 1 $_{\rm 5}$ level scheme is consistent with the fact that $\rm S_{e}$ 1 is lower than R ln 4 at 8 K and increasing gradually. The maximum value of C at 3 K is smaller than 8.51 J/K mol expected for the singlet-triplet Schottky peak, [16] indicating that the triplet excited state has a energy dispersion due to Pr-Prm agnetic interactions.

The FIOP appears in the eld region where one level out of the 5 triplet goes down due to the Zeem an e ect and e ectively degenerates with the ground state. A ctually, Se shown in Fig. 4 increases with increasing eld 3 K and seems to show a tendency of saturabelow tion (plateau) at R ln 2 when the FIOP is fully developed in elds above 8 T. Therefore the form ation of the FIOP probably needs the degree of freedom possessed by the quasi-degenerate doublet form ed in the high elds. W e speculate that the order parameter is of an antiferroquadrupole accompanied by a eld-induced antiferrom agnetism (AFM), as observed in CeB_6 [17,18] and Tm Te [19,20]. In these com pounds, the quadrupole ordering tem perature shifts to higher tem peratures with increasing eld. In PrOsSb₁₂, the negative Curie-W eiss tem perature _{CW} = 6:6 K determined below 20 K as shown in the inset of Fig. 5 indicates the existence of AFM correlations. Therefore, by eld-induced AFM components, the FIOP could be energetically stabilized leading to $dT_x = dH > 0$. Note that prelim inary data of d =dT indicate that dT_x =dH changes to negative above 10 T [7], as similarly observed in both CeB_6 and Tm Te.

In the case (2), the Schottky-like peak in C_e(T), sim – ilar to the one observed at 7 K in CeN iSn [21], im – plies the existence of a hybridization gap in the energy spectrum of the renorm alized quasiparticle excitations in PrOs₄Sb₁₂ [22]. From the C_e(T) data, the size of the gap is roughly estimated to be $_{\rm K}$ =k_B 8 K, which is four times larger than T_c. This fact suggests that the superconductivity appears in the temperature region where the gap structure is well developed. Figure 1 clearly shows that the gap structure is sensitive to magnetic eld and is destroyed above 5 T. In these elds, the quasiparticle density of states at the Ferm ienergy increases and consequently developed RKKY-type AFM interactions would help to form the FID P.

For a clear distinction between the cases (1) and (2), no decisive experimental facts are available at this stage. However, this point should be claried to understand the rst $4f^2$ -based HFSC in PrOs₄Sb₁₂.

Note added.-The e ect of the deviation from the T 2 -dependence of the Pr nuclear contribution becomes nonnegligible in high elds (e.g., see Fig. 1 in Ref. 23). If one follow the analysis described in Ref. 3, m_{Pr} = 1:15 _B/Pr is obtained in 8 T.N ote that the long heat pulse (1 min), the longtime T-response measurement (> 10 min) and our data tting procedure fully dealing with the tau-2 e ect caused by long nuclear-spin-lattice-relaxation times allow us the precise measurements of the nuclear contribution. A fler completion of this paper, we became e aw are of the result of M aple et al. who observed anom aly in corresponding to the FID P. [24]
