Multifractal stationary random measures and multifractal random walks with log-in nitely divisible scaling laws

We do not a large class of continuous time multifractal random measures and processes with arbitrary log-in nitely divisible exact or asymptotic scaling law. These processes generalize within a united framework both the recently do ned log-normal Multifractal Random Walk (MRW) [1,2] and the log-Poisson \product of cynlindrical pulses" [3]. Our construction is based on some \continuous stochastic multiplication" (as introduced in [4]) from coarse to ne scales that can be seen as a continuous interpolation of discrete multiplicative cascades. We prove the stochastic convergence of the dened processes and study their main statistical properties. The question of genericity (universality) of limit multifractal processes is addressed within this new framework. We nally provide a method for numerical simulations and discuss some specic examples.

#### I. INTRODUCTION

Multifractal processes are now widely used models in many areas including nonlinear physics, geophysics or econophysics. They are used to account for scale-invariance properties of some observed data. Our purpose in this article is to introduce a wide class of random measures and stochastic processes with stationary increments that possess exact multifractal scaling without any preferred scale ratio. This construction generalizes (and uni es) the recently introduced log-normal \Multifractal Random Walk" model [1, 2] and the log-Poisson compounded \Multifractal Product of Cynlindrical Pulses" [3]. Technical mathematical proofs are reported in the companion paper [5].

In the multifractal fram ework, scale-invariance properties of a 1d stochastic process X (t) are generally characterized by the exponents  $_{\rm q}$  which govern the power law scaling of the absolute moments of the  $\setminus$  uctuation"  $_{\rm l}X$  (t) of X (t) at any scale lup to a scale T, i.e.,

where m (q;l) is de ned as the expectation (from now on, the symbolE (:) will always refer to the mathematical expectation):

The so-called  $\backslash$  uctuation"  $_1X$  (t) can be de ned in various ways, the most commonly used de nition being

The scale-invariance property (1) can be quali ed as a continuous scale-invariance in the sense that the relation is a strict equality for the continuum of scales 0 < 1 T. A lternative \weaker" form s of scale-invariance have been widely used. All of them assume at least the asymptotic scale-invariance relation

The discrete scale—invariance property adds strict equality for discrete scale values  $l_n$  (with  $l_n$  !  $0^+$ , when n ! +1 )

The image implicitely associated with a multifractal process is a random multiplicative cascade from coarse to ne scales. Such cascading processes can be explicitely de ned in very dierent ways ranging from the original construction proposed by Mandelbrot in its early work [6] to recent wavelet-based variants [8]. Though these dierent constructions do not lead to the same objects, they all aim at building a stochastic process X (t) which uctuation  $_1X$  (t) at a scale 1 (where l is an arbitrary scalesmaller than the large scale T and < 1) is obtained from its uctuation  $_1X$  (t) at the larger scale 1 through the simple \cascading" rule

When the exponent  $_{\rm q}$  is linear in q, i.e., 9H ,  $_{\rm q}$  = qH , the process is referred to as a monofiactal process. Let us note that the so-called self-similar processes (e.g., fractionnal B rownian motions, Levy walks) are a particular case of monofiactal processes. On the contrary, if  $_{\rm q}$  is a non-linear function of q it is referred to as a multifractal process (or as a process displaying multiscaling or intermittency).

where W is a positive random variable independent of X and which law depends only on  $\ .$ 

In the multiplicative construction by M andelbrot [6] (which log-normal variant was originally introduced by Yaglom [7]), a positive multifractal measure M (dt) is built, i.e., X(t) = M([0;t]) is an increasing process and the uctuation  $_{1}X$  (t) at scale 1 is de ned by Eq. (3). In the more recent wavelet-based constructions X (t) is a process, not necessarily increasing, and the uctuation 1X (t) is de ned as the wavelet coe cient at scale 1 and time t [8]. Such cascade processes have been extensively used form odeling scale-invariance properties as expressed in Eq. (1). However, apart from self-sim ilar processes which are monofractal processes with continuous dilation-invariance properties, all cascade processes involve som e arbitrary discrete scale ratio and consequently only have discrete scale-invariance properties (Eq. (5)). Indeed, they rely on a \coarse to ne" approach consisting rst in xing the uctuations at the large scale T and then, using Eq. (6) iteratively, deriving uctuations at smaller and smaller scales. However, the (t; 1) time-scale half-plane is very constrained: one cannot choose freely 1X (t) at all scales and times. Thus, the cascade is generally not built using the whole time-scale half-plane but only using a sparse (e.g., dyadic) grid in this half-plane. Consequently an arbitrary scale ratio (e.g., = 1=2) is introduced in the construction. The continuous scaleinvariance property (1) is thus broken and replaced by the weaker discrete scale-invariance property (5) with  $l_n = {}^n T$ . M oreover, as a consequence, the uctuations 1X (t) in these approaches are no longer stationary.

Let us point out that despite the potential interest of stochastic processes with stationary uctuations and continuous invariance-scaling properties, until recently [1, 2, 3], explicit constructions possessing such properties were lacking. Let us assume that one can build a continuous cascade process X (t) satisfying Eq. (6) with a continuous dilation parameter . As rst pointed out by Novikov [9], if such a construction is possible, a simple transitivity argument shows that lnW must have an in nitely divisible law: its characteristic function is of the form  $\hat{G}$  (q) = F(q). One can then easily prove that  $m(q; 1) = m(q; 1)^{F(iq)}$ ; and consequently q = F ( iq). Continuous cascade statistics and login nite divisibility have been the subject of many works with applications in various domains ranging from turbulence to geophysics [9, 10, 11, 12, 13, 14, 15, 16, 17]. In the case W = H is deterministic, one gets Q = QH and therefore X (t) is a monofractal process. This is the case of the so-called self-sim ilar processes. The sim plest nonlinear (i.e., multifractal) case is the so-called log-norm al cascade that corresponds to a log-norm allaw for W and thus to a parabolic q spectrum . O ther well known  $\log$ in nitely divisible models often used in the context of fully developed turbulence are log-Poisson [18] and log-Levy [19] m odels.

From our know ledge, am ong all the attempts to build multifractal processes with continuous scale invariance

properties and stationary uctuations, only the recent works by Bacry et al. [1, 2] and Barral and M andelbrot [3] refer to a precise mathematical construction. Bacry et al. have built the so-called M ultifractal R andom W alk (MRW) processes as limit processes based on discrete time random walks with stochastic log-normal variance. Independently, Barraland M andelbrot [3] have proposed a new class of stationary multifractal measures. Their construction is based on distributing, in a half-plane, Poisson points associated with independent identically distributed (i.i.d.) random weights and then taking a product of these weights over conical domains. In the sam e tim e, Schm itt and M arsan considered an extension of discrete cascades to a continuous scale fram ework [4] and introduced in nitely divisible stochastic intregrals over cone-like structures sim ilar to those of Barral and M andelbrot. However they did not considered any continuous time lim it of their construction nor studied its scaling properties as de ned by Eq. (1).

In this paper, we propose a model that is based on the stochastic approach developed in [4] and that uni es all previous constructions within a single fram ework. Starting from original discrete multiplicative cascades, we will use a cone-like construction as in [4] and [3] in order to get rid of discrete scale ratios and to consider any log-in nitely divisible multifractal statistics. We will show that this allows us to build a very large class of multifractalm easures and processes (including original MRW [1, 2] and Barral-M and elbrot multifractal measures [3]) for which both long range correlations and multiscaling properties can be controlled very easily.

The paper is organized as follows. In section II, we review the discrete multiplicative cascades in order to naturally introduce the notion of stochastic integral over a cone-like structure in some \time-scale" half-plane. We then de ne a class of log-in nitely divisible stationary Multifractal Random Measures (MRM) which statistical properties are studied in section III. In section IV, we de ne the log-in nitely divisible Multifractal Random Walks. We show how their scaling properties can be inferred from the associated MRM. In section V we address some questions related to numerical simulations and provide explicit examples. In section VI, we discuss some links of the present work with previous connected approaches. Conclusions and prospects for future research are reported in section VII.

# II. FROM DISCRETE MULTIPLICATIVE MEASURES TO MULTIFRACTAL RANDOM MEASURES

In this section, we provide some heuristics about how one can build a positive stationary stochastic measure M (dt) with continuous scale-invariance properties, i.e., such that the associated increasing process X (t) = M ([0;t]) satis es Eq. (6) with a continuous dilation parameter .

# A. D iscrete multiplicative cascades




FIG. 1: De ning a continuous cascade interpolating M andelbrot cascades. (a) M andelbrot cascade: O ne starts from the coarse scale T and constructs the sequence M  $_{\rm ln}$  that is resolved at scale T 2  $^{\rm n}$  by iterating a multiplicative rule along the dyadic tree. At each construction step, the random multiplicative factor W  $_{\rm S_0\,:::s_n}$  can be represented as the exponential of the integral of an in nitely divisible noise over a square domain indicated by hatched sets. (b) C ontinuous cascade conical domains obtained as linear smoothing of the hatched domains in (a). Such cones are involved in the de nition of the process !  $_{\rm 2}$   $^{\rm 3}$  (t)

For the sake of illustration, let us start with simple discrete multiplicative cascades. In the original construction, as proposed by M andelbrot, one builds the m easure M (dt) as the lim it of a sequence of stochastic m easures M  $_{l_n}$  , indexed by a discrete scale parameter  $l_n$  = T  $^n$ (we choose = 1=2). The measure M  $_{\mathbf{l}_n}$  , at the step n of the construction, has a uniform density on successive dyadic intervals of size  $l_n$  . The idea is to build the sequence M 1, so that it statis es (when n is varying) a scale-invariance property. The n-th measure is obtained from the (n 1)-th measure by multiplication with a positive random process W which law does not depend on n. One can naturally index the dyadic intervals along the dyadic tree using a kneading sequence  $fs_1 ::: s_n g$  where  $s_i = 0$  (resp.  $s_i = 1$ ) if, at \depth" i, the interval is on the left (resp. on the right) boundary of its parent interval. Thus, for instance, one gets the following dyadic intervals:  $I_0 = [0;2^{-1}]$ ,  $I_1 = [2^{-1};1]$ ,  $I_{00} = [0;2^{-2}]$ ,  $I_{01} = [2^{2}; 2^{1}]$  and so on... With these notations, the multiplicative rule reads (see Fig. 1(a)):

where  $I_{s_0 ::: s_n}$  is of size T 2  $^n$  and is one of the two \sons" of the interval  $I_{s_0\,:::s_n}$  and W  $_{s_0\,:::s_n}$  are i.i.d. Since the construction is invariant with respect to a rescaling by a factor 2, the lim it measure M (dt) will then satisfy the sam e scale-invariance property and will be multifractal in the discrete sense of Eq. (5). There is a huge mathem atical literature devoted to the study of such a construction and we refer the reader to Refs. [20, 21, 22, 23] for rigourous results about the existence, regularity and statistical properties of M and elbrot cascades. In physics or other applied sciences, as recalled in the introduction, the previous construction (and many of its variants) is considered as the paradigm for multifractal objects and has been often used as a reference model in order to reproduce observed multiscaling. But because of its lack of continuous scale invariance and translation invariance, such models cannot be fully statisfactory in many contexts were the considered phenomena possess some degree of stationarity and do not display any preferred scale ratio.

#### B. Revisiting discrete cascades

In order to generalize Eq. (7) to a continuous fram ework one can try to perform the limit! 1 in the discrete construction as in Ref. [4]. A nother way to proceed is to represent a M andelbrot cascade as a discretization of an underlying continuous construction.

For that purpose, we suppose that the random weights W  $_{\rm S_0\, ::::S_n}$  in the cascade are log-in nitely divisible. For a continuous cascade, this choice can be motivated as follows: Let us suppose that the large scale density, M  $_{\rm T}$  (dt)

is equal (or proportional) to the Lebesgue m easure dt. W e would like to de ne iteratively the densities M  $_1$ (t), for all 1 T. To go from resolution  $1^0$  to resolution 1  $1^0$ , we thus write

where W  $_{l=1^0}$  (t) is a positive stationary discrete random process independent of M  $_1^0$  (t). Let us de ne

By iterating Eq. (8), we see that W  $_{l=T}$  (t) can be obtained as a \continuous product" of positive i.i.d. random variables. C onsequently !  $_{l}$  (t) can be written as the sum of an arbitrary number of i.i.d. random variables. This is precisely the de nition of an in nitely divisible random variable [24]. In order to go from discrete to continuous cascades, it is therefore natural to assume that, in the discrete situation, !  $_{l_n}$  (so :::s $_n$ ) = ln ( $_{i=0}^n$  W  $_{s_0:::s_i}$ ) is in nitely divisible. A \simple" way of building such an in nitely divisible process !  $_{l_n}$  is to represent it by a stochastic integral of an in nitely divisible stochastic 2D measure P (dt;dl) over a domain A  $_{l_n}$  (so :::s $_n$ ):

The stochastic measure P (dt;dl) is uniform ly (with respect to a measure (dt;dl)) distributed on the time-scale half-plane  $S^+ = f(t;l)$ ; t2 R; 12 R<sup>+</sup> g.

Let us recall that, by de nition  $^1$ , if P (dt;dl) is a stochastic in nitely divisible measure uniform by (with respect to a measure (dt;dl)) distributed on S  $^+$ , then, for any two  $^-$ mesurable sets A and A  $^0$  such that (A) = (A  $^0$ ), then P (A) and P (A  $^0$ ) are identically distributed random variables which characteristic function is nothing but

where '(p) depends only on a centering parameter m and the so-called canonical Levy measure (dx) which is associated with P. The general shape of ' is described by the celebrated Levy-K hintchine formula [24, 25]:

The sets A  $_{l_n}$  (s $_0$ ::: $s_n$ ) associated with each of the  $2^n$  values!  $_{l_n = T \cdot 2^{-n}}$  (s $_0$ ::: $s_n$ ) in M andelbrot construction can be chosen naturally as the union of all similar squares  $I_{s_0$ ::: $s_k$  [T 2  $^k$ ; T 2  $^{(k-1)}$ ], n k 1:

The sets A  $_2$   $_3$  (000) and A  $_2$   $_3$  (010) are indicated as hatched domains in Fig. 1(a). Since the W  $_{s_0:::s_n}$ 's are

i.i.d., we want to choose the measure (dt;dl) such that the measure of each square  $I_{s_0\,:::s_n}$  [T 2  $^n$ ;T 2  $^{(n-1)}$ ] is a constant. The natural measure to choose is (dt;dl) = dtdl= $I^2$ . It is the natural measure associated with the time-scale plane S  $^+$  in the sense that it is (left-) invariant by the translation-dilation group.

Fixing  $(dt;dl) = dtdl=1^2$  one then gets 8n,

and thus, from Eq. (12), W  $_{s_0} ::: s_n$  are i.i.d.: we recover exactly the M andelbrot construction.

# ${\tt C}$ . Towards multiplicative cascades with continuous scale—invariance

We would like to apply the previous scheme in the case the construction is no longer indexed by a discrete scale parameter  $l_n$  but by a continuous scale parameter  $l_n$ .

In order to \interpolate" sm oothly this construction both in time and scale, on can interpolate the previous union of similar squares A  $_{l_n}$  (so :::s $_n$ ) (Eq. (14)) using domains A  $_1$ (t) where (t; l) can take any value in S  $^+$ . In order the limit measure M (dt) =  $\lim_{l\to 0} M_l$ (dt) to be stationary, it is clear that one has to choose the set A  $_1$ (t) to be \translation-invariant" in the sense that

One thus just needs to specify the set  $A_1(0)$ . A \natural" choice (though, as we will see in section IIIF, it only leads to asymptotic, and not exact, scaling properties) seems to be the conical set (see Fig. 1 (b))

In case case, we get exactly the construction originally proposed, using a densi cation argument, by Schmitt and Marsan in Ref. [4]. Other choices for the function f (1) will be discussed in section IIIF.

Let us rem ark that the choice of the linear conical shape f(l) = 1 is consistent with the interpretation of the parameter l as a scale parameter. Indeed, the value of the measure P around some position ( $t_0$ ; l) in the halfplane  $S^+$  in uences the values of the measure over the time interval  $]t_0 = l=2$ ;  $t_0 + l=2]$ , i.e., exactly over a time scale l.

we refer the reader to ref. [26] for a rigourous de nition of the socalled \in nitely divisible independently scattered random measure"

#### III. STAT IONARY MULTIFRACTAL RANDOM MEASURES

## A. De ning M R M

A coording to the arguments of the previous section, we thus propose the following de nition for the class of log-in nitely divisible multifractal random measures. Let us introduce an in nitely divisible stochastic 2D measure P uniformly distributed on the half-plane  $S^+ = f(t;l)$ ; t 2 R; 1 2 R<sup>+</sup>g with respect to the measure (dt;dl) = dtdl= $I^2$  and associated with the Levy measure (dx). Let us recall that for any set A  $S^+$ , P (A) has an in nitely divisible law whose moment generating function is

where ' (p) is de ned by Eq. (13). Henceforth, we de ne the real convex cum ulant generating function, as, when it exists,

Let ! 1 (t) the stationary stochastic process de ned by




FIG. 2: Conical domain (Eq. (22)) in the (t;1) half-plane involved in the de nition of  $!_1$  (Eq. (20)).

As it will be shown in the following sections, the choice of the large scale behavior f(l) = T for l T is the unique one that ensures the convergence of the construction and the exact scaling of the  $\lim$  it measure. The cone-like domain  $A_1(t)$  is indicated as an hatched domain in Fig. 2

We nally dene the stochastic positive measure M  $_{\rm l}$  (dt) as

The MRM M is then obtained as the  $\lim$  it m easure (the m eaning and the existence of this  $\lim$  it will be addressed in the next section)

Since a sim ple change in the m ean of the stochastic m easure P would lead to the samemeasure up to a determ inistic multiplicative factor, we will assume, without loss of generality, that satis es

W e can consider som e generalizations of the previous construction. The rst one consists in changing the function f (1), i.e., to change the shape A 1 the measure P is integrated on. The second one consists in changing the m easure (dt;dl), i.e., to change the way them easure P is distributed in the half-plane S<sup>+</sup>. A ctually, from Eq. (12) one can easily show that the construction only depends on the function (A1), consequently, changing the shape of f(1) basically amounts changing (dt;dl). A simple example that illustrates such a freedom is the choice (dt;dl) = dtdl, i.e.is nothing but the 2D Lebesgue m easure. In that case,  $(A_1)$  remains unchanged if one chooses f(1) = 1 = 1 in the de nition (22). The param eter l is no longer a scale but can be interpreted as a frequency and thus S<sup>+</sup> is the time-frequency half-plane. Therefore, in the following sections, without loss of generality, we choose to x  $(dt;dl) = dtdl=1^2$  (i.e. to work within the time-scale half-plane S+) and we will discuss,

in section IIIF, the consequences which rise from other choices than (22) for the function f (1).

#### B. Existence of the lim it M R M M (dt)

In [5], we prove, within the fram ework of positive continuous martingales that, almost surely, M  $_{\rm l}$  converges to a well de ned limit measure when 1!  $0^+$ . Moreover, we prove that if  $^0(1)<1$  then there exists >0 such that  $(1+\ )<1$  and the moment of order  $1+\$ , E M  $_{\rm l}([0;t])^{1+}$  , is nite. Then, using the fact that (1)=0, it is straightforward to prove that

Consequently the limit measure M (dt) is non degenerated (i.e., di erent from zero). The overall proof is very technical and, for this reason, has not been reproduced in this paper.

However, if (2) < 1, one can prove (see Appendix A) that  $\sup_1 \mathbb{E} \ M_1[0;t]^2$ ) is bounded and that the sequence  $M_1(dt)$  converges in the mean square sense. Again, using the fact that (1) = 0, it follows that M (dt) is non degenerated. (Let us note that, as explained in section III D, one can prove [5] that assuming (2) < 1 basically amounts assuming that  $\mathbb{E} \ M \ ([0;t])^2 < +1$ ).

## C. Exact multifractal scaling of M (dt)

In order to study the scaling properties of the lim it measure M (dt), let us establish the scale invariance properties of the process  $!_1(t)$ .

# 1. Characteristic function of ! 1(t)

#### 2. Multifractal properties of M (dt)

The multifractal scaling properties of the lim it M RM M (dt) result from the scale invariance property of the process  $!_1$ (t) that is itself a direct consequence of previous exponential expression (33) for the characteristic function of the process  $!_1$  and the particular shape of the conical domains leading to expression (31). The pdf of the measure M ([0;t]) is thus heavy tailed with a tail exponent that can be, unlike classical -stable laws, arbitrary large.

#### E. Examples

In order to illustrate previous considerations let us consider som e speci c exam ples.

#### Deterministic case:

The simplest situation is when the Levy (dx) m easure is identically zero: This case corresponds to the self-similar, monofractal situation where (p) = pm. The constraint (1) = 0 implies m = 0, and we thus get the Lebesgue measure.

# Log-norm alM RM:

The log-norm alm RM is obtained when the canonical measures attributes a nite mass at the origin:  $(dx) = {}^2(x)dx$  and  ${}^2>0$ . From Eqs. (13) and (19), the cumulant generating function is that of a normal distribution: (p) = pm +  ${}^2p^2=2$ . The condition (1) = 0 implies the relationship m =  ${}^2=2$ . The log-normal q spectrum is a parabola:

Let us note that the so-obtained increasing process M ([D;t]) is the same as the increasing M RW process mentioned in the conclusion of [2]. This sim ilarity will be further discussed in section VIA 1.

#### Log-Poisson MRM:

When there is a nite mass at some nite value  $x_0 = \ln()$ , of intensity  $^2 = (\ln)^2$ :  $(dx) = ^2$   $(x x_0)$ . The corresponding distribution is Poisson of scale parameter and intensity  $\ln()$ : (p) = p  $(m \sin(\ln()))$  (1 p). The log-Poisson q spectrum is therefore exactly the same as the one proposed by She and Levêque in their cascade model for turbulence [18]:

where m  $^0$  is such that  $_1=1$ . Notice that in the lim it ! 1, (ln  $)^2$  !  $^2$ , one recovers the log-norm al situation. In the original She-Levêque m odel, =2 and =2=3 [18].

Log-Poisson compound MRM:

When the canonical measure (dx) satisfies  $(dx)x^2 = C < 1$  (e.g. (dx) is concentrated away from the origin), one can see that  $F(dx) = (dx)x^2 = C$  is a probability measure. In that case,

is exactly the cumulant generating function associated with a poisson process with scale C and compound with the distribution F [24]. It turns out that the  $\log P$  oisson compound MRM has the following multifractal spectrum:

This is exactly the spectrum obtained by Barral and M and elbrot in their construction of \product of cylindrical pulses"  $\beta$ ]. The similarity between our construction and Barral and M and elbrot construction will be further discussed in section VIA 2.

Log- stable MRM:

When (dx)  $x^1$  dx for 0 < 2, one has an log -stable MRM:

Such laws have been used in the context of turbulence and geophysics [15,19]. They have been often referred to as \universalmultifractals" because stable laws are xed points of in nitely divisible laws under a suitable renormalization procedure.

M any other families of  $_{\rm q}$  spectra can be obtained (e.g. log-G am m a, log-H yperbolic,...) for other choices of the Levy measure. Let us remark that in the case of a normal random variable  $!_1$ , the function  $_1$ () is nothing but the covariance of the process as introduced in Refs. [1, 2]. This function, that m easures the areas of dom ains A 1 intersections, is therefore the analog of the covariance for general in nitely divisible distributions. The equation (33) shows that our construction can be seen as a natural extension of Gaussian processes (or multivariate Gaussian laws) within the class of in nitely divisible processes (multivariate in nitely divisible laws) in the sense that it is completely characterized by a cumulant generating functions ' (p) (specifying the mean and the variance param eters in the Gaussian case) and a 2-points \covariance" function (t) (or covariance matrix).

## F. A sym ptotic scaling and universality

In the last section, we have seen that the choice (22) for f(1) leads to exact scaling of the m om ents of the associated MRM. In this section we study the scaling behavior of the moments for other choices of f(1)<sup>3</sup>. Let us remark that f(1) is dened up to a multiplicative constant. This just amounts to a choice in the scale of f(1)<sup>3</sup>.

In the following, f  $^{(e)}$  (l) will refer to the \exact scaling" choice (22) that was made in the previous sections. The so-obtained sets in the S $^+$  half-plane will be referred to as A $_1^{(e)}$  (t), the ! process as ! $_1^{(e)}$  (t) and the associated MRM as M $^{(e)}$  (dt).

# 1. Large scale perturbation of f (1)

Rigorous mathematical proofs can be found in [5]. Let us rst study the case when one builds an MRM using a function f (1) which diers from f  $^{(e)}$  (1) only for scales larger than a large (xed) scale L, i.e.,

An example of such large scale modi cation is the function de ned by (17), where g = g  $^{(s)}$  where g  $^{(s)}$  (l) = 0 and L = T . This function is the one which was used by

 $<sup>^3</sup>$  W e recall that we do not consider other choices for the uniform measure (dt;dl) in the half space S  $^+$  because f (l) and (dt;dl) are involved in the properties of the lim it measure M (dt) only through the function  $_1(t)=\ (A_1(0;t))$ . Barral and M andelbrot in Ref. [3]. Let us rst choose the particular case  $g=g^{(s)}$  (L being any strictly positive number). The so-obtained sets in the  $S^+$  half-plane will be referred to as  $A_1^{(s)}$  (t), the ! process as !  $_1^{(s)}$  (t) and the associated MRM as M  $_1^{(s)}$  (dt). In the rst case, < 1, one can show any moment of order 1 + ( > 0) cannot be bounded. Since E (M  $_1([0;t])$ ) = 1, general martingale arguments can be used to prove that M  $_1([0;t])$  converges towards the trivial zero measure.

If > 1, the lim it measure is proportional to the Lebesgue measure and thus one obtains the trivial asymptotic scaling:

Let us now consider the marginal case, f(l) = 1 + o(l) at small scales. We can therefore see, that, as far as asymptotic multifractality is concerned, the pertinent parameter is the small scale behavior of the function f(l) or equivalently the small time behavior of l=0 (t). As pointed out previously, in the case of a Gaussian eld! (t) (i.e. the in nitely divisible law has only a Gaussian component),

(t) is nothing but the covariance of the process. The previous discussion leads thus to the conclusion that non trivial lim it multifractal measures arise only in the marginal situation when the correlation function of the logarithm of the uctuations decreases as a logarithm ic function.

# ${\tt G}$ . An alternative discrete time construction for ${\tt M}$ R M

In the case  $^R$  x  $^2$  (dx) < 1 (e.g. the Levy measure has no mass in an interval around x = 0) a realization of the measure P (dt;dl) is made of dirac functions distributed in the S<sup>+</sup> half-plane. Thus the process M  $_1(([0;t])) = _0^{R_t} e^{!_1(t)} dt$  is a jump process that can be simulated with no approximation.

However, if  $x^2$  (dx) has a non nite integral (e.g., it has a Gaussian component), this is no longer the case. Thus, one has to build another sequence of stochastic measures  $M_1$ (dt) that converges in law towards M (dt) and that can be seen as a discretized version of M (dt). We will see, in following sections, that such a discrete time approach is also interesting for M ultifractal stochastic processes construction.

We choose  $M_1(dt)$  to be uniform on each interval kl; (k+1)l, 8k 2 N and with density  $e^{l_1(kl)}$ . Thus, for any t>0 such that t=pl with p 2 N , one gets

In the sam eway as for the measure M  $_1$  (dt), one can prove [5], within the fram ework of positive martingales, that, almost surely, M  $_{1=2^{-n}}$  (dt) converges towards a well dened limit measure when n! +1 (i.e., 1!  $0^+$ ). Moreover, in the same way as in section IIIB, if we suppose (2) < 1, then one can show (the proof is very similar as the one in Appendix A) that, in the mean square sense,

As long as (2) < 1, this construction gives therefore a way of generating a m easure which is arbitrary close (by choosing l sm all enough) to the lim it m easure M (dt).

# IV. LOG-INFINITELY DIVISIBLE MULTIFRACTAL RANDOM WALKS

In this section we build and study a class of multi-fractal stochastic processes that are no longer, as before, strictly increasing processes (measures). They can be basically built in two dierent ways: (i) By subordinating a fractional Brownian motion (fBm) with the previously dened MRM M (t) or (ii) by a stochastic integration of a MRM against a fractional Gaussian noise (fGn). As

we will see, most of the statistical properties of the so-obtained random processes are directly inherited from those of the associated M  ${\tt RM}$  .

#### A. MRW with uncorrelated increments

In the same spirit as the log-norm alm RW constructions in Refs. [1, 2] (see also [27]), we use a stochastic integration of  $e^{!_1(t)}$  against the (independent) W iener measure dW (t).

#### 1. De nition

Since E ( $e^{!_1(t)}$ ) = 1, one can consider the process Z  $_{t}$

U sing the same kind of arguments on nite dimensional laws, one can also prove that the nite dimensional laws of the process  $X_1(t)$  converge to those of the subordinated process B (M (t)). A ctually, one can show [5] that, as long as  $^0(1) < 1$  (i.e., 9 > 0, (1 + ) < 1 which is, as mentioned in section IIB, the condition for the limit measure M (dt) to be non degenerated), on has

The so-obtained M RW can be thus understood as a B rownian motion in a \multifractal time" M (t). The subordination of a B rownian process with a non decreasing process has been introduced by M andelbrot and Taylor [31] and is the subject of an extensive literature in mathematical nance. Multifractal subordinators have been considered by M andelbrot and co-workers[32] and widely used to build multifractal processes from multifractal measures (see below). In a forthcoming section we will see that multifractal subordination and stochastic integration do not lead to the same processes when one considers long range correlated G aussian noises (fG n).

#### 2. Expression of the moments and multifractal properties

Thanks to Eq. (69) (assuming  $^{0}(1) < 1$ ), one gets the expression of the absolute moments of X (t) (or X (t<sub>0</sub> + t) X (t<sub>0</sub>)):

# An alternative discrete time construction for MRW processes

As in Refs. [1, 2] or in section IIIG, one can also try to build an M RW process using a discrete approach. A discrete construction can be useful for numerical simulations. Let us, for instance, choose  $l_n=2^n$ . And let  $_1 k = \frac{R}{k!} (k+1) l_n dW$  (u) be a discrete G aussian white noise. We do not the piece-wise constant process  $X_{l_n}$  (t) as  $(t=pl_n)$ :

B. MRW processes with long-range correlations

#### 1. De nitions

In order to construct long-range correlated M RW , it is natural to replace the W iener noise (resp. B rownian motion) in previous construction by a fractional G aussian noise (resp. fractional B rownian motion). A fBm ,  $B_{\rm H}$  (t) is a continuous, self-sim ilar, zero-mean G aussian process which covariance reads (see e.g. [28] for a precise de nition and properties):

where 0 < H < 1 is often called the Hurst parameter. Standard B rownian motion corresponds to H = 1=2.

The  $\sin$  plest approach to construct a long-range correlated M RW follows the idea of M and elbrot that  $\sin$  ply consists in subordinating a fractional B rownian motion of index H with the M RM M (t), i.e.,

However stochastic integrals against fG n cannot be de ned as easily as for the white G aussian noise and the proposed constructions require the complex machinery of Malliavin calculusor Wick products [33, 34]. # 2. Multifractal properties

In the case of the subordinated version X  $_{\rm H}^{\rm s}$  (t) of the M RW , the scaling properties can be directly deduced

by the self-sim ilarity of  $B_H$  (t) [32]. Since  $B_H$  (t+ )  $B_H$  (t)= $^{law}$   $^H$  ( $B_H$  (t+ 1)  $B_H$  (t)), and M (t) is independent of  $B_H$ , one has  $X_H$  (M (t))= $^{law}$  M (t) $^H$   $B_H$  (1). We can see that the multifractal spectra of X  $_{\rm H}^{\rm S}$  and X  $_{\rm H}^{\rm I}$  are dierent: they do not correspond to identical processes as it was the case for the uncorrelated construction. Notice that the existence criterion (81), can be simply rewritten as  $_{\rm 2}^{\rm i} > 1$ . A coording to the considerations developed in section IIID, this condition ensures the existence of the second order moment of X  $_{\rm H}^{\rm i}$ . We then the class of processes X  $_{\rm H}^{\rm i}$  (t) can be extended, in some weak probabilistic sense, to values of H < 1=2+ (2)=2 is still an open problem (such processes would have an in nite variance). The condition of nite variance for X  $_{\rm H}^{\rm S}$  (t) is less restrictive since it comes to the condition K  $_{\rm 2H}$  < 1, where K  $_{\rm 2H}$  is de ned in Eq. (43). # C. A remark on subordination

where  $_{\rm q}^{\rm (i)}$  (resp.  $_{\rm q}^{\rm (i)}$ ),  $_{\rm i}$  = 1;2, is the spectrum associated with M  $_{\rm i}$ . The equation (87) corresponds to a \random ization" of the rescaling factor—that parametrizes the log-in nitely divisible law of  $_{\rm W}^{\rm (1)}$ ). It is easy to prove [24] that the law of  $_{\rm W}^{\rm (1)}$  ( $_{\rm W}^{\rm (1)}$ ) remains in netely divisible. The class of log-in nitely divisible MRM is therefore closed under subordination. The family of subordinated spectra (88) is thus included in the family of log-in nitely divisible spectra and the operation (85) does not allow us to build new MRM with exact scale invariance properties.

#### V. NUMERICAL SIMULATIONS

### A. Principles

In order to generate realizations of  $M_{l_n}$  (dt) (de ned by (63)), one needs to be able to generate realizations of  $!_{l_n}$  (kl\_n). However, following the de nition of  $!_{l_n}$  one would need realizations of the 2d random measure P (dt;dl) for  $l_n$ . In the case of a compound poisson process, the process  $M_1([0;t]) = \int_0^t e^{!_1(t)} dt$  is a jump process that can be synthetized easily.

In the general case, we need to nd a set of disjoint \elementary" dom ains of the half-plane  $S^+$  such that, for any k, there exists a subset of this set such that  $A_{l_n}$  (k $l_n$ ) can be expressed as a the union over the elementary domains of this subset. Since, at xed  $l_n$ , the boundaries of the domains  $A_{l_n}$  (k $l_n$ ) (k 2 ZZ) de ne a tiling of  $S^+$ , it is natural to consider the elementary cells of this tiling. Each cell is the intersection between left and right strips limited by left and right boundaries of conical domains: Let us de ne the cell  $B_1(t;t^0)$  (with  $t < t^0$ ) as




FIG. 3: MRW signals sampled at rate 1. (a) log-Normal MRW with T = 512 and  $^2$  = 0.05. (b) log-Poisson sample with T = 512, = 4 and ln( $^2$  = 0.05. In both signals, the cut-o las been xed to 1=8 for the num erical synthesis.

Let us note that if the function f is bounded (which is the case if we are under the hypothesis (22), i.e., in the case of \exact" scaling), the number of terms in Eq. (91) is nite.




FIG. 4:  $_{\rm q}$  spectrum estimation for log-Normal and log-Poisson MRW 's. The exponents have been directly estimated from linear regression of increment order q absolute moments in doubly logarithmic representations. These moments have been estimated using a statistical sample of 256 signals of 64 integral scales. The symbols () correspond to log-Poisson estimates while () correspond to log-Normal estimates. The solid line represents the log-Poisson analytical spectrum (52) and the dashed line to log-Normal analytical spectrum (51) rescaled using Eq. (71). The parameters of both processes are those of Fig. 2 and have been chosen so that the so called intermittency parameter  $^{\circ\circ}$  (0), is the same (0:05).

(where W is here a 1D W iener noise) will be thus identical to the normal process  $!_1(t)$  as de ned in Eq. (20). In the original study of Refs. [1, 2] the M RW has been de ned along this method.

# B. Num erical exam ples

In Fig. 3 are shown two sam ples of MRW which are respectively log-Norm aland log-Poisson (see Eqs. (51,52)). In both cases we have chosen T = 512 sample units, H = 1=2 ( is a Gaussian white noise). For the log-Norm alprocess,  $^2$  = 0.05 while = 4 and = e for the log-Poisson process. The log-Poisson process has been synthetized using Eq. (91) while a simple litering method was used for the log-Norm alprocess. Eq. (97) was solved numerically in the Fourier domain. In Fig. 4 are plotted the  $_{\rm q}$  functions estimated for both processes. These functions have been obtained from the scaling of the moments estimated using 256 MRW trials of 64 integral scales long. The  $_{\rm q}$  values for negative q have been

obtained using the so-called W TMM method that is a wavelet based method introduced to study multifractal functions [35, 36, 37]. The superimposed analytical formulae obtained with Eqs. (71), (51) and (52), t very well with statitical estimates except a large negative q values for the log-N ormal case. This can be explained as a nite statistics e ect.

#### VI. CONNECTED APPROACHES

In this section we review some specic results concerning respectively log-normal and log-Poisson compound M RW .

## A. Log-norm alM RW

The log-norm al M RW has been originally de ned in Refs. [1, 2]. It corresponds to the simplest situation when the Levy measure has only a Gaussian component. In that case, the Gaussian process  $!_{\,1}(t)$  can be directly constructed from a 1D white noise, without any reference to 2D conical domains. This model is interesting because its multifractal properties are described by only two parameters, the integral scale T and the so-called intermittency parameter  $^2$ . Some simple estimators of these quantities have been proposed in [1]. Moreover, many exact analytical expressions can be obtained and notably the value of the prefactor K  $_{\rm q}$  in Eq. (42). In [40], it is shown that this prefactor can be written as a Selberg integral [41]. Its analytical expression reads:

It is easy to check that K  $_{\rm q}$  is de ned only if q < q = 2=  $^2$ . We recover the nite moment condition (49), q < q with  $_{\rm q}$  = 1. Notice that, as emphasized by Frisch [42], the existence of in nite moments can be a draw back of a log-norm almultifractal as a model for experimental situations like turbulence. However, for a typical value  $^2$  = 5:10  $^2$ , q = 40, so a log-norm alapproximation can be very good in a range of q values far beyond the limit associated with the nite size of experimental samples. Let us nally mention that the log-normal MRW can be naturally generalized to a \multivariate multifractal model which is a multifractal vector of processes characterized by an intermittency matrix  $_{ij}$  [1]. This notion of \pint multifractality" can be very interesting in many applications.

# B. Multifractal products of cylindrical pulses

In reference [3], M andelbrot and Barral introduced a positive multifractal random measure using products of positive random variables associated with Poisson points

within 2D conical domains. Their construction is a particular case of MRM. It actually reduces to the case where (dx) is a Levy measure satisfying  $(dx)x^{2} < 1$ (see section IIIE) and where the set  $A_1(t)$  is delimited by the function f(l) as de ned by Eq. (17). Let us note that, since they have not considered the full domain A1(t) associated with the function f(l) as de ned by Eq. (22), as explained in section IIIF, this construction performs asymptotic scaling (4) but not exact scaling (1). However, these authors did not study the scaling properties of the random measures. They rather focused on the pathwise regularity properties. More precisely, they proved the validity of the so-called \multifractal form alism " (see e.g. [35, 36, 37, 38, 39]) that relates the function q to the singularity spectrum D (h) associated with (almost) all realisations of the process. For a given path of the increasing process associated with an MRM, D (h) is de ned as the Hausdor dim ension of the set of \iso-regularity" points, i.e., the points where the (Holder) regularity is h. Barral and M andelbrot proved that D (h) and  $_{
m q}$  are related by a Legendre transform ation. Since we proved that q is the scaling exponent of MRM moments, it follows that one can estimate the singularity spectrum of the MRM paths in the case of log-Poisson compound statistics. It should be interesting to extend the M andelbrot-Barraltheorem to the general log-in nitely divisible MRM and MRW paths.

#### VII. CONCLUSION AND PROSPECTS

### A. Sum mary and open questions

In this paper we have constructed a class of stationary continuous tim e stochastic measures and random processes that have exact or asym ptotic multifractal scaling properties in the sense of Eqs. (1) and (4). We have shown how stochastic integration of an in nitely divisible noise over cone-like dom ains, as originally proposed in [4], naturally arises when one wants to \interpolate" discrete multiplicative cascades over a continuous range of scales within a construction that is invariant by time translations. The exponential of these stochastic integrals (e! 1 (t)) can be interpreted as a \continuous product" from coarse to ne scales and thus as the continuous extension of the multiplicative rule involved in the de nition of discete cascades. We have shown that the probalility density functions associated with MRM and M RW processes can have, like discrete cascades, fat tails with arbitrary large exponents. However, unlike their discrete analog, our \continuous cascades" have stationary uctuations, do not involve any particular scale ratio and can be de ned in a causalway. This \sequential" form ulation, as opposed to the classical \top to bottom " de nition of multifractals, can be very interesting for modelling dynamical processes (see the next section). Let us note that we focused in this study on 1D processes but our construction can easily be extended to higher dim ensions.

It is well known (see Refs. [1, 2]) that the multiscaling (1) or (4) with a non-linear convex  $_{\rm q}$  function cannot extend over an unbounded range of scales and there necessarily exists an \integral scale" T above which the scaling of the moments changes. The existence of such an integral scale can be found in the general shape of function f (1) as discussed in section IIIF: One must have f (1) when 1! 0 and f(1) = o(1) when 1! + 1, so the scale T is a scale that separates these two asymptotic regimes. It is remarkable that there exists a particular expression for the function f(1) (Eq. (22)) for which the moments in the multifractal regimel T satisfy an exact scaling. The existence of processes with such properties was not a priori obvious. In the same section, we have shown that l is a necessary and su cient condition for the existence of a limit multifractal object. From a fundamental point of view, one important question concerns the unicity of our construction: Is any process satisfying (1) can be represented within the fram ework we have introduced?

It remains many open mathematical problems related to the processes which we introduced in this paper. Som e of them have been already m entionned, notably the questions related to the construction of stochastic integrals in section IVB. As discussed in section VIB, it should be interesting to generalize the results of Ref. [3] in order to link scaling properties and pathwise regularity within a multifractal formalism. Another interesting problem concerns the study of lim it probability distributions associated with MRM for which fery few features are known. Like in nitely divisible laws, they appear to be related to some sem i-group structure. Finally, one can wonder if log-in nitely processes we have de ned are not the natural candidates to be described within the fram ework of \M arkovian continuous cascades" as introduced in Refs. [43, 44].

# B. Possible applications

One of the main issues of the present work was to construct a wide family of multifractal processes (or measures) that are likely to be pertinent models in many elds were multiscaling laws are observed. Naturally, the rst application of which one can think, is fully developed turbulence. Turbulence and multifractals share a long history and we refer the reader to Ref. [42] for a review on the \intermittent" nature of turbulent elds. Recently, new aspects of turbulence were studied by considering uid dynamics from a Lagrangian point of view. This was possible because two groups developed new experim ental devices based on a fast imaging system [45] or ultrasound techniques [46, 47] allowing for a direct m easurem ent of the velocity of a single tracer in a turbulent ow. In a recent works, P inton and his collaborators [46, 47] studied the intermittency of Lagrangian trajectories and related it to the slow (logarithm ic) decay of the

particle acceleration correlations [47, 49], very much like for a M RW model. In other words, these authors found that the turbulent Lagrangian dynam ics is very well described by an equation of Langevin type with a driving force amplitude similar to  $e^{!\,_1(t)}$  involved in the M RW definition. The understanding of the physical origin of such dynamical correlations and the link between Lagrangian and Eulerian statistics is a very promising path towards the explanation of the intermittency phenomenon in fully developed turbulence.

Besides turbulence, \econophysics" [50, 51, 52] is an em erging eld where fractal and multifractal concepts have proven to be fruitful. Indeed, many recent studies brought em pirical evidences for the multifractal nature of the uctuations of nancial markets (see [1] and reference therein). Some physicists raised an interesting analogy between turbulence and nance [51, 53, 54, 55]. Logarithm ic decaying correlations and \1/f" power spectrum have been directly observed for various time series [54, 56], so it is reasonable to think that M RW models are well suited form odeling nancial time series [1]. The versatility of in nitely divisible M RW is very interesting to account for various stylized facts of nancial times series such that the multiscaling, the power-law tailbehavior of return pdf and therefore such models can be very helpful for nancial engineering and risk management.

Am ong all the remaining disciplines where multifractality has been observed, one can mention the study of network trac [57, 58, 59], geophysics and climatology [60, 61, 62], biomedical engineering [63], the modelling of natural images [64],... On a more theoretical ground, \continuous branching trees" and log-correlated random processes have also been considered in the physics of disordered systems [65, 66]. The study of free energy density in the therm ynamic limit in presence of log-correlated disorder (or equivalently on topologies involving random disordered trees) raise questions very similar to the study of limit MRM addressed in this paper. One can hope that pushing forward this analogy in a promising prospect to get signicant results in both elds.

The last integral behavior in the lim it 1! 0 can be easily evaluated. A fler some simple algebra we get:

Thus if condition (B4) is satisfied, i.e. 2H (2) 1>0,  $X_1(t)$  is a Cauchy sequence and thus converges in mean square sense.
