M icroscopic analog of tem perature within nonextensive

therm ostatistics

Abstract

It is presented a m icroscopic interpretation for the temperature within T sallis therm ostatistics, generalizing the classical derivation based on the B oltzm ann-G ibbs statistics. It is shown that with this de nition the zeroth law and the equipartition theorem are valid in their classical form . M oreover, it is observed that the equation of state for an ideal gas within generalized therm ostatistics preserves the classical B oyle's law form PV = N kT.

I. IN TRODUCTION

The explanation of the m acroscopic theory of them odynam ics in terms of the m ore abstract m icroscopic statistical m echanics is one of the m a jor achievem ents of the physics of the early twentieth century. This task included the establishment of connections between the m acroscopic state variables and their m icroscopic counterparts. Am ong the therm odynam ics variables, the external parameters, e.g. the volume of a gas, and the m echanical related quantities, e.g. the pressure, are easily interpreted m icroscopically. However, the non-m echanical therm odynam ical quantities, viz., tem perature, entropy and their various subsidiary quantities, are m ore cum bersom e to identify m icroscopically, since they are basically de ned within therm odynam ics, with no apparent m acroscopic m echanical equivalent quantity. The statistical m echanical analogues of tem perature and entropy are characteristic quantities of the ensemble distribution.

The concept of tem perature of a body lies in the very root upon which the whole science of therm odynam ics rests. It is connected to our common sense of \hot" and \cold ", and the zero law of therm odynam ics is the statem ent that this quantity can be compared by observing the behavior of bodies put in contact to each other. In statistical mechanics the tem perature can be related, via the theorem of equipartition of energy, to the am ount of kinetic energy per degrees of freedom of the system. W ithin the Boltzm ann-G ibbs (BG) approach, it is also associated with the constant that appears in the exponent of the canonical distribution.

An alternative form alism to the Boltzm ann-G ibbs therm odynam ics developm ent has been evolved in the last decade starting from the postulate of a generalized entropy form by T sallis [1]. Since then, a wealthy scientic bibliography has been produced presenting theoretical and experimental conmution of the generalized therm ostatistics. For a full and updated list of publications check [2].

It has been pointed out by Plastino [3] that systems with a small number of particles obey the generalized therm ostatistics. Moreover, it has been proven by Almeida [4] that both formalisms (Boltzmann-Gibbs and Tsallis) can be obtained via a common logical development based on the hypothesis of equiprobability on phase space, ergodicity and the use of structure functions.

Ourgoal in this paper is to present a microscopic interpretation for the tem perature within

T sallis therm ostatistics, generalizing the classical interpretation derived on the Boltzm ann-G ibbs formulation. This endeavor has been already considered by M artinez et. al. [5, 6] and P lastino et. al. [7]. However, our presentation, which is based on elementary techniques os statistical mechanics, leads to the resolution of disparities with the classical Boltzm ann-G ibbs approach that were encountered in these papers.

II. PRELIM INARY CONSIDERATIONS

Consider a system G with Ham iltonian H = H(q;p) and let denote its phase space. Let V (E) be the volume of the region of the phase-space where H(q;p) < E, and let (E) = QV(E)=QE denote the structure function [8], also known as density of states. Let's de ne the function

Let the system G be composed by two subsystems G_1 and G_2 with phase spaces $_1$ and $_2$, respectively. For i = 1;2, let's denote by $V_i(E)$ the volum e function in the phase space $_i$ of the region where $H_i(q_i;p_i) < E$, $_i(E)$ its respective structure function and $_i(E)$ the associated beta function.

If G_1 and G_2 are in weak interaction with each other, in the sense that $H(q;p) = H_1(q_1;p_1) + H_2(q_2;p_2)$, i.e., there is no term of interaction of G_1 with G_2 in the Ham iltonian, then the canonical distribution of the system G_1 in its phase space _1, when the total energy of G is E = a, is given by the density function [8]

and the structure function of the system G satis es the convolution relation

It has been shown in [4] that the form of $_1$ depends on the value of the parameter q_2 determined by

W hen $q_2 = 1$, $_1$ is an exponential (Boltzmann-Gibbs) and, when $q_2 \notin 1$, $_1$ is a powerlaw (T sallis) distribution. The function V_2 (E) can be obtained integrating Eq. (4). Let's assume that all of the volume functions $V_i (E)$ are such that $V_i (0) = _i (0) = 0$. Therefore, the general form of $V_2 (E)$ is

with C_2 a constant. An analogous procedure for the subsystem G_1 yields

with C_1 a constant. Hence, for i = 1;2,

From Eq. (3) we get that

$$(E) = C_{1}C_{2} - \frac{\frac{q_{1}}{q_{1}-1} + 1}{\frac{q_{2}}{q_{2}-1} + 1} E^{1=(q-1)};$$

where

and (x) is the gamma function. The function for G is then given by

From Eq. (9) we get that

$$V (E) = C_1 C_2 - \frac{\frac{q_1}{q_1 - 1} + 1}{\frac{q}{q_2 - 1} + 1} E^{q=(q-1)} :$$

The interpretation of the temperature is exactly the one based upon the theorem of equipartition of energy for the system G with total energy E = a, which m ight be expressed [9] in the form * +

where x_i stands for any of the variables p_i or q_i , k is the Boltzm ann constant and T is the absolute temperature. This is the same temperature de nition for the Boltzm ann-G ibbs

setting. Using the expressions for V (a) and (a), Eqs. (12) and (9) respectively, and the de nition of , Eq. (1), we may write the tem perature of the system G as

For a general system, we postulate that the function

$$T (G) = \frac{1}{kq} \frac{1}{(E)}$$

represents the physical tem perature of the system G.N ote that T is a function that depends on the observed part of the system. For the whole system G with constant energy E = a, we have that (a) = ((q 1)a)¹ and

Consider now the subsystem G_1 , which has a random energy E_1 distributed according to a probability density function [8][x15, pp. 75]

Therefore, the average value of the energy E_1 is

where B (m;n) is the beta function. Then, from Eq. (15) we get the value

which shows that the evaluation of T over any of the subsystem s $G_{\rm i}$ produces the same result.

Let's consider now the combination (weakly interaction) of two systems G_1 and G_2 , with parameters q_1 and q_2 respectively, to form a compound system G. Let's impose the condition that before the assembling T (G_1) = T (G_2), i.e.,

where a_1 and a_2 are the initial energies of the system s G_1 and G_2 respectively. Thus, the compound system G has energy $a = a_1 + a_2$ and parameter q related to q_1 and q_2 by Eq. (10). Therefore, computing T (G) using Eq. (15) we have

$$T (G) = \frac{1}{k} \frac{a}{\frac{q}{q-1}} = \frac{1}{k} \begin{pmatrix} a_1 + a_2 \\ \frac{q_1}{q_1-1} + \frac{q_2}{q_2-1} \end{pmatrix} = \frac{1}{k} \frac{a_1}{\frac{q_1}{q_1-1}} = T (G_1)$$

$$= \frac{1}{k} \frac{a_2}{\frac{q_2}{q_2 - 1}} = T (G_2); \qquad (26)$$

which implies that T (G), considered as a temperature scale, satis es the zero law of thermodynamics.

III. A P P L IC A T IO N

Consider now a system composed by N free particles in a con ned three-dimensional volum e V, i.e., an ideal gas system. It has been stated by P lastino and Lim a [7] that the virial theorem in the generalized therm ostatistics context leads to an equation of state for the ideal gas that is di erent from the usual Boyle's law; The Boyle's law being recovered in the lim it case of q ! 1. This con icting result was generated by the adoption of the tem perature T as inverse of divided by the Boltzm ann constant, $T = (k)^{-1}$. If instead of this we de ne the tem perature by the relation Eq. (15) we assure a priori the validity of the equipartition theorem in its classical form Eq. 13). The classical virial theorem for the ideal gas [10] states that

where r is the position vector of a particle and F_i is the generalized i force associated to q_i . Therefore, the de nition of temperature by Eq. (15) together with the classical virial theorem leads to the Boyle's law in its original form,

$$PV = N kT; (28)$$

even in the context of the generalized therm ostatistics.

IV. CONCLUSION

We have presented a microscopic identication of the temperature valid for both Boltzmann-Gibbs and Tsallis statistics. It was observed that the zeroth law of thermodynamics, the theorem of equipartition, and the equation of state for ideal gas are all valid in their classical form even within Tsallis framework, provided the adequate de nition of temperature is taken. The adoption of an inadequate form of the temperature leads to con icting results obtained by the BG and the Tsallis therm ostatistics, e.g. the modi ed Boyle's law deduced in [7].
