Signature of Spin Collective M ode in Local Tunneling Spectra of a d-w ave Superconductor

We consider the in uence of magnetic excitations on the local density of states in the d-wave superconductor. The magnetic susceptibility is calculated within the renormalized t t^0 J m odel and its in uence on the quasiparticle self-energy is considered using a minimal model originally proposed by Polkovnikov et al.[cond-m at/0203176]. We not the local density of states possess periodic components both along (;0) and (;) directions with the associated wavevectors changing in magnitude as the quasiparticle energy is varied. Comparison with the STM experiment reveals that the calculated LDOS modulation is inconsistent with the measured data.

Introduction: Observation of discernible \checkerboard" patterns in the local density of states (LDOS) has been reported for a superconducting $B_{1/2}Sr_2CaCu_2O_{8+}$ (BSCCO) compound in the mixed state, with the spatial periodicity close to four lattice constants [1]. Howald et al. reported the same periodicity exists for the LDOS in the same compound but without the magnetic eld [2]. Ho mann et al. in turn argued that this periodicity is in fact a function of energy, i.e. as the probing bias of the scanning tunnelling microscope (STM) is varied the spatialm odulation periodicity also changes system atically [3].

A num ber of theories have em erged in response to such striking set of observations [4{6]. Som e of these theories em phasize the possible em ergence of a new order param – eter near the vortex core [4] but, in view of the latest experimental nding β]m ay have di culty to explain how an induced order param eter can exhibit a length scale that depends sm oothly on energy. An alternative explanation advanced by W ang and Lee (W L) ascribes the periodicity to the quasiparticle scattering due to localized im purities [5]. In this approach scattering processes connect parts of the underlying Ferm i contours at di erent w avevectors as the quasiparticle energy is varied.

Q uite distinct from the proposal of W L is the theory of Polkovnikov, Vojta, and Sachdev (PVS) [6] who showed in a simple model that a dynamic spin uctuation mode with a distinct ordering wavevector Q may lead to observable periodic modulations in the local STM spectra at twice Q. They also invoke the local impurity pinning, which is necessary to break the translational symmetry and give rise to spatially varying LDOS. In principle the mechanism proposed by PVS does not depend on the presence of an external magnetic eld.

D ynam ical spin uctuations are observable in a number of families of cuprates. It has been shown that magnetic absorption peaks occur at incommensurate wavevectors (;), and (;) with varying with the absorption energy [7]. Brinckmann and Lee (BL) [8] argued that the underlying Ferm i surface topology in the superconducting state is responsible for such incom mensurate response. W ithin the Gutzwiller-renorm alized t t⁰ J m odel they indeed found the absorption peaks at (;), and (;) while at even low erenergies, the incom m ensurate peaks appear in the diagonal direction, (0 ; 0).

C oupled with the idea of PVS, it is worthwhile to ask whether such incommensurate magnetic spectrum will also modulate the LDOS at wavevectors that vary with the energy. In this paper, we exam ine this issue using the magnetic spectrum calculated from the renormalized t t⁰ J model. A ssum ing a simple interaction scheme between the spin of the quasiparticles and the magnetic excitation we evaluate the quasiparticle self-energy and thence the spatially varying LDOS. Ultimately our calculation is aim ed at a comparison with the latest experimental data [3], and in the process hope to gure out to what extent, if at all, the magnetic scenario for the observed periodicity is viable.

M ethods: W e adopt the renorm alized t t^0 J m odel [8] as the starting point:

In the above, $t_{eff} = tx + (J=4)^{P} hf_{j}^{y} f_{i} i; t_{eff}^{0} = t^{0}x; i_{j} = h f_{i} f_{j} i$, and x is the average doping. J_{eff} is the residual spin-spin interaction between quasiparticles.

From the above mean- eld H am iltonian one calculates the zero-tem perature magnetic susceptibility $_0$ (q;i), and through the residual spin-spin interaction $J_{eff}S_i$ S, the renorm alized spin susceptibility




FIG.1. Imaginary part of the magnetic susceptibility, $^{00}(q;) \mbox{ for } q = \ , \mbox{ and } 0 < q_k < 2 \ \mbox{ calculated from the renormalized t } t^0 \ \ \mbox{J m odel with } J_{\rm eff} = 0.34 \mbox{J. Di erent plots correspond to } = 0.12 \mbox{J}; 0.20 \mbox{J, and } 0.24 \mbox{J.}$

for J (q) = J_{eff} ($\cos q_x + \cos q_y$). In PVS's treatment the magnetic susceptibility is approximated by a phenomenological form, P_{VS} (q;i)¹ / ²+ ²_s+c² (q Q)², where s is the spin gap, and Q is the ordering wavevector. On the other hand, the t t⁰ J model result for the renorm alized m agnetic susceptibility is known to exhibit a continuous set of ordering wavevectors with respect to energy [8]. We show a horizontal scan of the imaginary part $^{(0)}(q;)$ with $q_r = for a series of energies ! in Fig. 1. The incom mensurate peaks near <math>q_x = are$ obvious, and both these peaks and the less pronounced peaks near $q_k = 0$ m ove tow and $q_k = when the energy is raised. In particular the peaks at ((E);) may give rise to a modulation in the charge sector with twice the wavevector [6,9], i.e. at (2 2 (E); 2) (2 (E); 0). With$

(E) being a decreasing function of energy, one naively expects LDOS m odulation wavevectors to decrease at a higher bias as well, in qualitative agreement with the experiment $[\beta]$. Below, we exam ine through explicit calculation whether this naive argument will hold.

The treatment can proceed by positing the elective action $L = L_M + L_{qp} + L_{qp M}$ consisting respectively of the magnetic and quasiparticle sectors and their coupling. For the magnetic part [6],

Space-time coordinates are denoted by x = (r;) and $y = (r^0; {}^0)$. The last term is the pinning potential, b-cated around r_i , for the spin density wave (SDW). Due to the pinning term the propagator h (r;i!) $(r^0;i!)$

(r;r⁰;i!) is no longer translationally invariant.

The quasiparticle coupling to the uctuating SDW is modelled by [6]

Through this term the quasiparticle propagator is in uenced by the collective mode, and exhibits translational symmetry breaking. The perturbative treatment of the e ective interaction is straightforward, with the one-loop result for the change in G reen's function G [10],

where T (i) = (r = 0;i). Frequency dependence in the coupling g(i) is introduced for generality. In arriving at this expression we have only kept those terms that break the translational symmetry and ignored the space-independent self-energy correction. A fler the W ick rotation, i! ! + i , the spatially varying LDOS is N (r; !) = (1 =)Im G (r; r; ! \pm i).

Norm ally the sum mation i is carried out analytically, and the resulting expression is evaluated by numerical means after the W ick rotation i! ! ! + i . In our case the renorm alized susceptibility (q;i) does not possess a simple Lehm ann expansion, which prevents the frequency summation from being carried out. Instead we resort to the time-ordered G reen's function method (as opposed to the M atsubara G reen's function method) which does not require the W ick rotation. At zero tem - perature LDOS can be obtained from the time-ordered G reen's function by (T = time-ordered)

Perturbation theory proceeds in entirely analogous manner, and we only quote the nal result for the G reen's function correction.

The time-ordered susceptibility $_{T}$ and G reen's function G_{T} are obtained from their M atsubara counterparts by i! ! + isgn(!).

Results: We evaluate Eq. (7) numerically on a large lattice of dimension [201 201] using self-consistently determ ined parameters $_{m ax} 2h f_i f_j ij = 0.48J$. The impurity site is located at the center, $r_i = (101;101)$. We use $J_{eff} = 0.34J$, and the broadening factor = 0.01J in evaluating (r;) and G (r;). The -integration is replaced with a discrete sum, d f()!

 $_{s}$ f (s), where s is an integer, s_{max} s s_{max} . The following results are taken with = 0.04J, and s_{max} = 14 in plying that virtual processes with the o - shell energy of up to 0.56J are taken into account in the self-energy evaluation. The commensurate response at q = (;) in the susceptibility occurs at $_{res}$ 0.32J for the present model, while at energies above and below $_{res}$, the resonance occurs away from (;) [8]. Our self-energy energy calculation therefore includes e ects from both above and below the resonance energy. We have con med on a smaller lattice that using a ner scale = 0:02J does not change the nalresult qualitatively. The on-site G reen's function $G_r(r;r;!)$ is evaluated for a subset of the lattice, typically for r lying in [101 101] about the impurity center, for j! jup to 0:32J. The real-space LDOS thus obtained is then Fourier-transformed according to N $(q;!) = r^{e^{iq} r} N(r;!)$.

Plots in Fig. 2 show N (q;!) calculated with the coupling constant q^2 () = const. Apart from the q = 0peak, we nd som e prom inent peaks along both diagonal (m eaning (;)) and horizontal (m eaning (; 0) and (0;)) directions. The peaks are located near the ends of the Brillouin zone at a sm all bias, and move toward q = 0 as the bias energy is increased. A horizontal (diagonal) scan of N (q;!) allows the identication of wavevectors $q_h(!)$ ($q_d(!)$) for which N (q_i !) is a lo- $\operatorname{calm}\operatorname{axim}\operatorname{um}$. The values of $\operatorname{q}_{\operatorname{d}}(!)$ $jq_d(!) \neq 2$ and jq_h (!) j are plotted in Fig. 4(a). C learly both q_h (!) $q_{i}(!)$ and $q_{i}(!)$ are decreasing functions of energy. The detailed shape of N (q;!) how ever depends som ew hat on whether V is negative (electrons tunneling out) or positive (electrons tunneling in).

As shown in Fig. 1 the magnetic absorption peaks are most pronounced around (;). Note how ever that the Green's function shown in Eqs. (5) and (7) are a product of several com plicated functions, and the magnetic absorption spectrum alone does not a priori characterize the LDOS. In this regard we can loosely classify the structures in (q;) as those near (;0); (0;), and those near (;). In the result shown in Fig. 2 contributions from these two regions will undoubtedly be m ixed. Instead, if we truncate the magnetic spectrum to be within a certain vicinity of (;), the quasiparticle G reen's function will also be in uenced by the magnetic excitations at these wavevectors, and none from around (;0); (0;). This is achieved by using the reduced susceptibility red(q;) = (q;) for $=4 < q_{i}q_{v} < =4$, red (q;) = 0 otherw ise. Its Fourier transform red (r;) is used in the evaluation of the new LDOS, N $_{\rm red}$ (r;!) and $N_{red}(q;!)$, shown in Fig. 3. In this calculation we use the cuto $q^2() = q^2(0) \exp[0:1(1 + t^2)]$. For a less sharp cuto such as $q^2() = q^2(0)$ or $q^2() =$ $g^2(0) \exp[0:1j = j]$, we nd no other distinguishable structure in N red (q;!) except a broad hum p centered at q = 0.




FIG.4. Energy dependence of $q_i\left(!\right)$ and $q_h\left(!\right)$ (de ned in the text) obtained from N (q;!) (Figure (a)) and from N $_{\rm red}\left(q;!\right)$ (gure (b)). In each gure, four data sets are shown for $q_i\left(!<0\right)$ (nd), $q_h\left(!<0\right)$ (nh), $q_i\left(!>0\right)$ (pd), and $q_h\left(!>0\right)$ (pd) against j! j. Note that all the q values decrease with energy j! jin (a), and increase in (b).

There is very little overlap between the two gures 2 and 3, as also re ected in the q(!) and $q_{h}(!)$ values obtained respectively from each gure. Figure 4(b) shows the peak intensity position of N red (q;!). Essentially all q_i (!); q_n (!) are greater than =2 in the N (q;!) while in the reduced LDOS, all q_d (!), and q_h (!) are less than =2. Furthermore, $q_i(!)$ and $q_n(!)$ in Fig. 4(b) are increasing functions of energy, as opposed to Fig. 4(a) where they are decreasing. In both plots, q_d (!) and $q_h(!)$ show the same dependence on energy, being both increasing or both decreasing functions. As previously mentioned a standard G inzburg-Landau argum ent about the coupling between SDW and charge-densitywave (CDW) [9] in plies that an ordering tendency occur-) for the SDW will lead to CDW modring at (; ulations at (2; 2). Naively, since decreases with energy, one expects q_h (!) in Fig. 4 (b) to be a decreasing function of !, which is contradicted by our calculation. In obtaining Fig. 3 we (1) truncated the magnetic spectrum within a small momentum window around (;) and (2) modi ed the coupling q'(). With this manipulation we were able to bring out features in the LDOS which were \hidden" in the calculation that led to Fig. 2. Since the coupling constant g must in reality be a function of both momentum and energy, one cannot be too certain a priori which of the features found in Figs. 2 and 3 are m ore readily observable in an experim ent.

D iscussion: We now come to comparison of our result with the experim ental data. First, it has been found in Ref. [3] that while $q_i(!)$ increases, $q_h(!)$ decreases at a larger bias j! j. This is in contrast to our calculation where both $q_i(!)$ and $q_i(!)$ behave analogously with respect to energy. Secondly, experimentally measured k_h (!) values are found to lie below =2 for a wide range of energies and hole doping, which m ay be consistent with F igure 4 (b), but in this case the energy dependence is opposite to our calculation. In F ig. 4 (a), q_i (!) and q_h (!) values are rather high which, translated into real space, in plies LDOS m odulations on the length of 2 4 lattice spacings. W hile such m agnetic- uctuationinduced LDOS variations are not forbidden and m ay very well be observable in the future, we m ust conclude that the LDOS m odulation based on the t t⁰ J m odel of the m agnetic excitation is inconsistent with the currently known experiment [3].

It is possible that the renorm alized t t^0 J m odeldoes not after all capture the quasiparticle band structure of the BSCCO and that in another model, one indeed nds the energy dependence of q_i and q_h consistent with the experiment within the magnetic uctuation scenario. For example, in W L [5], the model adopted is the phenom enological tight-binding model originally proposed by N orm an [11].

On the theoretical side, one should be careful that the naive G inzburg-Landau argument for SDW - CDW coupling m ay in some cases lead to predictions which are inconsistent with a full many-body calculation such as this one. Although the patterns in N (q;!) are ultimately due to the underlying magnetic uctuation, the reason for the particular energy dependence of the modulation period found in Figs. 2 and 3 remains unclear. Finally an entirely di erent mechanism such as W L's are not incom patible with the present model, and m ay well sim ultaneously lead to observable elects in a given system.
