# Statistical M echanics of

the Bayesian Im age Restoration under Spatially Correlated Noise

### Abstract

We investigated the use of the Bayesian inference to restore noise-degraded in ages under conditions of spatially correlated noise. The generative statistical models used for the original in age and the noise were assumed to obey multi-dimensional Gaussian distributions whose covariance matrices are translational invariant. We derived an exact description to be used as the expectation for the restored in age by the Fourier transformation and restored an image distorted by spatially correlated noise by using a spatially uncorrelated noise model. We found that the resulting hyperparameter estimations for the minimum error and maximal posterior marginal criteria did not coincide when the generative probabilistic model and the model used for restoration were in di erent classes, while they did coincide when they were in the same class.

#### I. IN TRODUCTION

Recent research has shown that the Bayesian inference is a useful approach to the inage restoration problem [1]-[3]. However, previous research has usually assumed that the superim posed noise is not correlated between pixels [1]-[12]. Statistical mechanics provides a useful method for analyzing the image restoration problem [4],[5]. Still, when we take optical e ects into consideration, it seems natural to take spatially correlated noise into account. We have investigated in age restoration under the condition of spatially correlated noise. We considered a case in which both the original image and noise obey a Gaussian distribution composed of translational-symmetric matrices. We were able to diagonalize the Gaussian distribution by using Fourier transformation. While previous research was done using spatially uncorrelated noise, we considered the availability of a spatially uncorrelated noise model against spatially correlated noise.

We considered tow methods for estimating the hyperparameters. The rst is minimizing the mean squared error - the hyperparameters are set so that the mean squared error is minimized. However, minimizing the mean squared error is not applicable to the image restoration problem because we need the original image to practice this method. The second method is maximizing the marginal likelihood [6] - the hyperparameters are estimated by maximizing the marginal likelihood acquired from only the distorted image. When the noise probabilities for generating and restoring coincidence are the same, the results given by the two methods are the same. When the probabilities are diment, we found that they are not.

### II. MODEL

The images we see in our daily life are always two-dimensional, although we assume a d-dimensional image form athem atical generalization, where the length of each side is L and the total number of pixels, N, is  $L^d$ . The i-th pixel value, i, of an original image can be written in a multiple G aussian distribution as

where and h are positive scalar values, G is a matrix, and I is the unit matrix. The partition function,  $Z_{prior}(;h)$ , is given by

Note that Eq. (2) is called the H am iltonian in statistical mechanics. In this paper, we argue that matrix G is translational invariant and that element  $G_{i,j}$  is given by [5]

Equation (4) m eans that interactions occur only between nearest-neighbor pixels. If takes a large value, i.e., the interaction of the rst term has a large e ect, the neighboring pixels tend to take the sam e value. W hen h is large, the absolute value of the pixels tends to be sm all. Furtherm ore, we use a periodic boundary condition,

The distorted image, =  $f_{ig}$ , is generated according to the following conditional probability, which obeys a Gaussian distribution:

where R is a translational invariant covariance matrix. In this paper, we consider the following spatially correlated noise:

0 a 1. The noise obeys an identical independent G aussian distribution with m ean 0 and variance  $b^2$ , when a = 0.

A general strategy commonly used in image restoration is to apply the Bayes formulation to the posterior probability. Here, is a restoration image based on the Bayes formulation. W hen a distorted image, , is given, one can use the formulation to calculate the restored image, :

# III. THEORY

### A. Expectation of the restored im age

Since the covariance matrices given by Eqs. (4) and (10) are translational invariant, they can be diagonalized using the discrete Fourier transform ation.

The discrete Fourier transform ation is

, h, and  $\mathbb{R}_k$  are unknown adjustable parameters that determ ine the properties of the original in age and noise. One of our major focus here is how to estimate these hyperparameters precisely.

To proceed further, we have to assume some explicit form of the source prior and noise posterior form ations, which are used when we restore the image. In this paper, we de ne both of these probability form ations as the same form ation except that they have di erent hyperparameters. We de ne the hyperparameters that correspond to ;h;, and  $\hat{\mathbf{R}}_k$  as  $\hat{\mathbf{R}}_k$ , respectively. If  $\hat{\mathbf{R}}_k$  is independent of k, the noise is spatially uncorrelated.

In this paper, we regard Eq. (27) as representing the restored in age.

B. M inim ization of m ean squared error

In this subsection, we estimate hyperparameters  $\hat{r}$ ,  $\hat{h}$ , and  $\hat{R}_k$  by using the criterion dened by Eq. (27) form inimizing the mean squared error between the original and restored in ages. The expectation of this mean squared error,  $E_1$ , is represented by

M ore precisely, when the ratio  $\hat{:} \hat{h} : \hat{R}_k$  is equal to the ratio  $:h : R_k, E_1$  is the minimum given by Eq. (37). Note that this equation represents the lim it of the restoration.

# C. Maxim ization of the marginal likelihood

The m inim ized m ean squared error criterion generally cannot be used since the unknown original im age itself is needed to evaluate the squared error. If we already had the original im age, there would be no need to restore the distorted im age. Hence, in this paper, we argue for using the maxim ization of the marginal likelihood.

As shown in Eqs. (1) and (8), we already know the source prior and noise probabilities. Using both probabilities, we can derive P():

## P ( ) is called the marginal likelihood.

M axim ization of the marginal likelihood is used to set the hyperparameters,  $\hat{r}$ ,  $\hat{h}$ , and  $\hat{R}$ , to use to obtain the maximum value of P () for distorted in age.

W ith Eqs. (3) and (9), the marginal likelihood is given by

In this section, we consider a m ethod to restore an image distorted by spatially correlated noise by m eans of the spatially uncorrelated noise m odel. To do this, we replace R as one

of the hyperparam eters:




FIG.1: M ean squared error between original and each restored in age. H orizontal axis denotes a from Eq. (10); vertical axis denotes m ean squared error. (A) Optimum decode given by Eq. (37). (B) Restored using criterion of m inimum restored error. (C) Restored using  $\hat{r}$  estimated by m axim izing m arginal likelihood. (D) Restored using  $\hat{r}$ ;  $\hat{h}$ , and  $\hat{r}$ , all estimated by m axim izing m arginal likelihood. (E) Error before decoding given by Eq. (39).

Figure 1 shows the analytical and simulated mean squared errors between the original




FIG. 2: Estimated f. Horizontal axis denotes a from Eq. (10); vertical axis denotes average estimated f obtained by maximizing marginal likelihood or optimal f obtained using criterion of minimum restored error. Solid line (B) denotes f used in Fig. 1 (B), dashed line (C) denotes f used in Fig. 1 (C), and dotted line (D) denotes f used in Fig. 1 (D).




FIG. 3: Estimated  $\hat{h}$  (dotted line) and  $\hat{}$  (dashed line). Both values were averaged with respect to 100 articially generated in ages. Horizontal axis denotes a from Eq. (10); vertical axis denotes average estimated  $\hat{h}$  or  $\hat{}$  or actual h or  $\hat{}$ . Solid line denotes actual h (= = 1:0).

in age and each restored in age, Fig. 2 shows the estimated  $\hat{r}$ , and Fig. 3 show the estimated parameters  $\hat{h}$  and  $\hat{}$ . We used 100 articially generated two-dimensional N =  $16^2$  images with hyperparameters = 1:0, h = 1:0, b = 0:75, and = 3:0. The horizontal axes of these three gures denote a from Eq. (10); a represents the magnitude of the spatial correlation of the noise (a = 0 implies no spatial correlation).

### A. M inim ization of m ean squared error

Curve (E) in Fig. 1 represents error  $E_2$  given by Eq. (39), that is, the mean squared error between the original and distorted in ages. (The dashed line represents the analytical

error, and the solid line represents the simulated results.) Because the numbers of pixels  $(N = 16^2)$  and samples (100) were nite, the simulated results have some uctuation. This uctuation tends to asymptotically disappear as the numbers are increased.

Curve (A) in Fig. 1 represents minimum error  $E_{1_{min}}$  given by Eq. (37), that is, the mean squared error between the original and distorted in ages restored using the spatially correlated noise model with the best parameters. Hence,  $E_{1_{min}}$  implies the limits of in age

restoration-no further error reduction is possible. Curve (B) in Fig. 1 represents the error in an image restored using the uncorrelated noise model. The restoration was done using hyperparameter  $\hat{r}$  from Eq. (28), which was acquired minimizing the mean squared error. (The dashed line represents the analytical results, and the solid line represents the simulated results.) Curve (B) in Fig. 2 shows the optimal values of  $\hat{r}$  by minimizing the mean squared error.

Note that when a = 0.0, curve (A) in Fig. 1 is equal to curve (B). Curve (B) in Fig. 1 shows the optimum performance when using the minimization of the mean squared error as the criterion. However, as mentioned, the hyperparameters cannot be estimated in practice by minimizing the mean squared error. Therefore, we will discuss how the error can be reduced by maximizing the logarithm is marginal likelihood in the next subsection.

B. Maxim ization of the marginal likelihood

Substituting Eq. (44) for Eq. (45), we get

W e can then determ ine the convergence point by m eans of an iterative calculation.

W e next determ ined the unknown hyperparameter,  $\hat{r}$ , by maximizing the marginal likelihood, assuming that  $\hat{r} = -and + \hat{h} = h$ . Thus, we restricted ourselves to the case where the generation model of the image was already known, as was and h. Curve (C) in Fig. 1 shows the mean squared error when the image was restored using the estimated  $\hat{r}$ . Curve (C) in Fig. 2 shows the estimated  $\hat{r}$ .

Note that the di erence between curve (B) in Fig. 2, the lim it of the restoration, and curve (C), obtained by minimizing the mean squared error increased with the noise correlation parameter, a. Therefore, the error obtained by maximizing the marginal likelihood (curve (C) in Fig. 1) increases with the noise correlation parameter, a. This implies that without know – ing the noise model, estimating the hyperparameters by maximizing the marginal likelihood does not work well. That is, the conventional uncorrelated noise model cannot cope with spatially correlated noise.

To con m this, we used m aximization of the marginal likelihood to estimate  $\hat{h}$  the hyperparameters of the image-generation probability-as well as  $\hat{r}$ . Curve (D) in Fig. 1 shows the mean squared error estimated using hyperparameters  $\hat{h}$ ,  $\hat{h}$ , and  $\hat{r}$ . Curve (D) in Fig. 2 shows the obtained  $\hat{r}$ , and Fig. 3 shows the obtained  $\hat{n}$  and  $\hat{h}$ . The error shown by curve (D) in Fig. 1 is much greater than that shown by curve (C).




FIG. 4: M ean squared error and m arginal likelihood. H orizontal axis denotes hyperparameter  $\hat{r}$ ; left vertical axis denotes m ean squared error (B) given by Eq.(35); right vertical axis denotes logarithm ic m arginal likelihood (C) given by Eq.(47). The parameters were a = 1.0, = 1.0, h = 1.0, and = 3.0. Those used for (B) correspond to those for curve (B) in Fig. 1 when a = 1.0. Likew ise, those used for (C) correspond to those for curve (C) in Fig. 1 (C) when a = 1.0.

Next, we demonstrate that the logarithm ic marginal likelihood, curve (C) in Fig. 1, does not have a local maximum and that the iteratively obtained solution of Eq. (49) corresponds to the global maximum. Curve (B) in Fig. 4 shows the mean squared error, E<sub>1</sub>, given by Eq.(35), and curve (C) shows the logarithm ic marginal likelihood,  $\ln (P_{app}())$ , given by Eq. (47). The horizontal axis denotes  $\hat{r}$ . Curve (B) shows that E<sub>1</sub> takes a minimum value, E<sub>1</sub> = 0.12, at  $\hat{r}$  = 32. The parameters used for curve (B) correspond to those for curve (B) in Fig. 1 when a = 1.0. Curve (C) shows that that the logarithm ic marginal likelihood takes a maximum value, E<sub>1</sub> = 0.28, at  $\hat{r}$  = 0.2. The parameters used for curve (C) correspond to those for curve (C) in Fig. 1 when a = 1.0. The important point is that the logarithm ic

m arginal likelihood, curve (C) in Fig. 4, does not have a localm axim um.

### C. Sam ple of im ages




FIG.5: Articial in ages. N =  $64^2$ .

Next, we show the practical signi cance of these di erences for a typical set of arti cial in ages. Figure 5(a) shows an original in age generated using hyperparameters = 0.5 and  $h = 1.0^4$ . Figure 5(c) shows the same in age after it was distorted by the noise shown in Fig. 5(b) (a = 1.0; b = 0.75, and = 3.0). The mean squared error, E<sub>2</sub>, between the original and distorted in ages was 0.57. Figure 5(d) shows the in age after it was restored using the complete restoration m odel: the generation m odel and noise m odel were consistent with the original m odels, and optim um values were used for the hyperparameters. When a = 1.0, curve (A) in Fig. 1 corresponds to Fig. 5(d), and the restored mean squared error, E<sub>1</sub>, is 0.27. Figure 5(e) shows the in age after it was restored using an uncorrelated noise m odel with hyperparameters obtained by maximizing the marginal likelihood. When a = 1.0, curve (D) in Fig. 1 corresponds to Fig. 5(e), and the restored mean squared error is 0.45. The in age in Fig. 5(d) resembles the original one, Fig. 5(a), while the one in Fig. 5(e) is similar to the distorted one in Fig. 5(c) and books slightly out of focus.




FIG.6: Natural in ages. N =  $64^2$ .

Furtherm ore, we show the results when natural in ages were used. Figure 6 shows the



(a) Original image

natural in ages and a table of the estimated parameters. We used b = 0.75 and = 3.0 for the noise parameters and three values for a: 0.0, 0.5, and 1.0. The three in ages on the left are distorted, and those on the right are the same in ages restored using  $\hat{}$ ,  $\hat{h}$ , and  $\hat{r}$  estimated using the maximized marginal likelihood. In this simulation as well,  $E_1$  increased with the noise correlation parameter, a. This tendency is rejected in the three restored in ages. For a = 1.0, the lower right in age, the noise looks like a stain that was not completely rem oved.

### D. Discussion




FIG. 7: M ean squared error between original in age and restored in age. The horizontal axis denotes a from Eq. (10), and the vertical axis denotes the m ean squared error. As a criterion, the optim all decode given by Eq. (37) is used. The parameters b = 0.75, and  $N = 64^2$  are xed. For the solid line (i), the other parameters were set as = 1.0; h = 1.0, and = 3.0. For the dashed line (ii), the other parameters were set as = 0.5;  $h = 10^4$ , and = 7.0.

Here, we consider why line (A) in Fig. 1 tends to decrease as a approaches 1:0. This phenom enon appears to be universal, and also occurs with another parameter set as shown in Fig. 7 (ii). For reference, we also show line (i) which is based on the parameter set that

was used in Fig. 1(A) with only N changed to  $N = 64^2$ . (Note that line (A) is independent of N).

For the original image, we used the Gaussian model represented by Eq. (1), which has neighboring interactions on each pixel. For the noise image, we used the Gaussian model represented by Eq. (8), in which the interaction is Gaussian functionally decreased. We expected the dimension between these two models to become conspicuously large near




FIG. 8: Typical in ages about Fig. 7 (ii).  $N = 64^2$ . Parameters for the original in ages were = 0.5 and h = 10<sup>4</sup>. The three original prepared in ages were the same. Parameters for noise in ages were = 0.5; h = 10<sup>4</sup>; = 7.0, and b = 0.75. Only a was changed. Note that when a = 0.55, the original and noise in ages were visually similar, and the restoration quality was lower in this case.

a = 1.0, and this di erence between the models would enable successful restoration near a = 1.0. Figure 8 shows the typical in ages about Fig. 7 (ii). The distorted in age was most di cult to restore in Fig. 8 when a = 0.55, as shown in Fig. 7 (ii). In this case, the original and the noise in ages were visually sim ilar; more precisely, the correlation lengths of the two in ages were sim ilar. Thus, to successfully restore a distorted in age, it is desirable that the statistical properties of the original in age should be di erent from those of the noise in age.

Here, we sum marize our explanation of why line (A) in Fig. 1 decreases near a = 1.0. As a approaches 1.0, the mean squared error decreases because the dimension of the statistical properties, especially the correlation length, between the two in ages enables easier restoration. Conversely, the mean squared error is greater at a = 0.55 on line (ii) in Fig. 7 because the correlation-length similarity between the images makes it dimension is greater at a = 0.55 on line (iii) in Fig. 7 because the correlation-length similarity between the images makes it dimension. To ensure successful restoration, the correlation length of the original image should be dimension that of the noise image, which is the case when a = 0.00 and a = 1.00 in Fig. 8.

### V. CONCLUSION

W e investigated the use of the Bayesian inference to restore in ages under conditions of spatially correlated noise. W e assum ed that both the original in age and the noise obeyed a G aussian distribution composed of translational symmetric matrices. W e used the Fourier transform ation to diagonalize the covariance matrices, which enabled us to apply various forms of statistical analysis. W e obtained the expected value of a restored in age and obtained the optim al analytical hyperparameters by m inim izing the m ean squared error and used these hyperparameters to determ ine the generation and noise models. Furtherm ore, we discussed whether the conventional spatially uncorrelated noise model could cope with the spatially correlated noise or not. W e used two methods to estimate the hyperparameters: m inim izing the mean squared error and maxim izing the marginal likelihood. The di erence between the errors obtained using the two methods increased with the noise correlation parameter. The restoration error was larger when we used the hyperparameters obtained using the maxim izing the maxim izing the maxim izing the maxim is approximated the spatially conventional spatially when we used the hyperparameters obtained using the maxim is action of the marginal likelihood method. Thus, the conventional spatially

uncorrelated noise model could not cope with the spatially correlated noise.
