Frequency behavior of R am an coupling coe cient in glasses

Low -frequency R am an coupling coe cient C () of 11 different glasses is evaluated. It is shown that the coupling coe cient demonstrates a universal linear frequency behavior C () / (= $_{\rm BP}$ + B) near the boson peak maximum, $_{\rm BP}$. Frequency dependence of C () allows to separate the glasses studied into two groups: the rst group has a frequency independent contribution B ~0.5, while the second one has B ~0. It was found that C () demonstrates a superlinear behavior at very low frequencies. This observation suggests vanishing of the coupling coe cient when frequency tends to zero. The results are discussed in terms of the vibration wavefunction that com bines features of localized and extended modes.

I. IN TRODUCTION

O ne of the m ost interesting topics in solid state physics is the nature of the low-frequency (0.1-3 THz) collective vibrations in glasses. W hile these frequencies are in the range of acoustic excitations, there are experim ental evidences that the vibrations are not pure acoustic plane waves and their density of vibrational states g() does not follow the D ebye behavior $(/ ^2, where is a frequency)$. A maximum in $q() = {}^{2}$ that appears at some frequency BP is usually called the boson peak. V ibrations around the boson peak can be studied by several experimental techniques: low-tem perature speci c heat and therm al conductivity¹, inelastic neutron² and X-ray^{3;4} scattering, infrared absorption⁵ and R am an scattering⁶. In the case of the low-frequency R am an spectroscopy, the density of vibrational states appears in the light scattering spectrum via the so-called light-vibration coupling coe cient, C (),⁷

where I () is the R am an intensity for the Stokes side of the spectrum , and n is the Bose factor.

A know ledge of C () and an understanding of its frequency dependence have signi cant in portance for the topic of the low-frequency vibrations. First of all, a know ledge of C () provides a relatively simple method to extract the vibrational density of states from a Raman experiment. Secondly, the light-vibration coupling coe cient contains inform ation on the vibrational wavefunction⁷ and, therefore, can be used as a test of di erent m odels.

Two classical models suggested for the description of C () lead to di erent predictions: (i) Shuker and G am m on⁷ assumed that vibrations are localized on a distance much shorter than the light wavelength and predicted C () = const, while (ii) M artin and B renig⁸ have demonstrated that a polarizability disorder mechanism applied to slightly dam ped acoustic waves leads to C () ~ ² behavior at low frequencies and a peak at higher frequencies, related to a correlation length of the polarizability uctuations. It was shown that quasiplane acoustic waves with nite mean free path, ', will also contribute to the low-frequency Ram an spectrum with C () ~ ², when ` ¹ / ⁴, Ref.^{6;9}, or with C () = const, when ` ¹ / ², Ref.^{9;10}.

There are a few challenges for experim ental evaluation of the true vibration coupling coe cient: Very low tem – perature data for both –R am an spectra and g() – should be used in order to avoid a quasielastic contribution (fast relaxation)^{6;11}; it is not obvious whether all vibrations at one frequency contribute to the R am an spectra with the sam e C (), or there are di erent kinds of vibrations and each contributes with its own C (). A com parison of the low -tem perature low -frequency R am an spectra of glasses with the total g() obtained from low -tem perature speci cheat or inelastic neutron data has dem onstrated that the coupling coe cient appears to vary nearly linearly with frequency^{12 {16}.

However, this comparison did not consider the possibility that two di erent kinds of vibrational excitations could co-exist around the boson peak. A lthough most of the authors at present accept the idea that the vibrations around the boson peak are strongly hybridized and can not be easily separated, the question is not yet completely settled. This question became especially in portant in the light of the results of Hyper-Ram an scatterring experiments¹⁷. The existence of dierences in the behavior of THz spectra in Ram an and Hyper-Ram an scattering experim ents was interpreted as evidence of the co-existence of two types of vibrational excitations. A lso, there are theoretical approaches describing the THz dynam ics of glasses as a co-existence of two di erent types of vibrations in this spectral range (for example,^{18;19}). In this case, the Ram an coupling coe cient can lose its good physicalm eaning²⁰. One of the strong argum ents in favor of the existence of a single type of vibrational excitation could be the universal behavior of C () for glasses with various structures. This universality suggests that the two hypothetical types of vibrations are interrelated.

A detailed analysisperform ed for silica glass has show n that C () varies linearly with frequency,

in the range 10-50 cm 121 . This result was interpreted in 21 as an evidence that the coupling coe cient extrapolates to a nonvanishing value in the lim it ! 0. How – ever, it was shown in 22 that the coupling coe cient dem onstrates a superlinear behavior just below 10 cm 1 , i.e. the observed linear behavior can not be extrapolated to zero frequency. It would be very in portant to know whether this behavior is general also for other glasses.

The present contribution analyzes the frequency behavior of the coupling coe cient in a broad set of different glasses, strong and fragile, covalently and ionically bonded, low molecular weight and polymeric. It is shown that all glasses demonstrate the linear behavior of C () (eq.(2)) around the boson peak frequency. One of the most striking results is that there are two groups of glasses. One has a frequency independent contribution B with a universal value ~0.5, while the second group of glasses has B 0. An interpretation of the results is proposed and a correlation with low-tem perature therm al conductivity is found.

II. R E SU LT S

The density of vibrational states must be known in order to extract the Raman coupling coe cient (see, eq.(1)). It has been show $n^{6;11;23}$ that relaxation-like processes give signi cant contribution to the R am an spectra and g() at frequencies below the boson peak even at tem peratures as low as 50 K. Thus, experim ental data obtained at T below 50 K should be used for extracting vibrationalg(). Two experimental techniques provide information on g(): inelastic neutron scattering² and measurements of low-temperature speci cheat. The latter has a few advantages: (i) the num ber of glasses for which speci cheat data are available is much larger than the num ber of glasses for which inelastic neutron scattering data are available; (ii) the density of states calculated from low-tem perature speci c heat data corresponds to a very low tem perature, where usually no neutron data are available. While in the past only a phenom enological analysis was available for extraction of the coupling coe cient from the comparison of the speci c heat and Ram an data (for example, $1^{13;24}$), recently it was shown that the integral equation for speci c heat tem perature dependence can be solved num erically and therefore the density of vibrational states may now be obtained from heat capacity m easurem ents 22 .

 SiO_2 . The low-temperature density of states of H eralux silica glass was calculated from the speci c heat

data published in²⁵ using the procedure described in details in²². It was shown in this work that the density of states obtained from the speci c heat data is in excellent agreem ent with the one measured by inelastic neutron scattering^{21;26}. Low tem perature polarized R am an data from Heralux glass were taken from 27 (T = 7 K) and depolarized data taken from 28 (T = 10 K). The Ram an coupling coe cient for the density of states evaluated from the speci c heat data is in good agreement with that calculated from comparison of the Ram an and neutron data^{12;21} (Fig.1). Note that the deviation of C () of R ef.²¹ in the high-frequency part is related to di erent kinds of silica glasses used for light and neutron scattering. The di erence between the results reported in¹² and those reported in²² at very low-frequencies is related to the presence of a quasielastic contribution at T = 50 K(low est tem perature used in Ref^{12}) in the range < 10 cm¹. This di erence stresses the importance of using very low temperature data for estimates of the vibrationalC().

Fig.1 dem onstrates (see also the inset) that in the frequency range 10-40 cm 1 the coupling coe cient varies linearly with frequency, C () / (= $_{\rm B\,P}$ + B). The coupling coe cient is proportional to frequency in the range from ~40 cm 1 up to ~120 cm 1 . A superlinear behavior is observed below 10 cm 1 . In the Raman experiment of $\operatorname{Ref}^{27}_{\bullet}$, the signal in the range 7-8 cm⁻¹ was so weak that it was not possible to detect it. In this case only an estimate of the upper limit of the signal is available. This estimate was used for the calculation of the upper $\lim it for C$ () at frequencies 7-8 cm 1 . The open circles in Fig. 1 show the upper lim it of the coupling coe cient (for the polarized spectrum). Thus, it is very likely, that the linear behavior of C () observed in^{21} is restricted to frequencies above 10 cm 1 , but the coupling coe cient has another frequency dependence for $\ < \ 10$ cm $^{-1}$. A lso than linear at < 10 cm⁻¹. Further measurements of Ram an scattering in silica glass at low frequencies and low tem peratures (< 10 K) are needed in order to clarify the frequency behavior of the coupling coe cient at < 10 cm 1 .

 B_2O_3 . The density of states was calculated from the speci c heat data of the D 5 sam ple published ir^{29} . The speci c heat data of 29 were extended above T=20~K by the results published in^{30} (the results of 29 show that the speci c heat data of di erent boron oxide glasses collapse to a single curve above $\sim\!15~K$). Ram an data m easured at T=15~K were taken from 31 (the sam ple used in^{31} is identical to D 5 from 29 as it follows from Ref. 32). The calculated coupling coe cient (Fig.2) is in good agreem ent with the one published in^{18} . Fig2. shows that the frequency behavior of the coupling coe cient in B_2O_3 glass is linear below 30 cm 1 and is proportional to $^{0.5}$ above 30 cm 1 .

Se. The density of vibrational states of Se glass was calculated from speci c heat data published $in^{33;34}$. In the range 10-60 cm⁻¹, this calculation is in fair agree-

m ent with the results of neutron scattering at T = 100 K published in³⁵. The depolarized Raman spectrum of Se glass at T = 6 K was taken from ¹³. The coupling coef-

cient (Figure 3) was calculated using density of states evaluated from both, speci c heat and neutron scattering data. It is linear in the range 5-20 cm 1 and varies m ore strongly than linearly above this range. The superlinear behavior of C () also appears below 5 cm 1 .

CKN. The vibrational density of states was calculated from the speci c heat data published in^{36} . The speci c heat in this work was measured up to 8.5 K. It is expected that the vibrational density of states found will be valid in a frequency range up to about 20 cm 1 (see^{22}) . The low-frequency Raman spectrum at T = 6 K was taken from 37 . The density of states at T = 252 K of CKN glass was measured in³⁸. Since the density of states does not dem onstrate signi cant tem perature variations for > 10 cm⁻¹ Ref.³⁸, the coupling coe cient at T = 200 K was calculated using the Ram an data at T =200 K (data from ³⁷) and neutron scattering data of³⁸ (no correction for the Debye-W aller factor was done for S(Q;)). The two estimates of the coupling coe cient (from neutron and speci cheat experiments, Fig.3) show good agreem ent in the range 10-30 cm $\,^1$, while the presence of the fast relaxation below 10 cm 1 is clear at T = 200 K. The coupling coe cient reveals a linear frequency behavior in the range 10-22 cm 1 and the stronger dependencies below 10 cm 1 and above 35 cm 1 .

A s_2S_3 . The density of states was calculated from the speci c heat data published it^{14} (data for the annealed sample). The evaluated density of states in the range 10-60 cm⁻¹ is in fair agreem ent with g() obtained from inelastic neutron scattering measurem ents³⁹ at room tem - perature. A low-tem perature depolarized Raman spectrum of the A s_2S_3 glass was measured in¹³. The values of C () from that work (Fig.4) show that the coupling coe cient is proportional to in the range 5-60 cm⁻¹.

G eO $_2$. Low temperature low frequency R am an data and speci c heat data for G eO $_2$ glass were taken from 40 . The density of states was calculated from the speci c heat. The values of C () (Fig.4) derived from that data show that C () is nearly proportional to for the whole frequency range 10-50 cm 1 .

G eSe₂. Inelastic neutron scattering data and lowtem perature speci c heat data for G eSe glass are presented in⁴¹. O ur evaluation of the vibrational density of states from the low-tem perature speci c heat (m easured up to 18 K) is in good agreement with room tem perature neutron data in the range 10-50 cm⁻¹. This agreement suggests that a contribution of the fast relaxation in this frequency range is negligible already at ambient conditions. A room tem perature R am an spectrum of G eSe₂ glass was taken from ⁴². The spectrum m easured in this work shows a well de ned peak already at room tem perature, supporting the contention that the quasielastic contribution is well suppressed at frequencies corresponding to the boson peak m axim um. The coupling coe cient was calculated from a com parison of R am an and neutron scattering data at room tem perature (Fig.4). This calculation demonstrates nearly linear frequency behavior of C () in the whole frequency range 8-90 cm 1 .

(A g₂O)_{0:14} (B₂O₃)_{0:86}. V ibrational density of states of a (A g₂O)_{0:14} (B₂O₃)_{0:86} glass was calculated from the speci c heat data of ³. Speci c heat data were measured up to 18 K in this work. Since the low -tem perature speci c heat coincides with that of B₂O₃ glass for T > 10 K⁴³, we extended the data of the (A g₂O)_{0:14} (B₂O₃)_{0:86} glass to higher temperature using the data from the B₂O₃ glass. The extended data allowed us to calculate the density of states for higher frequency. A low temperature depolarized Ram an spectrum recorded at T = 20 K was taken from ⁴³. The derived coupling coefcient of (A gO)_{0:14} (B₂O)_{0:86} glass (Fig.4) is linear in the range 10-60 cm ¹ and slightly superlinear above this range.

Polystyrene (PS). The density of vibrational states of PS glass was calculated from the speci c heat data published in^{30;44}. A low-tem perature depolarized R am an spectrum (at T = 6 K) was taken from ⁴⁵. In the frequency range 8-90 cm⁻¹, C () calculated from these data (Fig.5) agrees well with the coupling coe cient obtained earlier by direct comparison of neutron and R am an scattering data at T = 35 K (from ¹²). The contribution of the fast relaxation⁴⁵ at T = 35 K is responsible for the di erence betw een the two estimates of coupling coe cient at frequencies below 8 cm⁻¹. The coupling coe cient in PS glass (Fig.5) varies linearly with in the range 5-40 cm⁻¹ and superlinear above and below this range.

Polycarbonate (PC). The coupling coe cient at T = 15 K for PC glass was found in¹⁰ by direct comparison of neutron and R am an scattering spectra. It is linear in the range 5-50 cm⁻¹ and superlinear above this range (Fig.5).

Polym ethylm ethacrylate (PMMA). Calculation of vibrational density of states of PMMA glass was done from the speci c heat data published in^{30} . A low-temperature Ram an spectrum was measured in^{46} . C () obtained from that data (Fig.5) agrees wellw ith the coupling coe cient found in^{47} from comparison of neutron and Ram an scattering spectra at T = 30 K.C () varies linearly with in the range 7-30 cm⁻¹ and has a stronger frequency dependence above this range.

III.GENERAL FEATURES OF C ()

In this section som e general properties of the R am an coupling coe cient will be discussed. The goal is to reveal features that are universalor di erent for the glasses analyzed.

The results presented in the previous section indicate that the frequency behavior of coupling coe cient can be considered in three frequency ranges: signi cantly below the frequency of the boson peak maximum, $_{\rm BP}$; around $_{\rm BP}$ and signi cantly above $_{\rm BP}$. The com parison will

be done with the frequency axis scaled to $_{\rm BP}$. The frequency $_{\rm BP}$ was de ned as the position of the maximum in the curve g()=². Table 1 presents for the glasses under discussion the values of $_{\rm BP}$ de ned in this way.

Linear dependence of C () near $_{\rm BP}$. A linear behavior of C () for frequencies near that corresponding to the boson peak maximum can be seen for all the glasses. This linear behavior can be described by eq.(2). The constant B characterizes the relative contribution of two additive terms in eq.(2). Fig.6 presents a plot of C () for seven glasses (SiO₂, B₂O₃, Se, CKN, $(Ag_2O)_{0:14}$ $(B_2O_3)_{0:86}$, PS, PC) plotted against scaled frequency (am plitudes of the C () were norm alized near $=_{BP} = 1$). For clarity, only data above 0:5 $_{BP}$ are presented in this gure. Clear di erences in C () of the di erent glasses are observed at high frequencies. How ever, C () tends to a master curve (universal frequency dependence) at frequencies below ~1:5 BP. The universal behavior shown by the dashed line presents the dependence

The linear frequency dependence describes well the behavior of C () found experimentally starting from the frequency $0.5_{\rm BP}$. The high frequency limit of this behavior varies from $1.5_{\rm BP}$ for SiO₂ and Se up to about 4 _{BP} for the PC glass.

However, there exists another group of glasses that does not follow the frequency behavior highlighted in Fig.6. The results for the other four glasses (PMMA, A s_2S_3 , G eSe₂, G eO₂) are presented in Fig.7. C () for these glasses can be well described by a simple linear dependence with the constant B in eq.(2) having a value of zero.

Thus, all the glasses analyzed here are separated into two groups: those with C () / $=_{BP} + 0.5$ near the boson peak maximum (Fig.6), and another group with C () / (Fig.7). In the following we will refer to these two groups with the designation of "type-I" and "type-II", respectively.

Low -frequency behavior of C () (< 0.5_{BP}). At least four glasses (SiO₂, Se, PS and CKN) demonstrate superlinear frequency dependence in this spectral range. The low -frequency portions of C () for these glasses are presented in Fig.8 on a log-log scale together with the function C () / = $_{BP}$ + 0.5. The coupling coe cient varies superlinearly below some frequency ~0.5 $_{BP}$, deviating strongly from the extrapolation of linear behavior (Fig.8). The crossover frequency of a transition to superlinear behavior appears to be 0.3 $_{BP}$ for SiO₂ and 0.5 for So PS and CKN

 0.5_{BP} for Se, PS and CKN.

It is remarkable that these systems have signi cantly di erent m icrostructure and fragility. This suggests that superlinear frequency behavior for $< (0.3 \ 0.5)_{\rm BP}$ m ay be general for various glasses. The fact that we did not observe the superlinear frequency behavior of C () in other glasses can be explained by two reasons: either

the experimental data are not extended to low enough frequencies, or they are measured at tem peratures that are not low enough and the presence of the fast relaxation at low frequencies masks the true vibrational behavior. The importance of the relaxation contribution even at tem perature as low as T = 15 K can be dem onstrated in the case of the B_2O_3 glass. Indeed, from Fig.1 of 21 it is evident that the fast relaxation is not negligible at T =15 K and dominates for < 3 cm¹. Since the spectral shape of the fast relaxation spectrum in B203 does not depend on temperature³¹, we can subtract it from the Ram an spectrum at T = 15 K using the spectrum of the fast relaxation determined in³¹. The Raman spectrum of B₂O₃ glass corrected in this way (by adjusting am plitude of the relaxational spectrum at the low est points of the spectrum in Fig.1 of R ef.³¹) gives the coupling coef-

cient shown by the dotted line in Fig.8. This revised coupling coe cient depicts the superlinear behavior at < 0.5 $_{\rm B\,P}$.

H igh-frequency behavior of C () (> $2_{\rm BP}$). Figs.6 and 7 show no universal behavior of the coupling coe cient in this frequency range. It varies from sublinear to strongly superlinear behavior for di erent glasses.

IV . D ISC U SSIO N

The observation of the superlinear behavior of the coupling coe cient below some frequency < (0.3 0.5) $_{\rm BP}$ is very important. It has been shown that C () for acoustic-like vibrations should increase ~ ². This prediction was obtained in the fram ework of di erent model approximations (see, for example, Refs.^{6/8/9}).

Basing on their experim ental observations, the authors of R ef.²¹ suggested that the linear behavior of C () can be extrapolated to the limit ! 0 and C (= 0) has a nonvanishing value. The results of the present work show that this extrapolation is not correct and the character of the frequency dependence changes at lower , corresponding to the expectation that C () ! 0 when

! 0. However, the existing experimental data do not allow one to establish the exact frequency dependence, and this topic still requires further investigation.

At higher frequencies, C () dem onstrates the universal linear behavior for type-I glasses (Fig.6). The glasses in this class vary signic cantly in structure, fragility, and ratio of the excess vibrations to the D ebye level. There are many models that assume two dicerent kinds of vibrations coexisting at frequencies around the boson peak: propagating and localized or quasilocal. For example, in the fram ework of the soft potentialm odel⁴⁸ it is assumed that propagating waves have a Debye-like density of states and do not contribute to the R am an spectra, while excess vibrations are localized and have C () = const. The ratio of the excess vibrational density of states to the D ebye level around the boson peak is ~4 in SiO₂ and ~0.4 in CKN³⁶, i.e. it dicers up to 10 times. In that

respect, the observed universality of C (), obtained using the total density of vibrational states (Figures 6,7), supports an alternative idea that all vibrations around the boson peak are hybridized and can not be separated into propagating and localized.

In order to explain the observed universality of C (), signi cant theoretical work should be done. There are two complications in this problem : (i) there is no good approximation for the wavefunction of the vibrations around the boson peak; (ii) the scattering mechanism, i.e. the way how the vibrations modulate polarizability of the material, is not clear and might be di erent for di erent glasses. Below we consider a very simplistic model that m ight provide a qualitative description of the observed universal behavior of C (). One possible explanation for this behavior can be found in the fram ework of the approach of non-continuous glass nanostructure49 {51. The m odel assum es that the boson peak vibrations com bine properties of both localized and extended excitations. At short distances (inside of a nanocluster), displacem ents of atom s are coherent and the wavefunction is sim ilar to a vibration localized in the cluster. At longer distances, how ever, the vibrations start to have di usive character (probably as in⁵²). Note that the spirit of this consideration is very sim ilar to that of the model in^{53} .

For simplicity of discussion we will follow continuous medium approximation⁶. In this case the inelastic light scattering is caused by acoustic vibrations via the elastooptic e ect. The coupling coe cients for the Raman scattering of acoustic type excitations is written as^{6;7}:

Here s (r) is the strain of an acoustic vibration with frequency , h:::i means con gurational and statistical averaging, and P (r) is the elasto-optic constant. C rosscorrelations of P (r) and s (r) uctuations are neglected for simplicity. Since the phonon mean free path is much shorter than the light wavelength, the exponential exp(iq r) (where q is the scattering wavevector of the experiment) is also neglected. The polarization indices are om itted for simplicity. We assume hP (0) P (r) i P² and neglect contribution of the uctuating part of the elasto-optic constant in the Ram an coupling coe cient.

In the fram ework of the model considered, the integral of eq.(4) can be separated into two parts: the rst is for the short distances, where the wavefunction of the vibration m in ics the localized feature; the second one is for longer distances, where the wave function has di usive character:

Here, R is the radius of the nanocluster. The wavefuction in the rst term behaves as a localized vibration and this is the case described in the Shuker-G ammon model⁷. Therefore, the st term is frequency independent. The di usive character of the boson peak vibrations determ ines the frequency behavior of the second term in eq.(5). In Ref.⁵⁴, it was shown that the di usive feature of acoustic vibrations leads to C () / . Therefore, the second term in eq.(5) is proportional to frequency. Thus, the localized-extended character of the boson peak vibrations may be the reason for the linear frequency dependence of the Ram an coupling coe cient.

A coording to eq.(5), the relative contributions to C () of a frequency independent term and a term proportional to frequency re ects the relative weights of localized and extended part of the boson peak vibration. The result of F ig.6 m eans that at the boson peak m axim um the ratio of the localized and extended parts is the same for these glasses.

However, the frequency independent contribution to C () for some of glasses is negligibly small (Fig.7). In the fram ework of the considered model, it means that for these glasses either the vibrations have di usive-like character even inside a nanocluster or this part of the wavefunction does not contribute to light scattering due to selection rules. We do not have a clear explanation for the observed di erence and it rem ains a challenge for future investigations. At present we only show another hint that the peculiarity of type-II glasses m ay be related to localization of the vibrations. Indeed, if this is true one should expect that boson peak vibrations of type-II glasses are more extended than those of type-I glasses. This di erence has to show up in vibration transport properties. Figure 9 presents the therm al conductivity of SiO $_2$, PS, Se, GeO $_2$, PMMA and As $_2$ S $_3$ glasses (data from Refs.^{55 {57}}. The rst three glasses are type-I and the next three are type-II. It is convenient to compare the pairs of glasses in which the two members of the pair have closely sim ilar chem ical nature but belong to di erent classes, for exam ple, SiO_2 and GeO_2 , PS and $\texttt{PMMA},\texttt{As}_2\texttt{S}_3$ and Se. It appears (Fig.9) that glasses of di erent type (but of sim ilar chem ical nature) have com parable therm al conductivity at higher T but type-II glasses have higher therm al conductivity at the plateau. It is known that the plateau region in therm al conductivity corresponds to conductivity by vibrations around the boson peak. Thus, this com parison reveals weaker localization of the boson peak vibrations in type-II glasses and supports the above speculations. However, the question is far from settled and further investigations are needed in order to provide a m icroscopic explanation of the difference between the two types of glasses.

There are no universalities in the frequency dependence of C () for $> 2_{\rm BP}$. The high-frequency vibra-($\frac{1}{2}$ tigns depend strongly on a particular atom ic organization of a glass, its m icrostructure. A relation to peculiar m icrostructure may be a reason for di erent behaviors of C () in this frequency range.

V.CONCLUSION

The Ram an coupling coe cient, C (), is analyzed for the large number of glasses strongly di erent in their chem ical structure and fragility. It is dem onstrated that C () has a universal linear frequency dependence near the boson peak maximum : C () / $=_{BP} + B$, with B ~0.5 for one group of glasses and B ~0 for the second group. The observed universality suggests that the vibrations around the boson peak have som e universal properties for glasses with di erent structure. An explanation for the observed C () is formulated in the framework of a model describing the vibrational wavefunction as a combination of localized and extended parts. We relate the di erence in the behavior of C () in the two groups of glasses to di erent localization properties of the vibrations on a short length scale. This suggestion agrees with the observation of di erent behavior of therm alconductivity in these two types of glasses. It is also shown that C () has a superlinear behavior at frequencies below ~0.3 0.5 $_{\rm BP}$. A sharp rise in mean free path of the vibrations with decrease in may be a reason for this fast decrease in C (). No universality is observed at higher frequencies (above $\sim 2_{BP}$) suggesting that the particular atom ic organization of glasses is in portant in this spectral range.





























