## The distribution function of a sem i exible polymer and random walks with constraints

A b stract. { In studying the end-to-end distribution function G(r;N) of a worm like chain by using the propagator method we have established that the combinatorial problem of counting the paths contributing to G(r;N) can be mapped onto the problem of random walks with constraints, which is closely related to the representation theory of the Temperley-Lieb algebra. By using this mapping we derive an exact expression of the Fourier-Laplace transform of the distribution function, G(k;p), as a matrix element of an inverse of an in nite rank matrix. Using this result we also derived a recursion relation permitting to compute G(k;p) directly. We present the results of the computation of G(k;N) and its moments. The theory of exible polymers is now understood [1]-[4]. Many polymer molecules have internal stiness and cannot be modeled by the model of exible molecules developed by Edwards. This is especially true for several in portant biopolymers such as actin, DNA, and microtubules [5]. Models of semi exible polymers have also applications in dierent topics besides polymer physics [6]. If the chain length decreases, the chain stiness becomes an important factor. A quantitative measure for the stiness of the polymer is the persistence length  $l_p$ , which is the correlation length for the tangent-tangent correlation function along the polymer. Polymers with contour length L much larger than  $l_p$  are exible and are described by using the tools of quantum mechanics and quantum eld theory [1]-[4]. The standard coarse-graining model of a worm like or a semi exible polymer was proposed by K ratky and Porod [7]. A few rst moments of G (r; N) were computed in [8]-[10]. The literature on the computation of G (r; N) and its moments can be found in the book by Yamakawa [11]. For recent work see [12]-[14].

In this Letter we will study the problem of computation of the distribution function G (r; N) of the end-to-end distance of a semi exible polymer, which is described by K ratky-P orod model, by using the analogy of the worm like chain with the quantum rigid rotator in an external homogeneous eld [3], [15] within the quantum mechanical propagator method [16].

The relation to the rigid rotator was used in the recent work [14]. Relating the combinatorics of counting the paths contributing to G (r;N) to random walks with constraints and the Temperley-Lieb algebra [17], we have derived an exact formula for the Fourier-Laplace transform of the end-to-end distribution function, G (k;p), as an inverse of an in nite rank matrix of a very simple structure, given by Eqs.(6-7). Using a truncated matrix of rank n+1 one obtains n moments of  $r^2$  exactly from the (1,1) element of the 2n-th power of this matrix, i.e., by applying this matrix 2n times to a canonical basis vector. Moreoever, this enables one to compute the distribution function, which describes n moments of  $r^2$  exactly and all higher moments approximately. The truncation corresponds to taking into account the intermediate states with the quantum number of the angular momentum 1 n (see below).

The Fourier transform of the distribution function of the end-to-end polym er distance of the K ratky-P orod m odel [7] G (k;L) =  $d^3R \exp(ik(R - R_0))$ G (R R 0;L) is given by the path integral as follows

where  $l_p$  is the persistence length, and t (s) is the tangent vector at the point s along the contour of the polym er. The product over s in Eq.(1) takes into account that the polym er chain is locally inextensible. If the polym er interacts with an external eld, the potential energy  $l_p^{R_L}$  dsV (r(s)) should be added in the exponential of Eq.(1). Notice that the representation of G (k;L) by using the cum ulants of the moments of the end-to-end distribution function G (k;L) = exp (  $l_p^{R_L}$  ds  $l_p^{R_L}$  ds  $l_p^{R_L}$  (s) (k²) perm its to write the following differential equation for G (R;L), 0 G (R;L)=0 L  $l_p^{R_L}$  (l)  $l_p^{R_L}$  G = 0, where  $l_p^{R_L}$  is the Laplace operator. The latter with the term associated with the external potential was used in [18] to describe the localization of a sem i exible polym er onto interfaces and surfaces.

The path integral (1) (without the term depending on k) corresponds to the di usion of a particle on unit sphere, t(s) = 1. This problem is equivalent to the Euclidean rigid quantum rotator  $\beta$ , [15]. The G reen's function of the rigid rotator or a particle on unit sphere fulls the following equation

where is the spheric angle associated with angles , and ', and (  $_0$ ) is a two dimensional delta function. Henceforth instead of the contour length L we will use the number of statistical segments N = L=lp. Notice that in Q uantum M echanics N corresponds to the imaginary time it. The solution for P0 (;';N;0;'0;0) is

where  $Y_{lm}$  (;') are the spherical harm onics. At a given l, m takes the values l, l+ 1, :::, l. The quantity  $P_0$  (;'; N; 0;'0;0) is given by Eq.(1) with k = 0 and with the following boundary conditions for the path t(s) (0 s N):t(N) (;'), and t(0) (0;'0).

We now will consider the G reen's function P ( ;'; N; 0;'0;0) associated with Eq.(1). The dierential equation for P is

where U ( ) =  $ik = ik \cos()$ , and k is measured in units of  $\frac{1}{k}$ . As it is well-known from the propagator method [16] the latter can be written as an integral equation as follows




Fig. 1 { a) The 6th order of the perturbation expansion of the end-to-end distribution function. b) R andom walk with constraint associated with the last line in a).

Eqs.(3-5) describes also the Euclidean rigid quantum rotator in an external eld. The iteration of the latter generates the perturbation expansion of P in powers of the potential U ( ). The Fourier transform of the distribution function of the end-to-end distance of the polymer is obtained from P (;N;0;0) by integrating the latter over and 0: G (k;N) = d d0P (;N;0;0). The factor 4 is extracted from P (;N;0;0). Eq.(5) with xed and 0 is the distribution function of the end-to end distance with xed tangents of the polymer ends. The coe cient in front of (k²)<sup>n</sup> of the expansion of G (k;p) in powers of k², multiplied by the factor (1)<sup>n</sup> (2n + 2) is the Laplace transform of the moment <  $r^{2n}$  > of the end-to-end distribution function. Due to the folding character of the integrations over the contour lengths in (5), the Laplace transform of (3) with respect to N perm its to get rid of integrations over the contour length. Similar to the propagator method used elsewhere [16] each order of the perturbation expansion can be represented by graphs, examples of which are schematically shown in Fig.1. Each piece of the continuous

line between two consecutive vertices are associated with the Laplace transform of the bare green's function given by Eq.(3). at graph ends are equal to zero. The averages over  $\cos$  in each vertex gives that the quantum num bers lon both sides of a vertex di er by one. The weights associated with the vertices are given by  $w_1 = \cos i_{1;1,1} = \cos i_{1;1,1} = i = 41^2 - 1$ . The Laplace transform of the weights associated with each piece of the continuous line between two vertices, which are given by the exponential factor in Eq.(3), are given by  $e_1 = 1 = (p + 1(1 + 1) = 2)$ , where p is the Laplace conjugate to N. The quantum number m is conserved along the path and is zero due to the integration over the angles at the ends. Thus, the problem of counting di erent paths contributing to the transition probability d d  $_0P$  ( ;N;  $_0$ ;0) can be formulated as a problem of a random walk consisting of odd number of steps with the constraint that the step heights are equal to one. The example of such a random walk is given in Fig.1b. One can write the expansion of G (G;G) as follows

G (k;p) =

where the last term is the result of the sum mation of the series, A = dm is the product of the in nite rank matrices d and m, which are de ned as follows  $g_j = e_{i \ 1}$  i; j and  $m_{i,j} = w_{i \ 1}$  i;  $j+1+w_{i \ i;j+1}+w_{i \ i;j+1}$  (i,  $j=1,2,\ldots$ ). Approximating the last term in Eq.(6) by the matrices of nite rank n gives an approximate formula for the distribution function,  $G_{2n-2}$  (k;p), which gives exactly the rst 2n-2m on ents and approximate expressions for higher moments where the intermediate states with  $1=0;1;\ldots;n-1$  are taken into account. No matrix inversion is required for the exact Laplace transforms of the moments which may be calculated directly by the Fourier transform of (6). From the expansion in k one realizes that only the (1,1)-element of the 2n-power of A needs to be calculated for  $< r^{2n} > .$  Because of the simple band structure of A this is obtained exactly from a truncated matrix A of rank n+1.

The distribution function  $G_{2n}$  (k;p) (2n is the number of the exact rst m om ents contained in  $G_{2n}$  (k;p)) can be written as

where  $f_k$ , which are defined for each n, obey the following recursion relation  $f_k = u_k (1 + \frac{n}{l_b k + 2} f_1)$ , and  $u_i = k^2 e_{i-1} w_i^2 e_i$ . Eqs.(6-7) are exact and are the main result of the present Letter. The odiagonal matrix elements of the matrix  $I + k^2 A^2$  give the transition probabilities from the initial state  $(l_a, m_a = 0)$  to the nal state  $(l_a, m_b = 0)$ . The computation of the distribution function of the end-to-end distance with exact tangents of the end vectors demands consideration of paths with arbitrary  $l_a$ ,  $m_a$  and  $l_b$ ,  $m_b$ . The consideration of the transition probability with nonzero number m demands the change of the definition of the weights  $w_1$ . The simple band structure of the matrix, however, remains unchanged.

We have computed  $G_m$  (k;p) explicitly form 26. The distribution function, which takes into account exact 6 m oments, is given by

A  $11.26\,\mathrm{m}$  om ents we have computed are obtained in a form similar to <  $(r^2)^5$  > with numerical coecients given as fractional numbers. A  $11\,\mathrm{m}$  om ents full the expected  $11\,\mathrm{m}$  iting behaviour for small and large N .




Fig. 2 { Computation of G (k;N) for N = 0.01: Continuous:  $G_{rod}(k;N)$ , dots:  $G_{10}(k;N)$

Perform ing the inverse Laplace transform of G (k; p) by using M aple enables one to plot G (k; N). In the lim it of sm all N the distribution function  $G_m$  (r; N) approaches the rod lim it  $G_{rod}$  (r; N) = 1=(4 N<sup>2</sup>) (r N), which has the Fourier transform  $G_{rod}$  (k; N) =  $\sin$  (kN) = kN. In order to illustrate the accuracy of the truncated dustribution function a comparison of G (k; N) with the rod lim it is shown in Fig 2. The increase of m extends the interval of k of the

agreem ent between  $G_m$  (k;N ) and  $G_{\rm rod}$  (k;N ). However, for large m the M aple computation of the inverse Laplace transform of G (k;p) becomes unstable for small k at very small N .

The inverse Laplace transform of G  $(k;p)=p^2$  multiplied with the factor 2=N gives the structure factor of the sem i exible polymer S (k;N). Performing the inverse Laplace transform by using M aple permits to get plots of the structure factor.

In conclusion, we have studied the end-to-end distribution function of a worm like chain, the problem which is equivalent to the Euclidean quantum rigid rotator in a hom ogeneous external eld, by using the propagator method. We have established that the combinatorial problem of counting the paths contributing to the end-to-end distribution function can be mapped to the problem of random walks with constraints, which is closely related to the Temperley-Lieb algebra. Using this mapping we derived an exact expression for the Fourier-Laplace transform of the end-to-end polymer distance as the matrix element of the inverse of an in nite rank matrix. Starting with this result we have also derived a recursion relation permitting to compute G(k;p) directly. The mapping to the problem of restricted random walks and the Temperley-Lieb algebra, which is not restricted to the computation of G(k;N), gives a new tool of treating the semilexible polymers. Eqs.(6-7) give also the exact solution for the transition amplitude of a rigid quantum rotator in an external homogeneous imaginary eld in Euclidean sector.
