Logarithm ic corrections to nite size spectrum of SU (N) sym m etric quantum chains

We consider SU (N) sym metric one dimensional quantum chains at nite temperature. For such systems the correlation lengths, ground state energy, and excited state energies are investigated in the framework of conformal eld theory. The possibility of dierent types of excited states are discussed. Logarithm ic corrections to the ground state energy and dierent types of excited states in the presence of a marginal opeartor, are calculated. Known results for SU (2) and SU (4) sym metric systems follow from our general formula.

O ne of the fundam entalm odels of solid state physics is the H eisenberg m odel of insulating m agnets. In the one-dim ensional case (\spin chains"), the spin-1=2 H eisenberg m odels have been studied extensively: most of our understanding of their quantum critical behavior is based on the B ethe-A nsatz solution for the ground state and excitation spectrum $_{\rm 1}^{\rm 1/2}$ m apping to the Sine-G ordon theory, non-abelian bosonization, and m apping to the sigm a m odel. Although spin-1=2 H eisenberg chains are SU (2) sym m etric systems, fruitful generalizations have been accomplished in two di erent directions: (a) enlarging the representation of SU (2) group to study quantum chains with higher spins, and (b) introducing higher sym m etry groups such as SU (N).

Here we consider generalizations of the type (b) and investigate how higher symmetry a ects the ground state properties [Eqs. (8)-(10)] and nite size spectrum of quantum \spin" chains. Earlier studies of A $\,$ eck 6 show that any one dim ensional system with SU (N) sym m etry is critical, and at the very low energy scale these models are equivalent to (N 1) free m assless bosons. This system of free bosons - when viewed in the fram ework of two dimensional conformal eld theory, are the primary elds of the SU (N) k=1 W ZNW model. Adopting this model we give an explicit derivation of logarithm ic corrections to nite size spectrum of SU (N) symmetric quantum chains. Logarithm ic shifts in excited states energy levels have been theoretically observed for SU (2) and SU(4) symmetric systems away from the T=0quantum critical point. 7^{12} K nown results for N = 2 and N = 4 follow from our general formulas [obtained in Eqs. (27)-(28) and the paragraphs below Eq. (30)].

An one-dim ensional SU (N) sym m etric quantum chain of length L is described by the H am iltonian 13

Here $n = L=a_0$ is the total number of discrete points

(a₀ being the lattice spacing) and S_j^A are the (N 2 1) generators of the SU (N) Lie algebra at each lattice site j. For convenience, the interaction strength and the lattice spacing a₀ have been set equal to one in Eq. (1). At each site j, the generators S_j^A can be represented by N \ avors" of ferm ions, a_j [a = 1;:::;N]

For such a ferm ionic system the theory can be bosonized using non-abelian bosonization at low temperatures. In the continuum limit, the bosonized H am iltonian 4 (H $_{\rm e}$) can then be written in terms of the K ac-M oody currents,

where the norm all ordered K ac-M oody currents for the left (with Ferm im omentum $k_{\rm F}$ < 0) and the right moving (with $k_{\rm F}$ > 0) ferm ions are defined as,

At zero tem perature (T = 0) the interaction term, $P_{A=1}^{N^2-1}$ $J_L^A J_R^A$, in Eq. (3) renormalizes to zero, and the sum of rst two terms in the Hamiltonian that are quadratic in left and right moving currents, corresponds to the SU (N) $_{k=1}$ W ZNW model. The fundamental unitary N N matrix eld g of the W ZNW model is given by,

The eld g transforms as the fundam ental representation of SU (N)_L SU (N)_R which describes the exact symmetry of the H am iltonian in Eq. (3) at zero temperature. It is known that this ferm ionic theory is equivalent to a theory of (N 1) free m assless bosons at the criticality with velocities $v_{\rm s}$; they correspond to (N 1) excitation modes of the SU (N) symmetric quantum chain that oscillates at dierent values of $k_{\rm F}$. Furthermore, these oscillating modes are primary elds of the SU (N)_{k=1} W ZNW model and their scaling dimensions ($_{\rm p}$) can be obtained from 14

For SU (N), C_p (p = 1; 2; ;N 1) is the eigenvalue of the Casim ir operator in the p-th fundam ental representation [having a Young tableau with p boxes in a single column], and $C_{adj}=N$ is the eigenvalue of the Casim ir operator in the adjoint representation [having a 2-column Young tableau with (N 1) boxes in the rst column and 1 box in the second column]. In a highest weight () representation of SU (N), the corresponding Casim ir eigenvalue is given by 15

where is the highest weight corresponding to the adjoint representation and is normalized to 1, m is the total number of boxes in the Young tableau with r_o rows of length $b_1;b_2;$ $_{r_o}; land \ c_o$ columns of length $a_1;a_2;$ $_{c_o}; a\ U$ sing this formula we nd C $_p=p\ N$ p) (N + 1)=2N and C $_{adj}=N$. Hence, the scaling dimensions ($_p$) of primary elds of the SU (N) $_{k=1}$ W ZNW m odel are given by

For exam ple, in the case of SU (4) the three oscillating components have scaling dimensions (3/4, 1, 3/4) [for p = 1; 2; 3]. For SU (N), the mode (dominant) that oscillates at $k_F = 2 = N$ has a scaling dimension (1 1=N) [p = 1 or (N 1) in this case].

Finite-size corrections to Heisenberg chain with SU (2) and SU (4) symmetry has been studied using conformal eld theory. The relevance of studying nite size chains are twofold. One can not only compare the theoretical results with numerical simulations and experiments which are limited to nite size of the system but also can study the nite temperature behavior of the system by identifying the nite size in the imaginary time

direction, that corresponds to nite temperature. To obtain the nite-size corrections of a 1D chain of length L and with periodic boundary conditions we rst introduce a conform alm apping from the in nite plane (with coordinate z) to the cylinder (with coordinate w) via $w=(L=2)\ln z$. Identifying the length to be inverse of the temperature $[\![L=v_s=T]\!]$ the nite temperature results 17 of the ground state energy E $_0$ can be generalized to the SU (N) symmetric system,

Here E_0 (0) refers to the ground state energy at zero temperature. The thermodynamic quantities like specic cheat and entropy can now be obtained by taking the appropriate derivatives with respect to the temperature.

O ther quantities of interest are the nite tem perature corrections to the correlation lengths () of the di erent modes. These inverse of the correlation lengths, 1 are signature of energy gaps, (E $_{\rm n}$ E $_{\rm 0}$) between the ground state and the lowest lying excited states (E $_{\rm n}$) that are created by nite tem perature of the system . U sing the general formula for the scaling dimension Eq. (8)], we obtain $_{\rm p}^{-1}$ of the p-th staggered mode,

The tem perature dependence of the correlation lengths is in fact modi ed by logarithm ic corrections in the presence of marginal operators in the theory. The generic form of the Hamiltonian at the critical point containing a marginal operator (x;t) is

where g_0 is the coupling constant and H is the H am iltonian at the xed point. In our case Eq. (3)], the normalized marginally irrelevant operator is

For such a marginally irrelevant operator, the Ham iltonian at the critical point (T = 0) becomes equal to the xed point Ham iltonian. In Eq. (12), D is the normalization constant to be determined from the two-point correlator of . The operator product expansion (OPE) of the $J_{L\ (R\)}^{A}$ with any normalized Kac-Moody primary eld is given by 16

where the operators $J_{0;L}^A$ and $J_{0;R}^A$ are the generators of the global SU (N) $_L$ SU (N) $_R$ transform ations, and satisfy the characteristic equations, $J_{0;L}^A$ j (z^0)i = $_P^{T_L^A}$ j (z^0)i and $_P^{J_{0;R}^A}$ j (z^0)i = j (z^0)iT $_R^A$. Note that $_A^A$ ($J_{0;L}^A$) $_L^A$ and $_A^A$ ($J_{0;R}^A$) $_L^A$ are the C asim ir operators of SU (N) $_L$ and SU (N) $_R$ groups, respectively. The two-point correlators of the left currents (for k = 1) are,

U sing these results we explicitly calculate:

and then compare it to the standard conformal eld theory result i.e. h (z;z) $(z^0;z^0)i=jz$ z^0j^2 jz z^0j^2 to obtain the value of the constant,

Thus the normalized irrelevant marginal operator is given by,

P exturbation to the norm alized excited state ($_{\rm n}$) energies due to the m arginal operator can now be calculated 17 from

where and $_n$ are V irasoro prim ary elds generated by applying Fourierm odes of J_L^A and J_R^A on K ac-M oody primary elds. For large length (equivalently, smalltem perature), we may replace the coupling g_0 by its renormalization group in proved value (upto the log log term), 18

Here T_0 is the model dependent parameter of the system and the coecient b is dened via the following 3-point correlator,

Substituting this in Eq. (20) we obtain,

Here x_n is the scaling dimension of the V irasoro primary eld $_n$. Substituting Eq. (19) in Eq. (24) and using the OPE's as in Eqs. (13) and (14) it follows that b_n is directly proportional to the sum of the product of the eigenvalues of the generators $J_{0:L}^A$ and $J_{0:R}^A$,

To evaluate ${}^{P}_{\ A}\ T_L^A\ T_R^A$, we observe that the full sym metry, SU (N)_L SU (N)_R, of the quantum chain at the critical point is broken by the presence of the marginal operator, (z;z). Only the diagonal SU (N) SU (N)_L SU (N)_R is an exact sym metry of the quantum chain. Under this subgroup, the representation V_L V_R of SU (N)_L SU (N)_R decomposes into direct sum of various irreducible subrepresentations. If an excited state (j n i) belongs to a highest weight subrepresentation, V V_L V_R and C is the corresponding C asim ir invariant of the diagonal SU (N) in V , then we have 19

where C $_{\rm L}$ and C $_{\rm R}$ are the C asim ir invariants of SU (N) $_{\rm L}$ and SU (N) $_{\rm R}$ in the highest weight representations V $_{\rm L}$ and V $_{\rm R}$, respectively. Therefore, using Eqs. (25) and (26) we nd

The above formula may also be used to evaluate the renormalization group coecient, b Eq. (22)]: since

(z;z) is a V irasoro prim ary eld of conform aldimensions (1,1), we set $_{\rm n}$ (z;z) = (z;z) and $x_{\rm n}$ = 2 in Eq. (24), and hence, $b_{\rm h}$ = b. This can be seen as follows. The V irasoro prim ary elds $J_{\rm L}^{\rm A}$ and $J_{\rm R}^{\rm A}$ of conformal dimensions (1;0) and (0;1) transform as the adjoint representations, $V_{\rm L}^{\rm adj}$ and $V_{\rm R}^{\rm adj}$ of SU (N), and since $V_{\rm R}^{\rm adj}$ is conjugate to $V_{\rm L}^{\rm adj}$, the direct sum decomposition of $V_{\rm L}^{\rm adj}$ $V_{\rm R}^{\rm adj}$ under the diagonal SU (N) SU (N)_L SU (N)_R must contain a unique singlet. Hence, the Virasoro primary eld (z;z) in Eq. (19) transforms as this singlet representation and we have C = 0; C_L = C_R = N in Eq. (27). This implies

For example in the case of $\frac{H}{2}$ eisenberg spin-chain with SU (2) symmetry, $b=4=\frac{3}{p}$ and for the spin-orbital model with SU (4), $b=8=\frac{15}{15}$. Our result for SU (4) is new. Together with Eq. (21), the constant balso determines the correction of O (g_0^3) in the ground state energy,

To determ ine the logarithm ic shifts in the excited states energy levels, we need the ratio $2b_n = b$ in Eq. (23). From Eqs. (27) and (28) we get,

To evaluate b_n (and hence $2b_n\!=\!\!b)$ we must know the excited states. In SU (N) invariant quantum chains, the low lying excited states (j $_n$ i) correspond to (N - 1) primary elds of the SU (N) $_{k=1}$ W ZNW model with the scaling dimensions, $_p$. These elds transform as (q;q) representations of SU (N) $_L$ SU (N) $_R$, where

is the dimension of the p-th fundamental representation of SU (N) for p = 1; 2; ;N 1. For instance, the lowest excited states correspond to the fundamental primary eld g with the scaling dimensions, $_1=(1\ 1\exists N)$. This eld transforms under the (N;N) representation which decomposes under the diagonal SU (N) into the adjoint and singlet representations. For the excited states, Tr [gT A], belonging to the adjoint representation, we have C = N $_P$ $\frac{C_L}{N^2}$ $\frac{C_R}{N^2}$ = (N 2 1)=2N which implies b_h = 1=(N $^{\frac{N}{N^2}}$ 1) and $2b_h$ =b = 1=N 2 . For example, in the case of SU (2), this ratio $2b_h$ =b = 1=4; 7 and for SU (3) and SU (4) they are 1=9, and 1=16 respectively.

For the excited state, Tr g, belonging to the singlet representation we have C=0; $C_L=C_R=(N^2-1)$ =2N . In this case, $b_h=\frac{N^2-1}{N^2-1}$ =N and the $2b_h$ =b=11=N 2 . This result is new. In case of SU (2), the value $2b_h$ =b=3=4 has been previously obtained but for SU (3), $2b_h$ =b=8=9 and for SU (4), $2b_h$ =b=15=16 are predictions from our general form ula.




FIG. 1. Young tableau for the decomposition of (6; 6) representation of SU (4). The number in the parenthesis denotes the dimension of the corresponding representation.

We consider one more application of the formula (30) of current interest { the SU (4) sym m etric quantum chain described by the SU $(4)_{k=1}$ W ZNW model. In this case, to compute logarithm ic corrections to the excited states energy we note that there are three primary elds with scaling dimensions p = 3=4; 1; 3=4 for p = 1; 2; 3 respectively, as seen from Eq. (8). The case of p = 1[and p = 3], as discussed above, is the fundamental eld g [and its herm itian conjugate g] which transform sunder the (4; 4) [and (4; 4)] representation of SU $(4)_L$ SU $(4)_R$. From Eq. (10), the next lowest energy excited states correspond to the primary eld operator (denoted by) with $_2 = 1$. The eld transforms under the (6; 6) representation of SU $(4)_L$ SU $(4)_R$. This (6; 6) representation decomposes as direct sum of a singlet, an adjoint and a 20-dim ensional representation (as in Fig. 1) under the diagonal SU (4).

We now compute the ratio $2b_n$ =b for the excited states corresponding to 20-dim ensional representation which has a Young tableau with 2 rows and 2 columns. For this representation, the Casim ir invariant C in Eq. (30) is obtained from the formula (7): we nd C = 6, and $C_L = C_R = C_{p=2} = 5$ =2. Thus, for the excited states corresponding to in the 20-dim ensional subrepresentation of (6; 6), we have $2b_n$ =b= 1=4.

In sum m ary, we have studied nite size spectrum for one dimensional SU (N) symmetric quantum chains using both conformal eld theory and representation theory of SU (N). We have calculated in general the scaling dimensions of all the oscillating modes, and obtained the ground state energy as well as correlation lengths of the staggaered modes for a nite size system with SU (N) symmetry. Possibilities of dierent types of excited states

are also brie y discussed and a general form ula to compute the logarithm ic correction to the excited state energies has been derived. The existing results for N=2; 4 agree with the predictions from our general form ula.
