Cellular autom ata approach to three-phase tra c theory

Abstract. The cellular autom ata (CA) approach to tra cm odeling is extended to allow for spatially hom ogeneous steady state solutions that cover a two dim ensional region in the ow-density plane. Hence these models full a basic postulate of a three-phase tractheory proposed by Kemer. This is achieved by a synchronization distance, within which a vehicle always tries to adjust its speed to the one of the vehicle in front. In the CA models presented, the modelling of the free and safe speeds, the slow -to-start rules as well as som e contributions to noise are based on the ideas of the Nagel-Schreckenberg type modelling. It is shown that the proposed CA models can be very transparent and still reproduce the two m ain types of congested patterns (the general pattern and the synchronized ow pattern) as well as their dependence on the ows near an on-ram p, in qualitative agreem ent with the recently developed continuum version of the three-phase tra c theory B.S.Kerner and S.L.Klenov. 2002. J. Phys. A: Math. Gen. 35, L31]. These features are qualitatively di erent than in previously considered CA tra cm odels. The probability of the breakdown phenom enon (i.e., of the phase transition from free ow to synchronized ow) as function of the ow rate to the on-ram p and of the ow rate on the road upstream of the on-ram p is investigated. The capacity drops at the on-ram p which occur due to the form ation of di erent congested patterns are calculated.

1. Introduction

Tra c on a highway can be either free or congested. In empirical investigations congested tra c shows a very complex spatial-tem poralbehaviour (see the reviews [1, 2, 3, 4]). Based on a recent empirical study [5, 6] K emer found out that in congested tra c two di erent tra c phases should be distinguished: \synchronized ow " and \wide m oving jam ". Therefore, there are three tra c phases: 1. free ow, 2. synchronized ow, 3. wide m oving jam .

A wide moving jam is a localized structure moving upstream and limited by two fronts where the vehicle speed changes sharply, i.e. within a region that is small compared to the distance between the fronts. A wide moving jam propagates through either free or synchronized ows and through any bottlenecks (e.g. at on-ram ps) keeping the velocity of its downstream front [4, 7]. In this respect it di ers from synchronized ow, the downstream front of which is usually xed at the bottleneck, where it occurred. Such empirical spatial-tem poral features of wide moving jam s" and \synchronized ow " are the basis for the distinction of these tra c phases in congested tra c rather than a behaviour of tra c data in the ow-density plane [4, 7, 8].

W ide moving jams do not emerge spontaneously in free ow (with the possible exception that synchronized ow is somehow prohibited [9]). Instead, there is a sequence of two rst order phase transitions [6]: First the transition from free ow to synchronized ow occurs (called the F! S-transition), and only later and usually at a di erent location moving jams emerge in the synchronized ow (the S! J-transition).

D i erent explanations of these empirical ndings have been proposed by various groups in the last years, but so far they rem ain controversial (see e.g., [10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26] and the excellent review by Helbing [1]).

1.1. The fundam ental diagram approach and cellular autom ata models of the Nagel-Schreckenberg (NaSch) type

Empirical observations show that the higher the vehicle density is the low er the average vehicle speed. The average ow rate, which is the product of the average speed and the density, is a function of the density which has a maximum. This curve in the ow-density plane is called the fundam ental diagram [1, 2, 27].

Apparently the empirical fundam ental diagram was the reason that already the rst tra c ow models [28, 29, 30, 31, 32] were based upon the postulate that hypothetical spatially hom ogeneous and tim e-independent solutions, where all vehicles have the same distances to their neighbours and m ove with the same constant speed, (steady state solutions for short) exist that are related to a fundam ental diagram, i.e. a curve in the ow-density plane. (Steady state model solutions are offen called \equilibrium " solutions or \equilibrium " states of a tra c ow model. In this paper we will use the term \steady states".) A subset of these steady states would be unstable with respect to noise or external perturbations. This postulate underlies alm ost all tra c ow modeling approaches up to now [1, 2] in the sense that the models are constructed such that in the unperturbed, noiseless lim it they have a fundam ental diagram of steady states, i.e. the steady states form a curve in the ow-density plane.

The congested patterns which are calculated from these models for a hom ogeneous road (i.e. a road without bottlenecks) [1, 33, 34, 35] are due to the instability of steady states of the fundam ental diagram within some range of vehicle densities. When perturbed, they decay into a single or a sequence of wide moving jams (\moving

clusters" [33]), whose out ow saccelerate to rather high speeds com parable to free ow. This is why we nd it helpful to classify these models as belonging to what we call the \fundam ental diagram approach". In the next subsection another class of models will be described, which belong to the \three-phase tractheory" and lead to qualitatively dienent congested patterns, which are in better agreement with real observations. Its hallmark is a third kind of ow in addition to the wide moving jams and free ow, in which all vehicles interact strongly, but nevertheless drive smoothly at a reduced, rather uniform speed (synchronized ow). In view of the rich phenom enologies of the two model classes in particular near an on-ramp, the distinction of the two classes is admittedly a bit simplied at this point, but a more detailed com parison will be given in Sec. 5.

Apart from the congested patterns on a homogeneous road the dynamical behaviour near an on-ramp diers signicantly in the fundamental diagram approach [1, 10, 11, 12, 13, 14, 34, 15] and in the three-phase tractheory [8, 24]. It depends on both the ow rate to the on-ramp q_{on} and the initial ow rate on the road upstream of the on-ramp, q_{in} . Therefore it can be conveniently characterized by a so-called diagram of congested patterns. This is a map with coordinates q_{on} and q_{in} of the regions, where dierent congested patterns upstream of the on-ramp occur.

In this paper we focus on cellular autom ata (CA) trac ow modeling which was pioneered by Nagel and Schreckenberg in 1991/1992 [36]. The original Nagel-Schreckenberg model (NaSch model) as well as all subsequent modications and re nements of it [22, 23, 36, 37, 38, 39] belong to the fundam ental diagram approach (Fig. 1 (a)). See also the review s by W olf [40], Chow dhury et al. [2] and Helbing [1]. In this paper CA models belonging to the three-phase trac theory will be proposed, and it will be shown that their congested patterns di er qualitatively from the ones in the CA models of the NaSch-type.

W ithin the fundam ental diagram approach there is a subset of tra c models which show spatially hom ogeneous high density states with low speed. At rst sight these states look like synchronized ow ", but this interpretation is incompatible with the observed dynam ical behaviour near an on-ram p, as will be discussed now. In the diagram of congested patterns near an on-ram p obtained by Helbing et al. [1, 10] such high density states with low speed occur upstream of the on-ram p, if the ow rate q_{bn} to the on-ram p is high enough. Helbing et al. called these states hom ogeneous congested tra c" (HCT) [10] and proposed to identify it with synchronized ow [1]. In HCT no moving jam s occur spontaneously.

By contrast, in empirical observations of synchronized ow at low vehicle speed and high enough vehicle density moving jams do emerge spontaneously. These moving jams are particularly likely to occur, when due to the high ow rate to the on-ram p a strong compression of synchronized ow appears (the pinch e ect") [6, 8]. In fact, moving jams are only observed to emerge spontaneously in synchronized ow upstream of an on-ram p on which the ow rate is high enough [8]. At lower ow rates to the on-ram p synchronized ow of higher vehicle speed can occur in which the nucleation of moving jams was not observed.

1.2. The three-phase tra c theory

To explain the above and other empirical results, K emer introduced a three-phase tra c theory which postulates that the steady states of synchronized ow cover a 2D region in the ow-density plane, i.e. there is no fundamental diagram of tra c ow

in this theory [3, 6, 41, 42, 43].

This is not excluded by the empirical fact mentioned above, that a given vehicle density determ ines the average vehicle speed. Even if there is a continuous interval of di erent vehicle speeds at the same distance between vehicles (at the same density), as is indicated by empirical observations of synchronized ow, obviously their averaging leads to one value at the given density. A 2D region of steady states in the ow-density plane is also not ruled out by car follow ing experiments, where a driver has the task to follow a speci c leading car and not loose contact with it (e.g., [44]). In such a situation, the gap between the cars will be biased towards the security gap depending on the speed of the leading car. In synchronized ow the situation is di erent: The gap between cars can be much larger than the security gap.

As it has recently been postulated on very general grounds [8, 45] and demonstrated for a microscopic tracmodel [24], the fact whether the steady states of a mathematical description of tracbelong to a curve or to a 2D-region in the ow-density plane qualitatively changes the basic non-linear spatial-temporal features of the congested patterns which the model allows.

In particular the diagram of the congested patterns at on-ram ps is qualitatively di erent in three-phase tra c theory [8, 45, 24] from the diagram obtained in the fundam ental diagram approach [1, 10, 12, 13, 14, 15, 17]. Speci cally, at a high ow rate to the on-ram p, instead of HCT w ithout moving jams, we nd that moving jam s always spontaneously emerge in synchronized ow of low vehicle speed and high density, whereas synchronized ow of higher vehicle speed can exist for a long tim e w ithout an occurrence of moving jams [8, 24, 45]. This agrees with the empirical observations [8].

The m icroscopic m odel proposed by K emer and K lenov in order to derive the diagram of congested patterns within the three-phase tra c theory is relatively complex [24]. The main aim of this article is a derivation of cellular autom at a models within the three-phase tra c theory (where steady states of the models cover 2D - regions in the ow-density plane) which on the one hand are the most simple ones and on the other hand are able to reproduce the diagram of congested patterns found in [8, 24, 45]. The article is organized as follows. First, in the next section several cellular autom ata models with qualitatively di erent 2D -regions in the ow-density plane for steady states will be introduced. Second, the congested patterns at an on-ram p and their diagram s will be num erically derived for these models and com pared with one another and with the results in [24]. Third, the probability of the breakdown phenom enon (the F! S transition) at an on-ram p is studied and the capacity drop is calculated. Finally, the results of CA-m odels in the three-phase tra c theory and in the fundam ental diagram approach are compared.

2. Cellular autom ata m odels within three-phase tra c theory

2.1. Equations of motion

The starting point of CA-m odeling of three-phase trac theory is the basic set of nules from [24] which provides a 2D-region of steady states. Denoting the speed and space coordinate of a vehicle at discrete time t = n, n = 0;1;2;:: by v_n and x_n , respectively, the basic nules are rewritten for CA-m odels in the form :

 v_{free} is the maximum speed of the vehicles. It is assumed to be the same for all vehicles in this paper. $v_{s;n}$ is the save speed which must not be exceeded in order to avoid collisions. In general it depends on the space gap between vehicles, $g_n = x_{\gamma n} - x_n - d$ and the speed $v_{\gamma n}$ [46, 40], where the lower index `marks functions (or values) related to the vehicle in front of the one at x_n , the \leading vehicle", and d is the vehicle length (assumed to be the same for all vehicles in this paper). For the sake of comparability we neglect the $v_{\gamma n}$ -dependence and choose the same expression as in the standard N aSch-m odel [36]:

The crucial di erence compared to previous CA -m odels is that the acceleration behaviour given by v_{cin} (the rule of \speed change") depends on, whether the leading car is within a \synchronization distance" $D_n = D(v_n)$ or further away [24]. At su ciently large distances from the leading vehicle, one simply accelerates with an acceleration a, which is assumed to be the same for all vehicles and independent of time in this paper. However within the synchronization distance the vehicle tends to adjust its speed to the one of the leading vehicle, i.e. it decelerates with deceleration b if it is faster, and accelerates with a, if it becomes slower than the leading vehicle. The deceleration b should not be confused with braking for safety purposes (i.e. in order not to exceed v_{sn}). In practice the speed adjustment within the synchronization distance can often be achieved without braking at all simply as a result of rolling friction of the wheels with the road. Therefore the deceleration b is typically sm aller than the braking capability of a vehicle. For simplicity we set b = a in this paper, so that the speed change per time step within the synchronization distance is given by $v_n = a \operatorname{sgn}(v_n - v_n)$, where $\operatorname{sgn}(x)$ is 1 for x > 0, 0 for x = 0 and 1 for x < 0. In sum m ary,

W e want to emphasize that this rule decouples speed and gap between vehicles for dense tra c. This can be seen by assuming that vehicles drive behind each other with the same speed v. A coording to (3) neither the speed nor the gaps will change, provided, all the distances are anywhere between the safe distance d + v and the synchronization distance D (v) d + v. There is neither a speed-dependent distance, which individual drivers prefer, nor is there a distance-dependent optim al speed. This is the principal conceptual di erence between three-phase tra c theory and the fundam ental diagram approach, and it is the reason, why in three phase tra c theory the steady states lla two dimensional region in the ow-density-plane, while in the fundam ental diagram approach they lie on a curve.

Let us contrast (3) with two models belonging to the fundamental diagram approach, the NaSch-model with \com fortable driving" recently put forward by K nospe et al. [22, 23, 47] on the one hand, and W iedem ann's modelling approach [48] on the other. K nospe et al. [22, 23, 47] put forward an extension of the NaSch CA-model, in which a driver starts to brake within some interaction horizon, as soon as he sees the brake lights of the vehicle in front being switched on. If nobody puts on the brakes, vehicles would close up to the safe distance, which is a function of the speed. In this sense, the term \com fortable driving" is a bitm isleading: The behaviour m odeled ism ore accurately described as \com fortable braking". In contrast, the speed synchronisation (3) in our m odel happens always, whether som eone brakes or not. It

re ects what we believe to be the typical way, in which drivers take into account the vehicle in front of them .

In W iedem ann's modelling approach [48] each vehicle has a prefered following distance, but convergence to it is hindered due to imperfect perception, so that the actual distance has an oscillatory behaviour. This model belongs to the fundamental diagram approach, too, as the steady state solutions have a unique relationship between speed and distance between vehicles.

Of course, in models with a fundamental diagram of steady states, uctuations and external perturbations let the system evolve in time through a 2D region in the ow-density plane as well. However, the dynamics is governed locally by steady state properties, the unstable steady states acting as \repellors" and the stable ones as \attractors". If the steady states form a 2D region, part of which is stable and part of which is metastable, as is the case in three-phase tra c theory, the dynamics is fundamentally di erent. This leads also to qualitative di erences between the patterns of congested tra c obtained in three-phase tra c theory or in the fundamental diagram approach, respectively, as will be shown in detail below.

2.2. Synchronization distance

The conditions (1), (3) are the basis of the cellular autom ata models under consideration. It will be shown that this allows di erent form ulations for uctuations, acceleration, deceleration and for the synchronization distance D_n which all lead to qualitatively the same features of congested patterns and the same diagram of these patterns as postulated in three phase tra c theory [8, 45] and in agreem ent with the continuum model of K erner and K lenov in [24].

In particular, let us consider two di erent formulations for the dependence of the synchronization distance D_n on the vehicle speed. In the rst formulation, the synchronization distance D_n in (3) is a linear function of the vehicle speed:

In the second formulation, the synchronization distance D_n in (3) is a non-linear function of the vehicle speed:

In (4) and (5) d_1 , k and are positive constants. B oth form ulations lead to 2D -regions of steady states in the ow-density plane.

2.3. Steady states

W hereas in m odels belonging to the fundam ental diagram approach (e.g., [10, 12, 16, 18, 22, 23, 36, 39, 46, 49, 47] and the reviews [2, 1]) a vehicle would close up to the leading one adjusting its speed and gap as required by secure driving, in m odels with the basic structure (1), (3), a driver within the synchronization distance D_n adapts his speed to the one of the vehicle in front without caring, what the precise gap is, as long as it is safe. This explains why there is no unique ow-density relationship for steady states in the present CA m odels.

In steady states all accelerations must be zero. Then the time-index n can be dropped in the above formulas. According to (1) { (3), there are two possibilities: E ither the synchronization distance D (v) < g + d and the speed is $v = v_{free}$, or

Thus, in steady states all speeds are equal v. The conditions v has to full are only equal, if also the gaps g are all equal. Therefore we de ned steady states above as tim e-independent and hom ogeneous.

The density and the ow rate q are related to the gap g and the speed v by

Because v and g are integer in CA-m odels, the steady states do not form a continuum in the ow-density plane as they do in [24]. However, the inequalities of (6) de ne a two-dimensional region in the ow-density plane, in which steady states exist. As in [24] it is limited by three boundaries (Figs. 1 (b) and 2 (a, b)), the upper line U, the lower curve L, and the left line F. The parameters of the lines F and U are chosen to be the same for all CA m odels under consideration. Note that without the lower boundary L, the lines F and U constitute the fundamental diagram of the N aSch CA-m odel (Fig. 1 (a)) [36].

The left boundary F is given by $q = v_{free}$. This is free ow, where the ow rate q is not restricted by safety-requirem ents. On the upper boundary U the ow rate is determ ined by the safe speed v_s . For example, inserting (2) and (7) it is given by

The lower boundary L is determined by the synchronization distance D: A steady state with density and a speed $v < v_{\rm free}$ requires that D (v) 1= with equality on the lower boundary L. For example, using (4) with $d_1 = d$ one obtains (see Fig. 1 (b))

In the second model (5) the lower boundary L is a non-linear curve (see Fig 2 (a)):

This curve has the upper line U as a tangent at $= \max_{m ax} = 1=d$. As will be shown below, this allows to reproduce qualitatively the diagram of congested patterns of three-phase trac theory with simpler uctuations than what is needed in the case of the linear synchronization distance (4) with $d_1 = d$. However, if the parameter d_1 is chosen sm aller than d in (4), the line L intersects the line U before the jam density $\max_{m ax}$ is reached (Fig. 2(b)). In this case, if the di erence d d_1 is chosen in a proper way, the uctuations in the model with linear synchronization distance (4) may be as simple as for the non-linear D (5), in order to lead to qualitatively the same features. We also did simulations (not shown in this paper), where we replaced d in (5) by $d_1 < d$: The qualitative results remain unchanged.

2.4. Fluctuations of acceleration and deceleration

In order to show the power of the basic model (1), (3) [24], the remaining model speci cations (free and safe speeds, uctuations) will be the same as introduced in di erent N agel-Schreckenberg CA -m odels in the fundam ental diagram approach [36, 38, 39, 22, 23, 49, 50] (with a slightly more general modeling of uctuations). Nevertheless, it will be shown that all features of congested patterns which spontaneously occur upstream of the on-ram p as well as of their evolution (when the ow rate to the on-ram p is changing) are di erent in our CA-m odels. This proves that the basic rules (1), (3) [24] place our CA-m odels in the class belonging to the three-phase tra c theory.

In particular, as in the NaSch CA models [36, 38, 39, 22, 23, 49], the accelerations and decelerations are stochastic. They are implemented like in [39, 22]: In a rst step, a prelim inary vehicle speed of each vehicle v_{n+1} is

where v_{n+1} is calculated based on the system of the dynam ical equations (1) { (3). In a second step, a uctuation a $_n$ (to be specified below) is added to the value v_{n+1} calculated from the rst step. Finally the speed v_{n+1} at the time n + 1 is calculated by

This means, that the stochastic contribution a $_{n}$ may neither lead to a speed sm aller than zero, nor to a speed larger than what the determ inistic acceleration a would give, taking the limitations by $v_{\rm free}$ and $v_{\rm sm}$ into account.

We implement the uctuation $_{n}$ in (12) as

where r denotes a random number uniform by distributed between 0 and 1. This is a generalization of the random deceleration (with probability p_b) in NaSch cellular autom ata models [22, 23], because with probability p_a also a random acceleration can occur. $p_a + p_b$ 1 must be fullled. In a di erent way and for a di erent purpose a random acceleration was also introduced in CA-m odels by Brilon and W u [50]. As in a NaSch CA-m odel in the fundam ental diagram approach [39], the probability p_b in (13) is taken as a decreasing function of the vehicle speed v_n :

where p and $p_0 > p$ are constants. This corresponds to the slow-to-start rules rst introduced by Takayasu and Takayasu [51] and later used in the NaSch CA model by Barlovic et al. [39]: Vehicles escape at the downstream front of a wide moving jam with the mean delay time $_{del} = = (1 \quad p_0)$. As in [23] this provides the jam propagation through free and synchronized ows with the same velocity v_g of the downstream jam front that corresponds to a qualitative theory and to the related form ula $v_g = 1 = (m_{ax} del)$ from [6]. $m_{ax} = 1 = d$ is the density inside the jam.

The probability p_a of the random acceleration in (13) is also taken as a decreasing function of the vehicle speed v_n :

where v_p , p_{a1} and $p_{a2} < p_{a1}$ are constants. This simulates the e ect that the vehicle moving at low speed in the dense ow tends to close up to the leading one. Indeed, according to (1)-(4), (12), (13), if the probability p_a of the acceleration is high, the e ect of adapting one's speed to the speed of the leading vehicle is weak: W ith probability p_a the vehicle does not reduce its speed, and it may do so until it reaches the minimal safe gap. Note that the tendency to minimize the space gap at low speed can lead in particular to the 'pinch' e ect in synchronized tra c ow [4, 6], i.e., to the self-com pression of the synchronized ow at lower vehicle speed with the spontaneous emergence of moving jam s.

The tendency to m inimize the space gap at low speed is automatically built into our models, if the lower boundary L approaches the upper line U as in Fig.2 (a) and (b), because then the synchronization distance is no longer larger than the security gap at small speed. Indeed it turns out that the speed dependence (15) of p_a is not required in these cases for a realistic modelling. Therefore we choose the probability p_a of acceleration in (13) to be a constant in the model variants of Fig. 2.

2.5. Cellular autom ata models with cruise control within three-phase tra c theory

N ageland Paczuski [37] proposed a variant of the N aSch CA-m odelwhere uctuations are turned o for the vehicle speed $v_n = v_{free}$. This variant has been called the N aSch CA-m odelwith cruise control [1, 37].

In the case of such cruise control, i.e., when uctuations are turned o for the vehicle speed $v_n = v_{free}$, simpler CA models can be used, if either the synchronization distance is the non-linear one, (5) (Fig. 2 (a)), or if in the synchronization distance (4) $d_1 < d$ (Fig. 2 (b)).

In these cases, the CA-m odels with cruise control within three-phase trac theory consist again of the form ulas (1)-(3) and (5) (or (4) where $d_1 < d$). The form ula (12) for the incorporation of uctuations into the nal value of the speed v_{n+1} at time (n + 1) is also valid, but can be simplified, if only deceleration noise like in the N aSch-type cellular autom ats [39, 22, 23] is implemented:

2.6. Sum m ary of the new m odels and their param eters

In the following sections we shall discuss the congestion patterns obtained from $\sin u$ lations of four CA-models belonging to the class of three-phase trac theory as introduced above. For easier reference we specify them in Table 1 with the abbreviations KKW -1 to KKW -4. In addition we provide two tables containing a list of symbols (Table 2) and typical values for the parameters (Table 3).

A few remarks on the time and space discretization are in order. The usual choice of the time step in CA-models of tracis = 1s [2, 36]. Like in [22] we use a small-scale discretisation of space: The length of cells is chosen equal to x = 0.5 m. This leads to a speed discretisation in units of v = 1.8 km = h. Hence two vehicles are only considered as moving with di erent speeds, if this di erence is equal to (or larger) than v. In the model [24] with continuous changes in the vehicle speed, two vehicles are considered as di erent, if their di erence exceeds a much smaller

value $v = 10^{6}$ m = s. This is one of the reasons why uctuations in cellular autom ata are in general stronger than in the corresponding continuum model.

For allCA-models within the three-phase-tractheory investigated here we chose the probability $p_0 = 0.425$. This corresponds to a velocity $v_g = 15.5$ km =h of the downstream front of a wide moving jam and an out ow $q_{\rm out} = 1810$ vehicles=h from a wide moving jam. Note that the ow rate $q_{\rm out}$ refers to the case, where the vehicles reach the maximum vehicle speed $v = v_{\rm free}$, after they have escaped from the jam.

For the sake of comparison with other tracm odels, we choose occasionally in

Sec. 5 m odel parameters deviating from the ones given in Table 3. In this case the parameter values are given in the related gure captions.

3. Congested patterns on a hom ogeneous one-lane road

All CA -m odels introduced here (Table 1) show qualitatively similar results on the hom ogeneous one-lane road. Therefore, only num erical results of a simulation of m odel K K W -1 (Fig. 1 (b)) will be presented in this section.

For simulations of congested patterns on a hom ogeneous one-lane road, cyclic boundary conditions have been used. The one-lane hom ogeneous road has the length 60000 cells (30 km). We checked that all qualitative results remain the same, if open

boundary conditions are used and the length of the road is large enough.

3.1. Complex dynamics of synchronized ow

The features of spatio-tem poralpattern form ation on a hom ogeneous road (i.e. a road without bottlenecks or on-ram ps) are largely the same for the K K W -m odels considered here and the continuum m odel of K emer and K lenov [24]. How ever, due to stronger uctuations in the CA-m odels, the dynam ics of perturbations is som ew hat di erent.

(i) If the initial ow rate q_{in} does not exceed a value $q_{m\,\,ax} < \,q_D$,

the uctuations do not perturb the speed of a vehicle, which initially has maximal speed $v_{\rm free}$, signi cantly (Fig. 3 (a-c)). In this case, the uctuations lead to changes in the distances between vehicles, i.e. to a change in the vehicle density and hence to a change in the ow rate (black points F in Fig. 3 (c)).

(ii) However, if

the model uctuations lead to an occurrence of inhom ogeneous and non-stationary synchronized ow states where the vehicle speed is lower than $v_{\rm free}$ (Fig. 3 (d-f)). A coording to K emer's hypothesis about continuous spatio-tem poral transitions between di erent states of synchronized ow in three-phase trac theory [41, 42, 43] this behaviour corresponds to a complex motion within the 2D region in the ow-density plane, where steady states exist (open circles S in Fig. 3 (f)). Similar continuous spatio-tem poral transitions between di erent states of synchronized ow in agreem ent with K emer's hypothesis have recently also been found in a di erent C A m odel by Fukui et al. [26].

These inhom ogeneous synchronized ow states are the result ofm any independent local transitions at di erent road locations. As they cause a reduction of the initial m axim alvehicle speed, they look sim ilar to the F! S-transitions on the two-lane road which have been studied in [24]. How ever, in [24] the F! S-transition was in general caused by an external local perturbation, which led to the form ation of a local region of synchronized ow (see Fig. 1 (c) in [24]). By contrast, in the CA m odels under consideration the local transitions were induced by the intrinsic m odel uctuations in a wide range of densities given by (20). No external local perturbation was applied. As a consequence, a com plex inhom ogeneous spatio-tem poral pattern of synchronized ow appears everywhere on the road instead of the local region triggered by a perturbation in the continuum m odel (com pare Fig. 3 (d) in this article with Fig. 1 (c) in [24]).

(iii) A hom ogeneous initial state with vehicle speed lower than v_{free} , which in the absence of uctuations would belong to the steady states within the 2D-region of the ow-density plane, remains a synchronized ow state for a long time. However, as in (ii) the evolution of these synchronized ow states shows a complex spatio-tem poral behaviour of all trac ow variables (Fig. 4) due to the intrinsic model uctuations.

3.2. Em ergence of wide moving jam s

The emergence of wide moving jams (Fig. 5) shows qualitatively the same features as in [24].

(i) In particular, as in [24], moving jam s do not occur spontaneously, if the initial state with maximal vehicle speed $v = v_{free}$ lies within the range of ow rates (19), where the maximal speed can be maintained.

For a subset of these states, those with a density above a threshold for the wide moving jam formation, min (Figs. 3 (c, f) and 5 (c)), wide moving jams can be induced, but only by a very strong local perturbation. For the case when trac ow with the maximal vehicle speed $v = v_{\rm free}$ is formed downstream of a wide moving jam, the density min is related to the ow rate in the out ow of the wide moving jam, q_{out}.

The velocity of the downstream front of the wide moving jam v_g is a characteristic, i.e., unique, predictable and reproducible parameter which is a constant for given model parameters. This velocity together with the threshold point, ($m_{in};q_{but}$), determines the characteristic line J for the downstream front of a wide moving jam (the line J in Figs. 3 (c, f), 4 (c) and 5 (c)).

The strength of the perturbation needed to trigger a wide moving jam is highest for densities close to $_{m in}$. Then it is not enough that a vehicle is forced to stop (the maxim alam plitude of a perturbation), but this stop must be maintained for some time (about 2-3 m inutes at $_{m in}$) for a wide moving jam to nucleate in an initial trac ow with maxim all speed v = v_{free}. Note that for initial densities which are only slightly higher than $_{m in}$ a wide moving jam often spontaneously disappears due to the high

uctuations of the out ow from the jam in the KKW -1 m odel.

(ii) As in [24], the line J determ ines the threshold of the wide moving jam excitation in synchronized ow: All densities in steady synchronized ows related to the line J are threshold densities with respect to the jam formation (the S! J-transition). At a given speed, the higher the density, the lower is the critical amplitude v_c of a local perturbation for the S! J-transition: The critical amplitude v_c for the S! J-transition reaches its maximum value at the threshold density. At a given di erence between an initial density and the threshold density, the lower the initial speed, the lower the critical amplitude v_c is.

However, for synchronized ow states which lie in the vicinity of the safe speed (in the vicinity of the line U in Figs. 1 (b) and 2) the strong intrinsic model uctuations in the KKW -m odels (Table 1) lead to the S! J-transition without the need of any external local perturbation.

(iii) The latter result allows a simulation of the spontaneous emergence of wide moving jams (Fig.5 (a-c)). In the initial state all vehicles move with the maximal speed $v = v_{\rm free}$. For a low rate in the interval (20), the initial vehicle speed $v = v_{\rm free}$ can not be maintained for a long time: Due to local transitions the vehicle speed decreases and states of synchronized ow are formed at some locations on the road (Fig.5 (b, c) at x = 14 km) as already described in (ii) in Sect. 3.1. In these synchronized ow states, model uctuations grow leading to the spontaneous emergence of wide moving jam (Figs. 5 (a) and (b, c) at x = 8 km). For the model parameters used in Fig. 5 the spontaneous emergence of a wide moving jam can also occur for an initial state of synchronized ow with speed $v_{\rm in} < v_{\rm free}$.

Note that the uctuation parameters p and p_{a2} of both, random deceleration and random acceleration, are larger than in Fig.3 and 4, where no spontaneous emergence of wide moving jams from synchronized ow states had been observed within the simulation time. Fast drivers are more \nervous" in Fig. 5 than in the previous gures. However, this is not the only reason for the emergence of wide moving jams in the present example. This can be seen by comparing the average values of the random contribution to the speed for speeds larger than $v_p = 50.4$ km =h: W hile in the previous Figures h i = p_{a2} p = 0.012, it is here more than twice as large: h i = 0.03. A positive value of h im eans that the drivers are biased tow ands stochastic acceleration rather than deceleration. A stronger bias im plies a higher delay time in the vehicle deceleration. W e will come back to the question, how this makes wide m oving jams m ore likely, below, in Sec. 4.2 (ii).

(iv) Thus, as in the model of K emer and K lenov [24], in an initial trac ow with the maximal speed $v = v_{\text{free}}$ model uctuations can cause the spontaneous occurrence of synchronized ow, but not the spontaneous emergence of wide moving jams. The latter was only found in the KKW -models (Table 1), once synchronized ow was established. That synchronized ow states should occur rst and only later the spontaneous wide moving jam, is a common feature of three-phase-trac theory and agrees with empirical observations [3, 6]. Thus, in the KKW -m odels within the three-phase trac theory the diagram of congested patterns on the hom ogeneous road is qualitatively di erent from those in other approaches [1, 2].

4. Congested patterns at on-ram ps

4.1. Model of on-ram p

In this section, for all simulations of congested patterns at an on-ram p a one-lane road of 100 km length (200000 cells) with open boundary conditions is used. The reference point x = 0 is placed at the distance 20 km from the end of the road, so that it begins at the coordinate x = 80 km. The on-ram p starts at the point x = 16 km (32000 cells) and its merging area was 0.3 km long (600 cells).

For simulation of the on-ram p two consecutive vehicles on the main road within the on-ram p area are chosen random ly, their coordinates being denoted by $x^+ > x$. The entering vehicle is placed in the middle point between them at the coordinate $x_n = [(x^+ + x + 1)=2]$ (here [] denotes the integer part), taking the speed of the leading vehicle v^+ [18]. In addition it was required that the distance between the two vehicles on the main road should exceed some value

where was chosen to be equal to 0:55, if not stated explicitly otherwise.

O ur num erical investigations have shown that the main qualitative features of congested patterns at the on-ram p and of the related diagrams do not change, if instead of these simple rules for a vehicle squeezing in from the on-ram p to the road m ore sophisticated lane changing rules are used. It is important, how ever, that on the one hand the model of the on-ram p allows a gradual change of the ow rate to the on-ram p $q_{\rm on}$ from nearly zero to a relatively large (but for trac ow relevant) value, and on the other hand does not introduce large additional speed uctuations, when a vehicle from the on-ram p m erges with the trac ow on the main road.

4.2. D iagram s of congested patterns at on-ram ps

A diagram of congested patterns at the on-ram p represents regions of spontaneous occurrence of congested patterns upstream of the on-ram p at di erent values of the initial ow rate to the on-ram p q_{on} and the initial ow rate on the one-lane road q_{in} upstream of the on-ram p. As will be discussed in m ore detail below, these regions in principle depend on how long one waits, i.e. in how far one sam ples rare events. In practice a typical waiting tim e m uch longer than one hour has little m eaning, as real tra c is not a stationary stochastic process on large tim e scales.

W e found that the CA-m odels under consideration (Table 1) essentially show the same diagram of congested patterns which has been predicted for the three-phase tra c theory [8] and previously obtained in the continuous m icroscopic m odel [24]. How ever, for some parameter values there are interesting peculiarities in the KKW - m odels.

(i) In Fig.6 (a) and (b) the diagram of congested patterns at an on-ram p is shown for two di erent sets of the parameters of the KKW -1 m odel (Table 1) (parameterset I and parameterset II in Table 3, respectively). A lthough the KKW -1 m odel is considerably simpler than the model of K erner and K lenov studied in [24], the main features of the diagram (Fig. 6 (a)) and the related congested patterns which spontaneously occur upstream of the on-ram p (Figs. 7, 8 and 9) are qualitatively the same as in [24].

There are twom ain boundaries $F_s^{(B)}$ and $S_J^{(B)}$ on the diagram (Fig.6). The limit point of the boundary $F_s^{(B)}$ at $q_{pn} = 0$ is related to the maximum ow rate in free ow

where $q_{in} = q_{n ax}$. The explanation of the lim it point $q_{in} = q_{m ax}$ is very simple: On the hom ogeneous one-lane road (i.e. without the on-ram p) synchronized ow occurs spontaneously, if the ow rate exceeds $q_{m ax}$ (range (20)). Therefore, synchronized patterns should spontaneously occur upstream of the on-ram p for $q_{in} = q_{m ax}$ already for vanishing ow rate to the on-ram p q_{on} ! O.

Below and left of the boundary $F_S^{(B)}$ free ow occurs. Between the boundaries $F_S^{(B)}$ and $S_J^{(B)}$ di erent synchronized ow patterns (SP) occur upstream of the on-ram p, without wide moving jams being observed.

Right of the boundary $S_J^{(B)}$ wide moving jams spontaneously emerge in synchronized ow which has been form edupstream of the on-ramp. The only di erence compared to the results in [24] is that in Fig. 6 (a) there is no region where the moving synchronized ow pattern (MSP) occurs (about a possible occurrence of MSP see below). The diagram in Fig. 6 (a) is in accordance with general features of the diagram s of congested patterns at the on-ramp on a one-lane road which was postulated from qualitative considerations in [8].

A few technical remarks about the determ ination of the boundary $F_S^{(B)}$ are in order: A fler the on-ram p has been switched on at $t = t_0$, there is a transient, before the congested patterns are established upstream of the on-ram p, and one needs some criterion to detect the transition from free to synchronized ow. The criterion we used is that the speed drops below some threshold value V_{FS} and stays low for at least 4 m in. The value of V_{FS} is chosen equal to 80 km =h.

The delay time, until this criterion of the transition from free ow to synchronized ow is fullled, is marked as T_{FS} in Fig. 10. This delay time can be rather short (1 2 min) for large values of q_{pn} (Fig. 10 (a)) and increases for decreasing q_{pn} (Fig. 10 (b)). For small values of q_{pn} the speed returns quickly to high values, whenever it happened to drop below V_{FS} . Then one would not speak of a transition into synchronized ow any more (Fig. 10 (c)). This behaviour of T_{FS} has been used to determ ine the boundary $F_S^{(B)}$. Scanning the ($q_{pn};q_{in}$)-plane on a grid the leftm ost points were determ ined, where T_{FS} is still smaller or equal 30 m in (Fig. 10 (d)). Sim ilarly, a point on the boundary $S_J^{(B)}$ is found as the leftm ost point ($q_{pn};q_{in}$), where a wide moving jam emerges in synchronized ow within 60 m in. Thus, the quantitative positions of the boundaries $F_S^{(B)}$ and $S_J^{(B)}$ depend on the chosen time intervals. However, the qualitative forms of these boundaries are independent of the choice of the time intervals, provided they are high enough.

(ii) The diagram of congested patterns at the on-ram p in Fig.6 (b) is obtained for the same modelKKW -1 (Table 1) as in (a), however with the uctuation parameters parameter-set II in Table 3. As pointed out already in connection with Fig.5, this means that the delay time of vehicle deceleration was increased compared to Fig.6 (a). This has two e ects: First, the region between the boundaries $F_{\rm S}^{(B)}$ and $S_{\rm J}^{(B)}$, where SP occur without spontaneous wide moving jam formation, is reduced. Second, the boundaries $F_{\rm S}^{(B)}$ and $S_{\rm J}^{(B)}$ merge in the limit point $q_{\rm in} = q_{\rm max}$, where $q_{\rm on}$! 0. This means that in the CA-m odel with higher delay time of vehicle deceleration wide moving jams can spontaneously occur in synchronized ow already at extrem ely low ow rates to the on-ram p in the vicinity of the point $q_{\rm in} = q_{\rm max}$.

This can be explained by realizing that in the present model, an increase in the delay time of vehicle deceleration makes the e ect of speed adjustment within the synchronization distance weaker. As a result, it becomes more likely that a vehicle

closes up to the leading one, i.e. reaches the minimal safe gap g_n , so that model uctuations more easily get amplied to cause a wide moving jam.

(iii) In m odel KKW -2 (non-linear synchronization distance D (v)) the diagram of congested patterns at the on-ramp (Fig. 11 (a)) and the related congested patterns upstream of the on-ramp (Figs. 12, 13, 14) possess the same qualitative features as discussed in Fig. 6.

There is a peculiarity of the diagram of congested patterns (Fig.11 (b)) form odel KKW -3 (cruise control). In this case, there are no model uctuations at the maximal speed v = $v_{\rm free}$. Thus, if the ow rate to the on-ram p $q_{\rm on}$ = 0 and the initial state is related to the maximal speed v = $v_{\rm free}$, synchronized ow with lower vehicle speed can not appear spontaneously up to the top ow rate $q_{\rm in}$ = q_0 (see Fig.11 (b) and Fig.2 (a)).

However, already at an extrem ely low ow rate of q_{on} 1 2 vehicles—h these synchronized ow states with lower speed spontaneously appear upstream of the on-ram p, because of a small disturbance of the initial ow at the on-ram p. M oreover, the ow rate $q_{in} = q_{n ax}$ at which this e ect occurs can be noticeably lower than q_{out} in this case (Fig. 11 (b)). Therefore, at all ow rates q_{in} within the range

SP occur spontaneously at the on-ram p for q_{bn} as small as 1 2 vehicles=h (Fig. 11 (b)).

W e found that the KKW -4 m odel, which di ers from KKW -2 only by having the synchronization distance which leads to Fig. 2 (b) rather than Fig. 2 (a), can show qualitative the same diagram of congested patterns as obtained for m odel KKW -2 (Fig. 11 (a)). Likewise, if one replaces the non-linear synchronization distance in the cruise controlm odel KKW -3 by form ula (4) with $d_1 < d$ (as in KKW -4), the diagram of congested patterns can rem ain qualitative the same as Fig. 11 (b).

To explain these results, rst recall that in all these KKW -m odels the probability p_a (15) was independent of the vehicle speed, in contrast to the previously considered KKW -1 m odel. The fact that this simplication of acceleration noise nevertheless allows us to simulate the qualitatively correct pattern form ation in the three-phase trac theory can be traced back to the di erence in the 2D-regions of the steady states in the ow density plane for these CA-m odels:

For bw vehicle speeds the boundary L for these models is either tangential to the boundary U (Fig. 2(a)), or even coincides with it (Fig. 2(b)). On the other hand, the num erical study of the KKW -m odels shows that, if the vehicle speed in synchronized ow is very close to the safe speed, i.e. for synchronized states close to the boundary U, uctuations easily lead to the em ergence of a wide moving jam. As already mentioned, the purpose of introducing acceleration noise in ourm odels is a simulation of the pinch e ect, where moving jam s em erge spontaneously. B oth models in Fig. 2 are su ciently sensitive to uctuations at low speeds that the pinch e ect can be achieved with a relatively small probability p_a independent of the vehicle speed.

In contrast, in the KKW -1 model the boundary L of the 2D -region of steady states is not close enough to the boundary U even at low vehicle speeds (Fig. 1 (b)). In particular, there are synchronized states with low vehicle speed, which lie below the line J. Therefore, the probability p_a had to be chosen higher at low speeds in order to enhance the likelihood that a driver comes close to the boundary U. Then the pinch e ect is also obtained in this model, in accordance with empirical observations in [6, 8].

4.3. Synchronized ow patterns (SP)

As in [24], depending on the parameters either the widening synchronized ow pattern (W SP), or the moving synchronized ow pattern (M SP), or the localized synchronized ow pattern (LSP) can occur in our CA-m odels.

(i) As in [24], W SP occurs at high initial ow rate on the road upstream of the on-ram p, q_{in} , and low ow rate to the on-ram p, q_{on} , between the boundaries $F_s^{(B)}$ and $S_J^{(B)}$. The downstream front of W SP is localized at the on-ram p. The upstream front is continuously moving upstream, so that the width of W SP is gradually increasing in time (Figs. 7 (d, e), 9 (a, b), 12 (d), 14, 15 (b) and 16).

(ii) D epending on the ow rates q_{in} and q_{on} the distribution of the vehicle speeds inside W SP can be related to states with nearly hom ogeneous speed (Figs. 7 (d) and 9 (a, c)), or to non-hom ogeneous speed distributions, where sometimes non-stationary vehicle speed waves (propagating with di erent, negative and positive velocities) can occur (Figs. 7 (e) and 9 (b, d)).

(iii) Note a peculiarity of the KKW -models: The upstream front in WSP which separates synchronized ow downstream and free ow upstream moves with a relatively high velocity $(v_g^{(WSP)} 40 \text{ km/h})$. This non-realistic velocity is a consequence of simplicity of the models presented. In spite of this, the models give a realistic qualitative description of congested patterns and their evolution. More correct values for the front velocity have been found in the microscopic model of K erner and K lenov [24]. The other way to obtain realistic velocity of the front between free and synchronized ow smay be the use of a strongly non-uniform free ow upstream of the on-ramp. In this case, there is a large spread of gaps between vehicles in free ow. As a result, the speed of the front is diminished due to the presence of vehicles with too small gaps between them.

(iv) Recall that at very low ow rate to the on-ram p, q_{on} , and high initial ow rate on the road upstream of the on-ram p, q_{in} , in the diagram derived in [24] there is a region \M SP", where the moving synchronized ow pattern (M SP) spontaneously occurs. In this case, after SP has emerged upstream of the on-ram p, this SP comes o the on-ram p and begins to move upstream. In some cases, a new SP emerges at the on-ram p; this SP comes o the on-ram p later, and so on.

In contrast to the diagram of congested patterns in [24], W SP can appear also at very low ow rate to the on-ram p q_{on} (Figs. 6, 11). In other words, there is no region $\langle M SP \rangle$ " in our diagram s, which look like the one postulated by K erner [8] based on a qualitative consideration of the three-phase trac theory approach for a one-lane road. How ever, in [8] it was also mentioned that uctuations may cause M SP in the region, where W SP exists norm ally. Apparently for this reason, sometimes M SP appears at very low ow rate to the on-ram p q_{on} (close to the boundary $F_{s}^{(B)}$) in the region of W SP in the CA-m odels.

Thise ect is shown for the KKW -3 cnuise-control-m odel (Table 1) in Figs.15 (d) and 17, where MSP usually occurs in the region m arked \WSP & MSP" in the related diagram of congested patterns (Fig. 11 (b)) at lower ow rate to the on-ram p, q_{on} . W ithin the region \WSP & MSP" (at a slightly higher ow rate q_{on} than the one at which MSP occurs) a pattern which looks like a m ixture of WSP and MSP can occur (Fig.15 (c)): Near the on-ram p this pattern resembles MSP. How ever, upstream of the on-ram p the pattern m ore and m ore transform s into WSP. Note another peculiarity of the KKW -3 m odel: W hen WSP occurs in this m odel, the vehicle speeds and the ow rates in this WSP are usually related to points in the ow-density plane which are

in the vicinity or lie on the boundary L in the ow-density plane (Fig. 2 (a)), which corresponds to the synchronization distance D (see circles in Fig. 16 (b)). P resum ably, this behaviour is not a comm on feature of W SP, but due to the sim plicity of the m odel.

(v) As in the diagram in [24], at higher ow rate q_{on} and lower ow rate q_{in} between the boundaries $F_s^{(B)}$ and $S_J^{(B)}$ the localized synchronized ow pattern (LSP) occurs. The downstream front of LSP is localized at the on-ramp. However, the upstream front of LSP is not continuously moving upstream, so that the width of LSP remains spatially limited (Figs. 6 and 7 (f)). Note that the upstream front of LSP and therefore the width of LSP can oscillate in time. Moreover, at ow rates close to the boundary $F_s^{(B)}$, uctuations can cause random appearance and disappearance of LSP. The boundary which separates the region of WSP (see Figs. 6 and 11) from the region of LSP is marked by the letter W in the diagram of congested patterns.

4.4. General patterns (GP)

Right of the boundaries $S_J^{(B)}$ and G in Figs. 6 and 11 one nds the \general pattern" (GP). It is a self-maintaining congested pattern, where synchronized ow occurs upstream of the on-ramp, and wide moving jams spontaneously emerge in this synchronized ow (Figs. 7 (a, b) and 8, 12 (a, b) and 13, 15 (a)). In other words, in the GP wide moving jams are continuously generated som ewhere upstream of the on-ramp. In the out ow of the wide moving jams either synchronized ow or free ow occurs. GP in the KKW -m odels within the three-phase-tra c theory have comm on features, which are very sim ilar to those found in [24]:

(i) If free ow occurs in the out ow of a wide moving jam, then the mean velocity of the downstream jam front v_g and the mean ow rate in the jam out ow q_{out} are characteristic quantities of the model. They do not depend on initial conditions and are the same for di erent wide moving jams. The mean velocity of the downstream front remains a characteristic parameter no matter, what the state of ow in the jam out ow is.

(ii) If $q_{in} > q_{out}$, then it is obvious that the width of the wide moving jam, which is furthest upstream, increases monotonously (Figs. 7 (a), 8 (b), and 12 (a)). If in contrast, $q_{in} < q_{out}$, the width of the most upstream wide moving jam decreases and this jam dissolves. This process of wide moving jam dissolution repeates for the next most upstream jam and so on (Figs. 7 (b) and and 12 (b)). Nevertheless, if the di erence between q_{out} and q_{in} is not very large, the region of wide moving jams is widening upstream over time (Figs. 7 (b) and and 12 (b)). Thus, GP which is very sim ilar to the GP found in [24] spontaneously occurs in all CA-m odels (Table 1) within three-phase tra c ow theory under consideration. How ever, there are some peculiarities of the KKW -m odels which will be considered below.

(iii) The rst peculiarity of the KKW -m odels considered here is linked to the fact m entioned above that the upstream front in WSP which separates synchronized ow downstream and free ow upstream moves with a very high (non-realistic) negative velocity. Let us consider a case, in which the ow rate q_{in} is high (it corresponds to a point above the boundary W, Figs. 6 and 11) and the ow rate q_{on} is related to a point right of the boundary S_J^(B) in the diagram of congested patterns. In this case, rst WSP occurs which further transforms into the GP, i.e., wide moving jams spontaneously emerge inside the synchronized ow of the initial WSP (Figs. 7 (a) and 12 (a)). However, the upstream front of this initial WSP moves considerably

faster upstream than the fronts of any wide moving jam. For this reason, the upstream front of the whole GP at any ow rate q_{in} is determined by this upstream front of synchronized ow rather than by the most upstream wide moving jam. In Fig. 8 this upstream front of the synchronized ow is marked by the dashed line. Note that such a GP has been observed in empirical observations (see Fig. 20 and Sec. V A in [8]). In all CA -m odels within the three-phase-tract theory under consideration GP possesses sim ilar non-linear features (com pare Fig. 7 (a, b) with Figs. 12 (a, b), 15 (a) and Fig. 8 with Fig. 13).

(iv) There is also some dierence in the GP form ation in the continuous model [24] and in the KKW -m odels in the three-phase tract theory. This dierence concerns the boundary G which separates the dissolving general pattern (DGP) and the GP.

Recall that DGP appears right of the boundary $S_J^{(B)}$ at the initial ow rate $q_{in} > q_{but}$. In this case, after a wide moving jam has been formed in synchronized ow upstream of the on-ramp, the mean ow rate in the jam out ow cannot exceed q_{out} . Thus, the initial condition $q_{in} > q_{but}$ is not fulled any more. As a result, the GP transforms into DGP, where one or several wide moving jams propagate upstream, and either free ow or one of SP occurs upstream of the on-ramp. This behaviour is realized also in the KKW -m odels (Figs. 7 (c) and 12 (c)).

In [24] the boundary G intersects the boundary $S_J^{(B)}$ in the point $q_{in} = q_{out}$. In the CA-m odels under consideration, however, the boundary G is shifted to the left in the diagram of congested patterns, i.e., the boundary G intersects the boundary $S_J^{(B)}$ at some $q_{in} > q_{out}$ (Figs. 6 and 11).

This behaviour may be explained by hysteresis e ects or by the in uence of high amplitude uctuations (see the related remark at the end of Sec. VIIB.1 in [8]). Indeed, in comparison with the model in [24] in the CA-models model uctuations are very high. High amplitude uctuations occur also in the out ow of a wide moving jam. This may explain why for $q_{in} > q_{out}$ right of the boundary $S_J^{(B)}$ still the general pattern rather than DGP may occur at considerably lower ow rate to the on-ram p q_{on} than in the model in [24].

(v) In some cases the GP like that shown in Fig. 7 (b), i.e., the GP where the most upstream jam is dissolved in the course of time, can occur even if the initial ow rate q_{in} is slightly higher than q_{but} . This is linked to the fact mentioned in item (iii) above that the upstream front of synchronized ow in the GP propagates upstream faster than the one of any wide moving jam (see Fig. 7 (a, b) and Fig. 8 (b), where this upstream front is marked by the dashed line). Thus, upstream of the most upstream wide moving jam in GP a synchronized ow is formed. The ow rate in this synchronized ow, $q_{in}^{(syn)}$, is always lower than the initial ow rate q_{in} . The latter ow rate is realized upstream of the upstream front of synchronized ow in GP (Fig. 7 (a, b)). Therefore, the ow rate downstream of the upstream front of synchronized ow in GP, i.e., the ow rate $q_{in}^{(syn)}$ is the incoming ow rate for the most upstream wide moving jam rather than the initial ow rate q_{in} . For the KKW -1 m odel (param eter-set I of Table 3) the maximal value of the ow rate q_{in} at which GP of this type occurs is 1960 vehicles=h. For the KKW -2 m odel this ow rate q_{in} is very close to the ow rate $q_{out} = 1810$ vehicles=h. For the KKW -3 m odel this ow rate is $q_{in} = 2160$ vehicles=h.

(vi) In empirical observations of GP at on-ramps, it has recently been found [8] that GP possesses the following characteristic feature: If the ow rate to the on-ramp

 q_{bn} is high enough, the average ow rate in the pinch region $q^{(\text{pinch})}$ (averaged over a time interval which is considerably larger than the time-distance between narrow m oving jams emerging in the pinch region of GP) reaches the limit ow rate $q_{\text{lim}}^{(\text{pinch})}$. This means that the ow $q^{(\text{pinch})}$ does not decrease below $q_{\text{lim}}^{(\text{pinch})}$ even if the ow rate q_{on} further increases. This case is called the \strong" congestion [8]. In the strong congestion condition, GP can not exist if $q_{\text{in}} < q_{\text{lim}}^{(\text{pinch})}$ [45, 8]. Note that in the \weak" congestion condition which is realized at lower ow rates q_{on} the ow rate $q^{(\text{pinch})}$ changes noticeably when the ow rate q_{on} is changing.

As in the model [24], both the strong congestion and the weak one can be simulated in the KKW -m odels under consideration. In particular, GP can not exist if $q_{in} < q_{im}^{(p\,in\,ch)}$. Indeed, at high ow rates to the on-ramp q_{on} the boundary $S_J^{(B)}$ transforms into a horizontal line at $q_{in} = q_{lim}^{(p\,in\,ch)}$ (Fig. 6 and 11). For the KKW -1 m odel (param eter-set I of Table 3) we obtain $q_{out}=q_{lim}^{(p\,in\,ch)}$ 1:57. This value is also approximately in accordance with the empirical nding (see the empirical form ula (4) in [8]).

It should be noted that in the vicinity of this horizontal line on the boundary $S_J^{(B)}$, after the GP has been formed (precisely, when the related point in the ow - ow plane in Fig. 6 and 11 has been moved above and right of the boundary $S_J^{(B)}$), the strong congestion in the pinch region occurs, and the ow rate of the vehicles, which m ay actually squeeze to the road from the on-ram p, can decrease in comparison with the initial ow rate q_{on} . This e ect has also occurred in the model [24] at the related high initial ow rates q_{on} . Nevertheless, the GP remains the GP after this decrease in the real q_{on} which accompanies the occurrence and the disappearance of the GP when the ow rate q_{on} rate q_{on} which

of hysteresis e ects is out of the scope of this paper and it will be considered elsew here.

4.5. Probability of the breakdown phenomenon (the F! S transition) at the on-ram p

Let us rst recall, how the breakdown phenomenon looks like in the fundamental diagram approach. From a numerical analysis of a macroscopic trac c ow model within the fundamental diagram approach K emer and K onhauser found in 1994 [33] that free ow is metastable with respect to the formation of wide moving jams (F! J transition), if the ow rate is equal to or higher than the out ow from a jam, q_{out} . The critical amplitude of a local perturbation in an initially hom ogeneous free ow, which is needed for the F! J transition, decreases with increasing density: It is maxim alat the threshold density = min, below which free ow is stable. min is the characteristic density in the out ow from a wide moving jam, i.e. when $q = q_{out}$. The critical amplitude becomes zero at some critical density = $_{cr} > _{min}$, above which free ow is linearly unstable. O bviously the higher the amplitude of a random local perturbation the less frequent it is. Hence, the likelihood that the F! J transition occurs in a given time interval should increase with density (or ow rate). The probability should be very sm all at the threshold density $_{min}$ (at the threshold ow rate q_{out}), and it should tend to one at the critical density $_{cr}$ (at the related critical ow rate in free ow).

In 1997 M ahnke et al [52, 53] developed a m aster equation approach for calculating the probability of the F! J transition on a hom ogeneous road (i.e. w ithout bottleneck). B ased on this approach K uhne et al [54] con m ed that the probability of the F! J transition in the m etastable region is increasing with the ow rate in free ow. They

applied this result to explain the breakdown phenom enon at a highway bottleneck. For a recent comprehensive discussion of the breakdown phenom enon in CA-m odels and in the K rau et al. m odel in the fundam ental diagram approach see also [55, 56]. The theories in [33, 52, 53, 54, 55, 56] belong to the fundam ental diagram approach.

In contrast to these results, in K emer's three-phase trac theory [3, 42, 43] it is postulated that m etastable states of free ow decay into synchronized ow (F! S transition) rather than wide moving jams (F! J transition). Moving jams can emerge spontaneously only in synchronized ow, i.e. after a sequence of F! S! J transitions [6]. In particular, even the upper limit of free ow, q_{max} , is related to the F! S transition: In this limit point the probability of the F! S transition should be equal to one whereas the probability of the emergence of a moving jam (F! J transition) should be very sm all. Thus, in this theory the breakdown phenom enon in free trac is related to the F! S transition rather than to an emergence of moving jam s.

In the three-phase trac theory, it is also postulated that the breakdown phenom enon at a highway bottleneck (i.e., due to an on-ramp) is due to a localized determ inistic perturbation at the bottleneck [7]. Indeed, due to this perturbation the probability of the F! S transition should be considerably higher at the bottleneck than anyw here else. Thus, in this theory there is a spatially non-hom ogeneous distribution of the probability of the breakdown phenom enon (of the F! S transition) on a road (per unit of space and time): At e ective bottlenecks on the road the probability of the breakdown phenom axim a (see Fig. 1 (b) in [7]). This explains, why the breakdown phenom enon m ostly occurs at highway bottlenecks.

In the following we con m these hypotheses of three-phase trac theory for the KKW -m odels proposed in this paper. In particular we nd that a localized perm anent perturbation indeed occurs in the vicinity of the bottleneck (due to the on-ramp), and that it triggers the breakdown of initially free ow at the on-ramp rather than anywhere else.

As in [24], at the boundary $F_S^{(B)}$ the F! S transition occurs at the on-ram p. D ue to this transition the vehicle speed decreases sharply at the on-ram p. A sharp drop of vehicle speeds at the on-ram p (or at another bottleneck) is well-known from empirical observations (e.g., [57, 58]). Trac engineers have called this e ect "the breakdown phenom enon" in trac ow. The F! S transition has the nature of such a breakdown phenom enon.

In [24] it was also shown that the F! S transition is a rst order phase transition: It requires nucleation, i.e. the occurrence of a local perturbation in trac ow whose amplitude exceeds some critical value. This critical amplitude is a decreasing function of the vehicle density in free ow (see the curve F_S in Fig. 1 (b) in [24]). The higher the amplitude of a random perturbation (uctuation) the less likely it is, with a probability distribution that for very general reasons can be assumed to decay exponentially for large amplitudes. Therefore we expect that the probability that the F! S transition happens within a given time interval increases exponentially with the vehicle density in free ow.

Such behaviour of the probability of the breakdown phenom enon, i.e. the F ! S transition, has indeed been observed empirically by Persaud et al. [58]. In the case of the on-ram p, however, there is already a local perm anent non-hom ogeneity, which occurs due to the squeezing of vehicles into the main road. Corresponding to [7] this should explain why the F ! S transition occurs at the on-ram p with a considerable higher probability than away from the on-ram p at the same ow rate.

This local permanent (determ inistic) perturbation at on-ramp determ ines the character of the boundary $F_{S}^{(B)}$ [8]. The higher the ow rate to the on-ramp q_{on} is, the higher is the amplitude of this permanent perturbation. Therefore, the higher the ow rate to the on-ramp q_{on} is, the low erist ow rate q_{in} on the main road upstream of the on-ramp, at which the related critical amplitude occurs at the bottleneck: This may explain the negative slope of the curve $F_{S}^{(B)}$ in the ow-ow plane in Fig. 6(a).

However, a real local perturbation which leads to the F! S transition at the onram p has always also a random component, i.e., the real local perturbation should consist of two components: (a) a perm anent perturbation, the amplitude of which is the higher, the higher the ow rate to the on-ram p q_{on} is, and (b) a random component. The latter component should lead to the F! S transition at the on-ram p with som e probability also, if the ow rate upstream of the on-ram p, q_{in}, and the ow rate to the on-ram p, q_{on}, belong to points in the ow- ow plane in Fig. 6 (a) which lie to the left of the boundary $F_S^{(B)}$, i.e. still in the free ow region. This probability should increase, if the ow rate q_{sum} = q_{in} + q_{on} approaches the boundary $F_S^{(B)}$. If these assumptions are correct, then the probability of the F! S transition at the on-ram p m ust grow, if the ow rate upstream of the on-ram p q_{in} increases at a given constant ow rate to the on-ram p q_{on}, which can be related to the results of em pirical observations [58].

To study the probability of the F! S transition at the on-ram p (Fig. 18) in the KKW -1 m odel (parameter-set I of Table 3) a large number of runs of the same duration T_0 has been studied for given ow rates q_{sum} and q_{bn} . At the beginning of each run there was free ow at the on-ram p. For each run it was checked, whether the F! S transition at the on-ram p occurred within the given time interval T_0 or not. The result of these simulations is the number of realizations n_P where the F! S transition at the on-ram p had occurred in comparison with the number of all realizations N_P . Then

$$P_{FS} = n_P = N_P$$

is the probability that the F! S transition at the on-ram p in an initial free ow occurs during the time interval T_0 at given ow rates q_{sum} and q_{on} .

The ow rate q_{sum} was changed and the procedure with all realizations was repeated at the same ow rate to the on-ramp q_{on} . The ow rate q_{sum} at which the F! S transition at the on-ram p occurred in all realization is therefore related to the probability of the F! S transition P_{FS} = 1. We found that lower ow rates q_{sum} correspond to P_{FS} < 1. As expected above we found indeed an exponential increase of the probability P_{FS} as a function of the ow rate q_{sum} at a given ow rate to the on-ram p q_{on} . This con m s the above assumptions [7] about the nature of the breakdown phenom enon at the on-ram p.

Fig. 18 shows that the nucleation rate is the higher the larger q_{Dn} . This can be inferred from the fact that the range of ow rates downstream, q_{sum} , over which the nucleation probability changes by a given amount, is much narrower for higher q_{Dn} . The stronger permanent perturbation (higher q_{Dn}) acts like a bias which makes it easier to overcome the nucleation barrier.

The F! S transition leads to the occurrence of di erent synchronized ow patterns upstream of the on-ram p which have been considered above.

4.6. The capacity drop

Empirical observations show that the speed breakdown at a bottleneck is in general accompanied by a drop in highway capacity. If there is free rather than congested ow

upstream of the bottleneck, the highway capacity is usually higher. This phenom enon is called "the capacity drop" (for a review see [57]).

As explained in the previous section, the breakdown phenomenon in three-phase trac theory is a F! S transition at the bottleneck, so that the capacity drop is the di erence between highway capacity in free ow and in a situation, where there is synchronized ow upstream and free ow downstream of the bottleneck [42,7]. Thus the capacity drop is not determ ined by the out ow q_{out} from a wide moving jam in contrast to the fundam ental diagram approach.

O bviously, in order to study the capacity drop one has to consider the out ow from a congested bottleneck $q_{ut}^{(b ext{ottle})}$, which is measured downstream of the bottleneck, where free ow conditions are reached. In this paper we consider the special example of an on-ramp as bottleneck. In [7] K emer points out that $q_{out}^{(b ext{ottle})}$ is not just a characteristic property of the type of bottleneck under consideration only. It also depends on the type of congested pattern which actually is form ed upstream of the bottleneck. Hence, in the case of an on-ramp, $q_{ut}^{(b ext{ottle})}$ is expected to vary with $(q_{\text{on}};q_{\text{in}})$. O bviously, $q_{out}^{(b ext{ottle})}$ only lim its the highway capacity, if it is an aller than the tra c dem and upstream of the on-ramp, q_{ut}

is fulled. Then the congested pattern upstream from the on-ram p simply expands, while the thoughput remains limited by $q_{out}^{(bottle)}$. For example, if the general pattern (GP) is formed at the bottleneck, an increase of q_{in} does not in uence the discharge ow rate $q_{out}^{(bottle)}$. Instead, the width of the wide moving jam, which is most upstream in the general pattern, simply grows.

A ssum ing that (24) is ful led, the capacity drop is given by

$$q = q_{max} \quad q_{out}^{(bottle)}; \tag{25}$$

where $q_{n ax}$ denotes the highway capacity in free ow, i.e. the maximum ow rate in free ow. The minimum value, which $q_{out}^{(bottle)}$ can take, if one considers all kinds of congested patterns upstream from a bottleneck, should be a characteristic quantity for the type of bottleneck under consideration. We denote this quantity by $q_{n in}^{(bottle)}$. The maximum of $q_{out}^{(bottle)}$ (denoted by $q_{n ax}^{(bottle)}$) is predicted to be the maximum ow rate, which can be realized in synchronized ow [7], $q_{m ax}^{(bottle)} = q_{m ax}^{(syn)}$. Hence, the capacity drop at a bottleneck cannot be smaller than

$$q_{m in} = q_{m ax} \quad q_{m ax}^{(syn)} :$$
(26)

This general picture of the capacity drop proposed by K emer for the three-phase tra c theory has been con m ed by empirical investigations [7, 8] and in num erical studies of congested patterns at an on-ram p [24], as well as in this paper.

In particular, we found that for the KKW -1 m odel (param eter-set I of Table 3) $q_{nax}^{(syn)}$ 2250 vehicles-h. This ow rate corresponds to WSP at $q_{in} = q_{nax}$ and low ow rate to the on-ramp (q_{on} 10 vehicles-h). The ow rate $q_{nin}^{(bottle)}$ 1600 vehicles-h is related to LSP. Thus, the discharge ow rate $q_{out}^{(bottle)}$ in (25) can be changed in the range from 1600 to 2250 vehicles-h. As the capacity of the highway in free ow (for param eter-set I) is q_{nax} 2400 vehicles-h, the capacity drop (25) can vary in the range from 150 to 800 vehicles-h, depending on the type of congested pattern and the pattern param eters. In comparison with free ow conditions the capacity drops by

625% for W SP at low ow rate to the on-ram p up to 33.3% for LSP at a high ow rate to the on-ram p.

To show the dependence of the capacity drop on the congested pattern type and the pattern parameters more clearly, let us consider a speci c example: Initially the ow to the on-ramp, $q_{on} = 60$ vehicles=h, is low, and the ow rate upstream of the on-ramp, $q_{in} = 2160$ vehicles=h, is relatively high. As a result, W SP occurs (Fig. 6 (a)). In this case, the discharge ow rate $q_{out}^{(bottle)} = 1950$ vehicles=h, i.e., the capacity drop (25) is q = 210 vehicles=h. Let us now increase trac dem and upstream on the on-ramp, i.e., the ow rate q_{on} increases up to $q_{on} = 120$ vehicles=h but the ow rate $q_{in} = 2160$ vehicles=h remains the same. This causes the ow rate of synchronized ow in W SP to decrease more than the trac dem and ($q_{in} + q_{on}$) increases. For this reason, although the ow rate q_{on} increases, the discharge ow rate decreases: $q_{out}^{(bottle)} = 1800$ vehicles=h. This leads to a larger capacity drop (25): q = 360 vehicles=h.

If now the ow rate q_{on} is further increased up to $q_{on} = 240$ vehicles—h (the ow rate $q_{in} = 2160$ vehicles—h remaining unchanged), W SP transforms into GP (Fig. 6 (a)). This leads to a further decrease in the discharge ow rate: $q_{out}^{(bottle)} = 1700$ vehicles—h, which is due to the pinch e ect in synchronized ow of GP: The pinch e ect strongly reduces the ow rate through the pinch region of the GP: The capacity drop (25) increases to q = 460 vehicles—h.

If the ow rate q_{on} is once more increased up to $q_{on} = 900$ vehicles—h and the ow rate q_{in} remains the same, strong congestion occurs in the pinch region of the GP. This decreases the discharge ow rate to $q_{out}^{(bottle)} = 1630$ vehicles—h. Thus the capacity drop (25) increases to q = 530 vehicles—h. In all considered cases the condition (24) is fulled.

5. D iscussion

The numerical simulations of the CA-models within the three-phase tract theory, which we have developed in this paper, show that the basic vehicle motion rules (1), (3) introduced by K emer and K lenov in [24] for a microscopic three-phase tract theory allow a variety of simple speci cations for the synchronization distance, the uctuations and for the vehicle acceleration and deceleration which lead to qualitatively the same diagram of congested patterns and to the same pattern features at on-ram ps. This is due to the introduction of the synchronization distance D in the basic vehicle motion rules (1), (3), which leads to a 2D-region of steady states in the ow density plane. The robustness of the phenom ena with respect to di erent speci cations of the model details leads to the expectation that these phenom ena occur generically independent of e.g. the di erent laws and driver behaviours in di erent countries.

In the K K W -m odel form ulation of three-phase tra c theory based on these basic vehicle motion rules (1), (3) speci c functions for uctuations and for the vehicle acceleration and deceleration can be very simple. Nevertheless, the main features of the diagram s of congested patterns, which these CA-m odels show, are qualitatively the same as recently found within the three-phase tra c theory and in empirical observations [45, 8].

In [24] it has been shown that these pattern features and the related diagram of congested patterns at on-ramps in the three-phase tract theory are qualitatively di erent in comparison with the diagram by Helbing et al. [1, 10], which has been

derived for a wide class of tra c ow models within the fundamental diagram approach. In particular, in that diagram of congested patterns (congested states) near a boundary which separates trigger stop-and-go tra c (TSG) and oscillating congested tra c (OCT) (in the term inology of [1, 10]) a congested pattern which is a \m ixture" of TSG, OCT and HCT (hom ogeneous congested trac) should occur [1]. This pattern, which at st sight looks like GP, has been used in [1] for an explanation of the pinch e ect in synchronized ow and for the jam emergence observed in [6]. However, this m ixture pattern has no own region in the diagram of states in [10, 15, 1]: The pattern transforms into TSG, if q_{on} decreases, or into OCT or else HCT, if q_{on} increases. In our diagrams (Figs. 6 and 11 and in [24, 8]) there are no TSG, no OCT and no HCT. Instead, GP exists in a very large range of ow rates q_{on} and q_{in} . At a given q_{in} GP in the three-phase tra c theory does not transform into another congested pattern, even if $q_{\rm on}$ increases up to the highest possible values. Thus GP in the CA-models under consideration and in [24, 8] has a qualitatively di erent nature in com parison with the mixture of TSG, OCT and HCT in [1, 10]. Note that empirical observations of congested patterns at on-ram ps [8] con m the theoretical features of GP found within the three-phase trac theory [24, 8], rather than the theoretical features of either TSG, or OST, or HCT, or else of the mixture of TSG, OST, and HCT within the fundam ental diagram approach derived in [10, 15, 1].

In 2000, K nospe et al. [22] proposed a version of the NaSch model where in addition to the previous versions (e.g., [39]) drivers react at interm ediate distances to speed changes of the next vehicle downstream, i.e., to \brake lights". The steady states of this model with \com fortable driving" belong to a fundam ental diagram, i.e. the NaSch model with \com fortable driving" is a CA-model in the fundam ental diagram approach. The NaSch model with \com fortable driving fortable driving with a been applied in [22, 23, 47] for a description of three trac phases: free ow, synchronized ow and wide moving jam s.

In order to com pare this model with the ones investigated here, the congested patterns, which spontaneously occur at an on-ram p, and their evolution, when the ow rate to the on-ram p is changing were calculated for the N agel-Schreckenberg CA-m odel with \com fortable driving" [22, 23, 47]. These new results will be discussed below. It will be shown that both the diagram s of congested patterns and the pattern features of the KKW -m odels in three-phase-tra c theory are qualitatively di erent from those obtained for the N agel-Schreckenberg CA-m odel with \com fortable driving", with one exception, concerning the wide moving jam propagation, which will be discussed rst.

5.1. Wide moving jam propagation

The characteristic parameters of wide moving jam propagation which were found in empirical observations [59, 41, 4, 7] can be reproduced in many trac ow models in the fundamental diagram approach, where they have rst been predicted by Kerner and K onhauser in 1994 [33] (see also the later papers by B ando, Sugiyama et al. [60], by K rau et al. [46], by B arbovic et al. [39], and the reviews by C how dhury et al. [2] and by H elbing [1]). A salready mentioned, the slow-to-start rules [51, 39, 22] allow the wide moving jam propagation through di erent trac states and bottlenecks keeping the characteristic velocity of the downstream jam front. This e ect has recently been simulated in the N aSch model with \com fortable driving" [23]. This is in accordance with empirical observations and the wide moving jam de nition made above [41, 4, 7]. Because the slow-to-start rules [39, 22] are used in our CA-m odels as well, these CA-

m odels within the three-phase tractheory also show the elect of the wide moving jam propagation through dilerent congested patterns and bottlenecks (Fig. 19). In particular, if a wide moving jam which has been formed upstream of the on-ramp (the jam is marked as \foreign" wide moving jam in Fig. 19) then the jam propagates through the on-ramp and through GP (Fig. 19 (a)) and also through W SP (Fig. 19 (b)) keeping the velocity of the downstream front of the jam.

However, the e ect of the wide moving jam propagation [41] as well as the other characteristic parameters of wide moving jams are apparently the only features which are the same in the fundamental diagram approach [33, 46, 39, 23] and in the three-phase tract theory [4, 61]. All other known features of congested patterns which spontaneously occur upstream of the on-ramp and their evolution for the Nagel-Schreckenberg CA-model with \com fortable driving" [22, 23, 47] are qualitatively di erent from those, which follow from the KKW-models within the three-phase-tract theory, as will be shown in the next section. This is due to the principal di erence between the non-linear features of congested tract in the NaSch model with \com fortable driving" [22, 23] and in the three-phase tract theory presented in our paper.

5.2. C om parison with congested patterns in the Nagel-Schreckenberg cellular autom ata models with $\mod r$

In Figs. 20 - 24 we compare the congested patterns and their evolution obtained in the KKW -m odels of three phase trac theory with those for a Nagel-Schreckenberg type CA-m odel with \com fortable driving" with one lane, for which we use the rules and parameters presented in [2, 23, 47]. All calculations for the Nagel-Schreckenberg CA-m odel with com fortable driving are made for two dierent models of the on-ram p: (1) The lane changing rules described in [23, 47] are applied, or (2) the model of the on-ram p described in Sect. 4.1 is used. In the latter case the distance between two consecutive vehicles on the main road, which permits a vehicle to enter from the on-ram p, is chosen as $dx_{on}^{(m in)} = 4d$. This corresponds to the successor on the destination lane" is larger than or equal to the vehicle length d. It has been found that all features of the congested patterns and their evolution, when the ow rate to the on-ram p is increasing, rem ain qualitatively the same for both models of the on-ram p. Therefore, only one set of results for the model of the on-ram p described in Sect. 4.1 is shown in Figs. 20 - 24. This com parison show s the follow ing results.

(i) In the N agel-Schreckenberg CA -m odel with com fortable driving [23] without on-ram ps and other bottlenecks, i.e. on a hom ogeneous one-lane road, when the ow rate is gradually increasing, the free ow motion spontaneously transforms into a very complex dynam ical behaviour at some critical ow rate on the road, $q_{m ax}$: If a narrow moving jam em erges spontaneously, this jam dissolves within a very short time interval (about one-two time steps, i.e. 1-2 s), then a new narrow moving jam em erges which again dissolves quickly and so on at di erent locations and at di erent times. This behaviour resembles the oscillating congested trac which was reported for other trac ow models within the fundam ental diagram approach by Lee et al. [11], Tom er et al. [18] and in the diagram of congested patterns at on-ram ps by Helbing et al. [1, 10].

(ii) In the N agel-Schreckenberg C A -m odel with com fortable driving on a one-lane road with an on-ram p, a com plex oscillation pattern occurs upstream of the on-ram p

spontaneously for $q_{in} = q_{max}$, which is qualitatively the same as in (i): N arrow m oving jams rst emerge and then dissolve within a very short time interval at di erent highway locations and at di erent times. This pattern exists already for very small values of the ow rate to the on-ram p q_{on} (Fig. 20). We will call this pattern in the N agel-Schreckenberg CA-m odel with com fortable driving \oscillating m oving jams" (OM J) (Figs. 21 (d-f) and 22 (c, d)).

The OM J upstream of the on-ram p shows the same features as on a hom ogeneous road without on-ram p as mentioned above. The random emergence and dissolution of narrow moving jams on a short time scale, which is characteristic for OM J (Figs. 21 (gures right) and 22 (gures right)), is qualitatively di erent from the behaviour inside the widening synchronized ow pattern (W SP), which occurs spontaneously at the same parameters in the KKW -models within the three-phase trac theory (Figs. 21 (gures left) and 22 (gures left)).

Indeed, whereas inside W SP in the KKW \rightarrow m odels vehicles can move with nearly constant vehicle speed (Figs.21 (b) and 22 (b)), in the N agel-Schreckenberg CA \rightarrow m odel with comfortable driving inside OM J the vehicles must random ly slow down sharply sometimes up to a stop and then accelerate within a short time scale, and so on (Figs.21 (e) and 22 (d)). The inverse distance between vehicles shows the same high am plitude oscillating behaviour inside OM J in the N agel-Schreckenberg CA \rightarrow m odel with comfortable driving (Fig. 21 (f)). Its am plitude is much higher than would be expected due to bare model uctuations. This is the result of nonlinear am pli cation of uctuations in the N agel-Schreckenberg CA \rightarrow m odels the inverse distance between vehicles show s only sm all changes in W SP, the am plitude of which is comparable to the bare m odel uctuations. Thus, W SP in our CA \rightarrow m odels with OM J in the N agel-Schreckenberg CA \rightarrow m odel with comfortable driving.

(iii) If the ow rate q_{on} is further gradually increasing rst no transition to another congested trac pattern occurs in the Nagel-Schreckenberg CA-model with com fortable driving: OMJ persists in some range of the ow rate q_{on} (the region between the boundaries O and L which is marked \OMJ" in the diagram of congested patterns in Fig. 20).

(iv) However, above some ow rate q_{on} a widening region of very low m ean vehicle speed (about v = 10 km =h) and very low m ean ow rate (q_{LP} 480 vehicles/h) occurs spontaneously upstream of the on-ram p in the N agel-Schreckenberg CA-m odel with com fortable driving (Fig. 23 (d-f) and 24 (c, d)).

The downstream front of this congested pattern is pinned at the on-ram p and the upstream front is slow ly moving upstream. Therefore, this patterns may be called \the widening pinned layer" (W PL for short). Inside W PL as well as in OM J a very complex non-stationary behaviour of vehicles occurs. This random behaviour resembles the one in OM J, how ever with two di erences: (1) the maximal vehicle speed in W PL is much lower than in OM J, and (2) the vehicles come m much more frequently to a stop in W PL. Because of the extrem ely low mean vehicle speed and large uctuations in W PL, we cannot discern a regular pattern in W PL. States in which vehicles stop can emerge and dissolve stochastically but in a correlated way at di erent locations in W PL with tim e scale of about 5-10 m in. These correlations in W PL seem to propagate with a velocity faster than the propagation of the front between W PL and OM J.

(v) If the whole range of the ow rates $q_{\rm in}$ on the road upstream of the on-ram p

and the ow rate q_{on} to the on-ram p is studied, then the conclusion can be drawn that there are only two di erent congested patterns in the Nagel-Schreckenberg CA-m odel with com fortable driving at the on-ram p: The pinned layer (PL) which can be either widening (W PL) or localized (LPL) and OM J. In addition a combination of W PL and OM J is possible (the latter pattern is marked as \W PL & OM J" in Fig. 23 (d-f) and 24 (c)).

In particular, if the ow rate $q_{in} = q_{DMJ}$ (at $q_{in} = q_{DMJ}$ the boundaries O and L intersect one another), then to the right of the boundary L in the diagram of patterns for the Nagel-Schreckenberg CA-m odel with com fortable driving W PL occurs at the on-ram p, and upstream of this widening pinned layer OMJ is realized (in the region m arked as \W PL & OMJ" in Fig. 20). The case of such a spatial combination of W PL and OMJ is shown in Fig. 23 (d-f) and 24 (c)).

The same combination of WPL and OMJ occurs spontaneously from an initial state of free ow, if the ow rate q_{in} is within the range $q_W < q_{in} - q_{DMJ}$. This occurs, when the ow rate to the on-ramp q_{on} is increasing and becomes larger than the one which is related to the boundary O.

However if the ow rate q_{in} is within the range $q_{PL} < q_{in} \quad q_W$, then no OMJ occurs upstream of the W PL right of the boundary O (the region marked \W PL" in the diagram of congested patterns in Fig. 20). In the latter case free ow is realized upstream of the W PL.

If the ow rate $q_{in} < q_{PL}$, then right of the boundary O the pinned layer occurs whose upstream front does not move continuously upstream. Indeed, in this case the ow rate q_{in} upstream of the pinned layer is lower than the mean ow rate inside the pinned layer q_{PL} . This means that the localized pinned layer (LPL) rather than W PL occurs in the region marked \LPL" in the diagram in Fig. 20. The vehicle behaviour inside LPL is qualitatively the same as inside W PL. Note that O M J and W PL, and also LPL, which occur in the N agel-Schreckenberg CA-m odelw ith com fortable driving at the on-ramp, have not been observed in empirical observations [8].

These congested patterns in the N agel-Schreckenberg CA -m odelw ith com fortable driving are qualitatively di erent from the ones which occur spontaneously for the sam e conditions in the KKW -m odelsw ithin three-phase tractheory (Table 1). These di erences are sum m arized below:

(1) At the same given ow rate on the one-lane road upstream of the on-ramp, q_{in} , and at some ow rate q_{on} , where OM J is form ed in the N agel-Schreckenberg CA – m odel with com fortable driving, W SP occurs spontaneously upstream of the on-ramp in the K K W -m odels. It can be seen from Figs.21 (a-c) and 22 (a, b), where the spatial vehicle speed distribution in the W SP is shown that these pattern characteristics are di erent from OM J shown in Figs.21 (d-f) and 22 (c, d). In particular, whereas OM J in the N agel-Schreckenberg CA -m odel with com fortable driving is characterized by a com plex birth and decay of narrow m oving jam s, no m oving jam s were seen in W SP.

(2) If the ow rate q_{on} is further gradually increasing, W SP spontaneously transforms either into DGP or into GP in our CA-m odels within three-phase trac c theory. At high ow rate to the on-ram p q_{on} the GP does not transform into any other kind of congested pattern: the GP remains GP no matter how high the ow rate q_{on} upstream of the on-ram p is. In contrast, if the ow rate to the on-ram p q_{on} increases for a given value $q_{in} > q_{DMJ}$ in the N agel-Schreckenberg CA-m odel with comfortable driving, then to the right of the boundary L in Fig. 20 a widening pinned layer W PL develops upstream of the on-ram p.

(3) In the Nagel-Schreckenberg CA-model with comfortable driving upstream of

W PL the oscillating moving jams (OM J) occur spontaneously, if $q_{in} > q_{DMJ}$ (Figs. 20 and Fig. 23 (d)). In the KKW -m odels within three-phase trac theory, however, upstream of the most upstream wide moving jam in the GP a region of synchronized ow is realized, where no oscillations and no moving jams occur (Fig. 23 (a)).

(4) In the pinch region of the GP in our CA-m odels within three-phase tra c theory narrow m oving jams emerge. Some of these narrow m oving jams grow and transform into wide m oving jams spontaneously at the upstream front of the pinch region (Figs. 8 (a, b) and 7 (a)). These wide m oving jams propagate further upstream without any limitation. Thus, in the KKW -m odels wide m oving jams which possess the characteristic param eters m entioned above (Sect. 5.1) spontaneously occur in GP. In contrast, in the N agel-Schreckenberg CA-m odel with com fortable driving narrow m oving jams do not transform into wide m oving jams. Instead, OM J or W PL patterns are form ed. In other words, in contrast to our CA-m odels within three-phase tra c theory, in the N agel-Schreckenberg CA-m odel with com fortable driving no spontaneous emergence of wide m oving jam s which possess the characteristic param eters mentioned above (Sect. 5.1) occurs: In their m odel, such a wide m oving jam can only be excited by an additional external perturbation of a very large am plitude (which was done in [23] in order to create the wide m oving jam), i.e. by a perturbation which forces one of the vehicles to stop for several time steps.

(5) The fact that no wide moving jams can spontaneously occur in the Nagel-Schreckenberg CA -m odel with com fortable driving can be seen from a comparison of the left pictures for GP with the right pictures for WPL in Fig.23 and 24. In particular, there is a clear regular spatio-tem poral structure of wide moving jams which alternate with the regions where vehicles move sometimes with nearly the maxim alvehicle speed inside GP (left gures), whereas there is no such region inside WPL (right gures).

M oreover, wide m oving jam s which have spontaneously occurred in GP (Fig. 23 (a) and 24 (a)) propagate further without any limitation upstream. In contrast, in the N agel-Schreckenberg CA-m odel with com fortable driving regions inside W PL, where vehicles come to a stop, can emerge and dissolve random ly during several m inutes. These regions do not propagate through the upstream boundary of W PL.

5.3. Conclusions about features of the KKW -m odels in the three-phase tra c theory

Several CA -m odels belonging to three-phase tractheory were proposed in this paper. Their simulation gives results that allow to draw the following conclusions:

(i) The conditions (1), (3) from [24], where due to the introduction of the synchronization distance D a 2D-region of the steady states in the ow density plane appears, allow the formulation of several di erent sets of speci c functions for uctuations and for the vehicle acceleration and deceleration which lead to qualitatively the same diagram of congested patterns at on-ram ps.

(ii) In the KKW -m odel form ulation, speci c functions for uctuations and for the vehicle acceleration and deceleration in the basic m odel (1), (3) can be m uch simpler than in [24]. Nevertheless, the main features of the diagrams of congested patterns are qualitatively the same as within the three-phase tract theory in [8, 24].

(iii) The diagram s of congested patterns in the KKW -m odels within three-phase tra c theory have the following features which di er from the case considered in [24]. First, there is no region in the diagram s of patterns where the m oving synchronized ow pattern (MSP) occurs exclusively. However, MSP can spontaneously random ly emerge in the region \WSP", where the widening synchronized ow pattern (WSP)

occurs. Second, when the initial ow rate on the road upstream of the on-ram pq_{in} is higher than the mean ow rate in the wide moving jam out ow then the general pattern (GP) occurs at lower ow rates to the on-ram p in comparison with the case of the model in [24].

(iv) The congested patterns and the diagram of these patterns of the K K W – models explain empirical pattern features [8] and their evolution, when the ow rate to the on-ram p is changing.

(v) Both the diagrams of congested patterns and the pattern features of the KKW -m odels, which belong to three-phase trac theory, are qualitatively di erent from those derived by Helbing et al. for a wide class of trac ow models in the fundam ental diagram approach (for more details see [24]).

(vi) The features of congested patterns, which occur upstream of the on-ram p in the KKW -m odels di er from those in Nagel-Schreckenberg CA-m odels, which belong to the fundam ental diagram approach, including the one with comfortable driving (see Sect. 5.2). This is due to qualitatively di erent rules of vehicle motion of the basic model (1), (3) [24] in the three-phase tract theory in comparison with Nagel-Schreckenberg CA-models [1, 2, 22, 23, 36, 37, 38, 39, 40, 49, 47].








Figure 3. Trac patterns on a homogeneous one lane road with periodic boundary conditions for KKW -1-m odel (param eter-set I of Table 3). (a, b, c) Perturbation of free ow at moderate ow rate (q = 2160 vehicles=h < q_{max} 2400 vehicles=h) and (d, e, f) at high ow rate (q = 2842 vehicles=h > q_{max}). (a, d) - vehicle speed as function of time and distance (distance increases in downstream direction); (b, e) - vehicle speed and ow rate at the location x = 10 km as functions of time (one minute averaged data of virtual detectors); (c, f) - data in the ow-density plane which correspond to (b, e), respectively.






Figure 4. Synchronized ow behaviour on a hom ogeneous one lane road with periodic boundary conditions for KKW -1-m odel (param eter-set I of Table 3). (a) - vehicle speed as a function of time and distance; (b) - vehicle speed (left) and ow rate (right) at a xed location (x = 10 km) as functions of time (one m inute averages); (c) - data in the ow-density plane which correspond to (b). Initial free ow $q_{in} = 1800$ vehicles=h, initial speed $v_{in} = 54$ km =h ($v_{in} = 15$ m =s).






Figure 7. Congested patterns at the on-ram p belonging to Fig. 6 (a). (a) – G eneral pattern (GP) at $q_{in} > q_{out}$, (b) – GP at $q_{in} < q_{out}$, (c) – dissolving general pattern (DGP), (d, e) – widening synchronized ow patterns (WSP), and (f) – localized synchronized ow pattern (LSP). At $t_0 = 8$ m in ow from the on-ram p is switched on. Single vehicle data are averaged over a space interval of 40 m and a time interval of 1 m in. The ow rates (q_{on} ; q_{in}) are: (a) (500, 2300), (b) (740, 1740), (c) (105, 2400), (d) (90, 2300), (e) (90, 2160), and (f) (760, 1080) vehicles=h.




Figure 10. Speed breakdown due to the F! S-transition at the location x = 15.8 km (0.2 km upstream of the begin of the on-ramp). Fixed ow rate $q_{\rm in}$ = 2000 vehicles=h. Flow rate $q_{\rm on}$ is: (a) 120, (b) 90, (c) 55, and (d) 70 vehicles=h. Up-arrowsm ark the time t_0 + $T_{\rm FS}$, at which according to our criterion synchronized ow is detected: The vehicle speed drops below the level 80 km =h (dashed horizontal line) and remains low form ore than 4 m in.Sim ulations of the KKW -l-m odel (param eter-set I of Table 3).





Figure 11. Diagrams of congested patterns at the on-ramp for the KKW – m odels with non-linear dependence of the synchonization distance (5) on the vehicle speed (Fig. 2 (a)): (a) - KKW -2-m odel, (b) - KKW -3-m odel (Table 1 and Table 3). GP – general pattern, DGP – dissolving general pattern, WSP – widening synchronized ow pattern, MSP – m oving synchronized ow pattern, LSP – localized synchronized ow pattern. N ote that for the KKW -2-m odel (a) and the KKW -3-m odel (b) the value $V_{\rm FS}$ discussed in Sec. 42(i) is also chosen equal to 80 km =h. How ever for the KKW -3-m odel there is the exeption for the case, when q_{in} is close to the point of intersection of the curves L and F (Fig. 2 (a)). N earthis point them inim alspeed in WSP can be greater than 80 km =h, and the threshold speed $V_{\rm FS}$ is chosen as the average between $v_{\rm free}$ and this m inim alspeed.






Figure 13. The general pattern (GP) related to Fig.12 (a) (KKW -2-m odel): (a) -vehicle speed (left) and ow rate (right), (b) - corresponding data in the ow-density plane at the location x = 16 km. One m inute averaged data of virtual detectors, whose coordinates are indicated in (a, b). In (b) black points are related to the states of free ow with the speed v close to the m axim al one $v_{\rm free}$ (the points F) and circles are related to states of synchronized ow (the points S).








Figure 18. Probability of breakdown phenom enon at the on-ram p for the KKW -1-m odel (param eter-set I of Table 3): (a) - Tim e dependence of the vehicle speed, when the F! S transition occurs at the on-ramp (the arrow marks the F! S transition). D ata are one m inute averages of a virtual detector located at x = 15.8 km (200m upstream of the start of the on-ramp merging area). The dashed line shows the speed level 80 km =h; the characteristic duration of a sharp decrease in the vehicle speed (this "breakdown" is marked by the arrow) is about 1-2 m in in agreement with empirical observations. ($q_{on};q_{in}$) have the following values: (200, 1660) vehicles/h. (b, c) - The probability P_{FS} that the F! S transition occurs at the on-ram p within $T_0 = 30$ m in (curve 1) or already within $T_0 = 15 \text{ m in}$ (curve 2), after the on-ram p in ow was switched on (at $t_0 = 8 \text{ m in}$), versus the trac dem and upstream of the on-ram p, q $_{\text{sum}}$ = q $_{\text{in}}$ + q on . R esults are shown for two di erent ow rates to the on-ram p, $q_{on} = 60$ vehicles=h in (b) and q_{on} = 200 vehicles=h in (c). The following criterion that a F ! S transition has occurred is used: The vehicle speed just upstream of the on-ram p drops below the level 80 km = h and then remains at nearly the same low level for m ore than 4 m in (cf. (a)). The probabilities were obtained from N = 40 independent runs.




Figure 19. Simulation of the propagation of a "foreign" wide moving jam: (a) -Propagation through GP, (b) - Propagation through WSP. The on-ram p is located at x = 12 km , and the in ow is switched on at $t_0 = 7 \text{ min}$. The ow rates $(q_{on};q_{in})$ are: (a) (480, 2300) and (b) (110, 2160). The initial location of the "foreign" wide moving jam is $x=\,18~{\rm km}$, the initial jam length is 0:7 km . Single vehicle data are averaged over a space interval of 40 m and a time interval of 1 m in. KKW -1-m odel (Table 1): Param eter k of the synchronization distance D_n is k = 2.55 for (a) and k = 4 for (b). O ther m odel parameters are given in Table 3, param eter-set I.




Figure 20. Diagram of congested patterns at the on-ram p for the NaSch CAm odelwith com fortable driving. OM J-oscillating moving jam s, W PL -widening pinned layer, LPL - localized pinned layer. The param eters of the m odel are taken from [22,23], in particular, the maxim alspeed $v_{free} = 27 \text{ m} = \text{s} (v_{free} = 97.2 \text{ km} = \text{h})$, the minimal distance d = 7:5 m, the time step = 1 sec, the maximum ow rate $q_0 = 2817$ vehicles=h, the ow rate out from the jam $q_{out} = 1580$ vehicles=h. The other specic parameters of the CA-model with comfortable driving (notations as in [22, 23]) are $p_d = 0.1$, $p_b = 0.95$, $p_0 = 0.5$, h = 8, $gap_{security} = 3$, the cell length is 1:5 m . For the simulation of the on-ram p in the CA-m odel with com fortable driving the distance $dx_{on}^{(m \text{ in})}$ is chosen as $dx_{on}^{(m \text{ in})} = 4d$. The length of the road is 75 km , the on-ram p is at x = 65.4 km , the length of m erging area 0:6 km. As in Figs. 6 and 11, after the on-ramp has been switched on, there is a delay time for the congested pattern formation upstream of the on-ramp. However, here the boundaries O ("O scillating") and L ("Layer") depend more strongly on the delay time which is chosen for awaiting the congested pattern to occur upstream of the on-ramp, after the on-ramp has been switched on. The boundary O is determ ined as the points (q_on ; q_in), where either OM J or W PL or LPL occurred upstream of the on-ramp in an initial ow with maximum speed $v = v_{free} w$ ithin 20 m in after the on-ram p has been sw itched on. The time interval for the determ ination of the boundary L was 60 m in. The qualitative features of the diagram do not depend on these time intervals. The maximum ow rate in free ow $q_{max} = 1250$ vehicles=h.






Figure 21. Comparison of the widening synchronized ow pattern (W SP) in our CA-modelwithin the three-phase-trac theory (a-c) with the oscillating moving jam pattern (OMJ) at the on-ramp in the NaSch CA-model with comfortable driving (d-f). (a, d) - the vehicle speed as function of distance and time; at $t_0 = 8 \text{ m in the on-ram p in ow is switched on. (b, e) - the vehicle speed as$ function of distance at a given time. (c, f) - the inverse distance between vehicles as function of distance along the road. In (a-f) single vehicle data are used. For (ac), the KKW -1-m odel (Table 1) with the following parameters is used: k = 4:5, p = 0.04, $p_0 = 0.5$, $v_p = 14 \text{ m} = s p_{a1} = 0.5$ and $p_{a2} = 0.05$. The parameter of the merging condition (21) at the on-ram p is = 0.4. For (d-f) the CAmodel with comfortable driving given in [22, 23, 47] was used. In both models, $v_{free} = 27 \text{ m} = s, d = 7.5 \text{ m}$, = 1 sec, $q_0 = 2817 \text{ vehicles=h}$, $q_{out} = 1580 \text{ vehicles=h}$ (Table 2), the length of the road is 75 km , the on-ram p is at x = 65.4 km , the length of ${\tt m}$ erging area 0.6 km . The other speci c parameters of the CA-m odel with com fortable driving are the same as in Fig. 20. With these parameters one obtains the results in (a-c) for $(q_{in};q_{on}) = (1246;600)$ vehicles=h, in (d-f) for $(q_{in};q_{on}) = (1246;190) \text{ vehicles=h}.$




Figure 24. Comparison of the vehicle trajectories related to the patterns in Fig.23: GP in the KKW -1-m odel (Table 1) (gures left), congested pattern at the on-ram p in the NaSch CA-m odel with com fortable driving (gures right). M odel speci cations as in Fig.20 and Fig.21. (a) -vehicle trajectories (overview) of GP shown in Fig.23 (a). (b) -vehicle trajectories inside the region of wide m oving jam s in GP. (c) - vehicle trajectories (overview) of WPL and further upstream OMJ corresponding to Fig.23 (d). (d) - vehicle trajectories inside WPL.Only trajectories of every 7th vehicle are show n.
