## Longitudinal spin decoherence in spin di usion in sem iconductors

W e set up a set ofm any-body kinetic B boch equations with spacial inhom ogeneity. W e reexam ine the widely adopted quasi-independent electron m odel and show the inadequacy of this m odel in studying the spin transport. W e further point out a new decoherence e ect based on interference along the direction of di usion in spin transport due to the so called inhom ogeneous broadening e ect in the B boch equations. W e show that this inhom ogeneous broadening can cause decoherence alone, even in the absence of the scattering and that the resulting decoherence is m ore in portant than the dephasing e ect due to both the D 'yakonov-Perel' (DP) term and the scattering.

Study of spintronics has attracted trem endous attention in recent years, both in theoretical and experim ental circles,<sup>1</sup> thanks to the discovery of the long-lived (som etimes > 100 ns) coherent electron spin states in n-typed sem iconductors.<sup>2 {7</sup> Possible applications of spintronics include qubits for quantum computers, quantum memory devices, spin transistors, and spin valves etc. The last two applications involve transporting spin polarized electrons from a place to another by means of an electrical or di usive current. Therefore, it is of great in portance to study the spin transport. A part from the great num ber of works on spin injection, there are only a few experim ental reports on coherent spin transport over m acroscopic distance.<sup>3;8;9</sup> On theoretical aspect, most works are based on a quasi-independent electron model and focused on the di usive transport regim e,<sup>10 {15</sup> where equations for spin polarized currents can be set up and the longitudinal spin dephasing, generally referred to as spin di usion length can be achieved. In these theories, the mechanism for the spin relaxation is assumed to be due to the spin-ip scattering. In the absence of the scattering, the spin polarization will not decay in a nonm agnetic sam ple. In Ref. 16, Takahashiet al. calculated the scattering induced spin relaxation time associated with the spin diffusion starting from the many body kinetic equations.

Of particular interest to the spin transport theory in sem iconductors has been the question as to whether the quasi-independent electron m odel can adequately account for the experim ental results or whether m any-body processes are in portant. F latte et al. have concluded that an independent electron approach is quite capable of explaining m easurem ents of spin lifetim es in the di usive regim e.<sup>17</sup> In this paper, we reexam ine this issue from a full m any-body transport theory and show the inadequacy of the independent electron m odel in describing the spin transport. We also propose a mechanism that m ay cause strong longitudinal spin decoherence in addition to the spin dephasing due to scattering. The new mechanism is based on the interference e ect due to the wavevector dependence of the spin densities along the spacial gradients in the spin di usion. This wavevector dependence can be considered as some sort of \inhom ogeneous broadening", which can cause spin decay alone, even in the absence of scattering.

Recently, we have presented a many-body kinetic theory to describe the spin precession and dephasing in insulating samples as well as n-doped samples.<sup>18</sup><sup>20</sup> In this paper we extend this theory to the spacial inhom ogeneous regime and obtain the many-body transport equations necessary to investigate the spin di usion in n-doped G aAs. Here, we only focus on the spin transport inside the semiconductor and avoid the problem of spin injection at the boundary. Based on the two-spin-band m odel<sup>19</sup> in the conduction bands, we construct the sem iconductor B loch equations by using the nonequilibrium G reen function m ethod with gradient expansion as well as the generalized K adano -Baym Ansatz<sup>21</sup> as follows:

Here (R;k;t) represents a single particle density matrix. The diagonal elements describe the electron distribution functions (R;k;t) = f (R;k;t) of wave vector k and spin (= 1=2) at position R and timet. The o - diagonal elements (R;k;t) describe the inter-spin-band polarization components (coherences) for the spin

coherence. The quasi-particle energy "  $\circ$  (R;k;t), in the presence of a moderate magnetic eld B and with the DP mechanism<sup>22</sup> included, can be written as

Here " $_{\rm k} = {\rm k}^2 = 2{\rm m}$  is the energy spectrum with m denoting electron e ective mass, e is the electron charge and ~ are the Pauli matrices and h (k) originate from the DP mechanism which contains both the D resselhaus<sup>23</sup> and the Rashba term s.<sup>24</sup> In this paper, we only consider the rst one. Here E g denotes the band gap,

represents the spin-orbit splitting of the valence band, and m  $_{\rm CV}$  is a constant close in m agnitude to the free electron m ass m  $_0$ .<sup>26</sup> The electric potential (R;t) satisfies the Poisson equation

where  $n(R;t) = {P \atop k} f(R;k;t)$  is the electron density at position R and time t, and  $n_0(R)$  is the background positive electric charge density.  $\circ (R;k;t) =$

in which =  $2e^2m = {}_0^P$  f (K = 0) is the inverse screening length, with  $"_0$  being the static dielectric constant. The form factor  $J (iq_z)^2 = 2 \sin^2 y = [y^2 (y^2)]$  $^{2})^{2}]$ with  $y = q_z a = 2$ . It is noted that when one takes only the diagonal elements of Eq. (1) and neglects all , the st three terms on the left o -diagonalones hand side of the equation correspond to the drift term s in the classical Boltzm ann equation, modi ed with the DP terms and self energy from the Coulomb Hartree term.  $\frac{(R;k;t)}{(l_t)}$  j and  $\frac{(R;k;t)}{(l_t)}$  j in the B loch equations (1) are the coherent and scattering term s respectively, with the symbols j and j standing for \coherent" and \scattering". The components of the coherent term s can be written as<sup>21;20</sup>

W hile the scattering terms  $\frac{(e (R;k,r))}{(et)}$  are given in detail in Eqs. (5) and (7) of Ref. 20.

The Bloch equations (1) can be reduced to their counterpart in the independent electron approach as follows. The DP term forms an elective magnetic eld. It can

ip the spin-up electrons to the spin-down ones, and vice versa. The DP term combines with the scattering will result in a longitudinal spin dephasing.<sup>22;19;20</sup> By applying the relaxation time approximation to describe this dephasing and discarding the spin coherences (R;k;t)

as well as the DP term (to avoid double counting) and carrying out the sum mation over k, one obtains the the continuity equation for electrons of spin

in which  $n_0$  (R;t) = [n (R;t) + n P (R;t)]=2 is the total electron number at R.J (R;t) = \_k (e)v\_k f (R;k;t) is the electric current of spin . The spin dependent velocity is  $v_k = r_k$ " (R;k;t) where " (R;k;t) is given by Eq. (2) but without the DP term h (k). By applying the relaxation time approximation to describe the momentum scattering and keeping terms of the the lowest order (ie., neglecting terms containing ) and carrying out the sum mation over k, one obtains the expression for the current in the steady state:

Here and D represent the electron mobility and diffusion constant respectively. Equations (7) and (8) are the di usion equations in the independent electron approach.<sup>10;11;13 {15</sup>}</sup>

O ne can see from the derivation of above di usion equations that, by summing over k, the k dependence of the coe cients of  $r_R$  (R;k;t) in the B loch equation (1) is removed. This will not cause any problem when there is no spin precession. However, when the electron spin precesses along with the di usion, e.g. in the presence of a magnetic eld or of an electric one (i.e. the D P term), this kind of k dependence may cause additional decoherence.

To reveal this e ect, we apply the above kinetic equation to study the stationary state in the plane of an ndoped G aAs quantum well (QW), with its growth direction along the z-axis. The width of the QW is assumed to be sm all enough so that only the lowest subband is important. We assume one side of the sample (x = 0) is connected with an O hm ic contact which gives constant spin polarized injection. In this study, we assume the electric eld E = 0. The di usion is along the x direction. The electron distribution functions at the interface are assumed to be the Ferm i distributions

with T being the temperature and representing the electron chemical potential of spin . The spin coherence at the interface is assumed to be zero

It is understood that the boundary condition here is an approximation to describe the distributions just after the injection of the spin polarization from the 0 hm ic contact. There is no net charge injection into the QW and the well is kept charge neutral everywhere. A ctually, this boundary condition does not necessarily come from the injection at the interface. It can also be produced in the center of sem iconductors by a circularly polarized cw laser.

We rst consider a much simplied case by neglecting the DP terms h(k), the self energies as well as the scattering terms in the B loch equations (1). The simplied equations are therefore as follows

Here we take the magnetic eld B along the x-axis. f (x;k) = f (x;k) f (x;k). The solution for this simplied equations with the boundary conditions (9) and (10) can be written out directly




FIG.1. Electron densities of up spin and down spin (solid curves) and incoherently sum med spin coherence (dashed curve) versus the di usion length  $x \cdot B = 1 T \cdot N$  ote the scale of the spin coherence is on the right side of the gure.

Equations (13) and (14) clearly show the e ect of the k-dependence to the spin precession along the di usion direction. For each xed  $k_x$ , the spin precesses along the di usion direction with xed period without any decay. Nevertheless, for di erent  $k_x$  the period is di erent. The total di erence of the electron densities with di erent spin is the sum mation over all wavenum bers  $N = {}_k f(x;k)$ . It is noted that the phase at the contact x = 0 for di erent  $k_x$  is all the same. How-ever, the speed of the phase of spin precession is di erent

for dierent kx. Consequently, when x is large enough, spins with di erent phases may cancel each other. This can further be seen from Fig. 1 where the electron densities N =  $\int_{k} f(x;k)$  for up and down spin are plotted as functions of position x. The boundary electron densities at x = 0 are N<sub>1=2</sub> (0) = 2:05 10<sup>11</sup> cm<sup>2</sup> and  $N_{1=2}(0) = 1.95 \quad 10^{11} \text{ cm}^2$ . We take B = 1 T and T = 200 K . In order to show the transverse spin dephasing, we plot in the same gure the incoherently sum m ed  $_{k}$  j $_{\frac{1}{2}}$   $_{\frac{1}{2}}$  (x;k) j. It is understood spin coherence (t) = that both the true dissipation and the interference am ong the k states may contribute to the decay. The decay due to interference is caused by the di erent precessing rates of electrons with di erent wavevectors. For nite system, this leads to reversible loss of coherence among electrons.27;28 W e refer to this kind of loss of coherence as decoherence. W hereas for the true dissipation, the coherence of the electrons is lost irreversibly.<sup>29;27;28</sup> The irreversible loss of coherence is term ed dephasing in this paper. The incoherent sum mation is therefore used to isolate the irreversible decay from the decay caused by interference.<sup>19;29</sup> From the gure, one can see clearly the longitudinal decoherence caused by the interference effect. It is also noted from the gure that does not decay with the distance. This is consistent with the fact that there is no scattering in Eqs. (13) and (14) and the decay com es only from the interference e ect.

Facilitated with the above understanding, we turn to the spin di usion problem with the DP terms, selfenergies and scattering included. We take B = E = 0. By substituting the quasi-particle energy "  $\circ (R;k;t)$ [Eq. (2)] into the Bloch equations (1), the rst three terms in Eqs. (1) can be written as

It is therefore noted that the corresponding coe cients of  $Q_x \circ , Q_x \circ$  and  $Q_x \circ$  in the B loch eqautions are




FIG.2. Electron densities of up spin and down spin and the incoherently sum m ed spin coherence versus the di usion length x. Solid curves and dashed curve: N and from the full B loch equations; D ash-dotted curves and dotted curve: N and from the equations without the interference e ect. N ote the scale of the spin coherence is on the right side of the gure.

respectively. They are all k-dependent. Hence, sim ilar to the sim pli ed model, the interference e ect is also in portant in the full kinetic equation. The kinetic equations (1) and the Poisson equation (3), together with the boundary conditions (9) and (10) can be solved num erically in an iterative manner to achieve the stationary solution.<sup>30;31</sup> The num erical results for a typical QW with width a = 7.5 nm, boundary spin polarization N<sub>1=2</sub> (0) = 2.05  $10^{11}$  cm<sup>2</sup> and N<sub>1=2</sub> (0) = 1.95  $10^{11}$  cm<sup>2</sup> at temperature T = 200K are plotted in Fig. 2. In this computation, we only take into account the scattering due to longitude optical (LO) phonon. It can be seen from the gure that the surplus of the spin up electrons decreases rapidly along the di usion direction, sim ilar to the sim pli ed m odel shown above.

The fast decay above is understood mainly generated by the decoherence from the interference e ect due to the inhom ogeneous broadening. O ther dephasing e ects such as those caused by the DP term s in Eqs. (5) and (6)as well as the spin conserving LO phonon scattering also

contribute to the decay. Besides, we pointed out that the inhom ogeneous broadening e ect combined with spinconserving scattering can also cause spin dephasing.<sup>19</sup> Therefore, the above mentioned inhom ogeneous broadening may also cause spin dephasing in the presence of LO phonon scattering. To com pare the decoherence due to interference and the dephasing due to the DP term together with the scattering, we rem ove the interference e ect in the transport equations by replacing k in the coe cients [Eqs. (16)-(18)] with  $k = k_F$ . Here  $k_F$  represents the Ferm i wavevector. Therefore, if there is any decay of spin polarization along the di usion direction, it comes from the spin dephasing. The num erical result is plotted in Fig. 2. It is shown clearly that the decay of spin polarization due to the dephasing e ect alone (dashdotted curves) is much slower than that due to the decoherence (interference) e ect. In the gure we also plot the corresponding incoherently summed spin coherences

. One can see from the gure that both coherences decay slow ly and their decay rates are comparable when  $x > 1 \, \text{m}$ . This further justi es what m entioned above that the fast decay of the spin polarization is mainly due to the interference e ect.

In conclusion, we have set up m any-body kinetic B loch equations with spacial inhom ogeneity. We reexam ined the wildly adopted quasi-independent electron m odel and pointed out an important many-body spin decoherence e ect which is missing in the single electron model. The new decoherence e ect is based on an interference effect along the diusion direction in spin transport due to the so called inhom ogeneous broadening e ect. We have shown that this inhom ogeneous broadening e ect can alone cause spin decoherence, even without the scattering and that the resulting decoherence is more im portant than the dephasing e ect due to both the DP term and the scattering. Our study shows the inadequacy of the quasi-independent electron model. Therefore, it is in portant to use the fullm any-body theory to study the spin transport.
