Tem perature-dependent quasiparticle band structure of the ferrom agnetic sem iconductor EuS

W e present calculations for the tem perature-dependent electronic structure of the ferrom agnetic sem iconductor EuS.A combination of a many-body evaluation of a multiband K ondo-lattice model and a rst-principles T = 0{bandstructure calculation (tight-binding linear mun-tin orbital (TB-LMTO)) is used to get realistic information about tem perature- and correlation e ects in the EuS energy spectrum. The combined method strictly avoids double-counting of any relevant interaction. Results for EuS are presented in terms of spectral densities, quasiparticle band structures and quasiparticle densities of states, and that over the entire tem perature range.

I. IN TRODUCTION

Since the 1960s the europium chalcogenides EuX (X = 0, S, Se, Te) have attracted trem endous research activity, experim entally as well as theoretically $1^{,2,3}$ T hey are magnetic sem iconductors, which crystallize in the rocksalt structure with increasing lattice constants (5 to 7A) when going from the oxide to the telluride. The Eu²⁺ ions occupy lattice sites of an fcc structure so that each ion has twelve nearest and six next-nearest Eu-neighbors.

As to their purely magnetic properties the EuX are considered almost ideal realizations of the Heisenberg model for the so-called local-moment magnetism. Their magnetism is due to the half-lled 4f shell of the Eu²⁺. The 4f charge density distribution is nearly completely located within the lled $5s^2$ and $5p^6$ shells so that the overlap of 4f wavefunctions of adjacent Eu²⁺ ions is negligibly small. Hunds rules of atom ic physics can be applied yielding an $^8S_{7=2}$ ground state con guration of the 4f shell. The 7 $_{\rm B}$ moments are exchange coupled resulting in antiferrom agnetic (EuO, EuS), ferrin agnetic (EuSe), and ferrom agnetic (EuO, EuS) orderings at low tem peratures. The fact that them agnetic contribution to the therm odynam ics of the EuX is excellently described by the Heisenberg H am iltonian

allows to test models of the microscopic coupling mechanism by direct comparison to experimental data. There is convincing evidence that the exchange integrals can be restricted to nearest (J_1) and next nearest neighbors $(J_2)^{4,5}$. J_1 is positive (ferrom agnetic) decreasing from the oxide to the telluride. J_2 is negative, except for EuO, where the antiferrom agnetic coupling increases in magnitude from the sul de to the telluride. Liu and cow orkers^{6,7,8,9} have proposed an indirect exchange between the localized 4fm om ents mediated by virtual excitations of chalcogenide-valence band (p) electrons into the empty Eu²⁺ (5d) conduction bands together with a subsequent interband exchange interaction of the d electron (p hole) with the localized 4f electrons. U sing

this picture, very similar to the B been bergen-R ow land m echanism 10 , the calculated values for J_1 , J_2 agree nicely with experim ental data, both in sign as well as in m agnitude, for EuO, EuS, and EuSe. The results are found by a perturbative calculation of the indirect 4f-4f exchange interaction (1) with data from a linear combination of atom ic orbitals (LCAO) m ethod as band structure input. The di erent distances of the 4fm om ents do obviously create the di erent m agnetic behavior of the EuX. For the exchange integrals of the two ferrom agnets one nds: 4,5

A lthough in EuO the ferrom agnetic interaction is more pronounced (T_c (EuO) = 69:33K; T_c (EuS) = 16:57K)¹ a greater variety of experiments has been carried out with EuS than with EuO. The reason is that single crystals as well as Im s with well de ned thicknesses^{11,12} can better be prepared for EuS than for EuO. A part from this, the ferrom agnetism of EuS is interesting in itself for two reasons. There are competing exchange integrals J_1 and J_2 , and the magnitude of the dipolar energy is comparable to the exchange energy.

Besides the purely m agnetic properties a striking tem – perature dependence of the (empty) conduction bands has caused intensive investigation. This was rst detected for the ferrom agnetic EuX as red-shift of the opticalabsorption edge (4f-5d) upon cooling below T_c^{-13} . The reason is an interband exchange coupling of the excited 5d electron to the localized 4f electrons that induces the tem perature dependence of the localized m om ent system into the the empty conduction band states. A further striking e ect, which is due to the induced tem perature dependence of the Localized tem perature dependence of the states, is a m etal-insulator transition observed in Eu-rich EuO^{14,15}. The Eu richness manifests itself in twofold positively charged oxygen vacancies. O ne of the two Eu²⁺ excess electrons, which are no longer needed for the binding, is thought

to be tightly trapped by the vacancy. Because of the C oulomb repulsion, the other electron occupies an inpurity level fairly close to the lower band edge. W ith decreasing temperature below T_c the band edge crosses the in purity level thereby freeing in purity electrons. A conductivity jump asm uch as 14 orders of m agnitude was observed¹⁵. O ther remarkable e ects result from the interaction of the band electron with collective excitations of the m om ent system. O ne of these is the creation of a characteristic quasiparticle (m agnetic polaron) which can be identi ed as a propagating electron dressed by a virtual cloud of excited m agnons.

In previous papers we have proposed a method for the determ ination of the tem perature dependent electronic structure of bulk EuO^{16} as well as $EuO - \ln s^{17}$. The treatment is based on a combination of a multiband Kondo-lattice model (MB-KLM) with rst principles tight-binding linear mu n-tin orbital (TB-LMTO) band structure calculations. The many-body treatment of the (ferrom agnetic) KLM was combined with the rstprinciples part by strictly avoiding a double-counting of any relevant interaction. The most striking result concerned the prediction of a surface state for thin Eu0 (100) In s, the tem perature shift of which m ay cause a surface halfm etal-insulator transition¹⁸. For low enough tem peratures the shift of the surface state leads to an overlap with the occupied localized 4f states. Therefore, one can speculate that the resistivity of the EuO (100) Im sm ight be highly magnetic eld dependent, so that a colossal magnetoresistance e ect is to be expected.

In this paper we investigate in a similar manner the other ferrom agnet EuS, where we restrict ourselves rst to the bulk material. We want to derive the temperature dependent quasiparticle band structure (Q-BS), in particular concentrating on those e ects, which are due to a mutual in uence of localized magnetic 4f states and itinerant, weakly correlated conduction band states. There was earlier work on the Q-BS of bulk $EuS^{19,20}$. In these papers, however, an approach was employed that decomposes the Eu-5d band into ve consecutive non-degenerate subbands. For each of the subbands a single-band KLM was evaluated therewith disregarding the full multiband-structure of the EuS conduction band. Obviously this procedure leads to an overestimation of certain correlation e ects as a consequence of certainly too narrow subbands. We therefore use in this paper a multiband 4f-5d K ondo-lattice model to get reliably the tem perature dependent Q-BS of EuS with all correlation e ects in a symmetry-conserving manner. Ourm ethod com bines a many-body analysis of the mentioned multiband-model with a self-consistent LMTO band structure calculation.

Since the technical details can be taken from 16 we present in the following only the general procedure together with those aspects which are vital for the understanding of the new EuS results. In Section 2 we form ulate the multiband H am iltonian and x its single-particle part by a realistic band structure calculation. Furtherm ore, we describe the parameter choice for the decisive interband exchange coupling. Section 3.1 is devoted to the local-m on ent ferrom agnetism of EuS, while Section 3.2 repeats shortly how we solved the multiband K ondolattice m odel. In Section 4 the electronic EuS structure is discussed in term s of quasiparticle band structures and densities of states $(Q \rightarrow O S)$ as well as spectral densities, which are closely related to the angle and spin resolved (inverse) photoem ission experiment.

II. MULTIBAND KONDO-LATTICE MODEL

The complete model H am iltonian for a real substance with multiple conduction bands consists of three parts:

The rst term contains the 5d conduction band structure of the considered material as, e.g., EuS:

The indices m and m' refer to the respective 5d subbands, i and j to lattice sites. c_{im}^y and c_{im} are, respectively, the creation and annihilation operator for an electron with spin (= ";#) from subband m at lattice site R_i. T_{ij}^{mm} are the hopping integrals, which are to be obtained from an LDA calculation in order to incorporate in a realistic manner the in uences of all those interactions which are not directly accounted for by our m odel H am iltonian.

Each site R_i is occupied by a localized m agnetic moment, represented by a spin operator S_i. It stems from the half-lled 4f shell of the Eu²⁺ ion, according to H und's rule being a pure spin moment of 7 _B. The exchange coupled localized moments are described by an extended H eisenberg H am iltonian

In the case of EuS the exchange integrals J_{ij} can be restricted to nearest and next nearest neighbors (3). The non-negligible dipolar energy in EuS is expressed by a single-ion anisotropy D₀.

The characterizing feature of the norm al single-band K LM, also called s-f or s-d m odel, is an intraatom ic exchange between conduction electrons and localized spins. The form of the respective multiband-H am iltonian can be derived from the general on-site C oulom b interaction between electrons of di erent subbands. It was shown $in^{16,17}$ that in the special case of EuX (half-lled 4f shell, empty conduction band) the interband exchange can be

written as:

J is the corresponding coupling constant, and furthermore:

The st term in (7) represents an Ising type interaction while the two others refer to spin exchange processes. The latter are responsible for some of the most typical KLM properties.




FIG. 1: Spin dependent (solid lines up-spin, broken lines down-spin) bandstructure of bulk EuS calculated within a TB-LM TO scheme with the 4f levels treated as core states. The energy zero coincides with the Ferm ienergy.




FIG.2: Spin-dependent density of 5d-states of EuS as function of energy (calculated within a TB-LM TO scheme). The numbers are (in eV) for the lower band edges and for the centers of gravity. The Ferm i edge is below the 5d band (see Fig.1).

In order to incorporate in a certain sense all those interactions, which are not directly covered by the model Ham iltonian, we take the hopping integrals from a band structure calculation according to the TB-LM TO -atom ic sphere program of Andersen^{21,22}. In this method, the original Ham iltonian is transformed to a tight { binding Ham iltonian containing nearest neighbor correlations, only. The transform ation is obtained by linearly com bining the original muntin orbitals to the short ranged tight{binding mu n-tin orbitals. The evaluation is restricted to 5d bands, only. LDA -typical di culties arise with the strongly localized character of the 4f levels. To circum vent the problem we considered the 4felectrons as core electrons, since our main interest is focused on the reaction of the conduction bands on the magnetic state of the localized m om ents. For our purpose the 4f levels appear only as localized spins in the sense of H $_{4f}$ in Eq.(6). Figure 1 shows the calculated spin-dependent band structure of EuS, where, of course, the 4f levels are m issing. C learly, the conduction-band region is dom inated by Eu-5d states. For our subsequent model calculations it is therefore reasonable to restrict the single-particle input from the band structure calculations to the Eu-5d part, only. The low-energy part in Figure 1 belongs to the S-3p states. For comparison we have also performed an LDA+U calculation which is able to reproduce the right positions of the respective bands. However this method su ers from the introduction of adjustable parameters U and J being, therefore, no longer a \ rst principles" theory. The results of the LDA + U calculation do not di er strongly from those of the \norm al" LDA, with the 4f electrons treated as core electrons. So we have chosen the much simpler LDA calculation. Since we are mainly interested in overall correlation and tem perature e ects, the extrem e details of the bandstructure are surely not so important. In Figure 2, from the same calculation, the LDA-density of states is displayed. A distinct exchange splitting is visible which can be used to x the interband exchange coupling constant J in Eq.(7). Assuming that an LDA treatment of ferrom agnetism is quite compatible with the Stoner (mean eld) picture, as stated by several authors^{23,24}, the T = 0 splitting should amount to $E = JS \cdot Unfortunately, the results in Figure 2 do not$

fully con m this simple assumption but rather point to an energy-dependent exchange splitting. The indicated shifts of the lower edge and of the center of gravity lead to di erent J values:

In the following we will use both values for the a bit oversimplied ansatz H $_{\rm df}$ in Eq.(7) to compare the slightly dierent consequences.

It is a well-known fact (see Figure 1 in²⁵ and further references there) that the KLM can exactly be solved for the ferrom agnetically saturated (T = 0) sem iconductor. It is found that the "spectrum is rigidly shifted towards lower energies by the amount of $\frac{1}{2}$ JS, while the # spectrum is remarkably deformed by correlation e ects due to spin exchange processes between extended 5d and b-calized 4f states. We cannot switch o the interband exchange interaction H_{df} in the LDA code, but we can exploit from the exact T = 0 result that it leads in the "spectrum only to an unimportant rigid shift. So we take from the LDA calculation, which holds by de ni-

tion for T = 0, the " part as the single-particle input for H_{5d} in Eq.(5). Therew ith it is guaranteed that all the other interactions, which do not explicitly enter the K LM operator (4), are in plicitly taken into account by the LDA-renorm alized single-particle H am iltonian (5). On the other hand, a double counting of any decisive interaction is de nitely avoided.

III. M ODEL EVALUATION

A. Magnetic Part

Because of the empty conduction bands the magnetic ordering of the localized 4fm om ents will not directly be in uenced by the band states. For the purely magnetic properties of EuS it is therefore su cient to study exclusively the extended H eisenberg-H am iltonian (6). W hile the exchange integrals J_{ij} are known from spin wave analysis (see Eq.(3)), the single-ion anisotropy constant D $_0$ m ust be considered an adjustable parameter. V ia the magnon-G reen function

we can calculate all desired f spin correlation functions by evaluating the respective equation of motion:

Evaluation of this equation of motion requires the decoupling of higher G reen functions, originating from the Heisenberg exchange term and the anisotropy part in Eq.(6). For G reen functions com ing out of the Heisenberg term we have used the so-called Tyablikow approximation, which is known to yield reasonable results in all temperature regions. For G reen functions, which arise from the anisotropy term, we use a decoupling technique proposed by Lines²⁶. Details of the method have been presented in a previous paper²⁷ on EuO. As result one gets the following well-known expression for the temperature dependent local-moment magnetization:

where E (k) is the pole of the wave vector dependent Fourier transform of P_{ij} (E). Som e typicalm agnetization curves are plotted in F igure 3. They di er by the value of the anisotropy constant D $_0$, which is still an undetermined parameter. When $D_0=k_B$ increases from 0.01K to 0.4K $T_{\rm C}$ rises from about 15K to 16.9K. Regarding that J_1, J_2 are derived from a low-temperature spin-wave t, the agreement between the calculated $T_{\rm C}s$ and the experimental value of 16.57K 1 is remarkably good for alm ost all applied values of D $_0$, and best for 0.375K. Since we are interested above all in the electronic bulk band struc-




FIG .3: 4fm agnetization as a function oftem perature for various values of the single(ion anisotropy D $_0$. The vertical broken line m arks the used experim ental value ($T_c = 16.57 \text{eV}$).

ture and its tem perature dependence, the actual num erical value of D $_0$ does not play the decisive role. How ever, when treating system s of low erdim ensionality (Im s, surfaces), which is planned for a forthcom ing paper, then a nite D $_0$ will be the precondition for getting a collective m agnetic order of the spin system 28,29 .

Together with (12) and (13) practically all local spin correlations are derivable, as e.g.:

These and similar terms are responsible for the temperature dependence of the electronic selfenergy.

B. Electronic Part

The inspection of the electronic part starts from the retarded G reen function hc_{im} ; c_{jm}^{y} ii_E or its wave-vector dependent Fourier transform :

Here 1 represents the (M $\,$ M) identity m atrix, where M is the number of relevant subbands. The elements $T_k^{m\,m^{\,0}}$ of the hopping m atrix are the Fourier transforms of the hopping integrals in Eq.(5), while the elements of the selfenergy m atrix are introduced by

On the right-hand side of these equations appear further higher G reen functions which prevent a direct solution and require an approximative treatment. That shall be dierent for the non-diagonal terms ($i \in k$) and the diagonal terms (i = k), because the strong intraatomic correlations due to the on-site interaction (7) have to be handled with special care. For $i \in k$ a self-consistent selfenergy approach is applied, which has been tested in num erous previous papers^{16,17,25,27,30,31}. It simply consists in treating the commutators in (22) and (23), respectively, in form all analogy to the de nition equation (18) for the selfenergy:

For the diagonal term s (i = k) a moment technique is used that takes the local correlations better into account. For this purpose we explicitly evaluate the commutators in Eqs.(22), (23) obtaining then, as usual, further higher Green functions. In the rst step these new functions are reduced to a minimum number by exploiting that all functions, arising from the Ising-equation (22), can rigorously be expressed by linear com binations of those which com e out of the spin ip-equation (23). For a decoupling, the latter are then written as linear combinations of sim pler functions that are already involved in the hierarchy of Green functions. The choice, which kind of simpler functions enter the respective ansatz, is guided by exactly solvable limiting cases (ferrom agnetic saturation, zero-bandwidth lim it, $S = \frac{1}{2}$). We illustrate the procedure by a typical example:

This relation is valid for all tem peratures. On the other hand, in ferrom agnetic saturation ($hS^{z}i = S$) the same function reads for all spin values:

Eqs. (27) and (28) clearly suggest the following ansatz for the general case:

In order to x the coe cients mm° and mm° , we now calculate the rst two spectral moments of each of the three G reen functions in (29), and that exactly and independently from the respective G reen function. The diagonal parts of all other functions, appearing on the right-hand sides of (22) and (23), can be elaborated analogously.

By these manipulations we arrive at a closed system of equations for the selfenergy matrix elements $\lim_{ij} (E)$, which can numerically be solved. V ia the spectral moments, used for the various ansatze such as (29), a set of local spin correlations as those in Eqs.(12,14,15,16) enter the procedure. They are mainly responsible for the tem perature-dependence of the electronic selfenergy.




FIG. 4: The same as in Fig. 2, but in addition the T = 0 results of our combined many-body / rst principles theory. The latter has been performed for two di erent values of the exchange coupling J (dotted line J = 0.11eV; broken line J = 0.23eV). The up-spin curves have been shifted both to coincide at the low eredge with the LSD A curve. That dem onstrates that at T = 0 correlation e ects appear in the down { spectrum only.

To get a rst impression of correlation e ects in the electronic structure of EuS we have evaluated our complex theory for T = 0K. The Q-DOS results are exhibited in Figure 4. As explained and tentatively justied before Eq.(9) we use two dimensional tent to before the explained of the explained before Eq.(9). The "Q-DOS is una ected by the

actual value of J and coincides with the respective LDA curve, when we compensate, as done in Figure 4, the unimportant rigid shift ($\frac{1}{2}$ JS). So our approach fulls the exact (T = 0; = ")-lim it. The slight deviations, seen in the upper part of Figure 4, are exclusively due to the numerical rounding procedure. A posteriori this fact demonstrates once more that our above-described m ethod for implementing the LDA input into the many-body m odel calculation de nitely circum vents the offen discussed double counting problem. A sexplained in Section 2 we succeeded in this respect because for the special

case of a ferrom agnetically saturated sem iconductor the "spectrum is free of correlation e ects which stem from the interband exchange H $_{\rm df}$.

The lower half of F igure 4 dem onstrates that correlation e ects do appear, even at T = 0K, in the # spectrum. Besides a band narrow ing, they provoke strong deform ations and shifts with respect to the LDA result. Here the in uence of the di erent J values from Eq.(9) is quite rem arkable. For getting quantitative details of the EuSenergy spectrum a proper choice of the exchange constant is obviously necessary. The lower value (J = 0.11eV) is appropriate when we are mainly interested in the lower band-edge region. However, in the middle of the band, around the center of gravity, J = 0.23eV is surely the better choice.

IV. EUSENERGY SPECTRUM




FIG. 5: Quasiparticle densities of states of the Eu{5d bands of bulk EuS as a function of energy for various tem peratures. Solid lines for up{spin, broken lines for down{spin, thick line for $T = T_c$ (hS^z i= 0). The outerm ost curves belong to T = 0 (hS^z i=S = 1). They approach each other when increasing the tem perature. The inset shows on an enlarged scale the tem – perature shift of the lower up{spin edge. Exchange coupling: J = 0 (11eV.




FIG.6: The same as in Fig.5 but for J = 0.23 eV.

The main focus of our study is the temperature dependence of the 5d-energy spectrum of the ferrom agnetic sem iconductor EuS. The 5d bands are empty, except for the single test electron, so that the T-dependencem ust be exclusively caused by the exchange coupling of the band states to the localized m agnetic 4f states. Figure 5 and Figure 6 display the quasiparticle densities of states for ve di erent 4fm agnetizations, i.e. ve di erent tem peratures (Figure 3). The Q-DOS in Figure 5 are calculated for J = 0.11 eV. One sees that the lower edge of the " Q-DOS performs a shift to lower energies upon cooling from $T = T_C$ down to T = 0K. This explains the famous red shift of the optical absorption edge for an electronic 4f $5d_{t_{2\alpha}}$ transition, rst observed by Busch and Wachter^{32,33}. We nd a shift of about 0:17eV (see inset in Figure 5), very close to the experim ental data^{1,13}. This con $m \ s \ on \ con$ m s once m ore that J = 0.11 eV is a realistic choice for the exchange coupling constant as long as the lower part of the 5d spectrum is under consideration. Note, that our thing procedure for the exchange constant J (Fig. 2, Eq. (9)) does not predeterm ine the redshift.

Since we have taken into account for our calculation the full band structure of the Eu-5d conduction bands, the sym m etry of the di erent Eu-5d orbitals is preserved. The 5d bands of bulk EuS are therefore split into t_{2g} and e_g subbands (F igure 5), where the t_{2g} bands are substantially broader (7eV) than the e_g bands (4eV). In a previous study of the tem perature dependent EuS-band structure¹⁹ the Eu-5d complex was split into ve s-like bands by num bering for a given k vector the states from m = 1 to m = 5 according to increasing single-electron energies $_{m}$ (k). All k states with an energy $_{m}$ (k) then form the subband m . This sim pli ed procedure does not respect sym m etries and neglects subband hybridization, i.e. interband hopping $T_{ij}^{mm^{\circ}}$ form \in m⁰. The subband widths W turn out to be of order 1 3eV being therefore distinctly narrower than those in Figure 5. That has an important consequence. Since correlation e ects scale with the e ective (!) exchange coupling $\frac{J}{W}$, they become

for the sam e J m ore pronounced in narrow erbands. That is why we believe that correlations are to a certain degree overestim ated in¹⁹. As a consequence of the weaker e ective coupling the appearance of polaron-like quasiparticle branches is less likely in the present investigation.

In Figure 6 the Q-DOS is plotted for the stronger exchange coupling J = 0.23eV, which should be more realistic for the middle part of the spectrum, around the center of gravity. The tem perature-in uence on the spectrum is more pronounced than for the weaker coupling in Figure 5. Strong deform ations and shifts appear, being not at all rigid, i.e. far beyond the mean eld picture. However, not surprising, the lower edge shift between T = $T_{\rm C}$ and T = 0K comes out too strong. The calculated red shift of 0.27eV substantially exceeds the experimental value of 0.167eV 1 . A sm entioned above, the lower part of the spectrum is better described with J = 0.11eV.




FIG. 7: Spin{dependent quasiparticle bandstructure of the Eu{5d bands of bulk EuS for di erent 4f m agnetizations hS^{z} i=S. Exchange coupling: J = 0.11eV.




FIG.8: The same as in Fig.7, but for J = 0.23 eV.

W hile the Q-DOS refers to the spin resolved, but angle averaged (inverse) photoem ission experiment, the k dependent spectral density is the angle resolved counterpart. From S_k (E) we derive the quasiparticle band structure (Q-BS). Figures 7 and 8 represent as density

plots the spectral density for som e sym m etry directions.

The degree of blackening is a measure of the magnitude of the spectral function. Figure 7 holds for J = 0.11eV and Figure 8 for J = 0.23 eV. In both situations the "spectrum in case of ferrom agnetic saturation coincides with the dispersions obtained from the LDA calculation. In the weak coupling case (Figure 7) the tem perature in uence is mainly a shift of the total spectrum. The induced exchange splitting reduces with increasing T and disappears at $T = T_C$. Correlation e ects are more clearly visible in the case of J = 0.23 eV (Figure 8). They manifest them selves above all in lifetim e e ects. G reat parts of the dispersions are washed out because of m agnon absorption (emission) of the itinerant "(#) electron with simultaneous spin ip. In ferrom agnetic saturation a " electron has no chance to absorb a m agnon because there does not exist any m agnon. Therefore the dispersion appears sharp representing quasiparticles with in nite lifetime. On the other hand, the # electron has even at T = 0K the possibility to em it a magnon becoming then a "electron. Therefore correlation e ects are already at T = OK present in the # spectrum. For nite tem peratures, nite dem agnetizations, m agnons are available and absorption processes provoke quasiparticle dam ping in the "spectrum, too. The overall exchange splitting reduces with increasing temperatures, until in the lim it

T ! $T_{\rm c}$ (hS z i ! 0) the vanishing 4fm agnetization removes the induced spin asym m etry in the 5d subbands.




FIG.9: Spin{dependent spectral density S_k of the Eu{5d states of bulk EuS as function of energy for the same 4fm agnetizations as in Fig.8. Solid lines: up{spin; broken lines: down{spin; thick lines: $T = T_c$ (hS^zi = 0)). Exchange coupling: J = 0.23eV; k = .




FIG.10: The same as in Fig. 9 but k = L.




FIG.11: The same as in Fig.9 but k = W.

For a better insight into the tem perature-behavior we have plotted in Figs. $9{12}$ for four k{points from the




FIG.12: The same as in Fig. 9 but k = X.

Brillouin zone (, L, W, X) the energy dependence of the spectral density, and that for the same three tem peratures as in Fig. 8. For the {point we expect two structures according to the twofold (e_{α}) and threefold (t_{2g}) degenerate dispersions. As can be seen in Fig. 9 well de ned quasi particle peaks appear with additional spin split below T_C. The exchange splitting, introduced via the interband coupling to the magnetically active 4f system, collapses for T! T_C (Stoner{ like behavior). O bviously, quasiparticle damping increases with increasing tem perature. Sim ilar statem ents hold for the spectral density at the L {point. In accordance with the quasiparticle bandstructure in Fig. 8 three structures appear, the upper two being twofold degenerate (Fig. 10). Interesting features can be observed at the W {point (Fig. 11). At T = 0 four sharp peaks show up in the "{spectrum, and, though already strongly dam ped, the sam e peak { sequence com es out in the #{spectrum. The exchange splitting amounts to about 0:8{0:9eV.W ith increasing tem perature damping leads to a strong overlap of the two upper peaks, which are no longer distinguishable.

At the X {point the spin resolved spectral density exhibits four clearly separated structures, where the upper belongs to a twofold degenerate dispersion (Fig. 12). In the two middle structures, at least the #{peaks are so strongly dam ped that they certainly will not be observable in an inverse photoem ission experiment. A ltogether, the 5d{spectral densities of the ferrom agnetic sem iconductor EuS exhibit drastic tem perature{dependencies, what concerns the positions and the widths of the quasiparticle peaks.

V. CONCLUSIONS

We presented a method of calculating the temperature dependent bandstructure for the ferrom agnetic sem iconductor EuS. The essential point is the combination of a many body evaluation of a proper theoretical model with a $\$ rst principles" band structure calculation. The model of choice is the ferrom agnetic K ondo{ lattice model, which describes the exchange interaction between localized magnetic moments and itinerant conduction electrons. For a realistic treatment of EuS we have extended the conventionalK LM to a multiband version to account for orbital symmetry. Intraband{ and interband{hopping integrals have been extracted from a tight{binding linear mu n{thin orbital band structure calculation to incorporate besides the normal single{ particle energies the in uence of all those interactions which are not directly covered by the K LM {H am iltonian. By exploiting an exactly solvable limiting case of the K LM this combination of rst{principles and model{ calculations could be done under strict avoidance of a double{counting of any relevant interaction.

The many (body part of the procedure was perform ed within a moment (conserving interpolation method that reproduces exactly important rigorous limiting cases of the model. The resulting electronic selfenergy carries a distinct temperature (dependence, which is mainly due to local 4f spin correlations. Since the band is empty, the KLM reduces to a simple Heisenberg model as long as the purely magnetic 4f properties, as e.g. the mentioned 4f spin correlations, are concerned. The result is a closed system of equations which can be solved numerically for all quantities we are interested in.

W e have dem onstrated the tem perature { dependence of the energy spectrum of the ferrom agnetic sem iconductor EuS in terms of the 5d spectral density and 5d quasiparticle density of states. Peak positions and peak widths determ ine energies and life { tim es of quasiparticles, which have been gathered in special quasiparticle band structures. A striking tem perature { dependence of the empty 5d{bands is observed which is induced by the magnetic 4f{state. A well{known experimental con m ation of the T {dependence is the \red shift" of the optical absorption edge, uniquely related to the shift of the low er 5d (edge for decreasing tem perature from T = $T_{\rm C}$ down to T = 0K . The induced exchange splitting at T = 0 collapses for $T ~!~ T_{C}$ Stoner{like, but with distinct changes in the quasiparticle dam ping (lifetim e). All these tem perature{ dependent band e ects should be observable by use of inverse photoem ission.

W e expect further insight into interesting physics by a forthcom ing extension of our method to nite band occupations (Gd, Gd{ lm s}). The respective single{band model version has already been presented in previous papers^{30,34}. In particular a modi ed RKKY has been used³⁵ for a selfconsistent inclusion of the magnetic properties of the not directly coupled local moments. A further im plem entation of disorder in the local moment system will allow to treat diluted magnetic sem iconductors such as Ga₁ $_x$ M n_xAs and therefore contribute to the hot topic spintronics.
