B istable molecular conductors with a eld-switchable dipole group

A class of bistable \stator-rotor" m olecules is proposed, where a stationary bridge (stator) connects the two electrodes and facilitates electron transport between them. The rotor part, which has a large dipole moment, is attached to an atom of the stator via a single sigm a bond. Hydrogen bonds form ed between the rotor and stator make the sym metric orientation of the dipole unstable. The rotor has two potential minim a with equal energy for rotation about the sigm a bond. The dipole orientation, which determines the conduction state of the molecule, can be switched by an external electric eld that changes the relative energy of the two potential minim a. Both orientation of the rotor correspond to asym metric current-voltage characteristics that are the reverse of each other, so they are distinguishable electrically. Such bistable stator-rotor molecules could potentially be used as parts of molecular electronic devices.

I. IN TRODUCTION

The success or failure of molecular electronics (moletronics) [1,2] will largely depend on the development of e cient molecular electric switches. Switches are critical to the ability to store digital information and route signals in moletronic logic circuits. Single-molecule switches (SM S), in which the switching originates in the physical properties of individual molecules rather than molecular com plexes or lm s, are especially valuable. SM S will allow the ultimate miniaturization of moletronic devices, where one memory or con guration bit is represented by only one molecule.

For m em ory applications, the SM S has to be bistable. In principle, the bistability may be realized as two di erent electronic states of the molecule. Then the inform ation can be read out by direct sensing of the charge on the molecule or by measuring its electrical conductance. A strong dependence of conductance on the molecular charge state was reported by several groups [3(5]. How – ever, two electronic states are unlikely to have the same energy and the energy barrier between the states will be low . In a pure electronic mechanism , the higher energy state can only be stabilized by a third electrode, a solid state gate or electrolyte, that a ects the interior of the molecule and actually performs the switching between the two states. W hile three-term inal switches could potentially be used for signal gain and routing, memory applications will be limited. Given the smallphysical dim ensions of m olecules, the provision of a third electrode to every m em ory bit will be di cult to achieve.

Recently, it was suggested that a bit be stored in the form of current owing through a molecule [6]. Under special circum stances (attractive correlations between electrons on the molecule, and a high degeneracy of the molecular orbital), molecules could be electronically bistable. This is characterized by two very di erent currents passing through the molecule at the same applied voltage depending on the bias history. The highercurrent state is stable only at an external bias voltage exceeding some threshold. Thus this mechanism could be the basis only for volatile molecular memory, even if such specialm olecules are found.

A Itematively, bistability may be realized as two different conform ational states of the same molecule. In this case, the two states di er by the spatial positions of one or several atom s. The electric conductance of the two states can be di erent because: (i) the change in shape causes the current-carrying m olecular orbitals rehybridize, thus changing their energy and electron transm ission; or (ii) the redistribution of electrostatic charge signi cantly alters the current-carrying orbitals through direct Coulomb interactions. An additional constraint is switchability in a two-term inal geometry, which im plies som e degree of ionicity of m obile groups. At least one class of SM S that satis es all these requirem ents has been reported [7{9]. These are interlocked supermolecular com plexes, catenanes, rotaxanes, and pseudorotaxanes, in which the mutual orientation of two structural subunits of the complex have at least two local energy m in in a. The electrical switching observed in solid-state devices is speculated to be caused by the movem ent of a positively charged (+ 4) tetra-pyridinium ring [the full chem icalnam e is \cyclobis (paraquat-p-phenylene")]back and forth along the molecular backbone. The movem ent happens when one of the \stations" on the backbone is oxidized or reduced under bias and pushes the ring away or attracts it back. Signi cant current hysteresis has been observed in som e cases, although direct experim ental evidence for the ring m ovem ent inside the devices is still lacking. This example of ionic molecular switching is not the only possible mechanism. Its main drawback is

the slow switching speed, which is about 10 3 s, due to the large m ass of the m oving ring. One way to improve the performance of SM S is to design conformationally bistable m olecules with smaller m oving parts.

II.A NOVEL DESIGN FOR A SINGLE-MOLECULE SW ITCH

In this paper, we propose a new class of bistable conducting molecules that could be the basis for singlemolecule switches, memory bits and othermoletronic devices. The bistability is provided by the formation of one or more hydrogen bonds between the moving and stationary parts of the molecule. The two states are distinguishable by their current-voltage characteristics. The molecules can be ipped between the two states with an external electric eld, so that only two electrodes are required to operate the device.

The principal scheme of our SMS is shown in Fig. 1 (top). The molecule consists of two major subunits, the stator and the rotor. The stator bridges the two metalor sem iconductor electrodes and facilitates electron transfer between them . Thus it has to be a fairly conductive molecular structure, which implies the stator is entirely or piecew ise conjugated. The rotor is a side group that carries a signi cant dipole moment. Examples of such dipole rotors are the aldehyde (-COH) and am ide $(-CONH_2)$ groups. The rotor is attached to one atom of the stator via a single covalent sigm a bond, m aking stator-rotor rotation relatively easy. The key feature of the present design is that for som e stator-rotorm olecules, the symmetric position of the rotor (that is, when it is roughly perpendicular to the main axis of the stator) is unstable. This happens if the polar atom s of the rotor tend to form hydrogen bonds with the hydrogen atom s of the stator, which causes the rotor to tilt out of the symmetric position in either of the two possible directions. As a result, the total energy of the molecule as a function of the stator-rotor angle has s double-well shape. In this paper we consider the case of stators that are sym m etric with respect to the attachm ent point of the rotor. In this case, the two equilibrium conform ations must be the mirror images of each other. A coordingly, the two potential m in in a have the sam e energy. An example of a symmetric-statormolecule is shown in Fig. 1 (middle and bottom). The selection of one of the two equivalent potentialm in in a by the rotor part can be viewed as an exam ple of discrete sym m etry breaking.

To complete the general description, let us mention the other two important properties of our SM S. Firstly, the dipole moment of the rotor interacts with an external electric eld oriented along the stator axis. A eld of precisely this direction is generated by a potential di erence between the two electrodes. Thus, a strong enough external eld (external bias voltage) will change the energy

balance between the two states, the population of those states becomes inequivalent and some dipolar groups will ip from one state to the other, performing an act of switching. This process is expected to be them allyassisted. Secondly, since both equilibrium states are asymmetric with respect to the electrodes, the currentvoltage characteristics of both states will be asymmetric (although they will be the reverse of each other for a symmetric stator, as here). Therefore, the two states can in principle be distinguished electrically, by applying a sm all test voltage (much sm aller than the switching bias) across the electrodes and measuring the current in one particular direction (e.g. left to right in Fig. 1). These two m a properties of SM S are discussed in more detail below.

III.QUANTUM CHEM ISTRY CALCULATIONS

We have performed extensive quantum chemistry calculations of several stator-rotor m olecules [10]. Since the results are largely similar, we present them for 9hydro-10-acridinecarboxam ide-2,7-dithiol (1) depicted in Fig. 1. The stator comprises three fused rings that can be thought of as a derivative of the fully conjugated anthracenem olecule with onem iddle carbon saturated and another replaced with a nitrogen. The end thiol groups -SH serve the purpose of attaching the molecule to gold or platinum electrodes, a standard design feature in moletronic studies. The rotor is the am ide group $-CONH_2$, which has a dipole moment of d = 4.0 D ebye 0.8 e A. The symmetric orientation of the rotor (perpendicular to the plane of the stator) is unstable because of the formation of two hydrogen bonds with the oxygen and nitrogen of the am ide.

The relative energy of 1 as a function of the statorrotor angle , is shown in Fig. 2. It has the shape of a double well with the height of the energy barrier $4 E = 0.18 \quad 0.02 \text{ eV}$. The data was obtained from com - plete relaxation of the molecule with the positions of the end sulfur atom s xed. (The latter are supposed to bind strongly to the electrodes and therefore cannot m ove.) O ther useful quantities provided by the quantum chem - istry calculations are intra-molecular vibrational modes and frequencies. O fm ost interest to us is the stator-rotor rotation mode around the N-C bond. We identi ed its

frequency to be $! = 97 \text{ cm}^{1} = 1.8 \text{ 1b}^{3} \text{ rad/s. This in-form ation allow sus to estim ate the stability of the switch against therm al uctuations. The retention time can be found from K ram ers form ula:$

Using the above values, one nds = 58 ps at room tem perature (T = 300 K), = 33 m s at T = 77 K, = 1 hour at T = 54 K, and = 30 years at T = 40 K. W ith respect to the small retention times at room temperature, we should note that the energy barrier can be system atically increased by enhancing the hydrogen bonds and/or increasing their num ber. For instance, replacing the -CH segments of the stator with -C-OH brings the hydrogens of the stator closer to the rotor and increases their ionicity. As a result, the barrier increases to 0:6 eV. Such m olecules, how ever, are m ore di cult to synthesize. We believe it is more appropriate to focus initially on the sim plest m em bers of the stator-rotor fam ily. At the sam e time, we point out that ways to increase the energy barrier and retention times do exist in the fram ework of the present design.

A nother in portant parameter that can be estimated from the quantum chemistry data is the switching voltage. Taking into account the interaction energy of the dipole moment d with an external electric eld F, the full -dependent energy of the molecule becomes

where the second term represents the function plotted in Fig. 2. At zero tem perature, switching occurs when the eld changes the energy balance of the two states such that the barrier reduces to zero and the system rolls down to the only energy minimum available. This is illustrated in the inset of Fig. 2. Equating the derivative of Eq.(2) to zero and evaluating 0.4 = 0 as nite di erences, one nds that the barrier vanishes at eld F = 0.5 V / A, and the higher-energy state of the rotor becom es m echanically unstable. The nom inal length of the molecule (sulfur-to-sulfur) is 10.3 A. Adjusting for two sulfur-electrode bond lengths, the distance between the two electrodes is about 14 A. This results in a switching voltage of 7 volts. At non-zero tem peratures, switching occurs at a sm aller voltage, namely when the barrier is reduced such that the dipole is quickly ipped by them al uctuations. One should mention that these estimates do not take into account interaction of the molecule with otherm olecules or with the electrodes. W e believe, how ever, that they represent the correct m agnitude of the switching voltage.

IV . TRANSPORT CALCULATIONS

The bistability alone is not su cient to produce a molecular switch. The two states have to be distinguish-

able by their current-voltage (I-V) characteristics. We have perform ed self-consistent quantum -m echanical calculations of current through molecular Im s of 1 sandwiched between two sem in nite gold electrodes. Starting with the equilibrium molecular structure from the quantum -chem ical calculations, the end hydrogen atom s were removed and each replaced with a triangle of gold atom s. Together with the sulfur, the gold atom s form ed a triangular pyram id with sulfur at the pinnacle. The main axis of the molecule was near perpendicular to the bases of the pyram ids and the distance between the bases and the sulfur atom s was 1.9 A [11]. Then the (gold triangle)-m olecule-(gold triangle) com plexes were organized in a two-dimensional monolayer commensurate with the Au (111) surface and placed between two sem i-in nite gold electrodes. There was one moleculegold com plex per four surface atom s.

The current through the monolayer of 1 was calculated from the Buttiker-Landauer form ula [12]

where E_F is the Ferm i energy of one of the electrodes, and T (E) is the transmission probability for an electron with energy E to get through the molecules from one electrodes to the other. A tight-binding parameterization of the molecules [13] and the electrodes [14] as well as the details of calculation of T (E) with transport G reen's function form alism have been described elsewhere [15[18].

The calculated I-V characteristics of the stator-rotor SM S are shown in Fig. 3. The two curves correspond to the two stable states 11 and 10 of the molecule 1. The curves are not exact reverses of each other because 10 was not prepared as a geom etrical mirror in age of state 11. Instead, the geometries of the two states were optim ized independently. Then the molecules were oriented approxim ately perpendicular to the surfaces of the electrodes. As a result, the two geom etries slightly di ered, which produced di erent noise in the I-V characteristics that can be seen in Fig. 3. W e em phasize in this regard that in any real situation the molecules would not be all locked in the same ideal conform ational state but rather be distributed over a variety of conformations. Thus it is important to investigate the sensitivity of the I-V characteristic to changes in the junction geometry. We have shown earlier that the current through chem isorbed m olecules strongly depends on their orientation with respect to the electrodes [16,17]. We shall discuss below that, given the roughness of the electrode and disorder in the lm, there will be a spread of the I-V characteristics of individual molecules, and the corresponding deterioration in the perform ance of the molecular device.

The most important feature of the I-V characteristic of Fig.3 is the hysteresis loop at voltages between 3.2 and

4.2 Volts. Since the currents in the two curves di er by about a factor of two, this data demonstrates that the two states could be clearly distinguishable as long as the current ratio remains stable and is not washed out by uctuations of various kinds.

We now discuss the physical origins of the observed hysteresis. In both states, the asym metry of the I-V characteristic must originate from the asymmetry of molecular orbitals (MO), which in turn is caused by the electric eld of a dipole. To illustrate this point, we com pare in Fig. 4 the highest occupied molecular orbital (HOMO) and the low est unoccupied m olecular orbital (LUM O) of 11 [Fig. 4(b)] with the HOMO and LUMO of the stator alone (no dipole group) in its fully relaxed geometry Fig. 4 (a)]. It is instructive to view the electronic structure of a full molecule as a hybridization of those of the two benzene rings, see the right half of Fig. 4. In case (a), the molecule is symmetric, the two rings are identical, and the resulting HOMO and LUMO are equally distributed over the two halves of the molecule. Such an electronic structure will produce a symmetric currentvoltage characteristic if the two electrodes and moleculeelectrode contacts are made the same (which we always assume in this paper). In case (b), however, the electric eld of the tilted rotor shifts the electronic structures of the benzene rings with respect to each other. In 11, the electron rich (i.e. negatively charged) oxygen atom of the rotor is closer to the left benzene ring, while the positively charged -NH2 group is closer to the right benzene

ring. As a result, the electronic levels of the left ring end up being higher than the right ones by as much as 0.4 eV. A fter hybridization, the LUM O of the entire molecule is prim arily located on the right ring while the HOM O is on the left ring. C learly, such an electrical structure should produce an asymmetric I-V characteristics. The degree of asymmetry depends on the energy, conductivity, and spatial structure of the current-carrying molecular orbitals that are closest to the Ferm i level of the electrodes.

The mechanism responsible for the asymmetry of the I-V characteristic can be understood with the help of Figs.5 and 6. Figure 5 shows the energy-dependent transmission coe cient T (E) for 11.0 fm ost interest for us are the peaks marked A, B, and C. Peak A corresponds to the HOMO. It is the closest molecular orbital to the Ferm i level (1.5 eV below) but is less conductive than B or C. B and C are almost equidistant from E_F by

1:75 eV. It is critically in portant that the closest conducting level (HOM O in our case) is spatially asym metric. This is the major source of the I-V asymmetry, as illustrated in Fig.6. When an orbital is shifted from the center of the molecule toward one of the electrodes, the total voltage drop will be distributed unevenly between the two contacts. As a result, the condition for resonant tunneling will be met at di erent external biases for the two opposite polarities, com pare (b) and (c) in Fig.6. This sim ple argument applies equally well to the HOM O, LUM O, or any other conducting M O. If more than one M O are involved, the partial asymmetries may cancel.

Thus the main contribution comes from the closest conducting MO.For our SMS, the hysteresis region caused by the HOMO is indicated by an arrow in Fig.3. It turns out that this region is not the dom inant one in the calculated I-V characteristic. This is because of the relatively low conductance of the HOMO, compare A with B and C in Fig.5.

Two design rules of how to enhance the hysteresis regions of the I-V characteristic follow from the above analysis. The height of the hysteresis loop (that is the current di erence in states 1" and 0" at the same voltage bias) depends on the conductivity of the MO closest to the Ferm i level. Indeed, the current di erence appears because in 11 the carriers tunnel through the molecule resonantly, via a molecular level, while in 10 the carriers must go under the barrier in non-resonant mode. A strongly transmitting MO then produces a larger current di erence. The width of the hysteresis loop depends prim arily on the spatial asym m etry of the conducting M O, as explained above. In turn, the latter depends on the conjugation level of the stator, the length of the insulating bridge of the stator, and the size and orientation of the dipole moment of the rotor. Basically, the same factors determ ine the bistability of the molecule, which may be a ected if the molecule is changed in some way to increase the localization of the orbital. One general way to enhance the asymmetry of the MO is to use an asymmetric stator. W ithin the present design, when one wants to preserve the bistable potential pro le for the dipole group and yet break the symmetry of the backbone, one may e.g. replace one or two carbon atoms in one of the side rings by nitrogen atom s. These issues will be addressed elsew here.

Lastly, we discuss the variation of the I-V characteristic with changing molecular conformation and with changing geom etry of the molecule-electrode contact. In addition to the disorder in the lm, an important source of uctuating geometry of the molecule is temperature. At nite tem perature, the rotor uctuates about its equilibrium position which produces a uctuating eld on the stator and moves the conducting orbitals up and down in energy. We have estimated that at room temperature the rotation amplitude of the rotor of 1 is about 15 . Figure 7 com pares 11 with a rotor in its ground state and when it is swayed away by 15 . One can see that the difference in I-V characteristics is negligible. One must add that the inelastic tunneling through the molecules is also strongly tem perature dependent and m ay be observed. This mechanism is beyond the scope of the present paper.

The prime source of the uctuations of the contact geom etry is the nonuniform ity of the electrode surfaces and

m olecular lm s. W e investigated this e ect by tilting the m ain axis of the m olecule by 15 from the normal to the surface. Such a tilt a ects the overlap of m olecular orbitals with the wave functions of the electrode [16]. As a result, the conductance as well as the position of the resonance shift which m ight cause the closure of the hysteresis loop. The calculated I-V characteristics of 1 are shown in Fig. 7. One can see that the changes relative to the norm alposition are quite signi cant. W e conclude that the nonuniform ity of the m etal-m olecule contact geometry is a serious issue that m ight in pede the observation of the hysteresis and sw itching, unless the m olecule with a wide hysteresis loop is chosen.

V.EXPERIM ENTAL TESTS

The proposed design of the stator-rotor single molecule switch is based on three majore ects that should work together within the same molecular-electrode device. These are (i) the bistability of the molecules, (ii) the distinguishability of the two states by their I-V characteristics, and (iii) the ability to switch the molecules between the states with an external eld. It is very possible that within a particular junction, only one or two but not all three e ects will work at once. Identi cation of any one of them would still be important because it would show paths to SM S with better characteristics. We now brie y discuss the experimental modes that can be used to approach the problem .

(i) Bistability. This is the most de nite theoretical prediction for the stator-rotor molecules. Of course, not every such molecule is bistable. For instance, the rotor may be so large that the steric hindrance prevents it from rotating and leaves the symmetric orientation as the only stable one. However, for those molecules that are predicted to be bistable, the results are uniform across a number of modeling methods ranging from molecular m echanics to density functional calculations. Thus while the quantitative numbers (the barrier height, etc) m ight carry som e uncertainty, the very fact of bistability is robust. The question is whether the bistability is detectable by sim pler than m oletronic m eans, such as optical m ethods. Consider our SM S 1 from Fig.1. In the gas phase, the two states would be the exact m irror in ages of each other and their infrared (IR) spectra would be indistinguishable. Now, suppose the molecules self-assemble on a gold surface such that they bind with one thiol group only. The presence of the surface will break the symmetry and make the two states inequivalent. As a consequence, som e of the IR peaks will split. M oreover, the two states will be split in energy by 10-100 K (the scale of dipole-dipole interaction on separation 1-2 nm). Thus the partial intensities of the IR doublets are expected to have a strong tem perature dependence.

(ii) D istinguishability. It is possible that a molecule is bistable, the energy barrier is low, yet the electric eld is too weak to switch it. This may be because of the long length of the molecule, low breakdown threshold, e ective screening, and so on. In this case, it will still be possible to detect the current di erences between states 0 and 1, where the switching of molecules between the states will be therm ally activated. A signature of such behavior would be telegraph noise observed at a xed bias voltage between $V_{\rm F}\,$ and $V_{\rm R}$. The frequency of the telegraph noise would be strongly (exponentially) dependent on tem perature and the eld. (In interpreting the data, one will have to take into account other possible sources of telegraph noise, like the di usive motion of m etalatom snear the m olecules at the m olecule-electrode contact.)

The described approach would be di cult to realize on m olecular lm s because there will be signi cant fractions ofm olecules in states 0" and 1" at any given tim e and the net average would not uctuate much. Instead, m easurem ents should be performed on single molecules. It would also elim inate the disorder-induced washing out of the hysteresis regions discussed in the previous section. A number of experimental techniques allowing singlemolecule electrical measurem ents have been developed in recent years [3{5,19{23}}.

(iii) Switchability. It m ay happen that the molecule is bistable and switchable by an external electric eld, but

does not possess a large hysteresis bop because of the weak in uence of the dipole on the current-carrying orbitals of the stator. Then, in principle, the switching can be detected by other means such as optical. One possibility is to shine light through one of the electrodes that is IR transparent or made thin enough to let some light through. In this case, the electrodes should probably be made of di erent materials to make the two states of the switch inequivalent.

O by iously, the best dem onstration would be the direct observation of a I-V hysteresis, preferably in the singlem olecule m easurem ent.

VI.SUMMARY

In this paper, we have proposed a class of bistable stator-rotor molecules that could be used for singlemolecule switches and possibly for other moletronic applications. The basic idea is to incorporate into the molecule a rotor with a large dipole moment that perform s three roles simultaneously. Firstly, the rotor is capable of form ing hydrogen bonds with the stator, which makes the entire molecule bistable. These two stable conform ational states of the rotor can, in principle, represent the digital \zero" and \one". Secondly, the rotor m akes the two states distinguishable electrically. In either state, the rotor is positioned asym metrically with respect to the stator, see the bottom of Fig.1. The electric eld of the dipole then lifts the mirror symmetry of the electronic structure of the stator. As a result, the response of the stator to an external bias becom es asymmetric. Thus, the state of the switch can be read out by interrogating it at a sm all test voltage that is always the same in polarity and magnitude. The two states are distinguished by the current passing through the junction. Thirdly, the rotor provides the m eans to switch the m olecule between the states. The dipole mom ent of the rotor interacts with a large external electric switching eld, which changes the relative energies of the two states and enables the molecules to transfer into the lowest one. Provided that the switching voltage (that is, the writing voltage) is higher than the reading voltage, the entire read-write cycle can be done with only two external term inals.

The rotor performing three simultaneous functions results in an economical design of the molecular switch. The candidatem olecules are likely to be as smallas three fused benzene rings and relatively simple to synthesize. In fact, several stator-rotor molecules, similar to 1 but without the thiol clips, are commercially available [24]. W hat is needed are the experimental methods that would allow them to be placed between electrodes and test their conform ational and electrical properties.

Building in and optim izing three functions within one molecule is a challenging task. However, the proposed

switching mechanism applies to a whole class of statorrotor molecules, rather than to one particular molecular species. There are several ways to manipulate the m echanical and electronic properties of the molecule by changing the chem ical composition of the stator and rotor. For instance, increasing the dipole moment of the rotor decreases the switching voltage. Enhancing the insulating bridge in the middle of the stator increases the asymmetry of the I-V characteristics, and using an asymmetric stator-recti er widens up the hysteresis loop in IV curve, etc. W e have also identi ed several experim ental tests that could be used to screen out and isolate only one or two functions (see the previous section). One proposal is to compare infrared spectra of stator-rotor molecule in the gas phase and self-assembled on a surface. If the molecule is bistable, then some IR peaks should split when the molecules are on the surface and their relative intensity should be strongly tem peraturedependent.

F inally, we mention that only symmetric stators have been discussed in this paper. Stator-rotorm olecules with asymmetric stators are richer in physical content and potential moletronic applications. Such molecules will be discussed in a separate publication.
