# G eneral Form ula for the Therm oelectric Transport Phenom ena based on the Ferm i Liquid Theory: Therm oelectric Power, Nernst Coe cient, and Therm al Conductivity

On the basis of the linear response transport theory, the general expressions for the therm oelectric transport coe cients, such as therm oelectric power (S), Nemst coe cient (), and Therm al conductivity (), are derived by using the Fermi liquid theory. The obtained expression is exact as for the most singular term in terms of  $1 = {}_{k}$  ( ${}_{k}$  being the quasiparticle damping rate). We utilize the W and identities for the heat velocity which is derived by the local energy conservation law. The derived expressions enable us to calculate various therm oelectric transport coe cients in a system – atic way, within the fram ework of the conserving approximation as Baym and K adano. Thus, the present expressions are very useful for studying the strongly correlated electrons such as high-T<sub>c</sub> superconductors, organic metals, and heavy Ferm ion system s, where the current vertex correction (VC) is expected to play in portant roles. By using the derived expression, we calculate the therm al conductivity in a free-dispersion model up to the second-order with respect to the on-site C oulom b potential U. We nd that it is slightly enhanced due to the VC for the heat current, although the VC for electron current makes the conductivity () of this system diverge, re ecting the absence of the Um klapp process.

## I. IN TRODUCTION

In general, the transport phenom ena in metals are very important physical objects because they o er much inform ation on many-body electronic properties of the system. Especially in strongly correlated electron systems like high-T c cuprates or heavy Ferm ion systems, various transport coe cients show striking non-Ferm i liquid type behaviors. Historically, theoretical studies on transport phenom ena give considerable progresses in various elds of the condensed matter physics, such as K ondo problem and high-T c superconductivity.

A coording to the linear response theory [1{3] or the K ubo form ula [4], transport coe cients are given by corresponding current-current correlation functions. Thus, to study transport phenom ena, we need to calculate the two-body green function with appropriate vertex corrections (VC's). Unfortunately, in m any cases it is a di cult analytical or num erical work. Therefore, at the present stage, transport coe cients are usually studied within the relaxation time approximation (RTA), by dropping all the VC's. The e ect of the VC can be included by the standard variational m ethod by Z im an based on the Boltzm ann transport theory [5] How ever, it is not so powerful for anisotropic correlated system's because there is no system atic way of choosing the trial function. Thus, it is desired to establish the m icroscopic transport theory based on the linear response form ula.

B ased on the K ubo form ula, E liashberg derived a general expression for the dc-conductivity () in the Fermi liquid by taking the VC's into account, by performing the analytic continuation of the current-current correlation functions [6]. B ased on the expression, Y am ada and Y osida proved rigorously that diverges even at nite temperatures if the U m klapp scattering process is absent. [7]. By generalizing the E liashberg's theory including the outer m agnetic eld, the exact form ulae for the H all coe cient ( $R_H$ ) [8] and the m agnetoresistance (=) [9] in Fermi liquid system s were derived. By using these form ulae, in principle, we can perform the conserving approximation for these coe cients with including appropriate VC's for currents [10].

In general, the VC's for currents are expected to be in portant especially in strongly correlated system s. For example, in high-T c cuprates, the so-called K ohler's rule  $(\Re_H j)^{-0}$  and = / 2) is strongly violated [11]. M oreover,  $R_H < 0$  in electron-doped compounds, although the shape of the Ferm i surface is everywhere hole-like. These behaviors, which cannot be explained within the relaxation time approximation (RTA), had been an open problem in high-T c cuprates. Based on the conserving approximation, we found that these anomalies are well reproduced by the VC's for electron currents [12[14]. The e ect of the VC's, which are dropped in the RTA, becomes much important in a Ferm i liquid with strong antiferrom agnetic or superconducting uctuations.

However, as for the therm oelectric transport coe cients such as the therm oelectric power (TEP, S), the Nernst coe cient (), and the therm al conductivity (), we do not know useful expressions for analysis in the strongly

correlated systems so far. Here, the de nition of S, , and under the magnetic led B parallel to the z-axis are given by

where Q is the heat current. Unfortunately, the conserving approximation for these coecients is not practicable because we do not know how to calculate the VC's for them. Thus, at the present stage, only the RTA is accessible, which will be insu cient for a reliable analysis of the strongly correlated system s because VC's should be included.

There is a long history of the m icroscopic study on them oelectric transport phenomena. To this problem, we cannot apply the K ubo form ula to the electronic conductivity naively because there is no H am iltonian which describes a temperature gradient  $@_x T$ . In 1964 Luttinger gave a m icroscopic proof that them oelectric transport coe cients are given by the corresponding current-current correlation function [1]. Later, M ahan et al. m uch simplied the Luttinger's expression in the case of electron-phonon and electron-impurity interactions [3]. However, the analysis of the VC for the heat current for electron interacting systems is still an open problem, which is necessary to go beyond the RTA. This analysis will be m ore complicated and profound than that for the electric conductivity perform ed by E liashberg [6].

In the present paper, we derive the therm oelectric transport coe cients by perform ing the analytic continuations of the current-current correlation functions, on the basis of the linear response theory developed by Luttinger or M ahan. O ur expressions are valid for general two-body interactions. The VC for the heat current is given without am biguity by the W and identity with respect to the local energy conservation law. The derived expressions are \exact" as for the m ost divergent term with respect to  $_{k}^{1}$ , where  $_{k}$  is the quasiparticle damping rate. The present work enables us to perform the \conserving approximation" for S, and , which is highly dem anded to avoid unphysical results. A ctually, the VC 's would totally modify the behavior of these quantities in strongly correlated electron system s, as it does for the H all e ect and the magnetoresistance. In this respect, the RTA is unsatisfactory because all the current VC 's are neglected there.

W e note that Langer studied the W and identity for the heat current, and discussed the therm al conductivity [15]. However, the derived W and identity was not correct as explained in xIII, although it did not in uence the therm al conductivity at lower tem peratures fortunately. We derive the correct W and identity in xIII, and give expressions for , S and  $\cdot$ .

In them odynam ics, the TEP of m etals becomes zero at absolute zero temperature, which is the consequence of \the third law of the them odynam ics". (As is well known, the third law also tells that the heat capacity vanishes at T = 0.) Similarly, both and also become zero at T = 0 if the quasiparticle relaxation time (= 1=2) is nite at T = 0 due to impurity scatterings. Unfortunately, these indisputable facts are nontrivial in a naive perturbation study once the electron-electron correlations are set in. In the present work, we derive the general expression for S which autom atically satisfy S (T = 0) = 0 owing to the W ard identity for the heat velocity.

In high-T c cuprates, the N emst coe cient increases drastically below the pseudo-gap tem perature, which is never possible to explain within the RTA [16]. A coording to recent theoretical works, superconducting (SC) uctuation is one of the promising origins of the pseudo-gap phenom ena [17{20]. Based on the opinion, we studied for high-T c cuprates using the general expression derived in the present paper [21]. Then, we could reproduce the rapid increase of only when the VC's due to the strong antiferrom agnetic and superconducting uctuations are taken into account. This work strongly suggests that the origin of the pseudo-gap phenom ena in high-T c cuprates is the strong d-wave superconducting uctuations.

In the case of heavy Ferm ion system s, the TEP takes an enhanced value around the coherent tem perature, and its sign changes in some compounds at low er tem peratures. Such an interesting non-Ferm i liquid like behavior is mainly attributed to a huge energy dependence of the relaxation time, () (= 1=2 ()), due to the K ondo resonance. This phenom enon was studied by using the dynam ical mean eld theory [22,23]. Also, the TEP in the K ondo insulator was studied in ref. [24] in detail.

The contents of this paper are as follows: In xII, we develop the linear response theory for them oelectric transport coe cients. By performing the analytic continuation, we derive the general form ula of S and in the presence of the on-site C oulom b potential U. In xIII, we derive the W and identity for the heat velocity which is valid for general two-body interactions, by using the local energy conservation law. The W and identity assures that the expressions for S and derived in the previous section are valid even if the range of the interaction is nite, as for the m ost divergent terms with respect to <sup>1</sup>. In xIV, the general form ula for is derived. It is rather a complicated task because the gauge invariance should be maintained. In xV, we calculate in a spherical correlated electron system in the absence of Um klapp process, and obtain its exact expression by including the VC 's within the second order perturbation. The physical meaning of the VC is discussed. Finally, the sum many of the present work is shortly expressed in xV I.

First, we shortly summarize the linear response theory for therm coelectric transport coe cients, initiated by Luttinger. Here we consider the situation that both the electron current  $J^1 - J$  and the heat current  $J^2 - Q$  are caused by the external forces  $X^{-1} = T$  and  $X^{-2} = \tilde{T} - \frac{1}{\tau}$ , where  $\tilde{E}$  is the electric eld. In the linear response,

where l;m = 1;2. Because the relation  $\frac{dS_e}{dt} = \int_{1}^{P} J^1 X^1$  (S<sub>e</sub> being the entropy) is satisfied in the present de nition, the tensor  $\hat{L}^{lm}$  (B) satisfy the Onsager relation;  $L^{lm}$  (B) =  $L^{ml}$  (B), where ; = x; y; z [25].

A coording to the quantum mechanics, the electron current operator  $\tilde{j}$  and the heat current one  $\tilde{j}^{0}$  are given by [2]

where e < 0 is the charge of an electron, H is the H am iltonian without external elds X<sup>1</sup>,  $(r_i) = {\overset{P}{c}} c^y (r_{ij}c (r_i)$  is the density operator (being the spin su x), and  $h(r_i)$  is the local H am iltonian by which H is given by H =  ${}_i h(r_i)$ . By using these current operators, J and Q are given by  $J(r_i) = h_j^2(r_i)$  i and  $Q(r_i) = h_j^2(r_i)$  i, respectively.

To derive the expressions for various conductivities m icroscopically, we introduce the virtual external potential term F which causes the currents X<sup>1</sup> (l = 1;2). Then, the \total H am iltonian" is expressed as  $H_T = H + F$  ( $e^{i! + ...)t}$ , where > 0 is a in nitesimally small constant. A coording to the linear response theory [1,4], the current  $J^1$  at t is given by

Because of the relation  $\frac{@F}{@t} = T \frac{@S_e}{@t} = T \sum_{l}^{X} J^l X^l$  the expression for  $\hat{L}^{lm}$  is given by [2]

where = 1=T and ; = x;y. T is the -ordering operator, and  $!_1 = 2$  Tl (l being the integer) is the bosonic M atsubara frequency. By writing the diagonal component of  $\hat{L}^{lm}$  as  $L^{lm}$ , , S and are given by [2]

where e (e < 0) is the charge of an electron.

Hereafter, we analyze the function  $\hat{L}^{lm}$  (i!<sub>1</sub>) given by eq.(8) at rst, and perform the analytic continuation to derive  $\hat{L}^{lm}$  by eq.(7). We study a tight-binding model with two-body interactions, which is expressed in the absence of the magnetic eld as:

In eq.(13),  ${}^{0}_{k} = {}^{P}_{i} t_{i;0} e^{ik} (r_{0} r_{0})$ , where  $t_{ij}$  is the hopping parameter between  $r_{i}$  and  $r_{j}$ . U  $\circ$  (q) represents the electron-electron correlation between and  ${}^{0}$  spins. For example, U  $\circ$  (q) U ;  $\circ$  for the on-site C oulom b interaction.

The one-particle G reen function is given by  $G_k$  () = 1=( +  $\binom{0}{k}$  k ()), where k () is the self-energy and

is the chem ical potential. In a Ferm i liquid,  $_{\rm k}$  T is satisfied at su ciently low temperatures because of the relation  $_{\rm k}$  / T<sup>2</sup> [26]. In such a temperature region, the following quasiparticle representation of the G reen function is possible:

A coording to eq.(3), the electron current operator for eq.(12) is given by

In the same way, we consider the heat current operator de ned by eq.(12): In the case of the on-site C oulom b interaction, for sim plicity, it is obtained after a long but straightforward calculation as

which contains a two-body term in the case of  $U \notin 0$ . It becomes more complicated for general long-range potential. This fact seems to make the analysis of the therm coelectric coelectric coelectric.

Fortunately, as shown in Appendix A, eq.(17) can be transformed into the following simple one-body operator form by using the kinetic equation:

where  $!_1$  and  $_n$  are boson and ferm ion M atsubara frequencies, respectively. The case of the nonlocal electron-electron interaction is discussed in the next section by constructing the W and identity for the heat velocity.

By using eq.(18), we obtain the expression for  $L^{12}$  without the magnetic eld as follows:




FIG.1. The four-point vertex correction and the three-point vertex function , respectively.

where  $g_k(n;!_1) = G_k(i_n + i!_1)G_k(i_n)$ .  $k_k(n;!_1)$  and  $(k_n;k_{n^0};!_1)$  are the three- and four-point vertices respectively, which are expressed in Fig. 1. They are reducible with respect to the particle-hole channel. Note that we put the outer momentum p = 0 in eq.(20) because we are interested in the dc-conductivity.

The expression (19) for  $L^{12}$  derived for the on-site C oulom b interaction is equal to that for a system with the impurity scattering and the electron-phonon interaction derived by Jonson and M ahan. [3]. In the next section, we will show that the expression is also valid for general types of two-body interactions as for the most divergent term with respect to 1 on the basis of the W ard identity.

The dc-TEP is obtained by the analytic continuation of eq.(19) with respect to  $i!_1$ , by taking all the VC's into account. (The analysis on the VC's in ref. [3] is insu cient.) In the present work, we perform the analytic continuation rigorously by referring to the E liashberg's procedure in ref. [6]. Next, by using the W and identity (26), we derive the simple expression for the TEP within the most divergent term with respect to 1.

A fler the analytic continuation of eq.(19),  $L^{12}$  (+ i ) of order O (<sup>1</sup>) is given by

where the total electron current  $J_k$  with VC's and the quasiparticle heat velocity  $q_k$  are respectively given by

where  $g_k^{(1)}() = fG_k^A()\hat{g}, g_k^{(2)}() = jG_k()\hat{j}$  and  $g_k^{(3)}() = fG_k^R()\hat{g}$ , respectively. The denition of the four-point vertex  $T^{m}$ ;  $p^{0}$ ;  $p^{0}$  is given in ref. [6], which are listed in Appendix B. In general,  $T^{2i}$  is well approximated at lower tem peratures as  $(T^{1i} + T^{3i})=2$  [6]. Thus, taking the W and identity for electron current is taken into account [26,27],  $v_k()$  is simply given by

Next, we consider  $q_k$  () de ned in eq.(24): By seeing its functional form, the relation  $q_k$  (= 0) = 0 is nontrivial. However, if  $q_k$  (= 0) were nonzero, then  $L^{12}$  in eq.(19) would be proportional to T<sup>-1</sup>. In this case, S =  $eL^{12} = T^2$  diverges at T = 0, which contradicts \the third law of the therm odynam ics"! In this sense, eq.(24) is too primitive for a reliable (num erical) analysis at lower tem peratures.

Fortunately, by noticing that  $T^{2i} = (T^{1i} + T^{3i})=2$  at low er tem peratures, the quasiparticle heat velocity  $q_k$  () given in eq.(24) can be rewritten in a simple form as

where  $\mathbf{v}_k$  () is given in eq.(25). Equation (26) is the W and identity which will be derived from the local energy conservation law in the next section. This W and identity leads to  $L^{12} / T^{3-1}$  because of  $\mathbf{q}_k$  ( = 0) = 0, so the di culty in analyzing the TEP towards T ! 0 is removed.

In the same way, we derive the exact formula for the thermal conductivity within the most divergent term with respect to  $^{1}$ . By the similar way to the derivation of eq.(19), we obtain that

where  $Q_k$  () is the total heat current with VC's, which is given by the analytic continuation of  $Q_{kx}$  (i<sub>n</sub>; i!<sub>1</sub>) from the region  $_{n} + !_{1} > 0$  and  $_{n} < 0$ , and by taking the limit !! 0. We stress that  $Q_{k}(=0) = 0$  at zero temperature, because the  $^{0}$ -integration range in eq.(30) is restricted to within j $^{0}$ j T due to the therm al factors in T<sup>22</sup> given by the analytic continuation; see A ppendix B. This fact leads to the result that L<sup>22</sup> (+ i ) given by eq. (29) is proportional to  $T^{3-1}$  as T ! 0. As a result, at low er temperatures, the relation /  $T^{-1}$  is assured in the present analysis. In sum m ary, (i) the TEP is given by  $S = \frac{e}{T^2} L^{12}$ , where  $L^{12}$  is given in eq.(21) and J, v and q are given by eq.(22),

eq.(25) and eq.(26), respectively. (ii) the therm alconductivity is given by  $=\frac{L^{22}}{T^2}$  TS<sup>2</sup>, where L<sup>22</sup> is given in eq.(29). At low er tem peratures, the rst term  $L^{22}=T^2$  is dom inant because it is proportional to T<sup>-1</sup> whereas the second term is proportional to  $T^{3}$  <sup>1</sup>.

F inally, we note that the conductivity is given by [6]

# III.GENERALIZED WARD IDENTITY

As we discussed in xI, the TEP becomes zero at zero temperature, which are ensured by \the third law of the therm odynam ics". This fact means that  $L^{12}$  given by eq.(21) should be proportional to  $T^{3-1}$  as T ! 0. This relation is ensured if the W ard identity (26) is satis ed exactly. In this section, we derive the generalized W ard identity for general types of the two-body interactions, by noticing the local energy conservation law;  $\frac{\theta}{\theta+}h + \tilde{r}$   $\tilde{J}^{Q} = 0$ , where h (z) is the local part of the Ham iltonian. The obtained heat velocity has a correction term  $\tilde{q}$  (see eq.(38)), which turn out to be negligible for transport coe cients at lower tem peratures. The present derivation is analogous to the proof for the generalized W ard identity for the electron current which is described in ref. [28]. In this section, we drop the spin su xes for simplicity of the description. In the same reason, we put = 0 because it will not cause a confusion. Here, we introduce the four-dimensional heat velocity;  $(h(z);j^{\circ}(z))$   $(j^{\circ}_{1}(z);j^{\circ}_{1}(z);j^{\circ}_{2}(z);j^{\circ}_{3}(z))$ . Then, we

consider the following function  $X^{Q}$  (= 0 3):

For the moment, we assume that h(z) is a local operator i.e., the two-body interaction U (x y) is a -function type. (This restriction on h(z) is released later in the present section.) Because the relation  $i[h(z);c(x)](z_0 = x_0) = \frac{\theta}{\theta x_0}c(x)^4(z = x)$  is satisfied, then

in term s of the zero-tem perature perturbation theory, which is diagram matically shown in g2. In the nite tem perature perturbation theory,  $q_p($ ) is expressed as eq.(24). We stress that eq.(37) is satisfied only when we take account of all the diagram s for  $k (k; k^{0})$  which are given by the functional derivative = G. (see Appendix D.)

F inally, we discuss the following two restrictions assumed in the proof of the W ard identity:

(i) In the above discussion, we assumed that the potential term in h(z) is local, which is not true if the range of the interaction is nite. In this case, a correction term C (x;y;z) given in eq.(C 9) should be added to (34), as discussed in Appendix C. This correction term gives rise to the additional heat velocity q(k) given by eq.(C 13). Note that  $q_k$  () vanishes identically in the case of the on-site C oulom b potential. As a result, the W ard identity for the heat velocity in the case of general two-body interactions is given by

Fortunately, q(k) does not contribute to the transport coe cients as discussed in Appendix C.As a result, we can use the expression for q(k) in eq.(37) for the purpose of calculating S, and , even if the potential U (k) is momentum -dependent.

(ii) Here we treated the space variables like x, y and z as continuous ones for the sim plicity. However, it is easy to perform the sim ilar analysis for the tight-binding model, by replacing the derivative of x with the dimension. For example, the local energy conservation law is expressed as  $\frac{\theta}{\theta t}h(r_1) + (j(r_{1+1}) - j(r_{1-1}))=2a = 0$ , where a is the lattice spacing. We stress that the W and identity in eq.(36) is rigorous also in the case of the tight-binding model. Note that we give the another proof for the W and identity based on the diagram matic technique in Appendix D, which is valid for general tight-binding models.

We comment that Langer studied the W and identity for the heat velocity in ref. [15]. Unfortunately, because of a m istake, an extra factor  $\sqrt{G_k} G_k^{(1)}$  (!) should be subtracted from the r.h.s. of his W and identity (i.e., the heat velocity), eq.(3.31) in ref. [15]; see eq.(37) or (38) in the present paper. In fact, the factor k (k + q) in eqs. (3.16) and (3.22) (in eqs. (3.19) and (3.23)) of ref. [15] should be replaced with  $k^2$  (with  $(k + q)^2$ ). This failure, which is fortunately not serious in studying the transport coe cients at lower temperatures, becomes manifest if one studies the W and identity in term s of the x-representation, like in the present study.

# IV.FORM ULA FOR THE NERNST COEFFIC ENT

A coording to the linear response theory, the Nemst coe cient is given by

where ^(B)  $\hat{L}^{12}$  (B)=T<sup>2</sup> is called the Peltier tensor ( $\mathcal{J} = \hat{a}$  ( $\tilde{r}$ T)), and tan <sub>H</sub> <sub>xy</sub> = is the Hall angle. Note that <sub>yx</sub> (B) =  $L_{yx}^{12}$  (B)=T<sup>2</sup> =  $L_{xy}^{21}$  (B)=T<sup>2</sup> =  $L_{xy}^{21}$  (B)=T<sup>2</sup> because of the Onsager relation. In addition, <sub>yx</sub> (B) = <sub>xy</sub> (B) in the presence of the four-fold symmetry along the magnetic led B.

In this section, we investigate the o-diagonal Peltier coe cient  $y_x$  due to the Lorentz force to derive the expression for the N emst coe cient. Up to now, the general expression for the H all coe cient [8,29] and that for the magnetoresistance [9] were derived by using the Ferm i liquid theory based on the K ubo form ula. These works enabled us to perform num erical calculations for the H ubbard m odel [12,14,31] within the conservation approximation as B aym and K adano [10]. Hereafter, we derive the general expression for the N emst coe cient by using the technique developed in refs. [8], [9] and [29].

For the present purpose, we have to include the external magnetic eld. In the presence of the vector potential, the hopping parameter  $t_{ij}$  in eq.(13) is multiplied by the Peierls phase factor [9]:



Below, we see that the dc-Peltier coe cient  $y_x$  is given by the analytic continuation of  $y_x$  (i! 1).

The diagram matic expression for  $C_{xy}$  (i!<sub>1</sub>) is very complicated, containing six-point vertices. Fortunately, as for the most divergent term with respect to <sup>1</sup>, they can be collected into a small number of simpler diagram s as shown in g.3 by taking the W and identity into account [8,9,29]. We can perform the present calculation for  $C_{xy}$  (i!<sub>1</sub>) in a similar way to that for  $_{xy}$  in ref. [8], only by replacing  $j_{=x}$  with  $j_{=x}^{0}$  and using the W and identity for the heat velocity. As a result, we obtain the following result:

Here, we assume that the magnetic eld B is parallel to the z-axis. Then, we can easily check that  $C_{xy} (i_1)$  in eq.(48) is expressed as  $C_{xy}^{=x; = y} (i_1)_{z}$ . This fact assures that  $_{xy} (i_1)$  given in eq.(47) is gauge-invariant, that is,

where  $\mathcal{Q}_k$  () is the total heat current introduced in eq.(30) W e stress that  $\mathcal{Q}_k$  (= 0) = 0 at T = 0, as is discussed in хШ.

It is instructive to make a comparison between xy and xy=eT: The latter is given by eq.(50) by replacing  $Q_x$ with  $J_x$ . In this case, the second term of eq.(50), which contains the k-derivative of k, vanishes identically because of the Onsager relation  $x_y(B) = y_x(B)$ . As a result, the general expression for  $x_y$  given in eq.(3.38) of ref. [8] is reproduced.

If the system has the four-fold symmetry along the z-axis, then xy(B) = yx(B). In this case, considering that  $\lim_{k \to \infty} G_k()_{j} = \int_{k} ()_{j}^{4} + eq.(50)$  can be rew ritten as [12,13]

where  $J_k = \tan^1 (J_{kx} = J_{ky})$ . In an interacting system without rotational symmetry, the second term with  $k_k$ -derivative of k does not vanish in general since  $\mathcal{J}$  is not parallel to  $\mathcal{Q}$  ow ing to the VC's by T<sup>22</sup>. In contrast,  $\mathbf{v}_k$  () =  $\mathbf{q}$  ()= because of the W ard identity. In ref. [21], based on the uctuation-exchange (FLEX)+T-m atrix approximation, we studied the Nemst coe cient of the square lattice Hubbard model as an elective model for high-T  $_{
m c}$  cuprates. We found that the second term of eq. (53) gives the huge contribution in the pseudo-gap region if the VC's for currents are taken into account in a conserving way. As a result, the origin of the abrupt increase of the Nemst coe cient under the pseudo-gap tem perature is well understood.

## V.D ISCUSSIONS

#### A.Vertex Correction for Therm alConductivity

In previous sections, we studied various analytical properties for  $q_k$  ( ) or  $\mathcal{Q}_k$  ( ), using the W ard identity for the heat velocity derived in xIII. In this subsection, we study a free dispersion m odel ( $_{\rm k}$  = k<sup>2</sup>=2m) in the presence of the electron-electron interaction without Um klapp processes. This situation will be realized in a tight-binding Hubbard model when the density of carrier is low; n 1. Here, we explicitly calculate the total heat current  $Q_k$  () in terms of the conserving approximation. The present result explicitly shows that  $J_k() \in \mathcal{Q}_k() = .$ 

Next, as a useful application of the expression for the transport coe cients derived in previous sections, we study the therm al conductivity in a free-dispersion model. Because of the absence of Um k lapp processes, the  $(\Gamma^2$ -term of the) resistivity of this system should be zero even at nite tem peratures. In a microscopic study based on the K ubo form ula, this physical requirem ent is recovered by taking account of all the VC's for the current given by the




FIG.4. The vertex corrections (by T<sub>22</sub>) for the heat/electron current in the second order perturbation theory.

W and identity [7]. On the other hand, the therm alconductivity is nite even in the absence of the Um klapp processes because heat currents are not conserved in the elastic norm al scattering processes. Hereafter, we derive the T<sup>1-1-1</sup> linear term of in the free dispersion model in terms of the conserving approximation. For this purpose, we can drop the second term of eq.(11) because  $L^{12}L^{21}=T^2L^{11}=TS^2$  O ( $T^{3-1}$ ). The obtained result is exact within the second order perturbation with respect to U.

First we consider the second order VC's as shown in gA. Because  $Q_k$  (= 0) = 0, we can write  $Q_k$  () =  $C_k$  up to 0 (). The correction term s given by (a-c) in gA,  $Q_k^{(a-c)}$  (), are given by




FIG.5. The self-energy given by the second order perturbation.

In conclusion, the vertex corrections slightly enhances (by  $\frac{9}{8}$  times) the therm alconductivity in a three-dimensional free-dispersion model within the second order perturbation theory.

Thus, the important result in ref. [7] is recovered. On the other hand, the therm alconductivity does not diverge even in the absence of the Um klapp processes, because the norm al scattering process attenuates the heat current.

where we perform ed the -integration rst by assuming the relation T. In an anisotropic system, the k-dependence of the integrand in eq.(80) m ay be strong. In high-T<sub>c</sub> cuprates, for example, it is known that the anisotropy of  $_{k}(0)$ on the Ferm i surface is very large because of the strong antiferrom agnetic uctuations. The point on the Ferm i surface where k takes its m in imum value is called the \cold spot", and the electrons around the cold spot m ainly contribute to the transport phenom ena. Because  $_{k}$  ( $_{k}$ ) has a huge  $k_{2}$  -dependence in high-T<sub>c</sub> cuprates around the cold spot, the sign of S is alm ost determ ined by the sign of  $e^{\frac{\theta_{k_{1}}}{\theta_{k_{2}}}}$  at the cold spot [31]. Next, we discuss the Nemst coe cient. W ithin the RTA, the Nemst coe cient is derived from eqs.(50), (29) and

(31) by dropping all the VC's by T<sup>22</sup>. In an isotropic system, by RTA is expressed in a simple form as [2,33]

We stress that  $Q_k^0$  (0) is not equal to  $J_k$  (0) in general, because the VC's for heat current and the electron one work in a di erent way; see discussions in xIV and xV A .

W e also comment that the M ott form ula type expression for xy,

Finally, we discuss the Nemst coe cient in high-T  $_{\rm c}$  cuprates which increases drastically below the pseudo-gap tem perature, T  $\cdot$  A coording to the num erical analysis based on the conserving approximation [21],  $k_k$ -dependence of  $\mathcal{J}_k$  j becomes huge due to the VC caused by the strong superconducting uctuations. Moreover,  $\mathcal{Q}_k = \mathcal{J}_k$  is large because the VC is much elective only for  $J_k$ . By considering eq.(53), the growth of the Nernst coel cient in high-T  $_c$ cuprates under T is caused by the enhancement of  $\frac{\theta}{\theta_{k_{E}}}$   $jT_{k}$  j not by  $\frac{\theta}{\theta_{E}}$  (E) [21].

## VI.SUMMARY

In the present paper, we have derived the general expressions for S, and in the presence of electron-electron interactions based on the linear response theory for the therm oelectric transport phenom ena. Each expression is \exact" as for the most divergent term with respect to 1. The heat velocity  $q_k()$ , which is required to calculate S, and , is given by the W and identity with respect to the local energy conservation law. We have studied the analytical properties of  $q_k$  () as well as the total heat current  $Q_k$  () in detail.

The expressions for S, and derived in the present paper are sum m arized as follows. Note that they are valid even if the Coulom b potential U (k) has a momentum -dependence, as discussed in Appendix C. Here, e(< 0) is the charge of an electron.

(i) TEP: It is better to include the \incoherent correction", which will be important in strongly correlated systems, as is discussed in ref. [34]. As a result, the nalexpression for S is given by

These derived expressions enable us to calculate the VC 's in the fram ework of the conserving approximation. In each expression, the factor 2 due to the spin degeneracy is taken into account. We note that our expression are equivalent to that of the relaxation time approximation (RTA), if we drop all the vertex corrections in the form ulae. How ever, the RTA is dangerous because it may give unphysical results owing to the lack of conservation laws. In conclusion, the present work gives us the fundamental frame work for the microscopic study of the therm collectric transport phenomena in strongly correlated electron systems. O wing to the present work, the conserving approximation for therm collectric transport coelectric transport co




FIG.6. The diagram matic expression for  $(i_n; i_n; i_1)$ .




FIG.7. The de nition of the region [(l;m);N].



In sum mary, when U (k) is momentum-dependent, the corrections term for the heat velocity q(k), given by eq.(C13), emerges. Fortunately, its contribution to transport coe cients would be negligible when the concept of the quasiparticle is meaningful, except for very high temperatures. In conclusion, the derived expressions for S, and , given by eqs.(84), (85) and (51) respectively, are valid for general electron-electron interactions, with the use of the heat velocity q(k) in eq.(37).




FIG.10. The generalized W and identity with respect to the heat velocity.


