D ispersion A nom alies in B ilayer C uprates and the O dd Sym m etry of the M agnetic R esonance

W e present a theoretical model which accounts for recent angle resolved photoem ission data in bilayer cuprate superconductors. Lineshapes and dispersions of the various bonding and antibonding features in the spectra are quantitatively reproduced. The observed dispersion anom alies are consistent with the interaction of electrons with a bosonic mode which is odd with respect to the layer indices, a unique property of the magnetic resonance observed by inelastic neutron scattering.

Recent angle resolved photoem ission (ARPES) experin ents on bilayer cuprate superconductors were able for the rst time to resolve a bilayer splitting between bonding and antibonding bands [1, 2, 3, 4]. The dispersion near the (;0) point of the Brillouin zone shows an unusual asymmetry between bonding and antibonding self energy e ects. In particular, Feng et al. [1] found that the energy distribution curves (EDCs, taken at constant m om entum) in overdoped B $\frac{1}{2}$ Sr₂C aC u₂O ₈₊ (T_c = 65K) consist of three features: an antibonding band (AB) peak near 20 meV, a bonding band (BB) peak near 40 m eV, and a bonding hum p near 105 m eV. Recently, G rom ko et al. [2] reported strong selfenergy e ects in the dispersions derived from momentum distribution curves (MDCs, taken at constant energy) in similar samples $(T_{c} = 58K)$. Near momentum $(k_{x}; k_{y}) = (1; 0: 13) = a_{y}$ an S-shaped dispersion anom aly, discussed previously in Ref. [5], was shown to be present only in the bonding band MDC, at binding energies between 40 meV and 60 m eV . In both experim ents, a low energy double peak structure in the EDC was only resolvable in the same momentum region.

In this letter, we demonstrate that all of these features can be explained by a model which assumes that low energy scattering of electrons between the bonding and antibonding bands is strong com pared to scattering within each of those bands. As scattering events which connect di erent bilayer bands are odd with respect to permutation of the layers within a bilayer, this im plies that the corresponding bosonic excitations which mediate such scattering must be dom inant in the odd channel. The magnetic resonance observed in inelastic neutron scattering has exactly this property [6, 7], and m oreover has the correct energy to reproduce the observed dispersion anom alies. Thus, the recent ARPES experim ents on bilayer cuprates provide independent support for a strong coupling between this resonance and electronic excitations.

If the electrons are phase coherent between the two planes, then the spectra w ill exhibit separate bonding (b) and antibonding (a) features with (norm al state) dispersions given by ${}^{(b)}_{\kappa}$ and ${}^{(a)}_{\kappa}$. In the cuprates, the resulting energy splitting is an isotropic [1, 8]

In the superconducting state, the dispersions are modied by the presence of the d-wave order parameter given by $_{R} = _{0} (\cos k_{x} - \cos k_{y})$. In agreement with experiment [1, 3], we assume $_{0}$ to be the same for the bonding and antibonding bands. Then, the dispersion in the superconducting state takes the form $(E_{R}^{(a,b)})^{2} = _{R}^{(a,b)}$

This \non-interacting" picture, though, is insu cient to describe the three observed dispersion features. We are able to account for them in a model where electrons are coupled to a resonant spin mode situated below a gapped spin uctuation continuum. Such a spectrum is observed in inelastic neutron scattering experiments [6]. In bilayer materials, the spin susceptibility is a matrix in the layer indices, having elements diagonal ($_{aa}$, $_{bb}$) and o -diagonal ($_{ba}$, $_{ab}$) in the bonding-antibonding representation. The components of the spin susceptibility transforming as even and odd with respect to the layer indices are given by $_{e} = _{aa} + _{bb}$ and $_{o} = _{ab} + _{ba}$. For identical planes, $_{aa} = _{bb}$ and $_{ab} = _{ba}$. The m easured susceptibility is then given by

where d is the separation of the layers within a bilayer. The resonance part, $_{res}$, was found to exist only in the odd channel, whereas the continuum part, $_{c}$, enters in both [6]. Thus, $_{o} = _{res} + _{c}$ and $_{e} = _{c}$. This means the resonance mode can only scatter electrons between the bonding and antibonding bands. In contrast, the spin uctuation continuum scatters both within and between these bands. A swe dem onstrate below, the odd symmetry of the resonance is crucial in reproducing the ARPES spectra.

We employ for the single layer self energy the functional form of Ref. [9]. It is proportional to the convolution of the G or kov-G reen's function \hat{G} with the dynamic spin susceptibility . We write this self energy symbolically as $\hat{} = g^2$ \hat{G} (the hat denotes the 2x2 particle hole space, and g is the coupling constant). For a bilayer system, there is a separate self energy for each band, $\hat{}^{(a,b)}$. U sing the above notation, these self energies are given by

D ispersion anomalies arise mainly from coupling to the resonance mode. This means that dispersion anomalies in the bonding band are determined by the antibonding spectral function and vice versa. (The spectral functions for the bonding and antibonding bands are given by the imaginary parts of the diagonal components of the G reen's functions.) Because the antibonding band is (in contrast to the bonding band) close to the chemical potentialat (;0) [1], the associated van H ove singularity leads to a larger self energy for the bonding band.

The self energy e ects can be described very accurately by using a model spin spectrum which consists of a perfectly sharp resonance mode below a gapped continuum with gap $_{\rm h}$. We approximate the intensity of the continuum to be constant. In reality, the intensity of the continuum decays at high energies. However, as we are interested in self-energy e ects in an energy range j j< 200 m eV, the above approximation is adequate. A high frequency cut-o in the convolution integrals in Eqs. (3a) and (3b) was introduced. The precise cut-o procedure how ever does not a ect the low energy physics. A ny variation in the cut-o can be accounted for by a readjustment of the coupling constants and the norm al state renorm alization factor. We model the resonance mode, R = 2Im _res, and the continuum, C = 2Im _c, by




FIG.1: M omentum dependence of a) the resonance m ode and b) the gapped spin uctuation continuum. The resonance m ode is peaked at $\mathcal{Q} = (;)$ with a correlation length equal to twice the lattice constant, res = 2a. The continuum spectrum, in contrast, is rather broad around \mathcal{Q} .

function is zero for negative argum ent and where the one otherwise. The momentum dependences of the resonance m ode and the continuum, given by the functions r (q) and c (q), are plotted in Fig. 1. The resonance mode, shown in Fig.1a, is peaked at \mathcal{Q} , with a correlation length of res = 2a, where a is the lattice constant. The gapped continuum, shown in Fig. 1b, is much broader. This is m otivated by the experim entaldata [6], which show that the continuum is enhanced around \mathcal{Q} with a correlation length of only 0.5 lattice constants. A lso, the m om entum dependence of the continuum excitations exhibit experimentally a at behavior around Q, as in Fig. 1b. To sim plify the model, we use the same functional form for the gapped continuum in the even and odd scattering channels. This is consistent with the superconducting state data, where the gap in the odd channel (about twice the

m axim alsuperconducting gap), is close to the optical gap in the even channel.

W e have chosen param eters appropriate for the overdoped sample ($T_c = 65K$) studied in experiment [1]. The norm al state dispersion is obtained from a 6 parameter tight-binding t to experimental data [11], with the bilayer splitting given by Eq.1. In order to determ ine the total of 7 param eters for this t, we used three Ferm i wavevectors, $\tilde{k}_{N} = (0.37; 0.37) = a, \tilde{k}_{A}^{(b)} = (1; 0.217) = a,$ and $\tilde{K}_{A}^{(a)}$ = (1;0:135) =a, the Fermi velocity at \tilde{K}_{N} , $v_{\rm N}$ = 2:316 eVA, and the norm all state band energies at (;0), $_{M}^{(b)} = 105 \text{ meV}$ and $_{M}^{(a)} = corresponding bilayer splitting is <math>_{M}^{(a)}$ 18 m eV (the $_{\rm M}^{\rm (b)} = t_2 = 87$ m eV). Finally, to obtain the correct overall shape of the dispersion, we xed the band energy at (;), using a reasonable value y = 0.8 eV. The high energy (j $\neq 200$ m eV) dispersions are not a ected strongly when going from the norm al to the superconducting state. However, even in the normal state, the bare dispersion is renorm alized by the norm al state spin uctuation continuum . To account for this renorm alization, we multiply the above dispersion by a factor of 1.4 in order to obtain the bare dispersion. For the remaining parameters of the model, we use $_0 = 16 \text{ meV}$ [1], $_{res} = 27 \text{ meV}$, $h = 0.9 \, _0, g^2 r(Q) = 0.15 eV^2, and g^2 c(Q) = 0.72 eV.$ The value for the resonance energy was obtained from the relation $res = 4.9k_B T_c$ found experimentally to hold for overdoped $B_{12}Sr_2CaCu_2O_{8+}$ [6, 7, 12]. The resonance weightr(Q) has not been measured for overdoped materials. For optim ally doped B i_2 Sr₂C aC u_2 O $_{8+}$, it is 0:95 $_B^2$ per plane [7], and we estimated for this case g = 0.65eV [9]. Assuming for the overdoped sample the same coupling constant, the above value for $g^2 r (Q)$ would in ply a resonance weight of $0.36 \frac{2}{B}$ per plane. Sim ilarly, with this coupling constant and our value for $g^2 c (Q)$, we obtain a (2D)-momentum averaged continuum contribution of 1:7 $\frac{2}{B}$ =eV per plane (gotten by sum m ing the even and odd channels for energies ! < 0.2 eV). Our calculations are for a tem perature T = 10K.Note we use unrenorm alized G reen's functions in Eqs. 3a and 3b. This




FIG.2: a) Tight binding Ferm i surfaces for antibonding and bonding bands in overdoped B i₂Sr₂C aC u₂O₈₊ (T_c = 65K). b) Renorm alization function and c) in aginary part of the self energy at the (;0) point of the zone for the bonding band (BB) and antibonding band (AB).d) Spectral functions for $k_y = =$ a, and k_x varying from 0 to 0.27 =a. For com parison with experiment, the spectra are convolved with a Lorentzian energy resolution function (FW HM 12 meV).

approximation is su cient to explain a large variety of data, and can be justilled by considerations discussed in Ref. [10].

The bonding and antibonding norm al state Ferm i surfaces are shown in Fig. 2a. The bilayer splitting is maxim al near the (;0) points of the zone. Thus, we will concentrate on this region in the following. In Fig.2b we show the renorm alization function for bonding and antibonding bands at the (;0) point. The renorm alization is stronger for the bonding band than the antibonding band. This is a result of the proximity of the antibonding saddle point singularity to the chem icalpotential. As is seen in this gure as well, both bands are renorm alized up to high energies. The high energy renorm alization approaches that of the norm al state dispersion (1.4).

The imaginary part of the self energy is shown in F ig.2c for the bonding and antibonding bands. A sem ission processes are forbidden for j j < res, the imaginary part of the self energy is zero in this range. D ue to scattering events to the antibonding band, electrons in the bonding band have a large imaginary part of the self energy in the range between 40 and 60 m eV. These events are dom inated by emission of the resonance, and are enhanced due to the van Hove singularity in the antibonding band close to the chemical potential. In contrast, the imaginary part of the antibonding self energy is not enhanced because the bonding band is far away from the chemical potential at (;0). Consequently, it shows linear behavior over a wide energy range, with a gap at low




FIG.3: Dispersion of EDC peak positions (left) and MDC peak positions (right) near the (;0) point of the Brillouin zone. The EDC dispersion consists of three branches, one antibonding peak, one bonding peak and one bonding hum p. The MDC bonding dispersion shows a characteristic S shape behavior. The sm all sym bols in the right picture show again the EDC peak positions for convenience.

energies (j j< res).

Fig. 2d presents the intensities for the bonding and antibonding spectra. The antibonding spectra consist of a low energy AB peak, and the bonding spectra have a low energy BB peak and a higher energy BB hum p feature. In agreement with experiment ([1] and [2]), the width of the EDC spectrum is large for the BB hum p, but not so for the BB and AB peaks. We also mention that the BB peak is well de ned in the whole region between the BB Ferm i crossings on either side of (;0), but the

nite energy resolution does not allow to resolve it near (;0) as seen in Fig.2d.

In Fig. 3 we show our results for dispersion of the EDC and MDC peak positions. In the EDC dispersions, Fig. 3a, we reproduce the experim entally observed three branches [1], one antibonding peak and two bonding branches, denoted BB peak' and BB hum p'. The BB peak has a very at dispersion near $k_x = 0$ in agreem ent with experim ent [1]. Its position at 40 m eV is approxim ately given by $_{\rm res}$ + $_{\rm A}$, where $_{\rm A}$ is the gap at the antibonding Ferm i crossing. Thus, the energy separation between the AB peak at the AB Ferm i crossing and the BB peak at (;0) is a measure of the resonance mode energy res in overdoped com pounds. The BB hum p position at high binding energies (105m eV) is determ ined by the norm alstate dispersion of the bonding band. Because the spin uctuation continuum changes only at low energies when going from the norm alto the superconducting state, the position of the BB hum p m axim um is not very di erent from the norm al state BB dispersion. This is in




FIG. 4: Spectral functions for $k_y = -a$ at $k_x = 0$, $k_x = 0.12$ =a and $k_x = 0.21$ =a. The full lines are the sum of antibonding (dotted) and bonding (dashed) spectral functions. For comparison with experiment, a Lorentzian energy resolution function of 12 meV width was assumed. The double peak structure is clearly resolved for $k_x = 0.12$ =a, as in experiment [1, 2].

agreem ent with experim ent [1]. The intensity of the AB peak decreases quickly when it approaches the BB peak, but is strong at (;0) because of the proximity of the AB band to the chemical potential in this region.

In Fig. 3b, we present the MDC dispersions (for comparison we also reproduce the EDC dispersions as small symbols). The MDC dispersion consists of two branches, an ABMDC branch and a BBMDC branch. The selfenergy e ects are most clearly observable in the BBMDC branch. In the binding energy range between 40m eV and 60m eV, there is an S-shaped break' region, connecting the BB hump EDC branch with the BB peak EDC branch. This S-shaped behavior reproduces the nding of recent experiments [2].

The dispersion anom alies observed in the bonding band are a m irror of the large number of states close to the chem ical potential near (;0) for the antibonding band. Scattering events involving a mode with energy res couple the bonding band electrons in the energy region between 40 and 60 m eV strongly to those antibonding band electrons. The corresponding processes are in the odd scattering channel. The energy range of anom alous dispersion is shifted by the resonance mode energy with respect to the antibonding binding energies.

Finally, in Fig. 4 we compare spectra for three positions in the Brillouin zone, corresponding to the spectra presented in Refs. [1, 2]. For each spectrum, the bonding (dashed) and antibonding (dotted) contributions are indicated. The spectra are convolved with a Lorentzian energy resolution function to allow for direct comparison with experiment. We reproduce all experimental ndings. First, at (;0), only the BB hump and the AB peak are resolved. This is due to resolution e ects mentioned above. Second, near the AB Ferm i crossing, the spectra show a characteristic double peak structure, with a relatively sharp AB peak and a BB peak separated from a broad BB hump. Third, at the BB Ferm i crossing, only the BB peak is observed. The BB hump is so sm all in intensity that it only leads to a kink-like feature in the spectrum.

W e have presented a theory to account for the experim entally observed self energy e ects in the bilayer split bands in double layer high tem perature superconductors. W e reproduced quantitatively the EDC dispersions, the MDC dispersions, and the spectral lineshapes. W e found that the ARPES data are consistent with the interaction of the electrons with a sharp bosonic mode which is odd in the layer indices, a property unique to the magnetic resonance observed by inelastic neutron scattering.
